FIG. 2 is a side elevational view of an opposite side from FIG. 1;

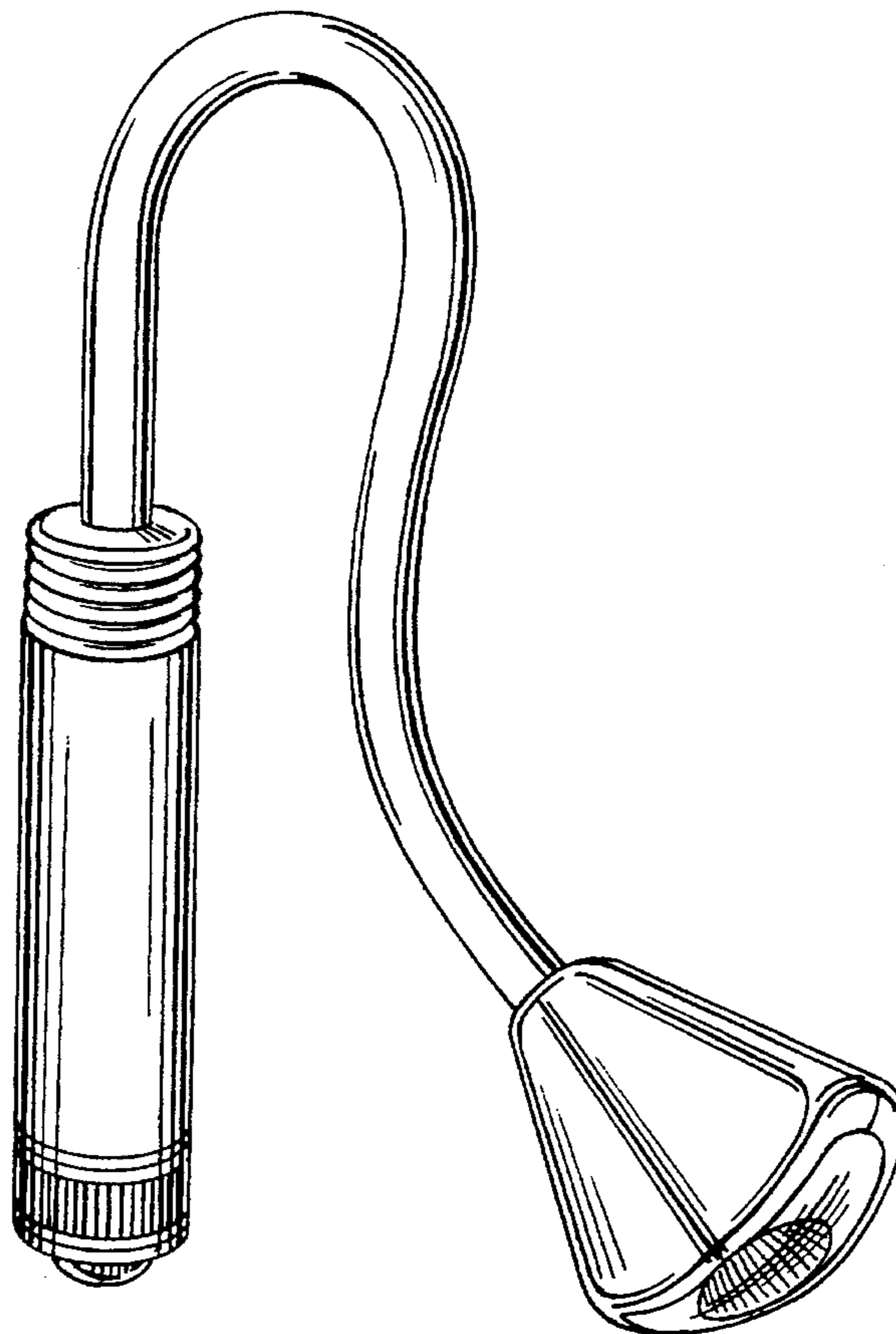
FIG. 3 is a front elevational view thereof;

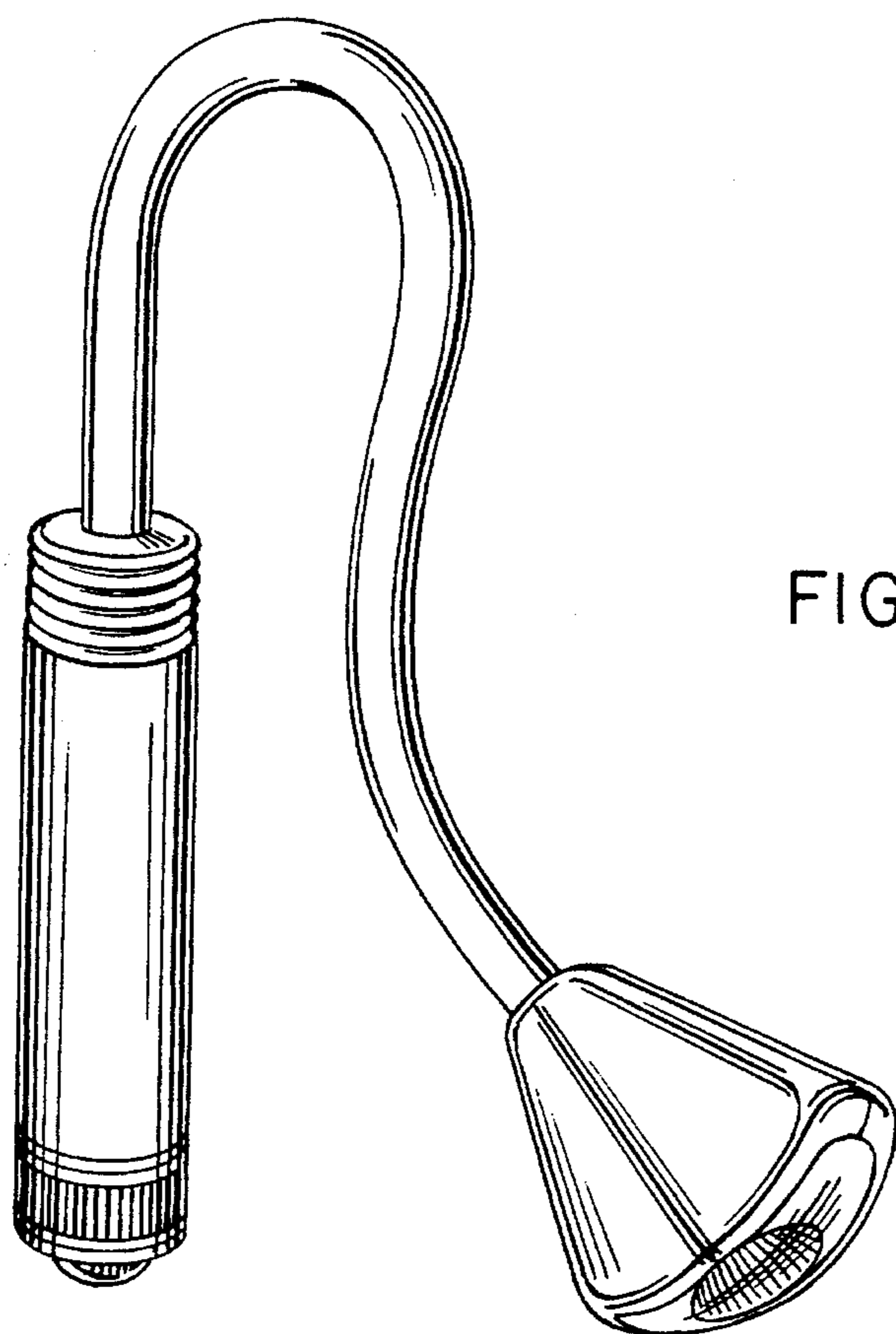

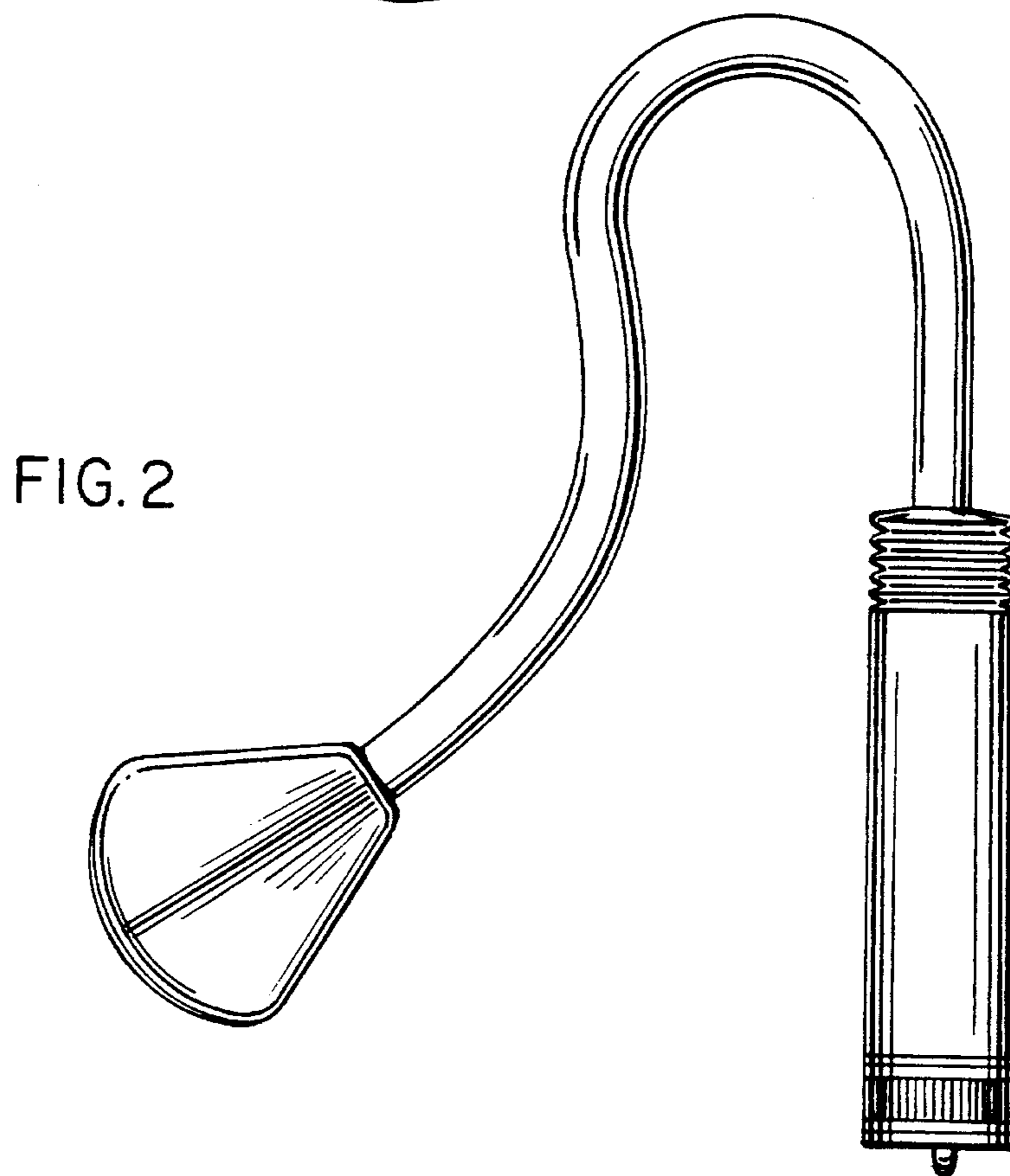

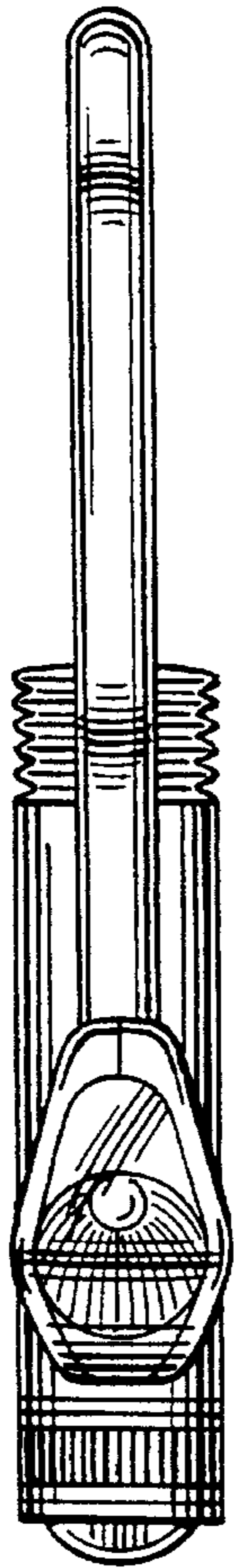

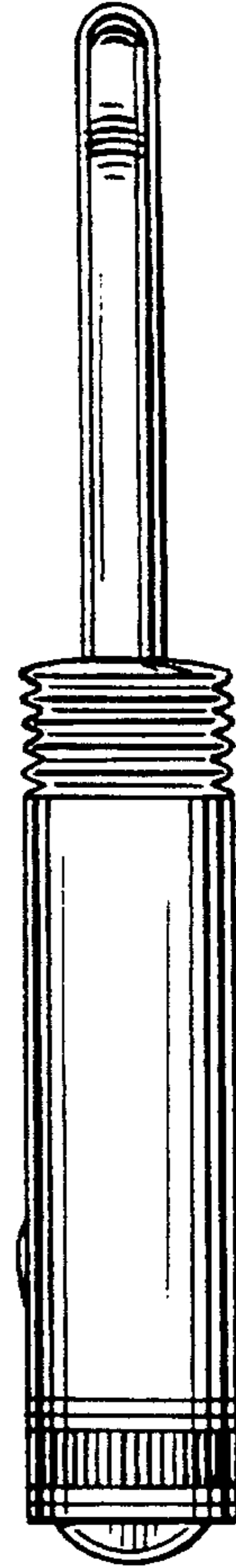

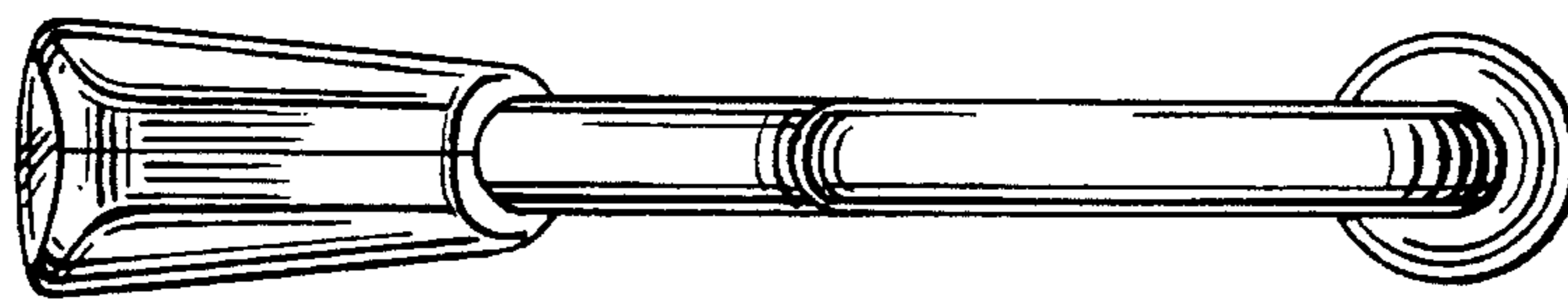

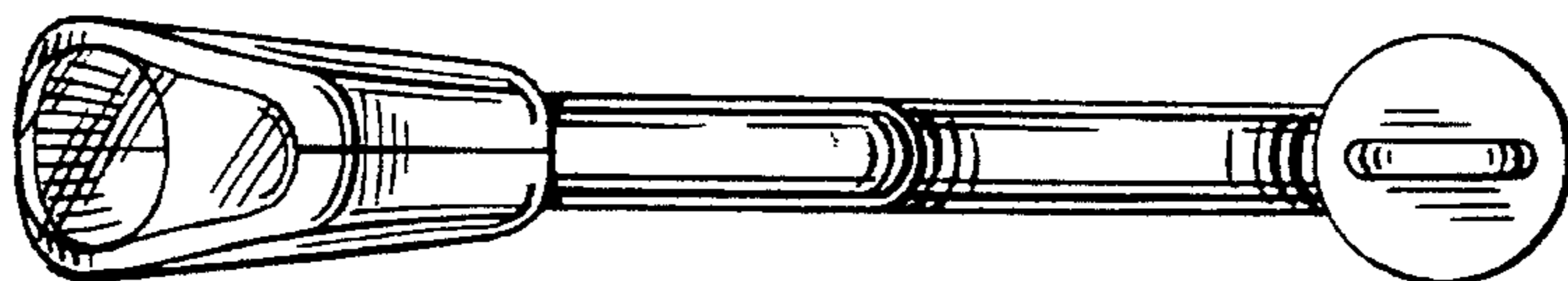
