[57] **CLAIM**

The ornamental design for a wheeled luggage case, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view taken from the upper lefthand corner of the case embodying my new design;

FIG. 2 is a front view of the case shown in FIG. 1;

FIG. 3 is a back view thereof showing the side opposite that shown in FIG. 2;

FIG. 4 is a left side view thereof;

FIG. 5 is a right side view thereof;

FIG. 6 is a top view thereof; and,

FIG. 7 is a bottom view thereof;

FIG. 8 is a perspective view taken from the upper lefthand corner of a second embodiment of a case embodying my new design;

FIG. 9 is a front view of the case shown in FIG. 8;

FIG. 10 is a top view thereof;

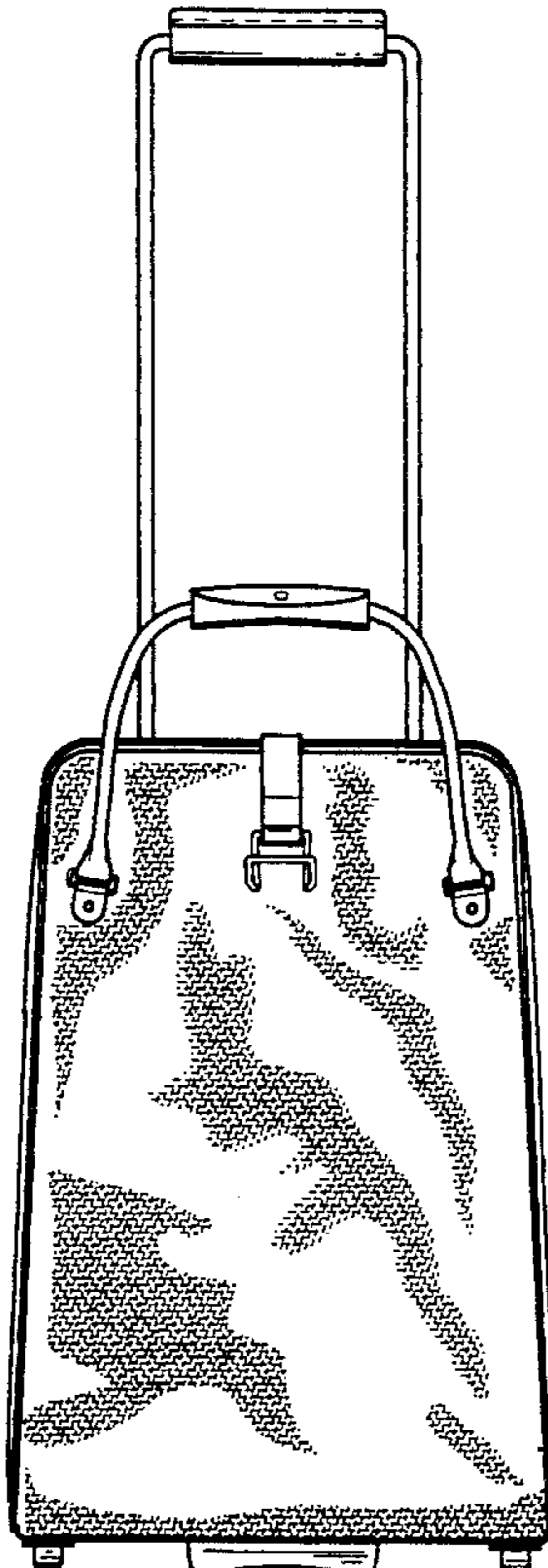
FIG. 11 is a back view thereof showing the side opposite that shown in FIG. 9;

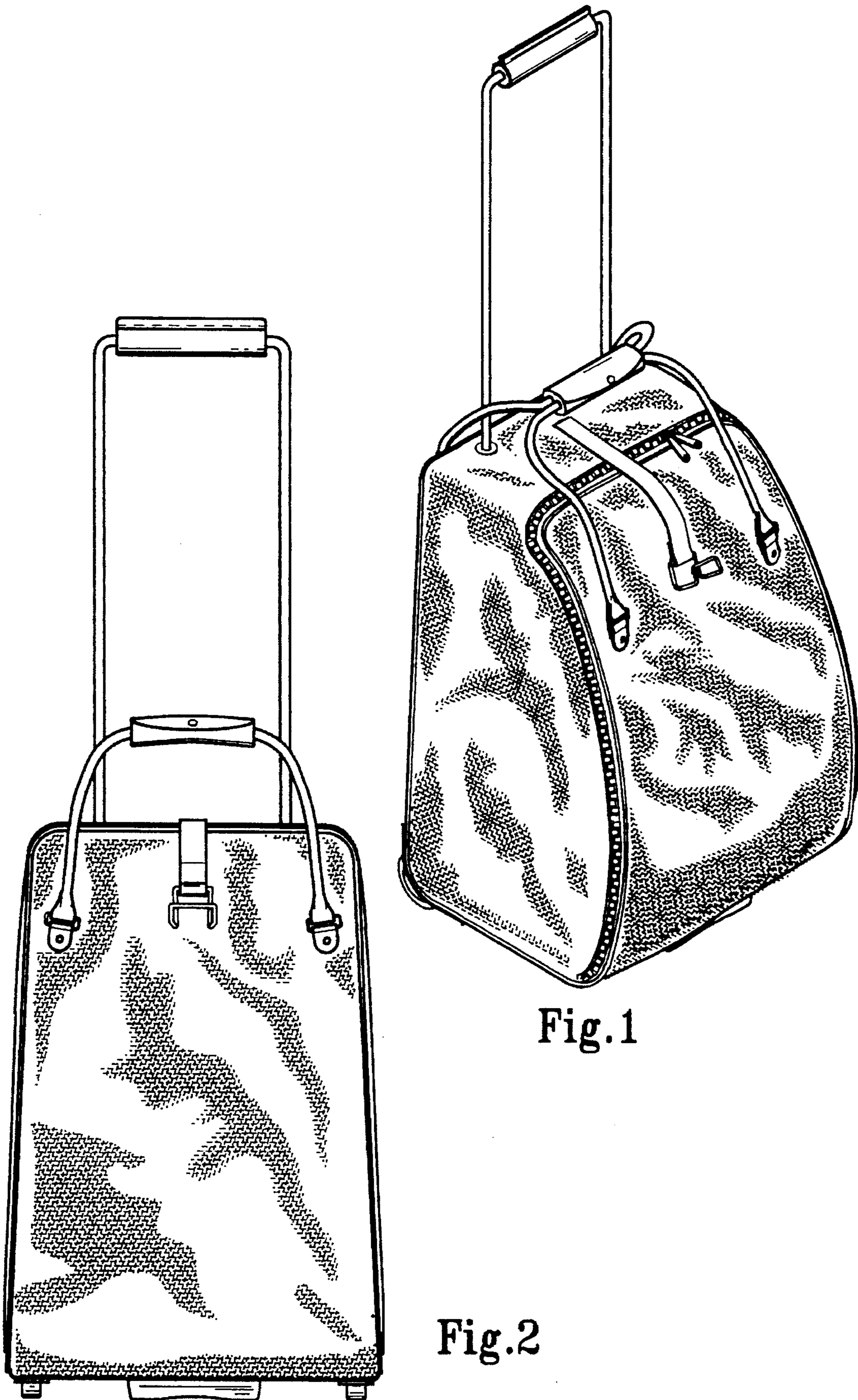

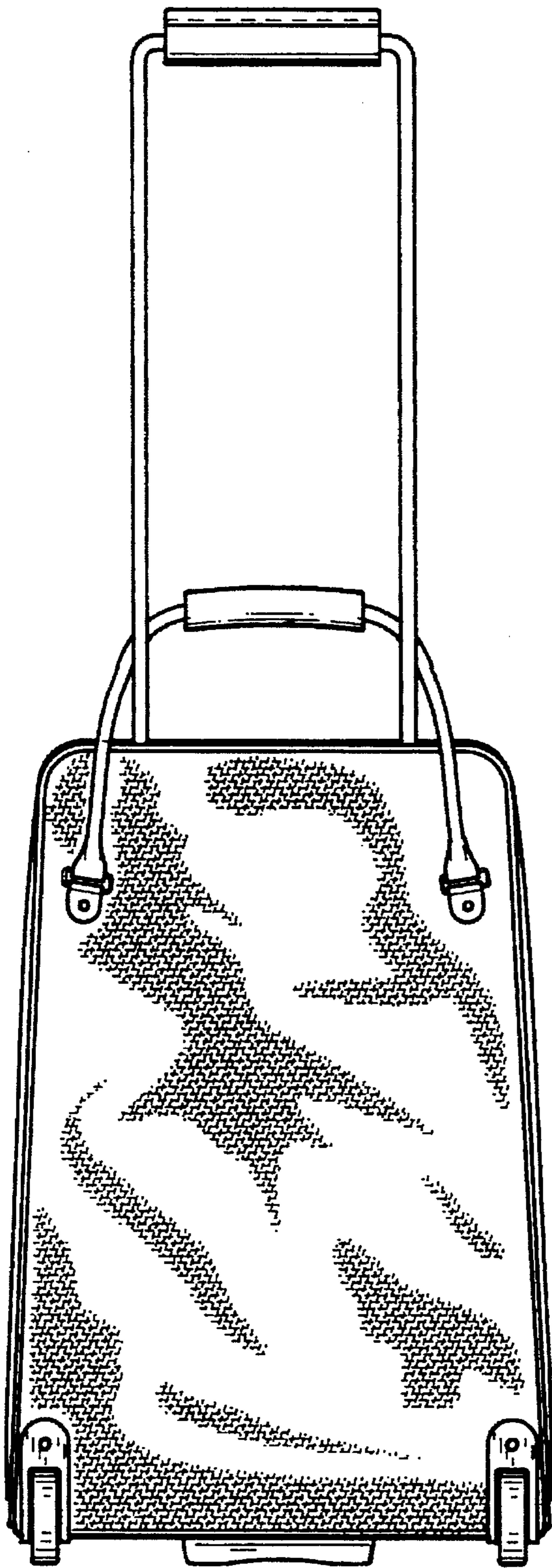

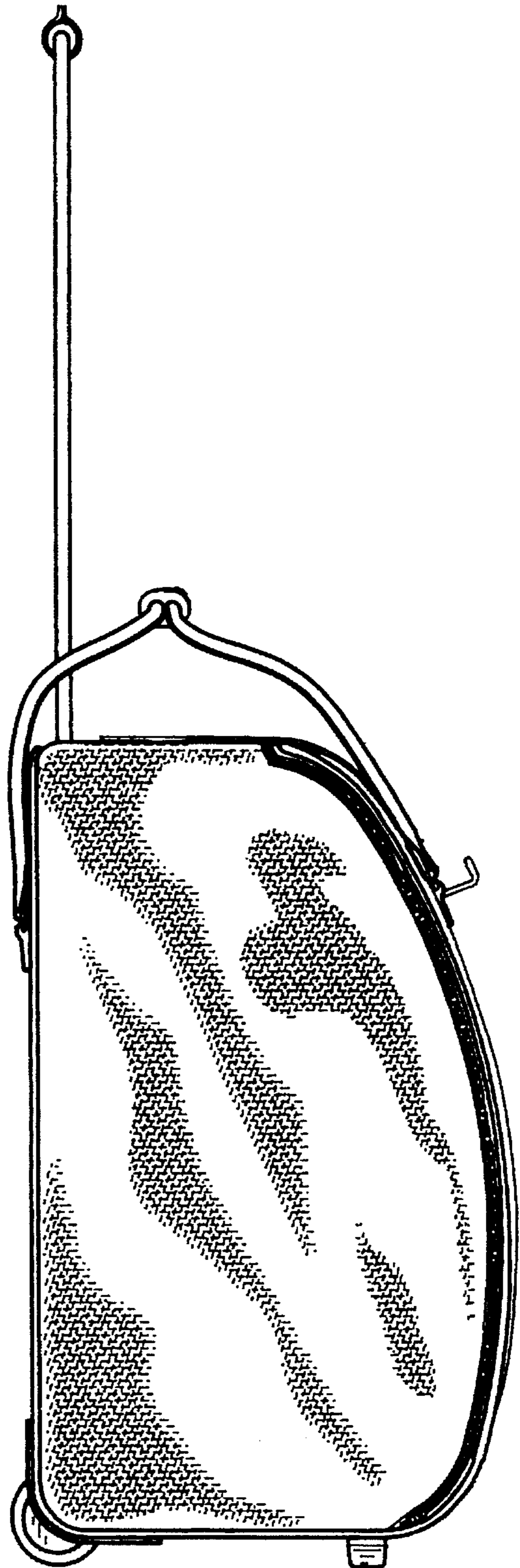

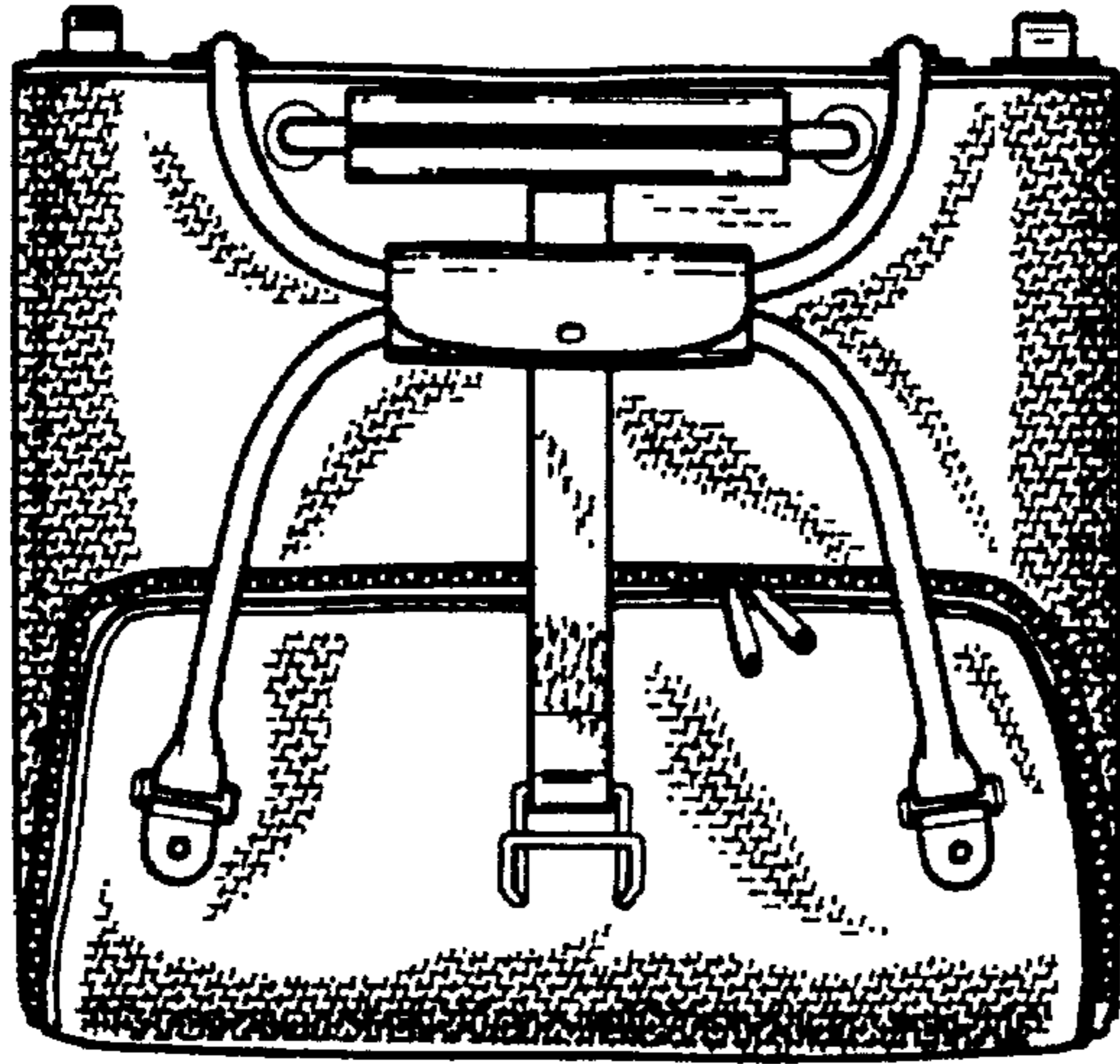

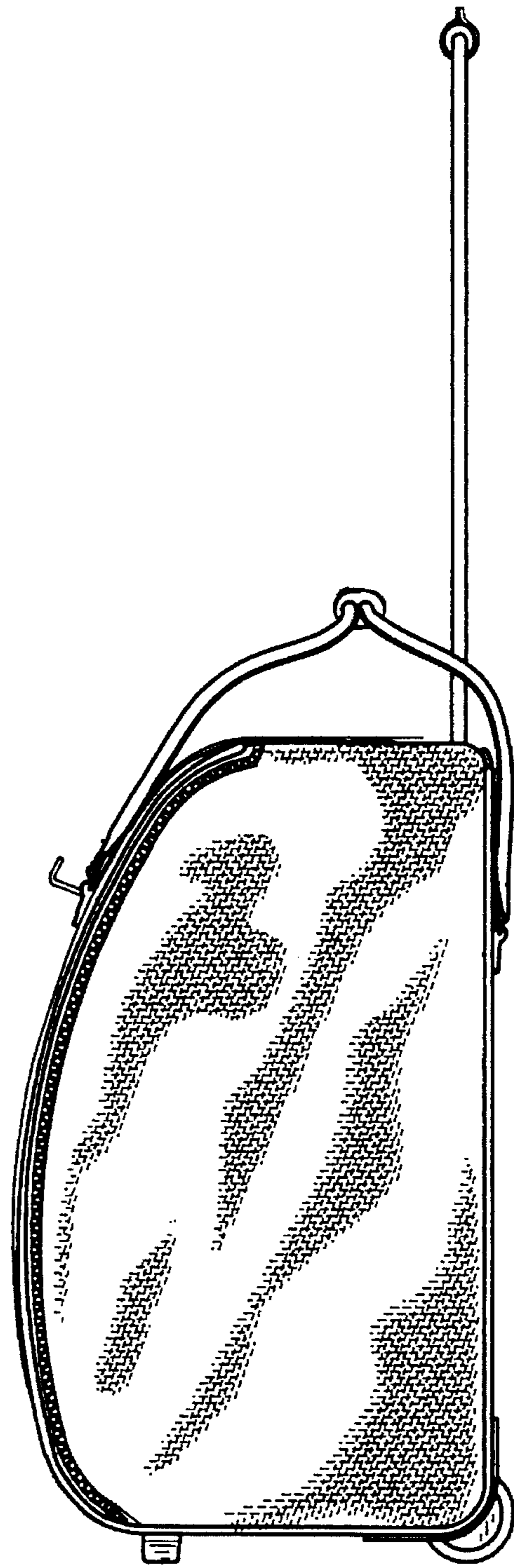

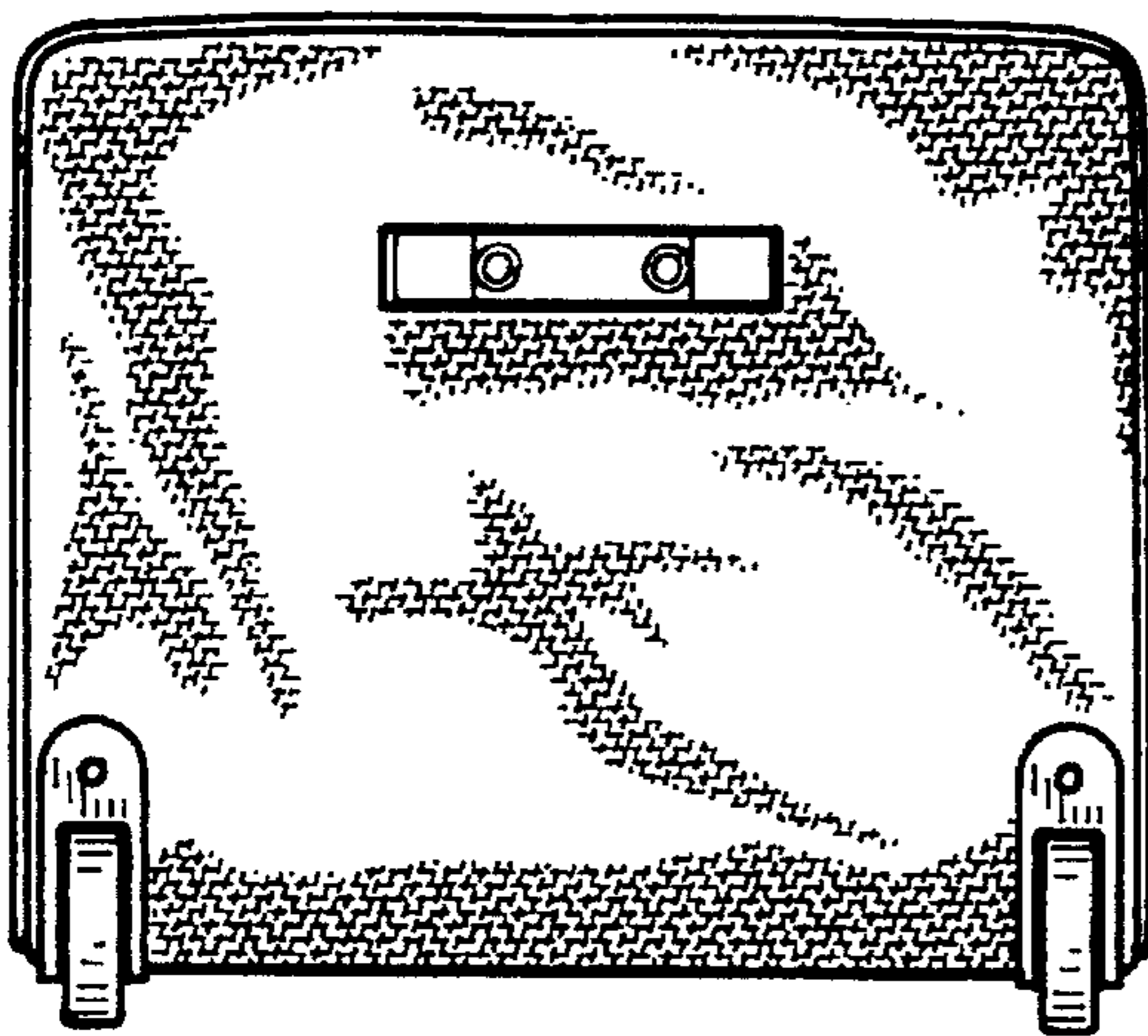

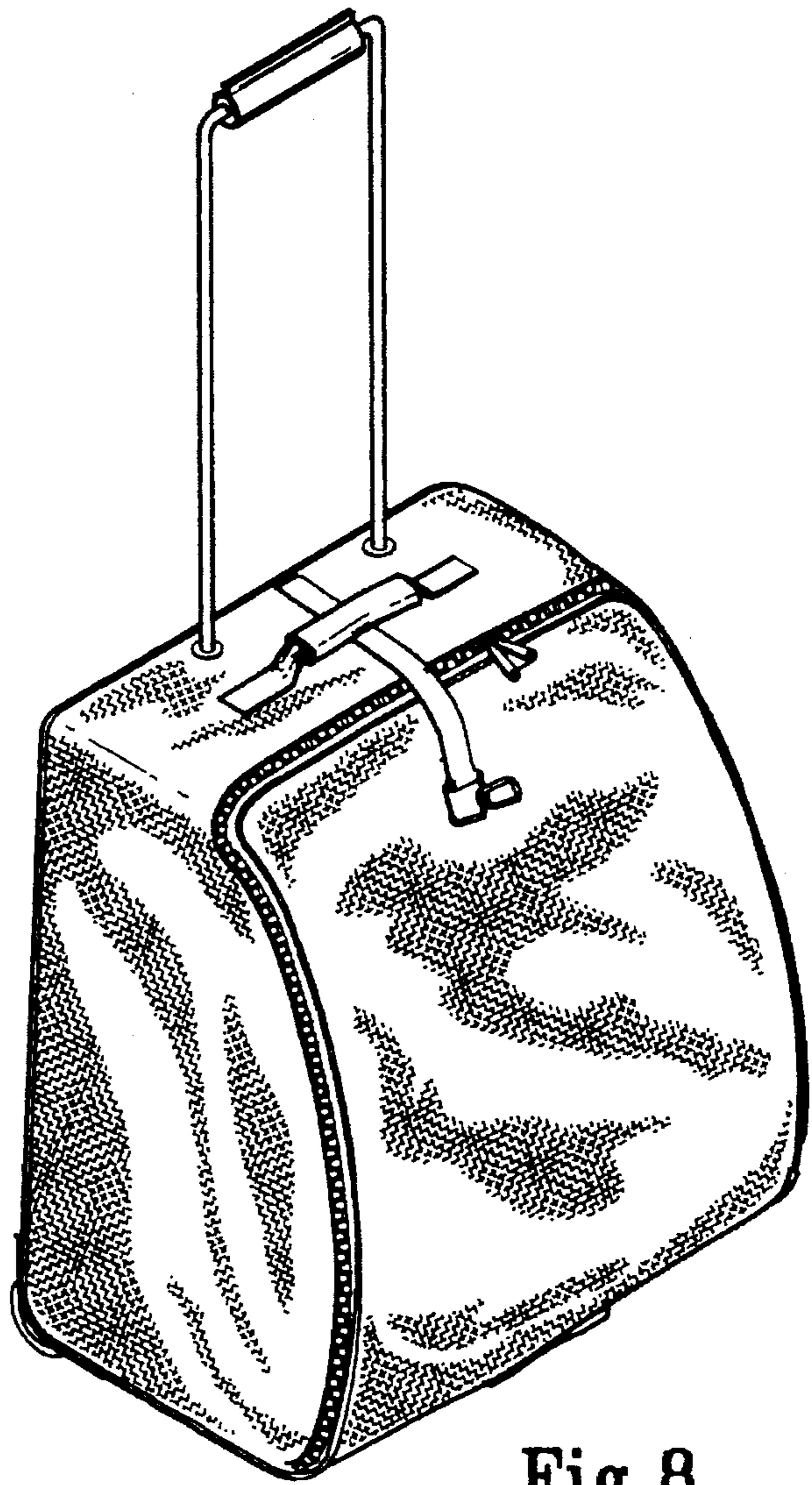

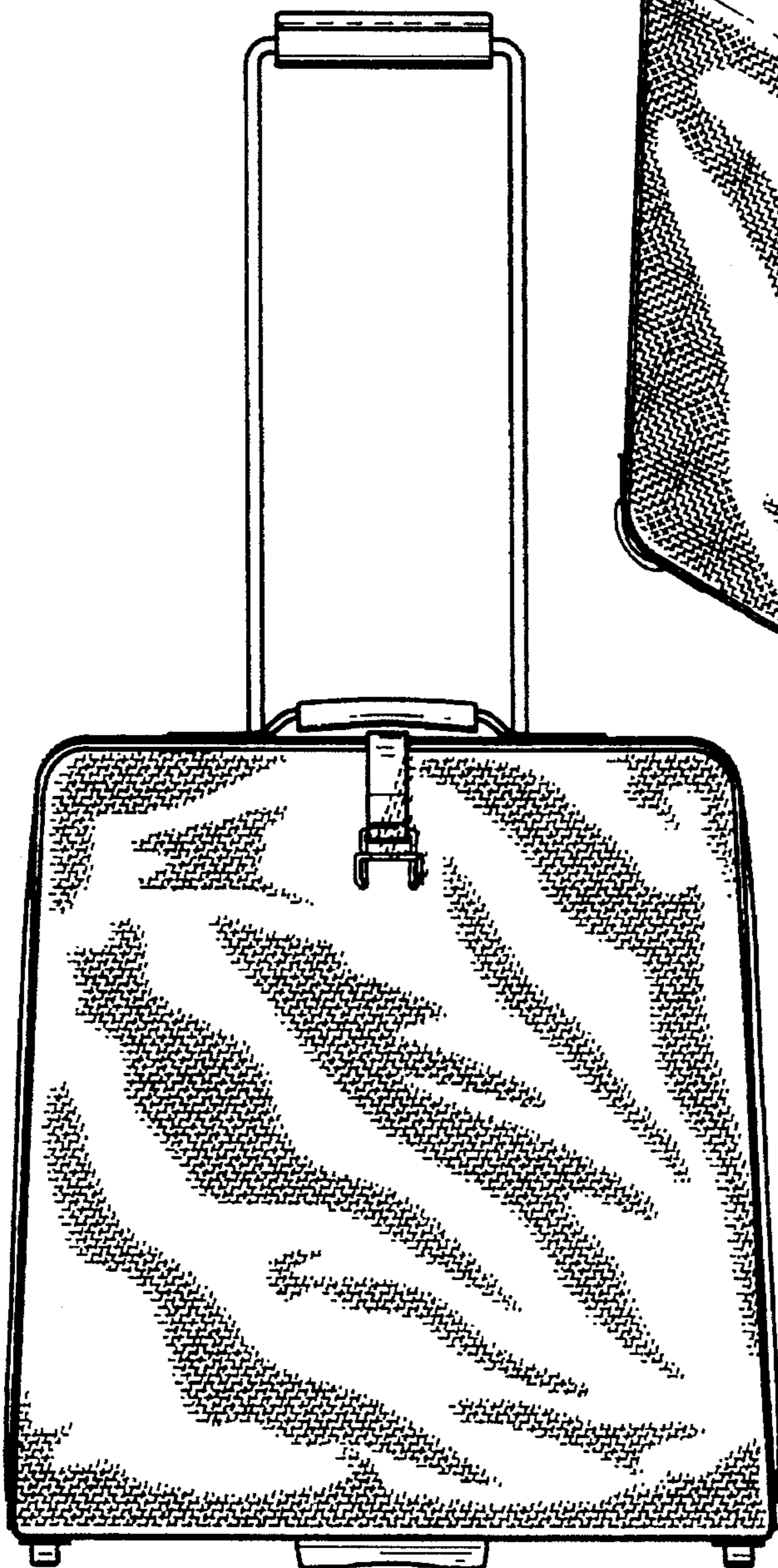

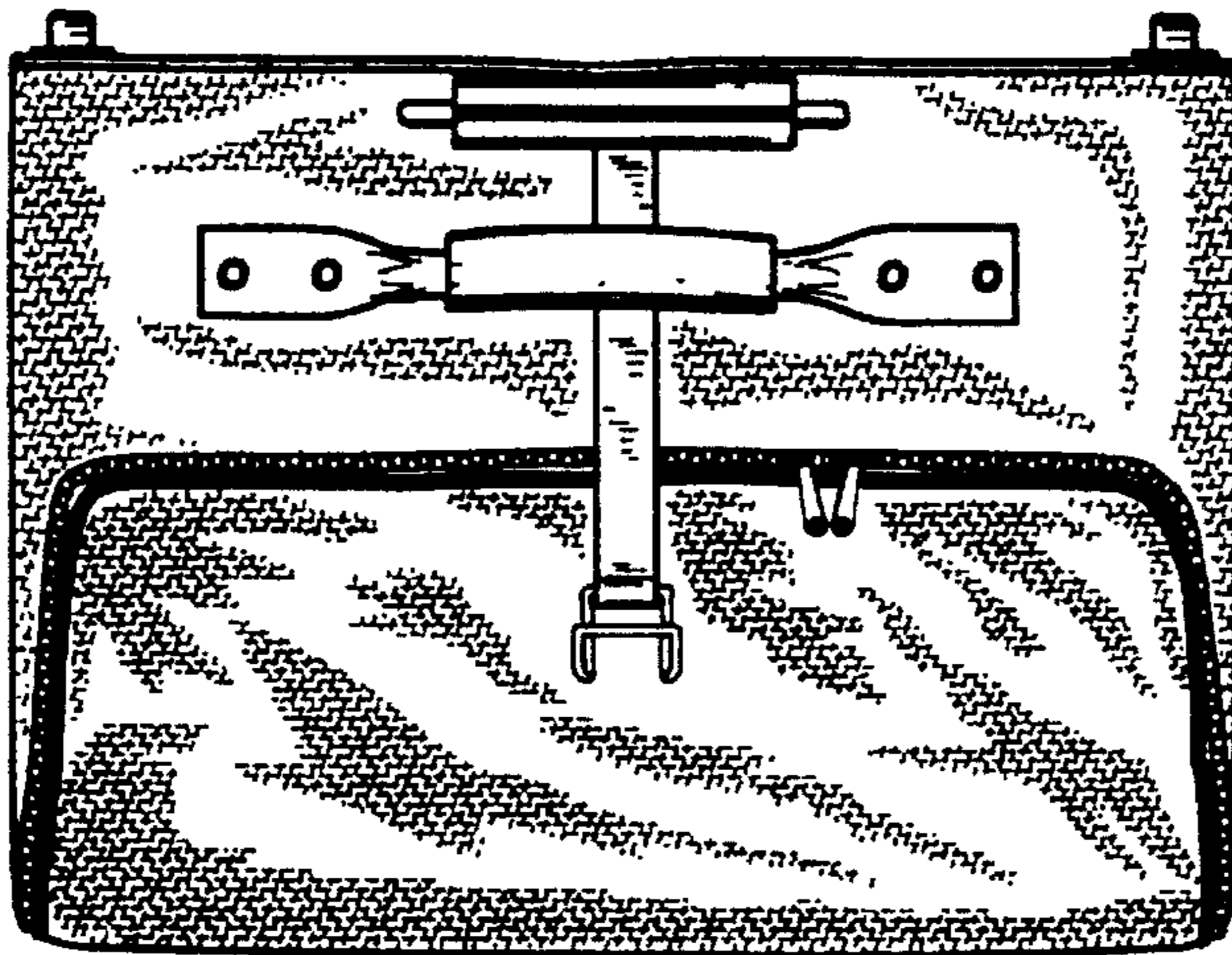

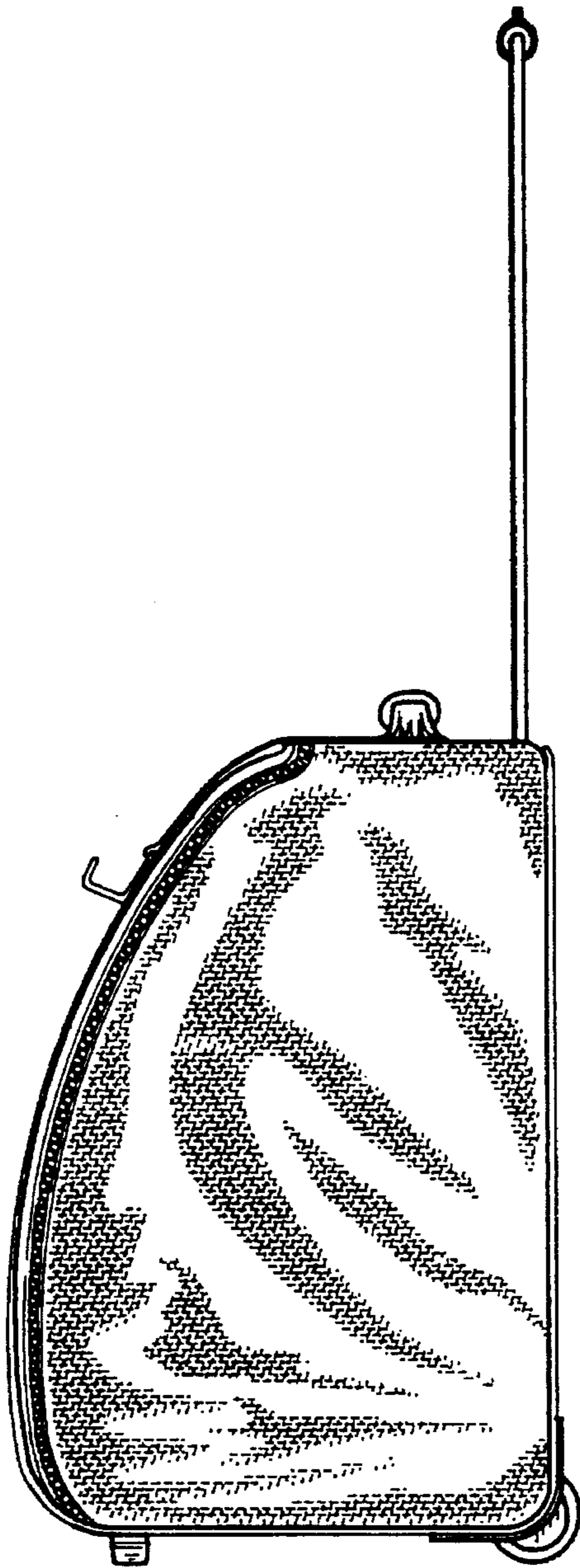

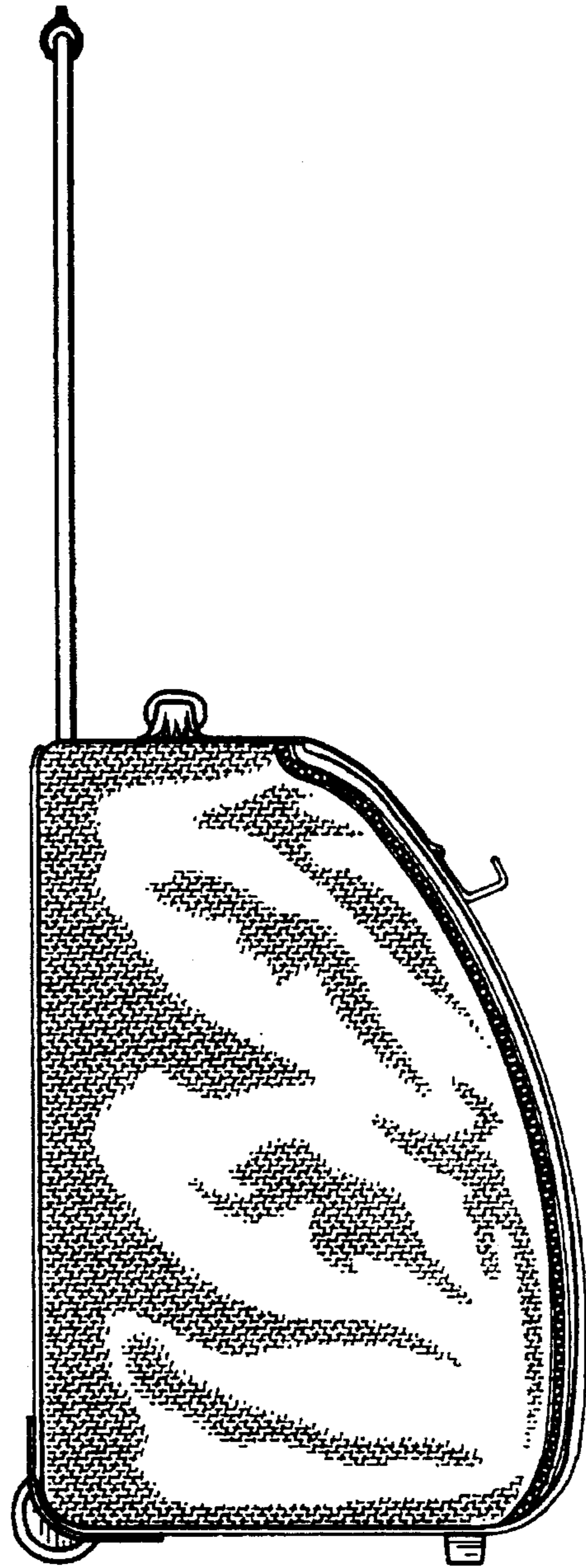

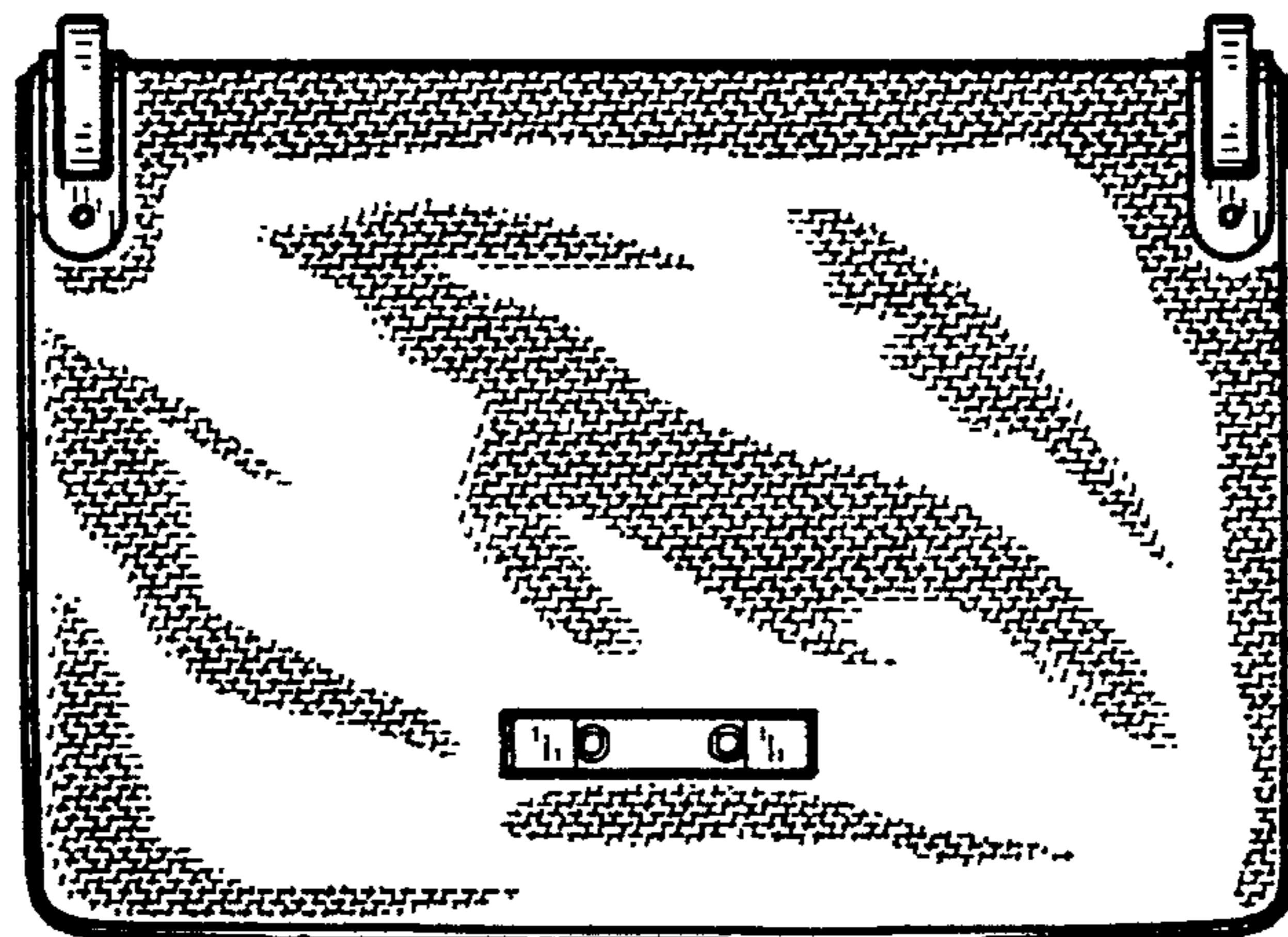
