[57] **CLAIM**

The ornamental design for a cosmetic dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a cosmetic dispenser showing our new design; FIG. 2 is a side elevational view thereof, the opposite side being the same; FIG. 3 is a top plan view thereof; FIG. 4 is a front elevational view thereof; FIG. 5 is a rear elevational view thereof; and, FIG. 6 is a bottom plan view thereof, the broken lines being for illustrative purposes and forming no part of the claimed design.

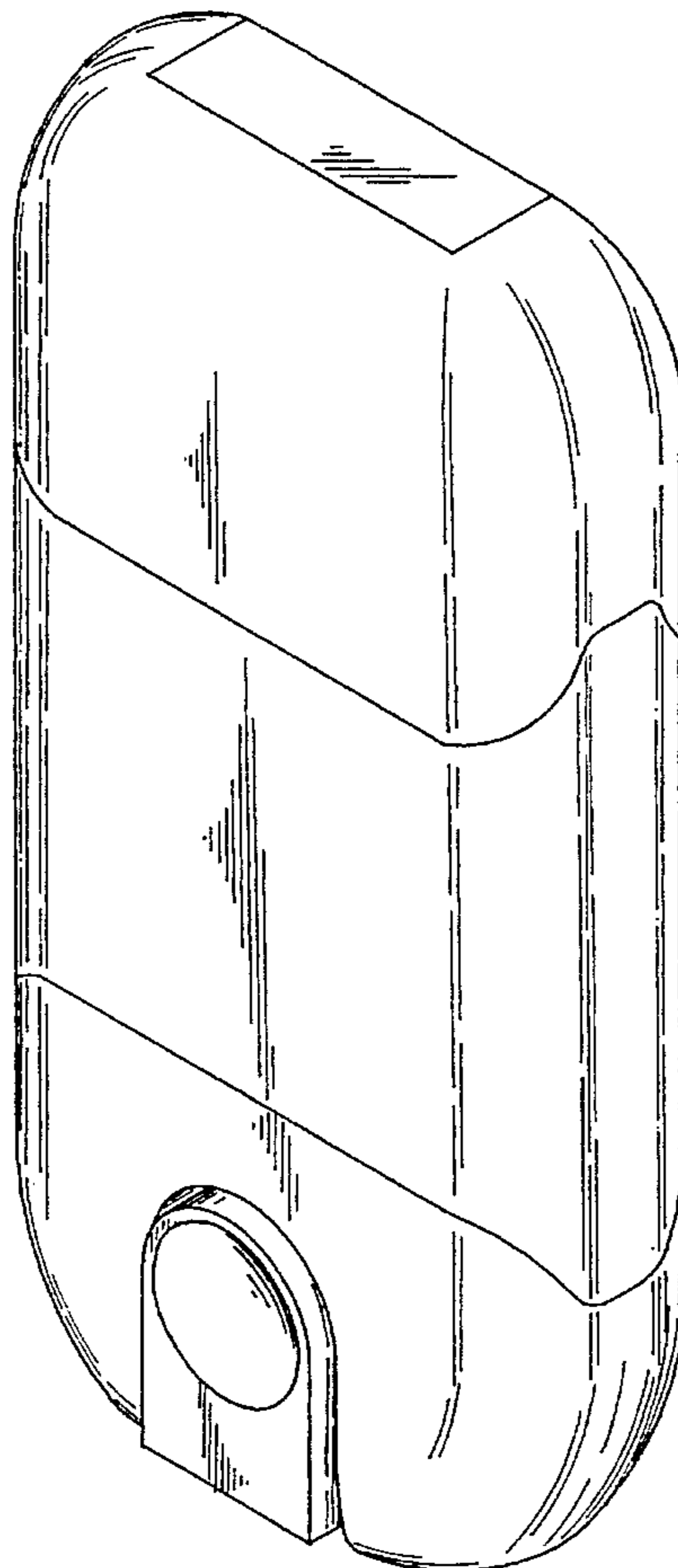

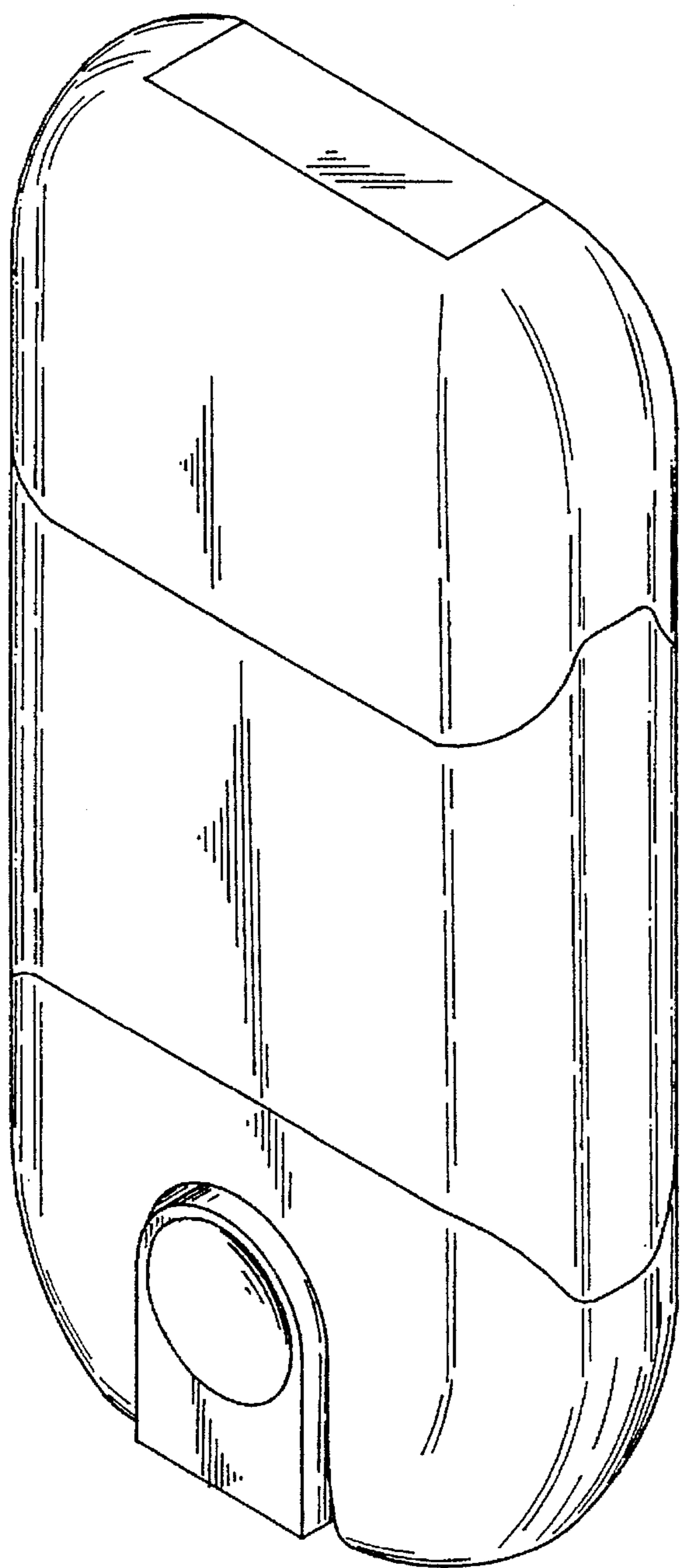

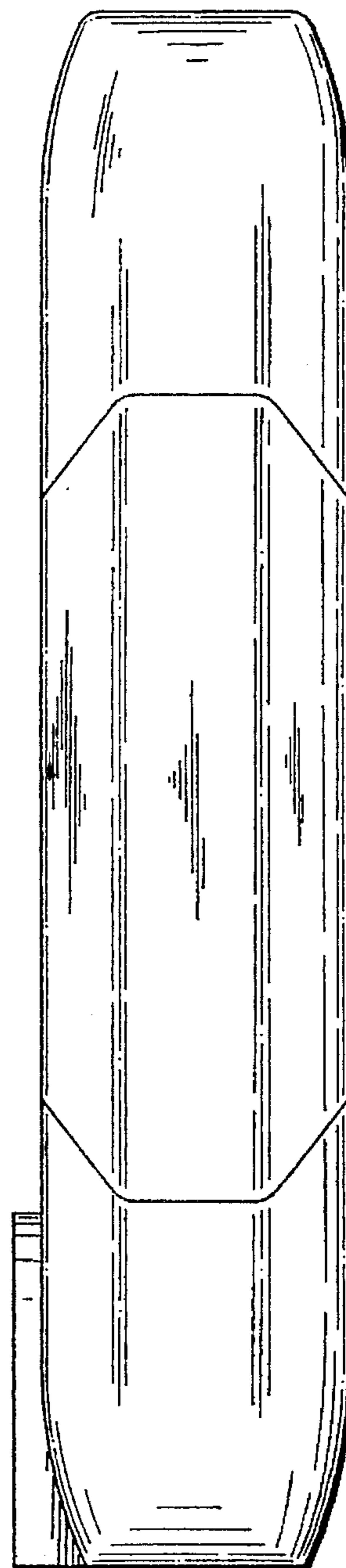

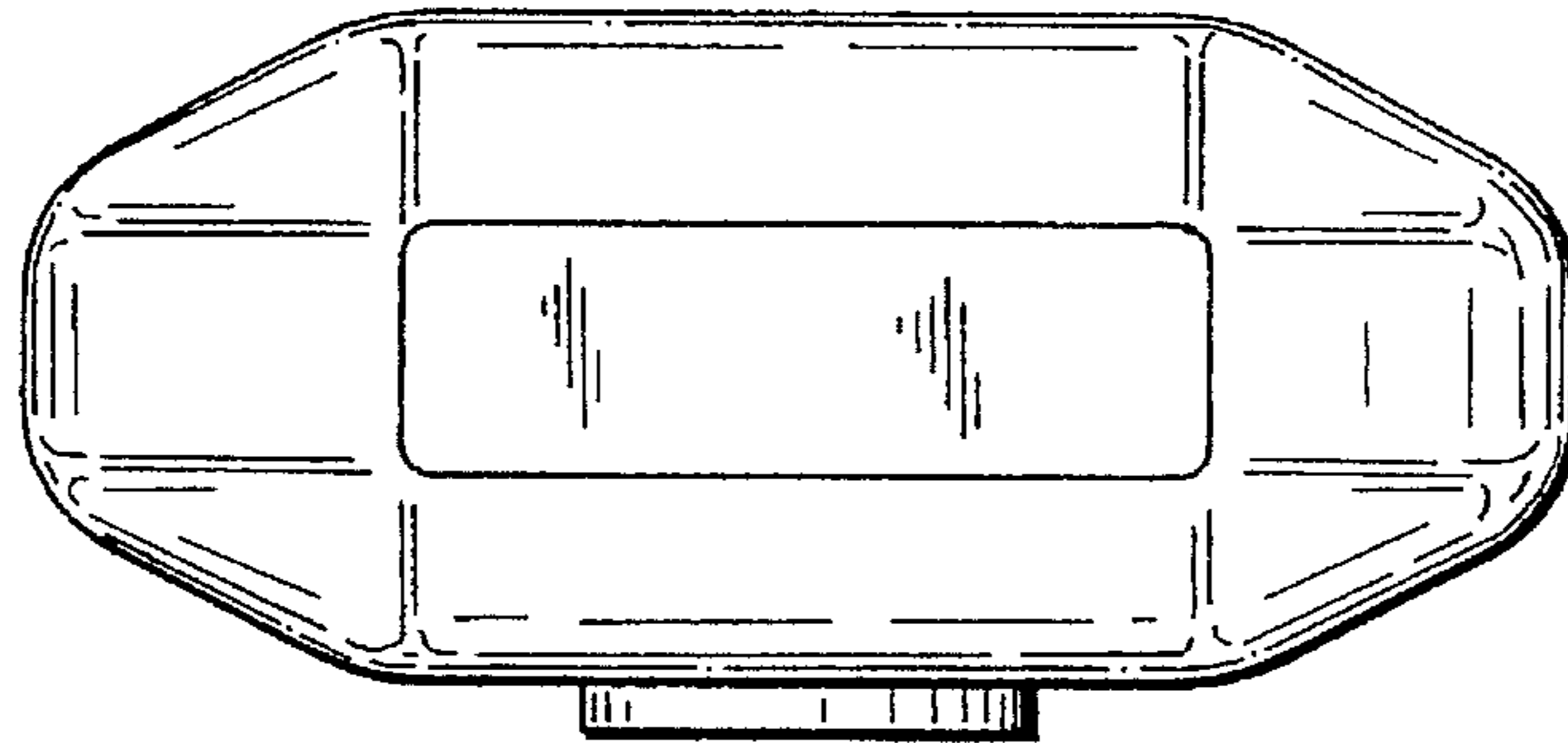

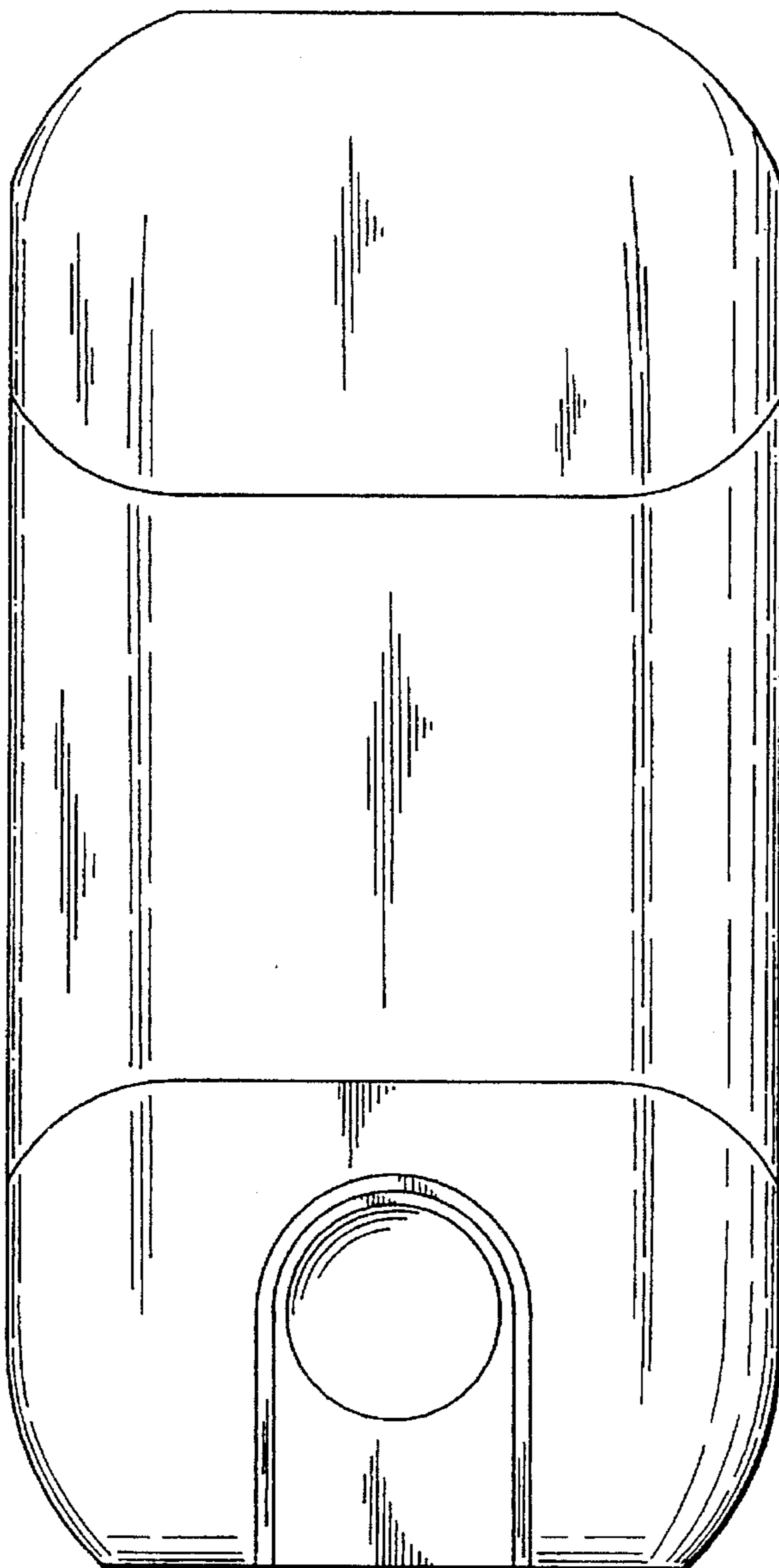

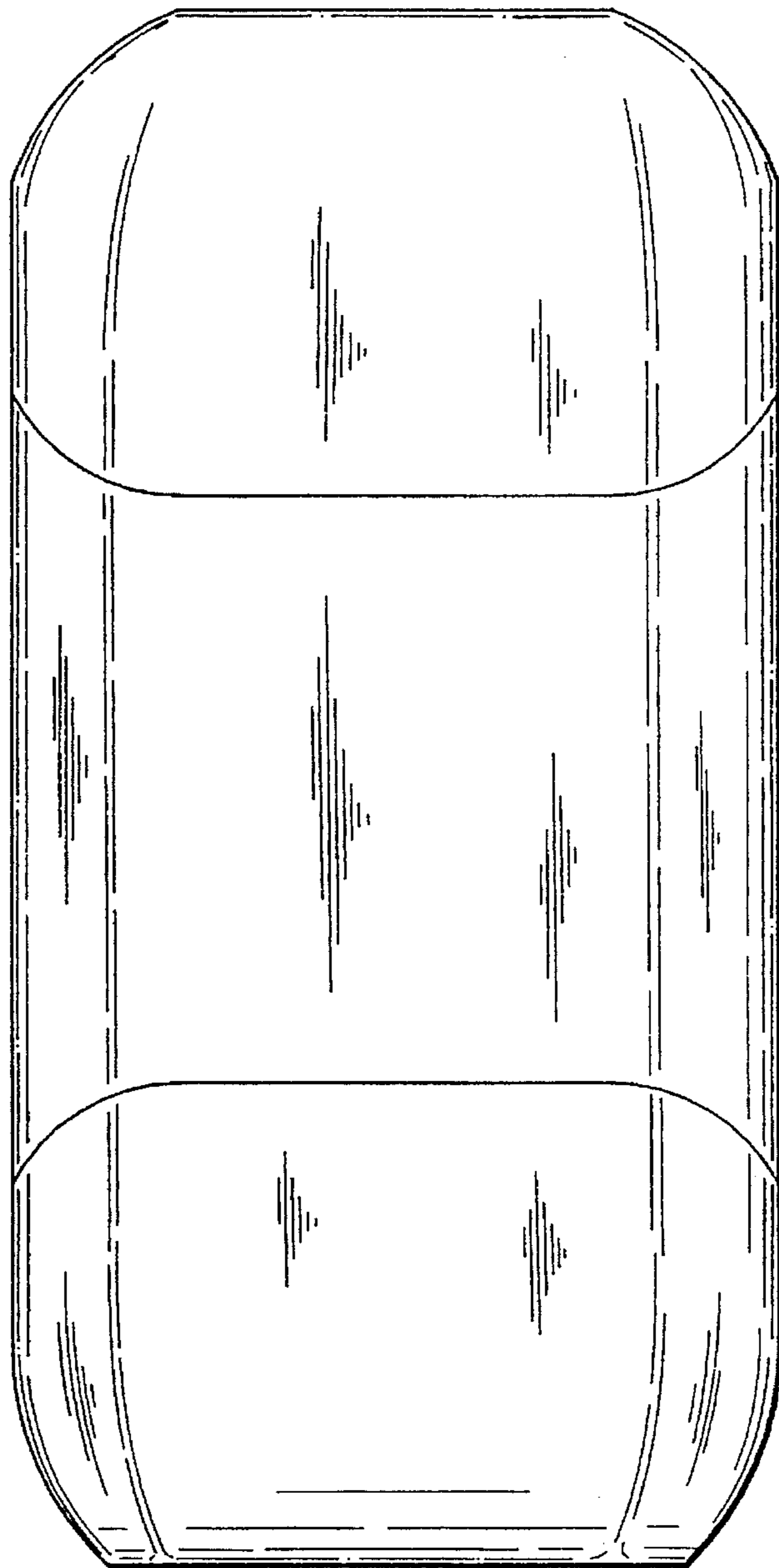
