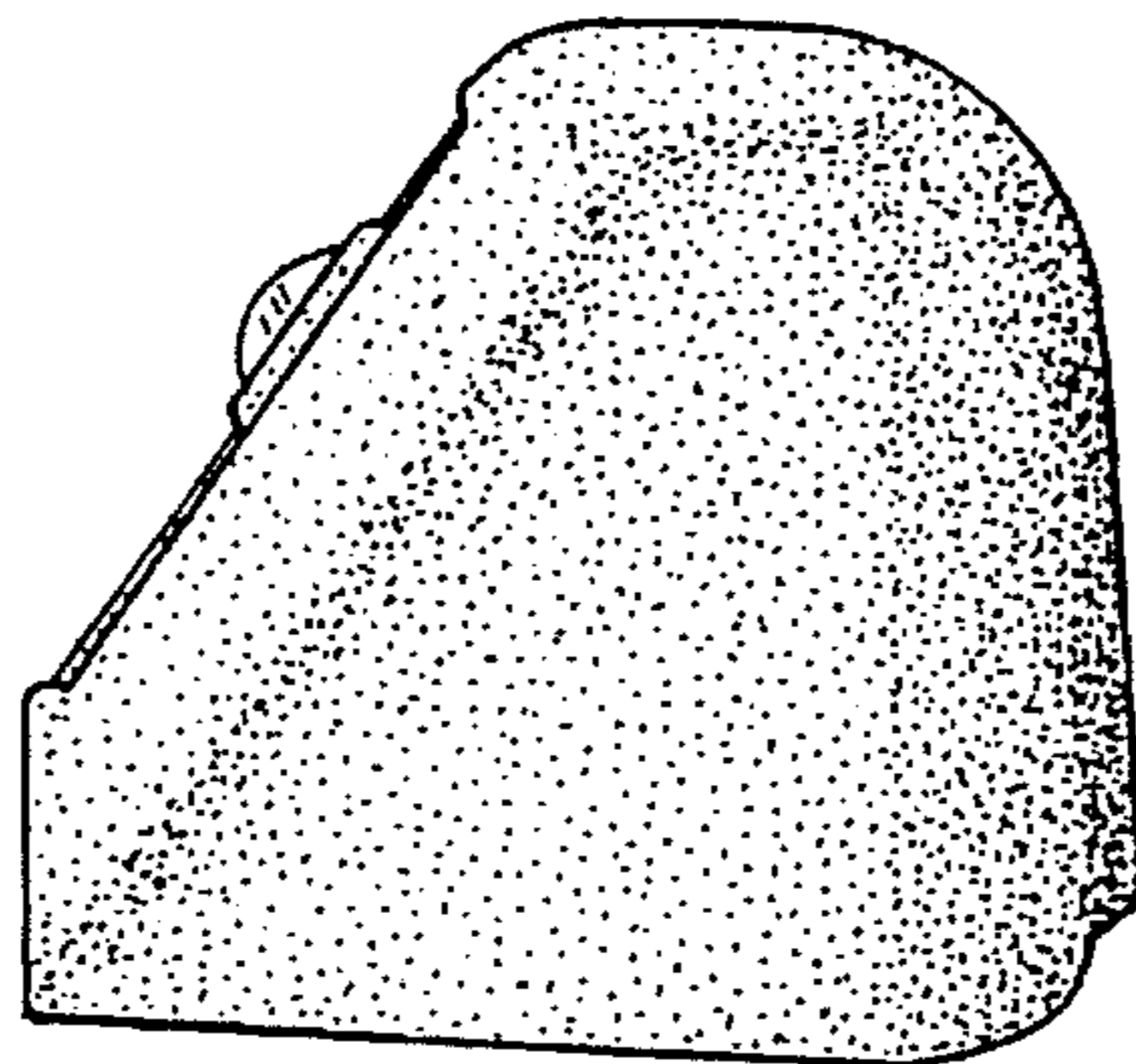
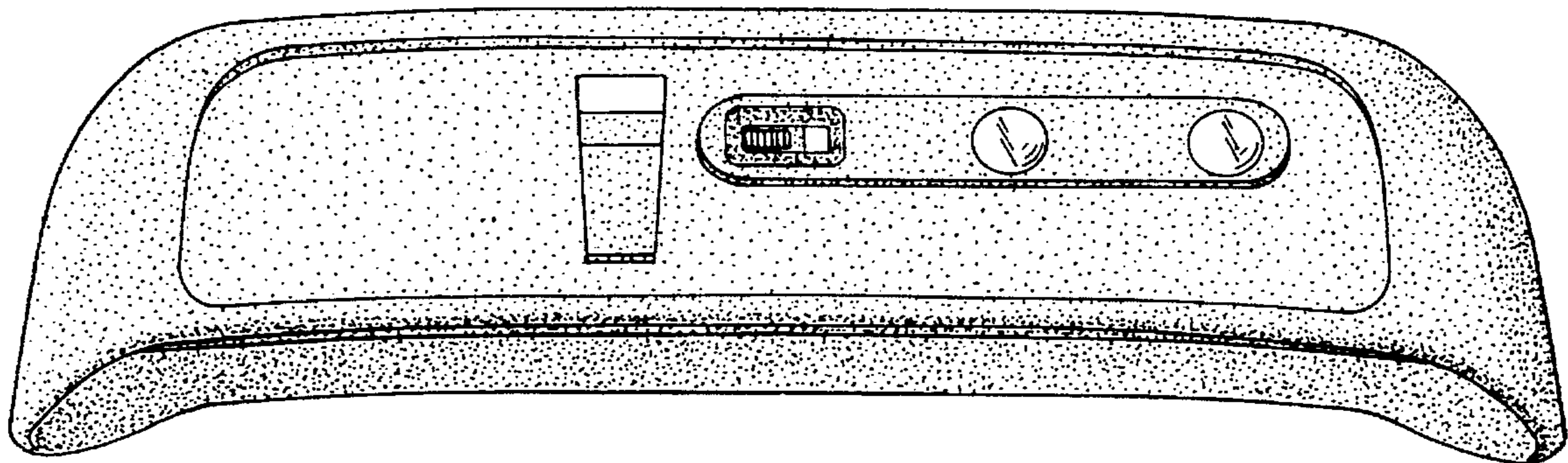
[57] CLAIM

The ornamental design of a vacuum cleaner top console, as shown and described.

DESCRIPTION

FIG. 1 is a top view of a vacuum cleaner top console showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a left end view thereof;
FIG. 5 is a right end view thereof;
FIG. 6 is a rear elevational view thereof; and,

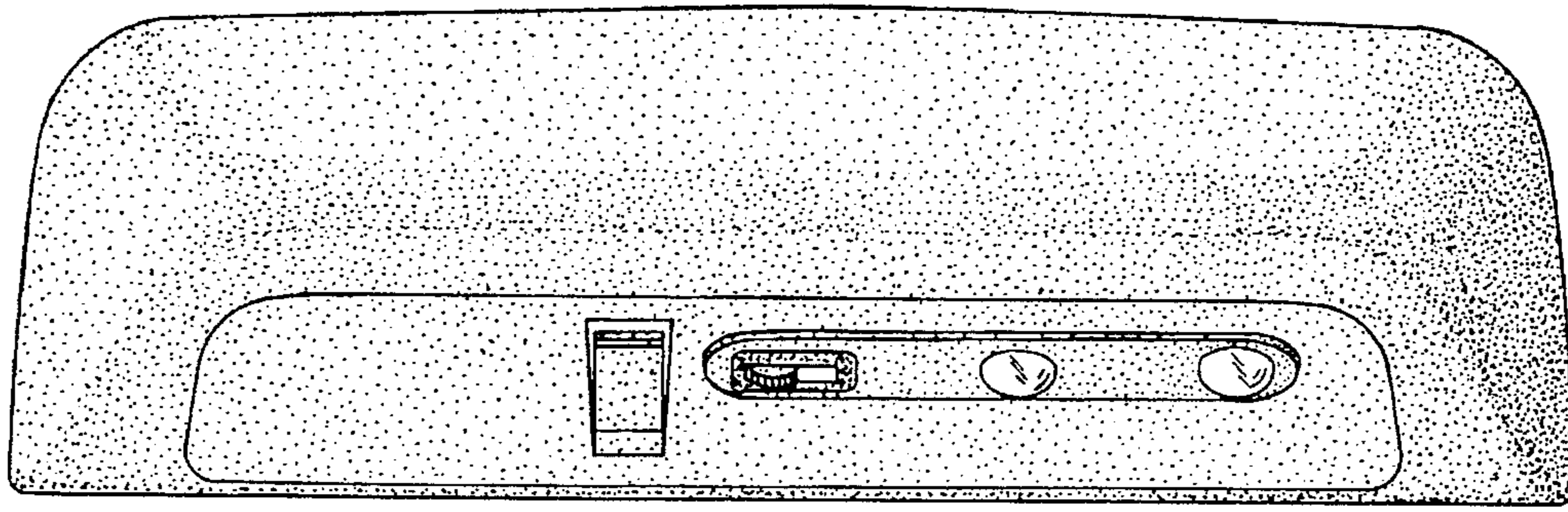

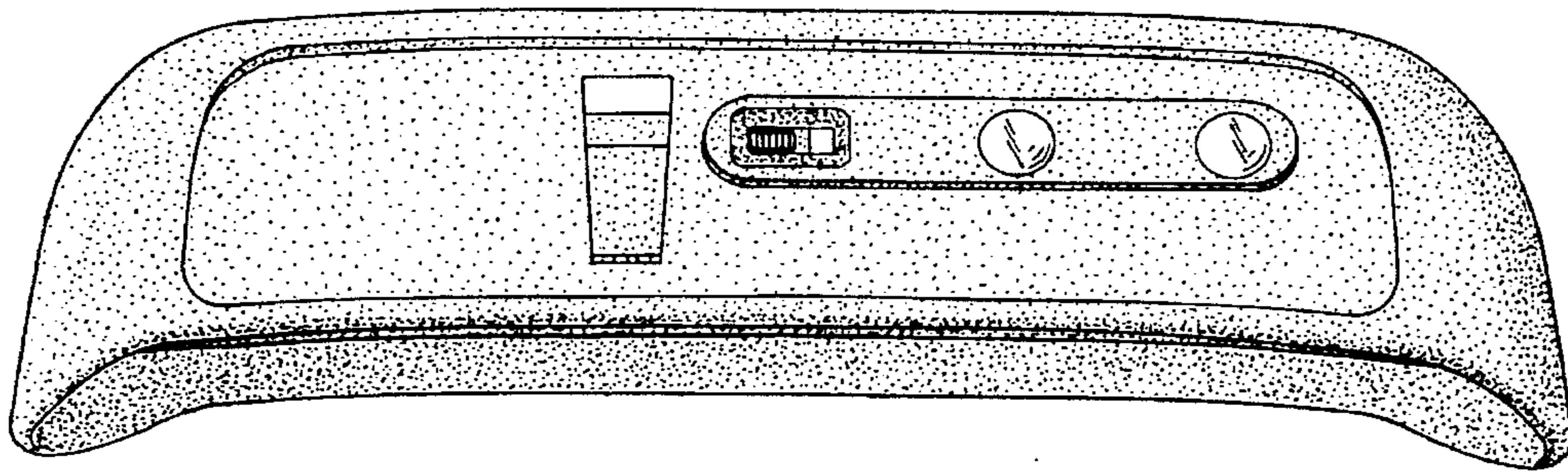

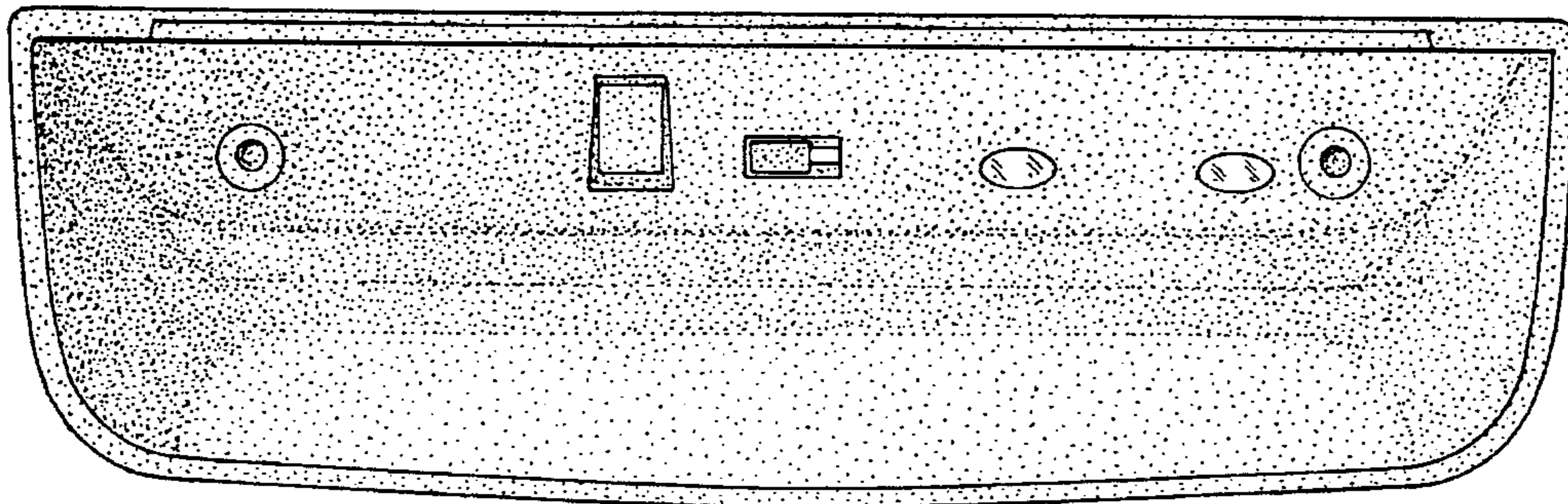

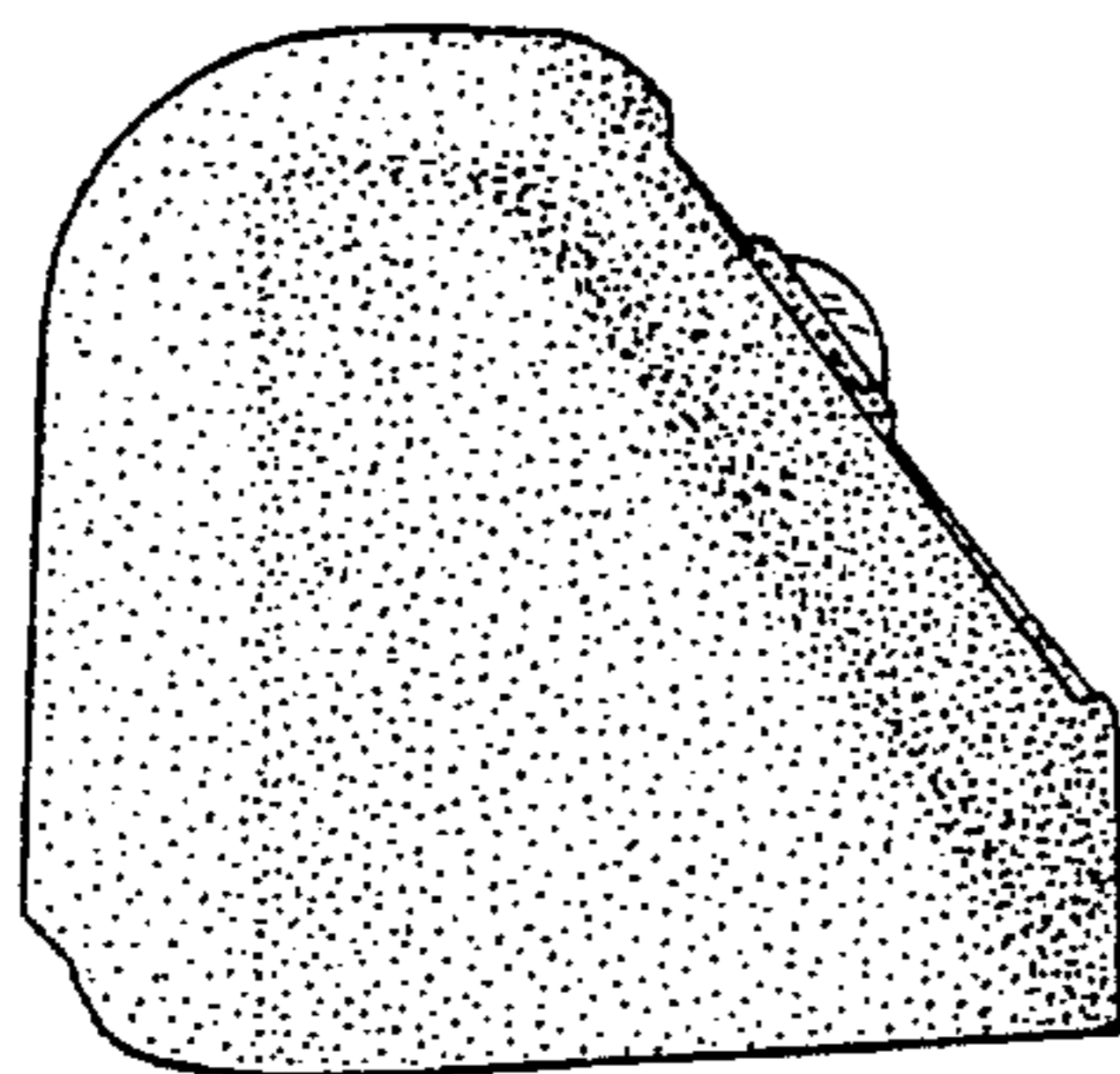

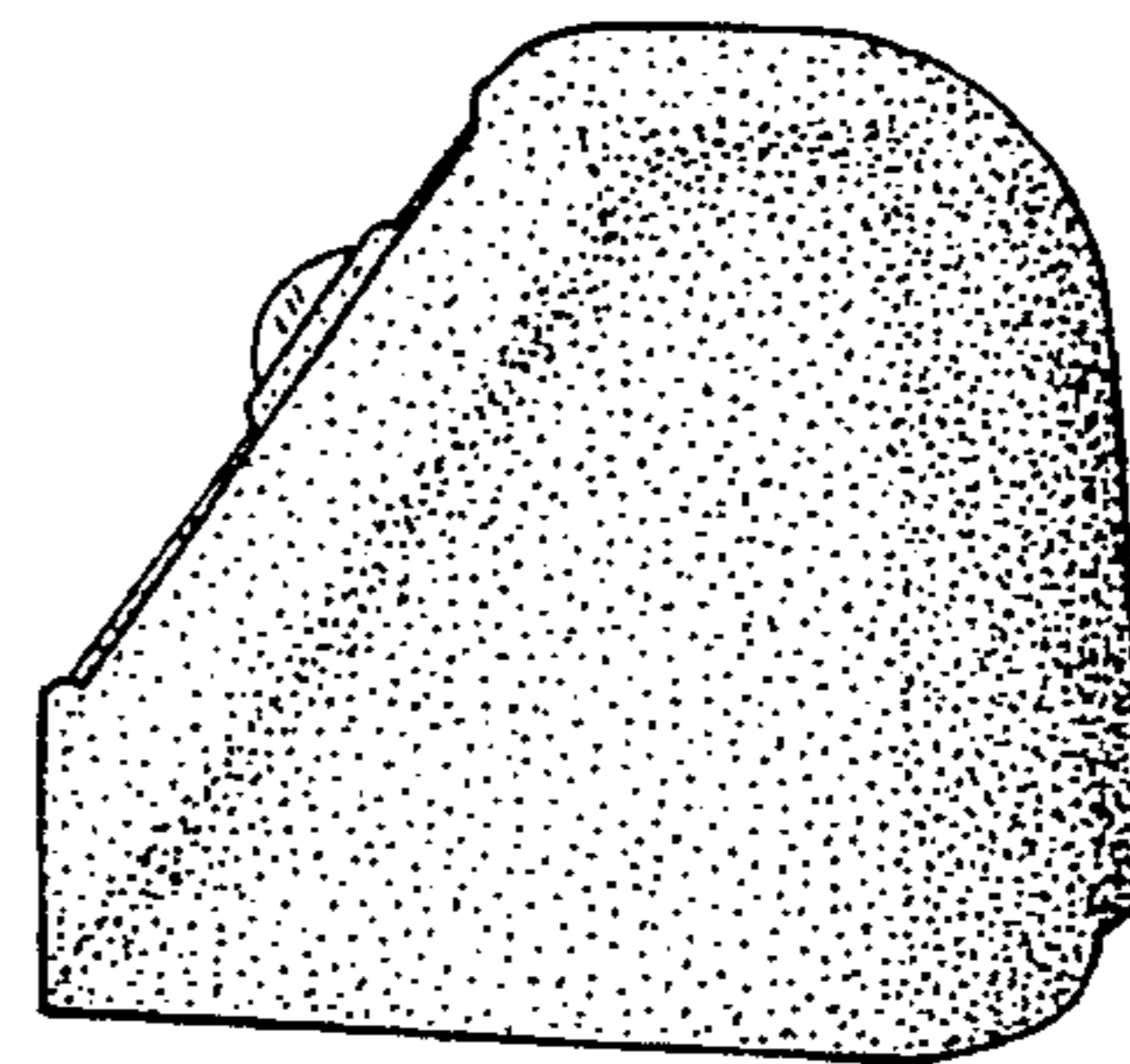

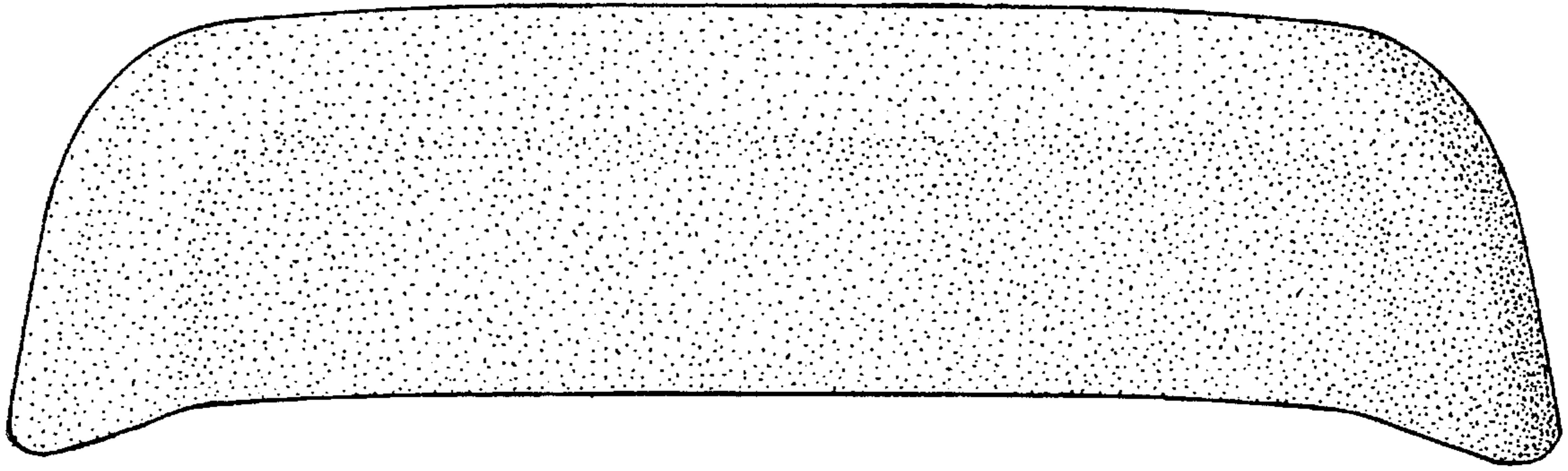
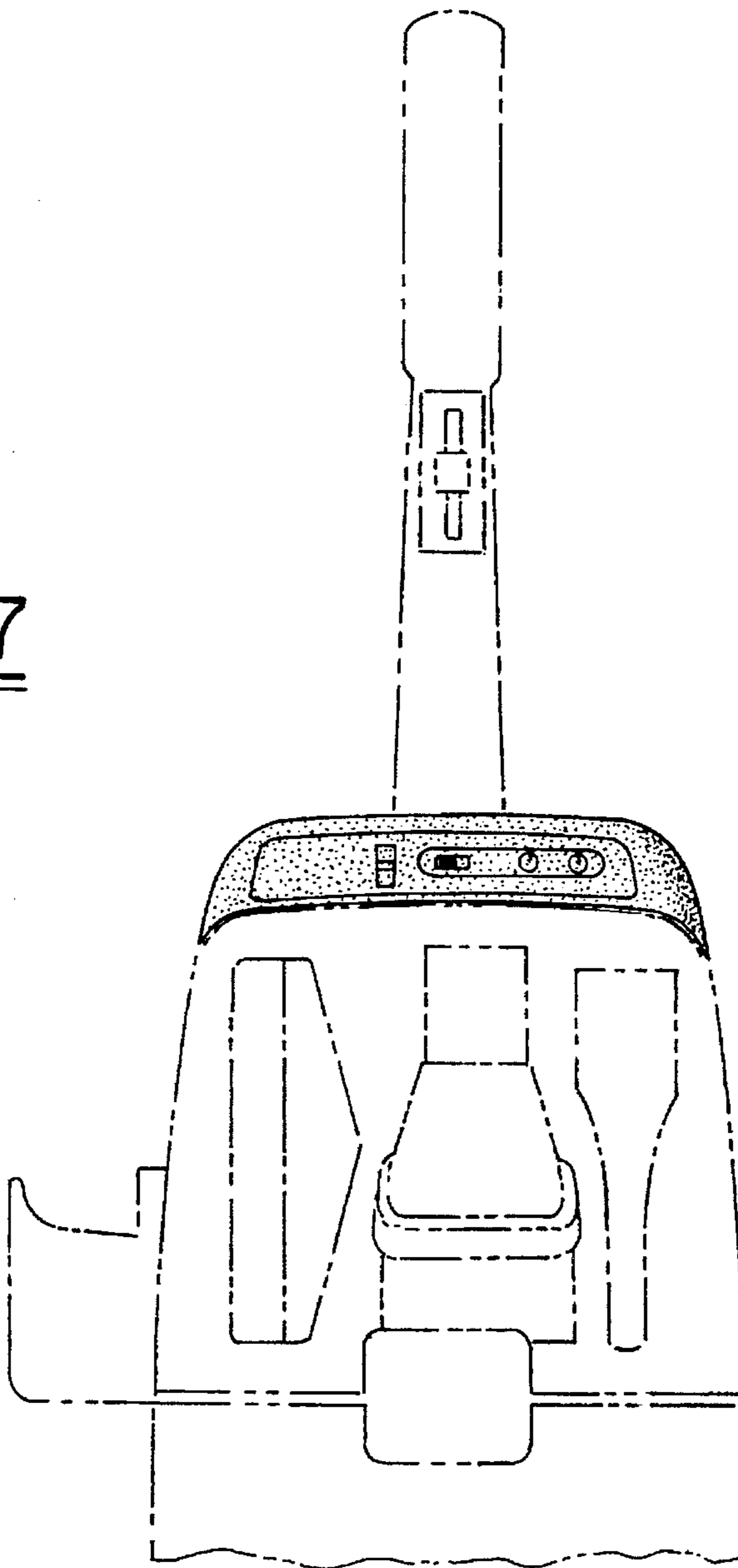
