The ornamental design for a patient garment as shown.

DESCRIPTION

FIG. 1 is a front view of a patient garment showing my new design, with two portions of a front panel portion of the garment shown unbuttoned and folded back to show portions of a rear panel;

FIG. 2 is a rear view of said patient garment;

FIG. 3 is a left-side view of said patient garment;

FIG. 4 is a right-side view of said patient garment;

FIG. 5 is a top view of said patient garment; and,

FIG. 6 is a bottom view of said patient garment.

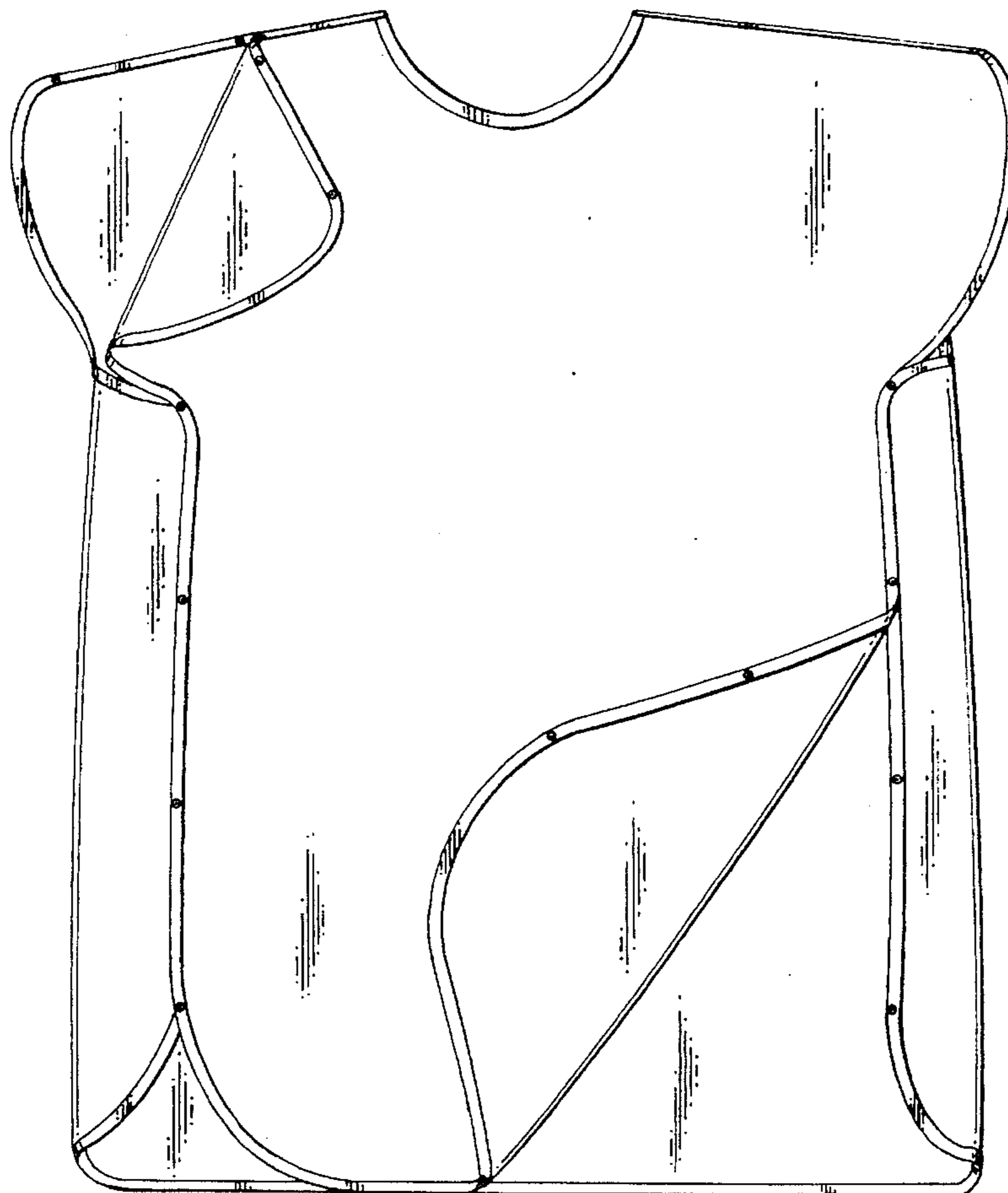

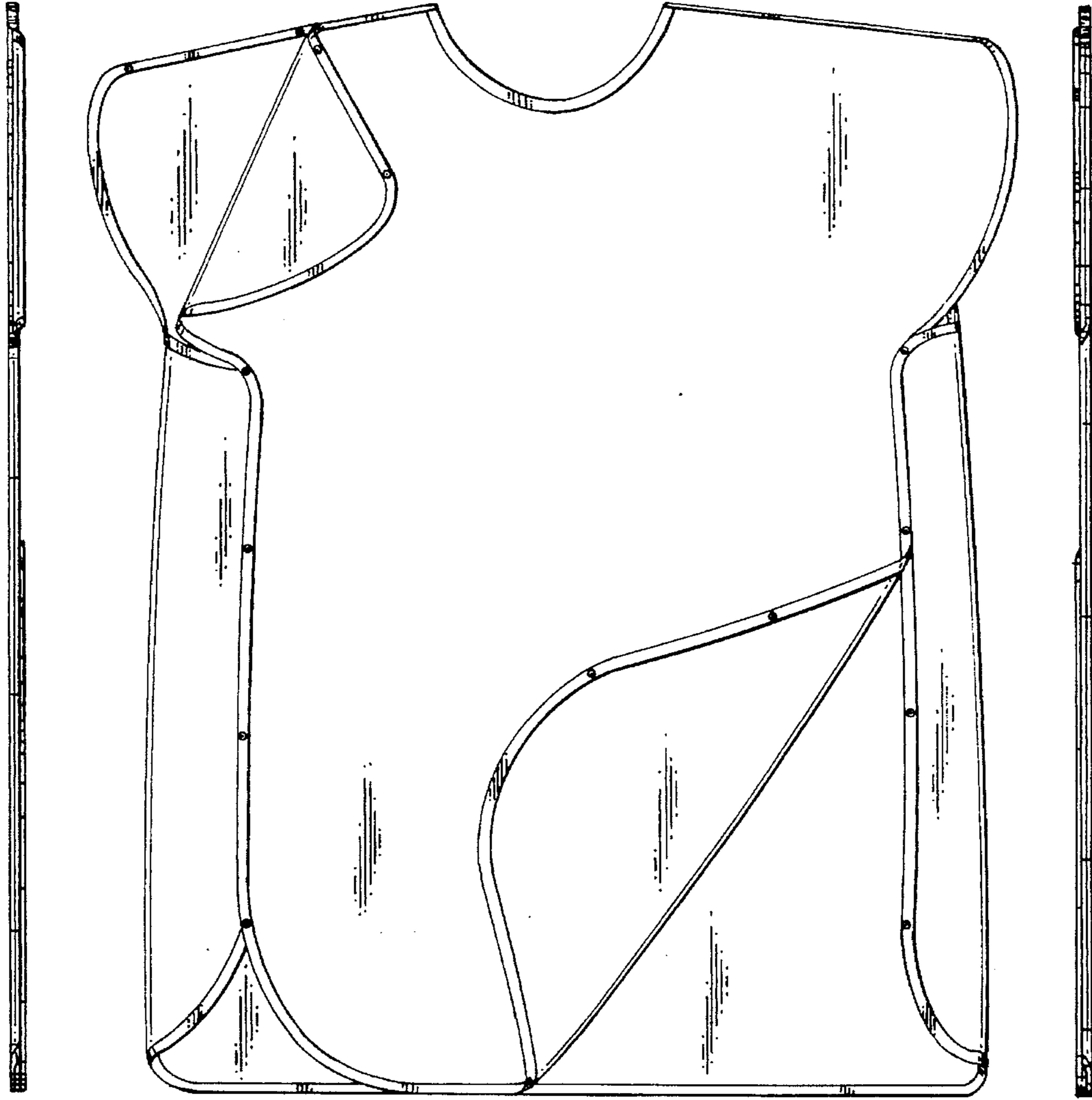

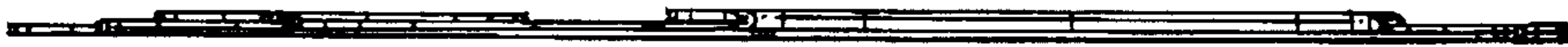

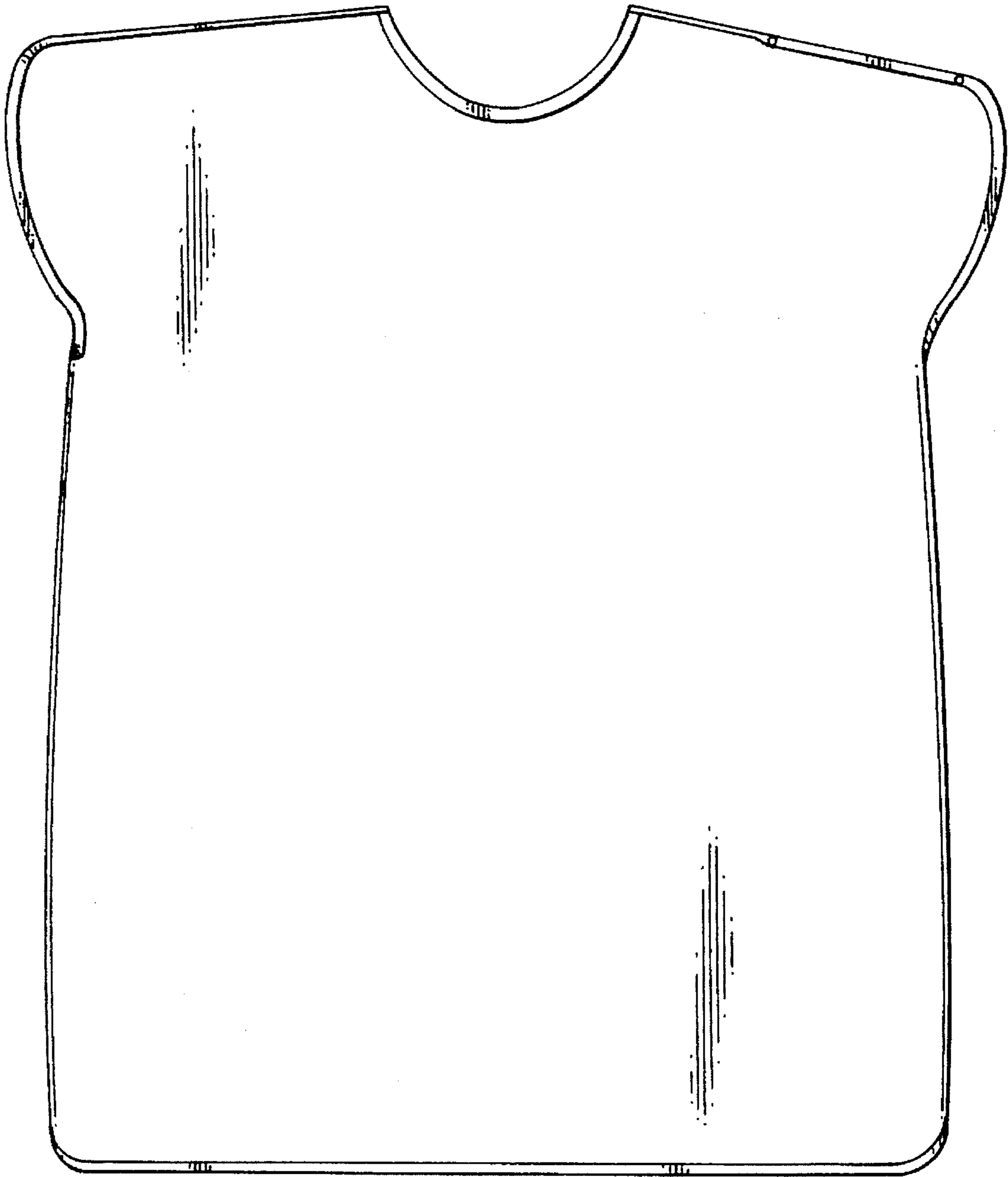
