The ornamental design for a beverage carrier, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a beverage carrier showing my new design with the strap broken away to indicate indeterminate length;
FIG. 2 is a rear plan view thereof with the strap fragmentally shown for ease of illustration;
FIG. 3 is a right side view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a top view thereof; and,
FIG. 6 is a bottom view thereof.

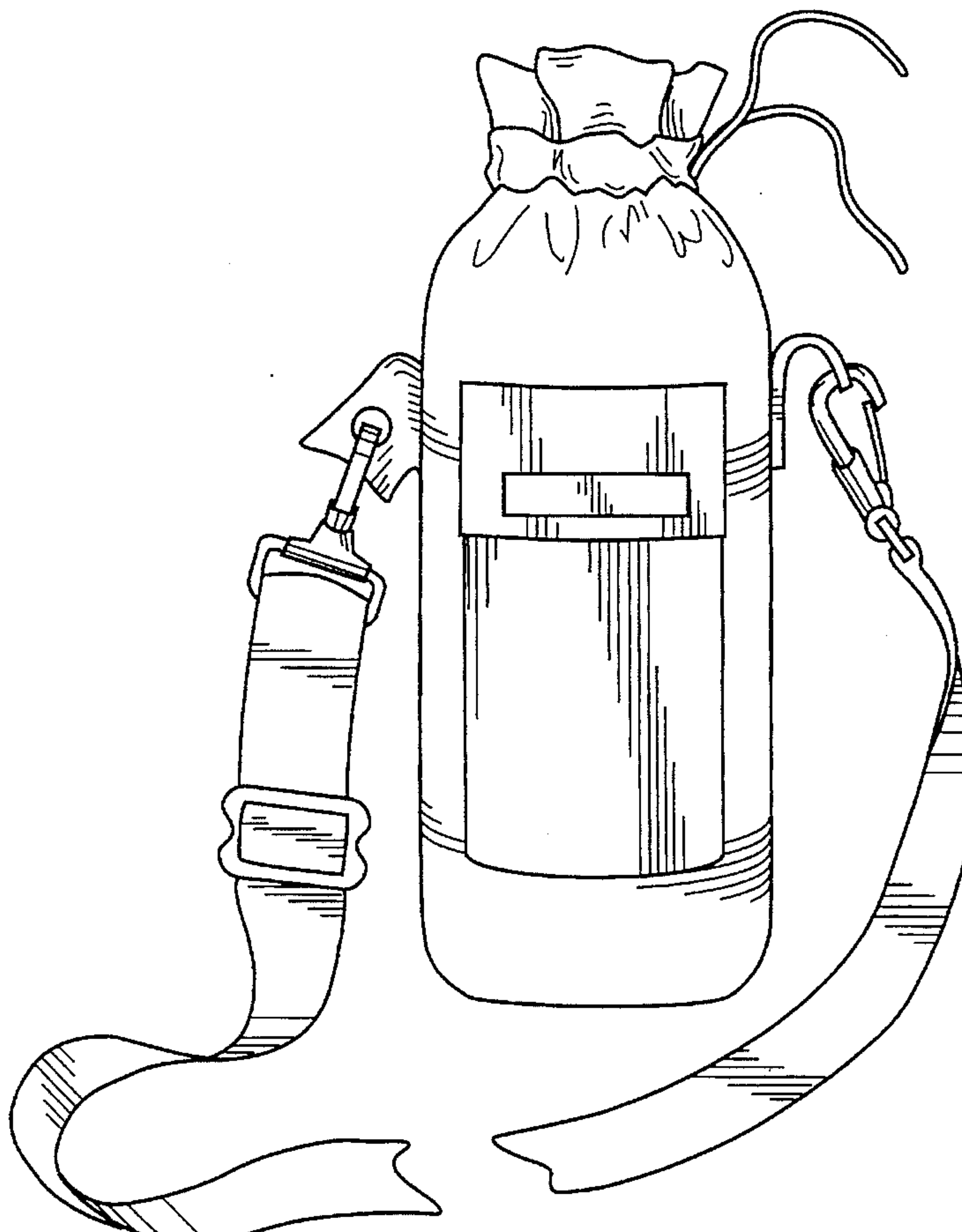
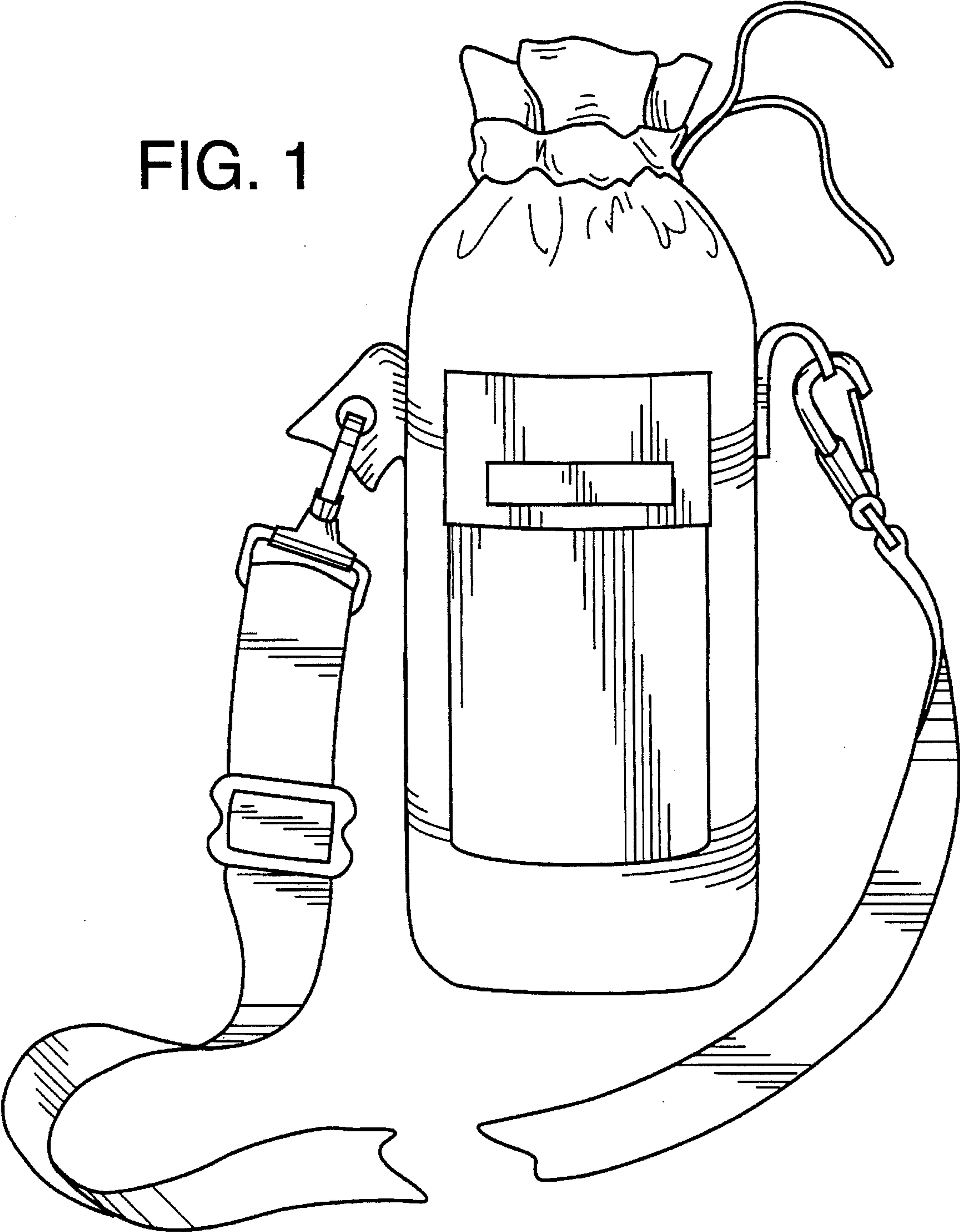

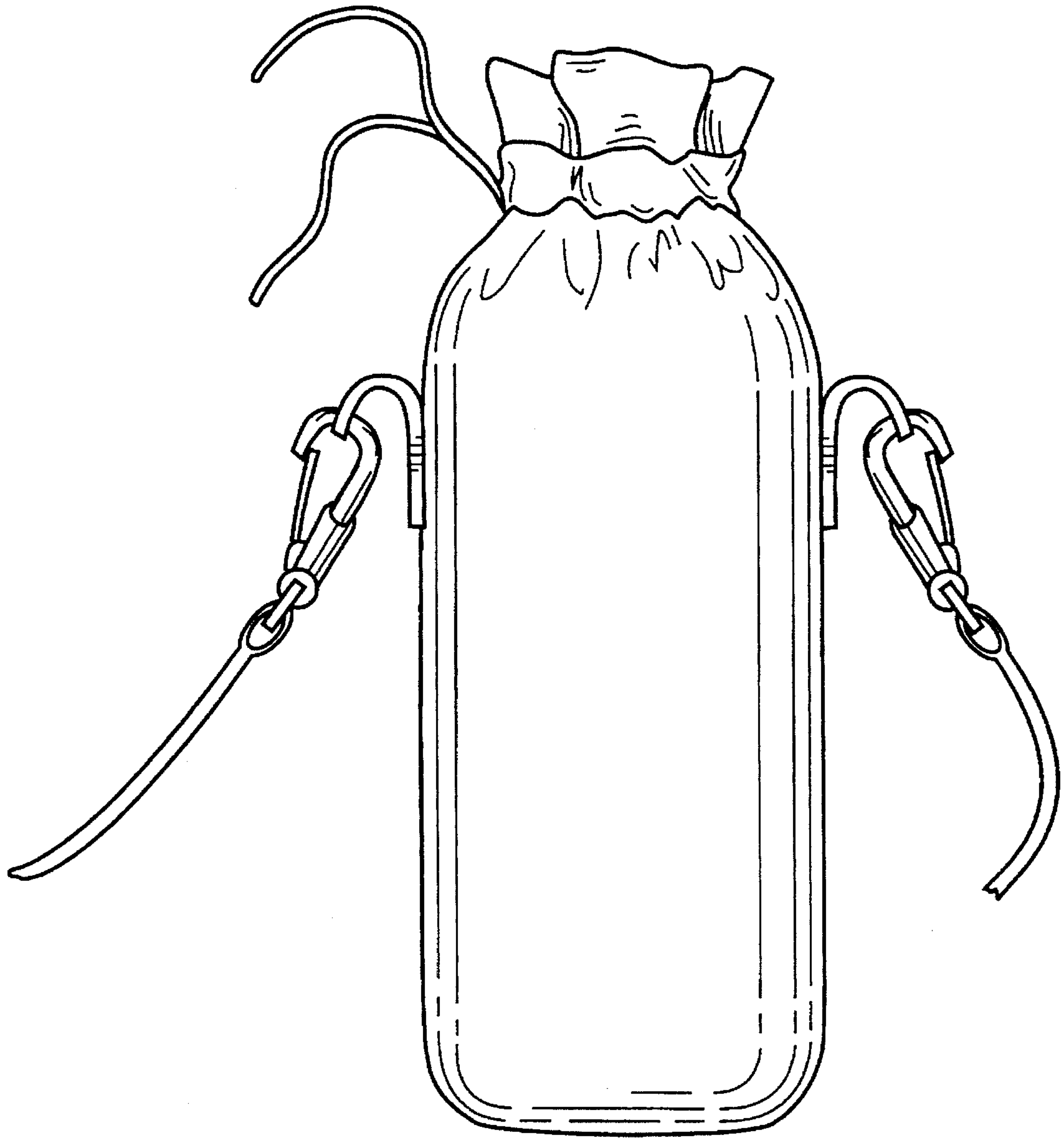

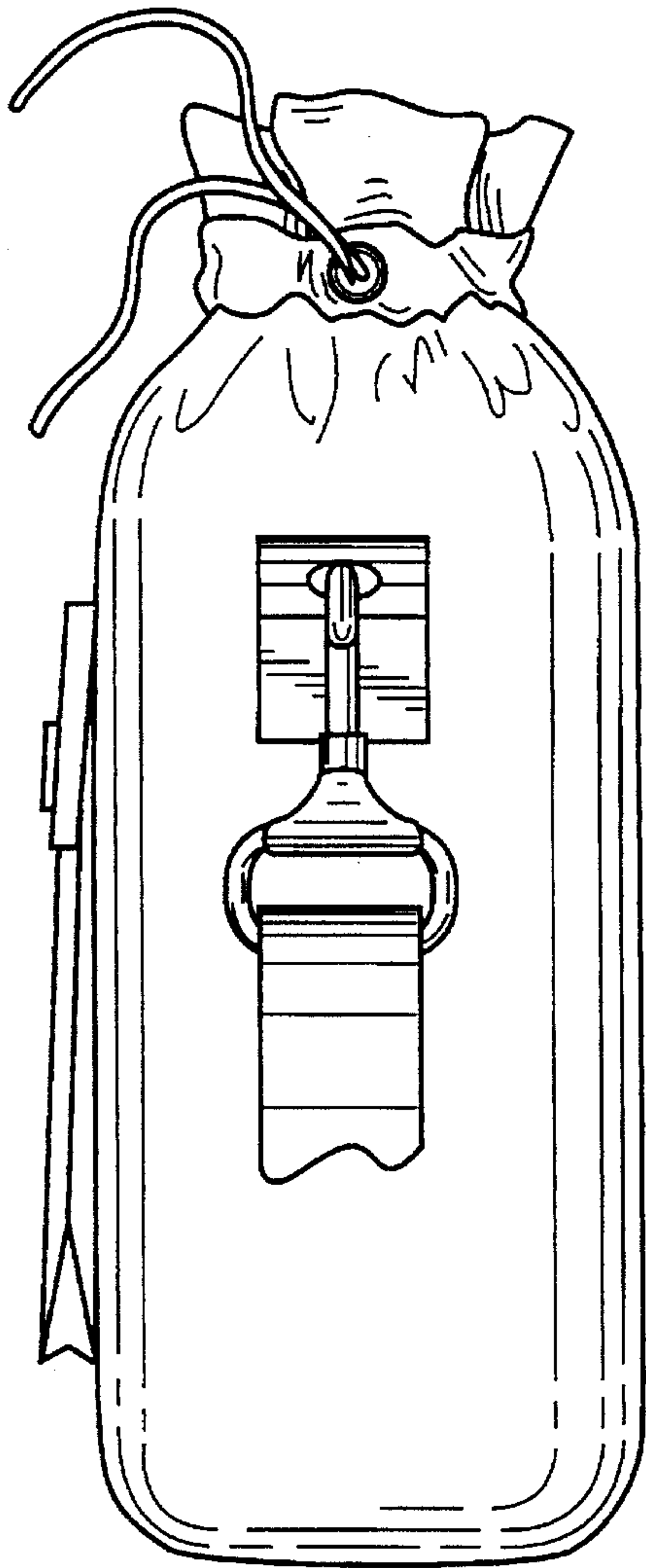

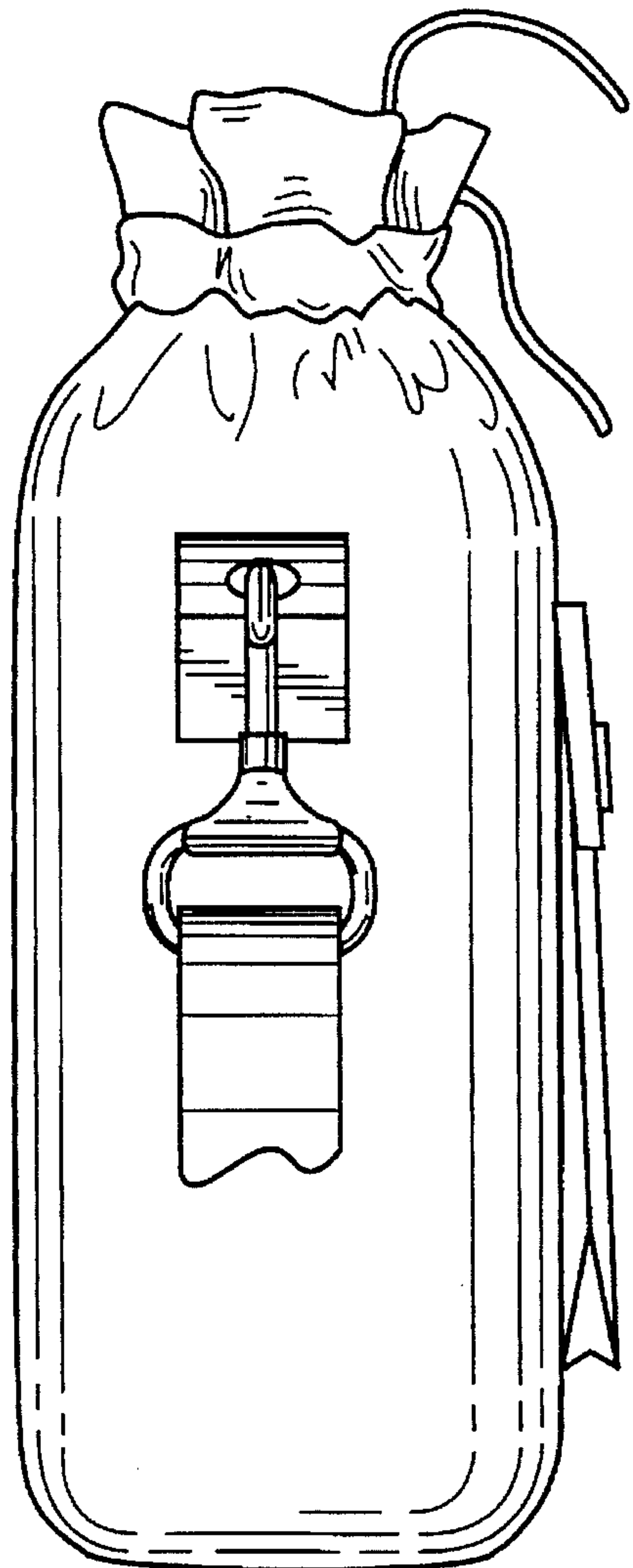

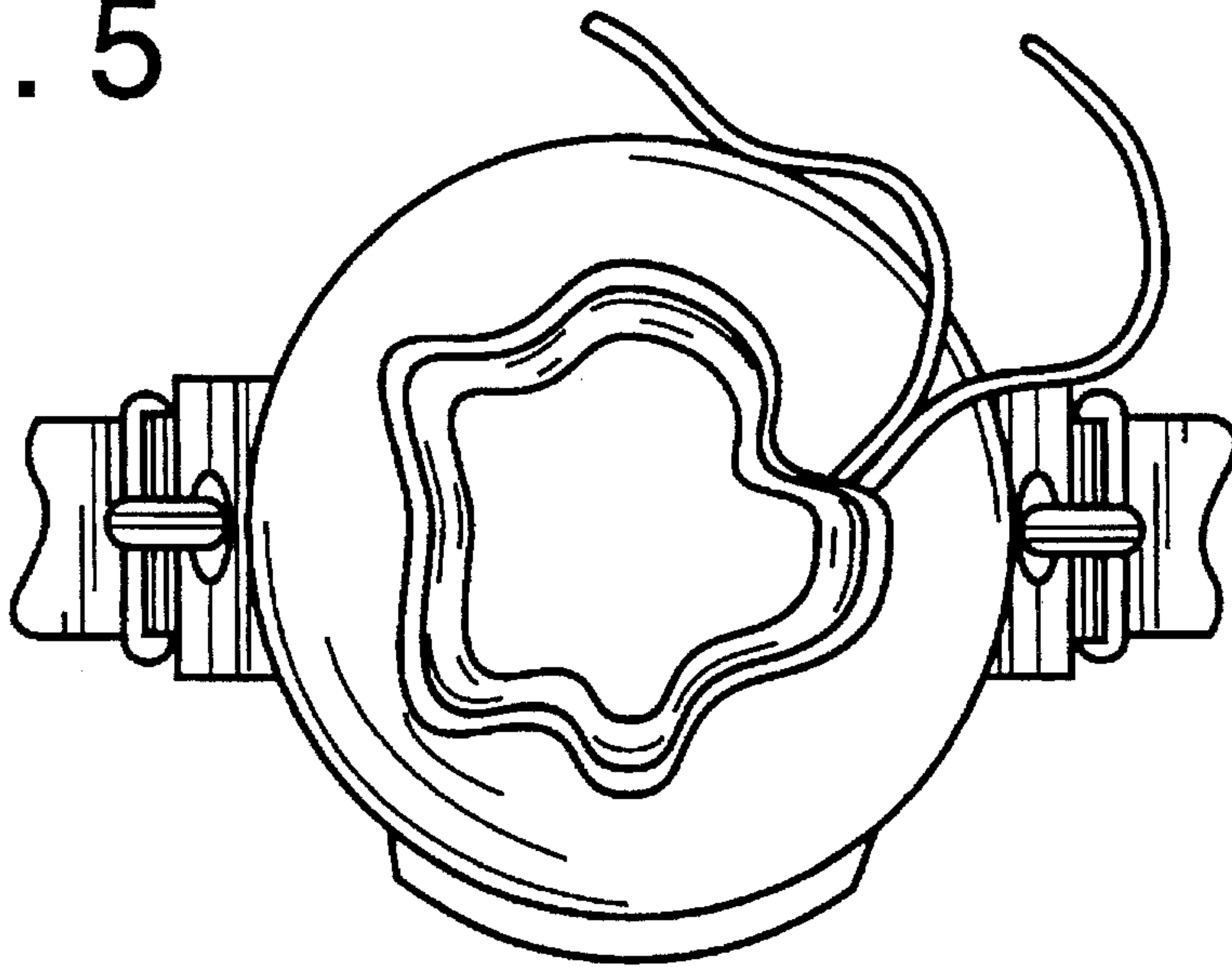
