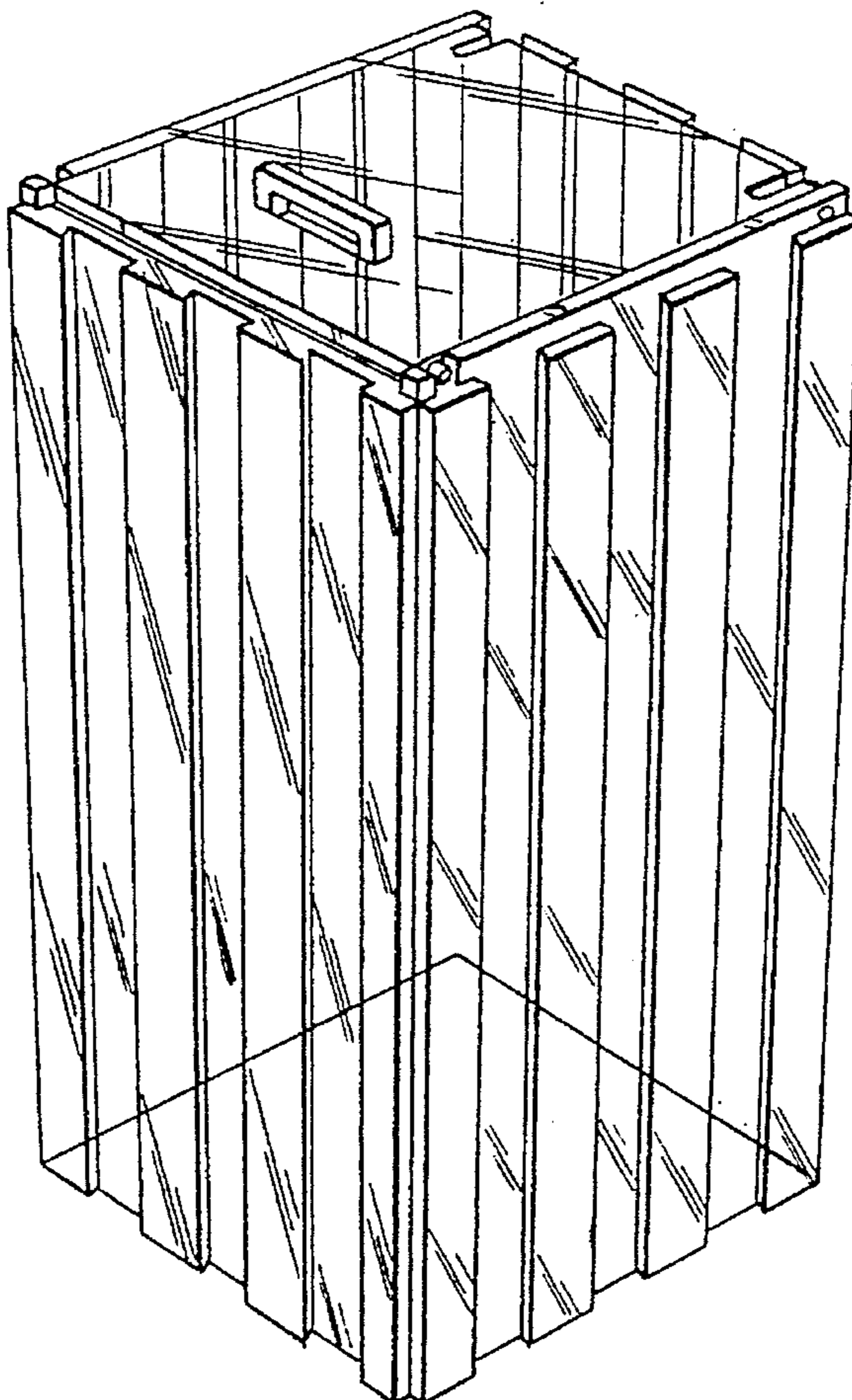

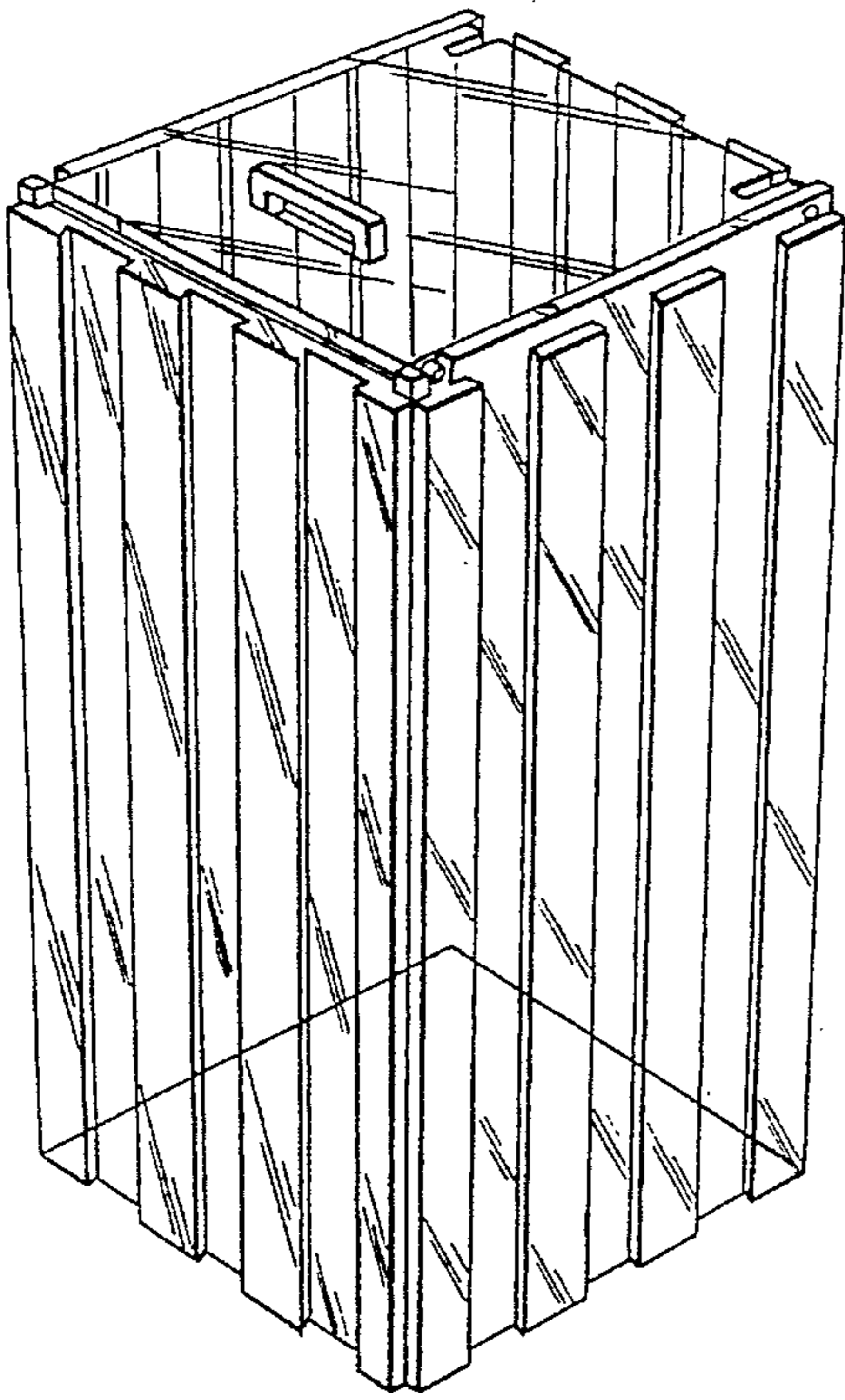

The broken lines showing of other units in FIGS. 3, 7, and 8 are for illustrative purposes only and form no part of the claimed design.

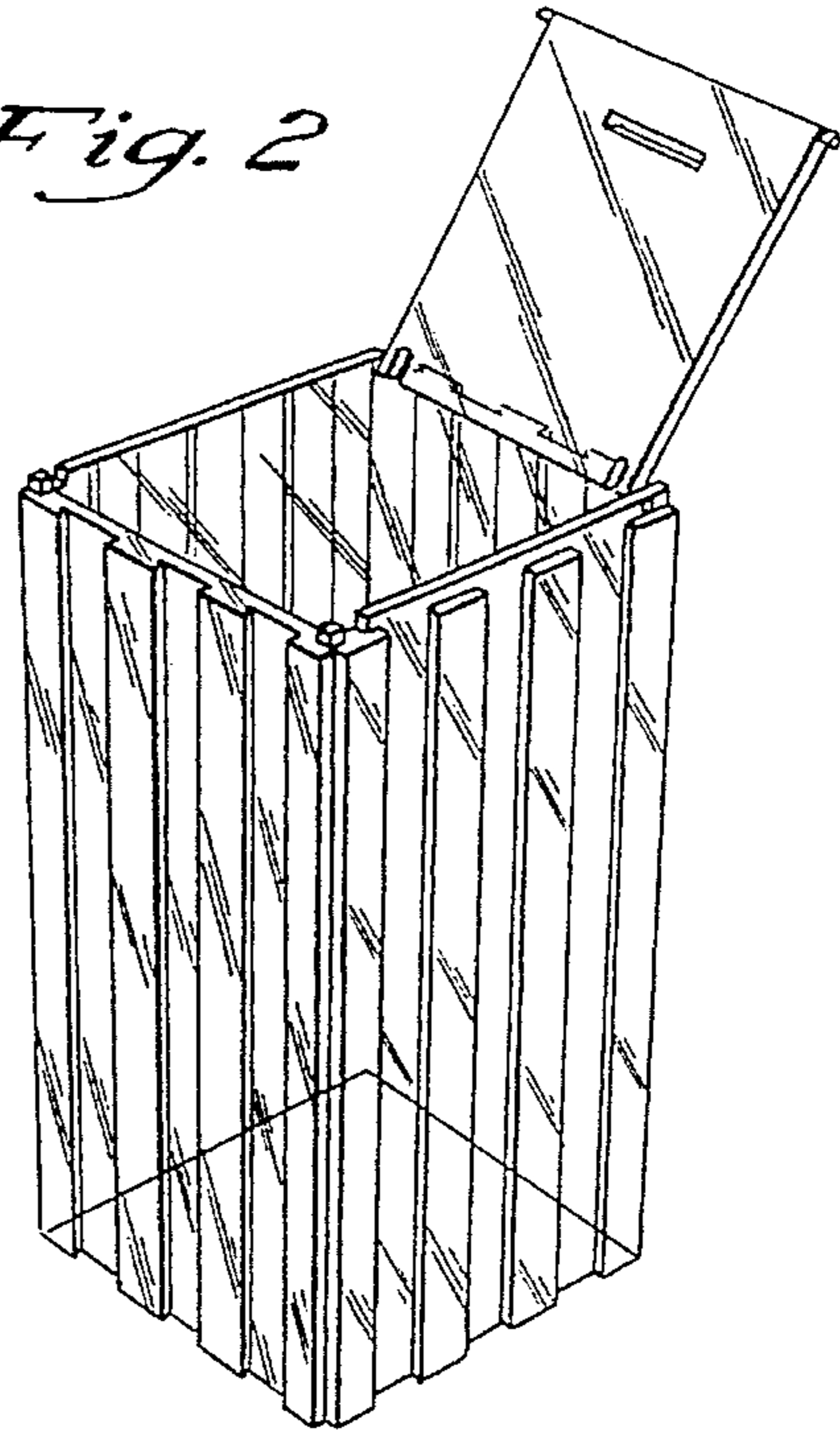

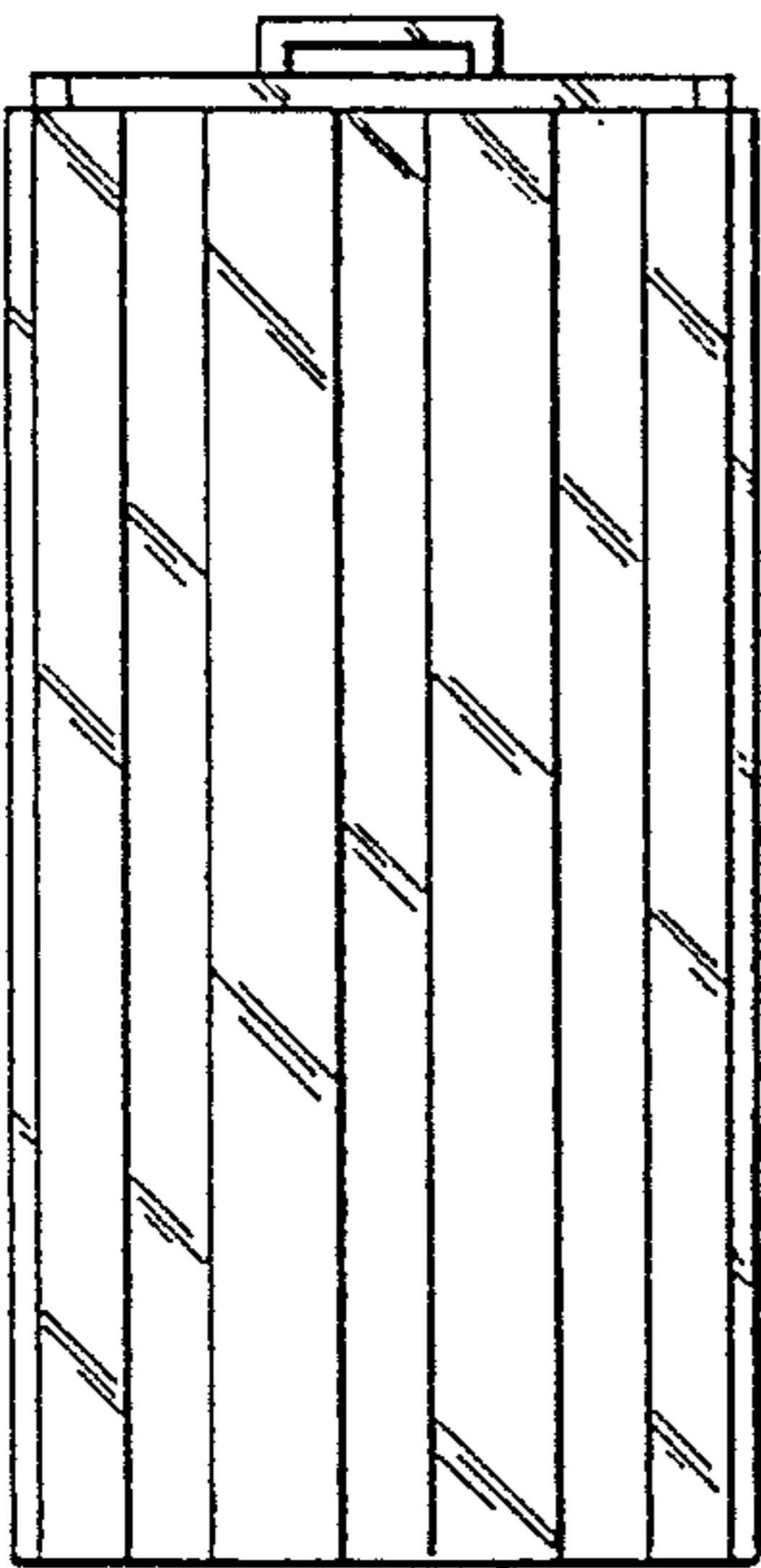
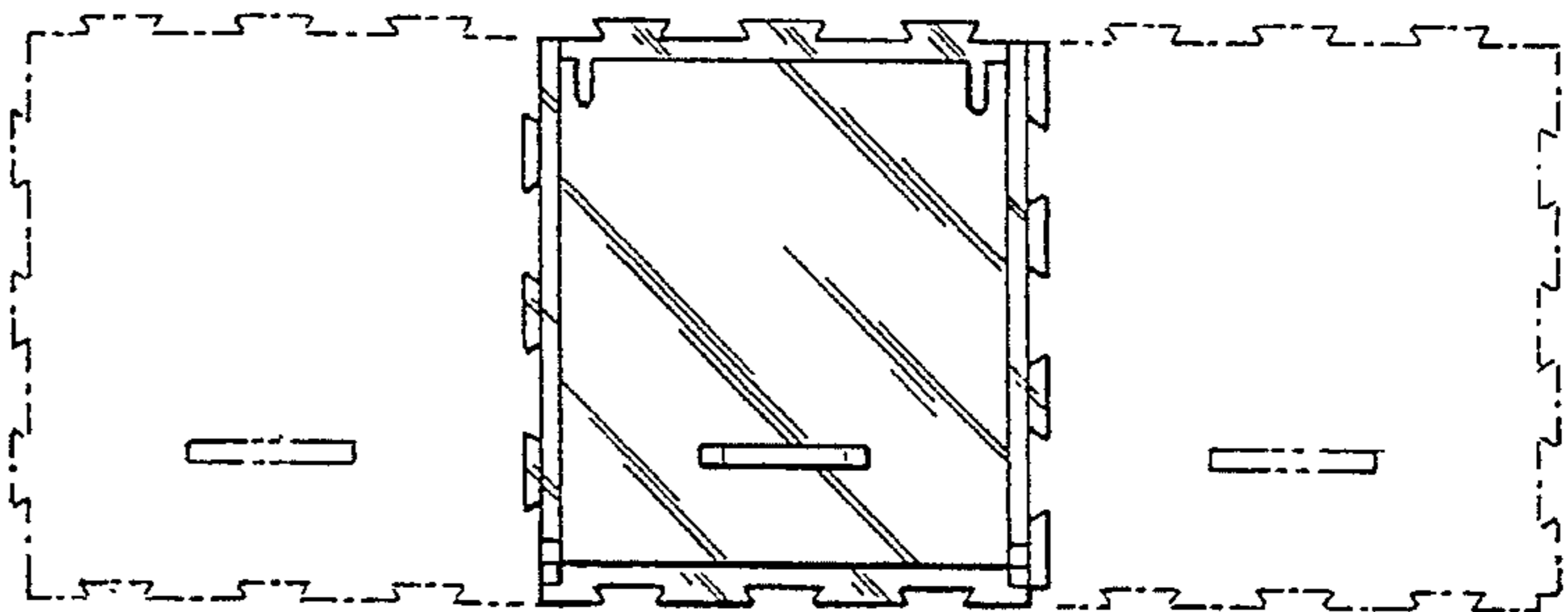

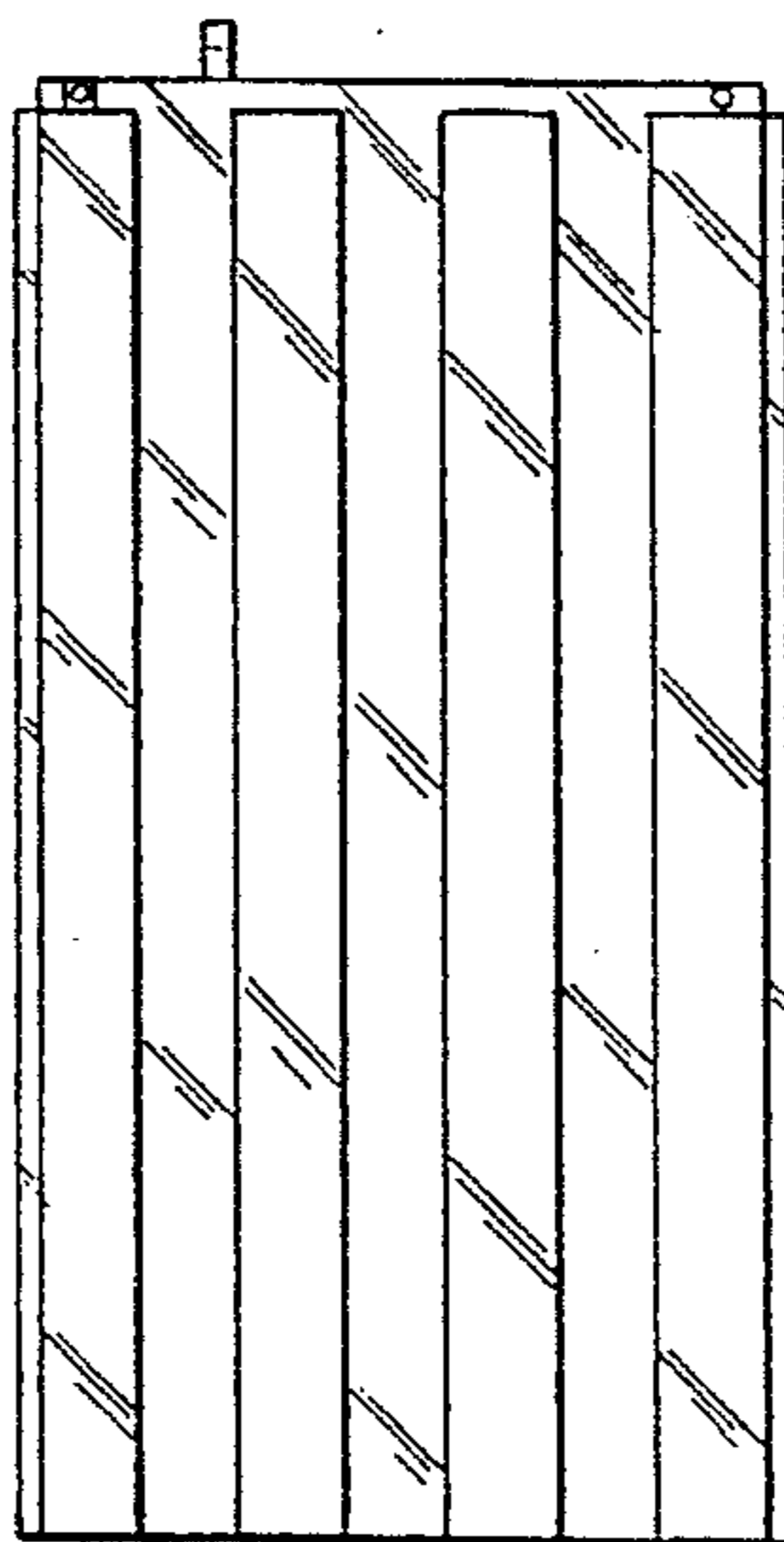

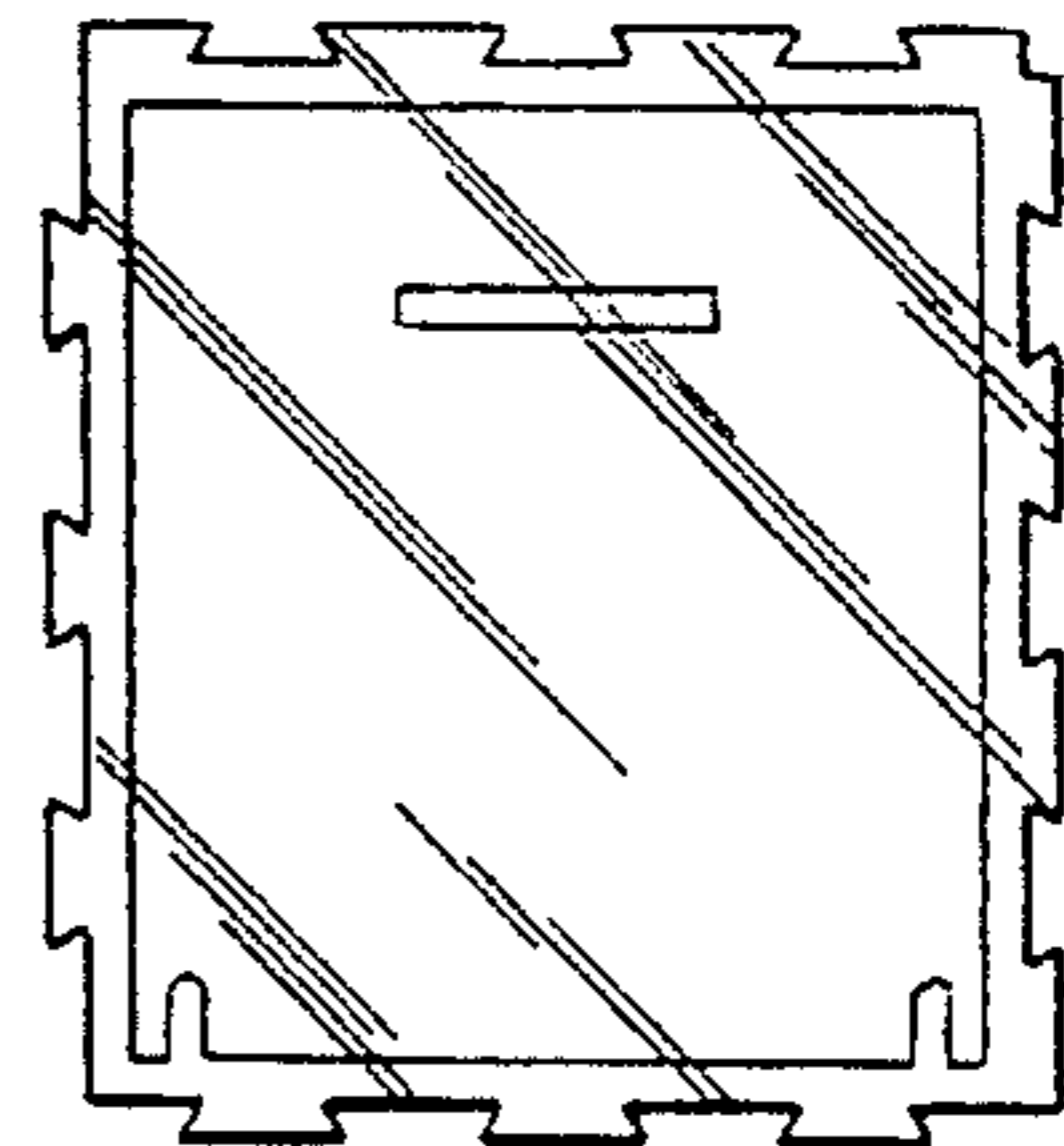

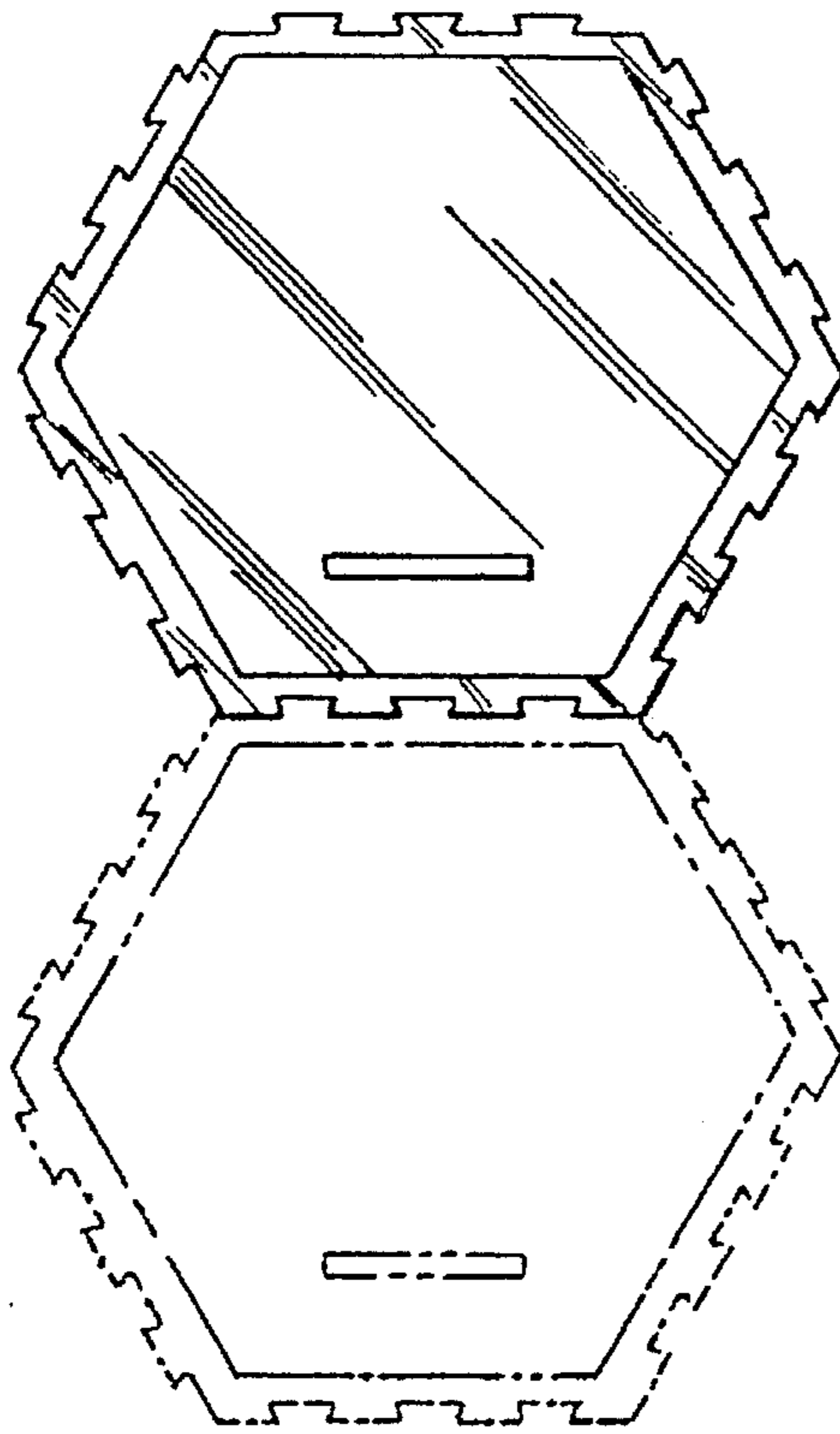
