DESCRIPTION

FIG. 6 is a rear elevational view of the collapsible bottle of FIG. 1; and,

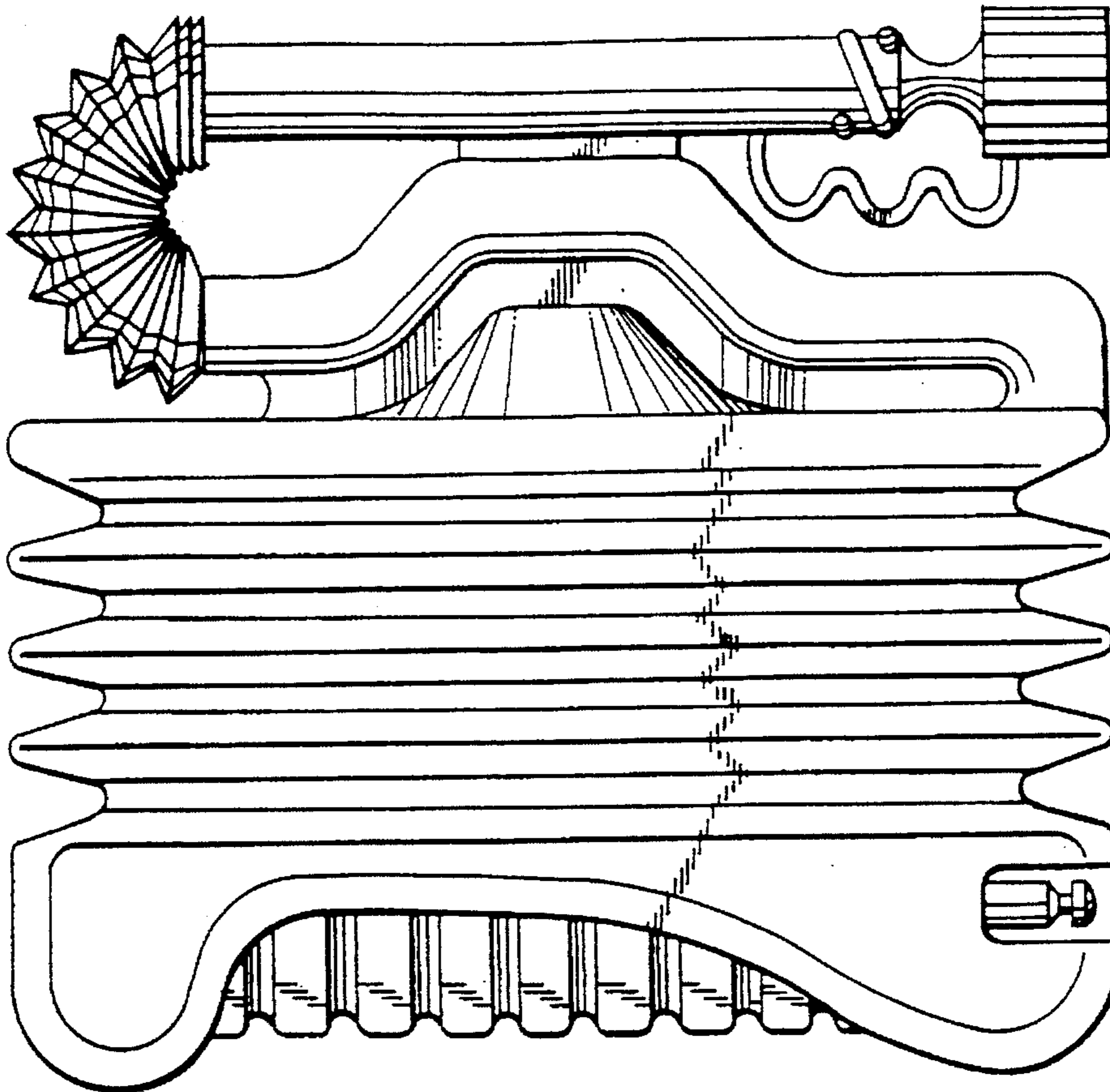
FIG. 7 is a top, front, and side perspective view of the collapsible bottle in a dispensing position.

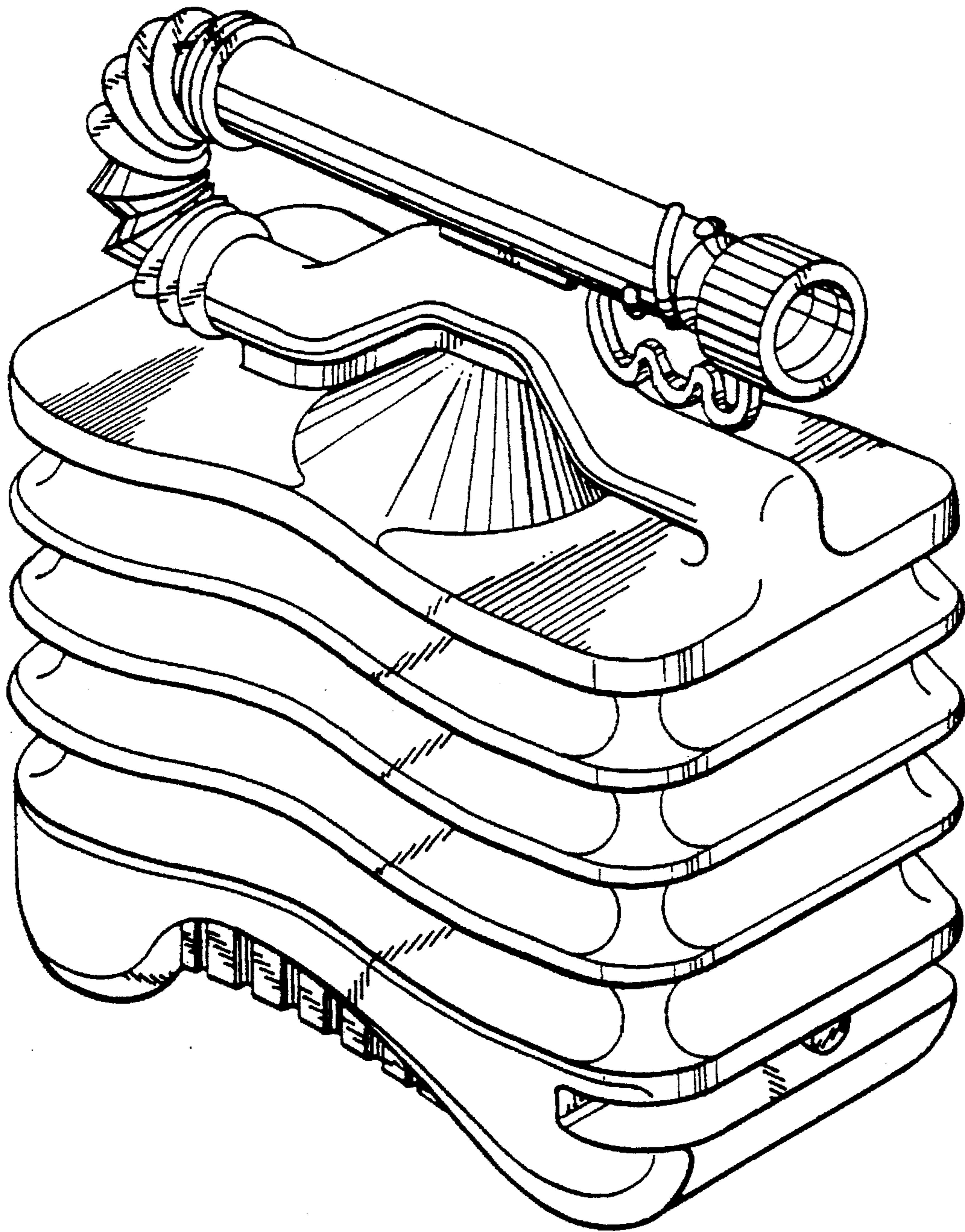

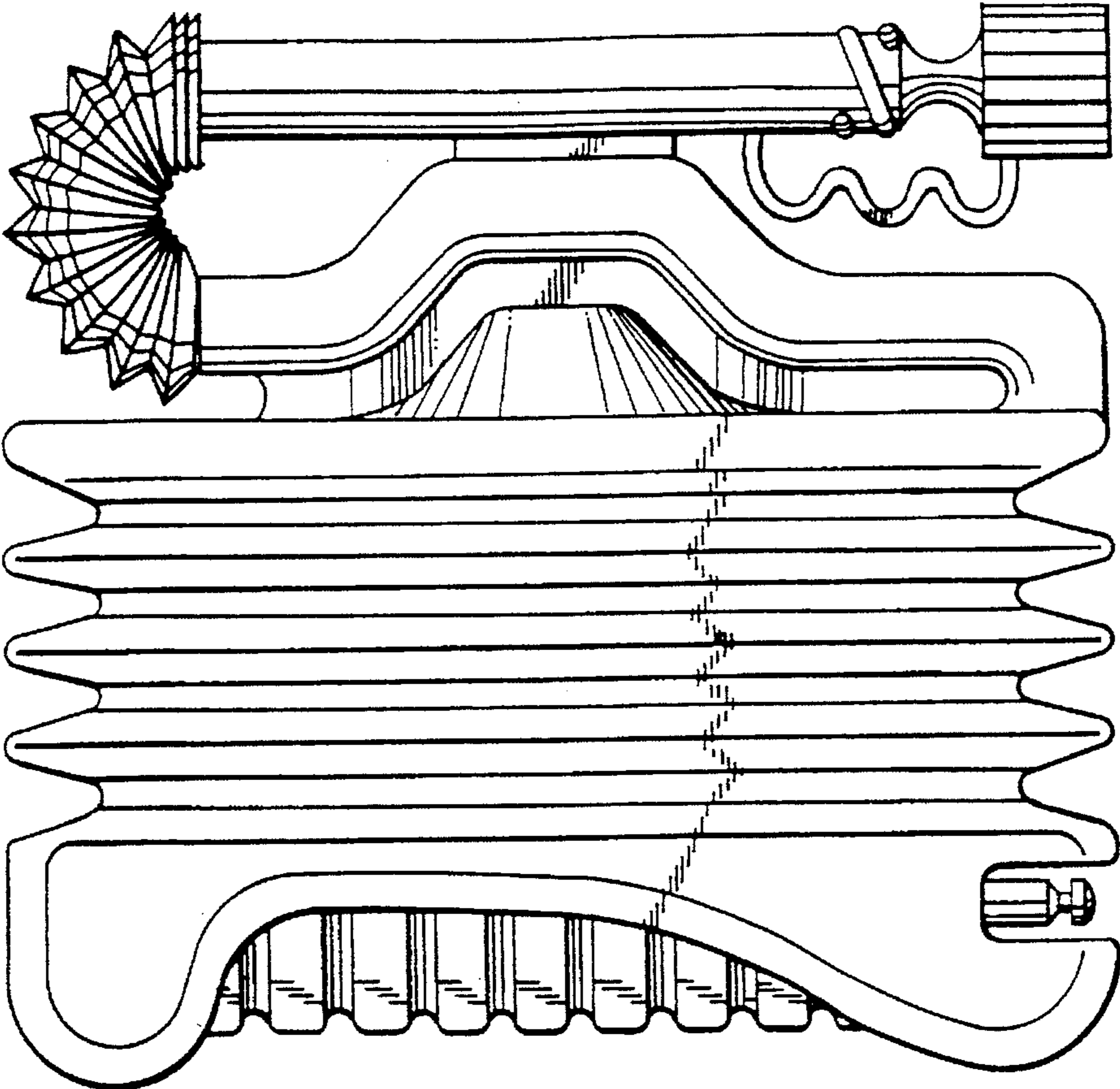

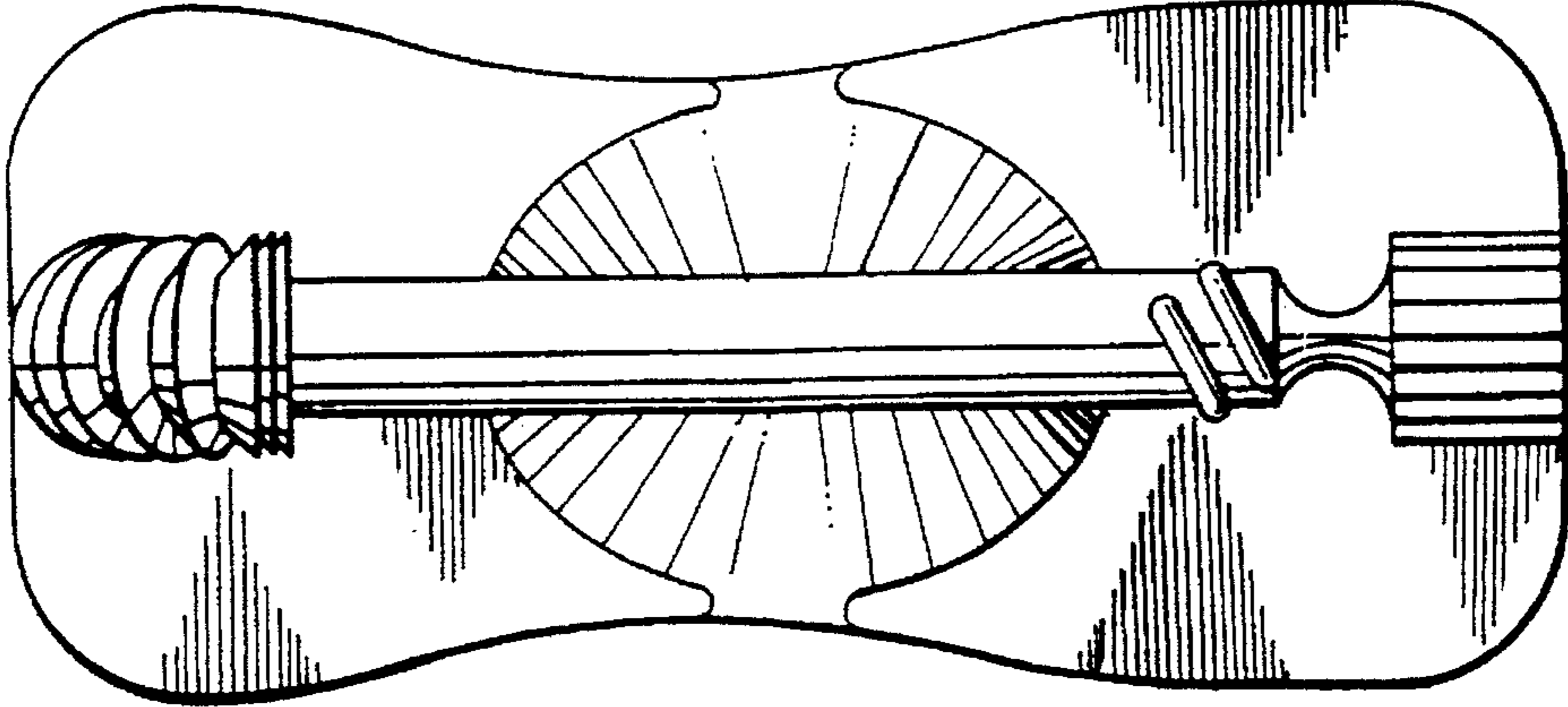

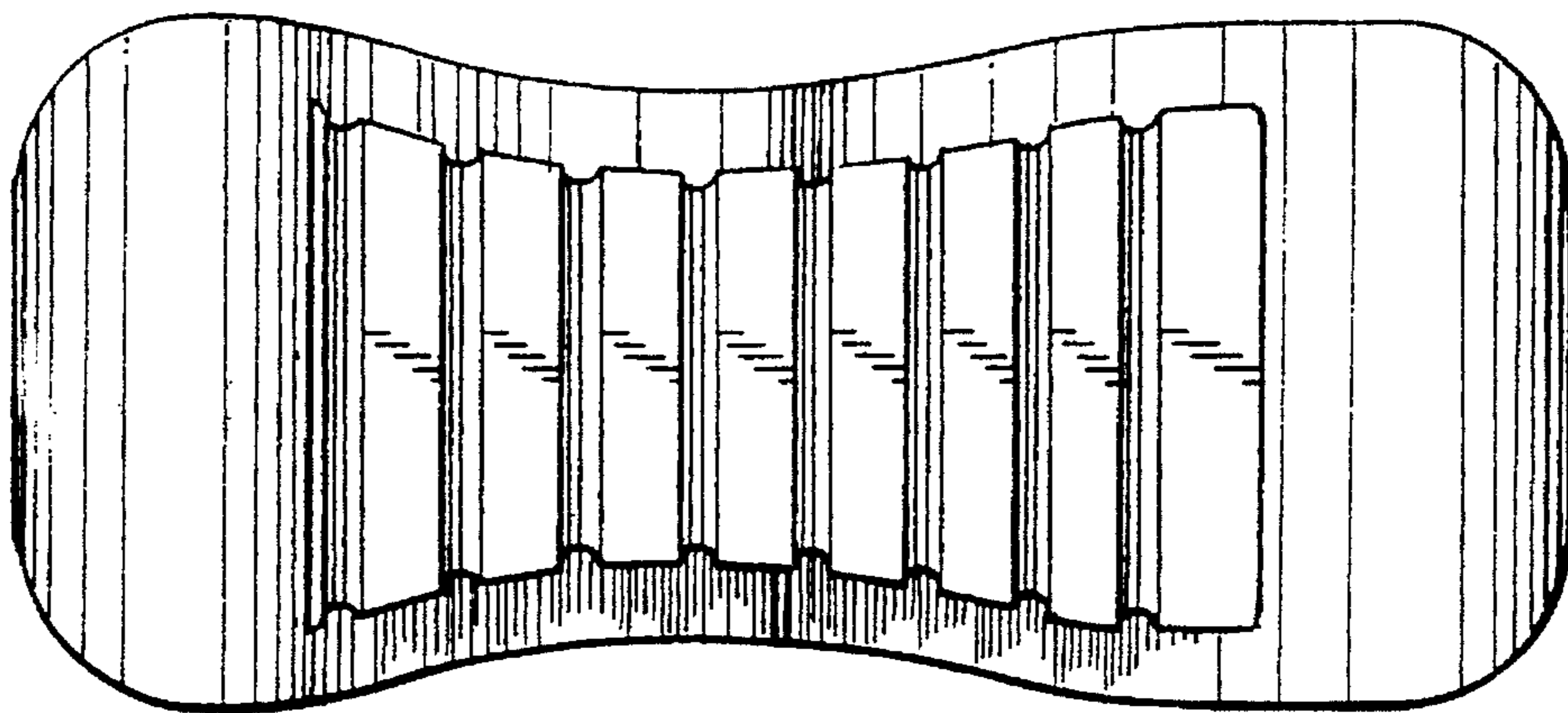

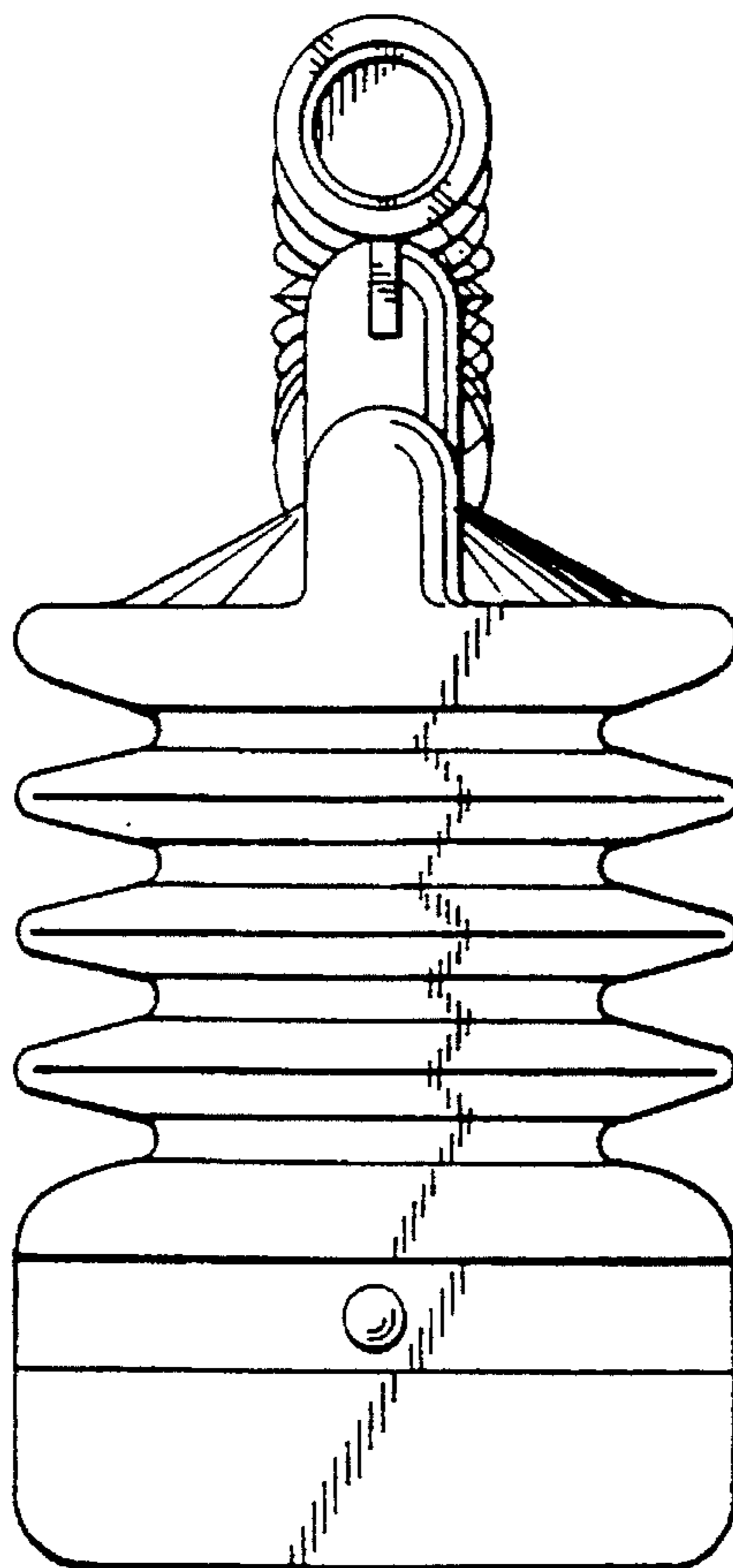

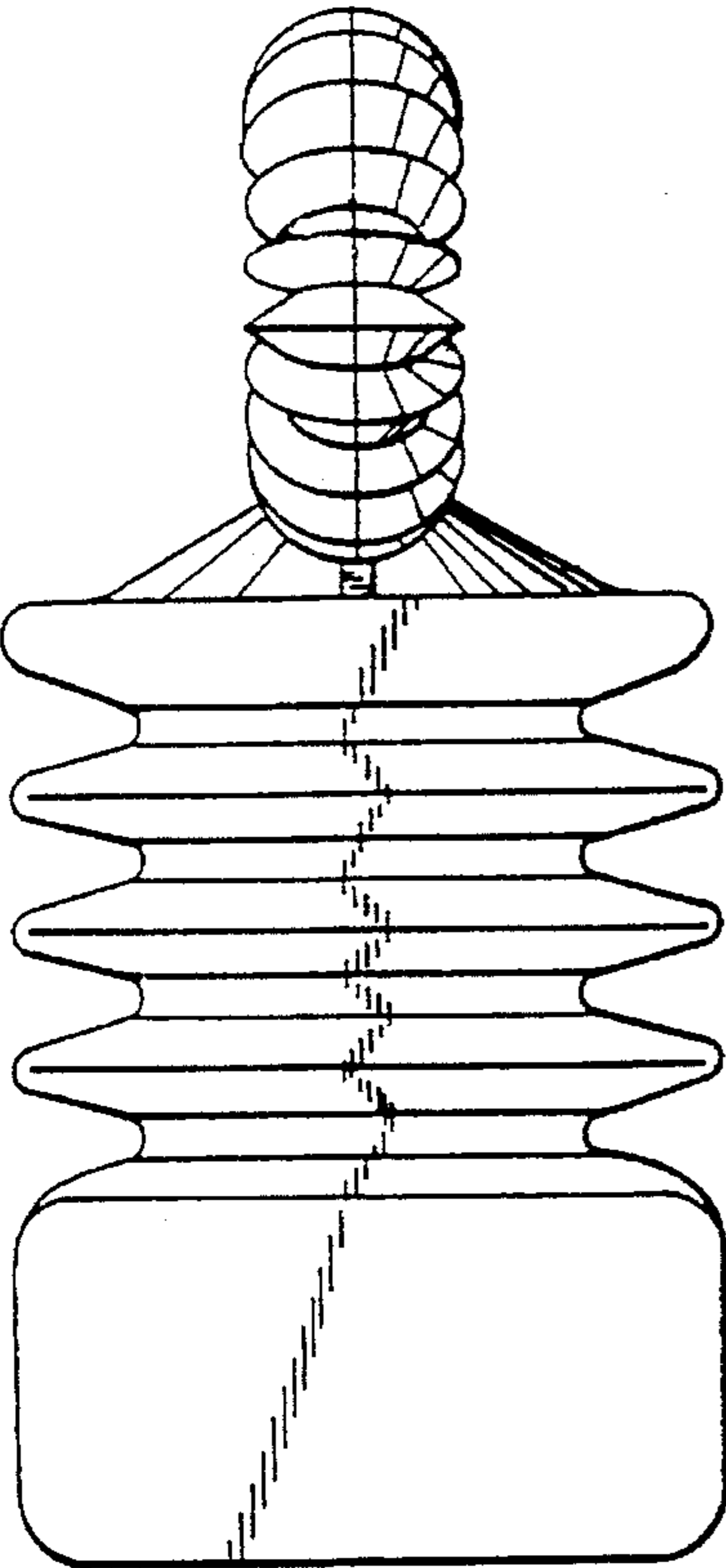

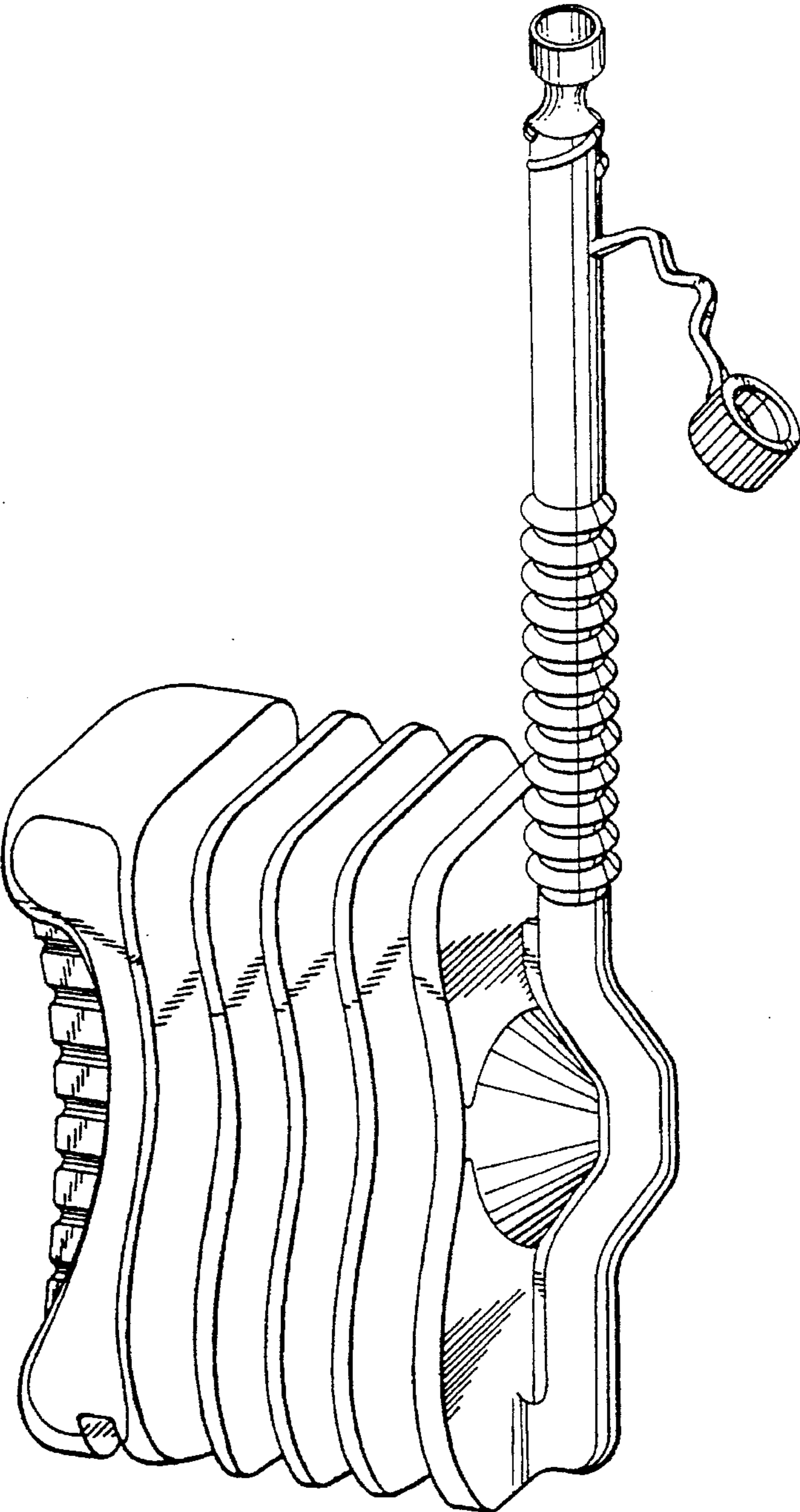
