[57] CLAIM

The ornamental design for a side window cover for vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a view in perspective of a side window cover for vehicle attached to the passenger side of a pickup truck, wherein the pickup truck is shown in broken lines for illustrative purposes only and is not part of the claimed design;

FIG. 2 is an enlarged front view thereof;

FIG. 3 is an enlarged rear view thereof;

FIG. 4 is an enlarged left side view thereof;

FIG. 5 is an enlarged right side view thereof;

FIG. 6 is an enlarged top view thereof;

FIG. 7 is an enlarged bottom view thereof;

FIG. 8 is a view in perspective of an alternative embodiment of a side window cover for vehicle attached to the passenger side of a pickup truck, wherein the side window cover for vehicle has a cut-away portion and the pickup truck is shown in broken lines for illustrative purposes only and is not part of the claimed design;

FIG. 9 is an enlarged front view of the alternative embodiment;

FIG. 10 is an enlarged rear view of the alternative embodiment;


FIG. 11 is an enlarged left side view of the alternative embodiment;

FIG. 12 is an enlarged right side view of the alternative embodiment;


FIG. 13 is an enlarged top view of the alternative embodiment; and,


FIG. 14 is an enlarged bottom view of the alternative embodiment.

















