The ornamental design for a shed, as shown and described.

DESCRIPTION

FIG. 1 is a top right front perspective view of a shed showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a right side elevational view thereof; the left side elevational view being a mirror image;

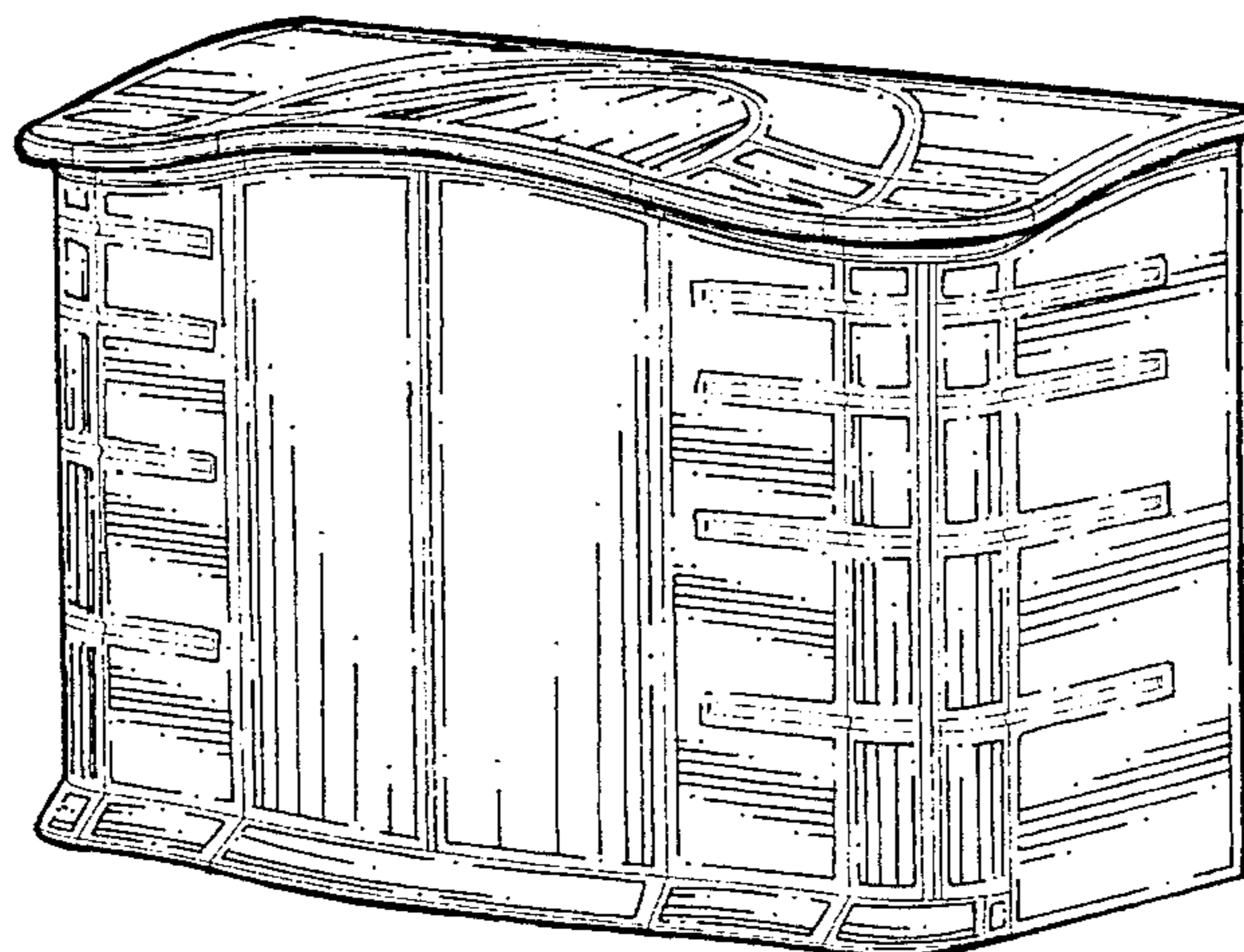
FIG. 4 is a top plan view thereof;

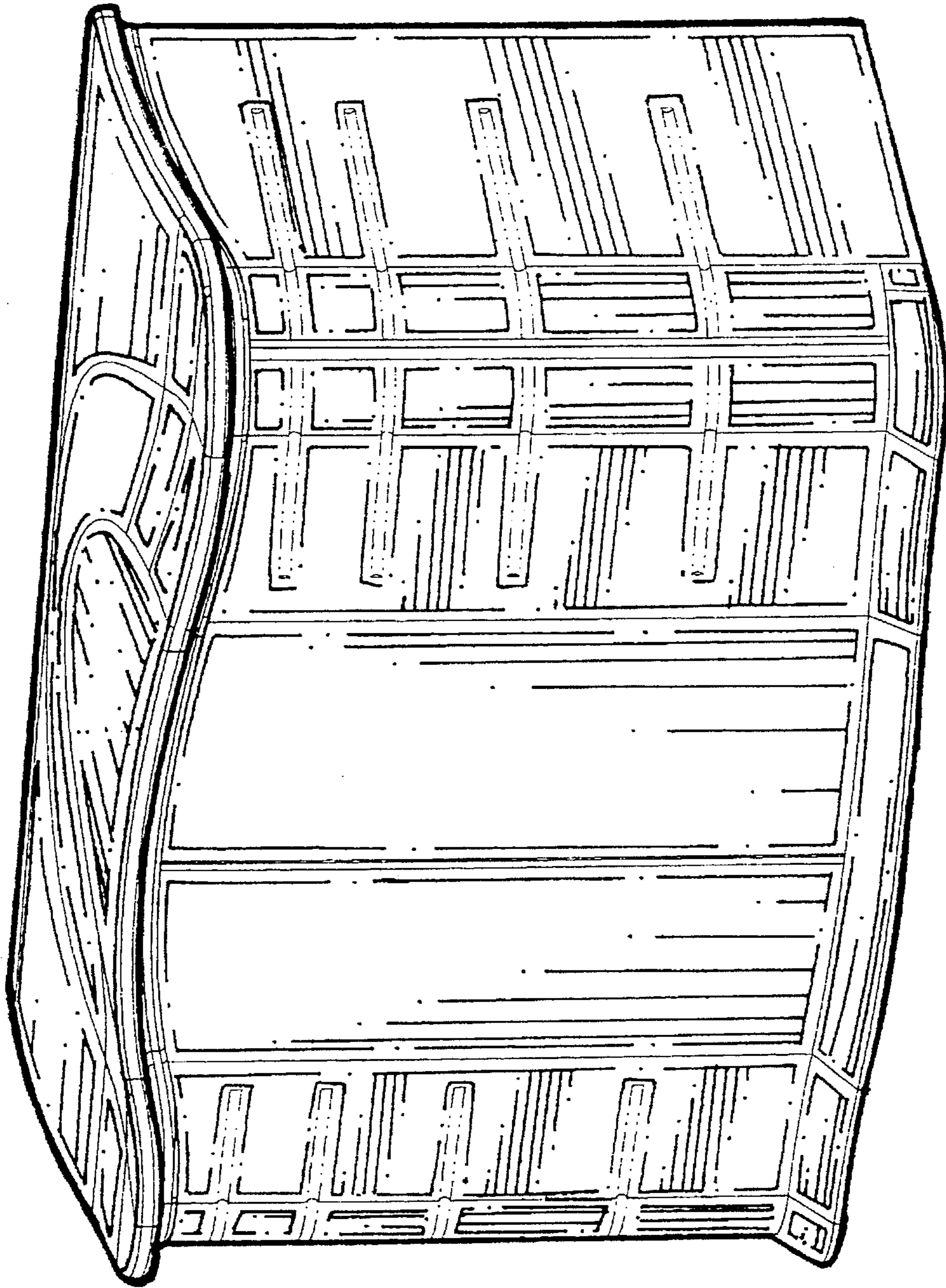

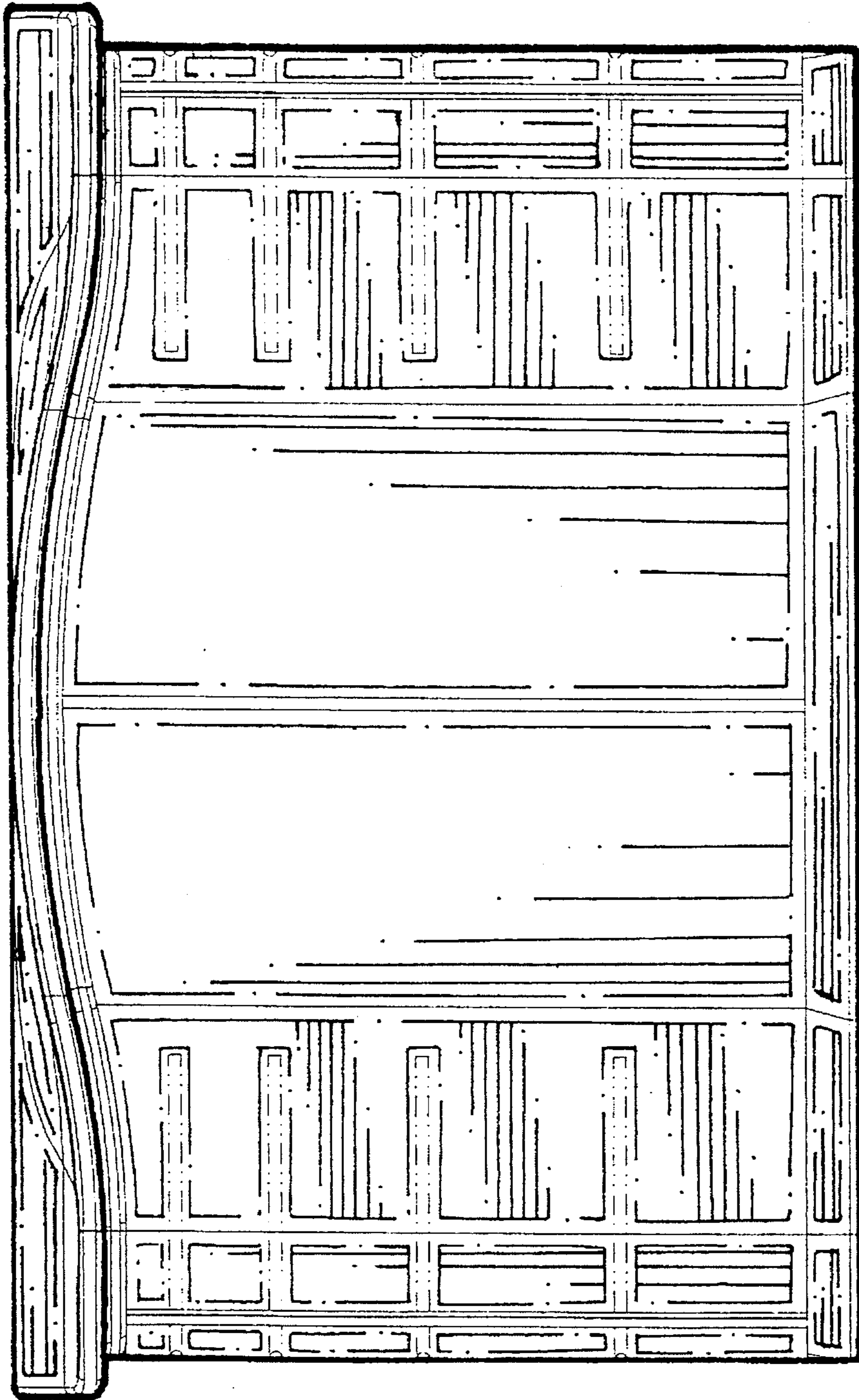

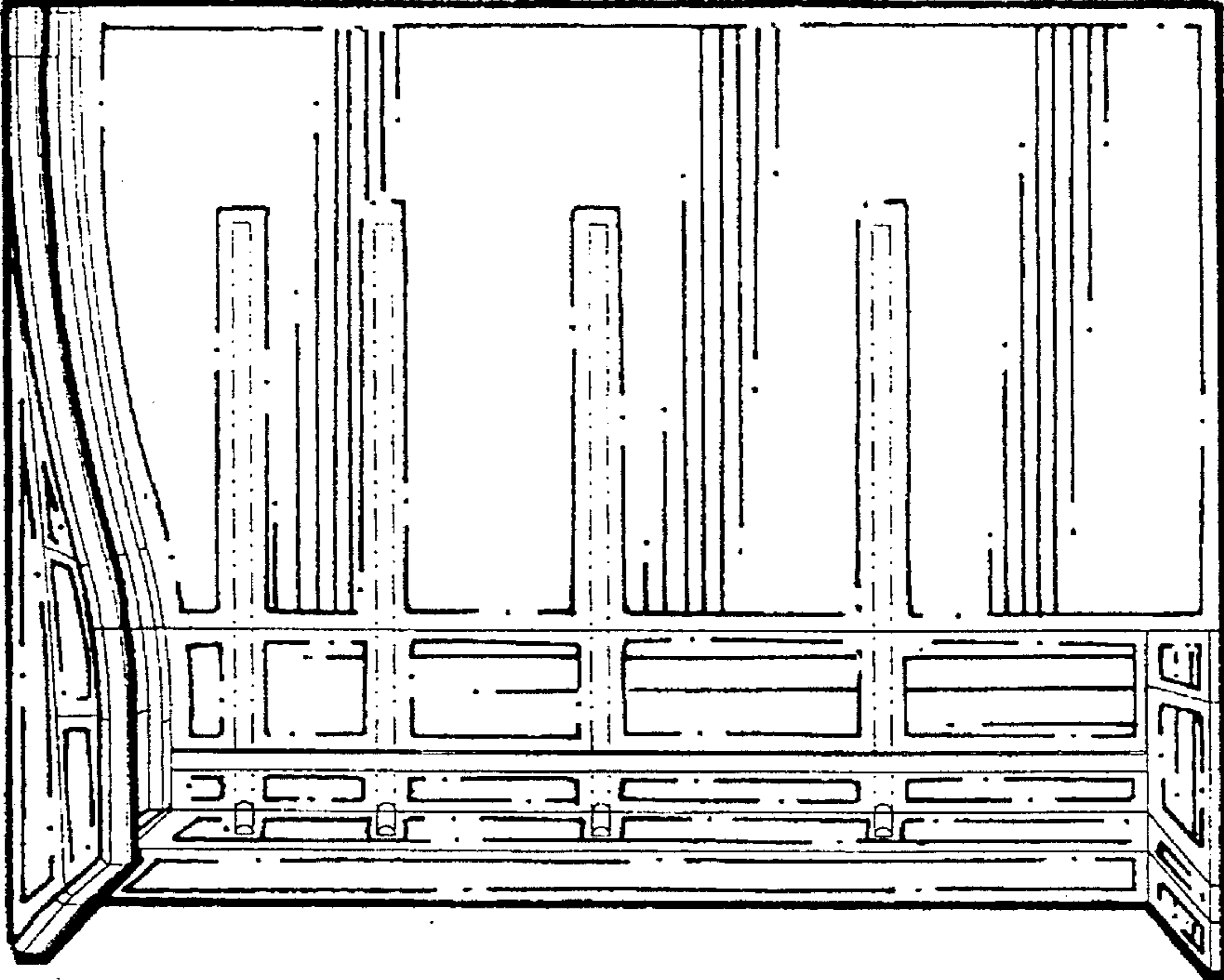

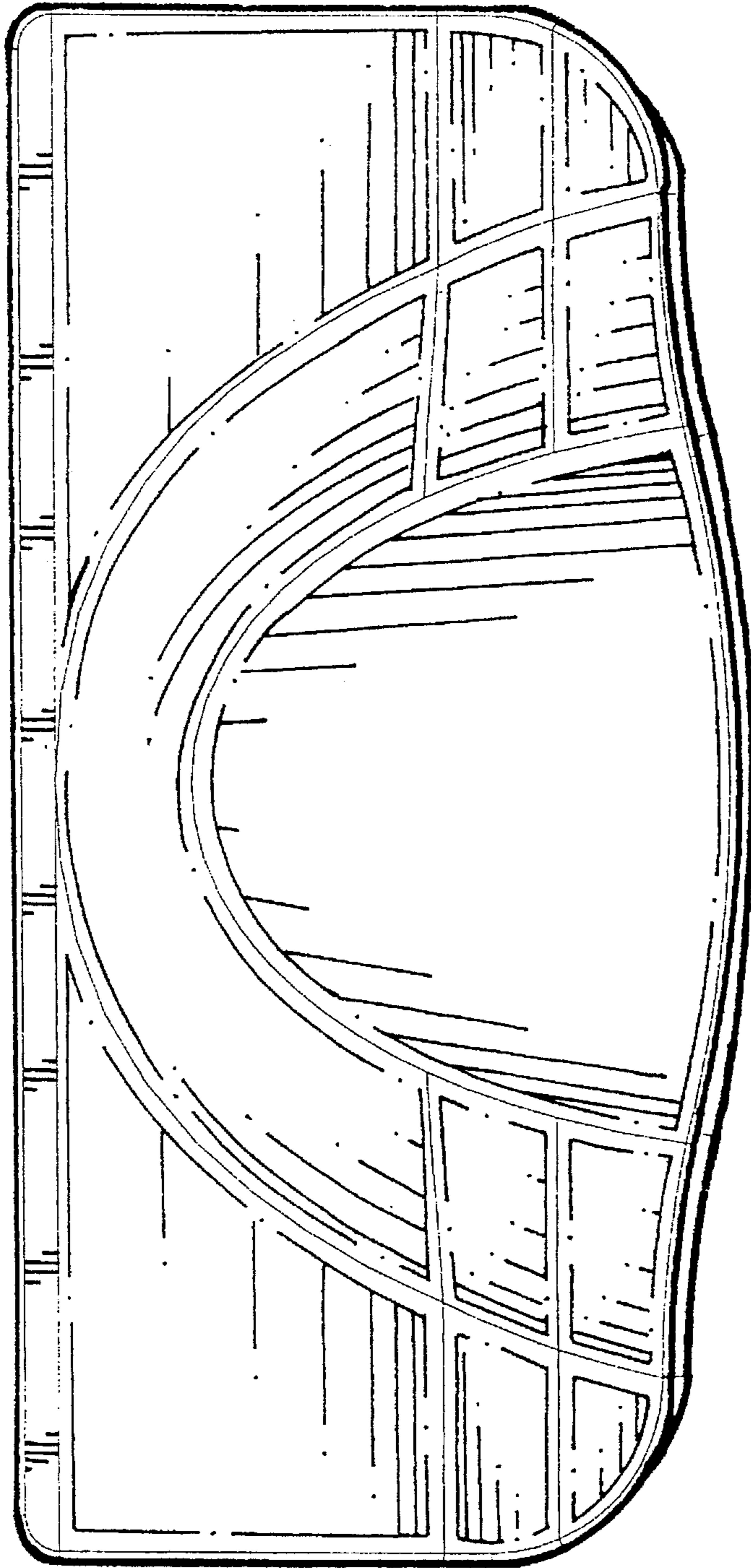

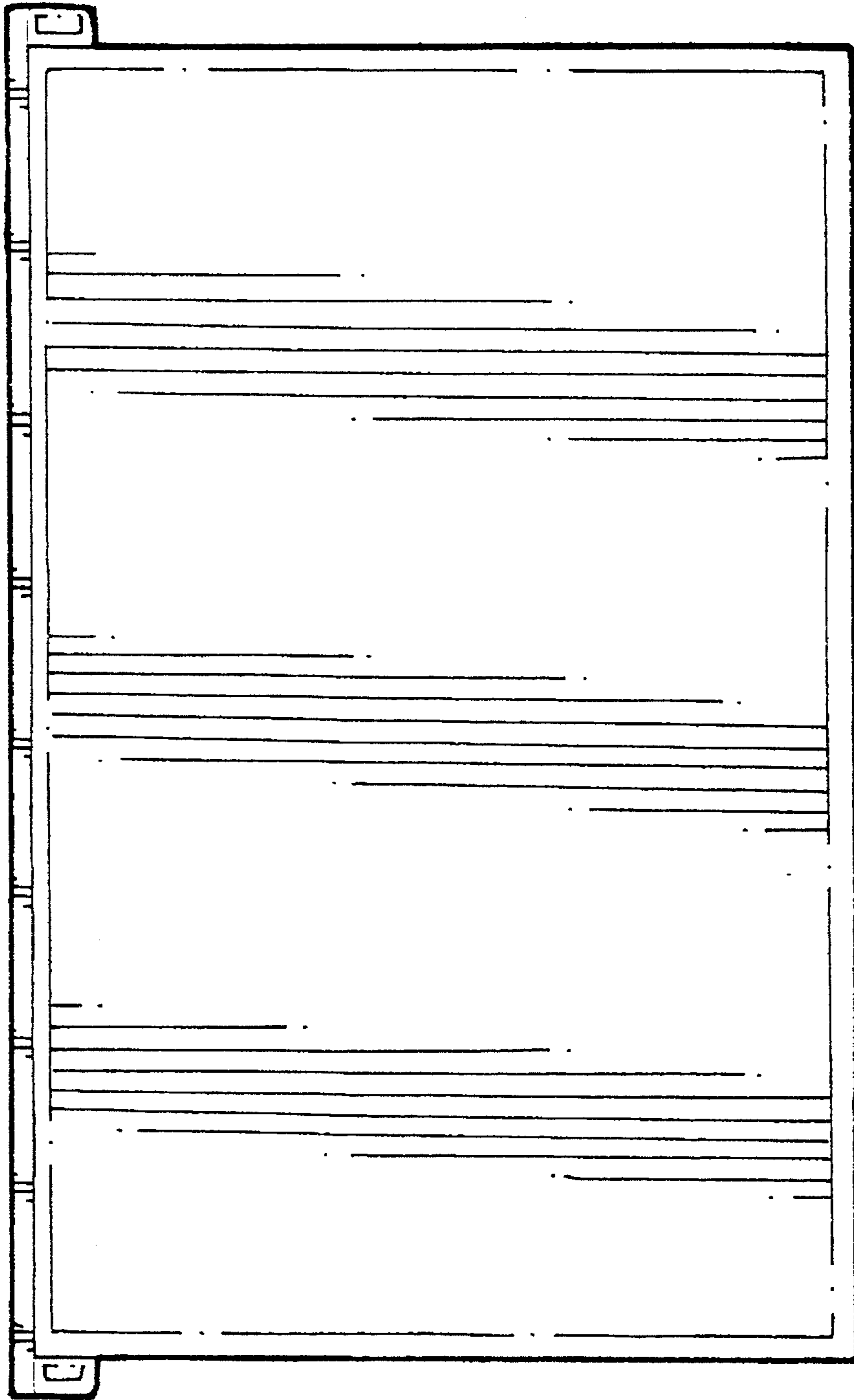

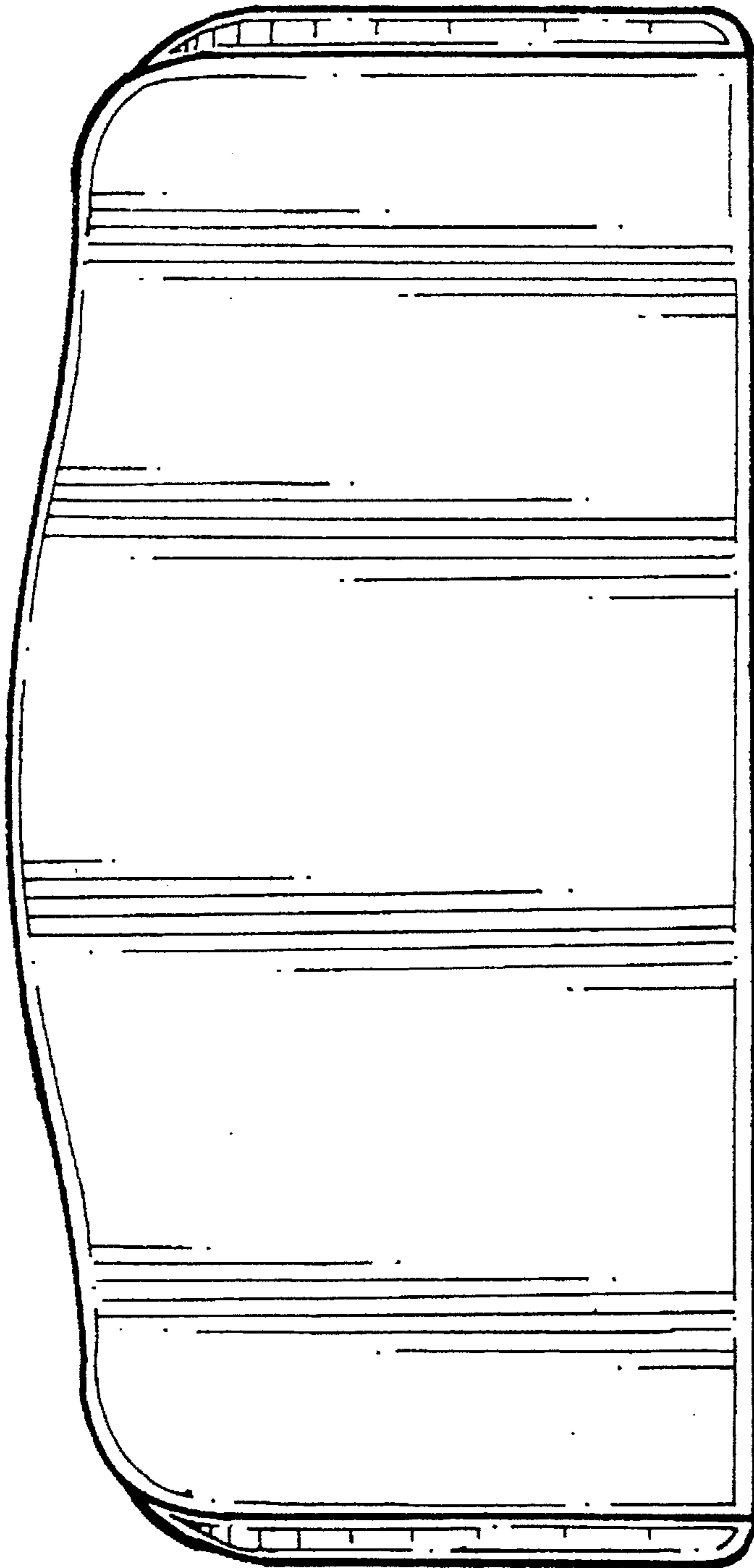
