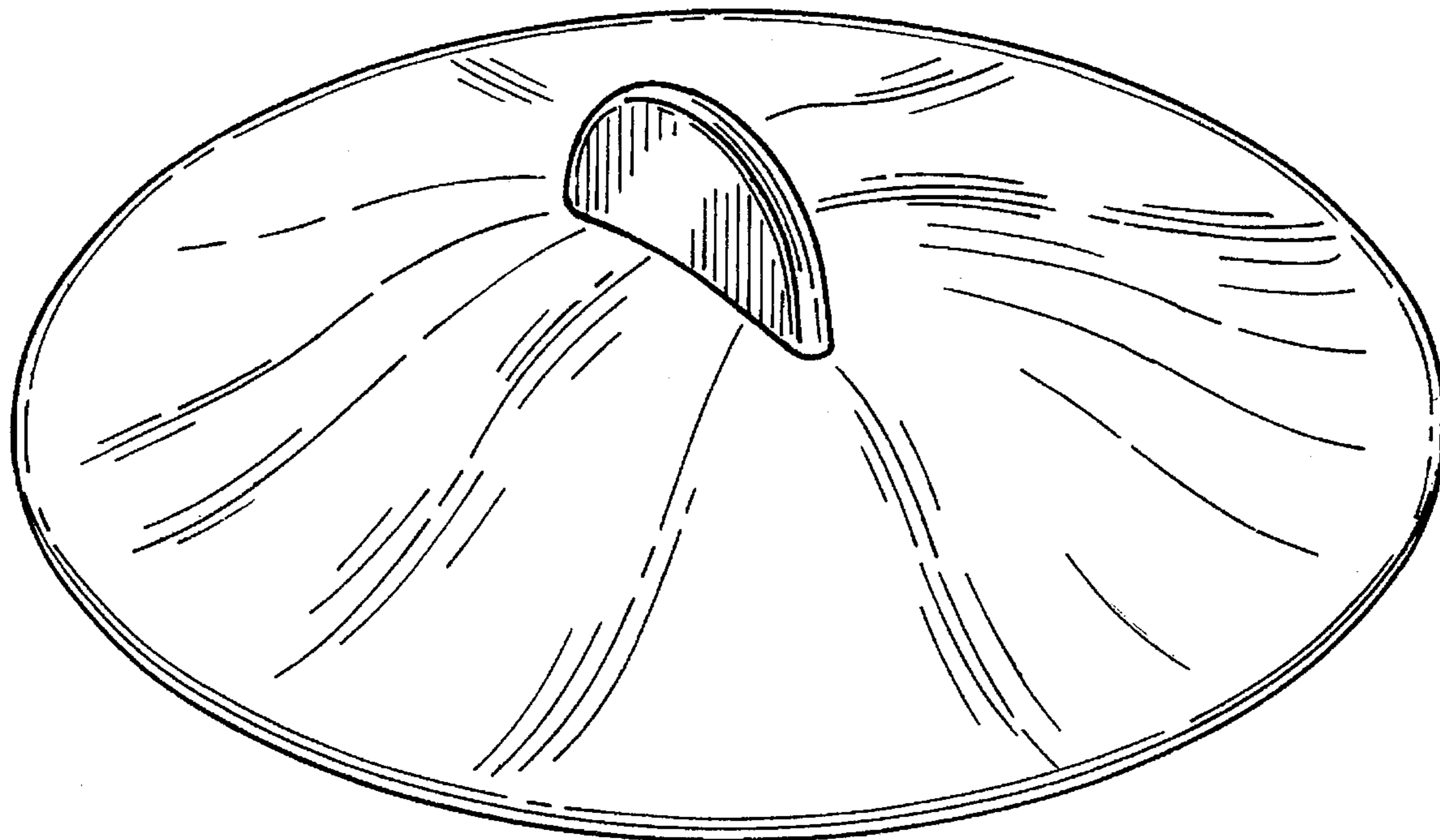
[57] **CLAIM**

The ornamental design for a steamer lid, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and side perspective view of a steamer lid showing my new design;
FIG. 2 is a top plan view thereof;

FIG. 4 is a front elevation view thereof;
FIG. 5 is a rear elevation view thereof;
FIG. 6 is a left side elevation view thereof;
FIG. 7 is a right side elevation view thereof;

FIG. 9 is a cross-section thereof taken on line 9—9 in FIG. 2;
FIG. 10 is a top, front and side perspective view of a variation thereof;

FIG. 12 is a bottom plan view of the variation thereof;
FIG. 13 is a front elevation view of the variation thereof;

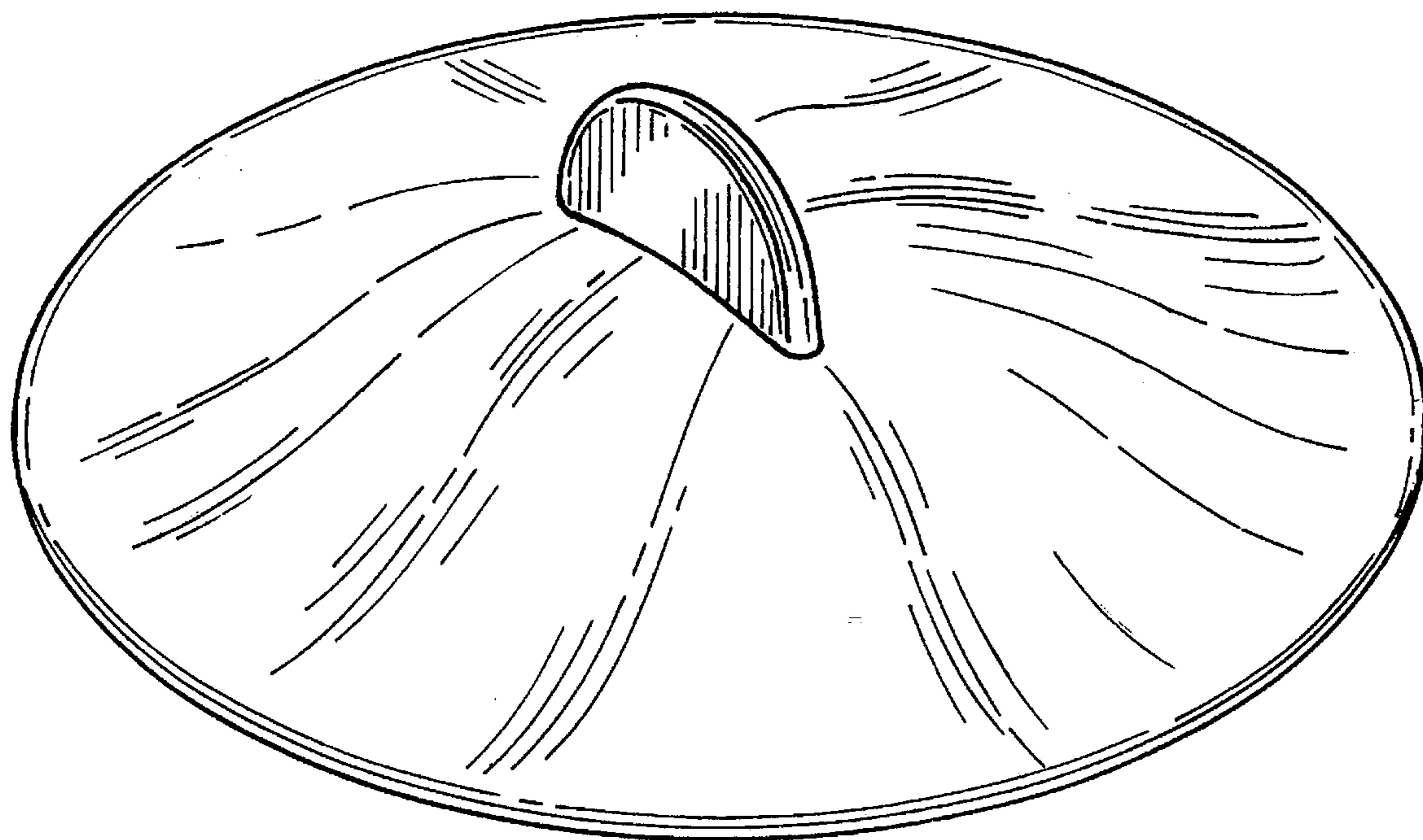

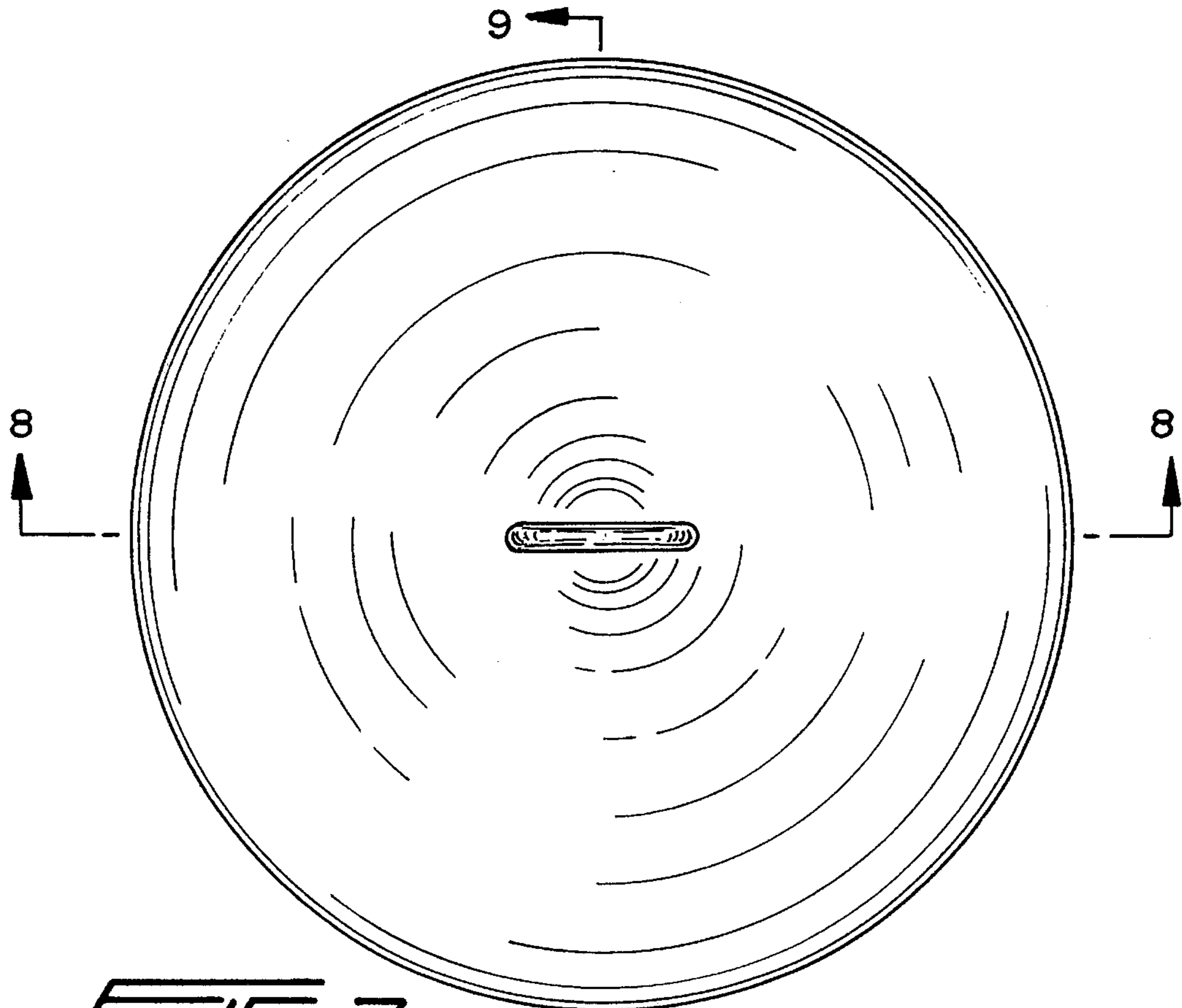

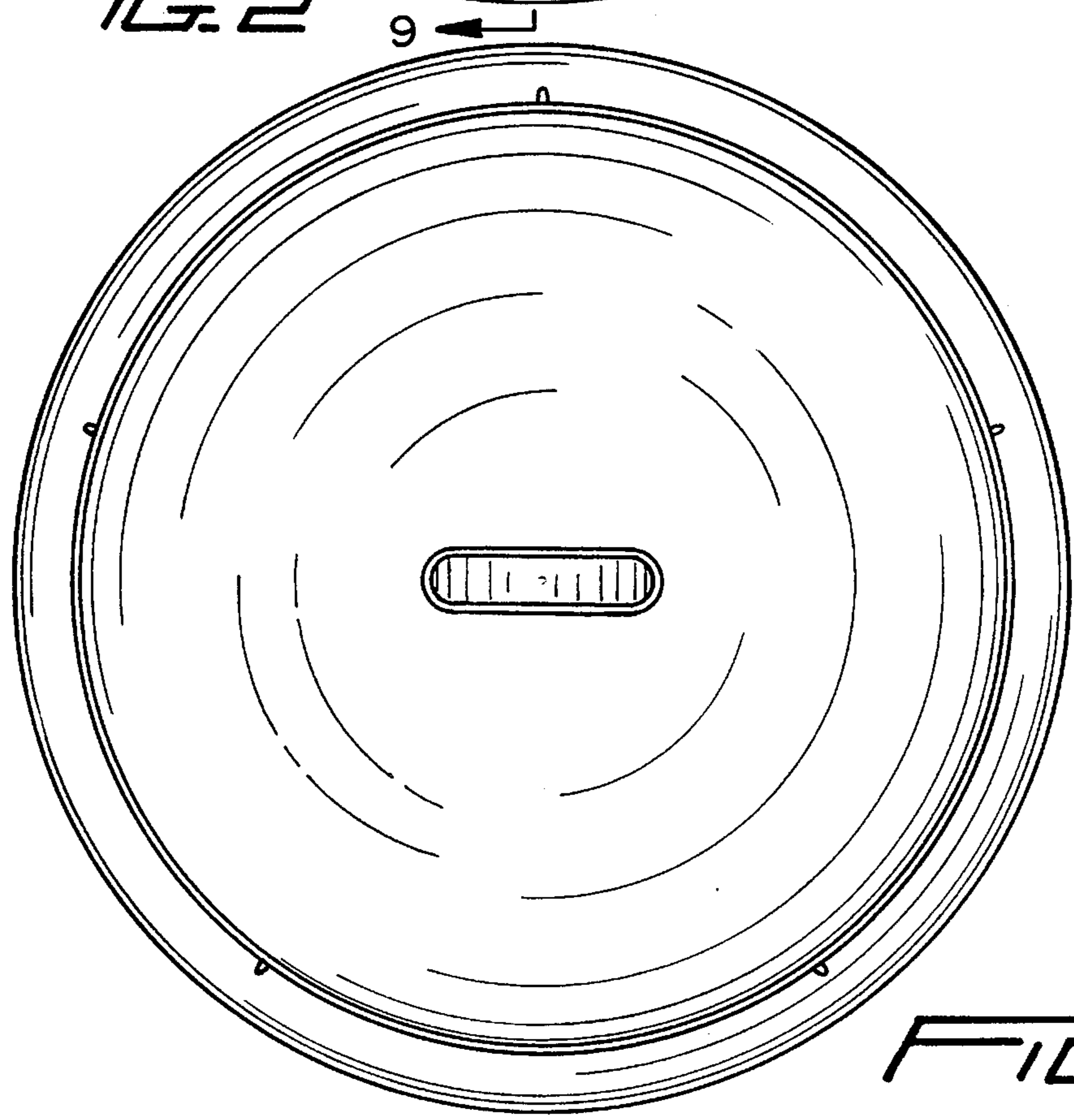

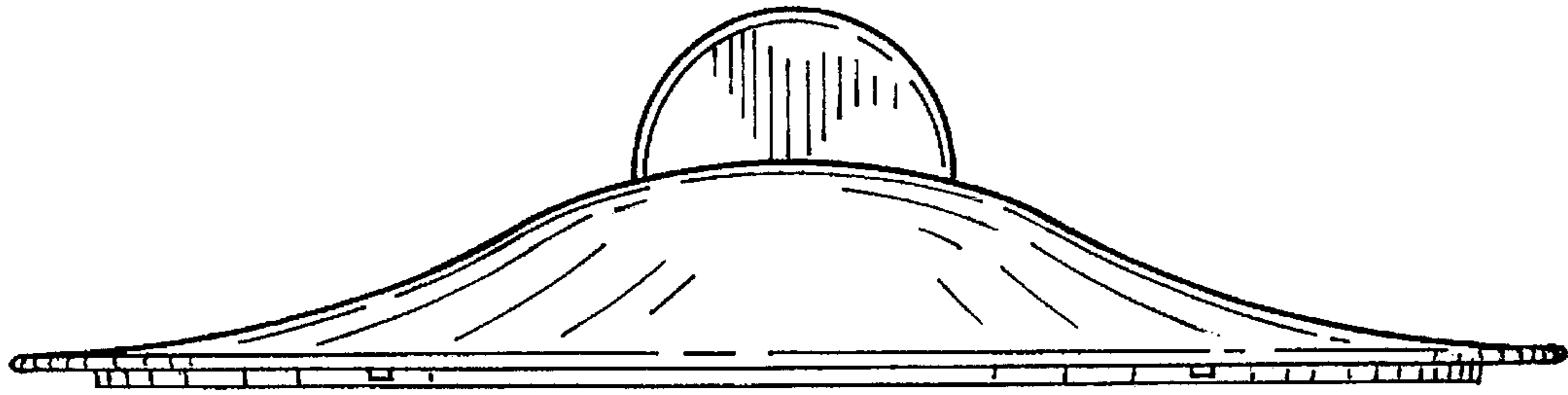

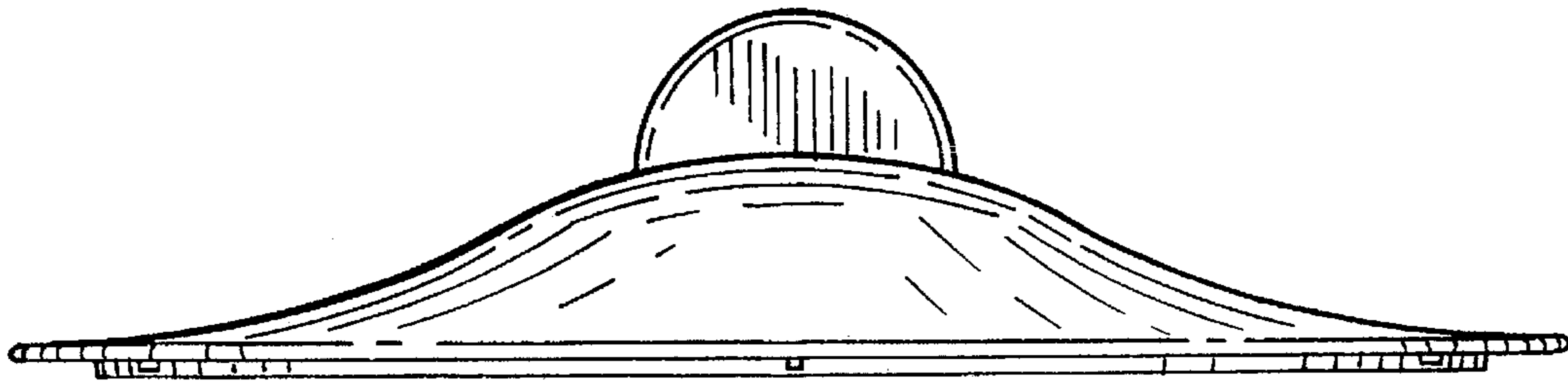

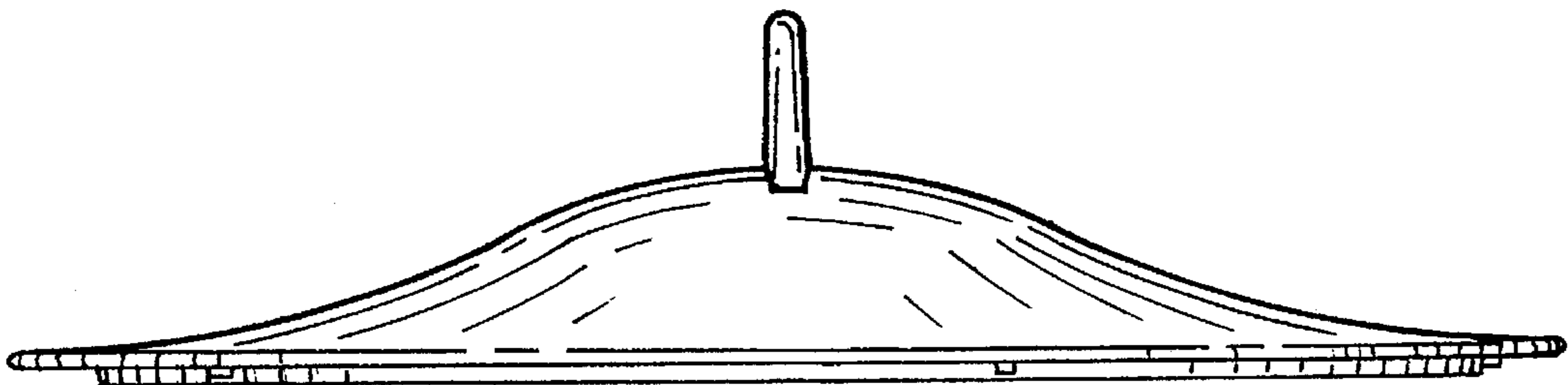

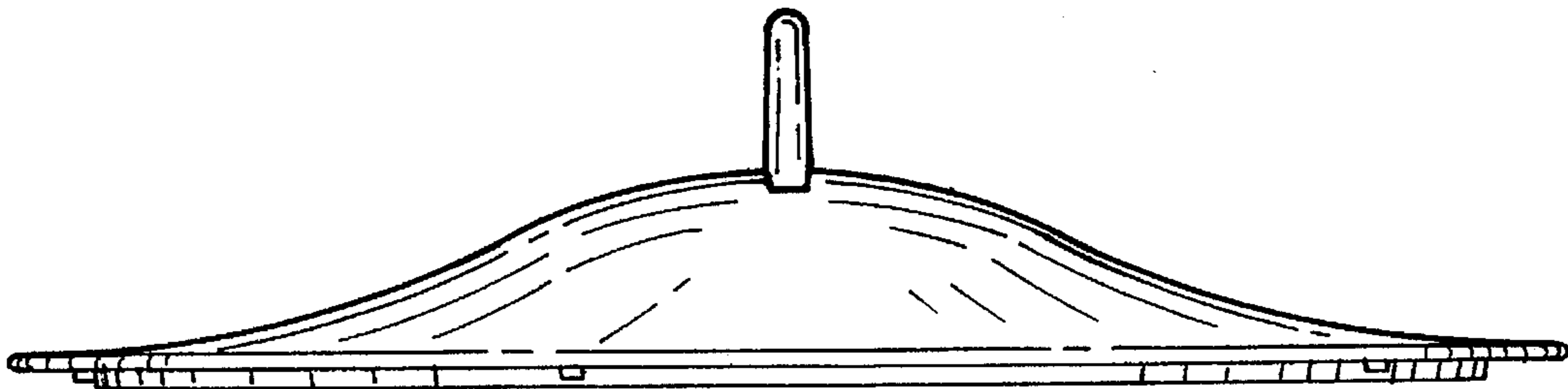

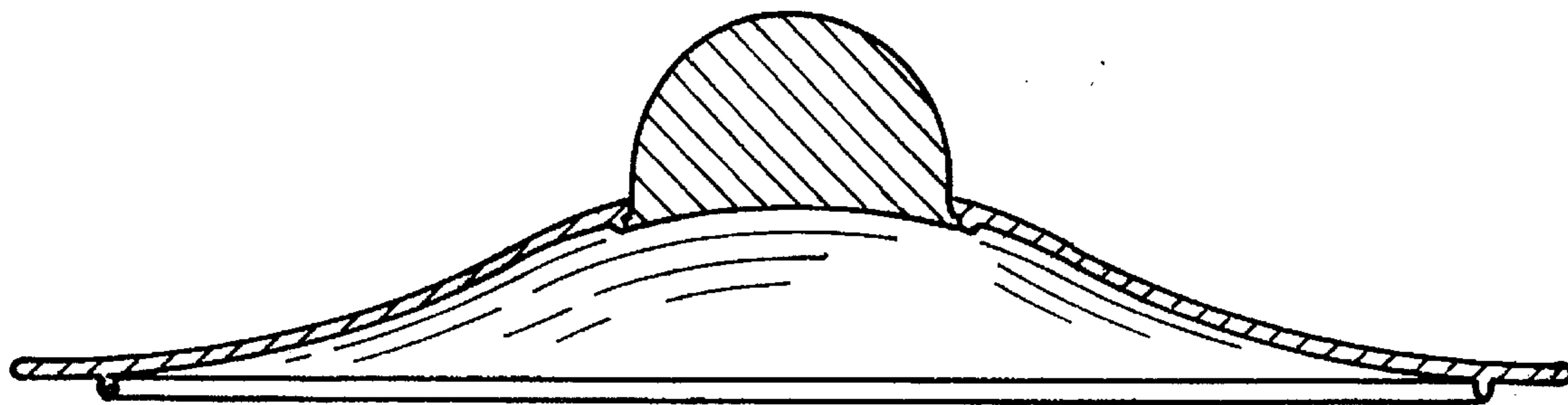

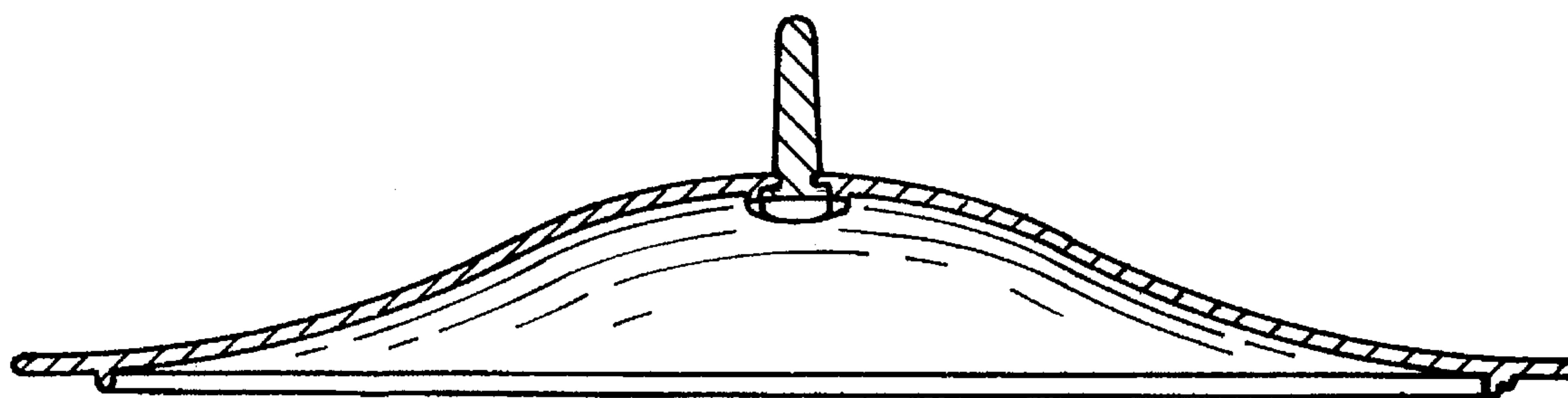

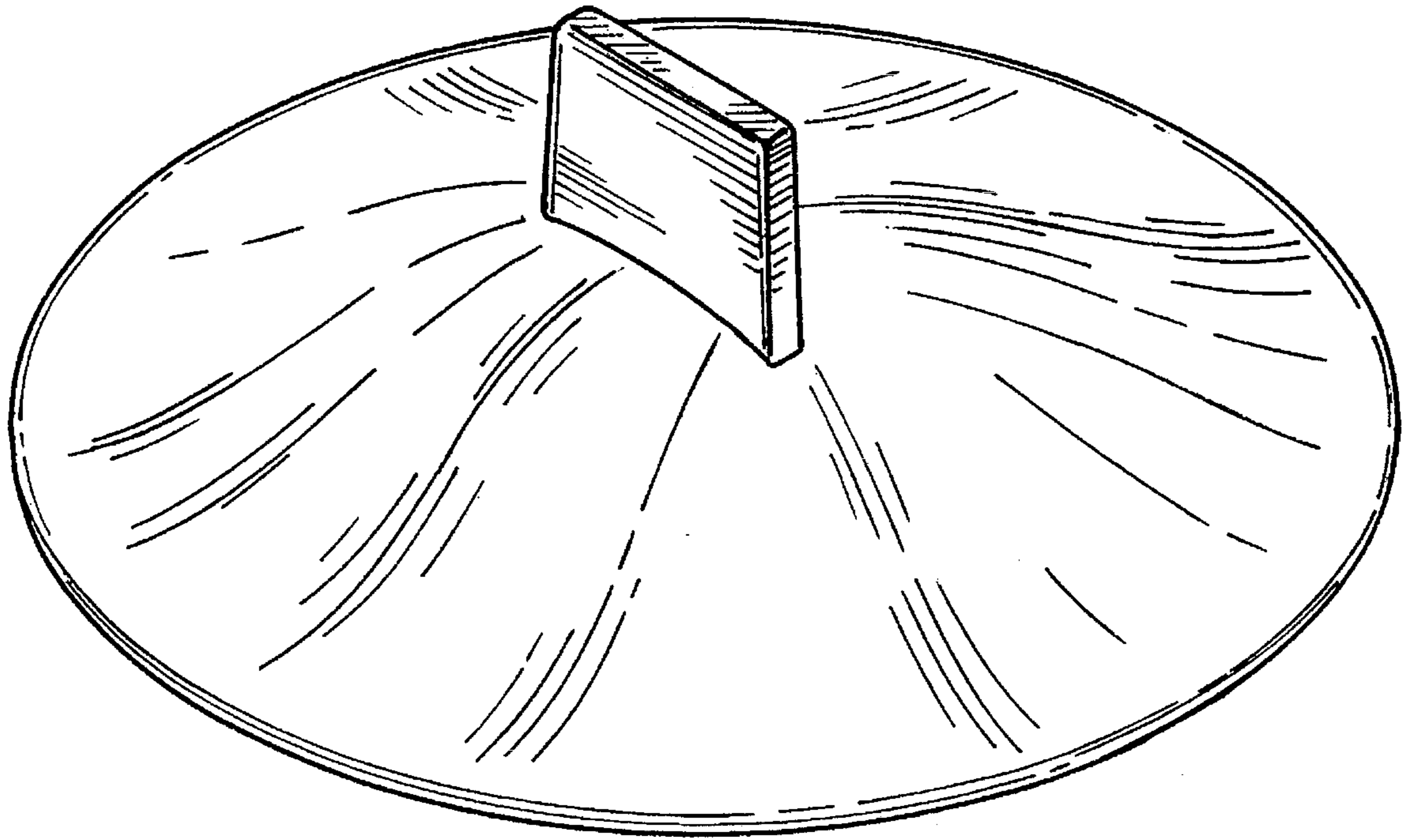

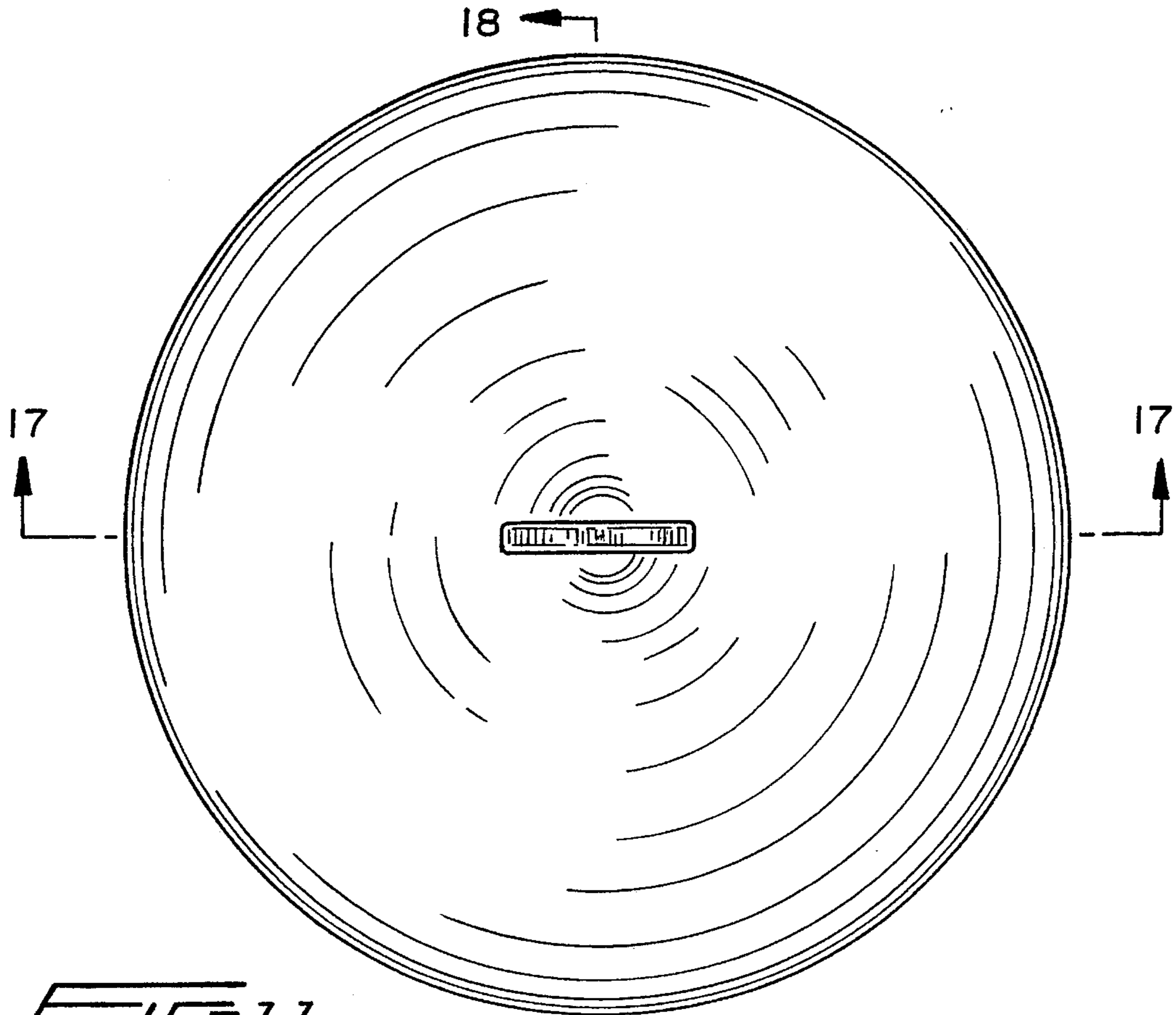

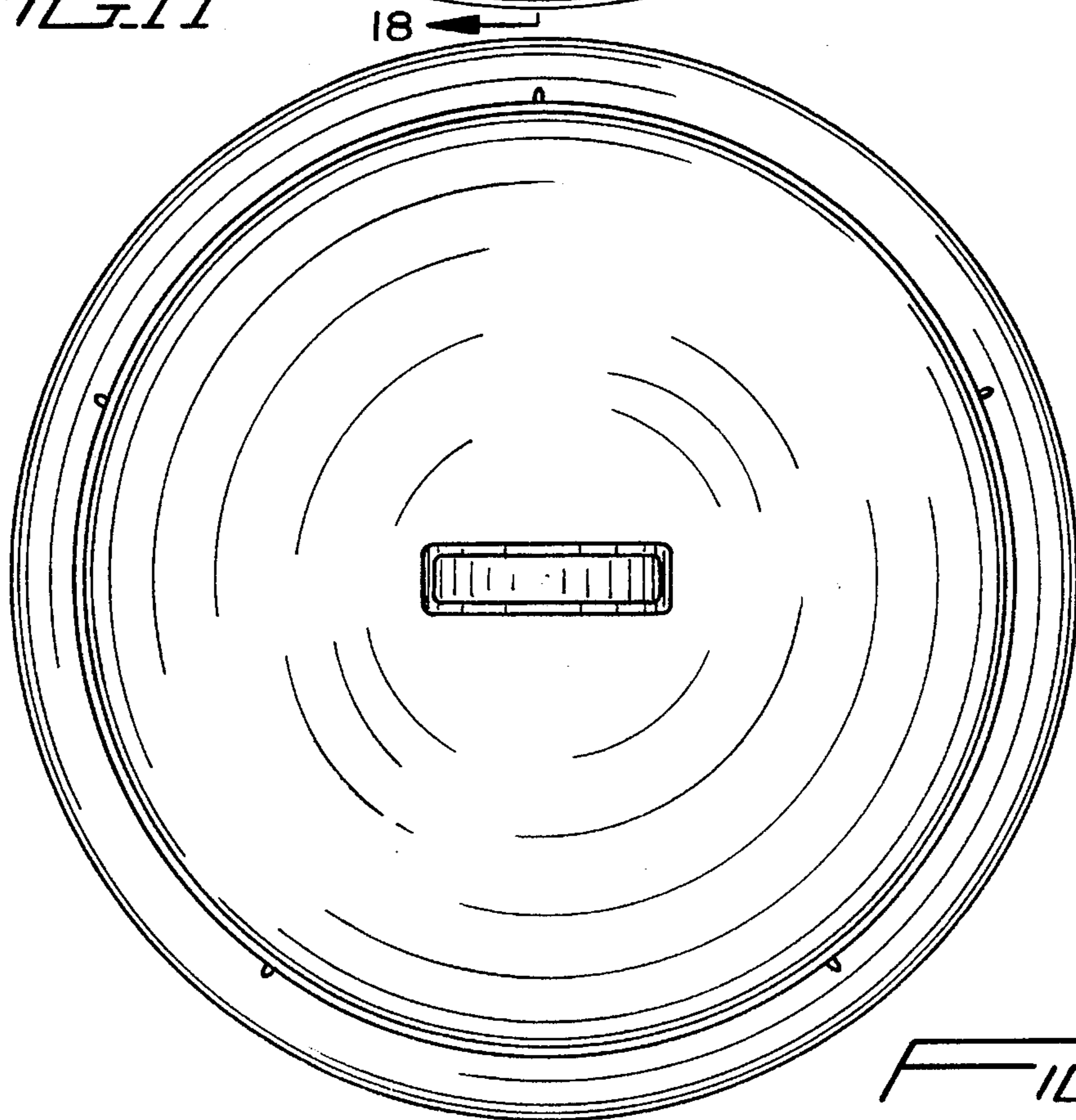

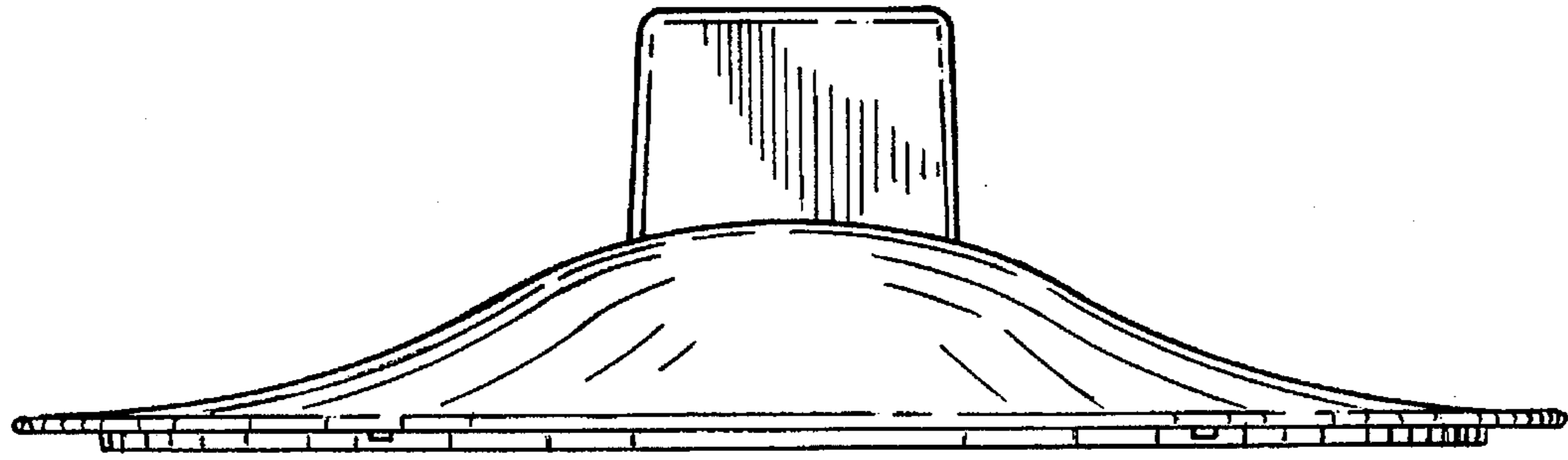

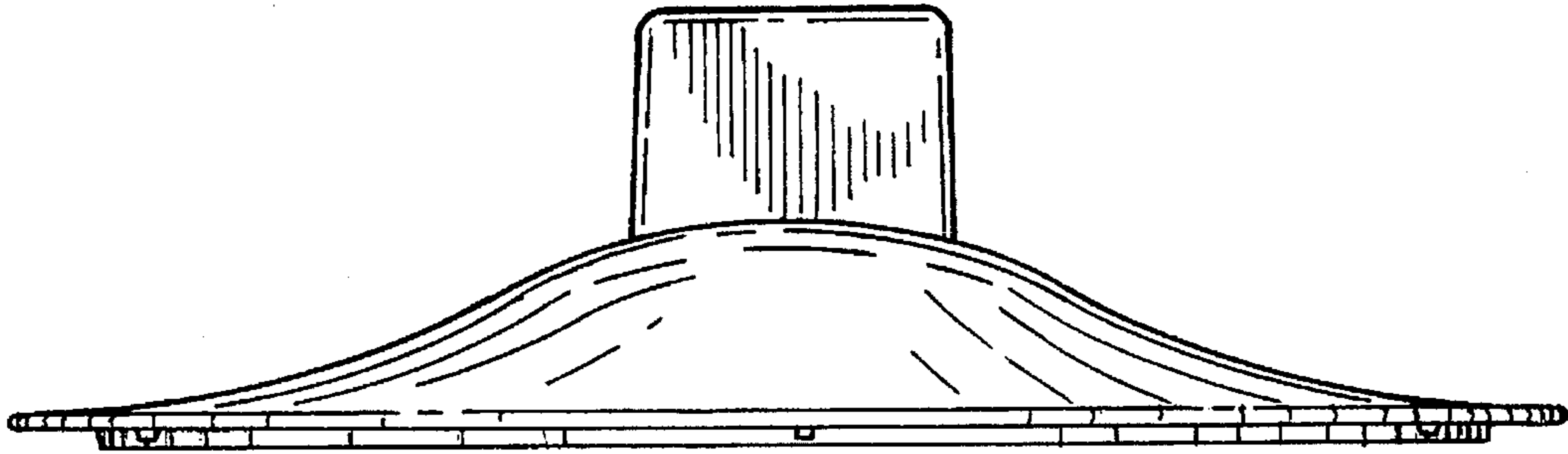

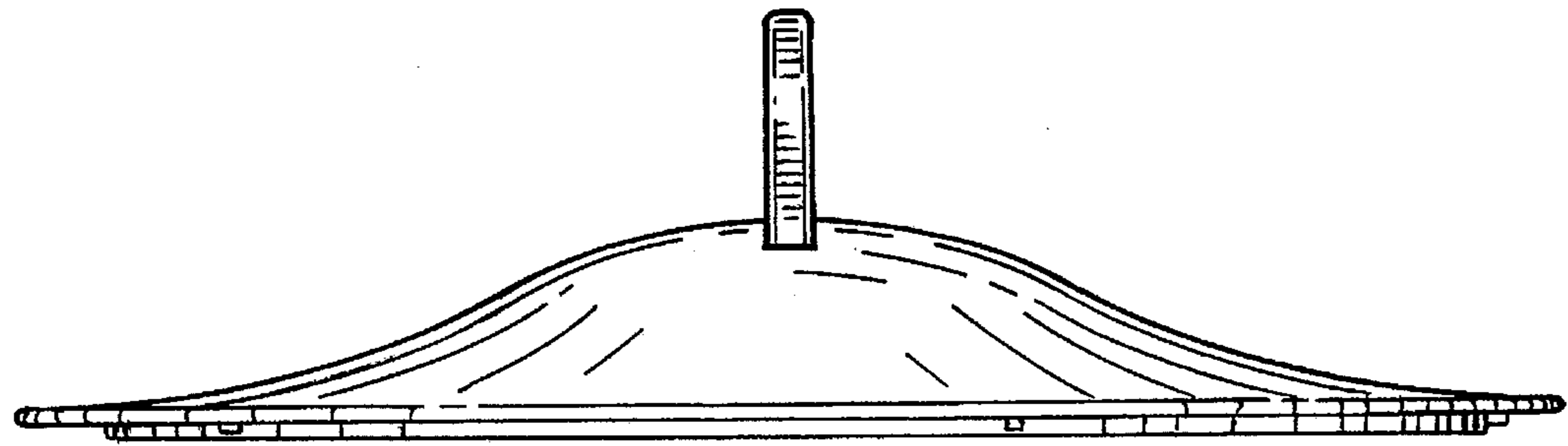

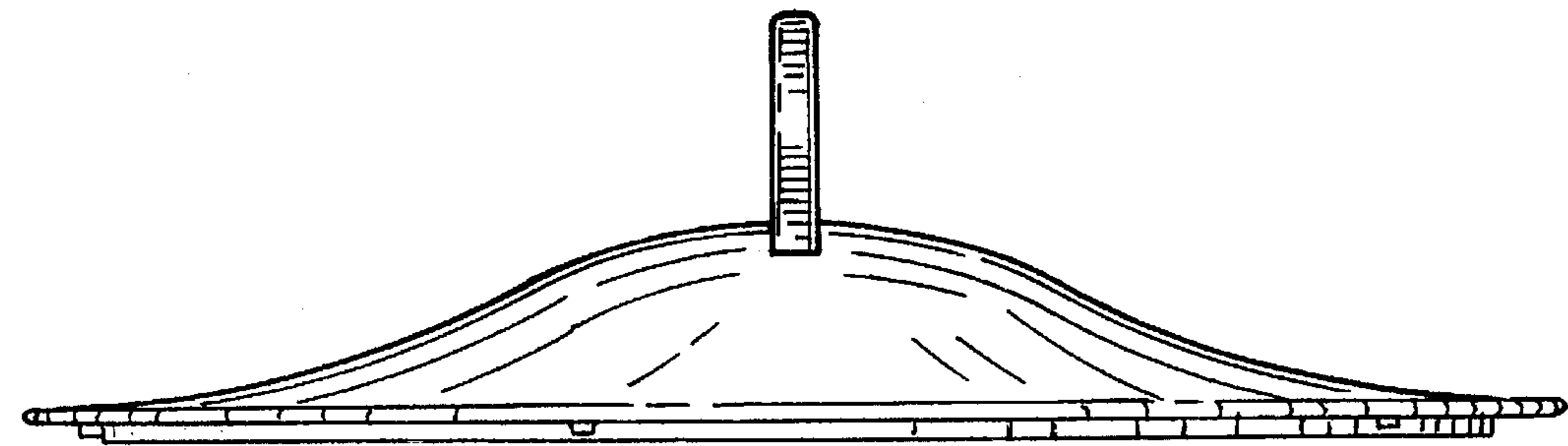

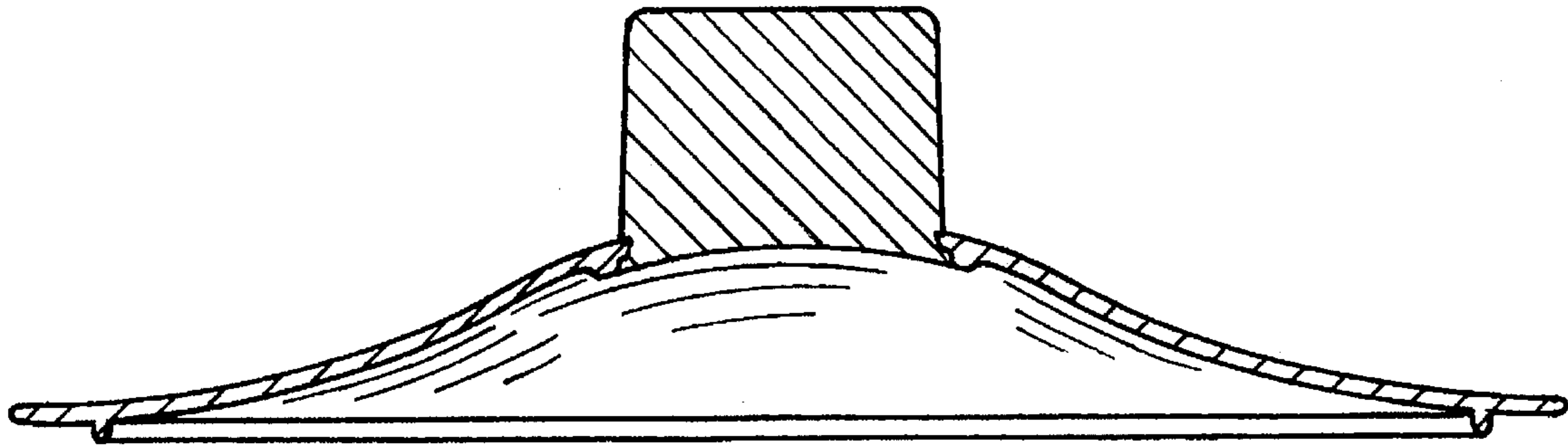

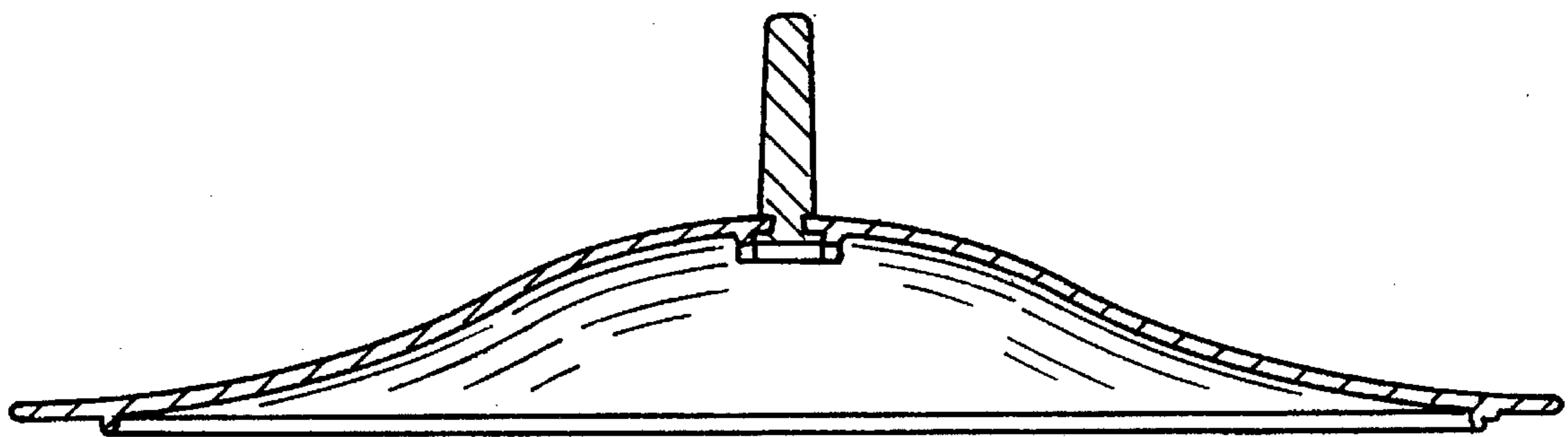
