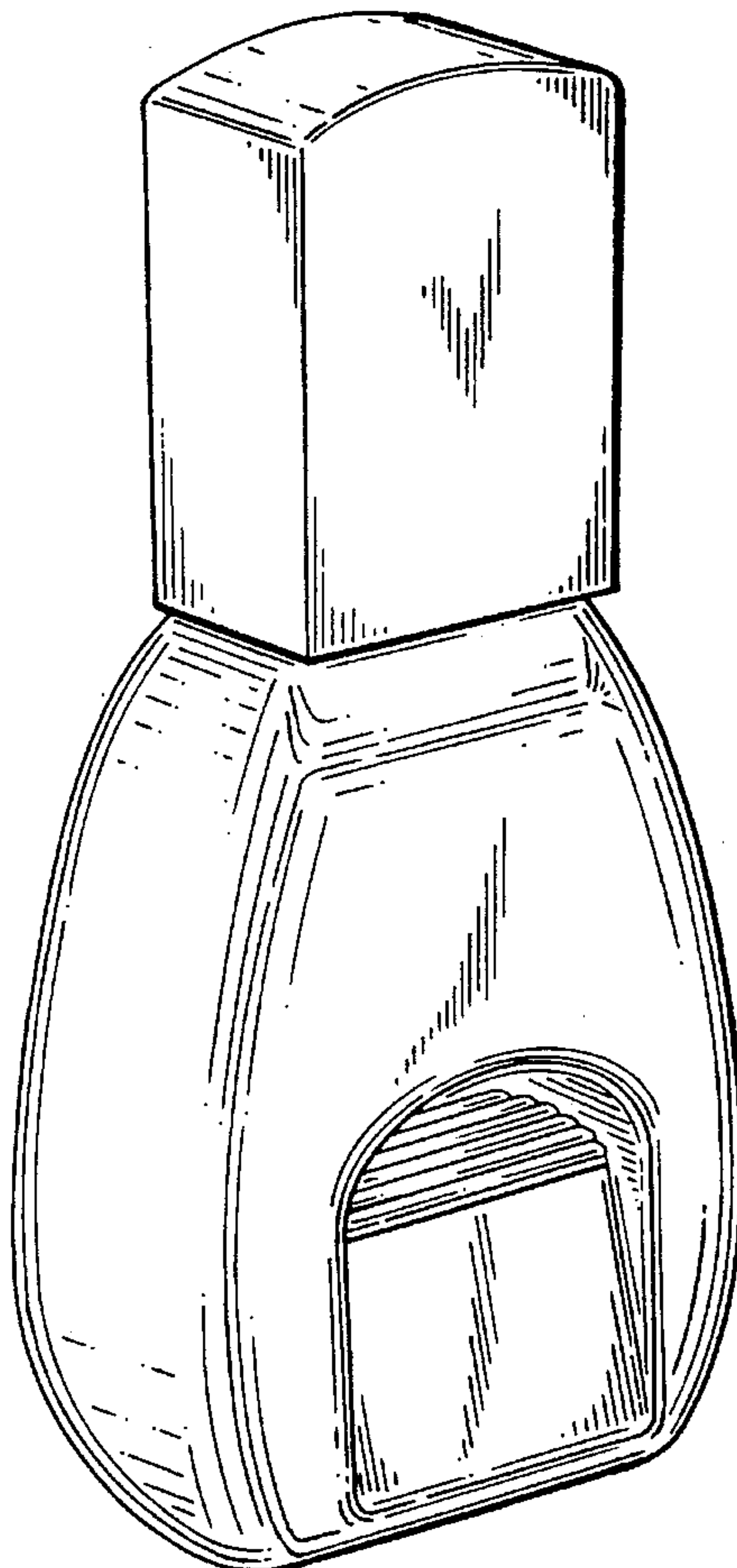
FIG. 1 is a perspective view of a spray bottle showing our new design, shown without a cap;

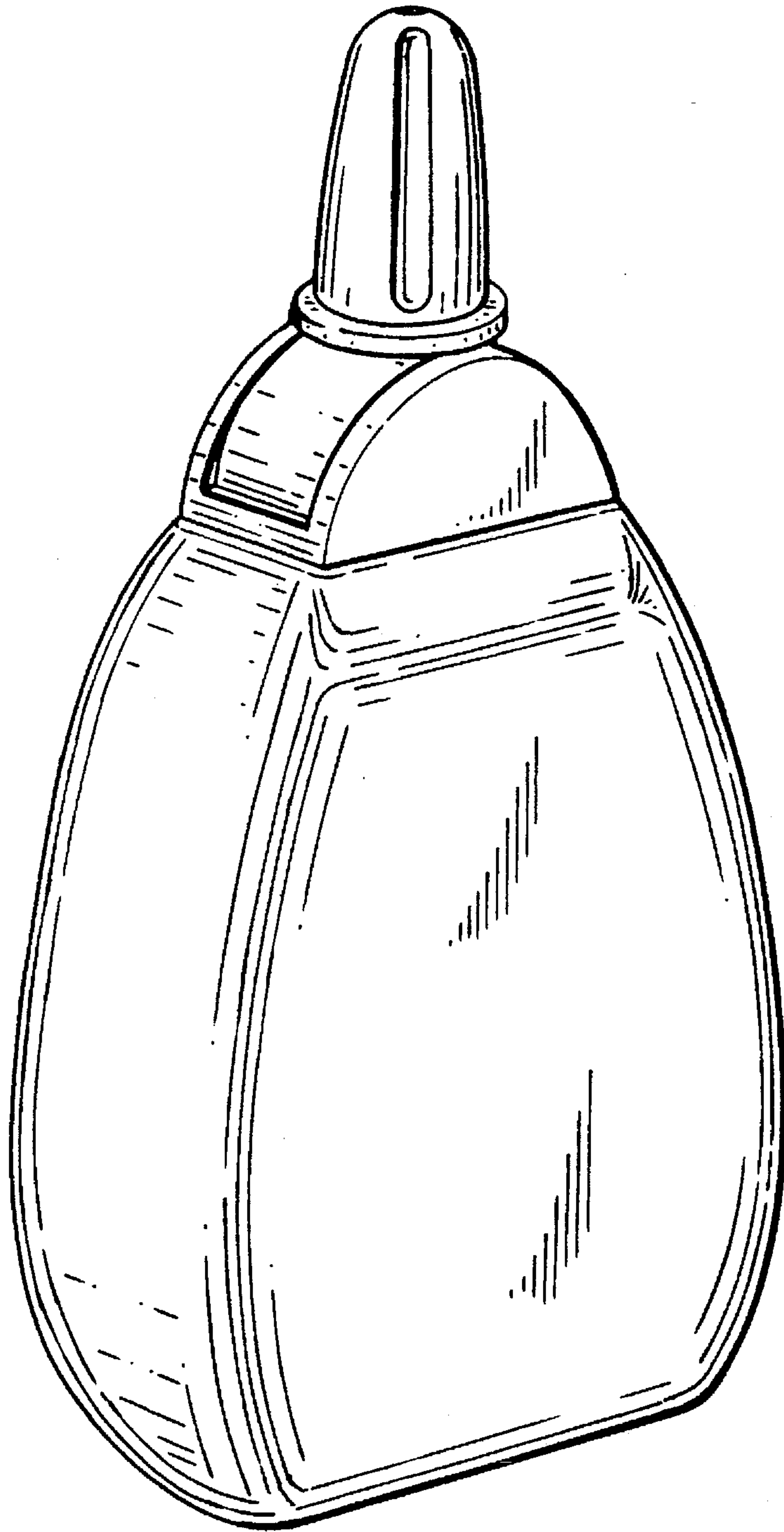

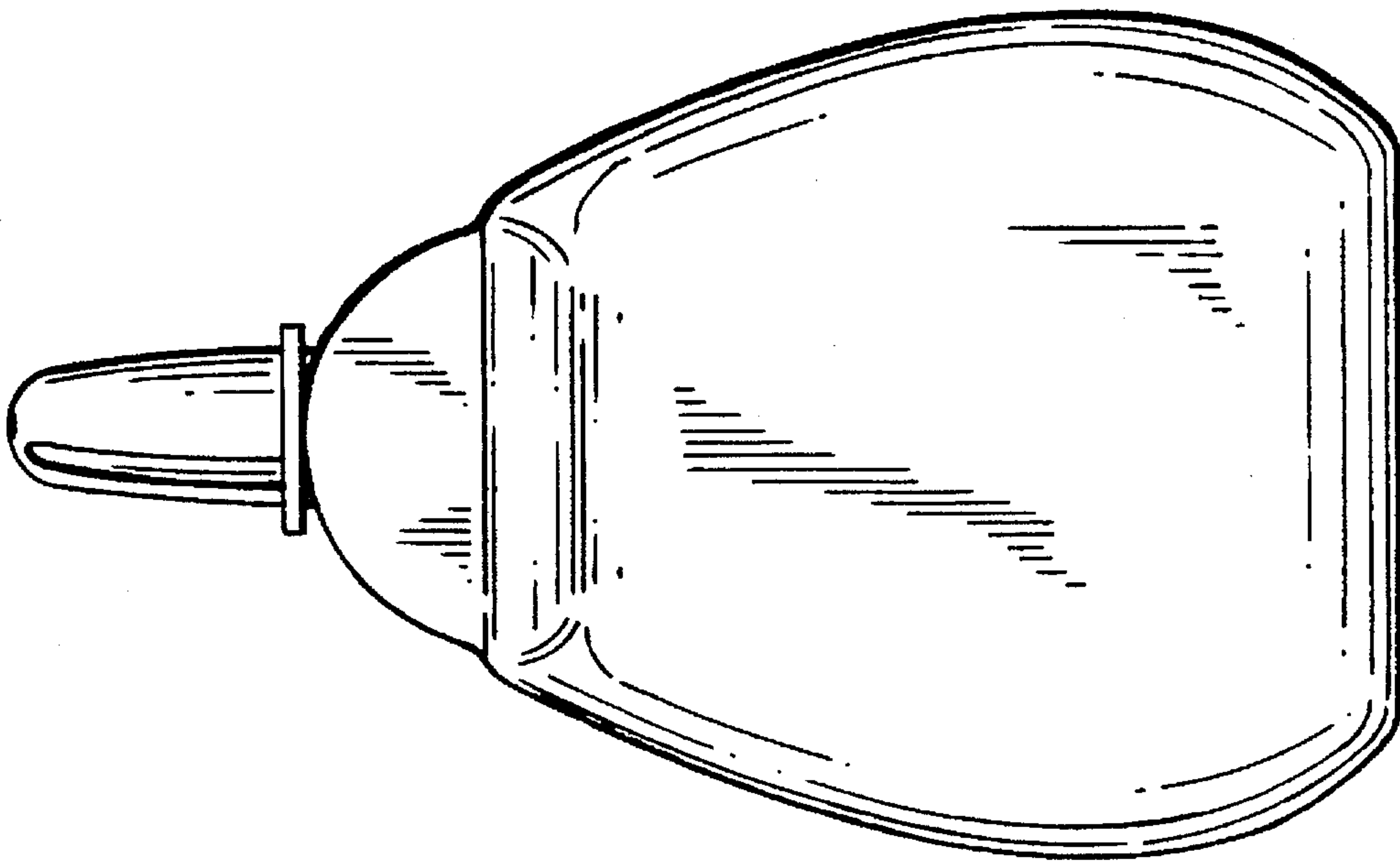

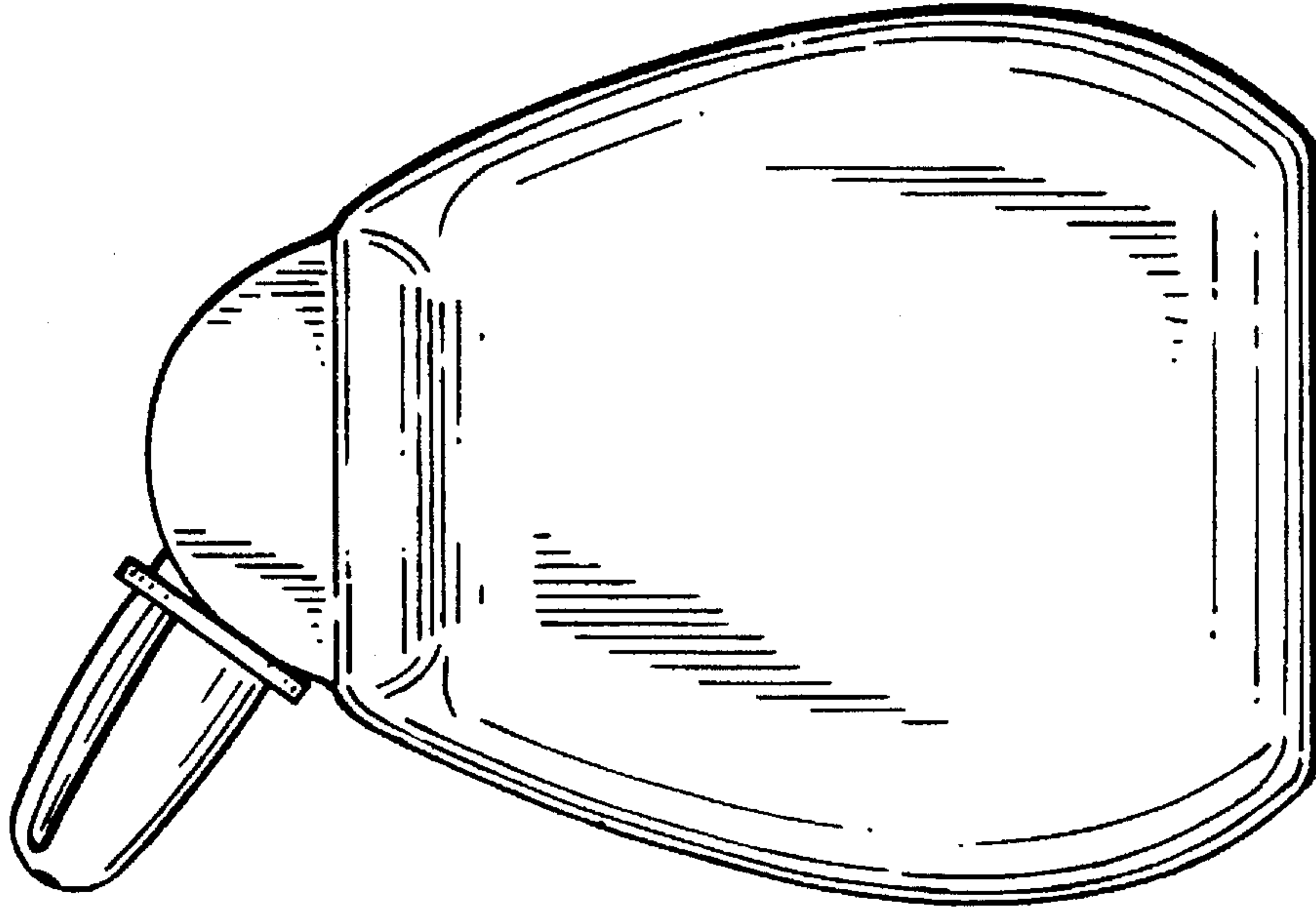

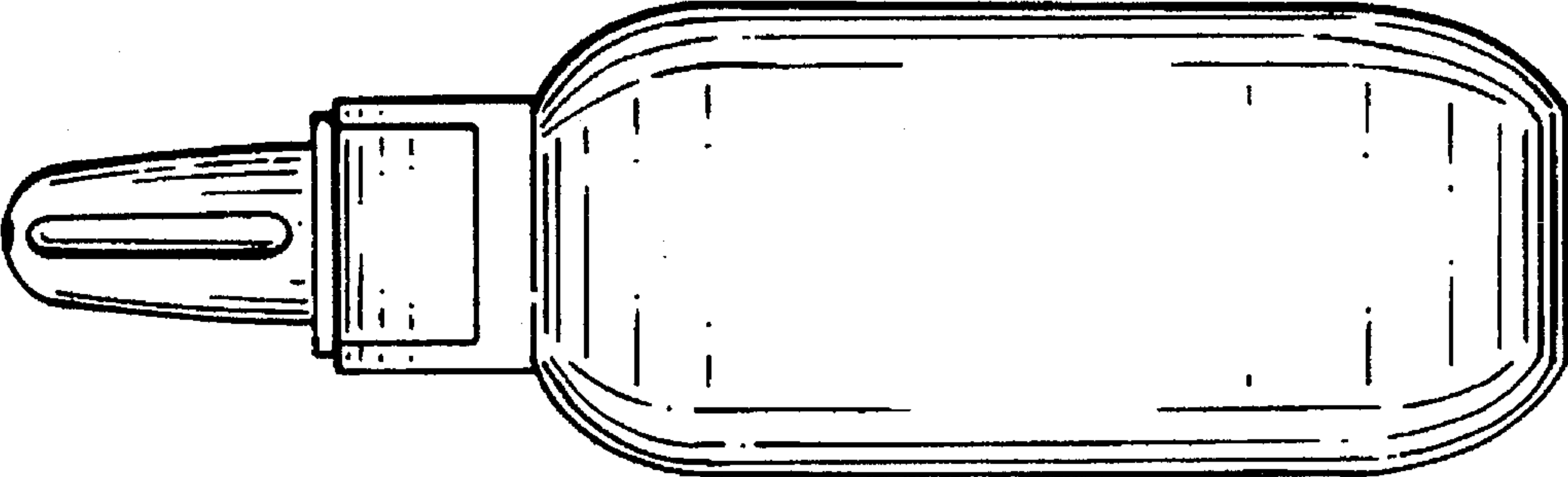

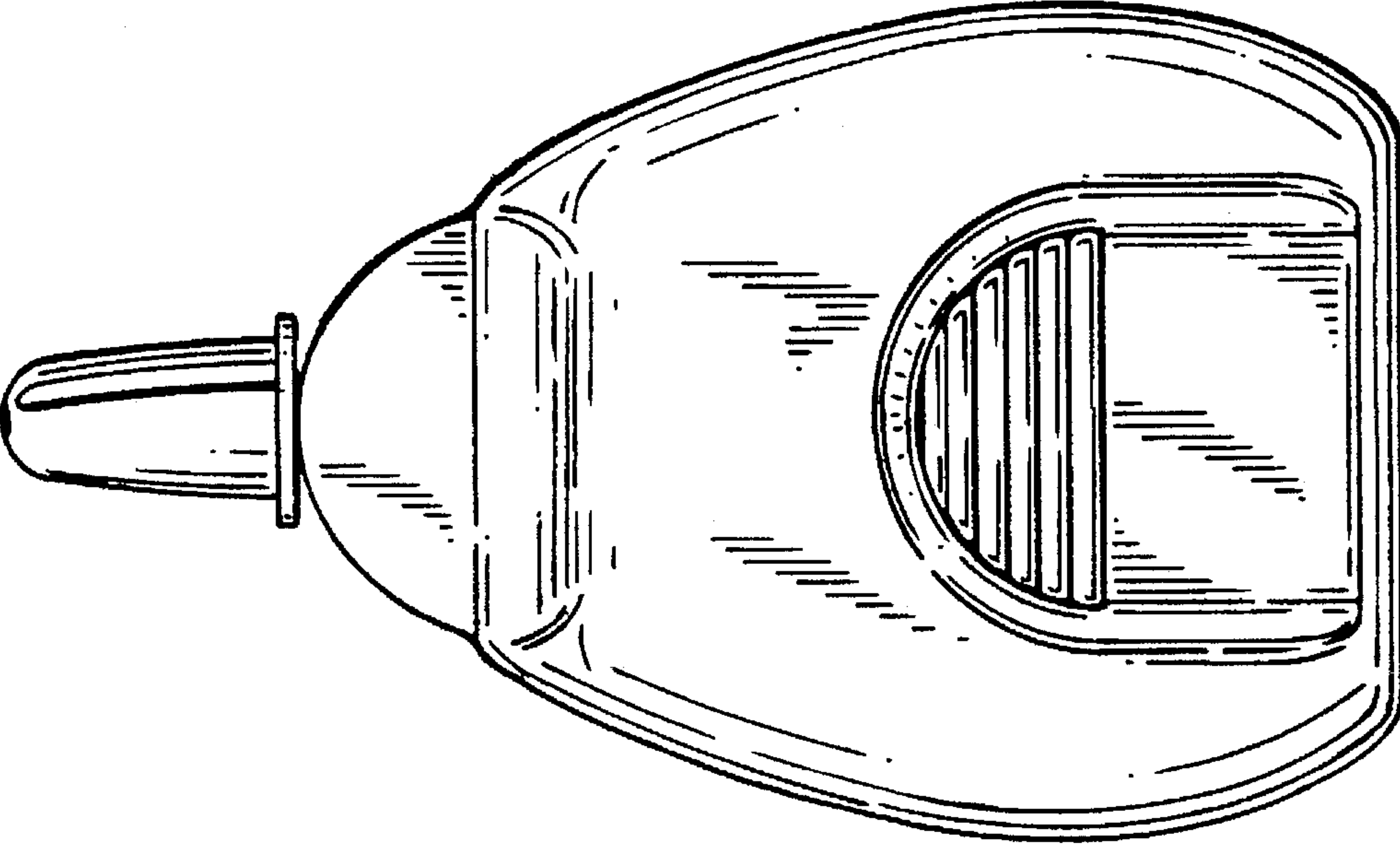

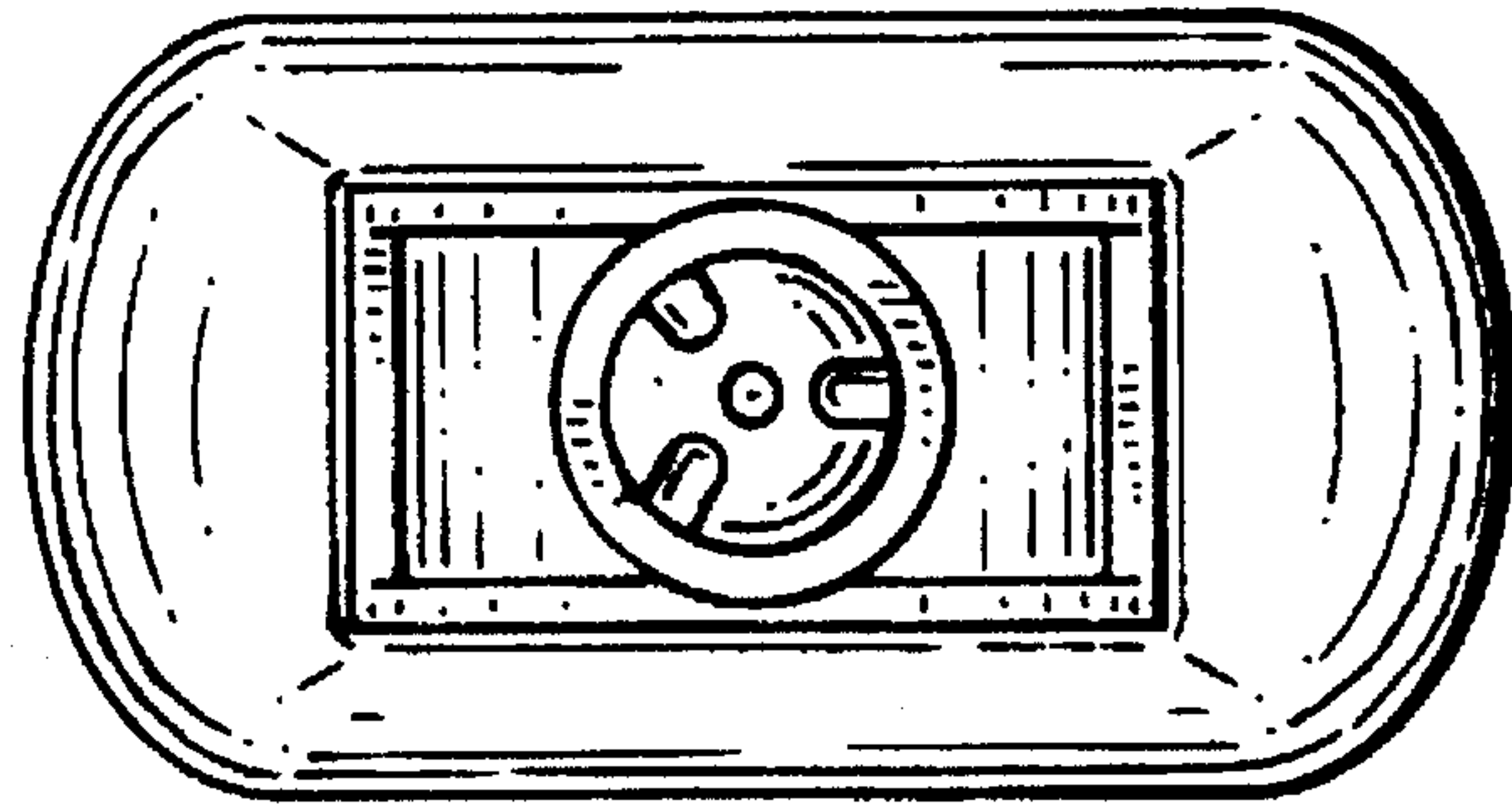

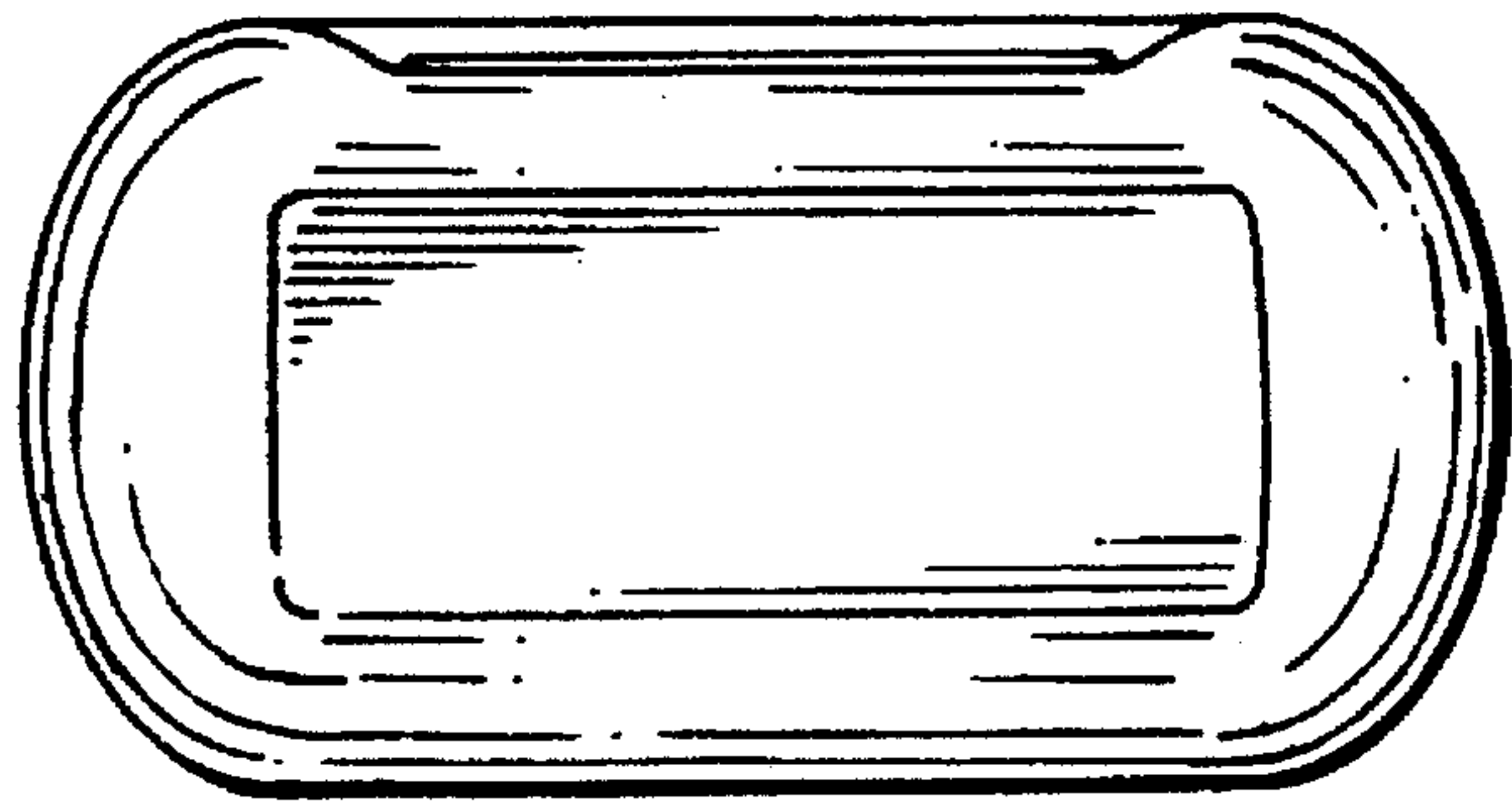

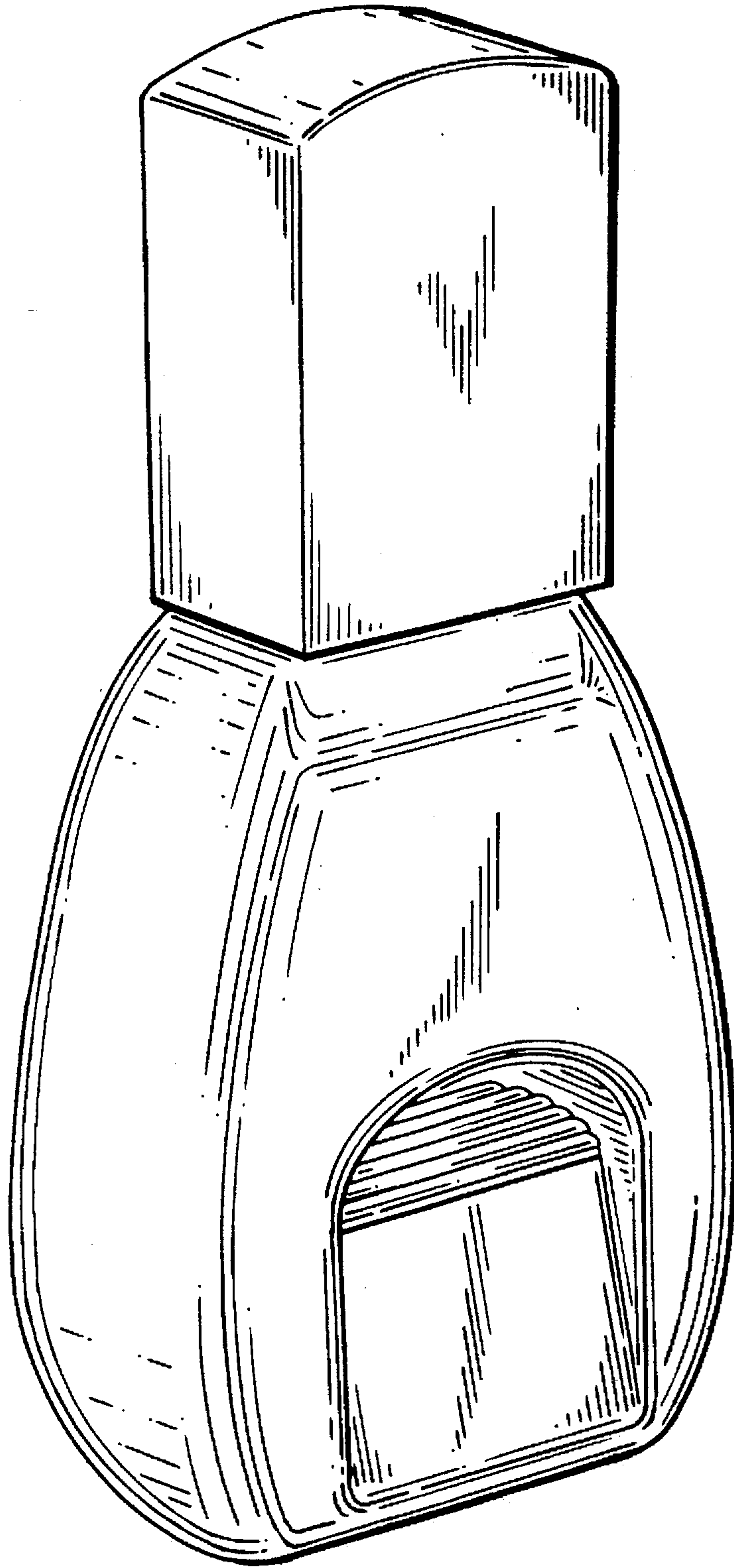

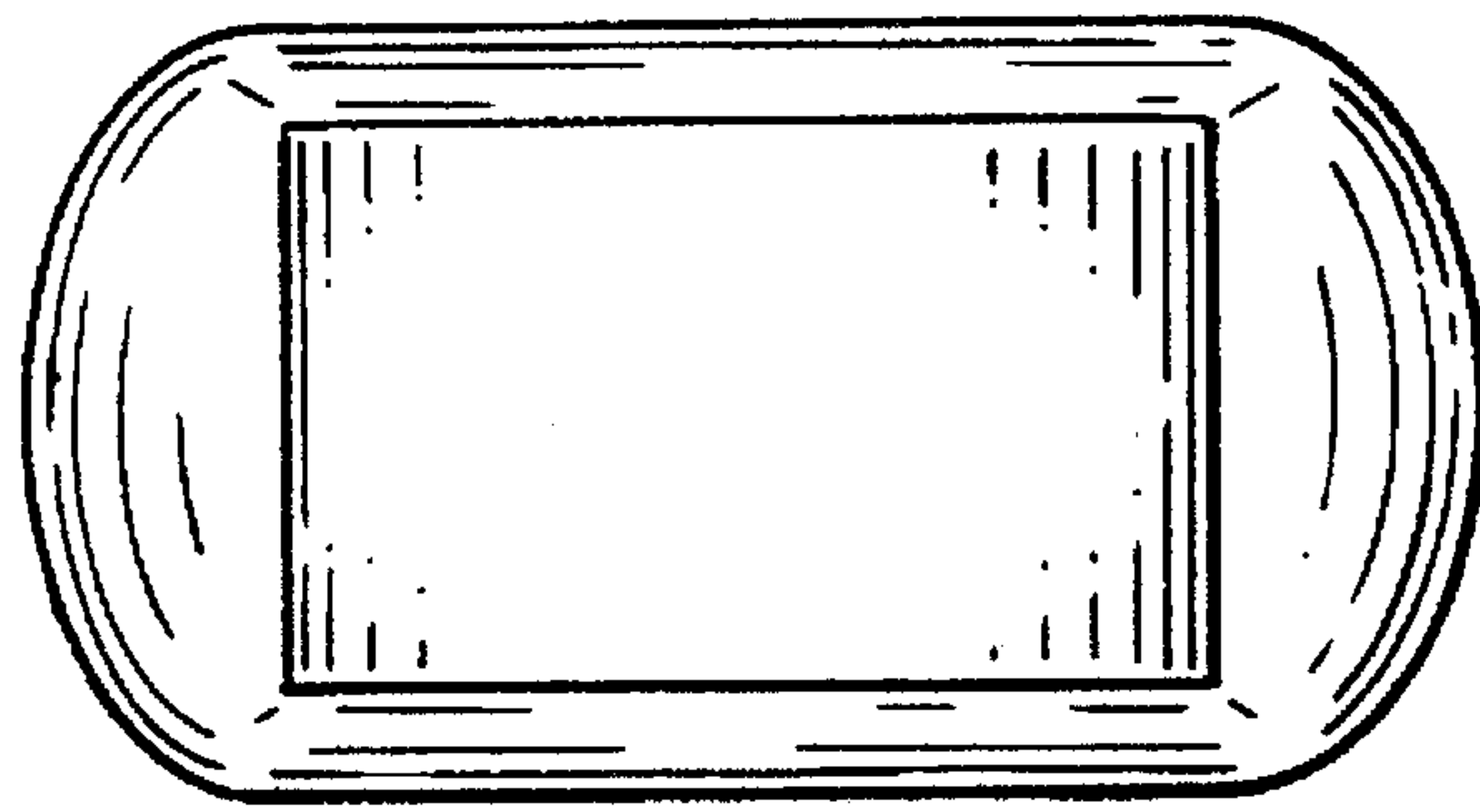
