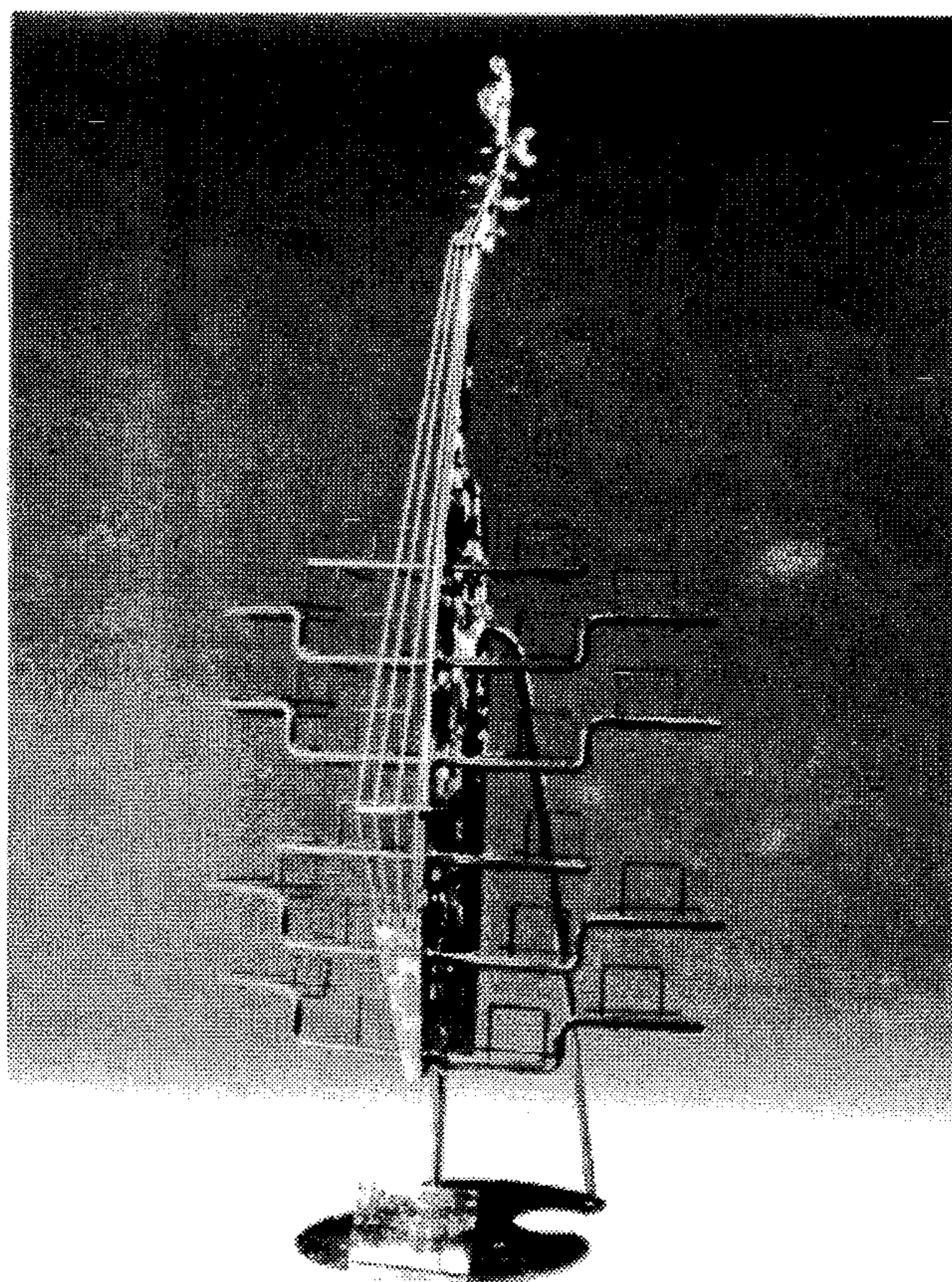
The ornamental design for a CD cassette stand, as shown and described.

DESCRIPTION

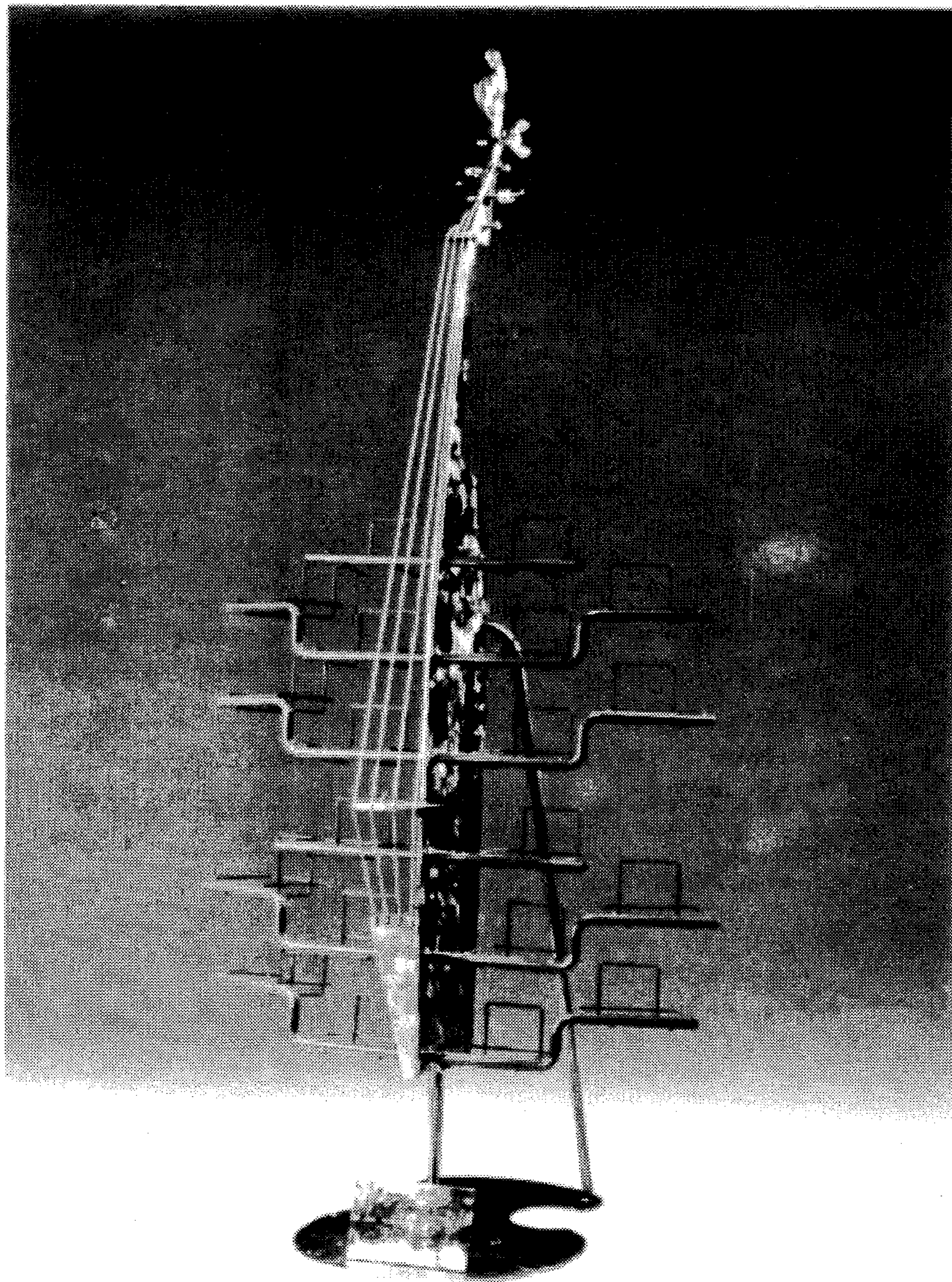

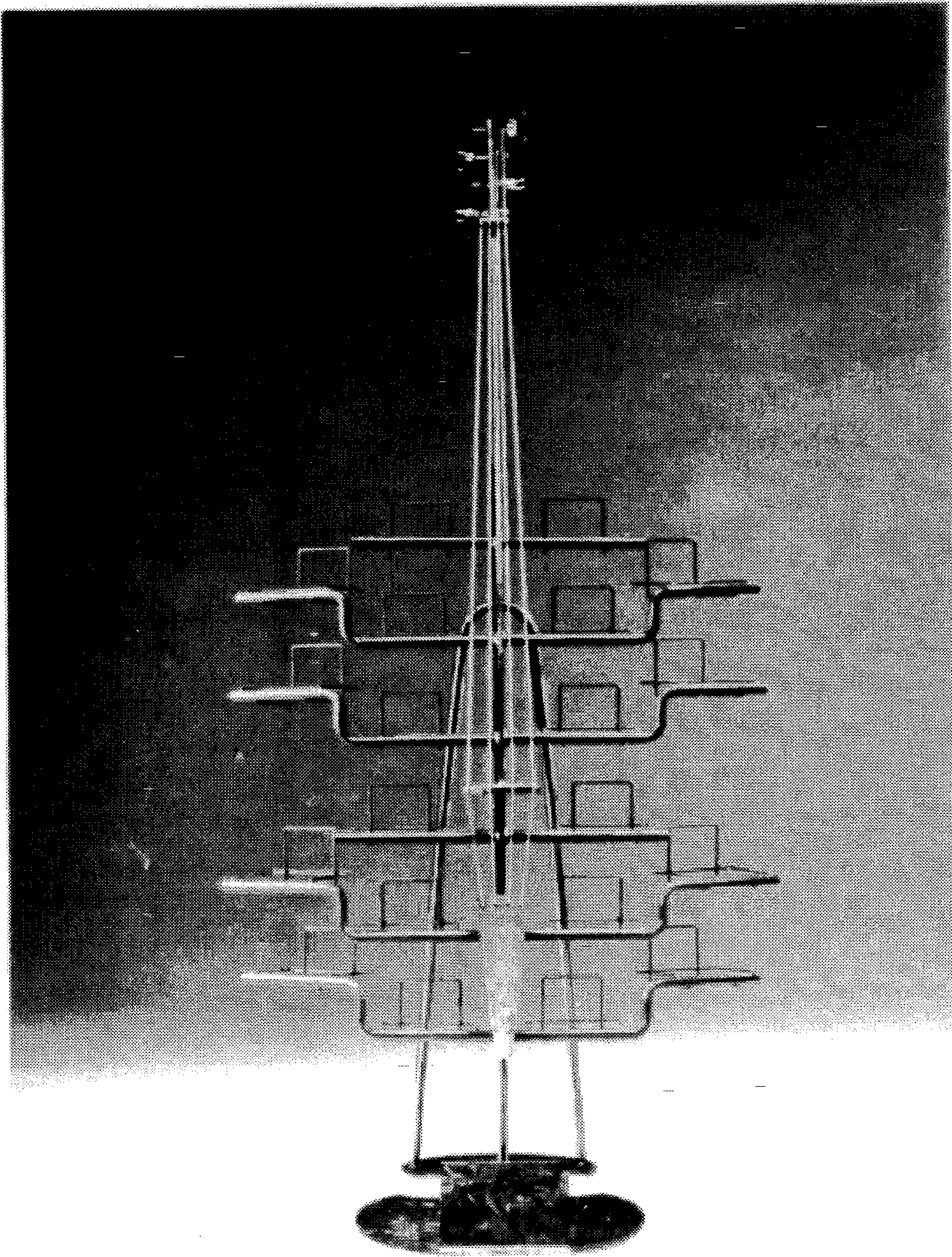

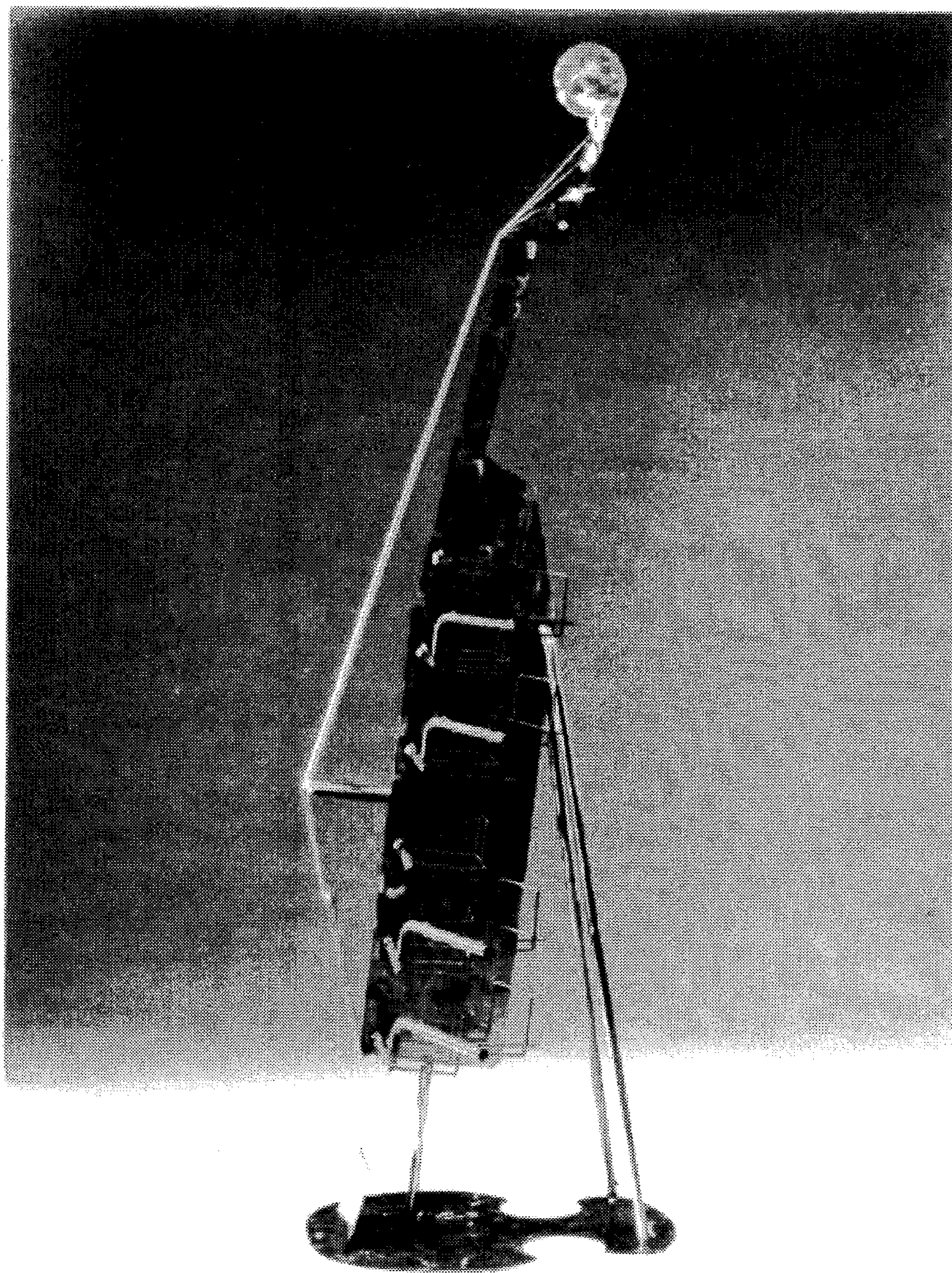

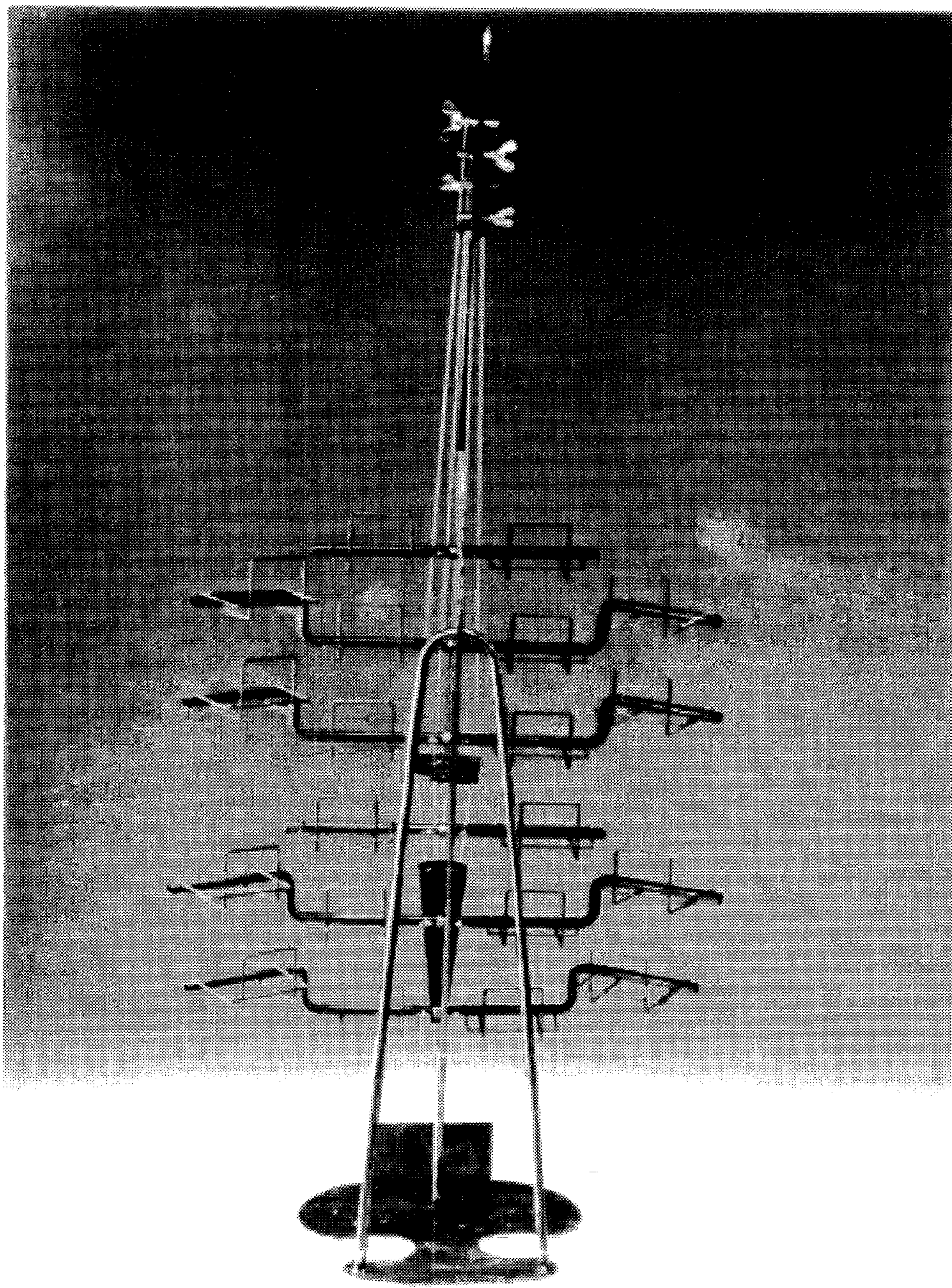
