### DESCRIPTION

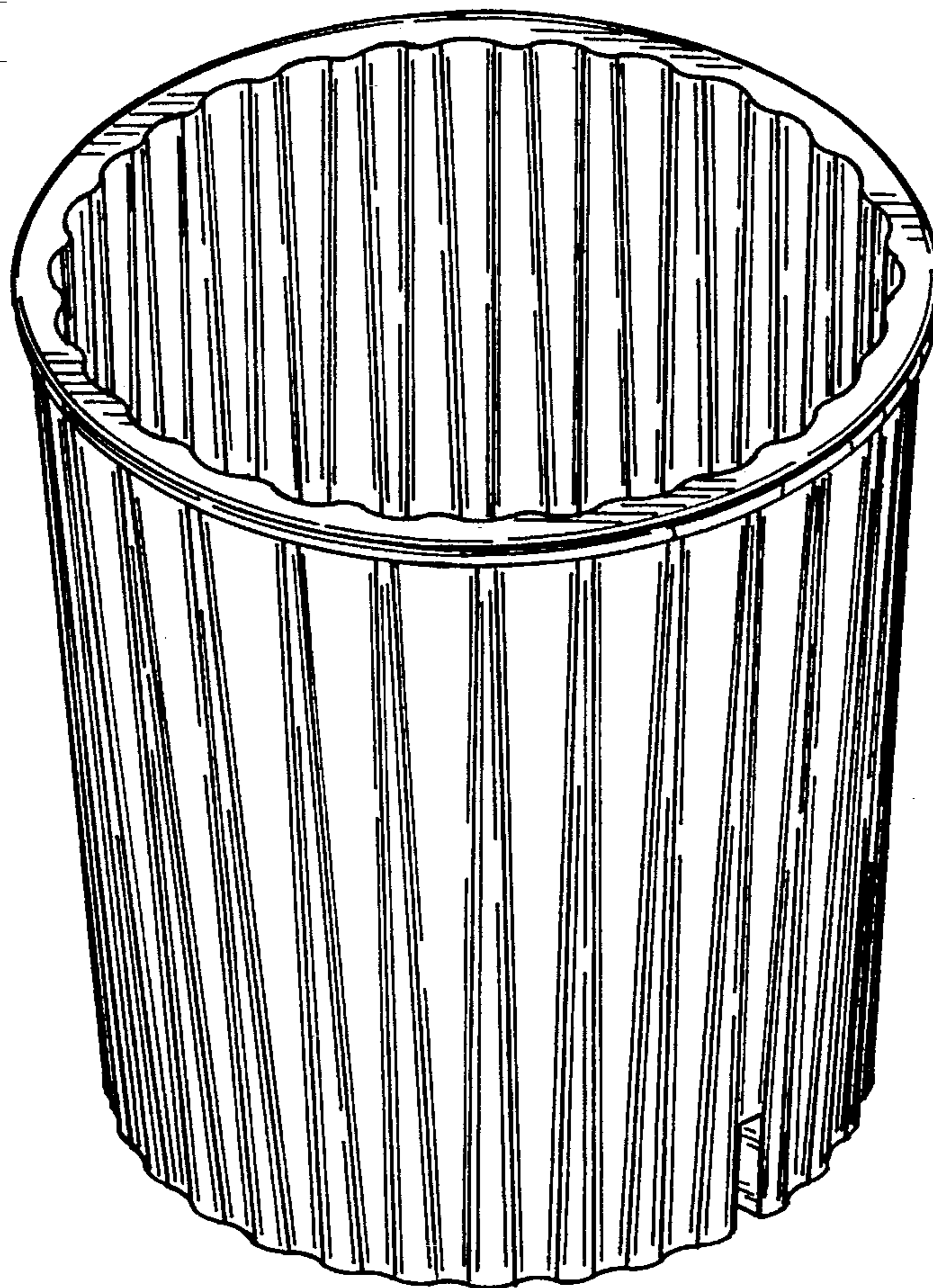
FIG. 1 shows a perspective view of the cocktail glass of this invention;

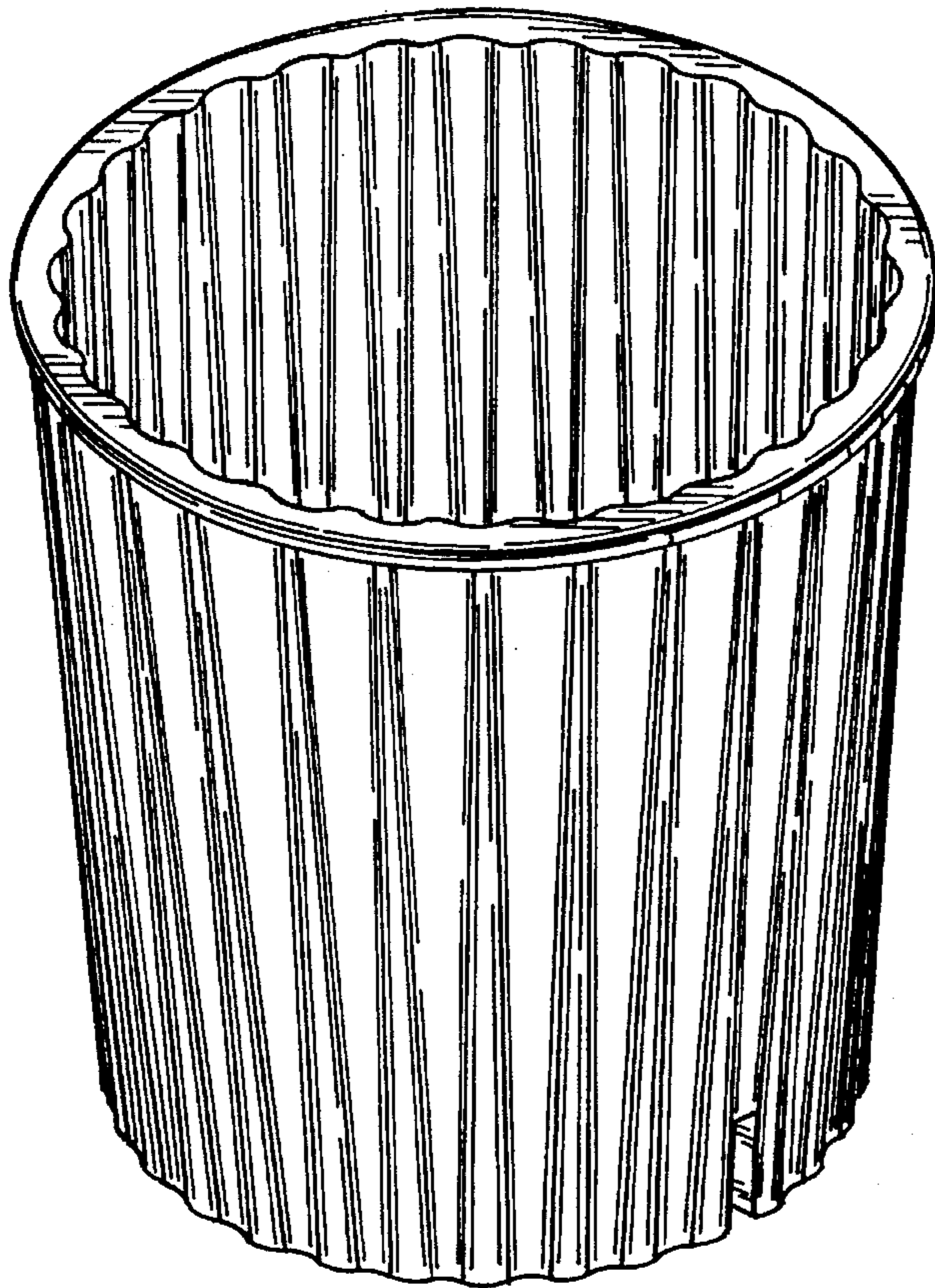
FIG. 2 shows a side elevation view of the cocktail glass;

FIG. 3 shows a view looking downwardly into the cocktail glass from the top; and,

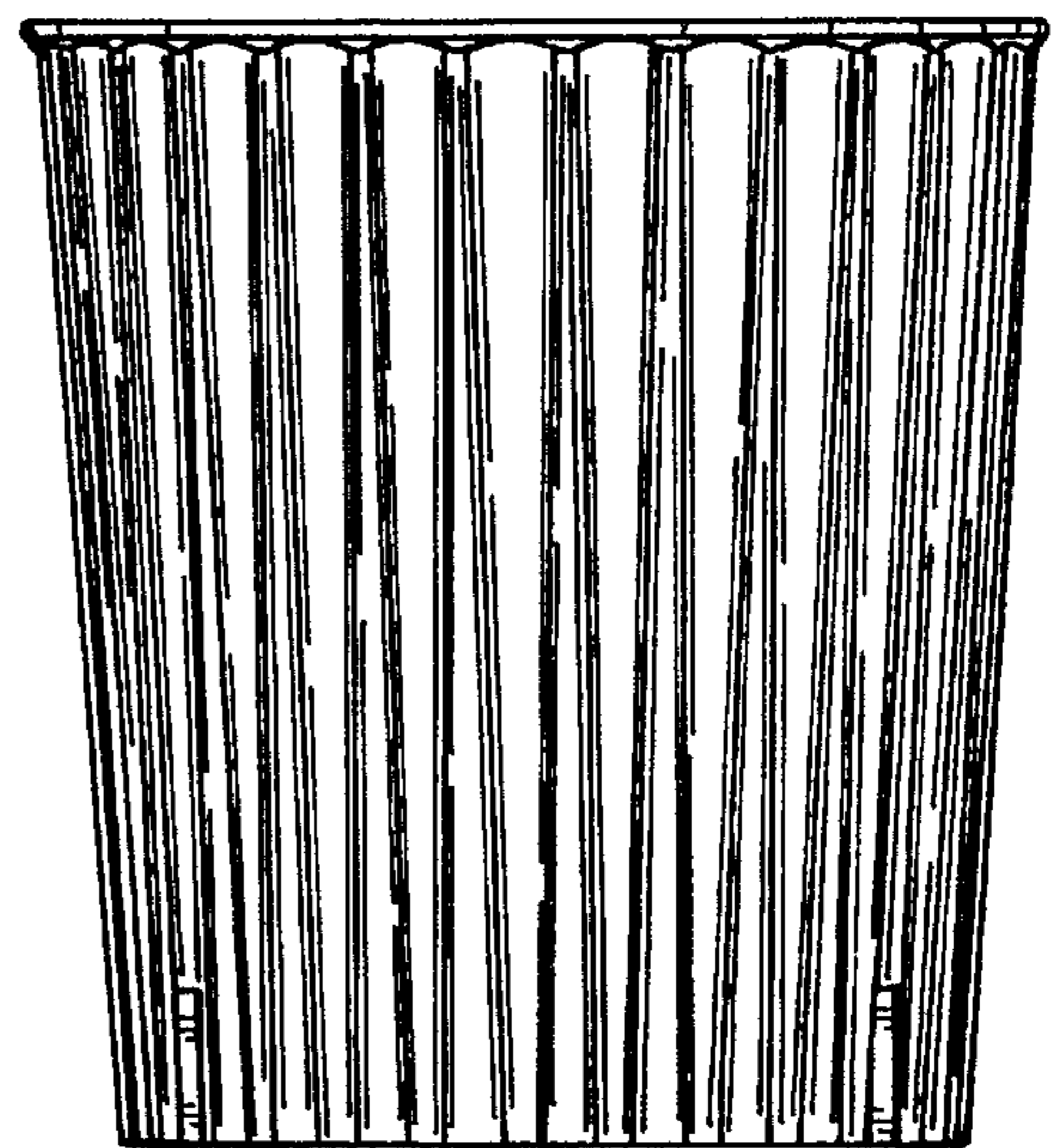
FIG. 4 shows a bottom plan view of the cocktail glass.

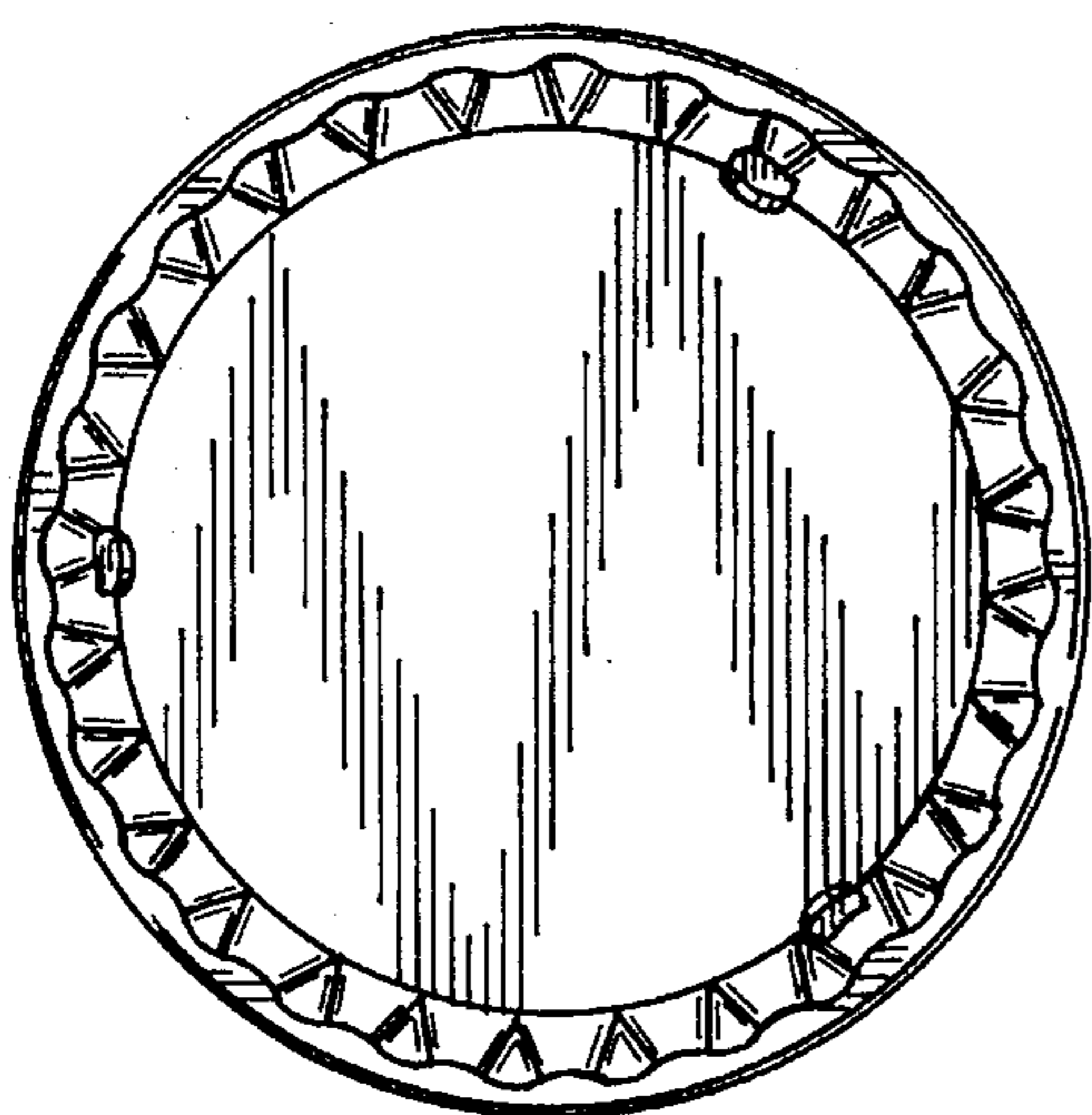




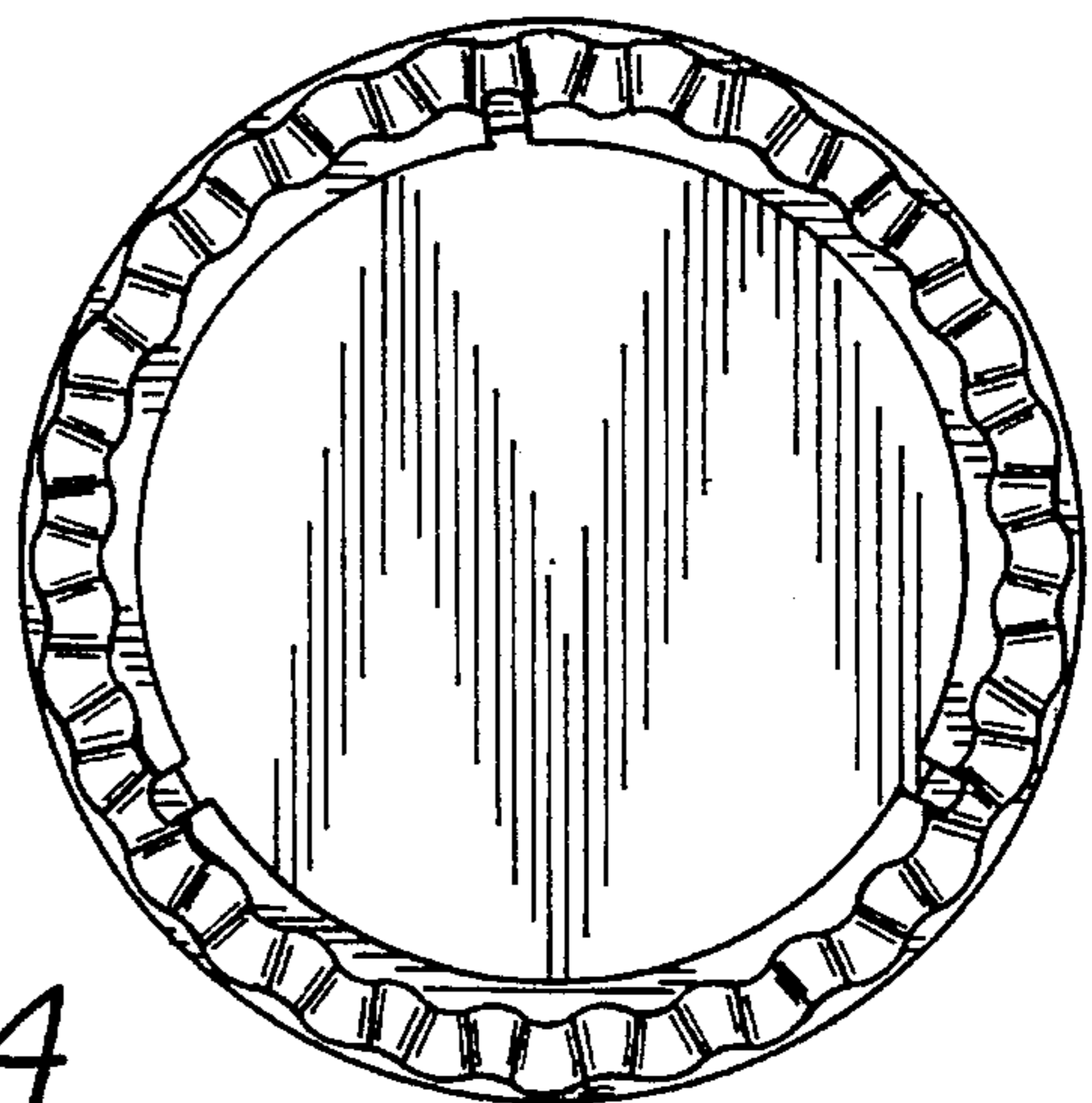
