The ornamental design for a vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the vehicle of the invention, as viewed from the top, left-hand side with the rear fins closed;

FIG. 2 is a front view of the vehicle of the invention, with the rear fins closed;

FIG. 3 is a side view of the vehicle of the invention with the rear fins closed;

FIG. 4 is a top plan view of the vehicle of the invention with the rear fins closed;

FIG. 5 is a rear view of the vehicle of the invention with the rear fins closed;

FIG. 6 is a front perspective view of the vehicle of the invention, as viewed from the top, left-hand side, with the rear fins open;

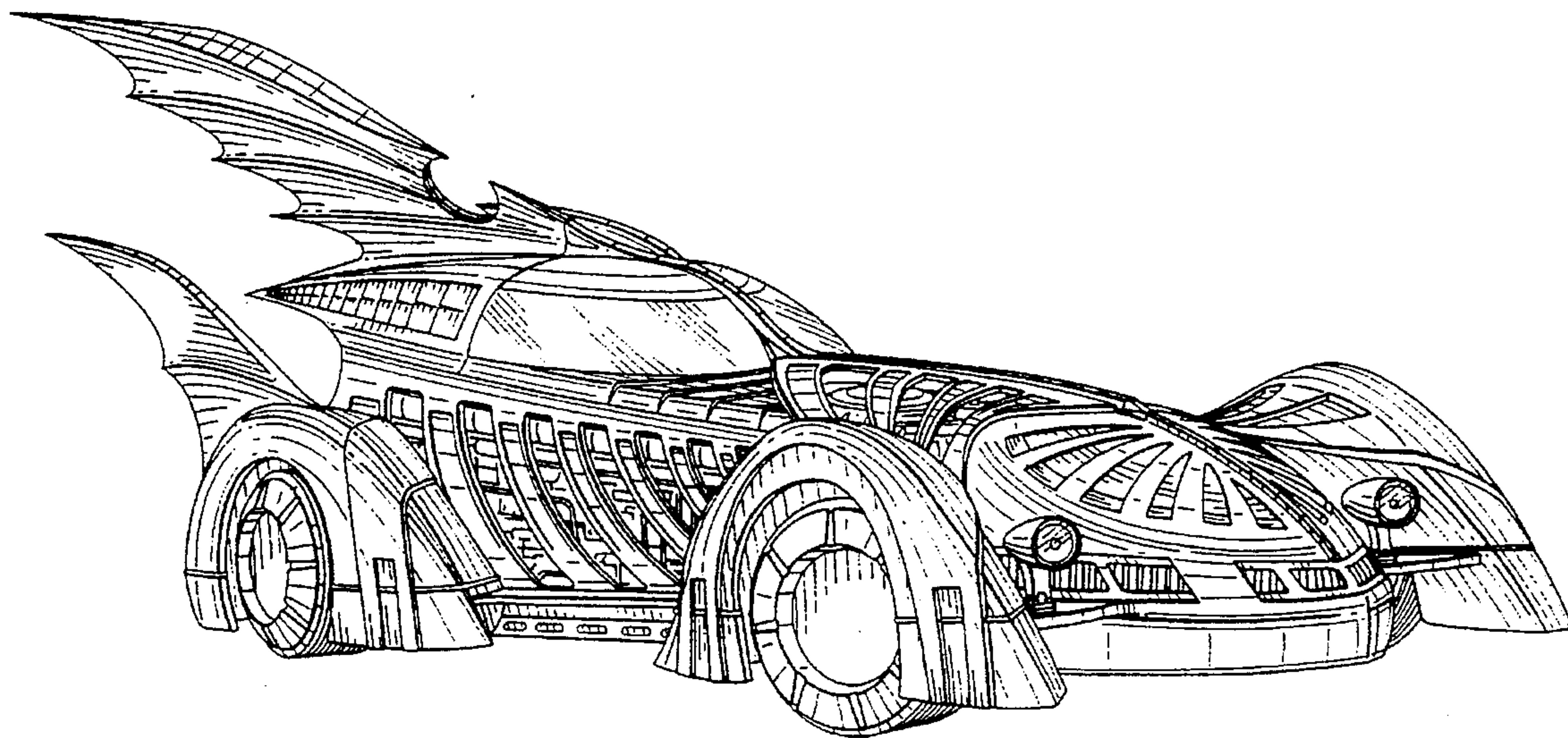
FIG. 7 is a front view of the vehicle of the invention, with the rear fins open;

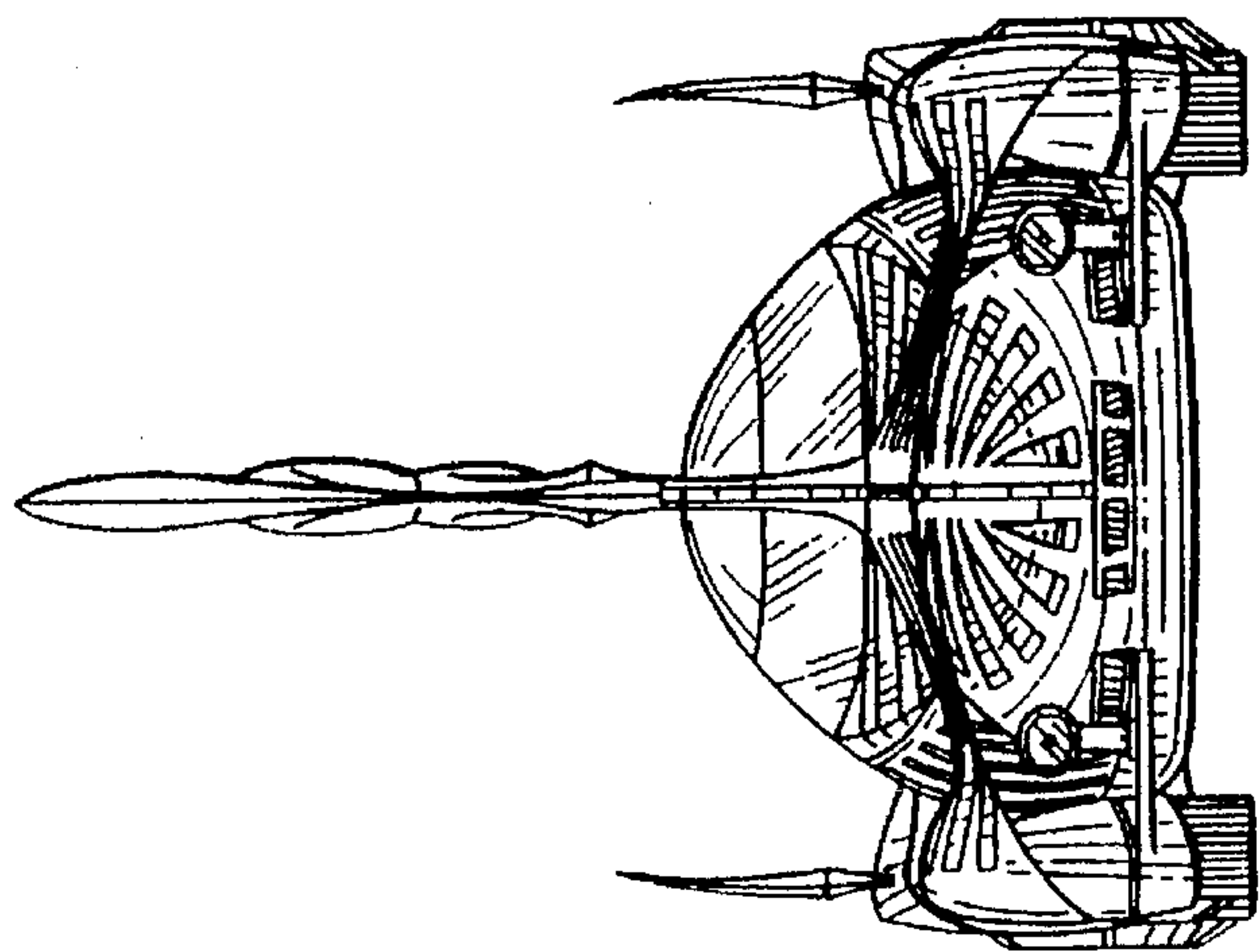
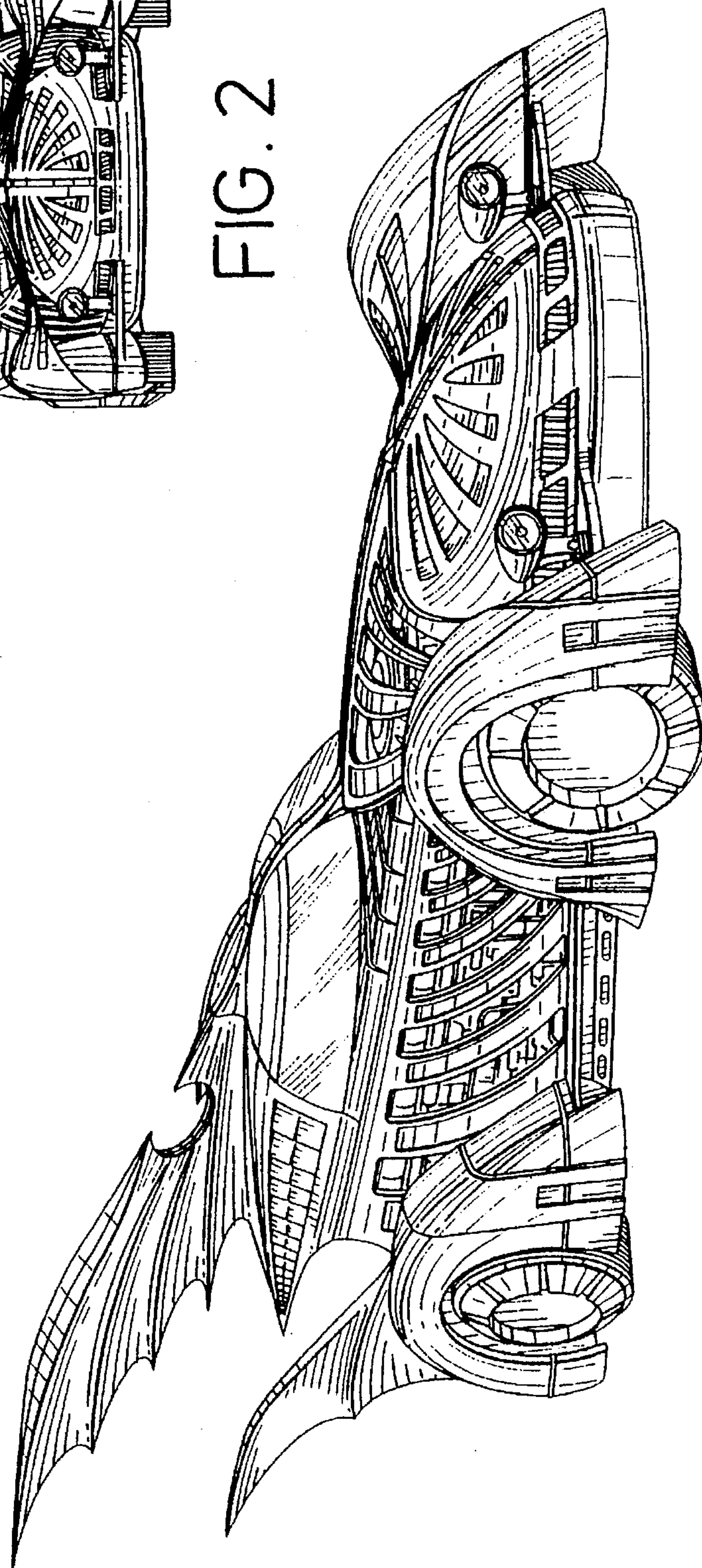

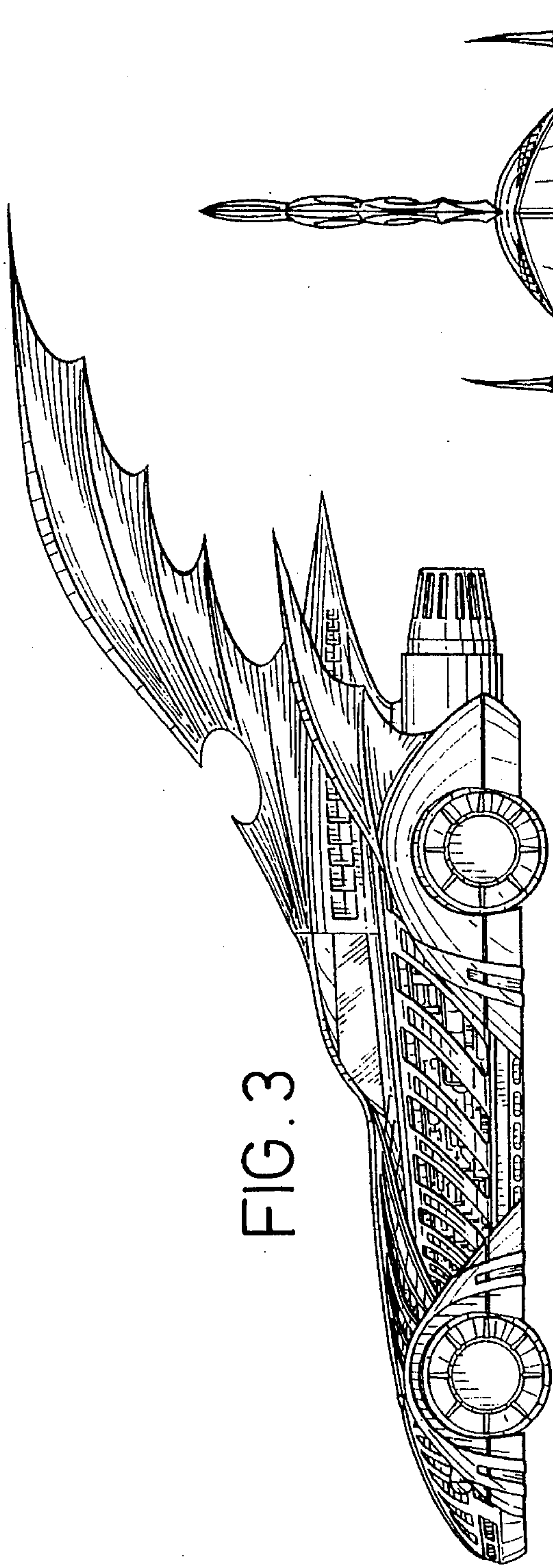

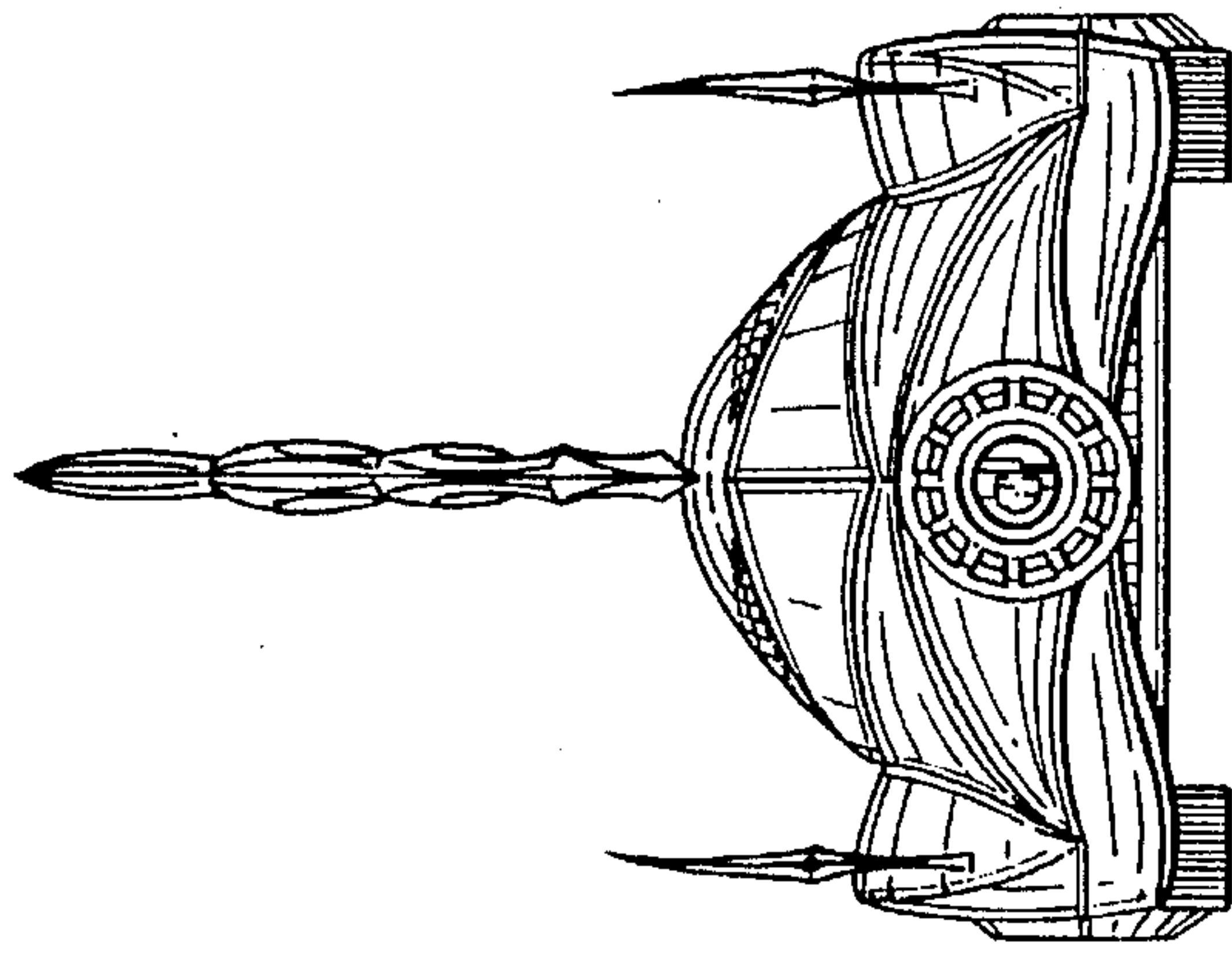

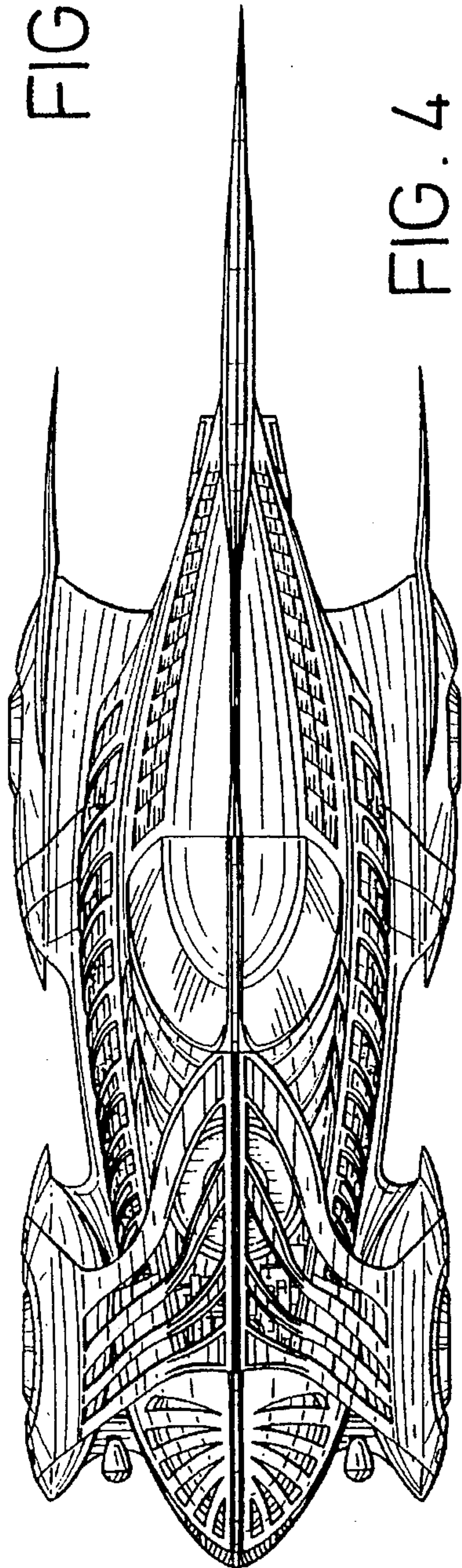

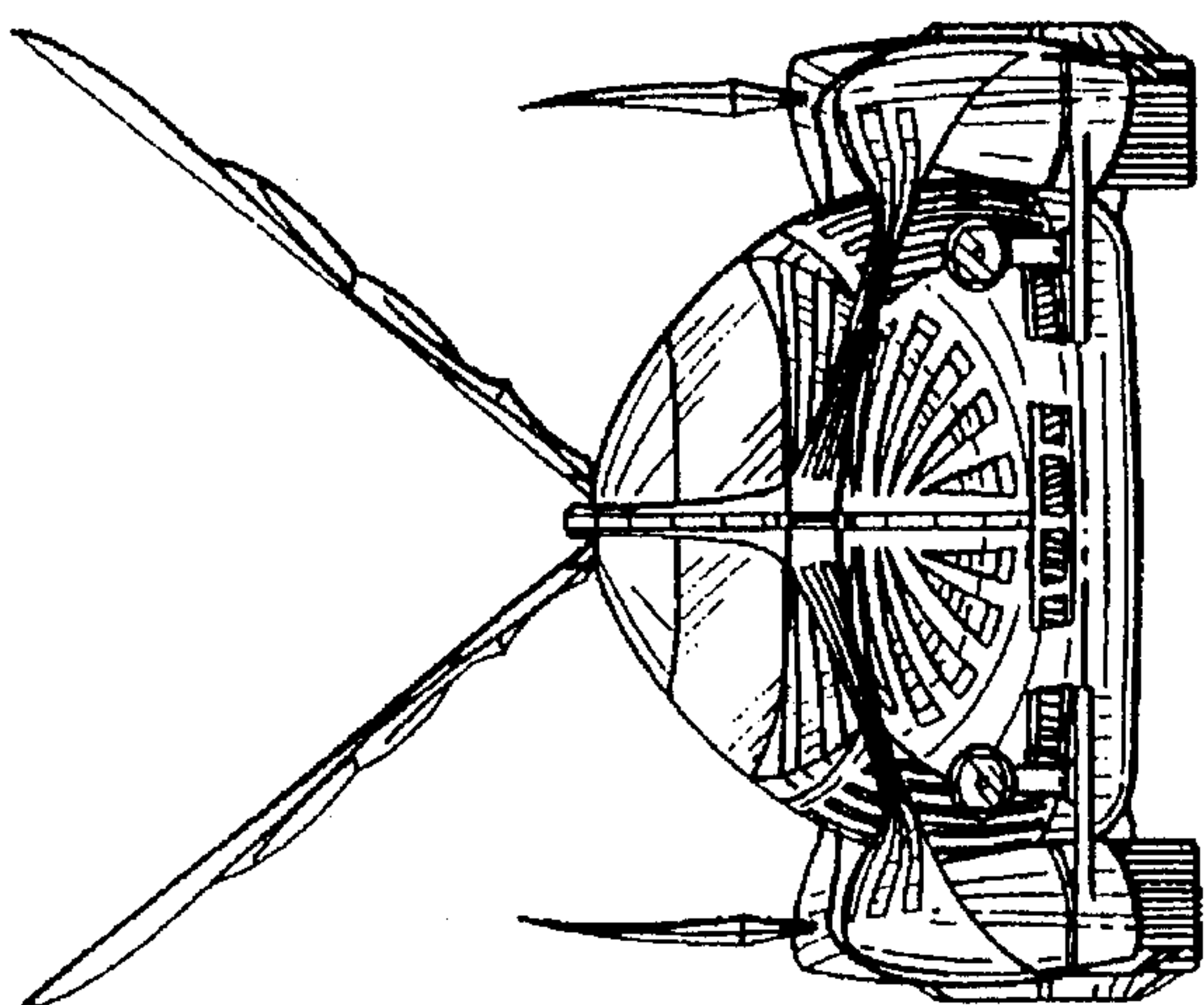
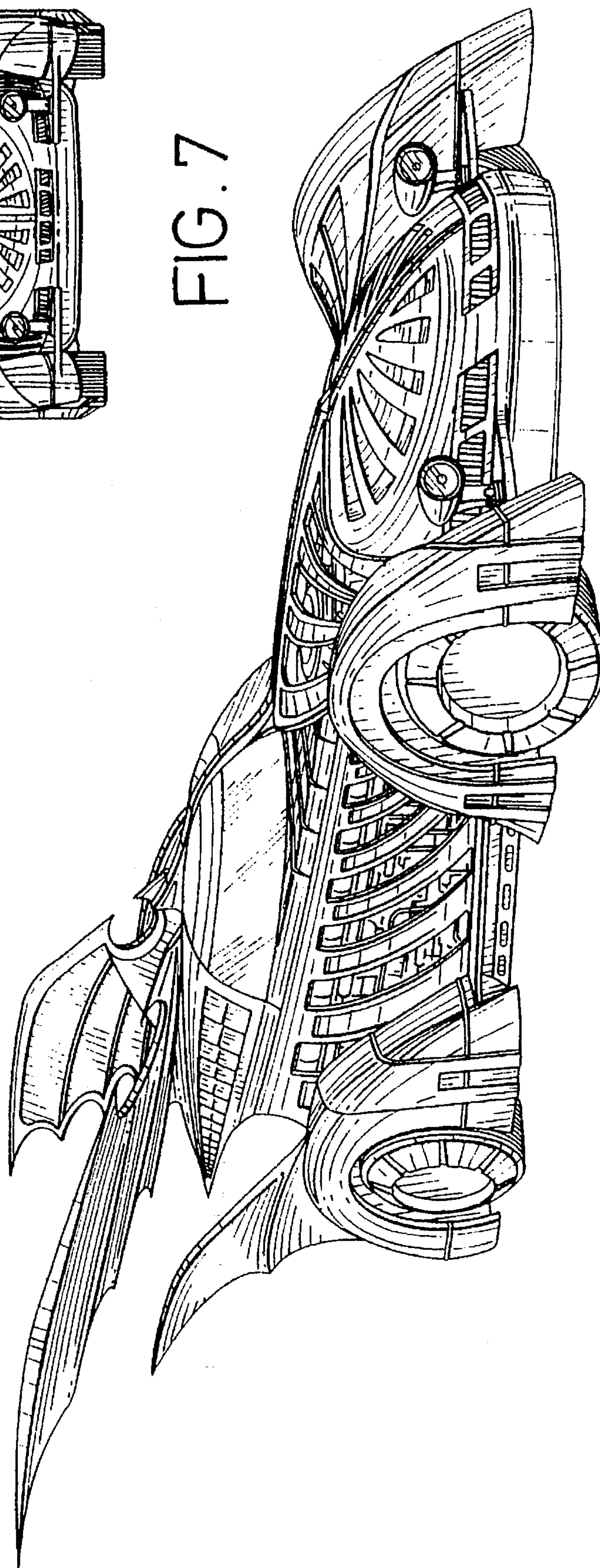

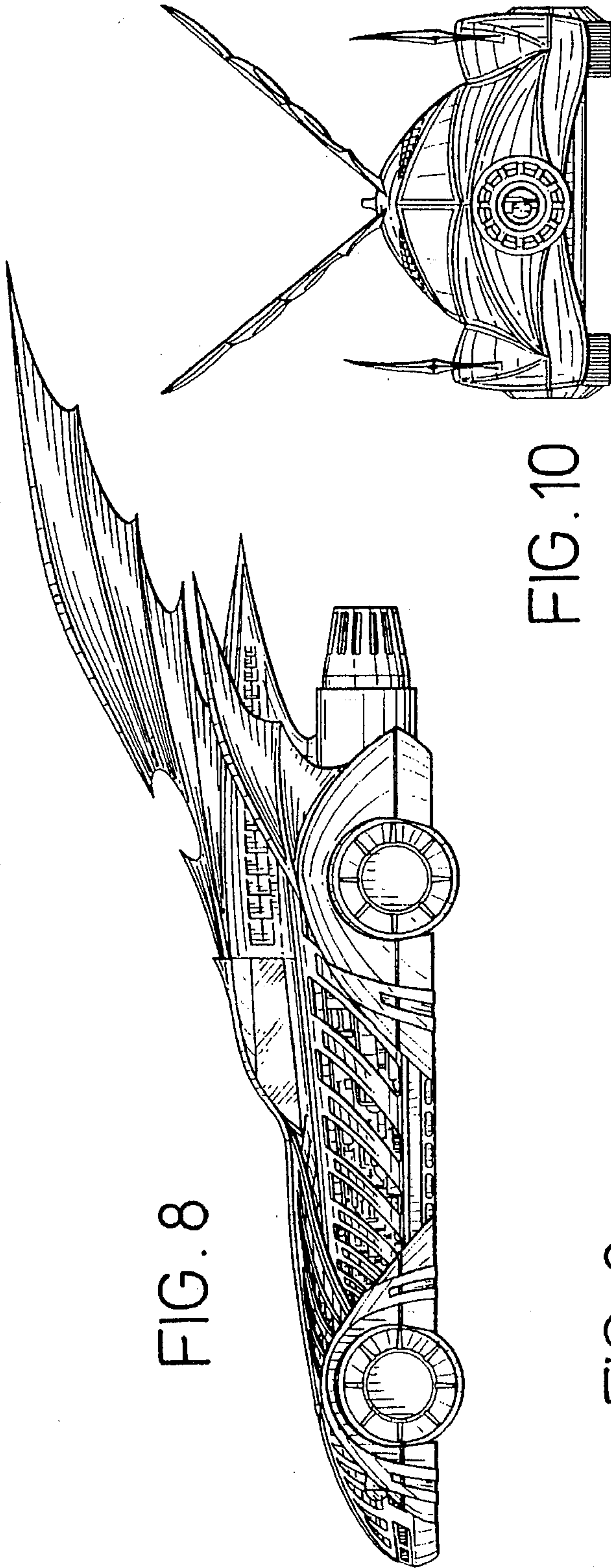

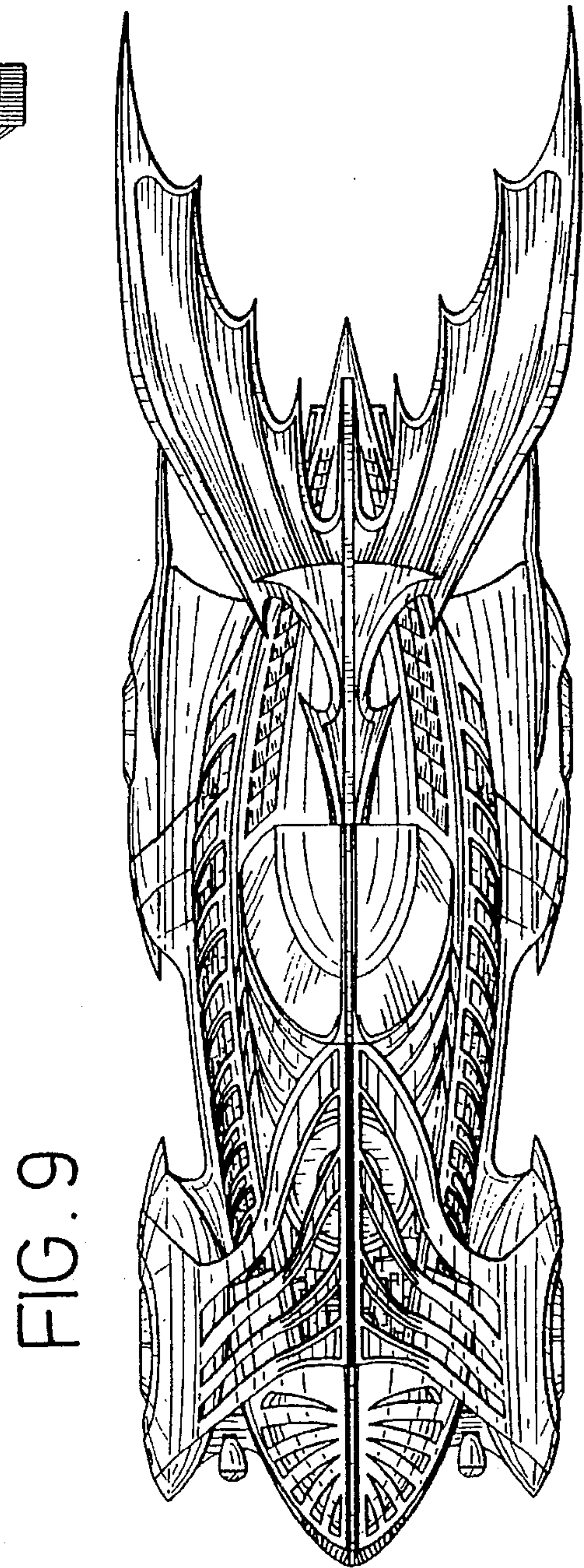
