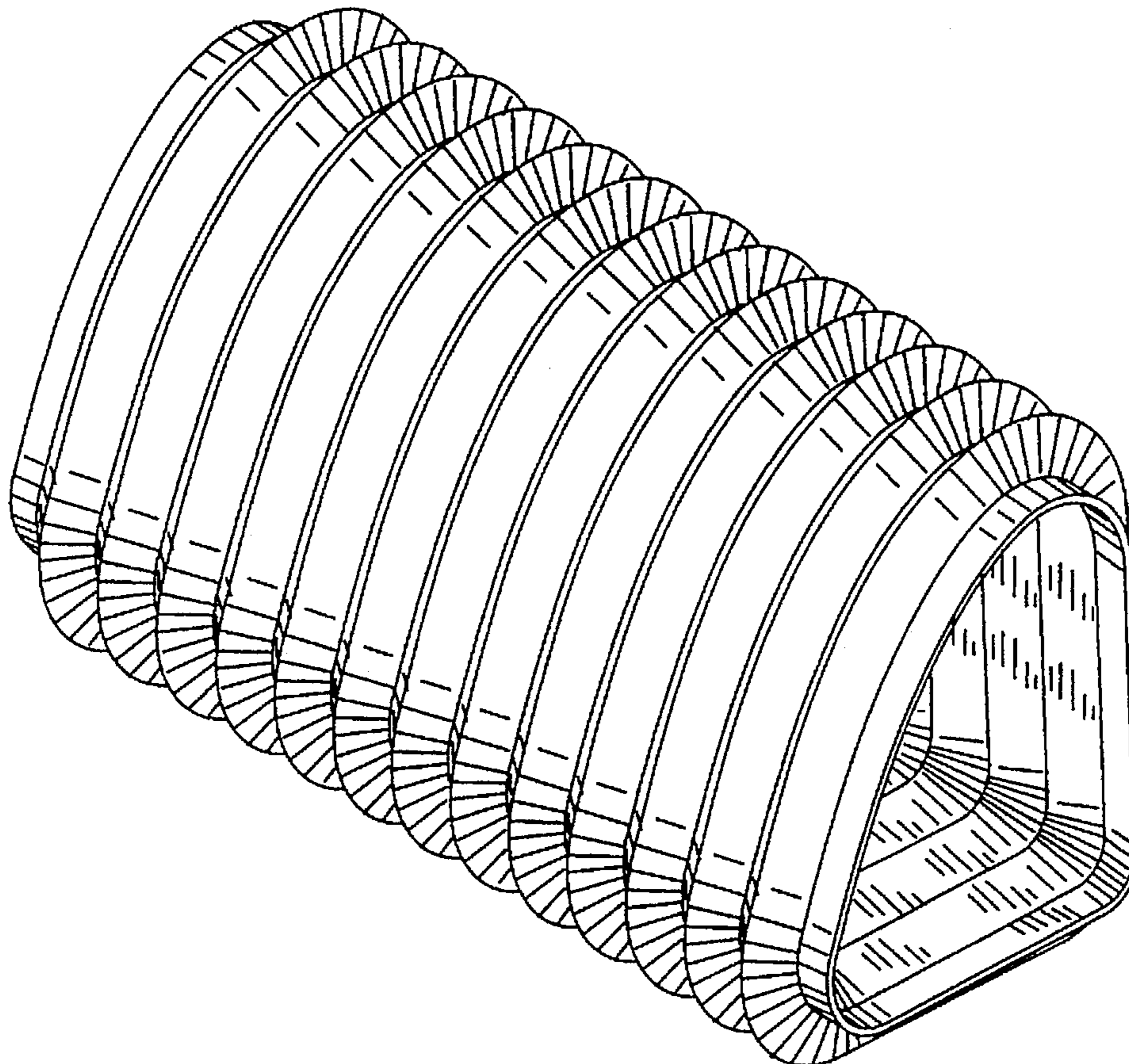
[57] **CLAIM**

The ornamental design for a cover for a mirror mount, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a cover for a mirror mount according to our design;  
FIG. 2 is an end elevation view; the opposite end being a mirror image thereof;  
FIG. 3 is a front view thereof;  
FIG. 4 is a back view thereof;  
FIG. 5 is a top view thereof; and,  
FIG. 6 is a bottom view thereof.

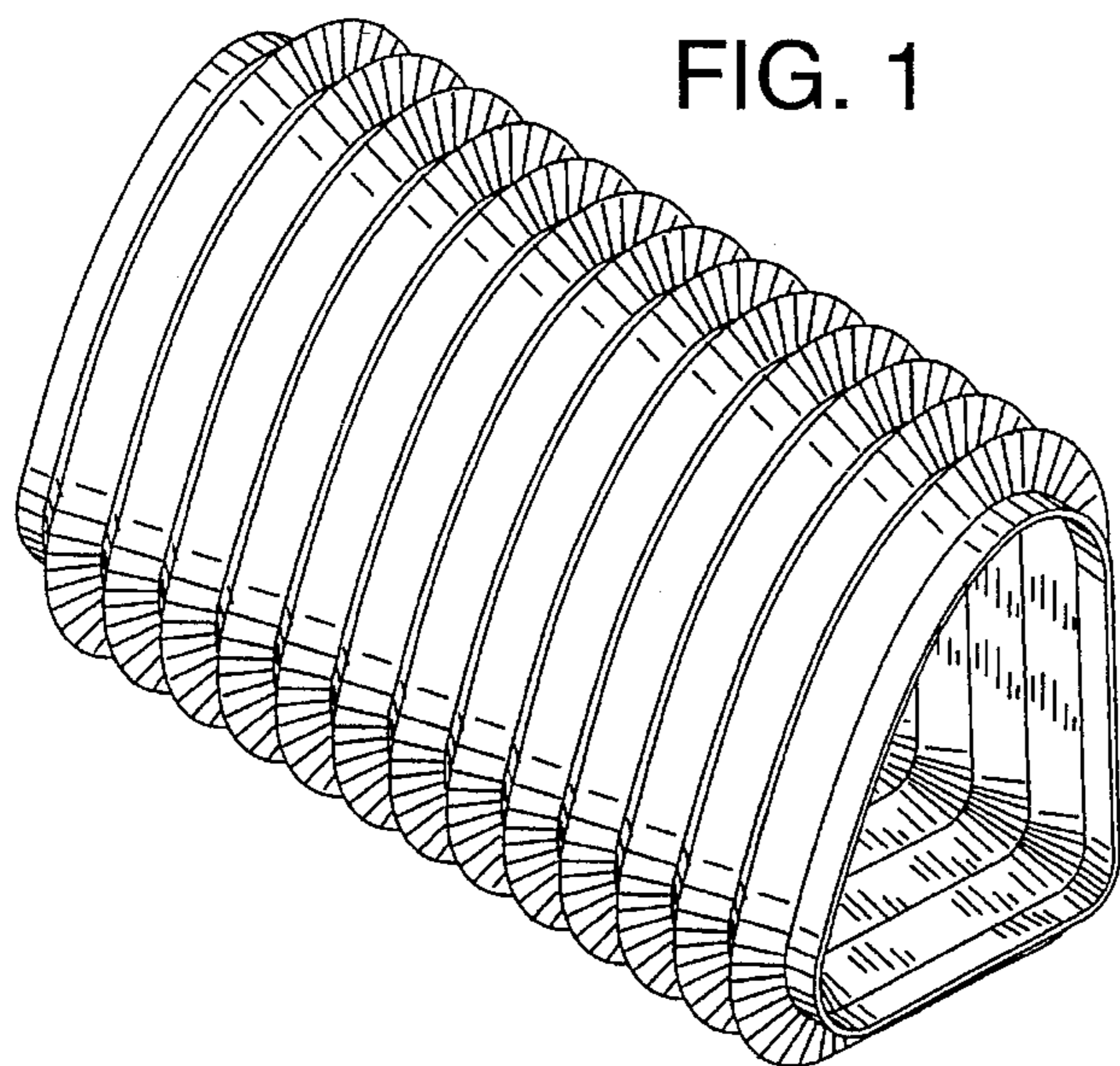

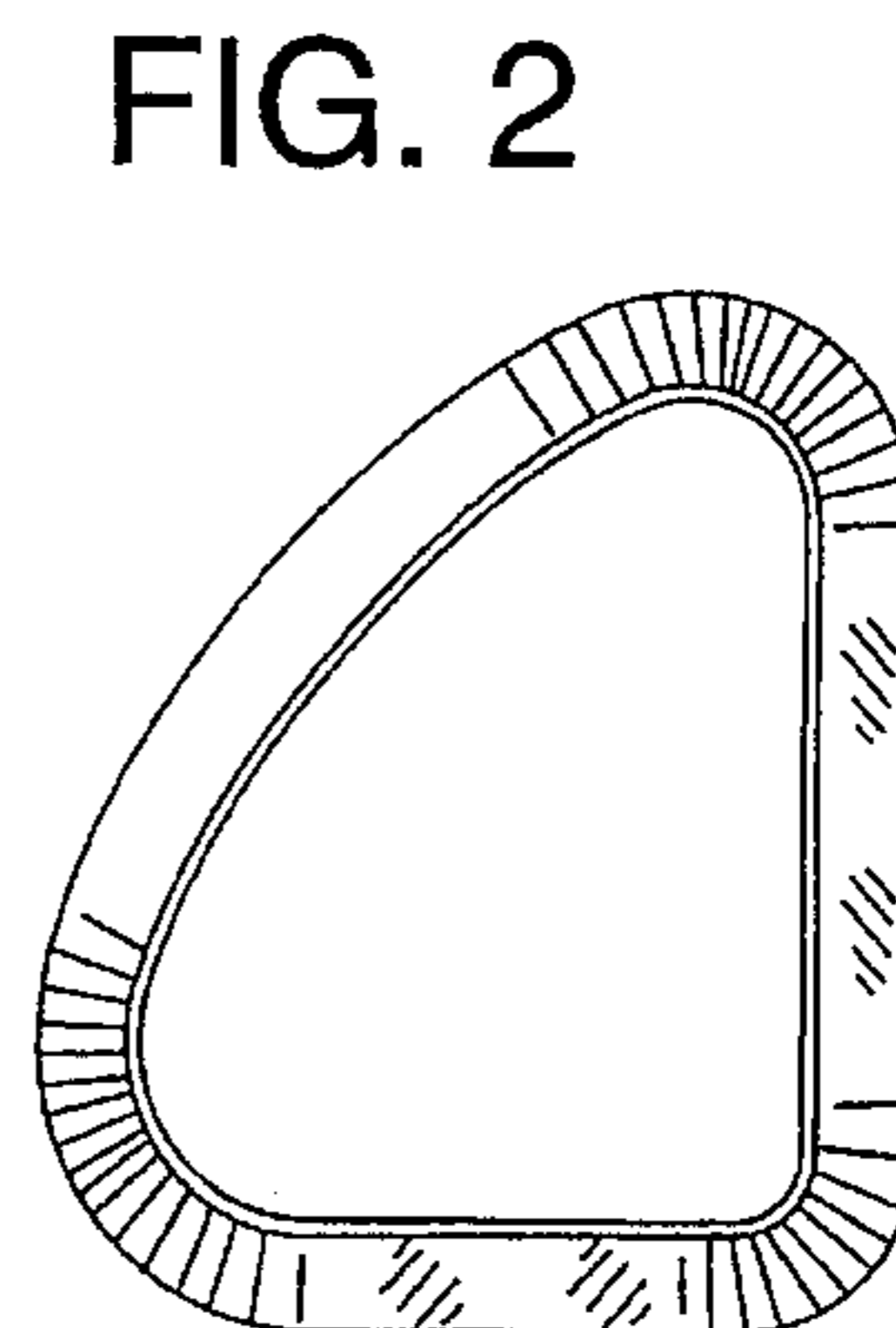

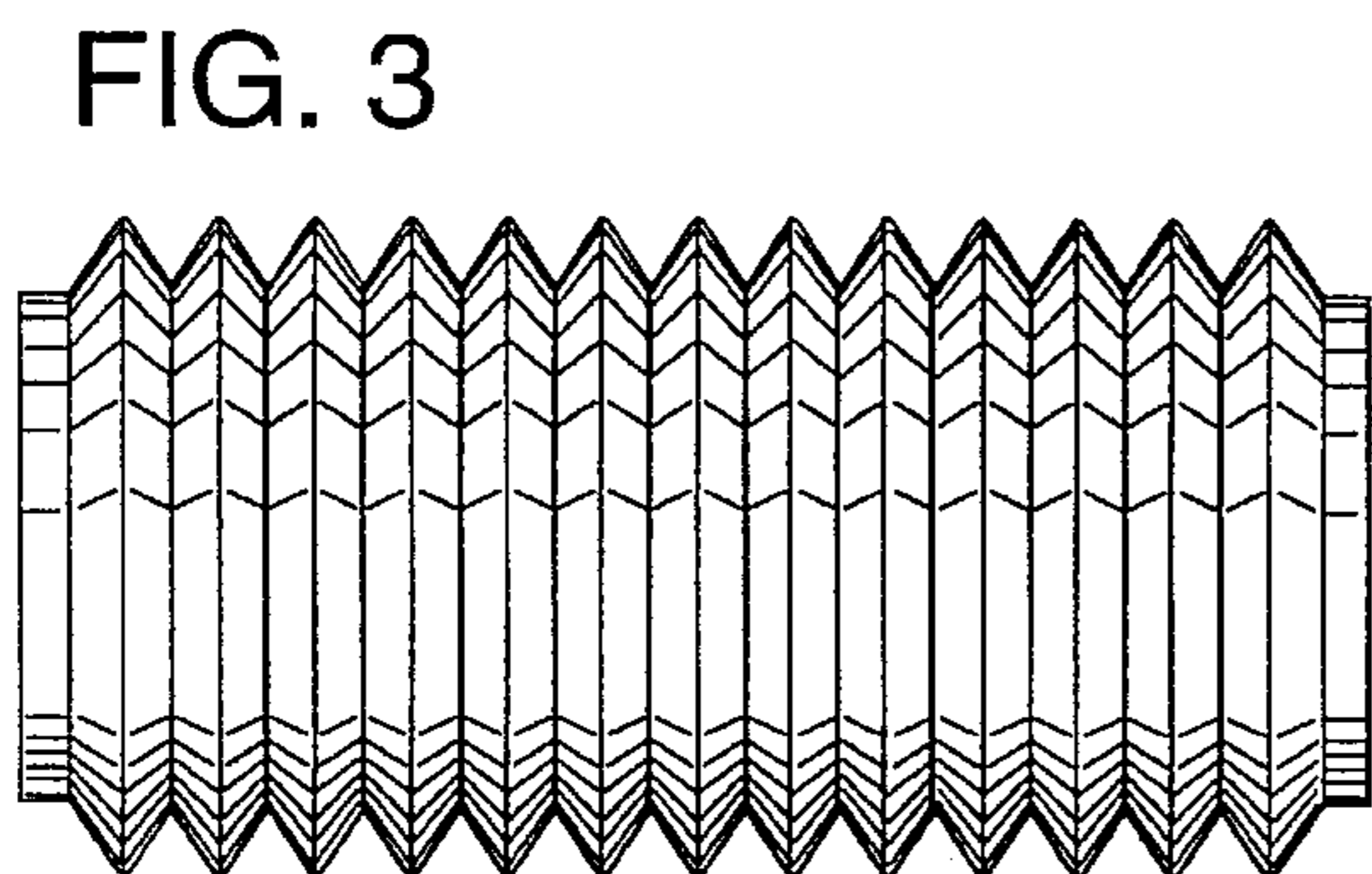

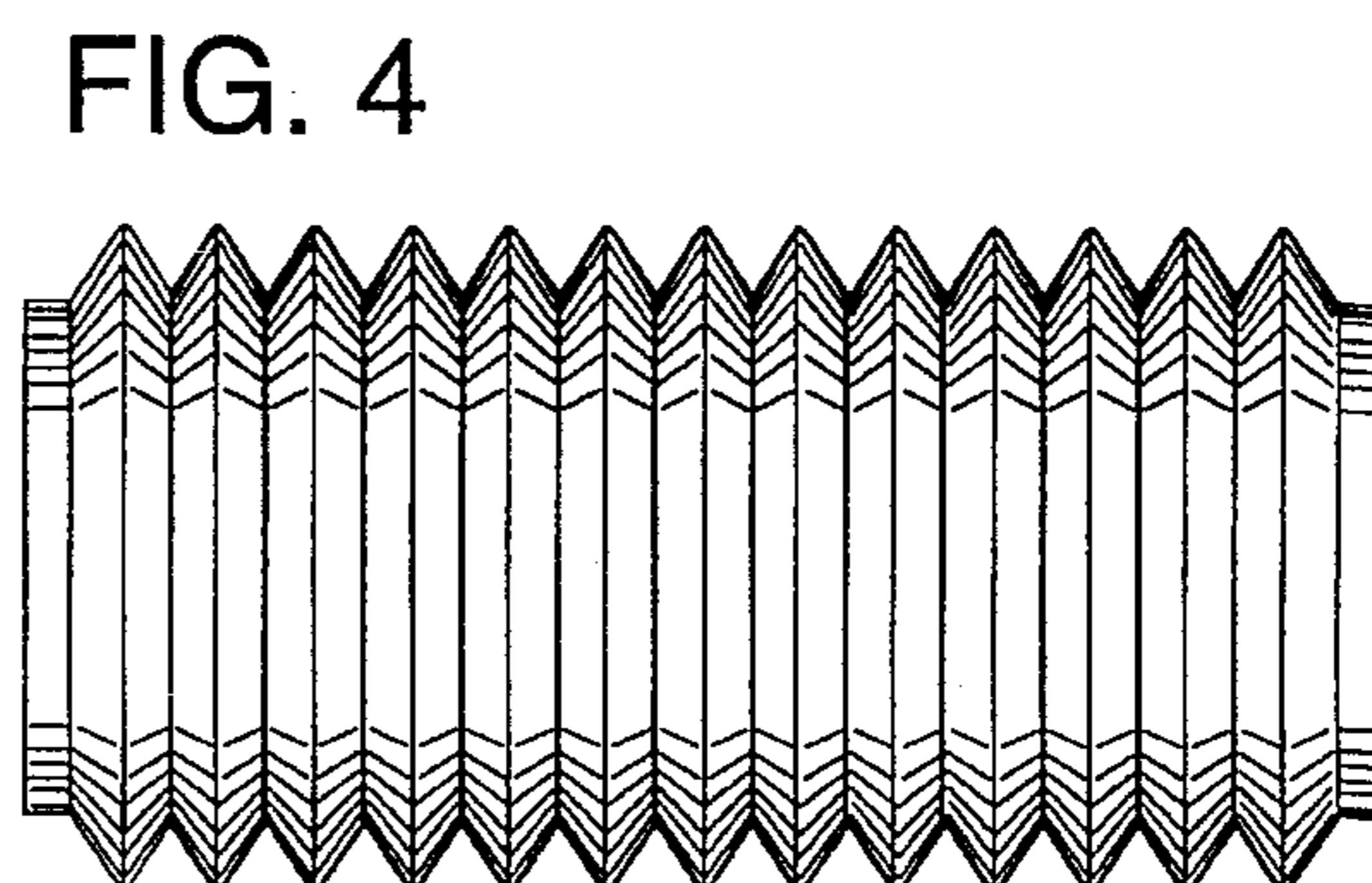

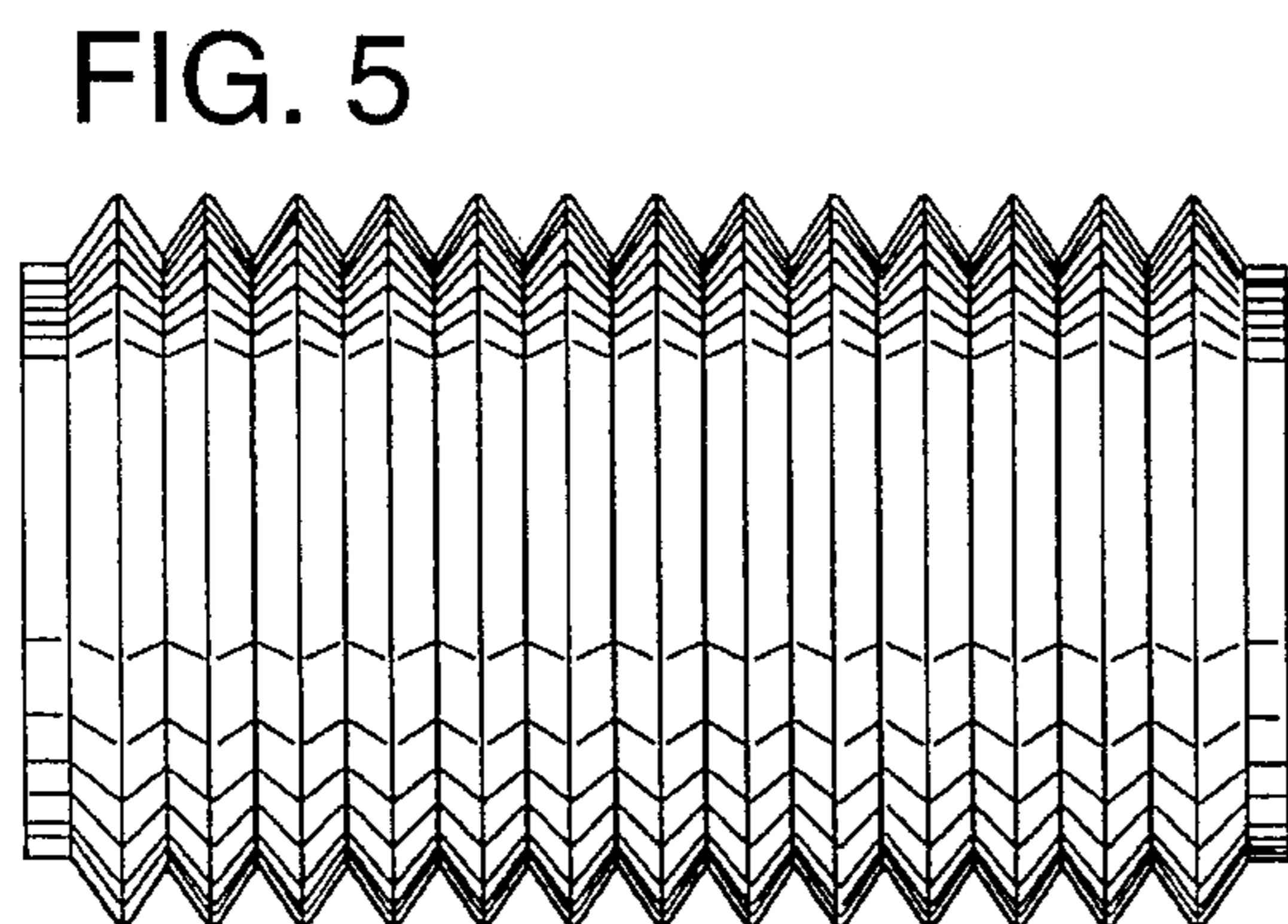

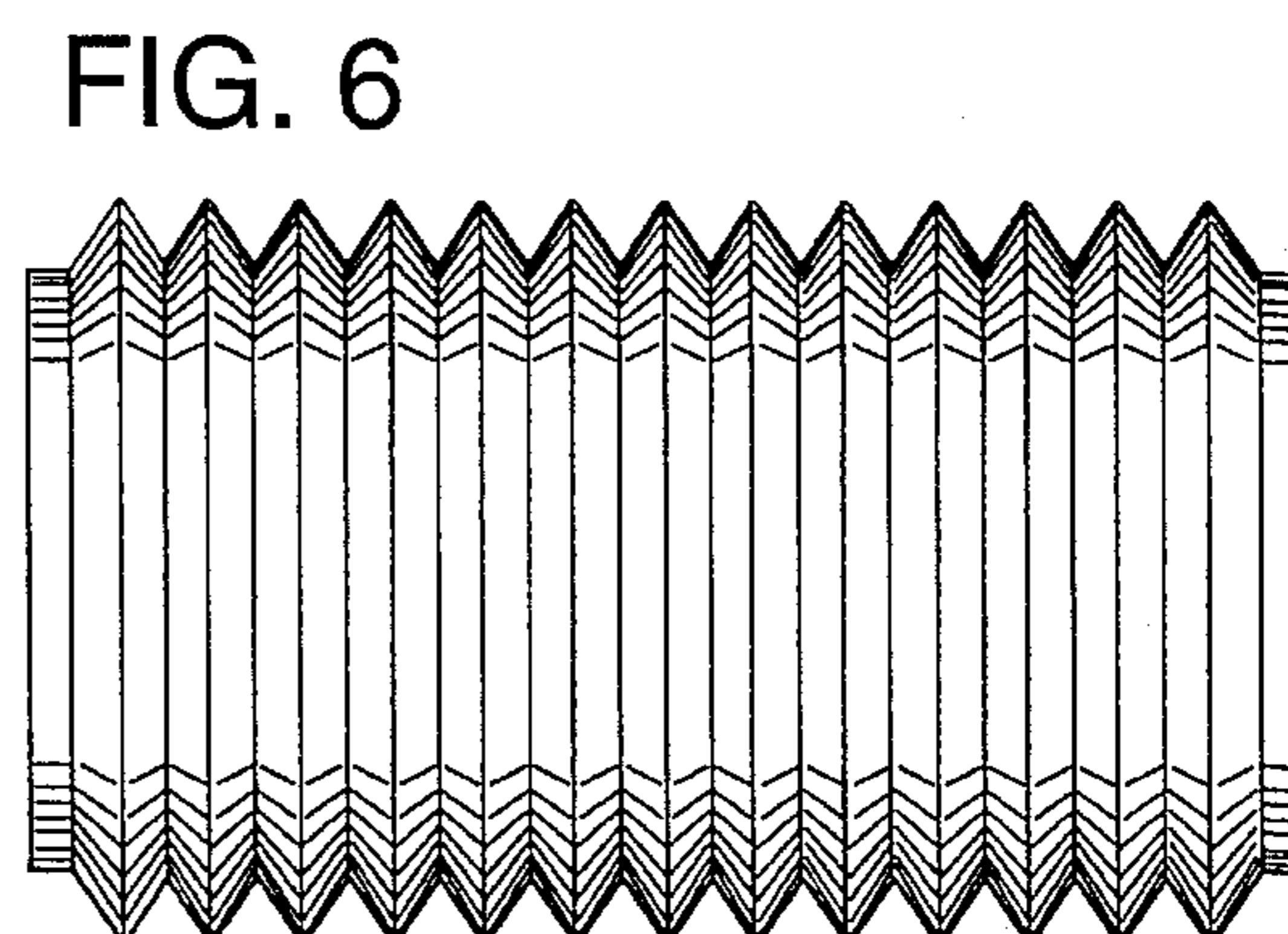
