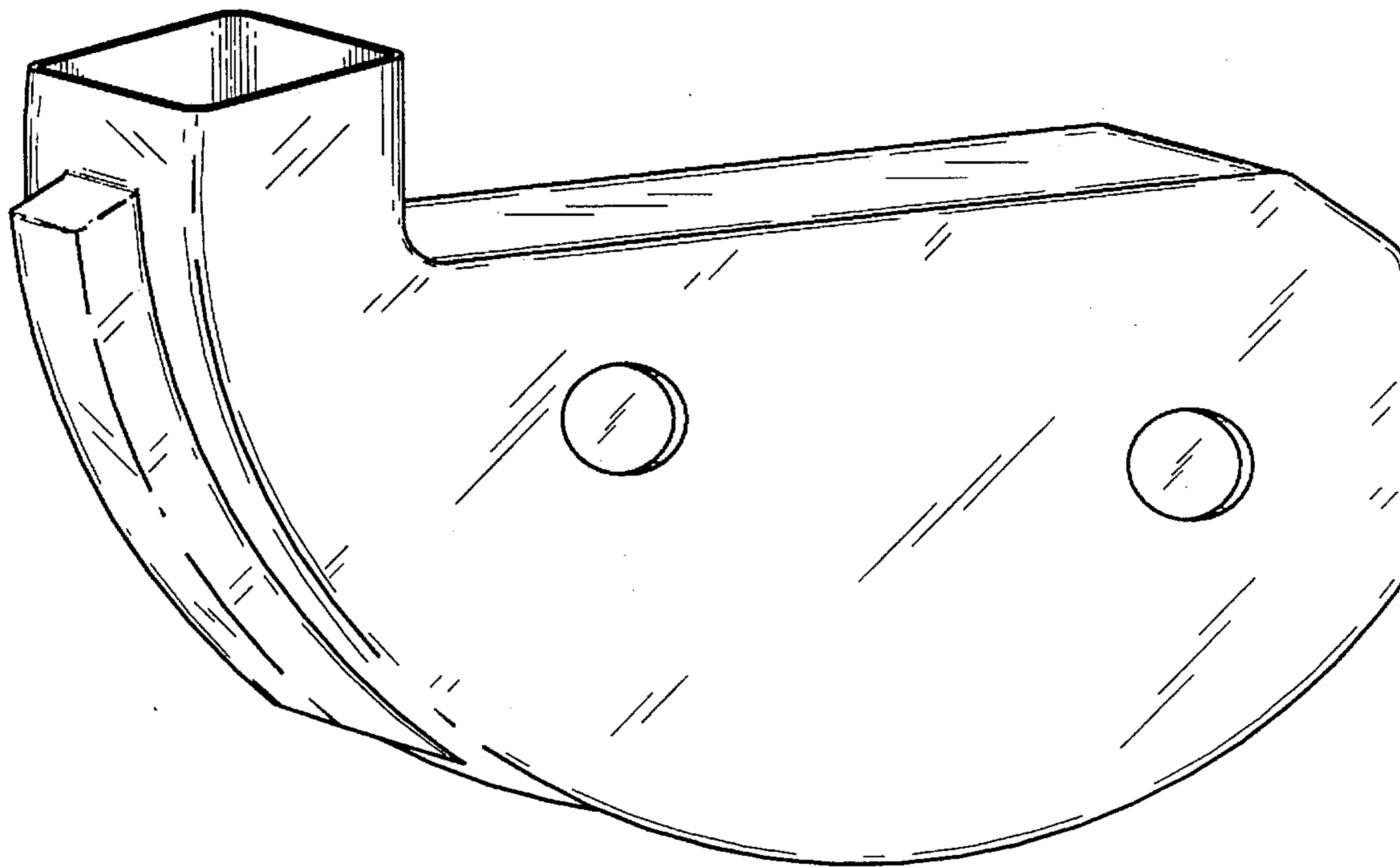
[57] CLAIM

The ornamental design for a large volume ink reservoir for ink jet printers, as shown and described.

DESCRIPTION

FIG. 1 is a right side view of a large volume ink reservoir for ink jet printers showing our new design; FIG. 2 is a left side view thereof; FIG. 3 is a front view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a top view thereof; FIG. 6 is a bottom view thereof; and, FIG. 7 is a perspective view thereof.

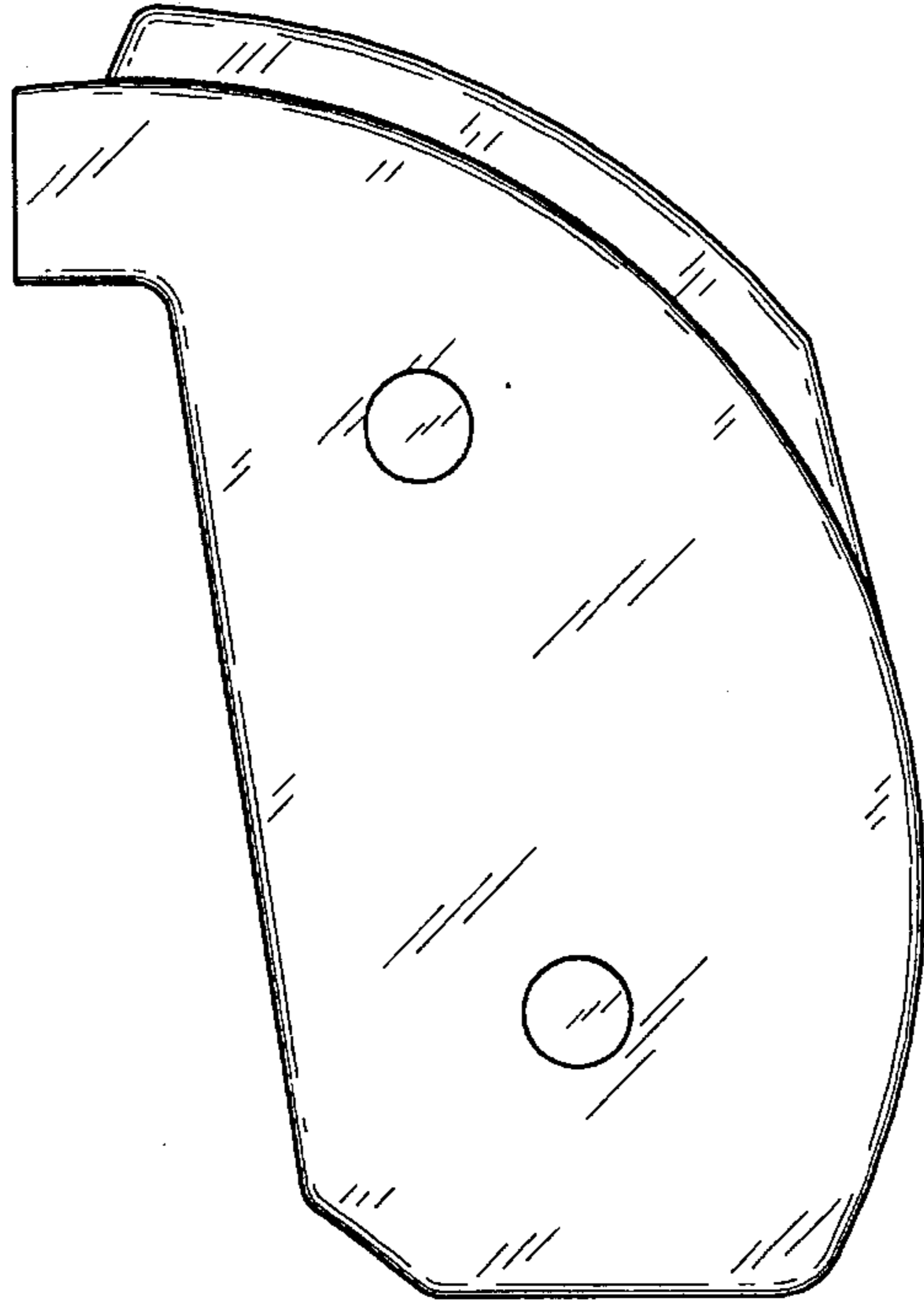

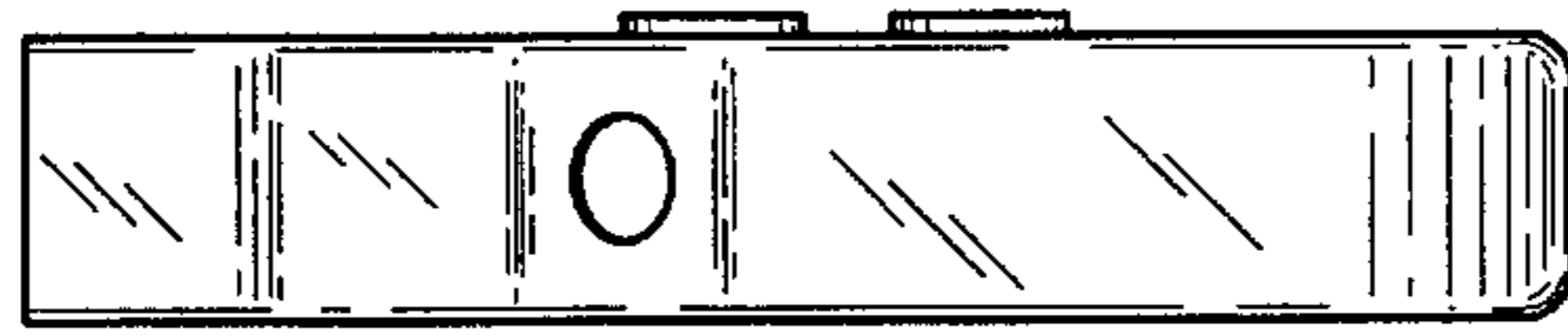

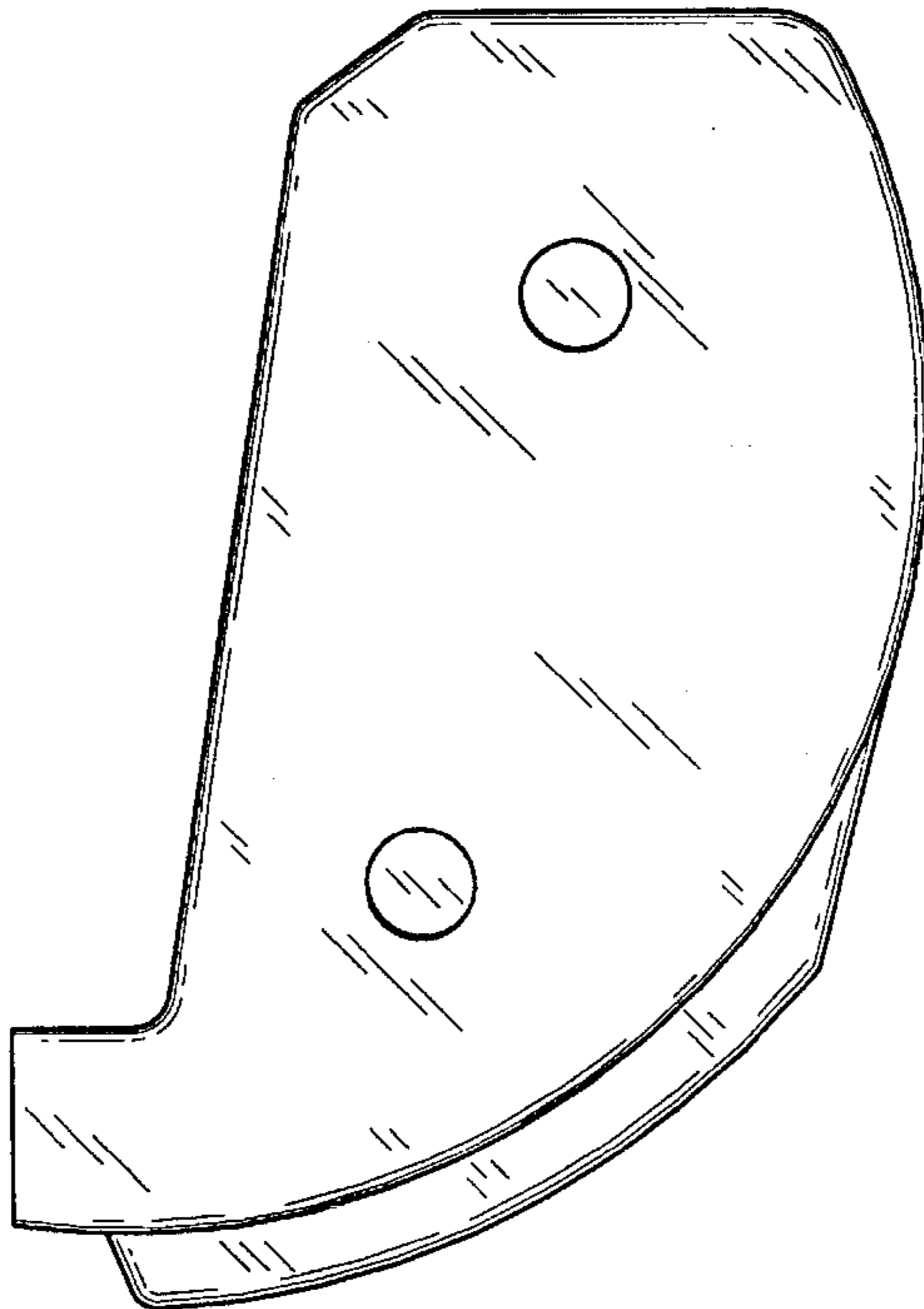

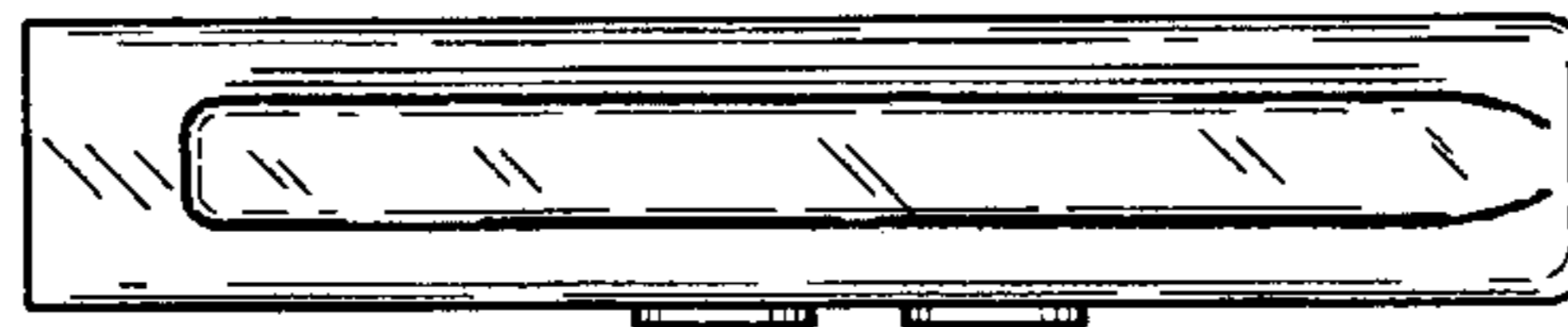

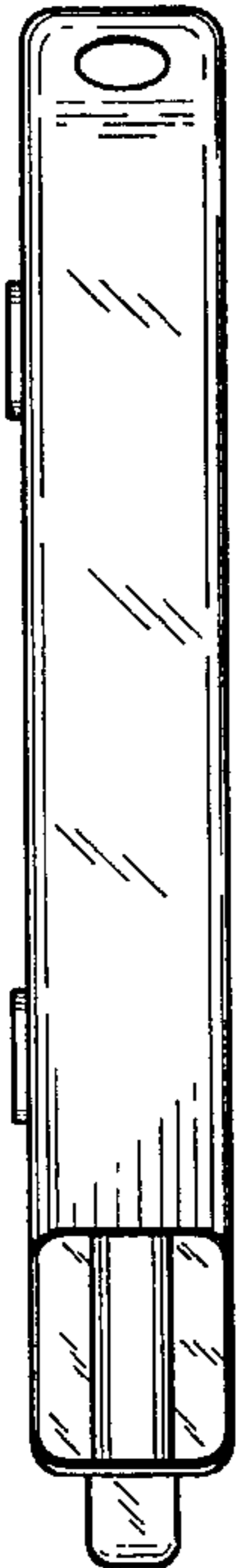

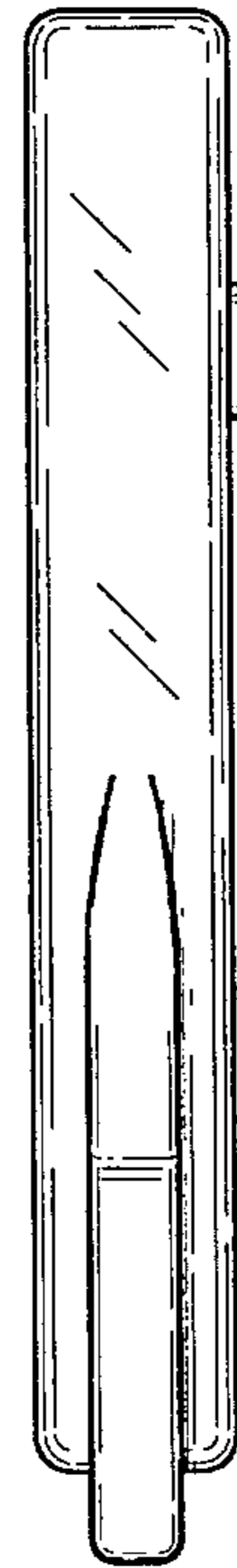

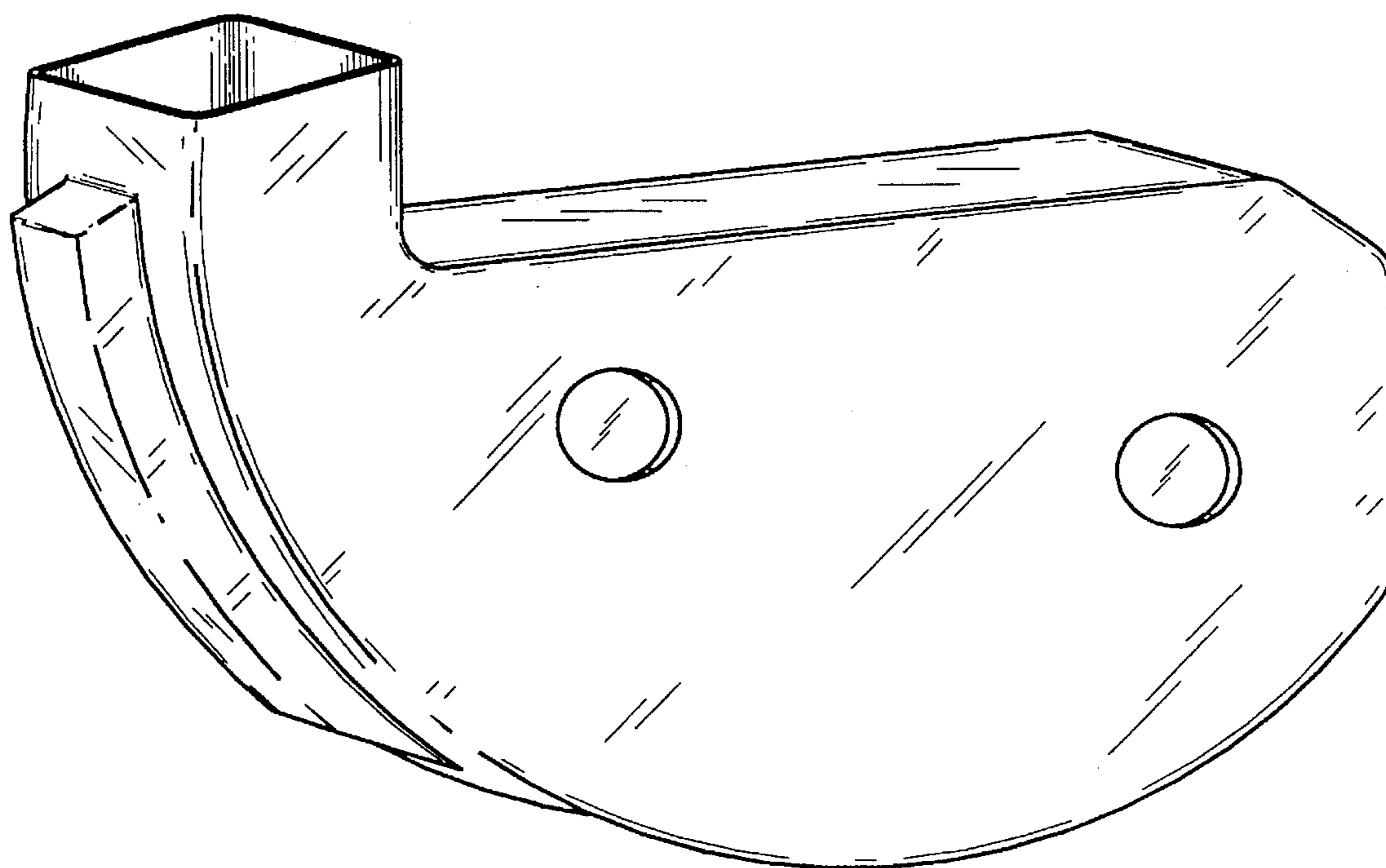
