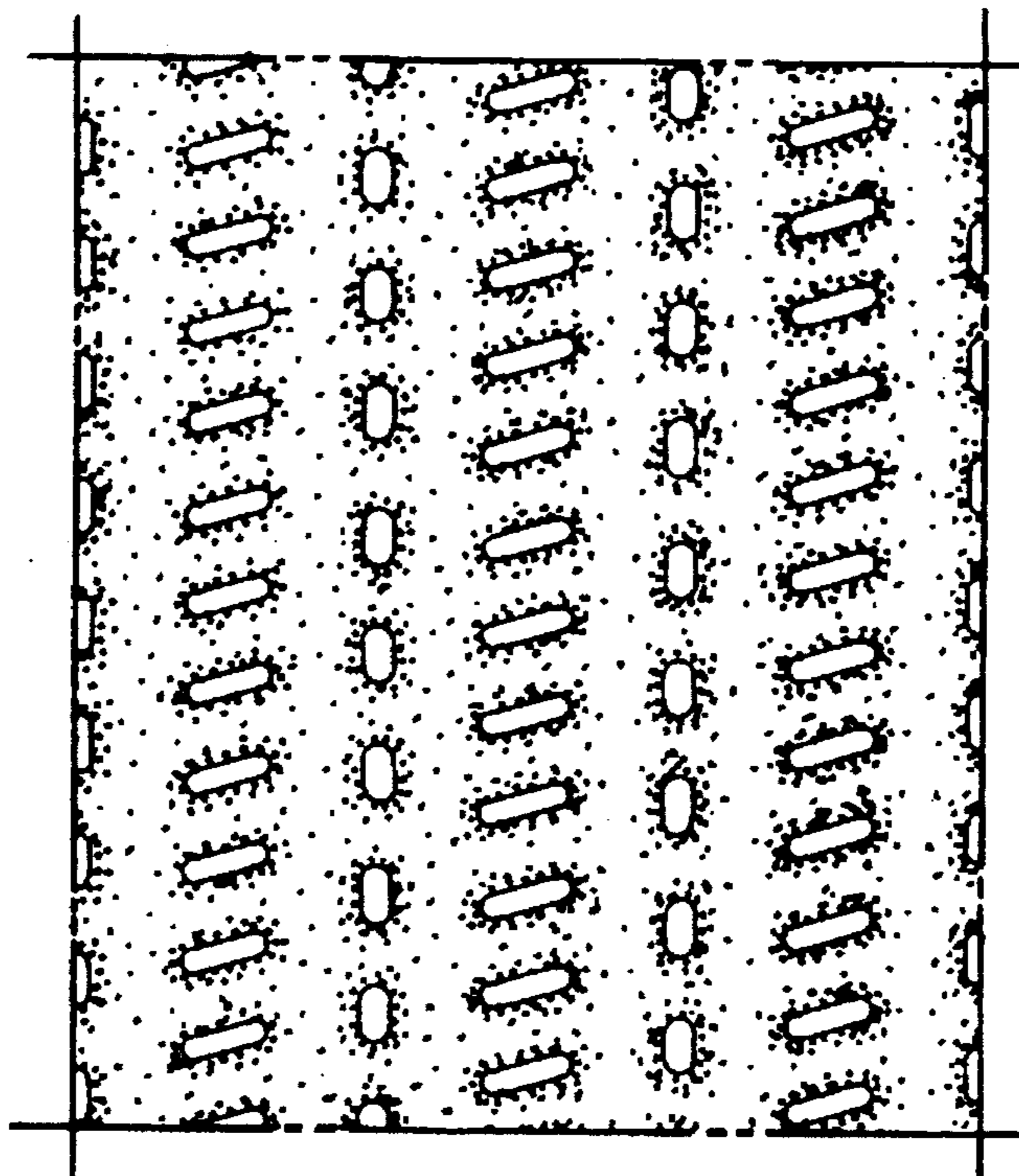
[57] **CLAIM**

The ornamental design for a nonwoven fabric, as shown.

DESCRIPTION

FIG. 1 is a plan view of a nonwoven fabric showing our new design, the opposite surface being a reverse image; and, FIG. 2 is an enlarged fragmentary view thereof. The broken line showing in the plan view figure depicts the boundaries of a repeat unit of the claimed design.

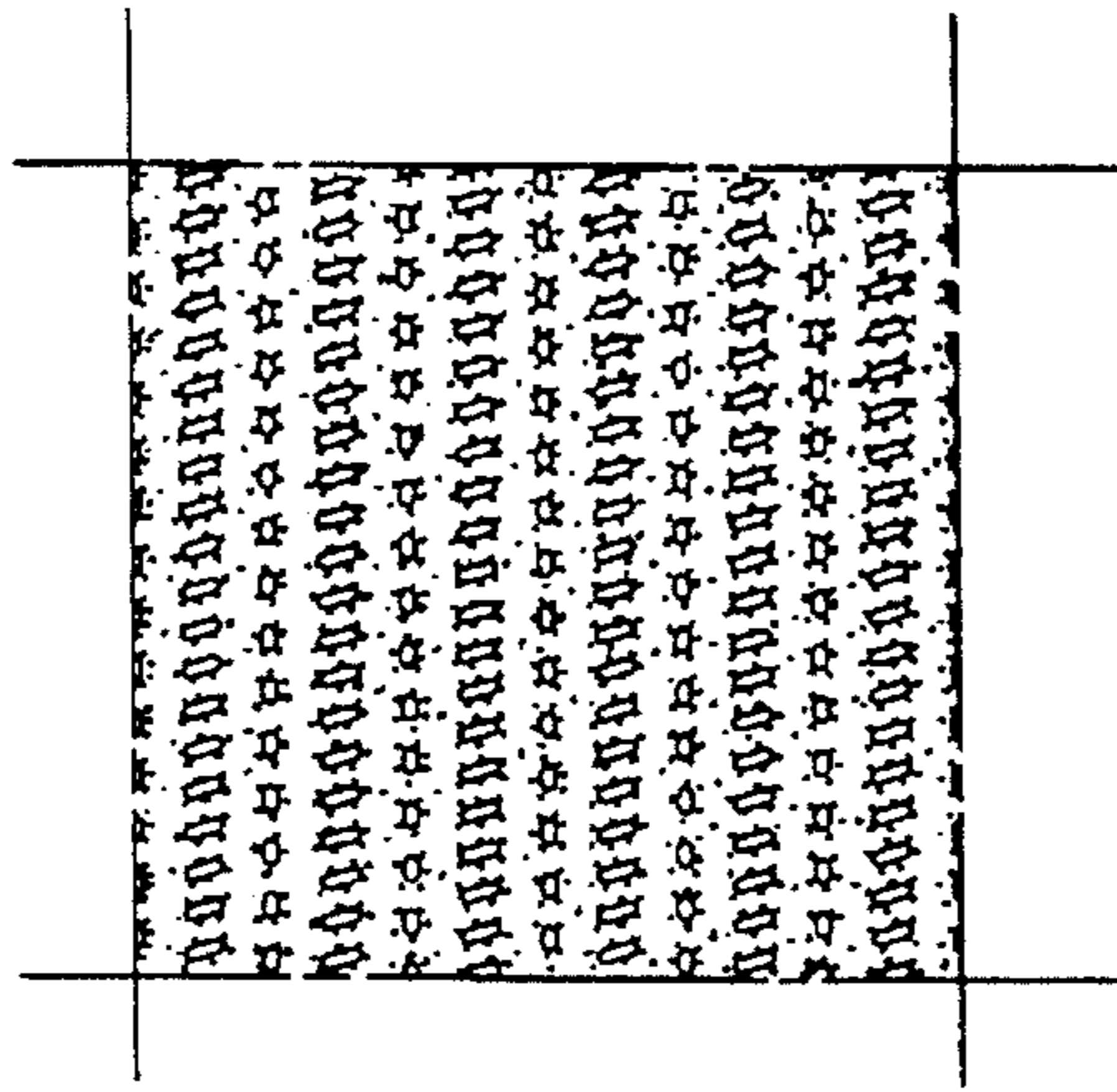

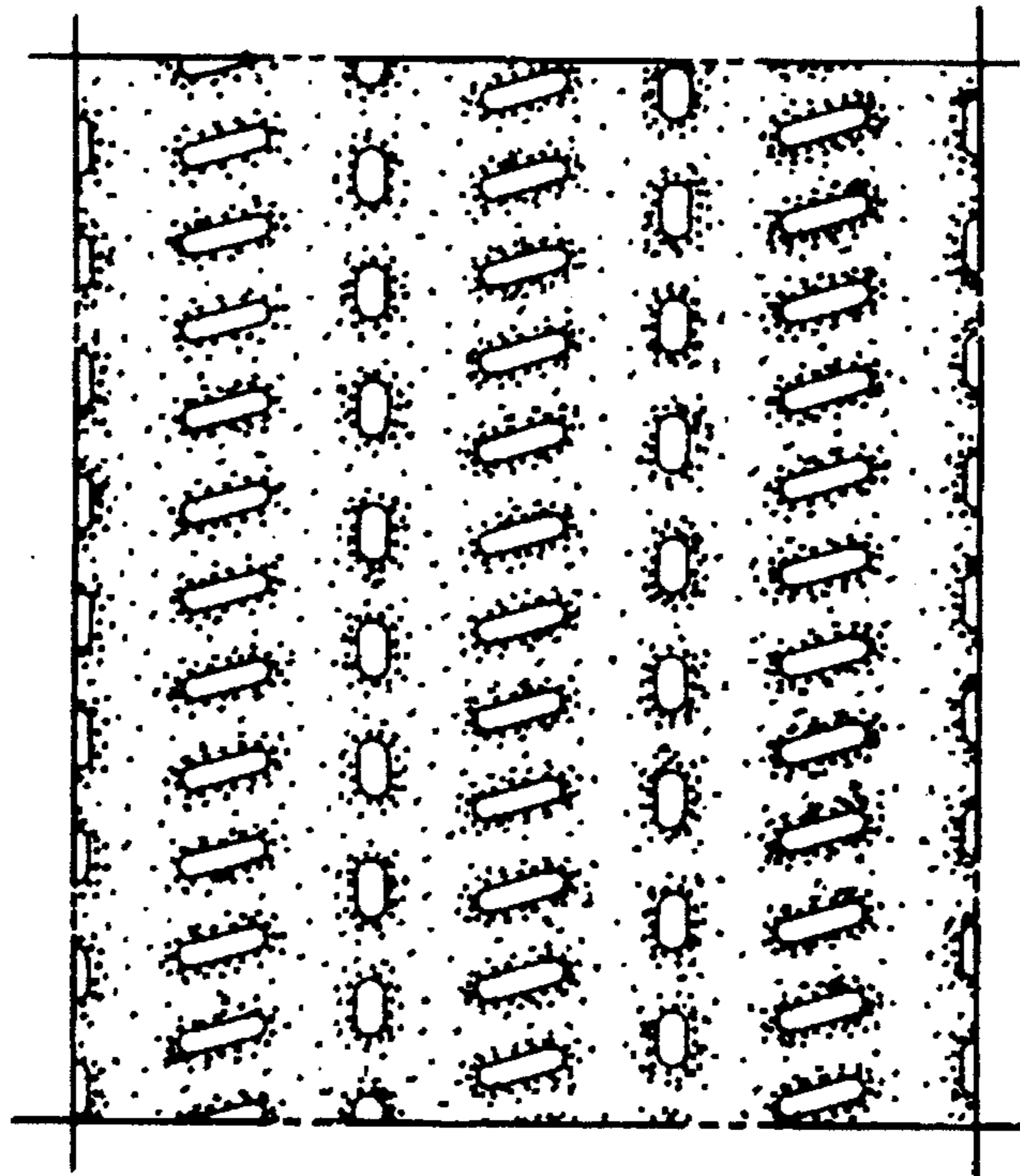
