The ornamental design for a drinking vessel, as shown and described.

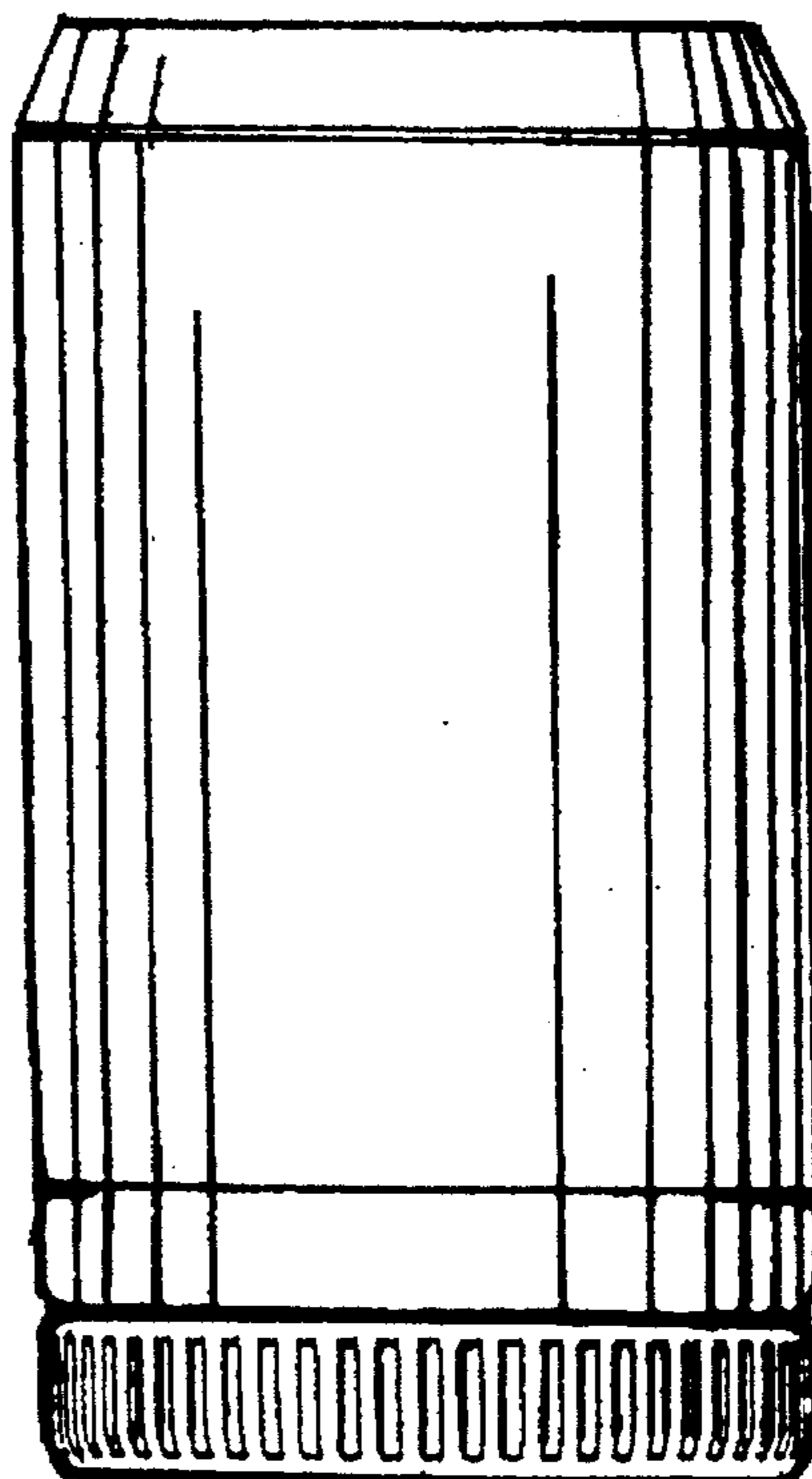
DESCRIPTION

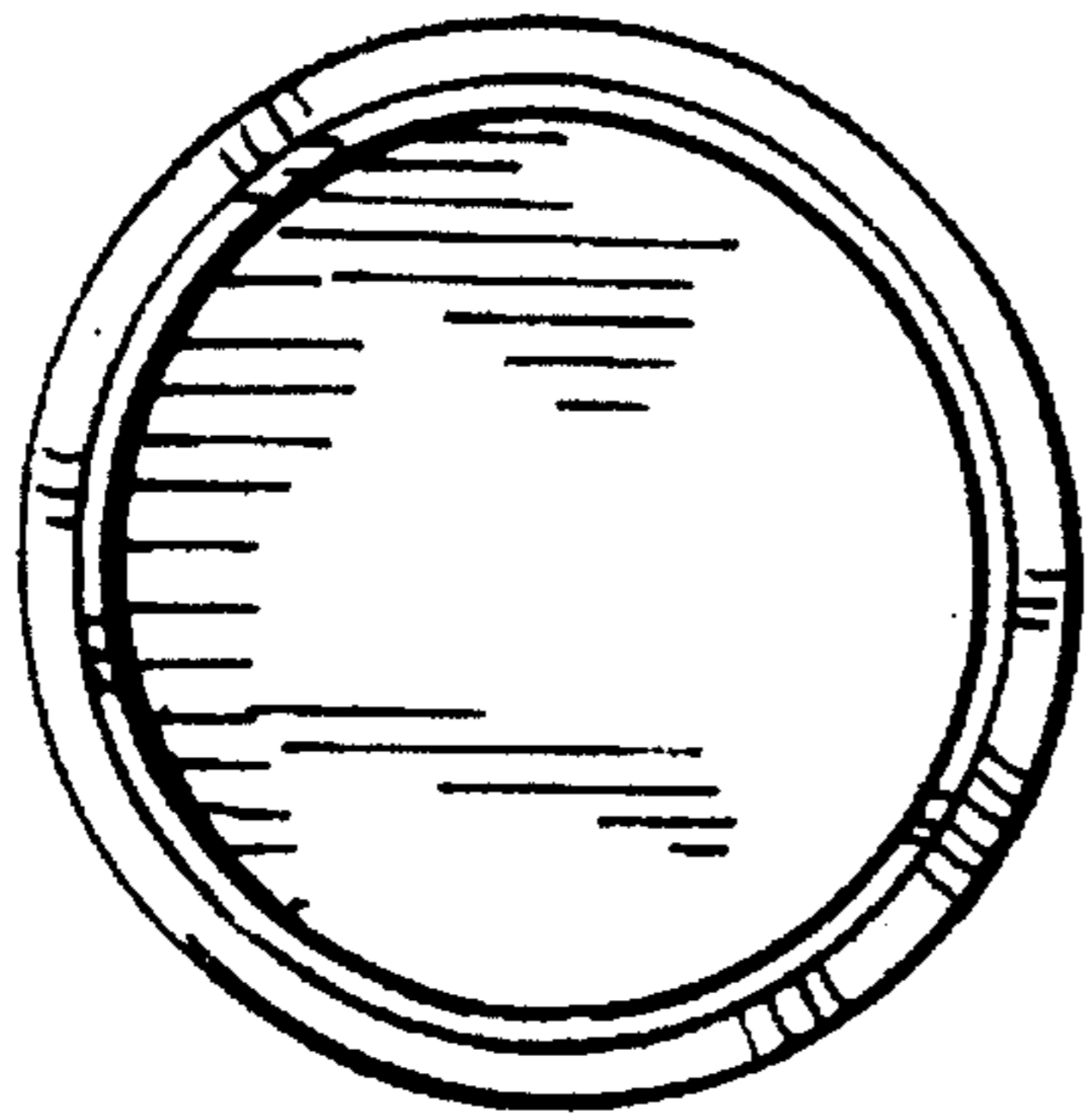

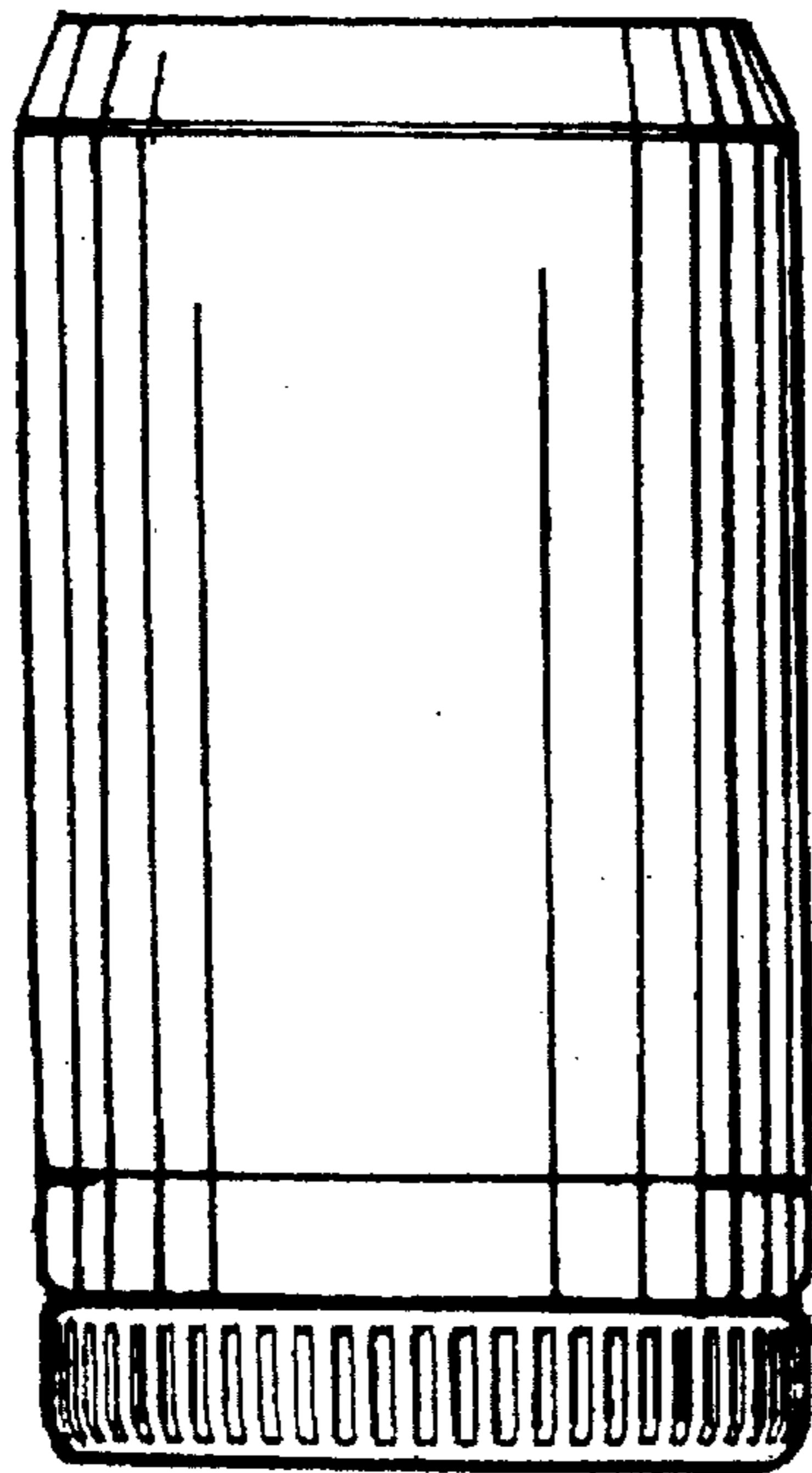

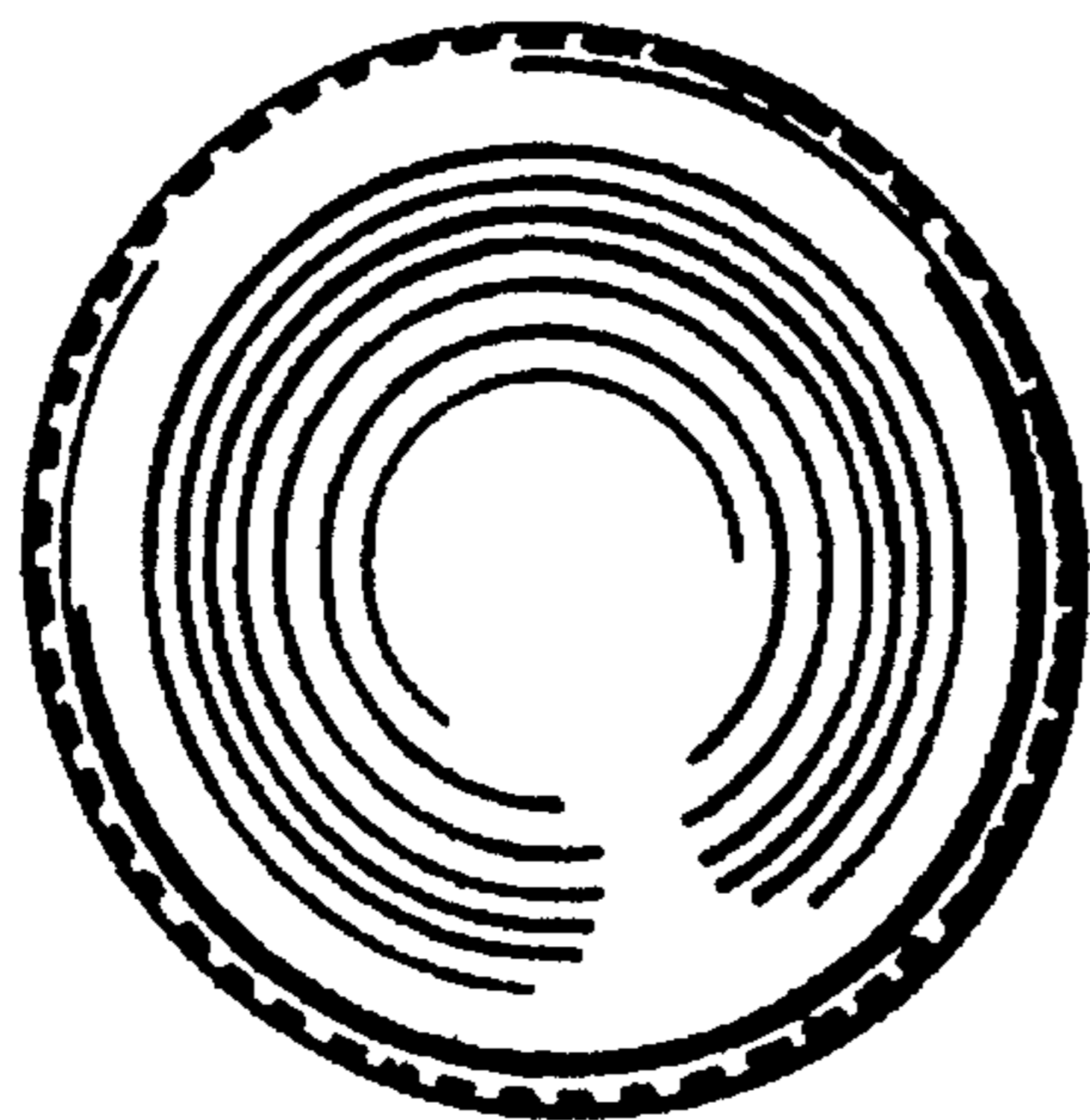
