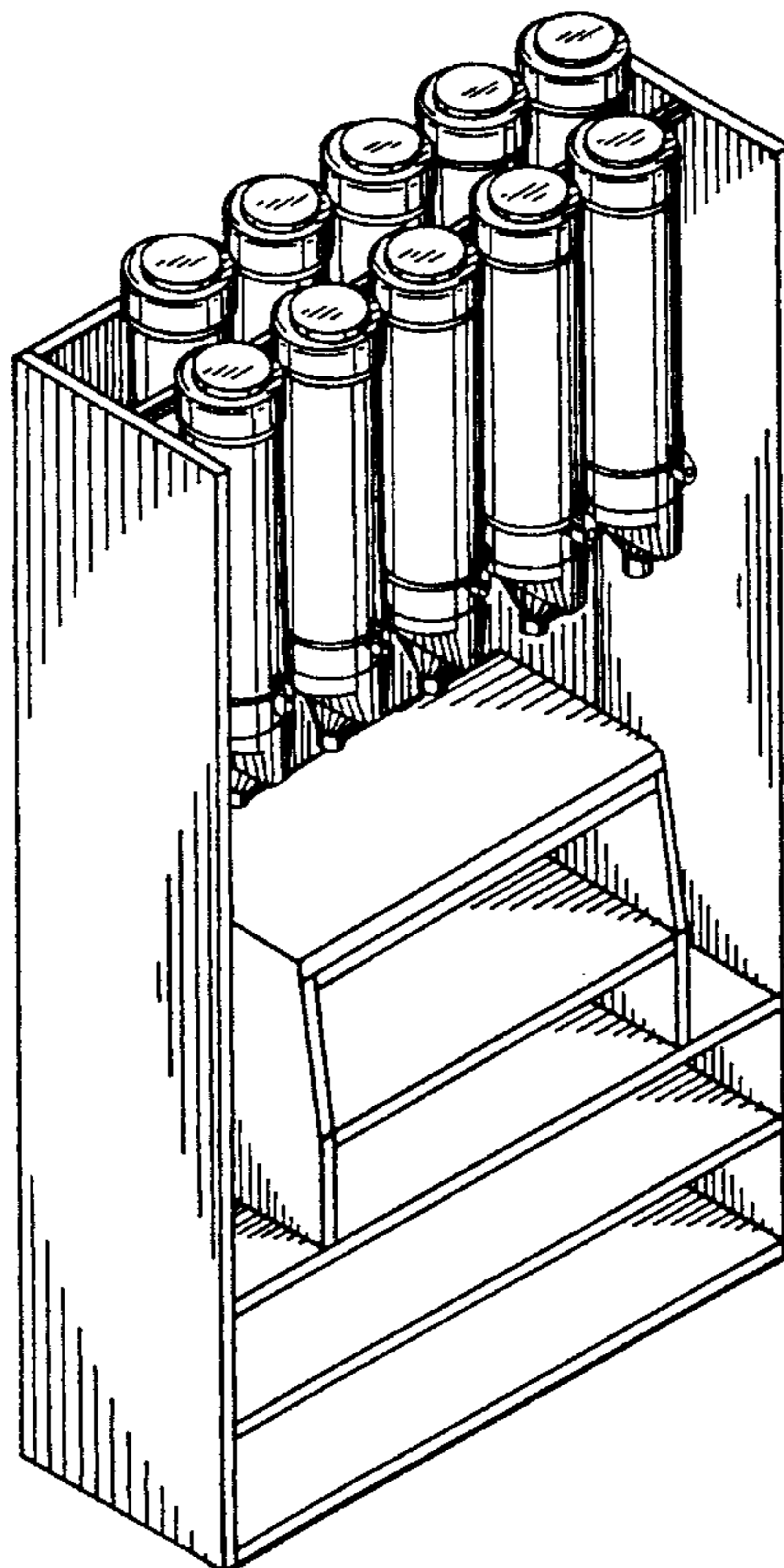
[57] **CLAIM**

The ornamental design of a merchandising unit for storing and dispensing perishables, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a merchandising unit for storing and dispensing perishables showing our new design; FIG. 2 is a front view of the merchandising unit; FIG. 3 is a side view of the merchandising unit; FIG. 4 is a top view of the merchandising unit; FIG. 5 is a bottom view of the merchandising unit; and, FIG. 6 is a rear view of the merchandising unit.

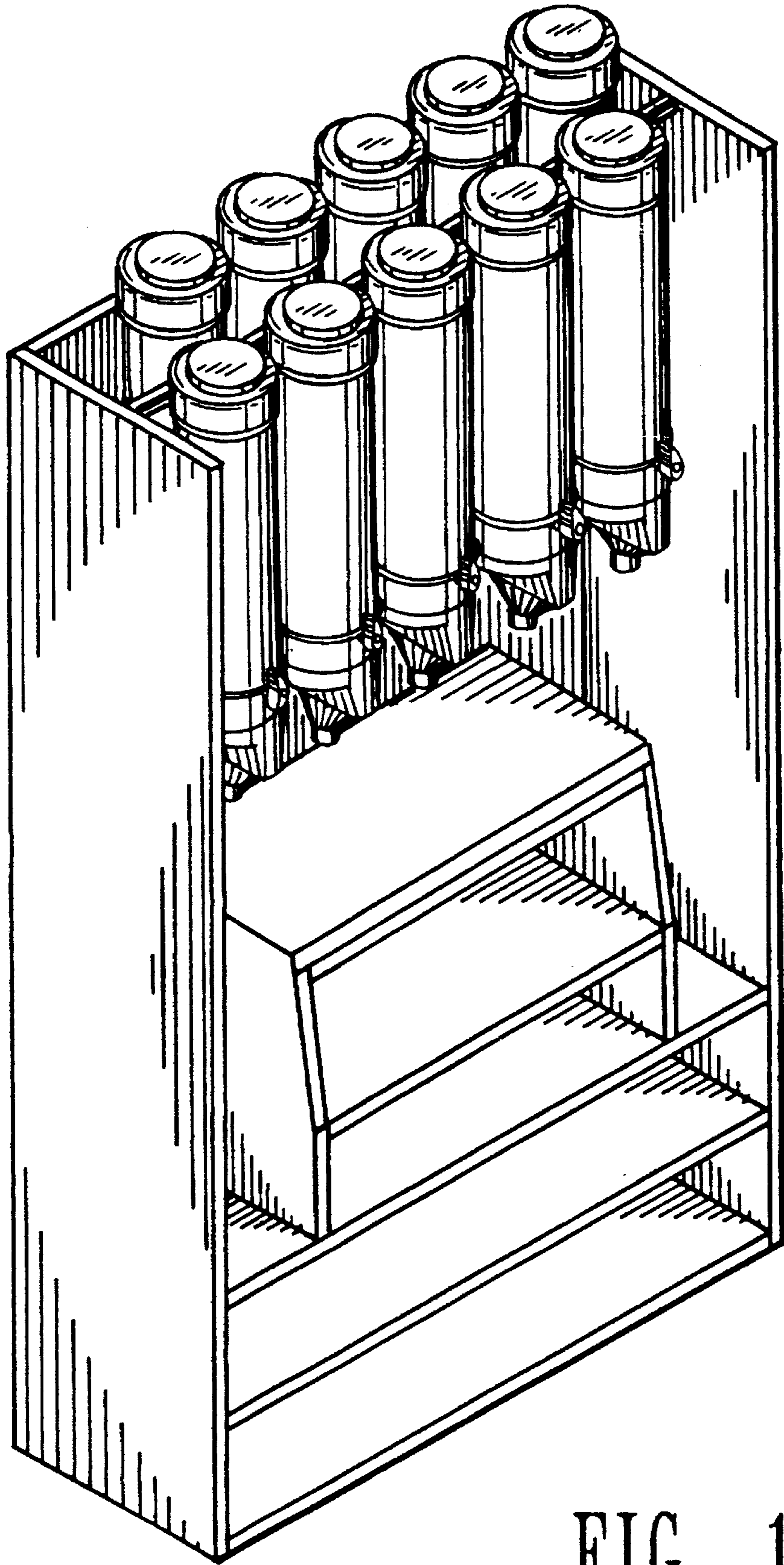

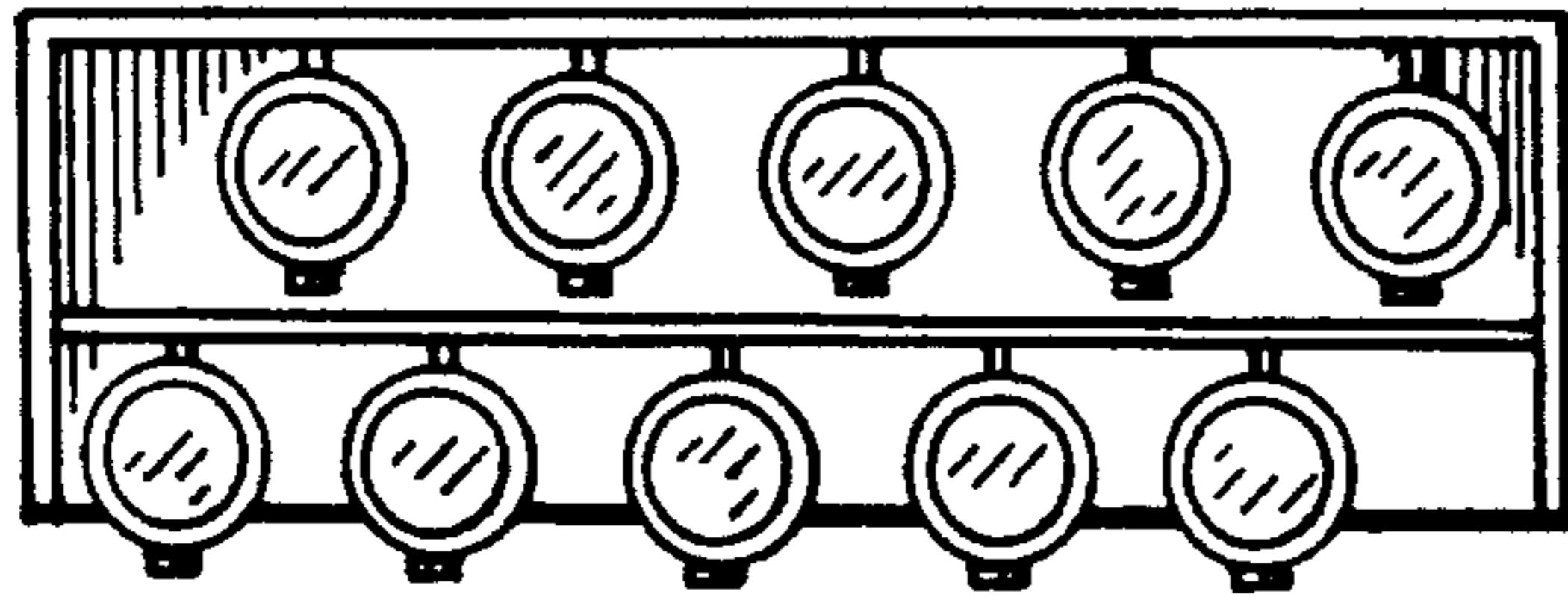

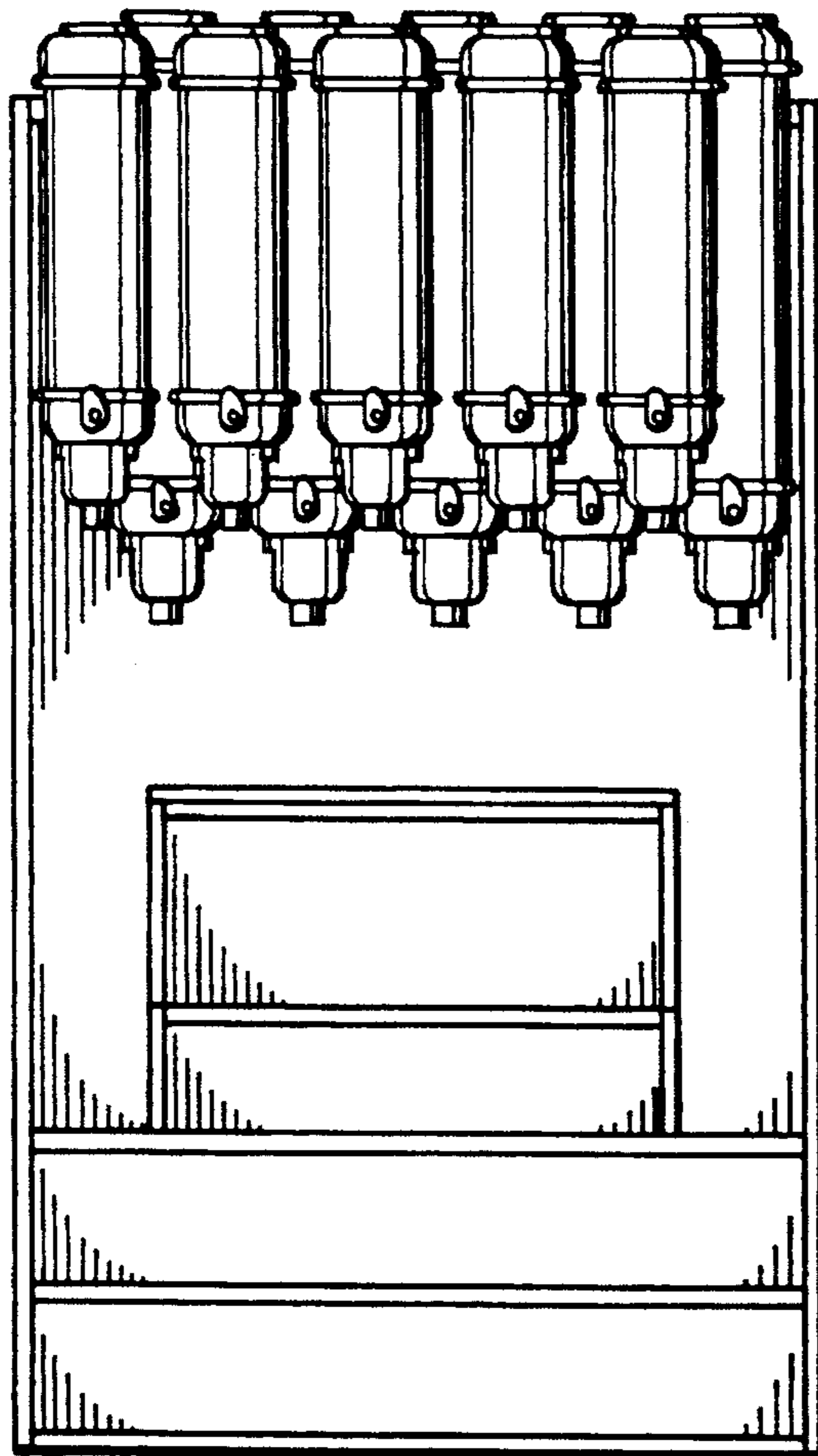

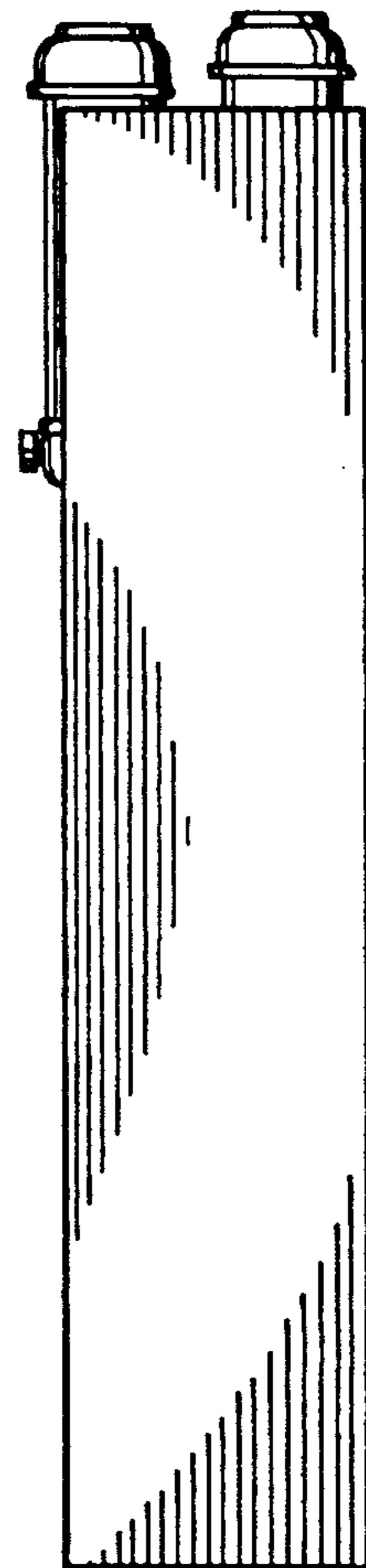

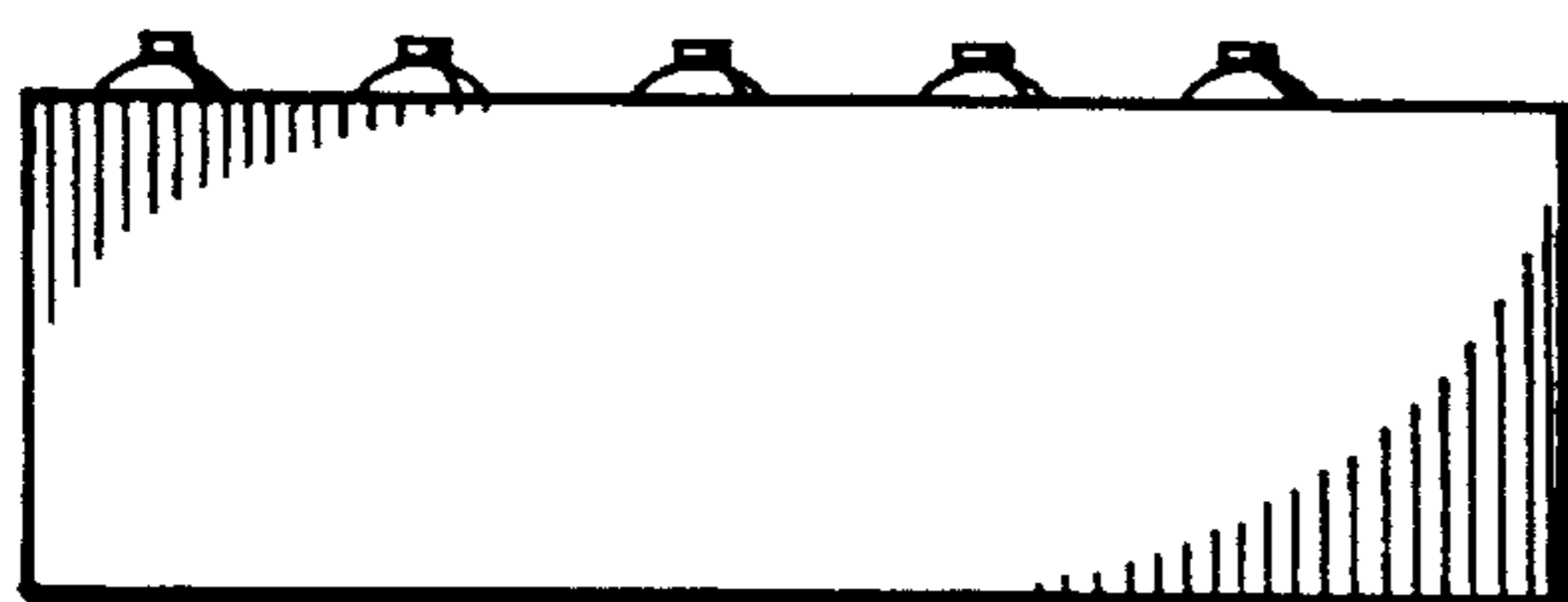

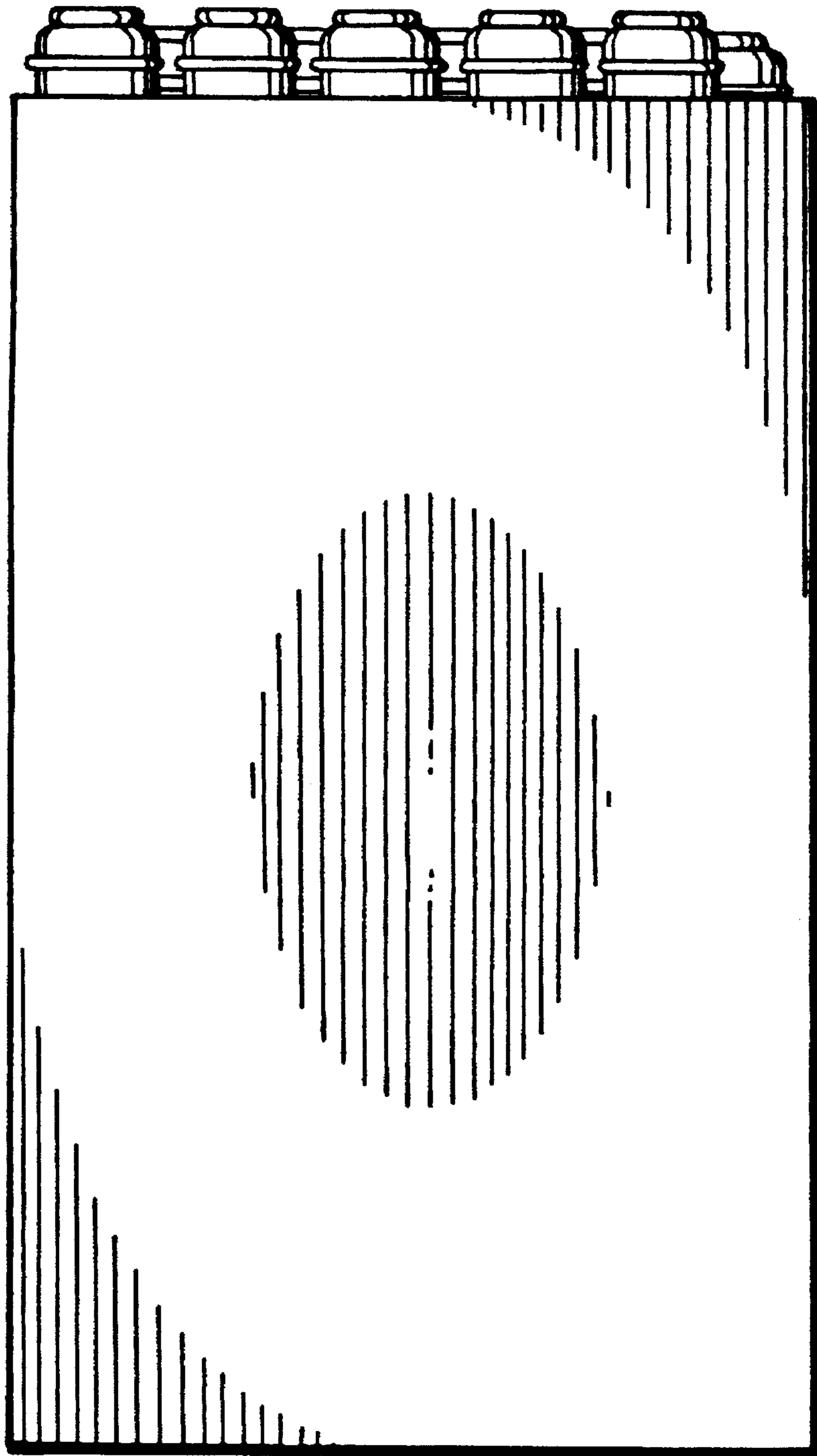
