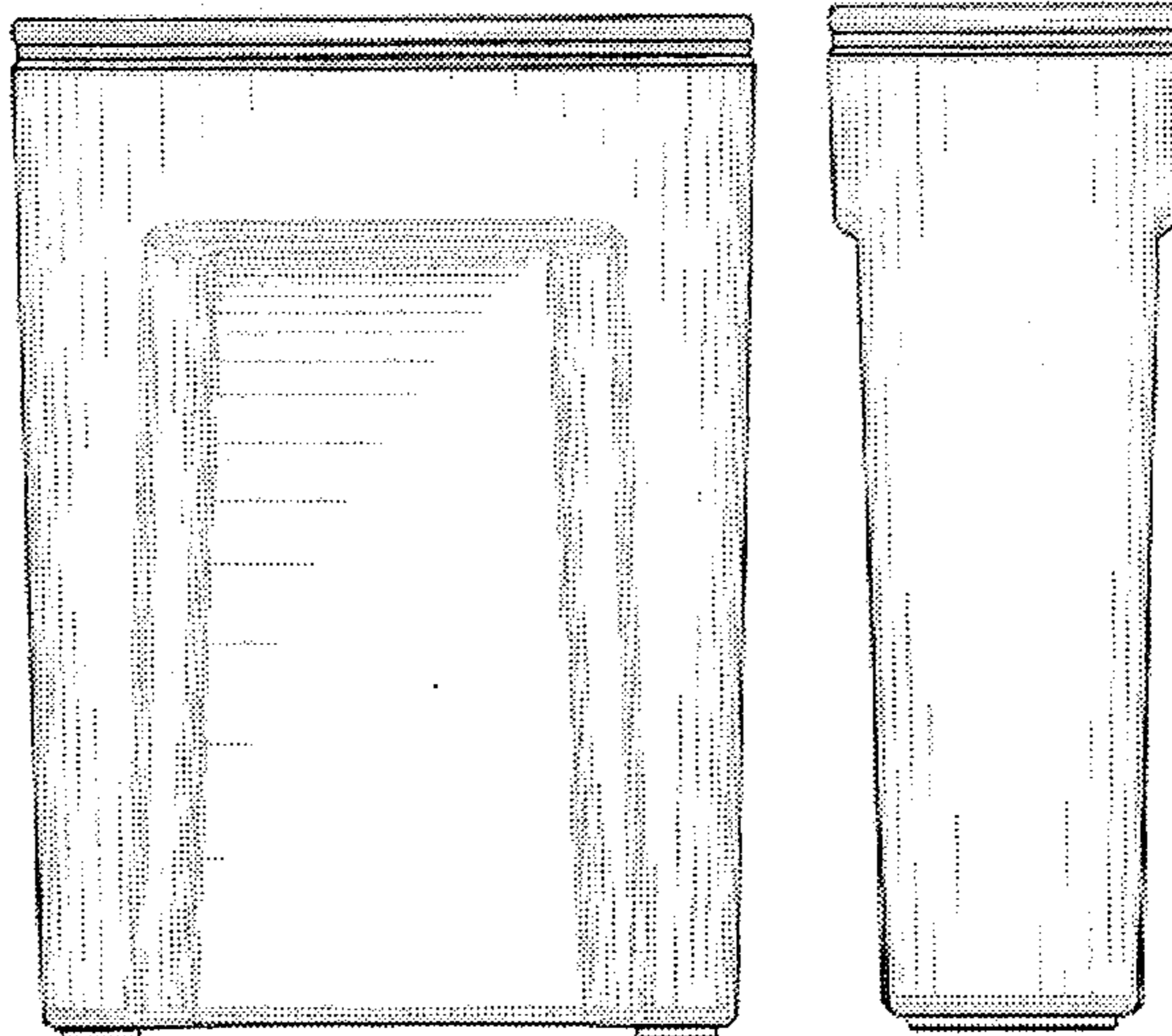
## [57] CLAIM

The ornamental design for a food storage container, as shown and described.

## DESCRIPTION

FIG. 1 is a top right front perspective view of a food storage container showing our new design;  
FIG. 2 is a front elevational view thereof; the rear elevational view being a mirror image;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof; and,  
FIG. 5 is a left side elevational view thereof; the right side elevational view being a mirror image.

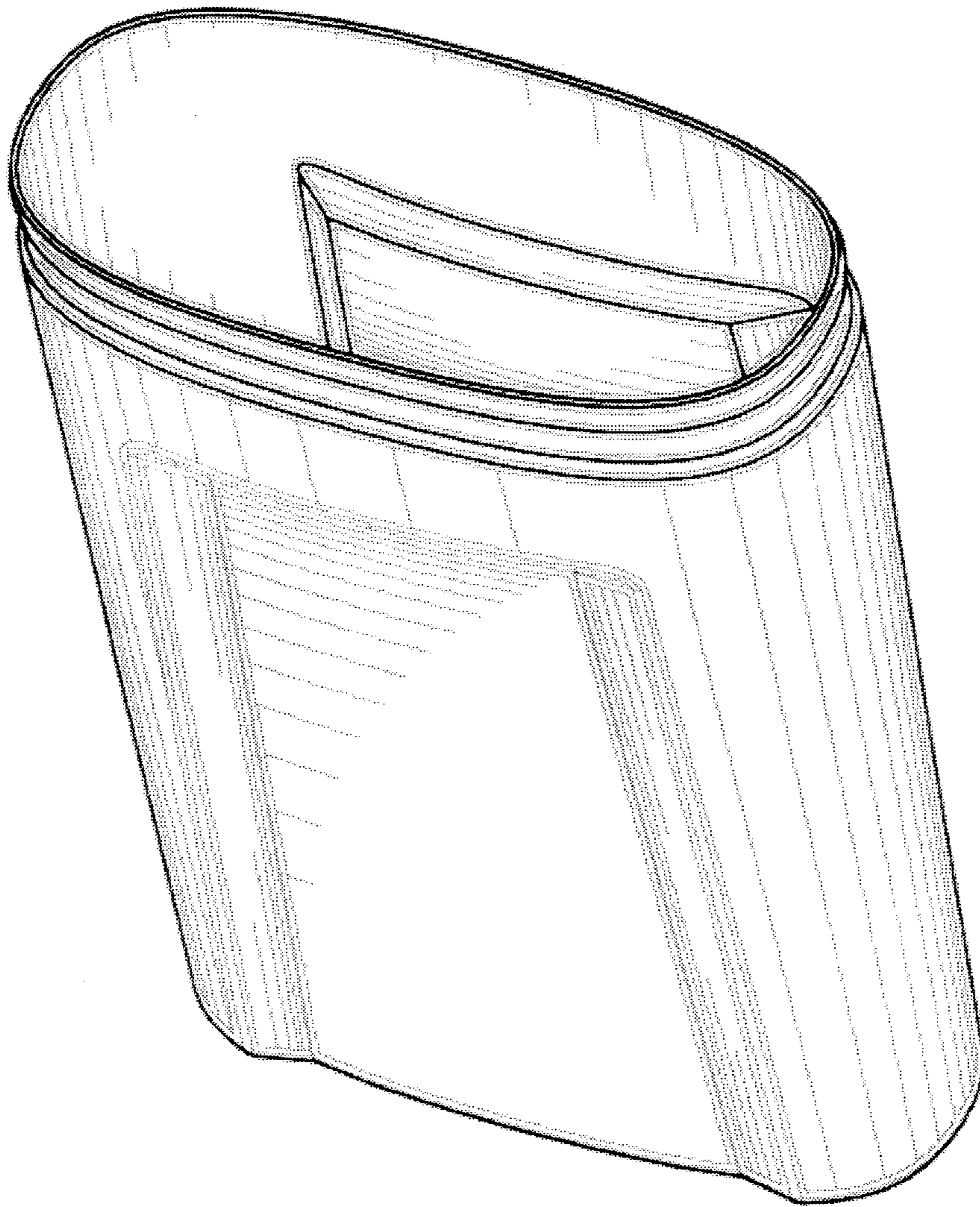

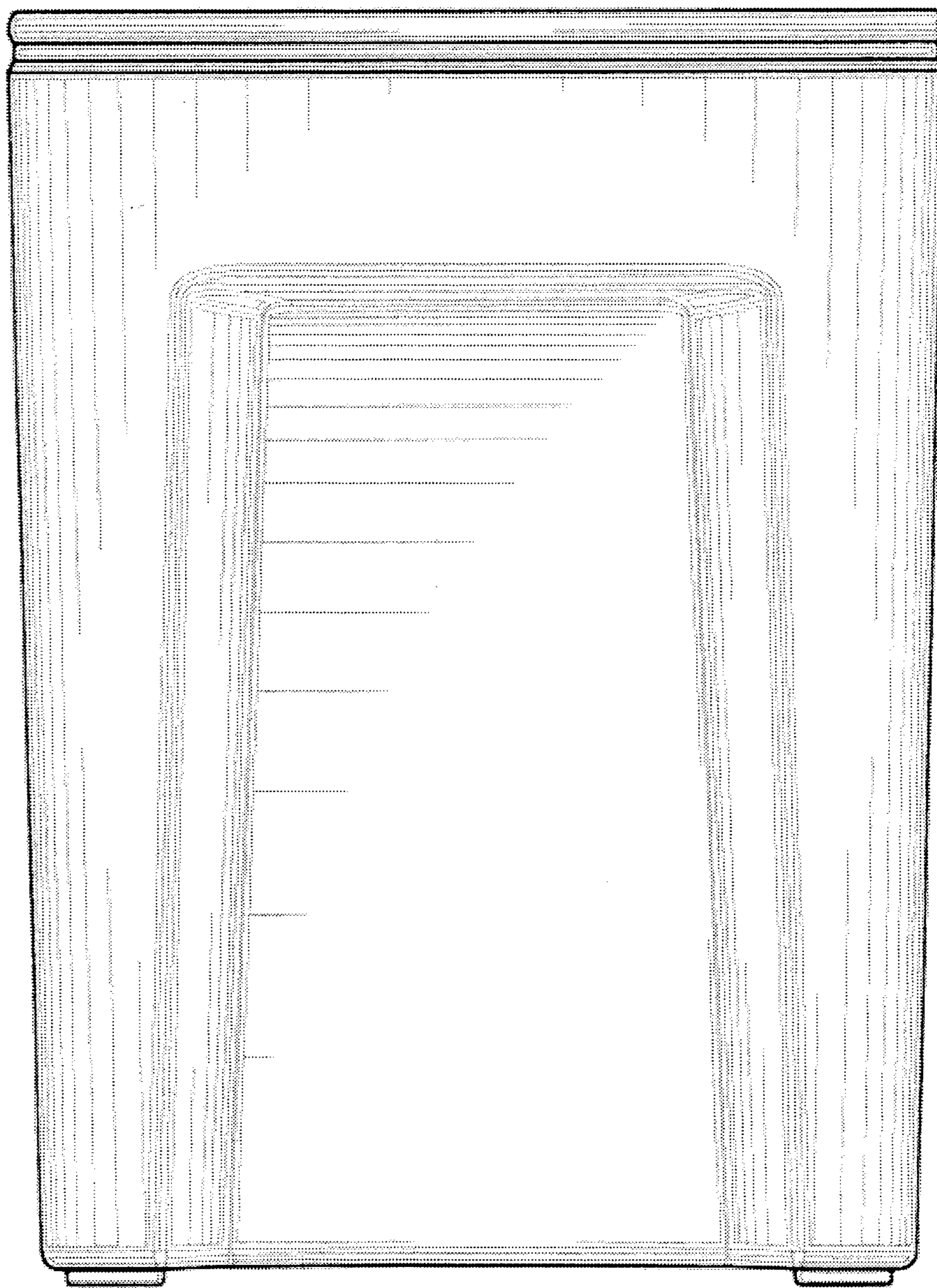

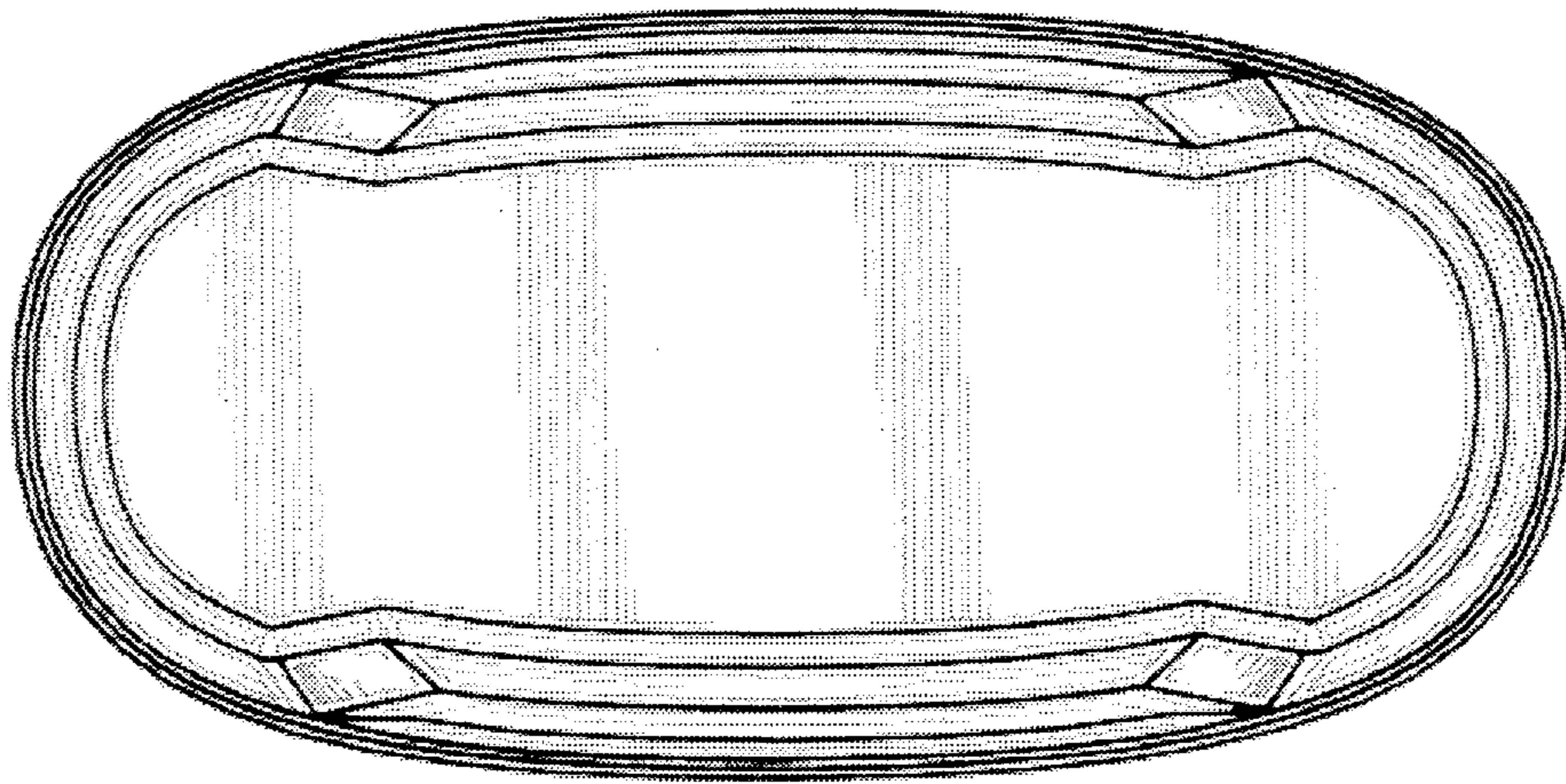

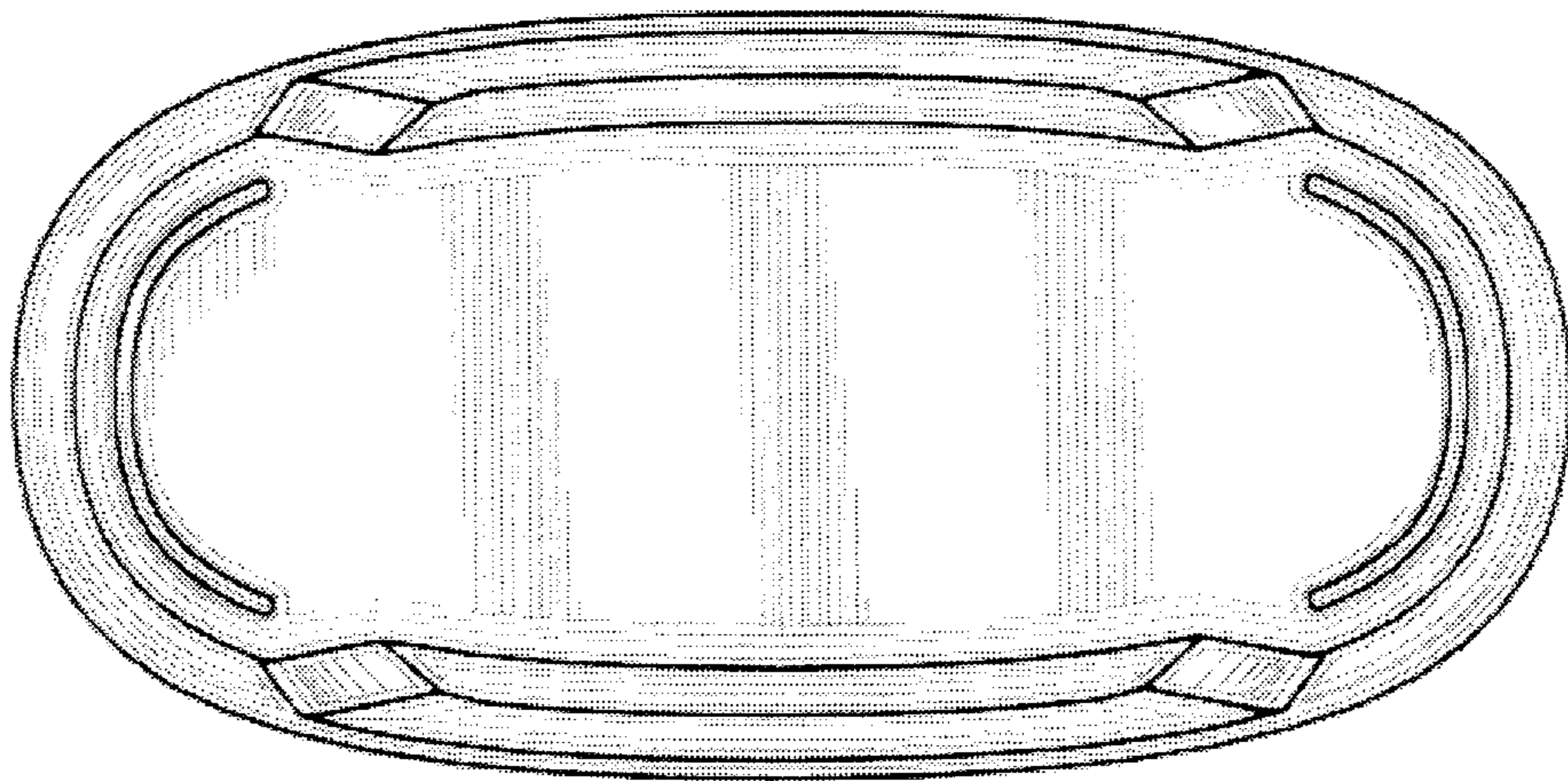

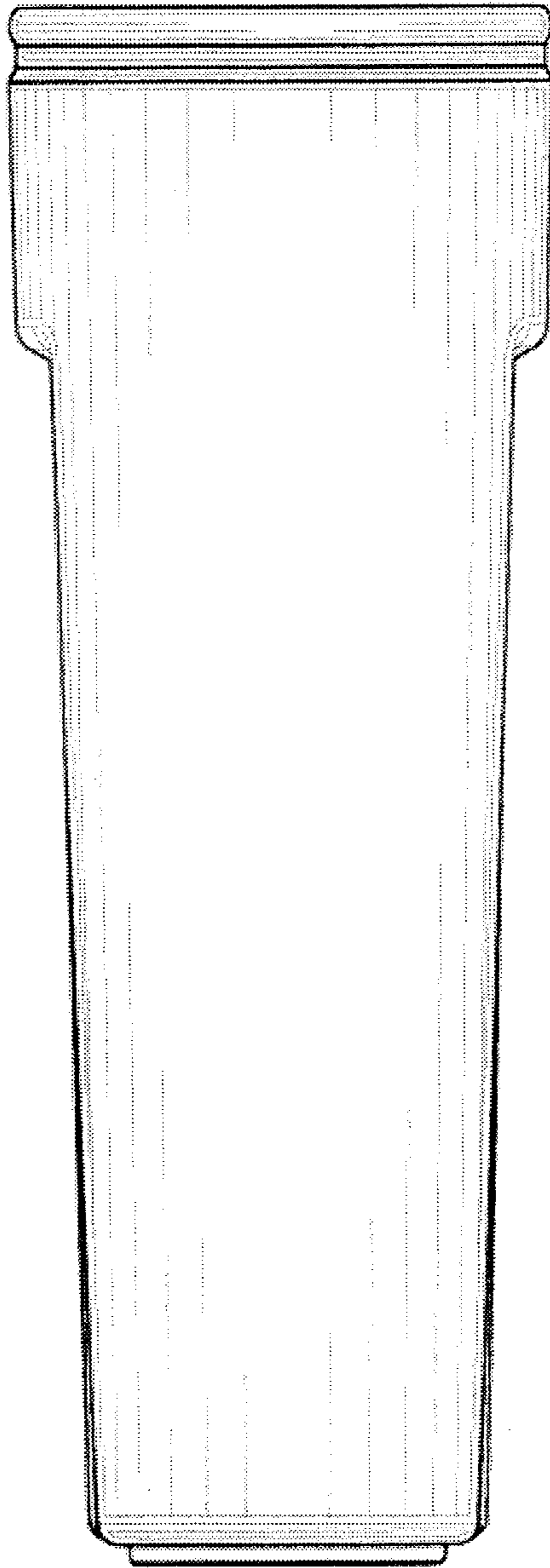


