[57] **CLAIM**

The ornamental design for a combined portable computer docking station and computer, as shown and described.

DESCRIPTION

FIG. 1 is a top front and left side perspective view of the

combined portable computer docking station and computer showing our new design;

FIG. 2 is an exploded top front and right side perspective view thereof showing the front end of the docking station in the unfolded position and the lid of the computer closed;

FIG. 3 is a top view of the docking station thereof shown separately for clarity of illustration only;

FIG. 4 is a bottom view thereof;

FIG. 5 is a left side view thereof;

FIG. 6 is a right side view thereof;

FIG. 7 is a front view thereof;

FIG. 8 is a rear view thereof;

FIG. 9 is a right side view thereof similar to FIG. 6 and shown with the front end in the unfolded position;

FIG. 10 is a top view of the portable computer thereof shown with the lid closed and also shown separately for clarity of illustration only;

FIG. 11 is a top view thereof similar to FIG. 10 and shown with the lid open;

FIG. 12 is a front view thereof;

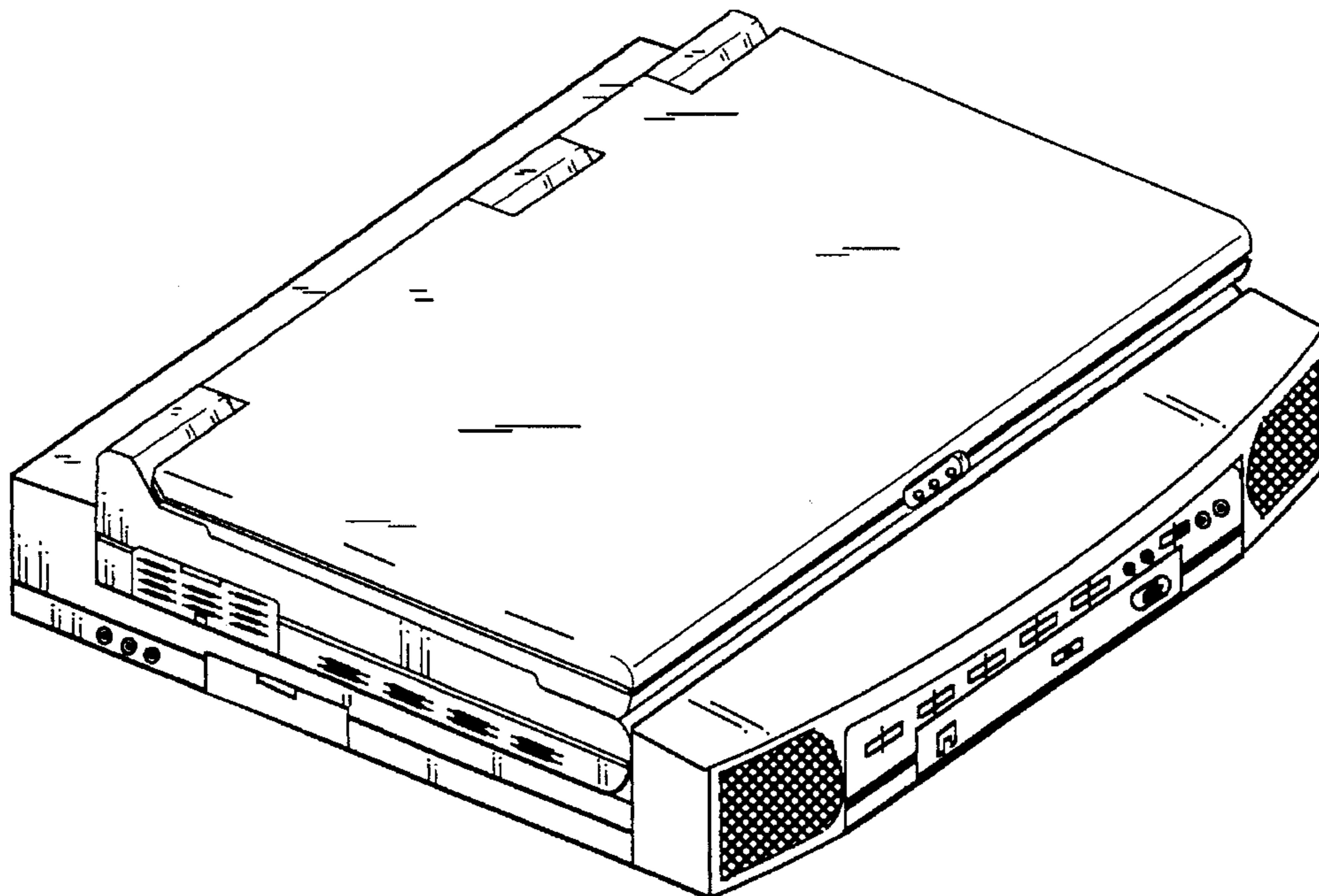
FIG. 13 is a rear view thereof;

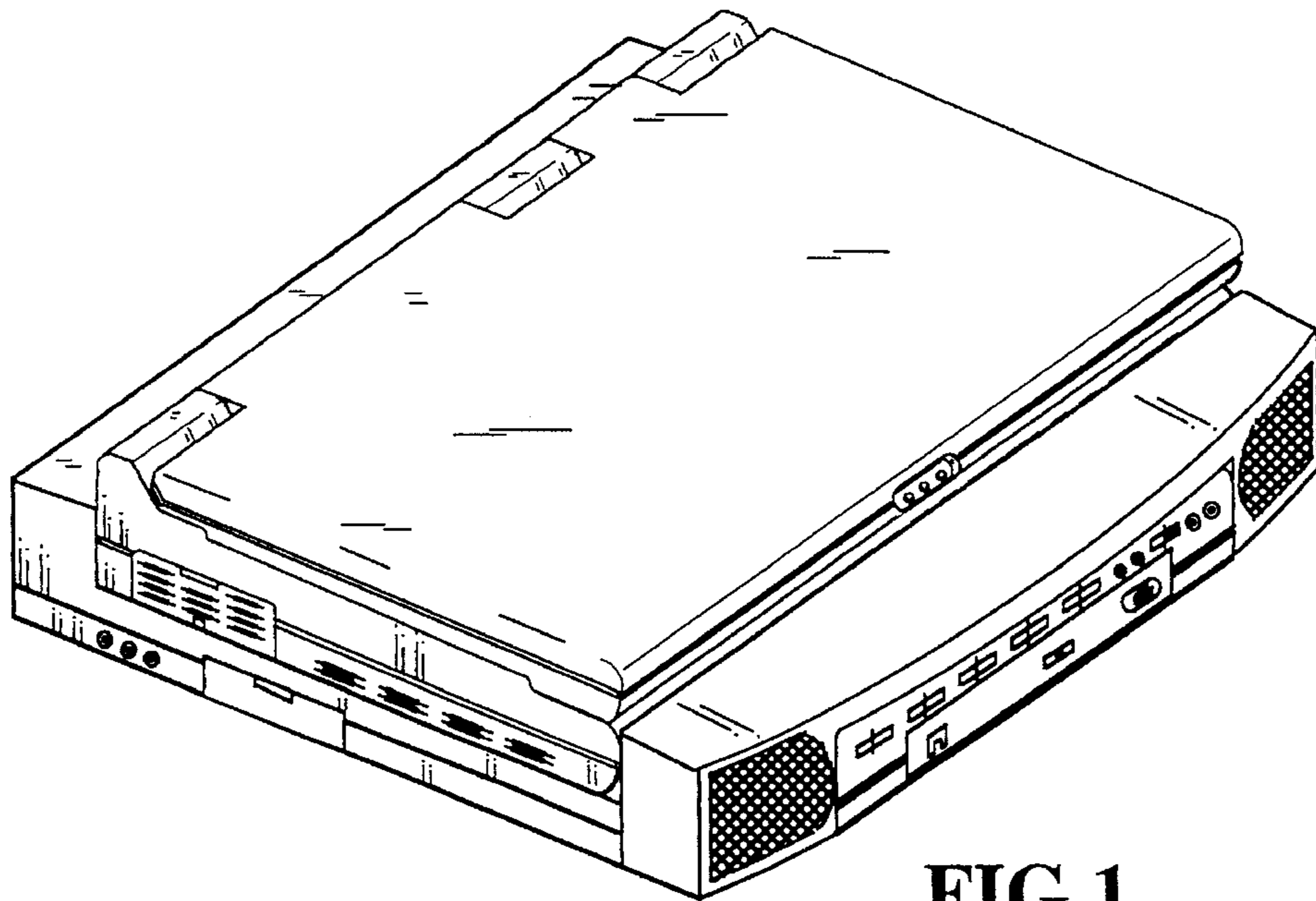

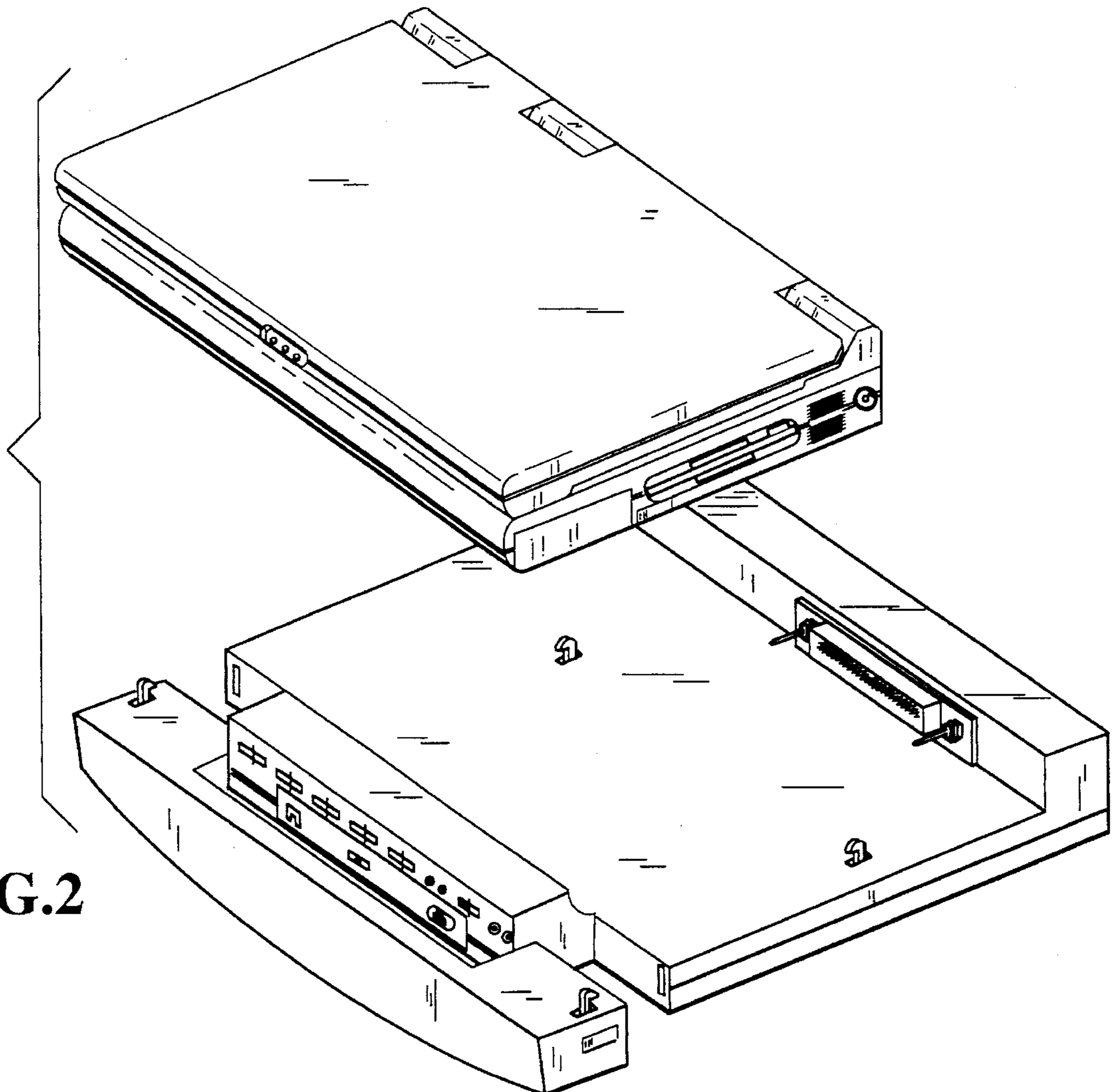

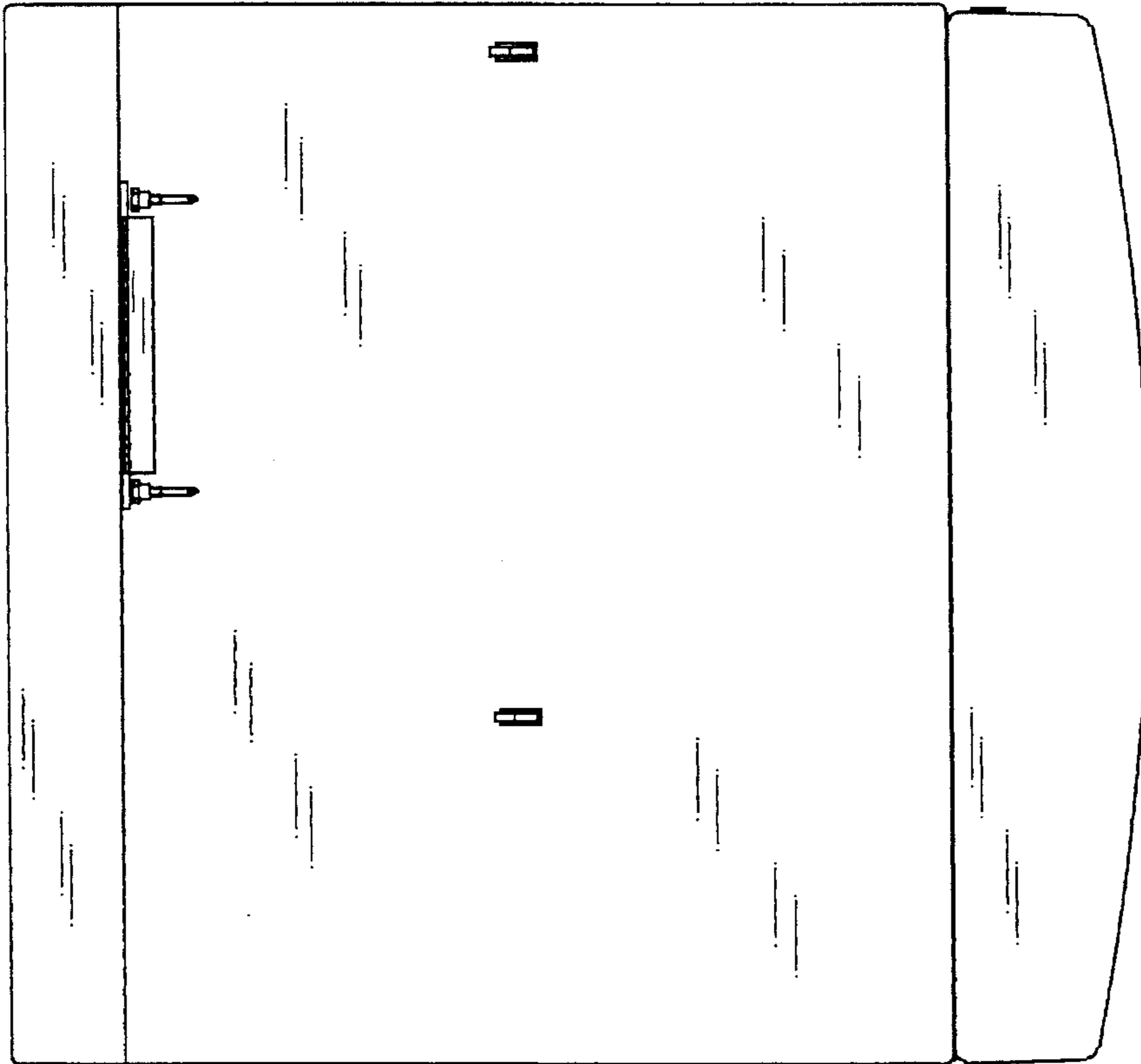

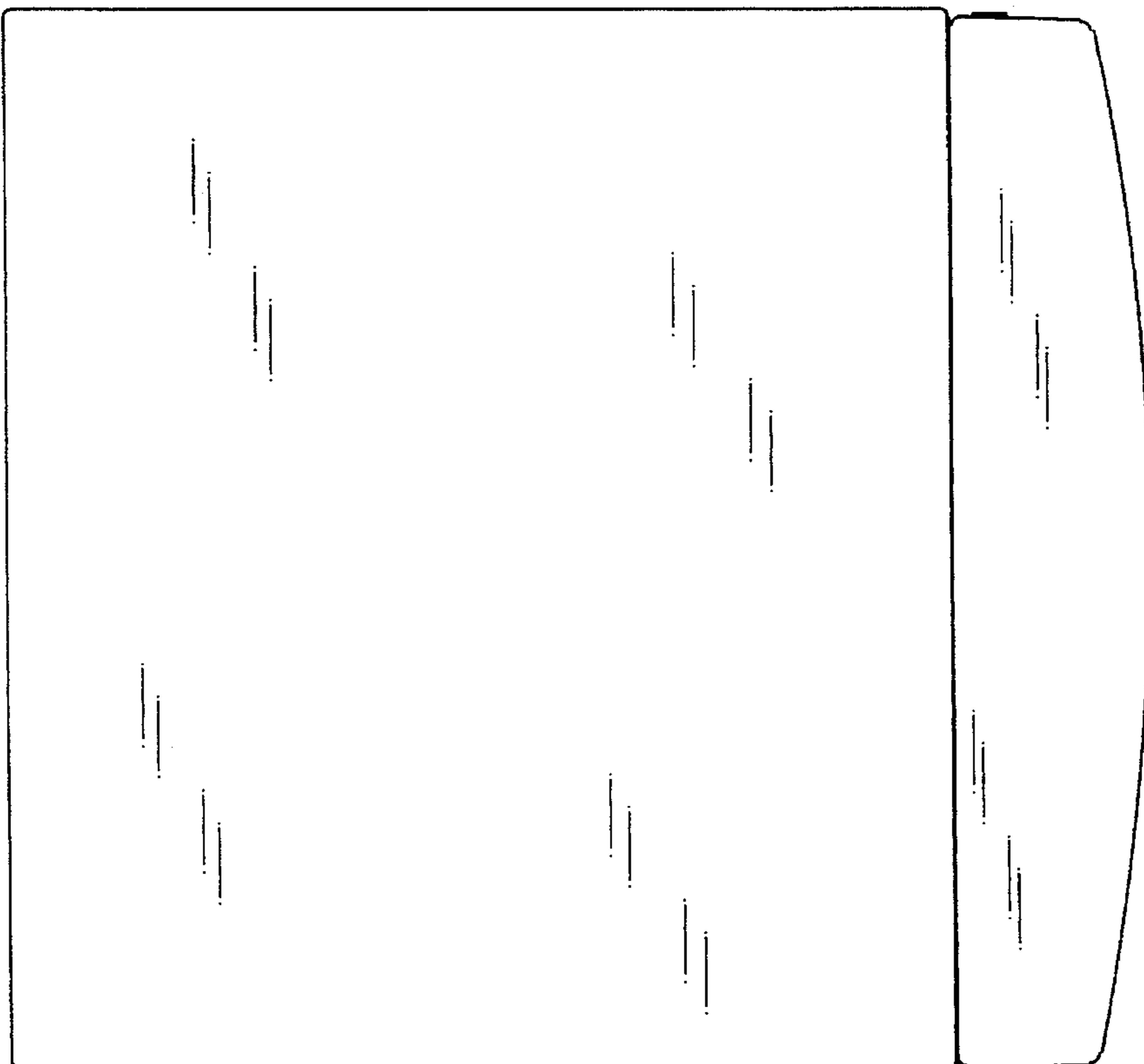

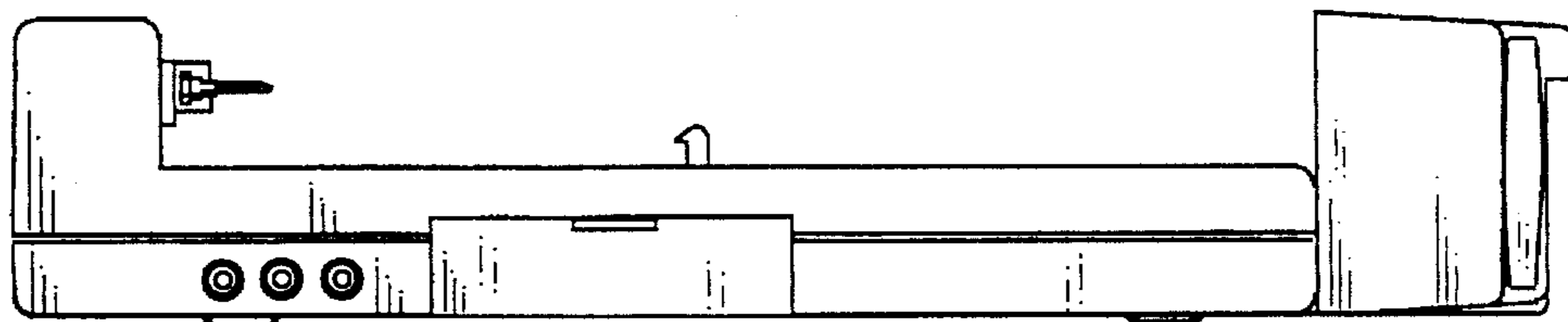

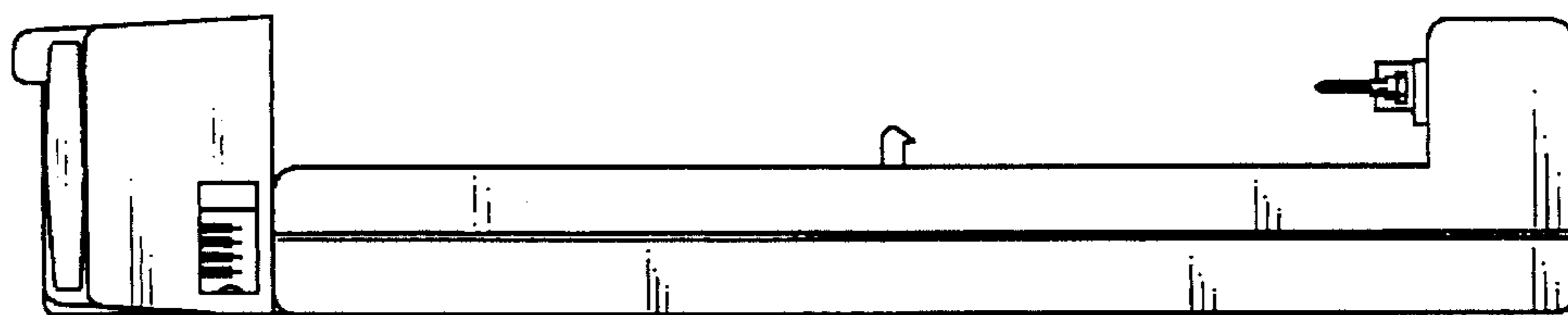

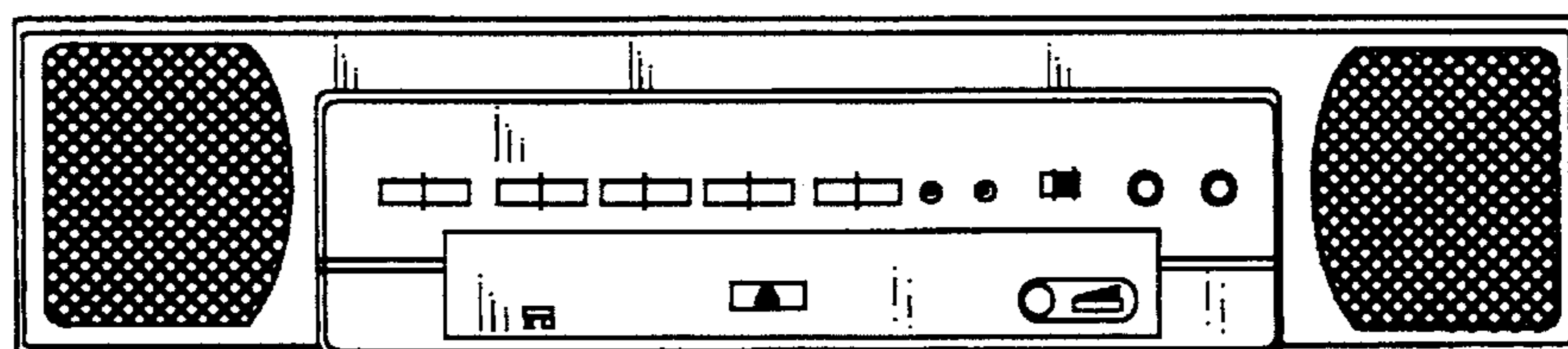

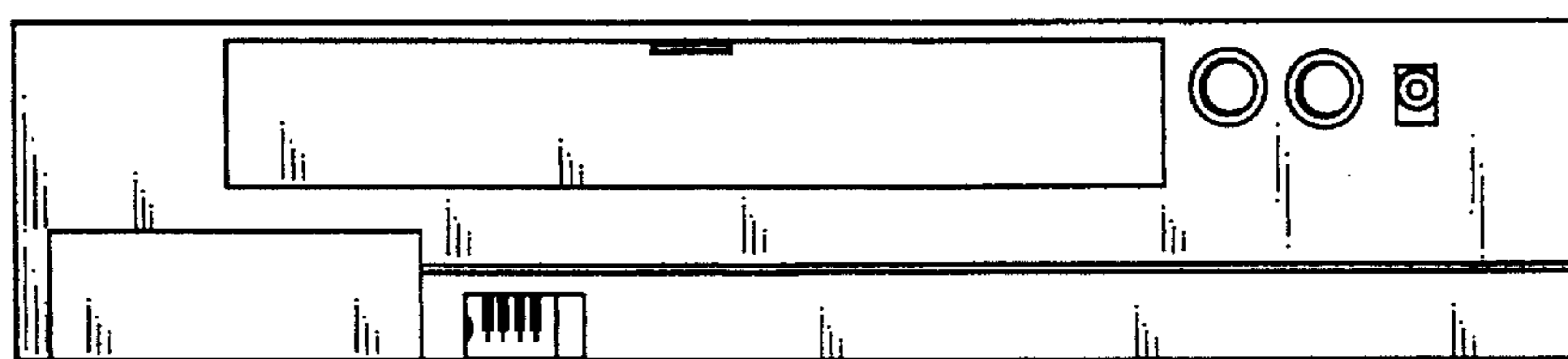

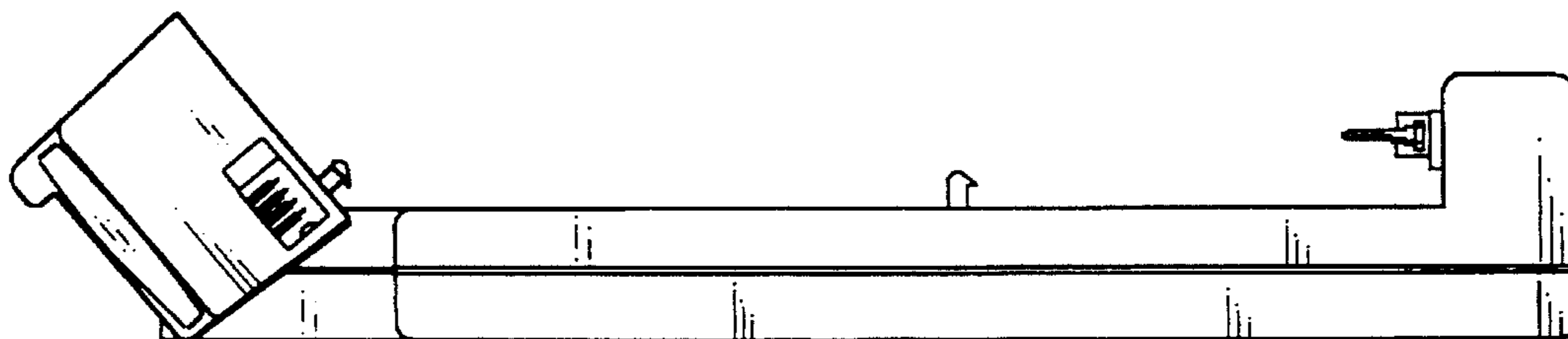

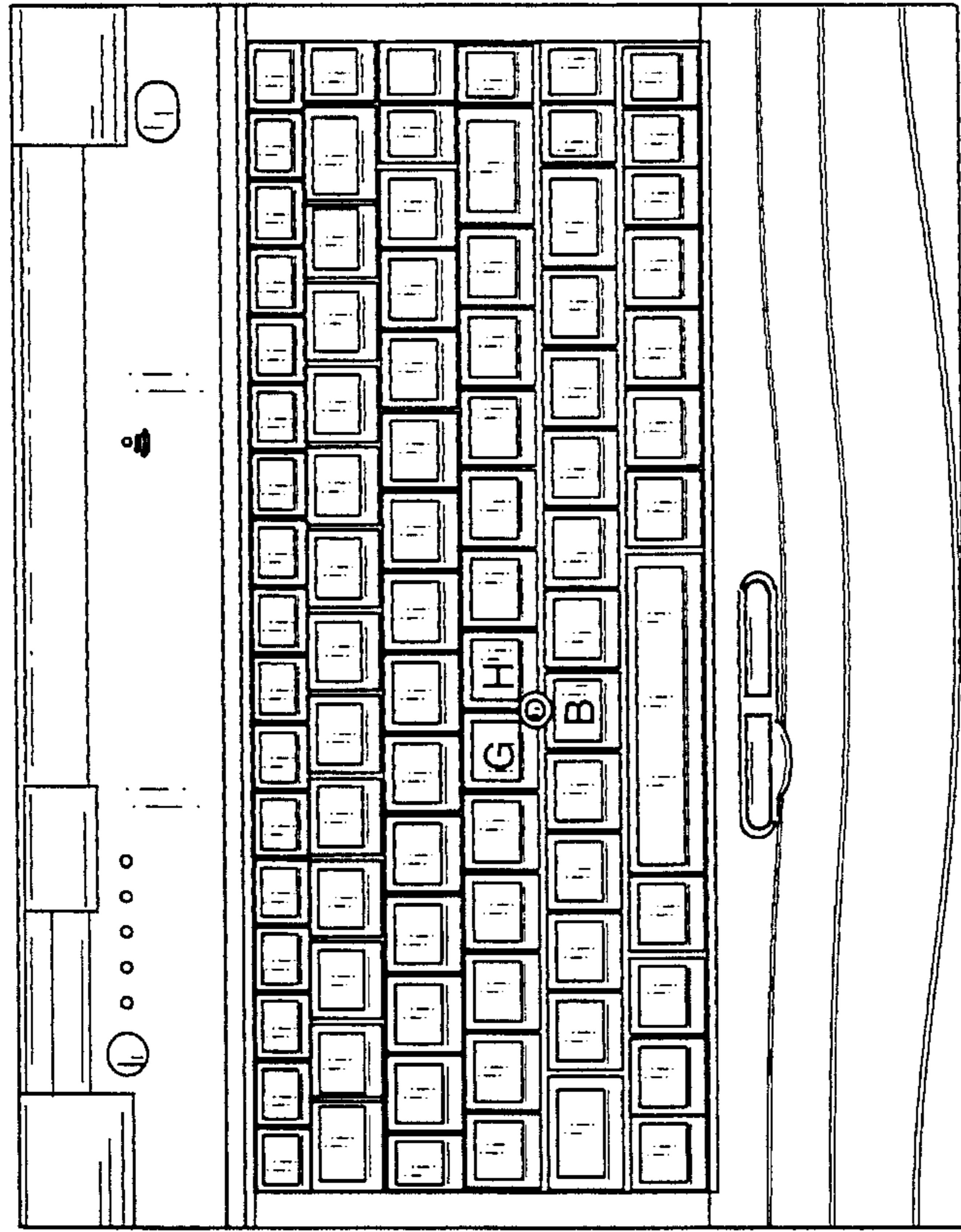

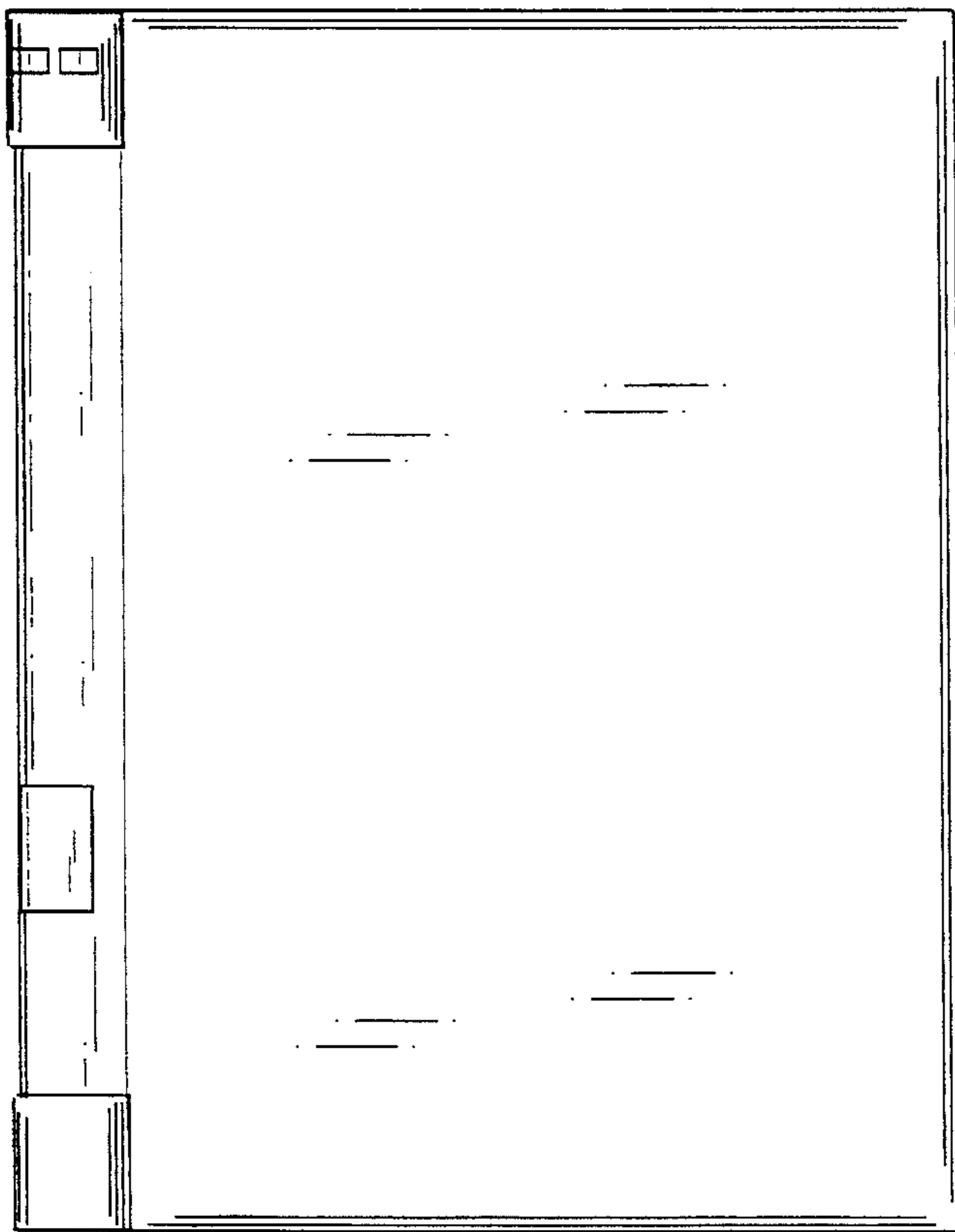

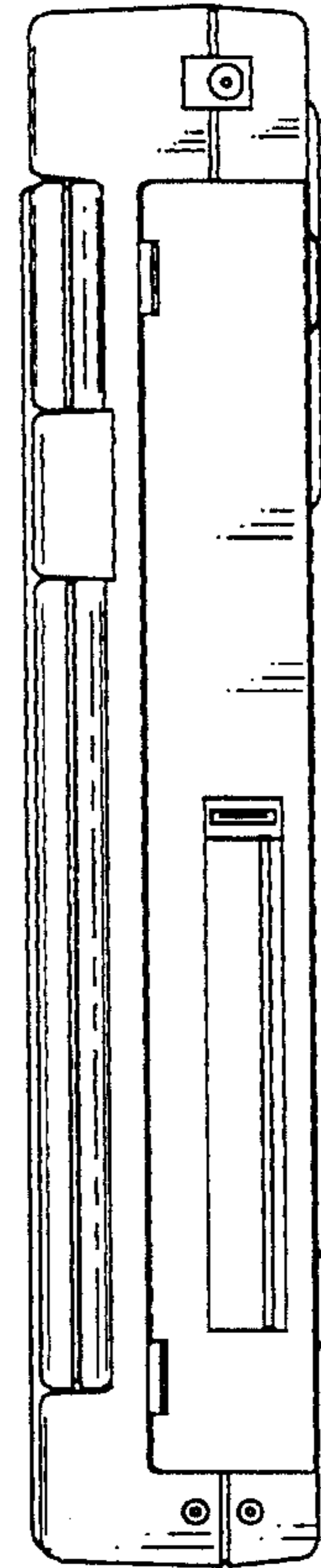

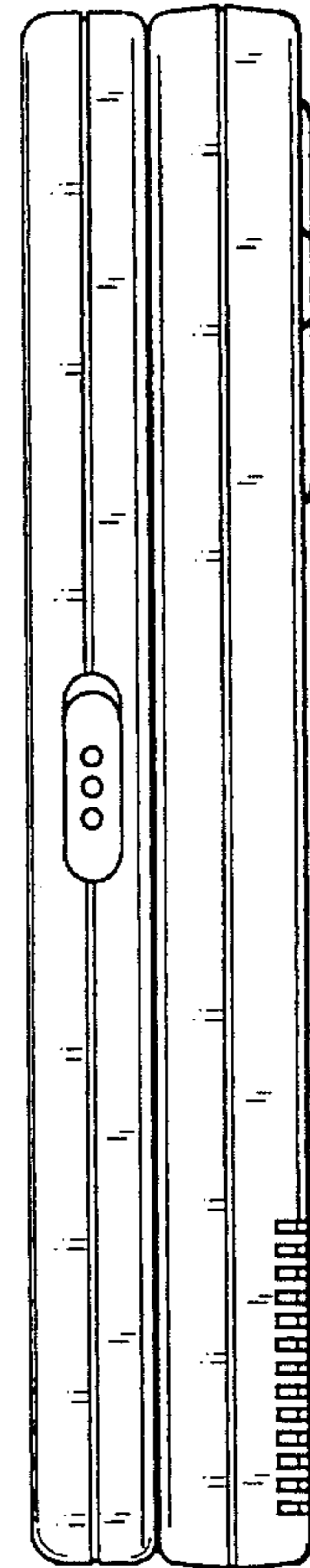

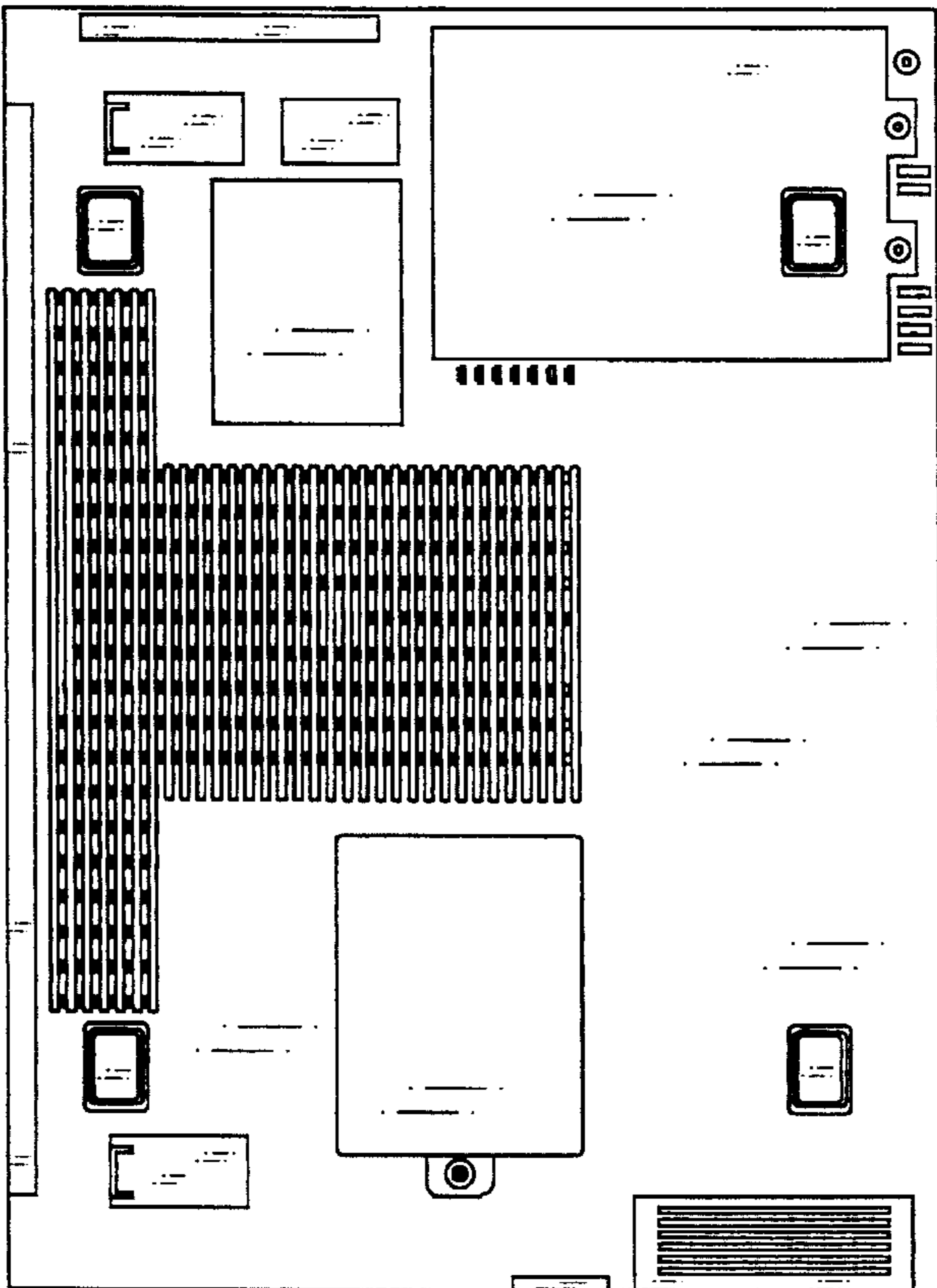

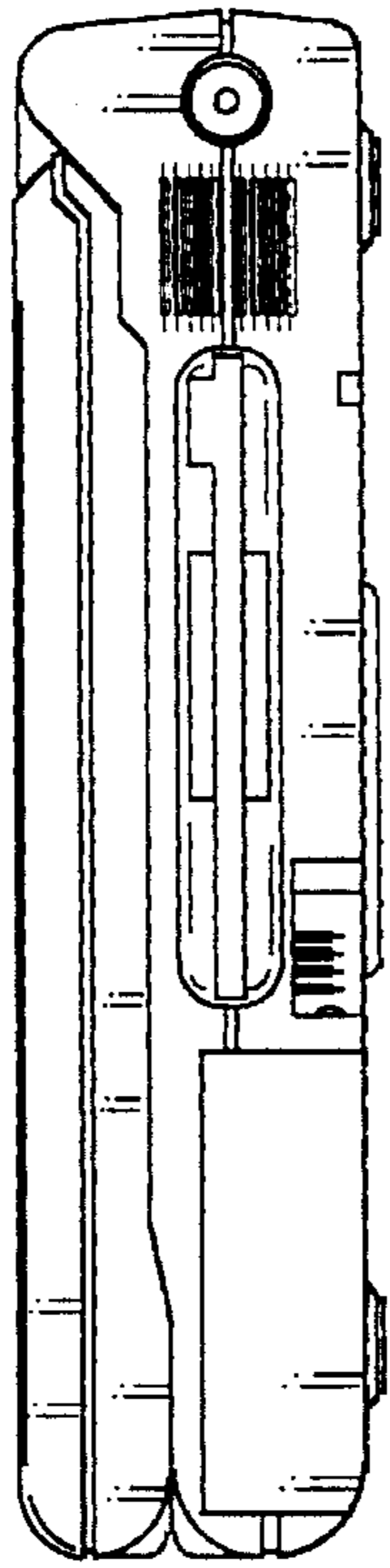

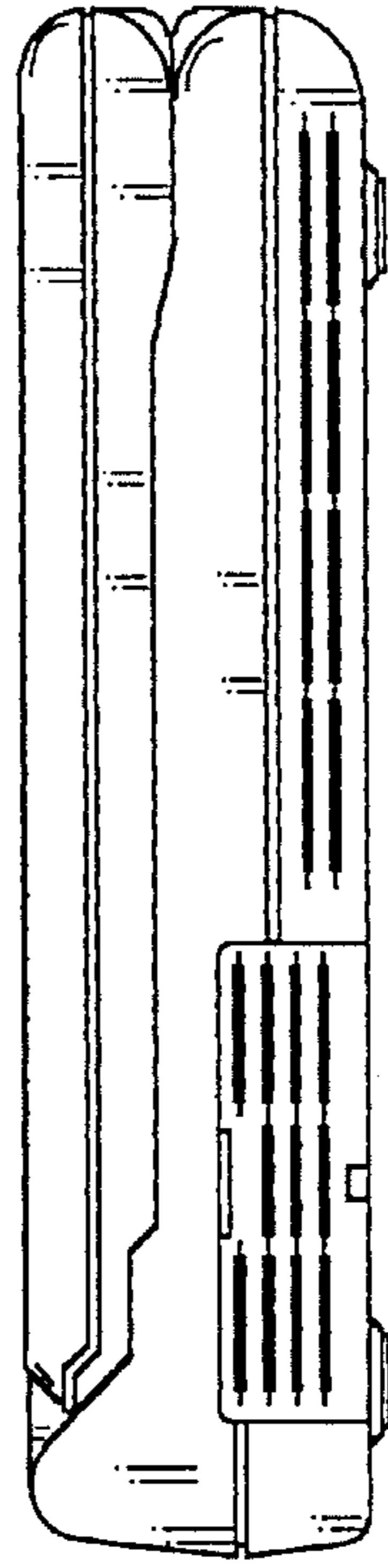
