[57] **CLAIM**

The ornamental design for a telephone card reader console, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, left perspective view of a telephone card reader console showing our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a left side view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a rear elevational view thereof; FIG. 7 is a front elevational view of a second alternate embodiment of FIG. 1, the only difference being a plate filling a card reader position; FIG. 8 is a front elevational view of a third embodiment of FIG. 1, the only difference being a plate filling a digital display position; FIG. 9 is a left side view of FIG. 7; FIG. 10 is a right side view of FIG. 7; and, FIG. 11 is a top plan view of FIG. 7.

The broken line showing of FIG. 1 is for illustrative purposes only and form no part of the claimed design.

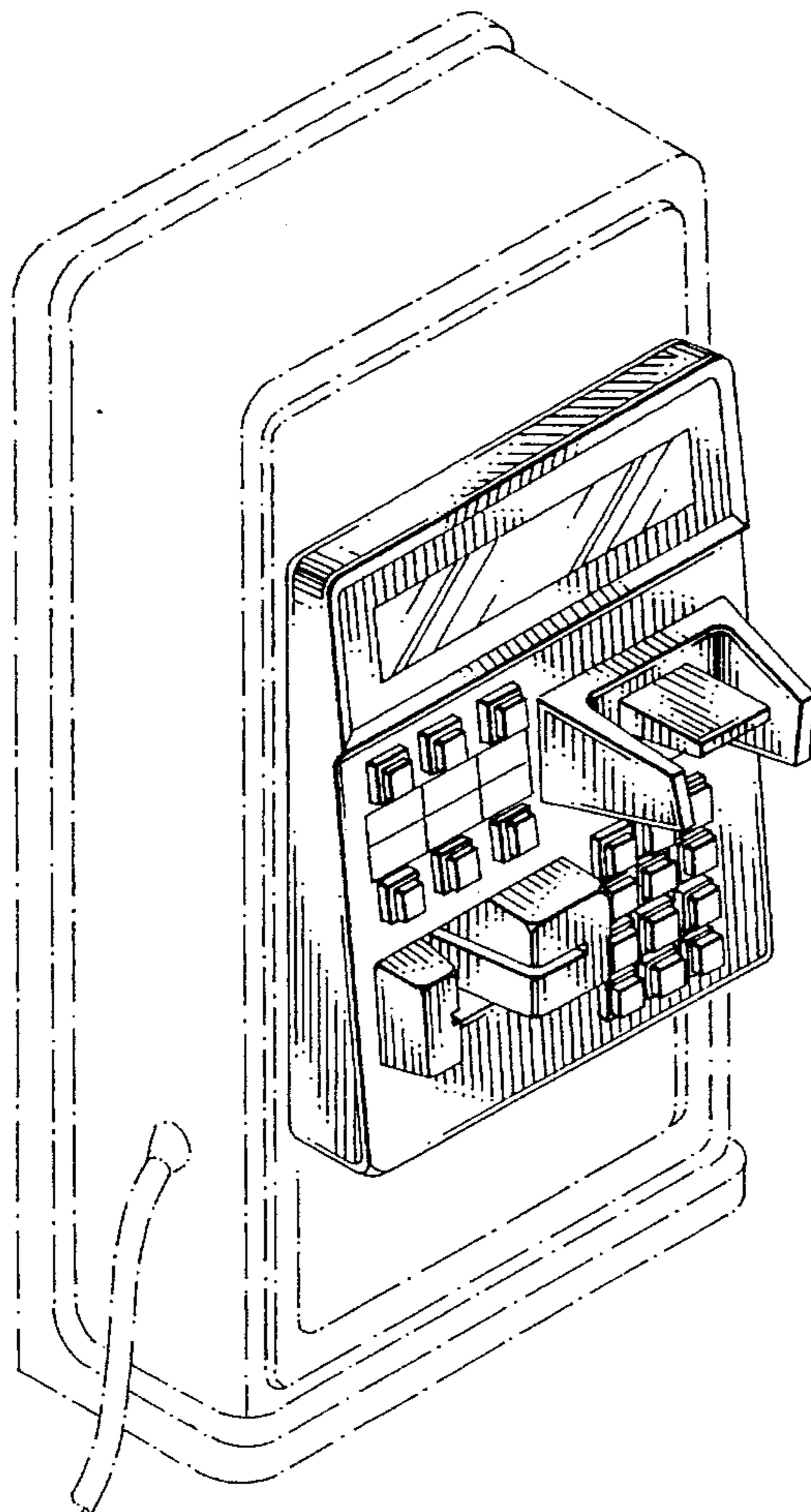

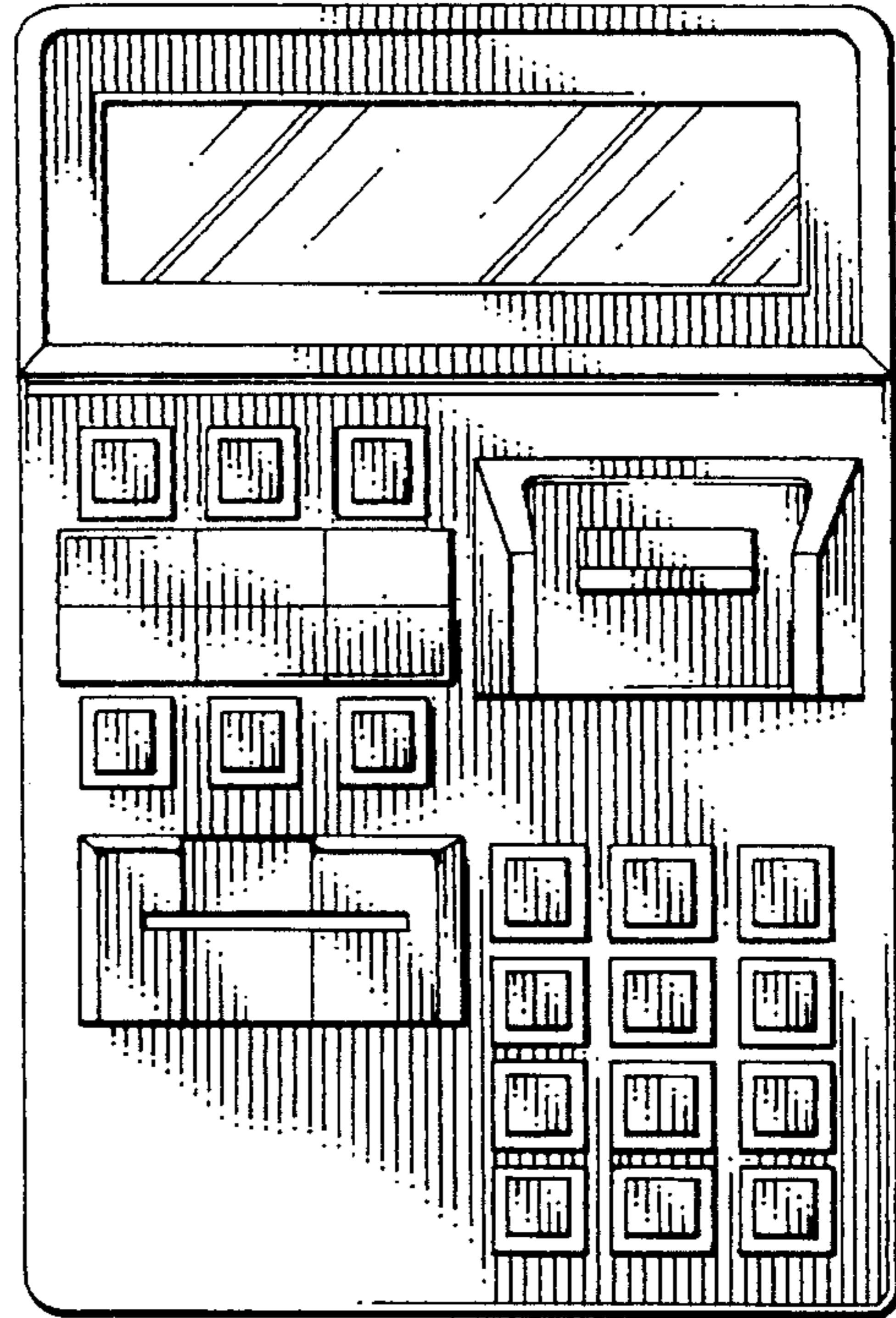
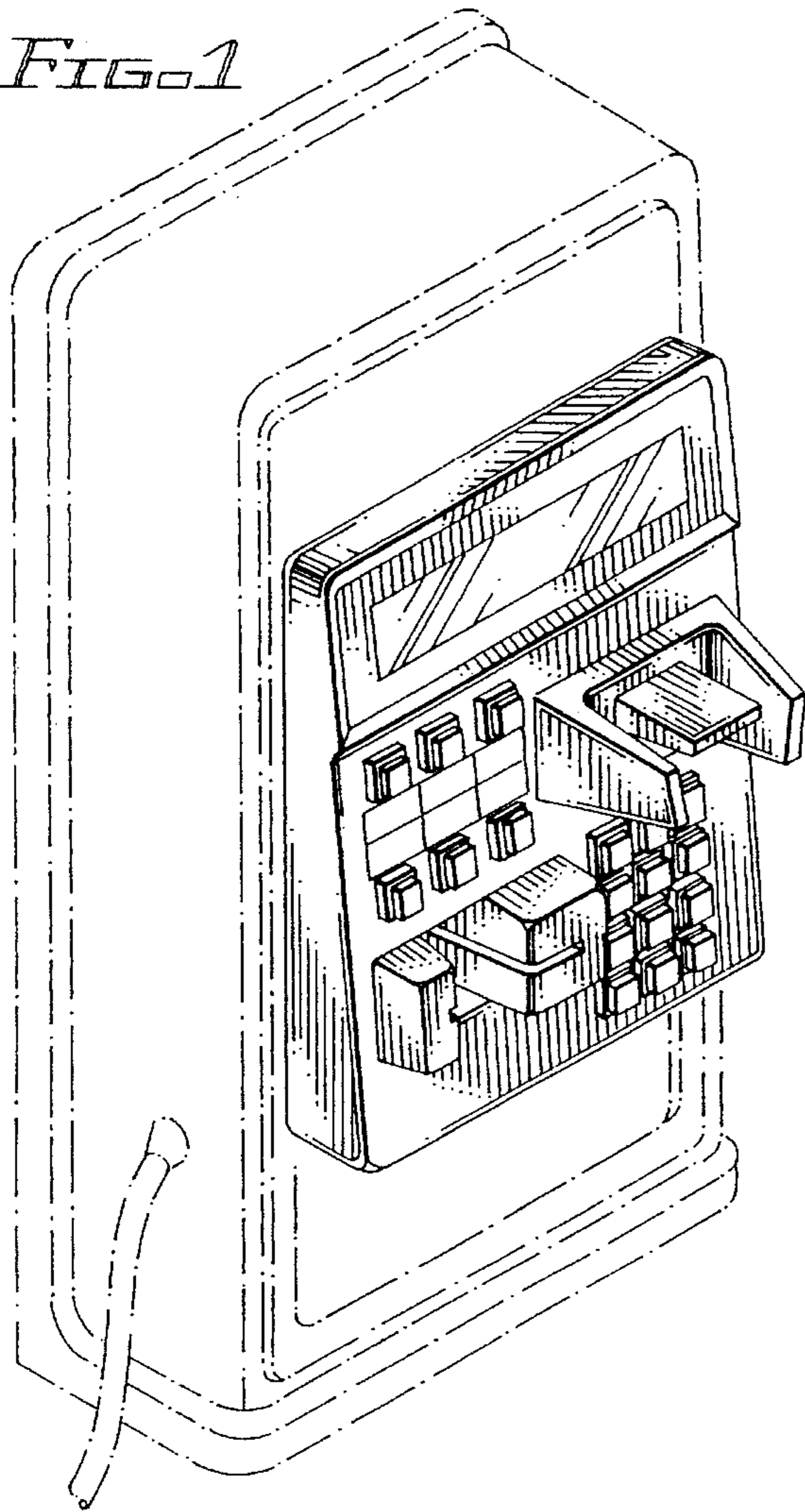

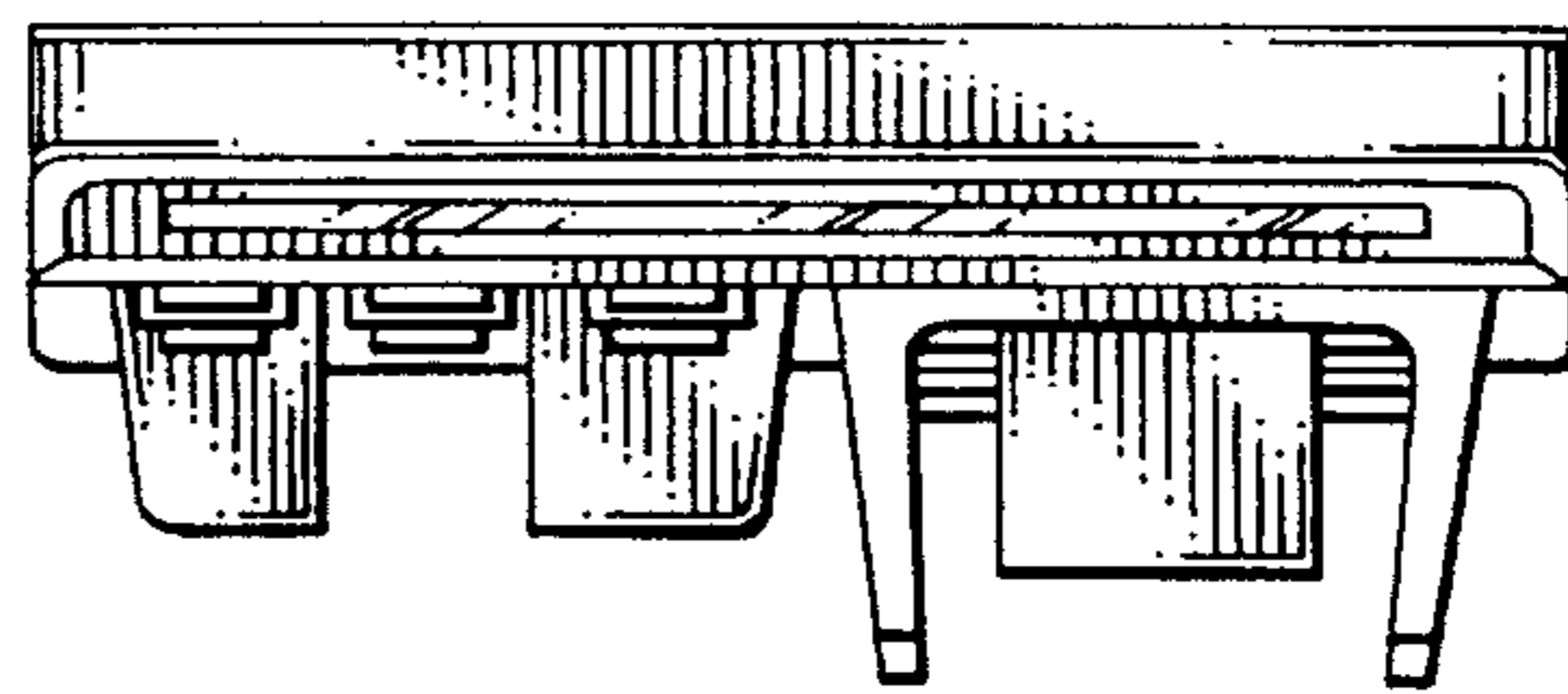

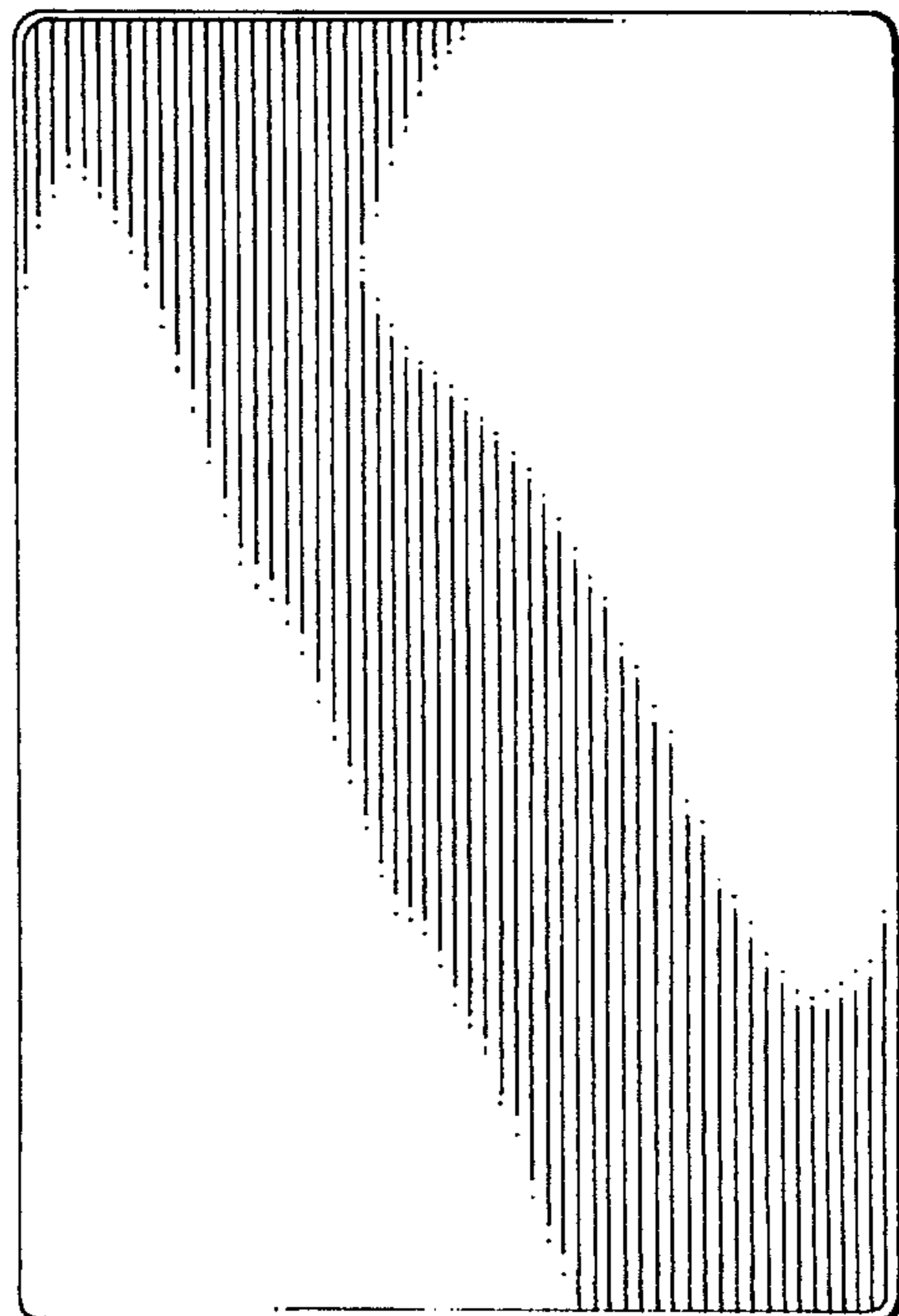

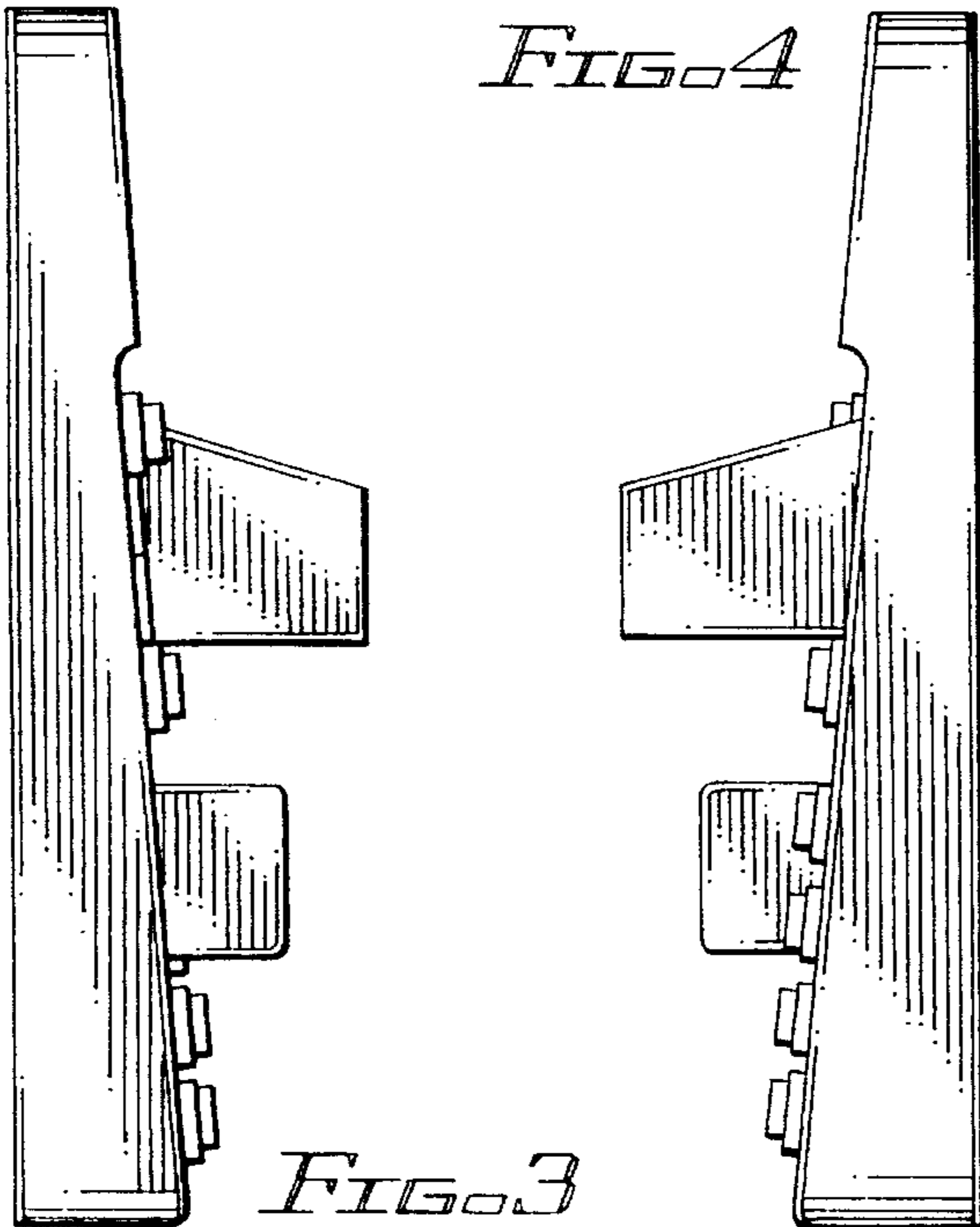

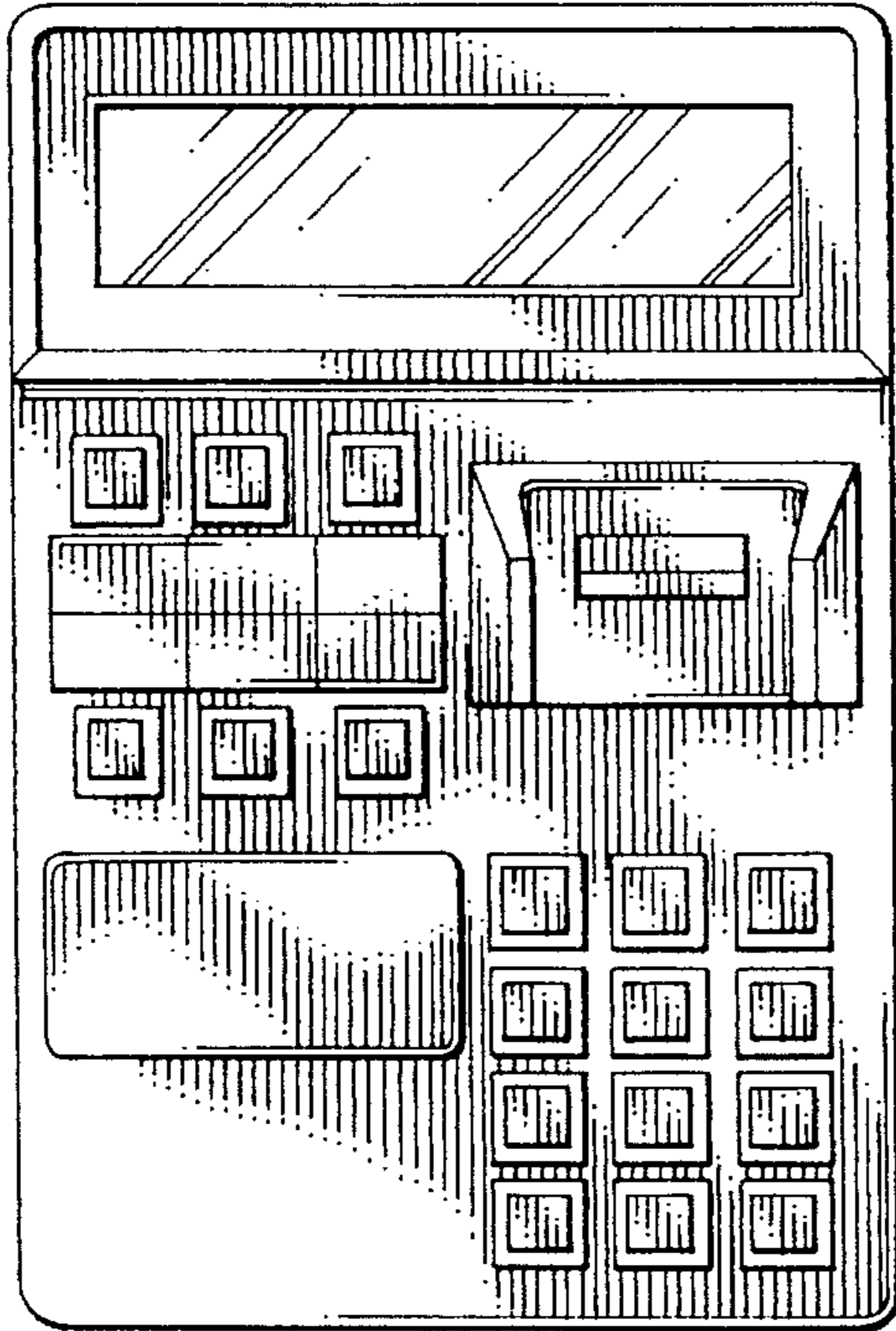

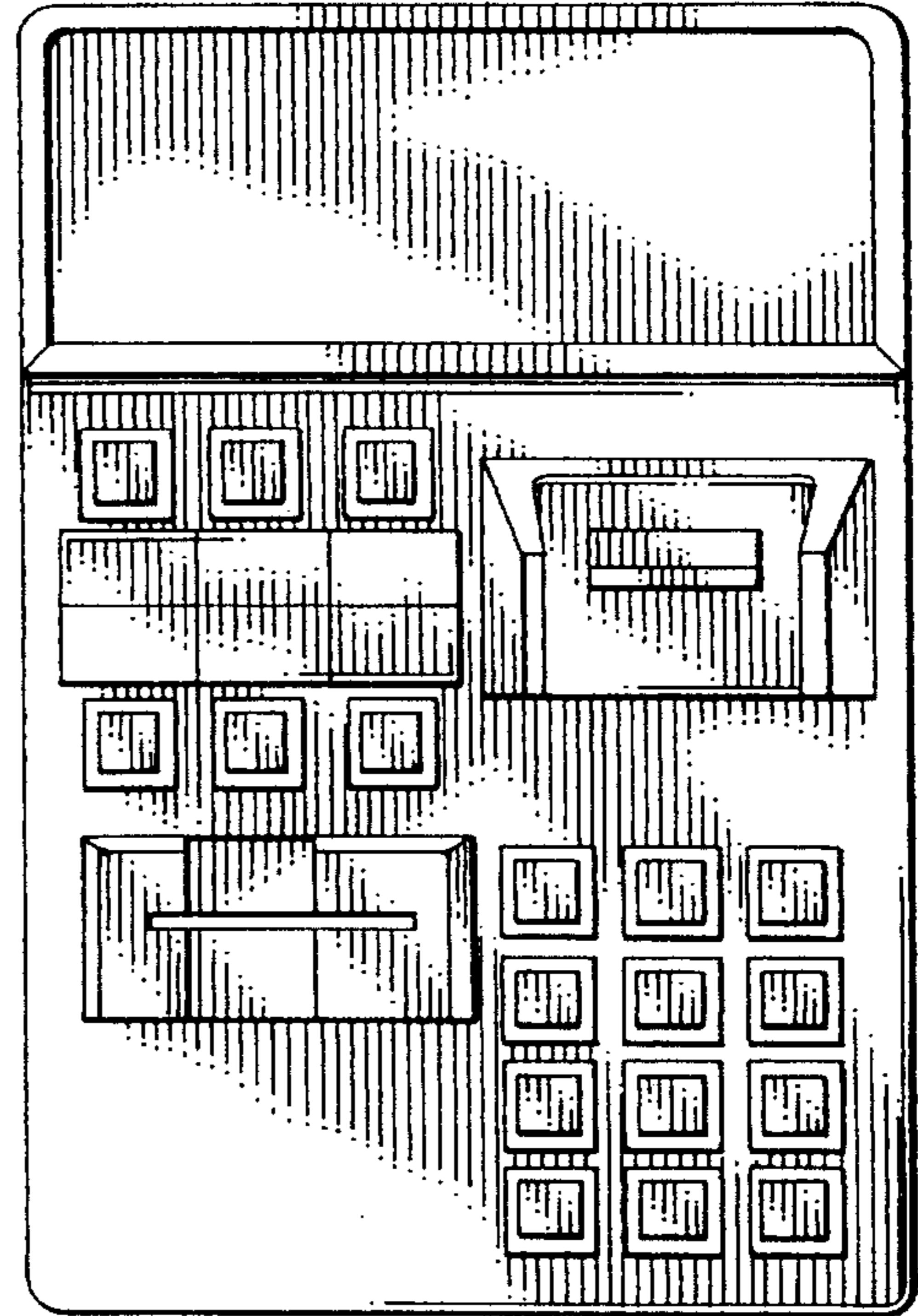

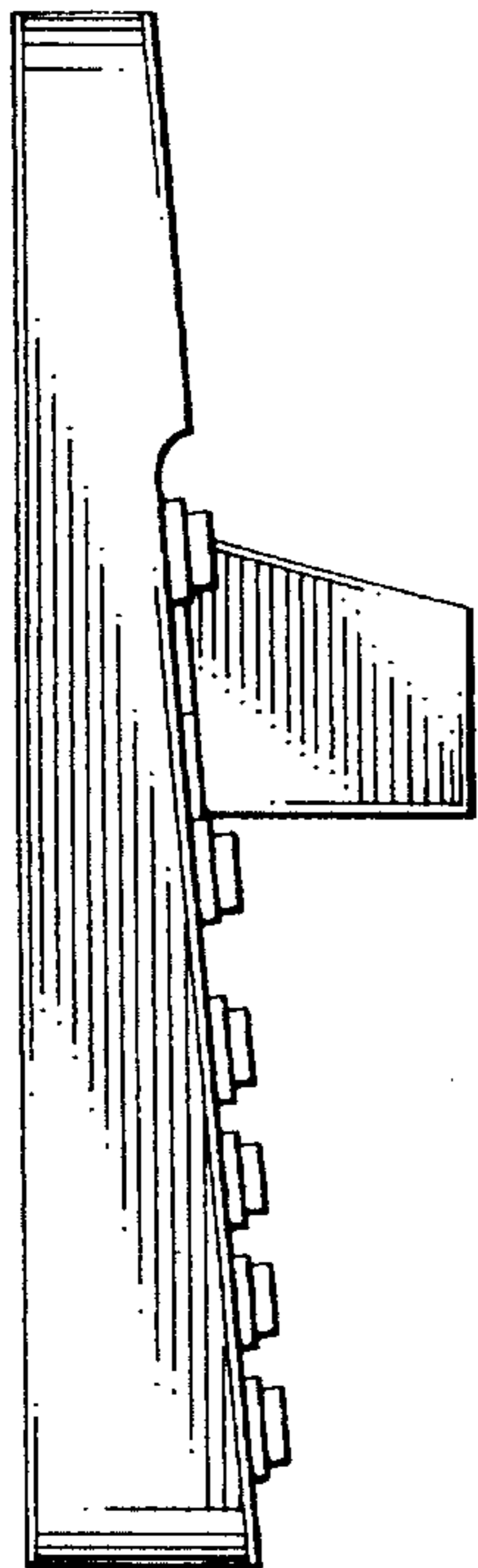

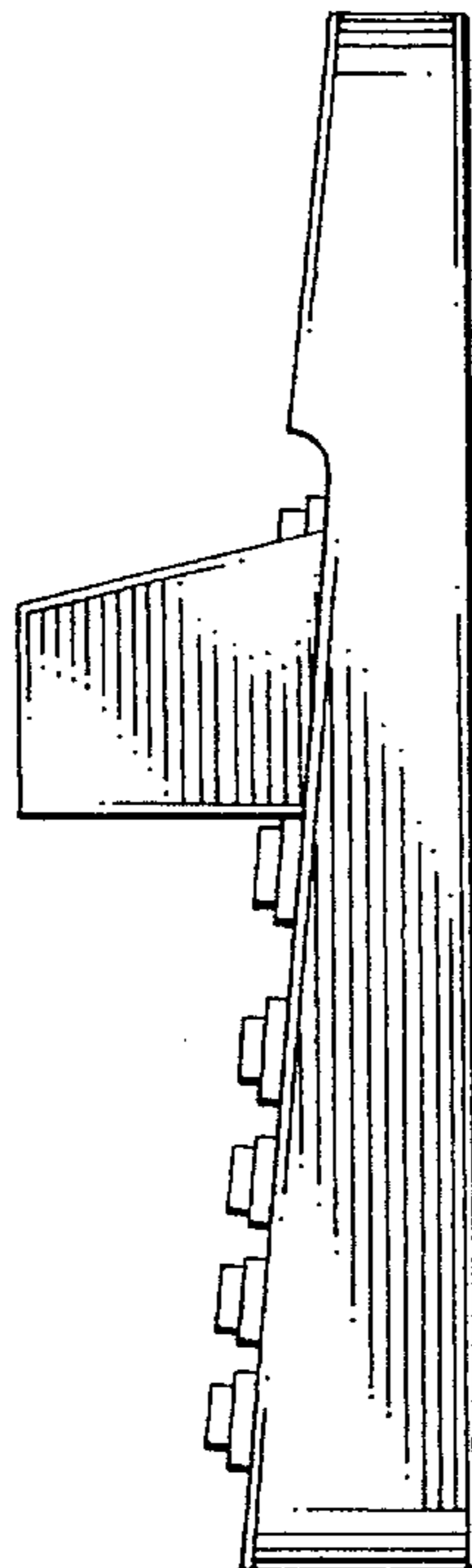

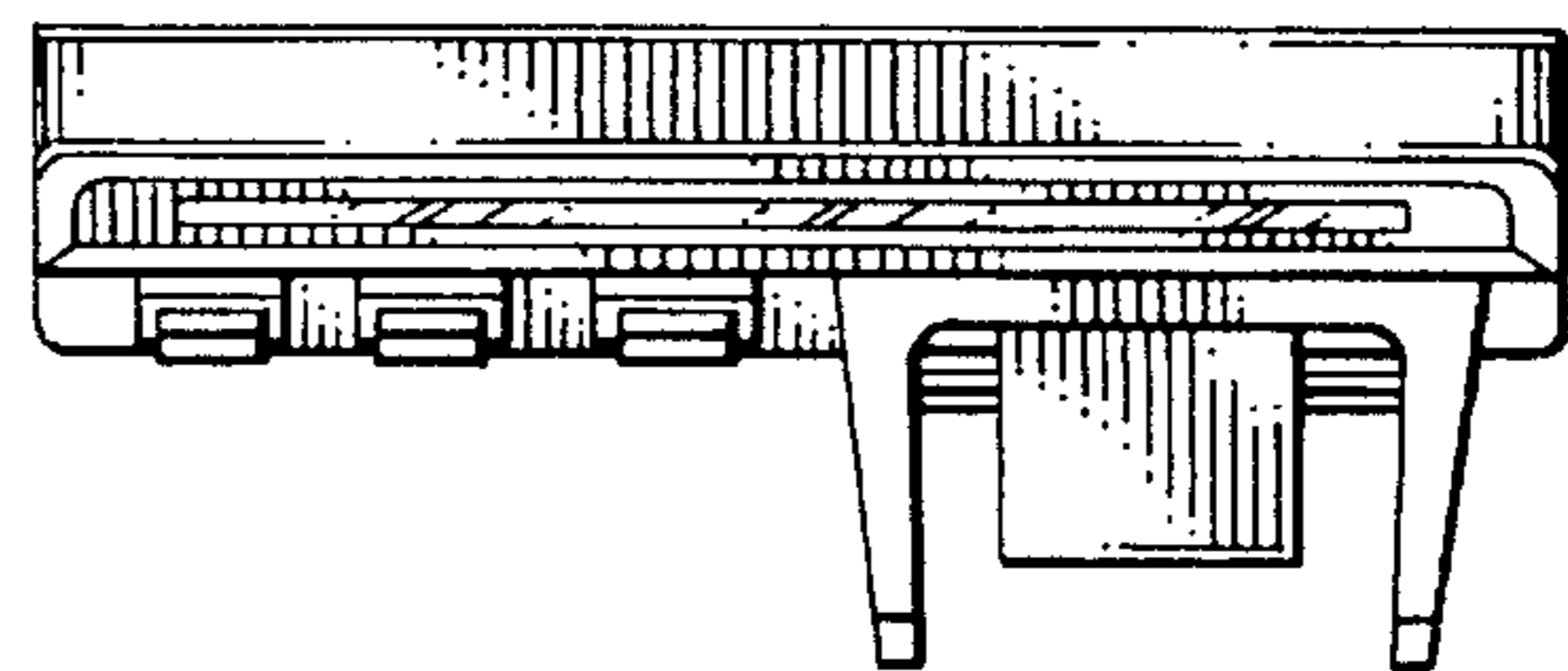
