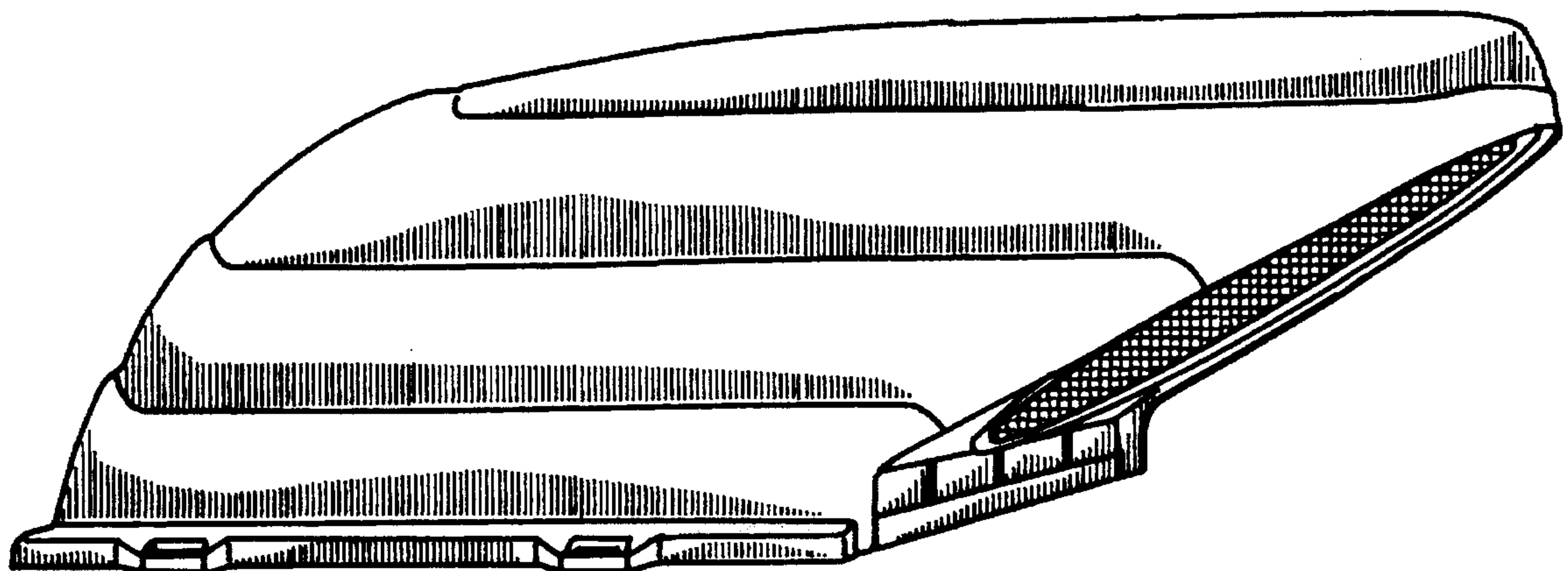
### [57] CLAIM

### DESCRIPTION

FIG. 1 is a rear perspective view of my new design for an air vent cover;

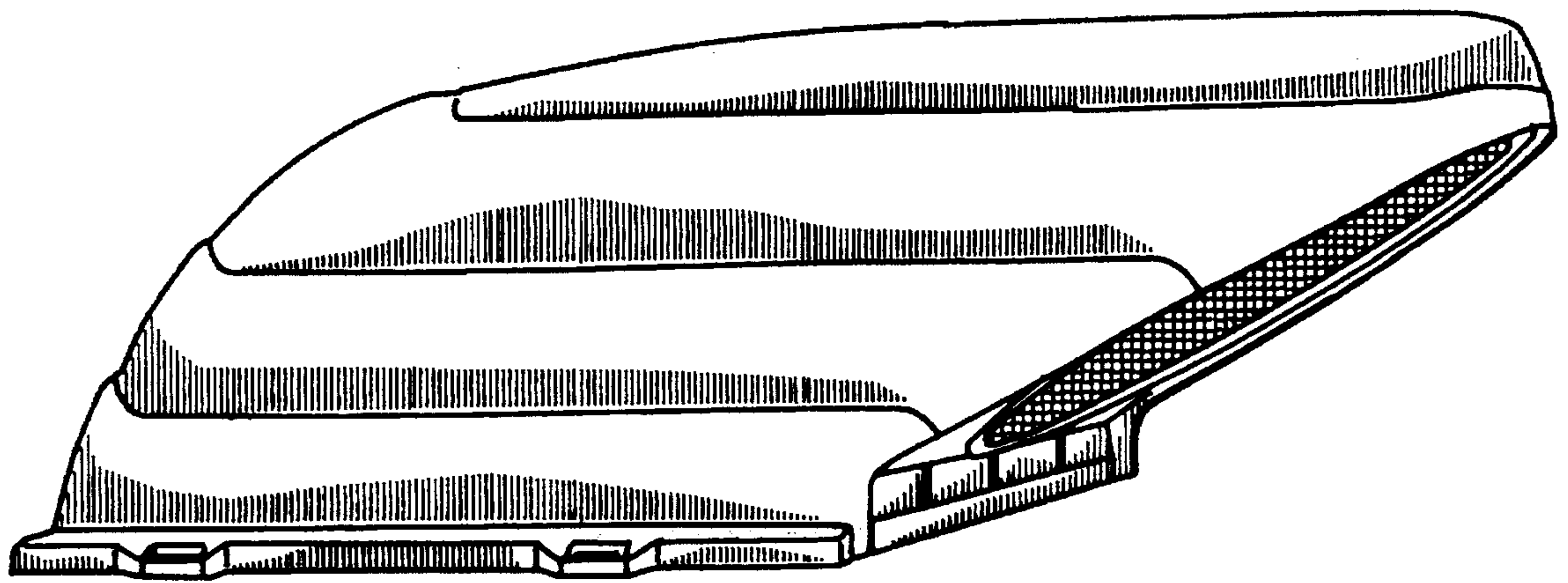

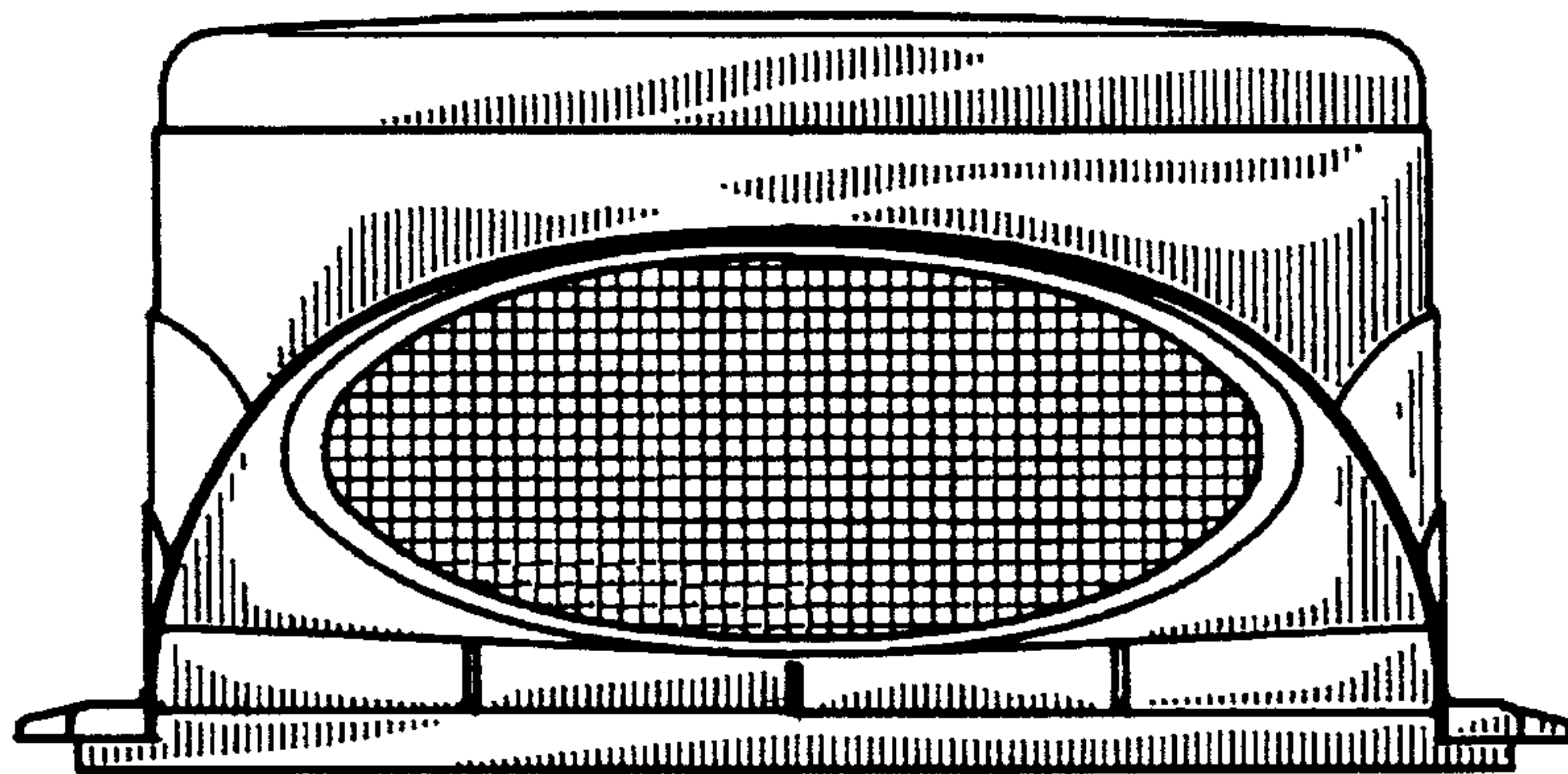

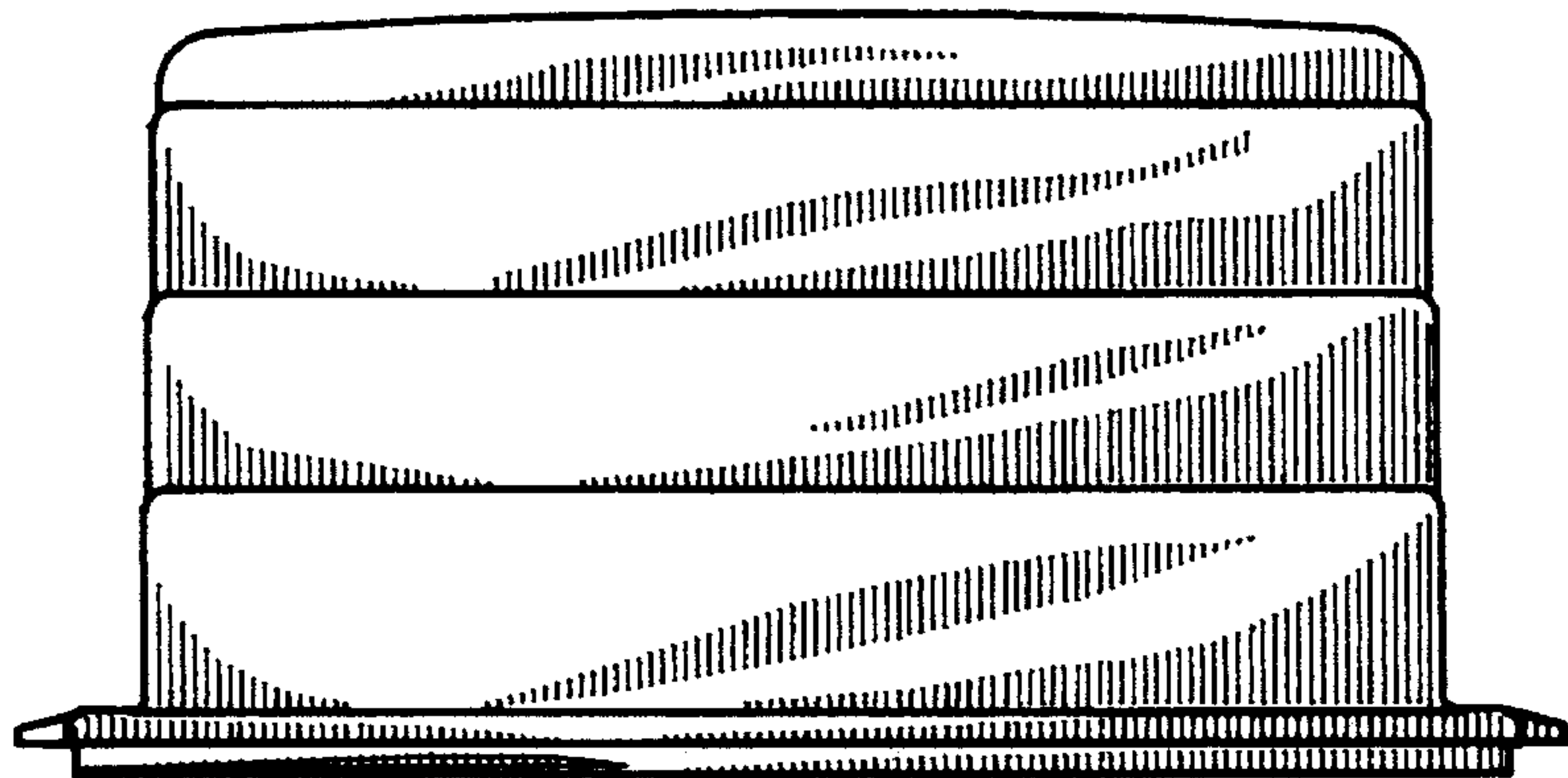

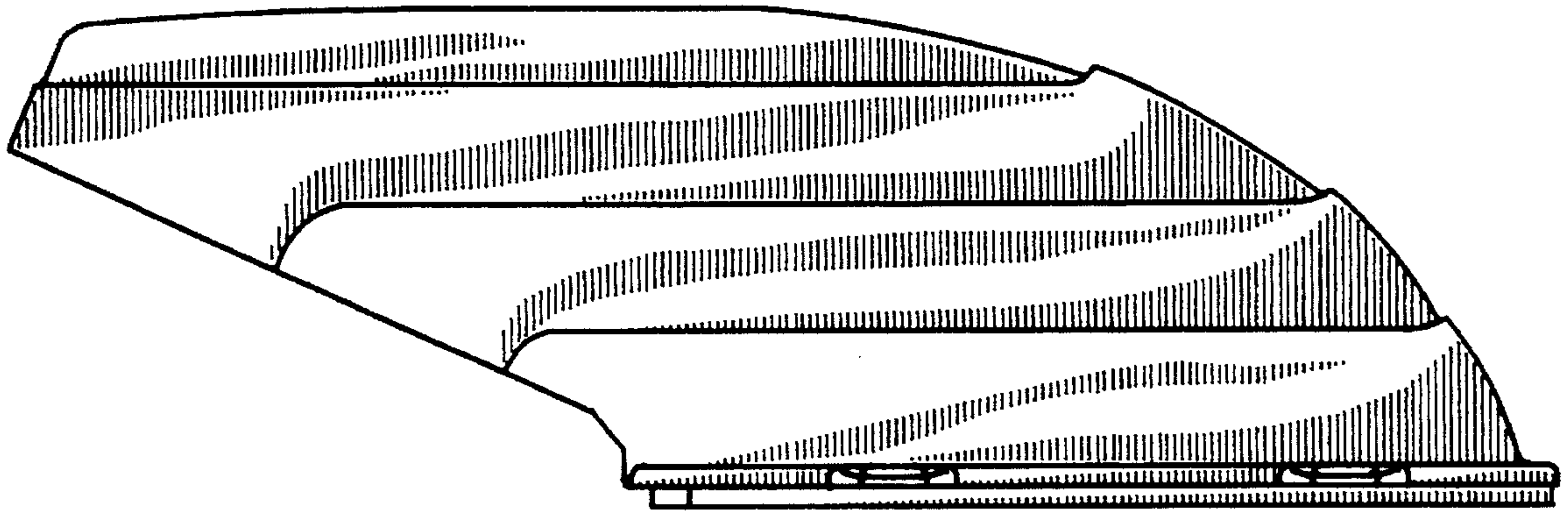

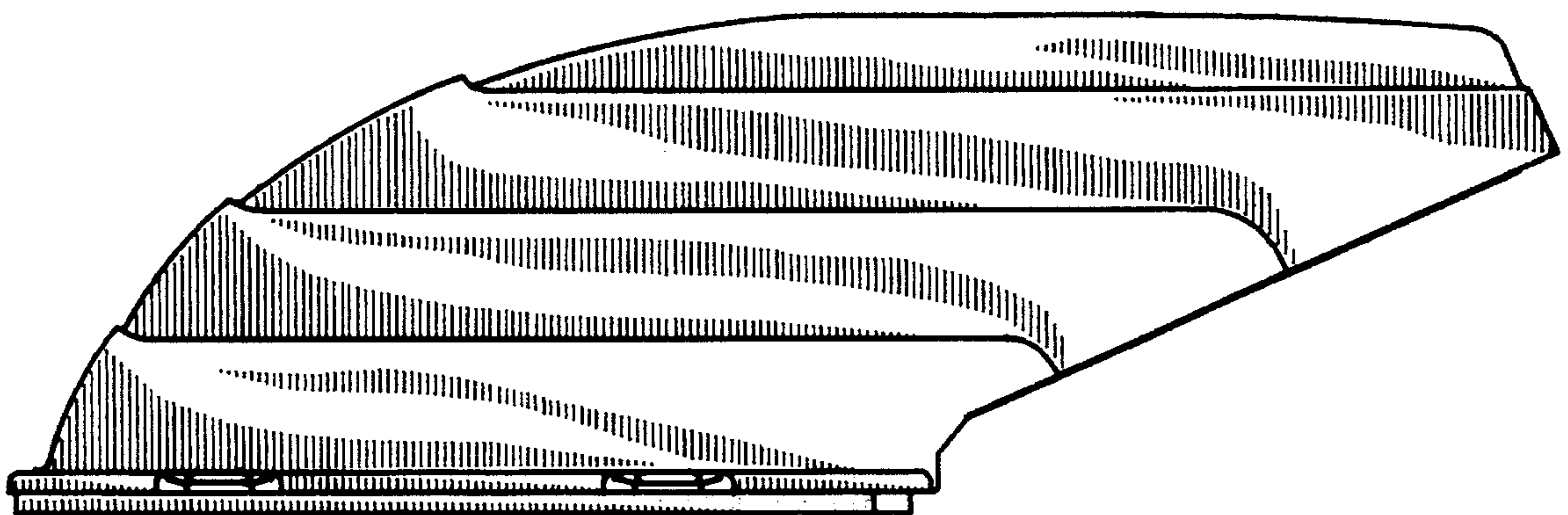

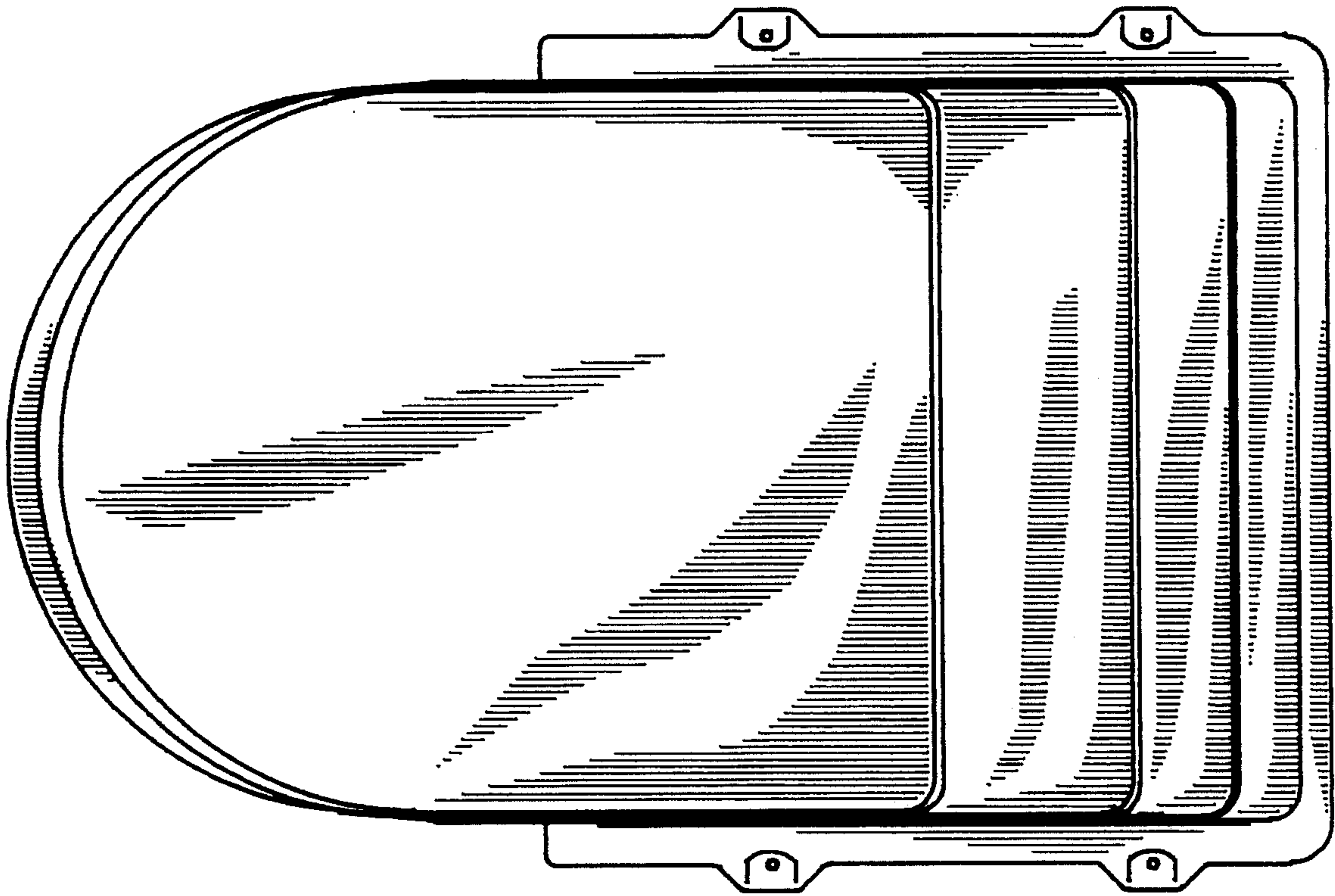

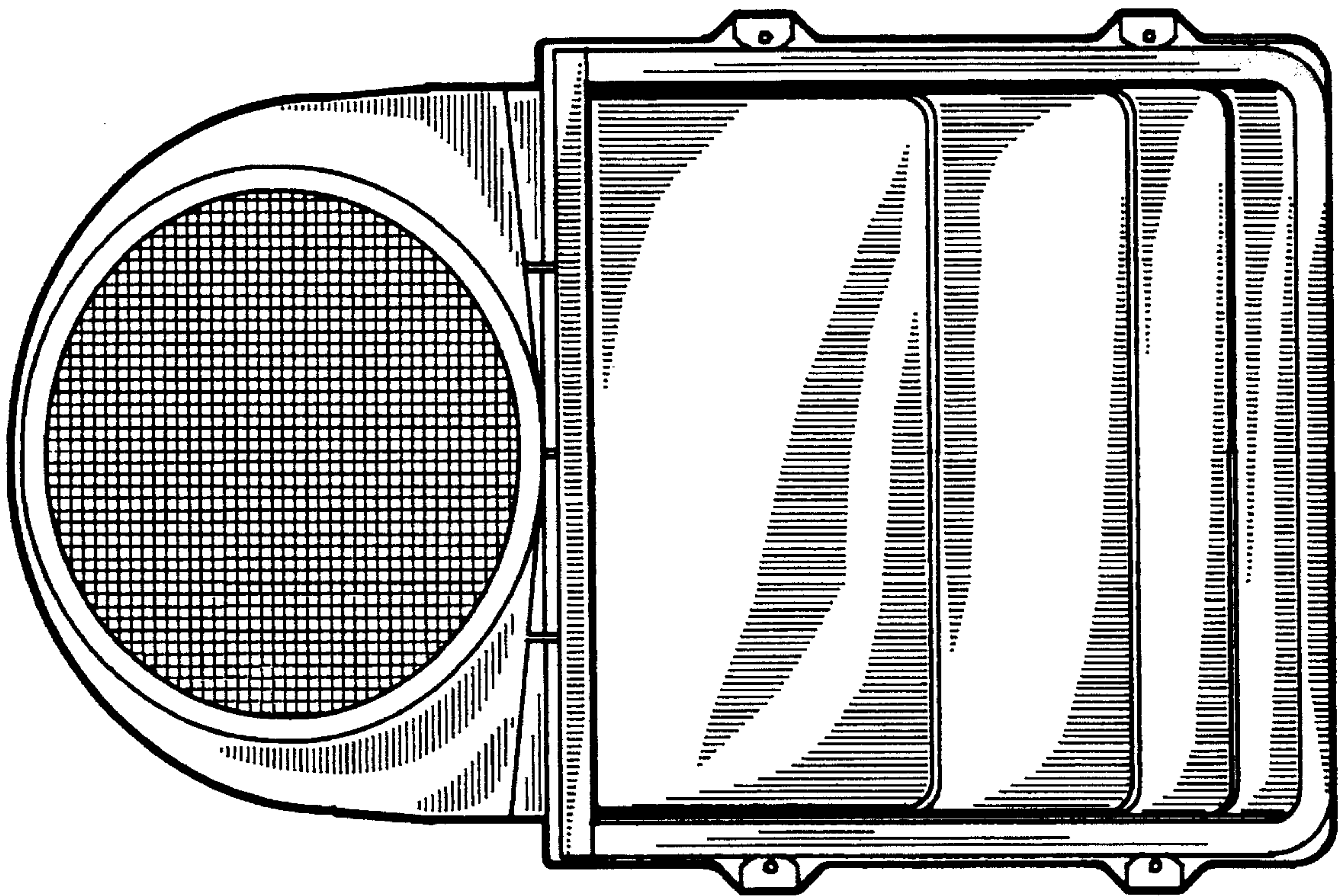
