[57] **CLAIM**

The ornamental design for a jewelry chain, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a jewelry chain showing my new design;
FIG. 2 is a side elevational view;
FIG. 3 is a perspective view of a single link that comprises the chain, the jewelry chain being omitted for ease of illustration;

FIG. 4 is a perspective view of an alternate link to that shown in FIG. 1, the chain being omitted for ease of illustration;

FIG. 5 is an end elevational view of FIG. 1;

FIG. 6 is a front elevational view of a jewelry chain showing a second embodiment of my new design;

FIG. 7 is a side elevational view of FIG. 6;

FIG. 8 is a perspective view of a single link that comprises the chain of FIG. 6, the jewelry chain being omitted for ease of illustration;

FIG. 9 is a perspective view of an alternate link to that shown in FIG. 6, the chain being omitted for ease of illustration;

FIG. 10 is an end elevational view of FIG. 6;

FIG. 11 is a front elevational view of a jewelry chain showing a third embodiment of my new design;

FIG. 12 is a side elevational view of FIG. 11;

FIG. 13 is a perspective view of a single link that comprises the chain of FIG. 11, the jewelry chain being omitted for ease of illustration;

FIG. 14 is a perspective view of an alternate link to that shown in FIG. 11, the chain being omitted for ease of illustration;

FIG. 15 is an end elevational view of FIG. 11;

FIG. 16 is a front elevational view of a jewelry chain showing a fourth embodiment of my new design;

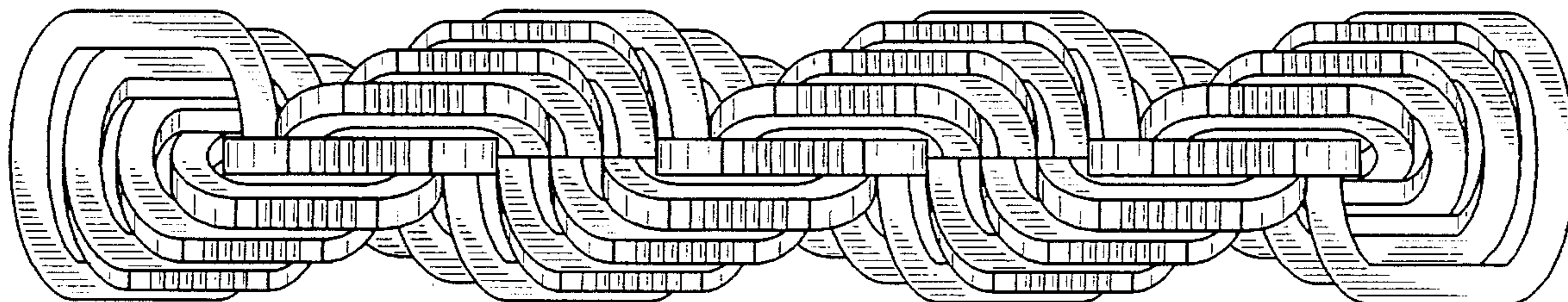
FIG. 17 is a side elevational view of FIG. 16;

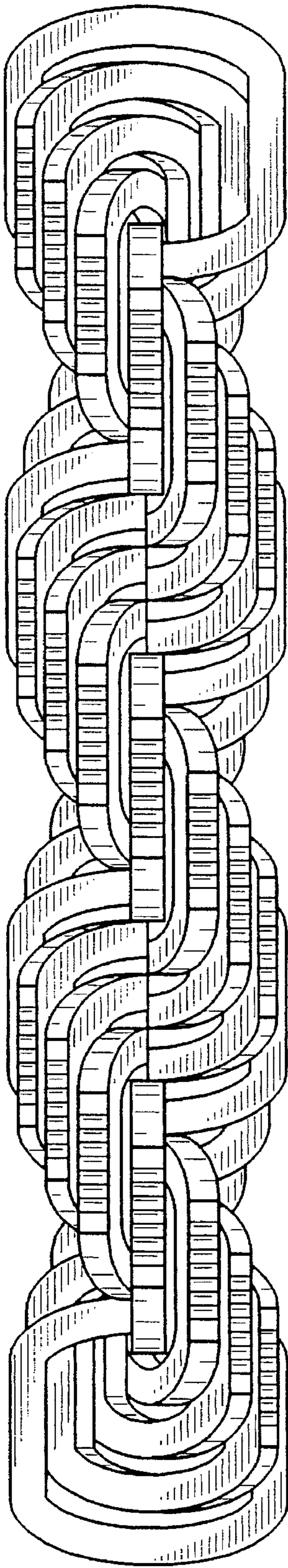

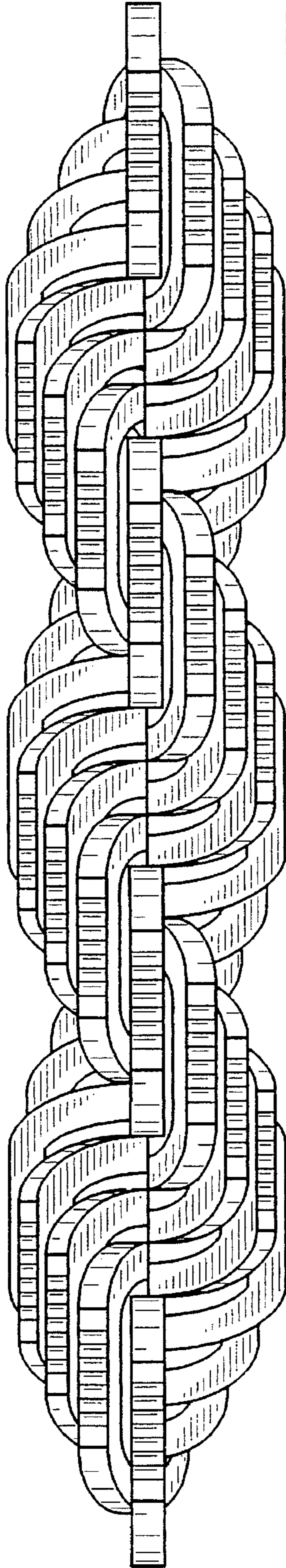

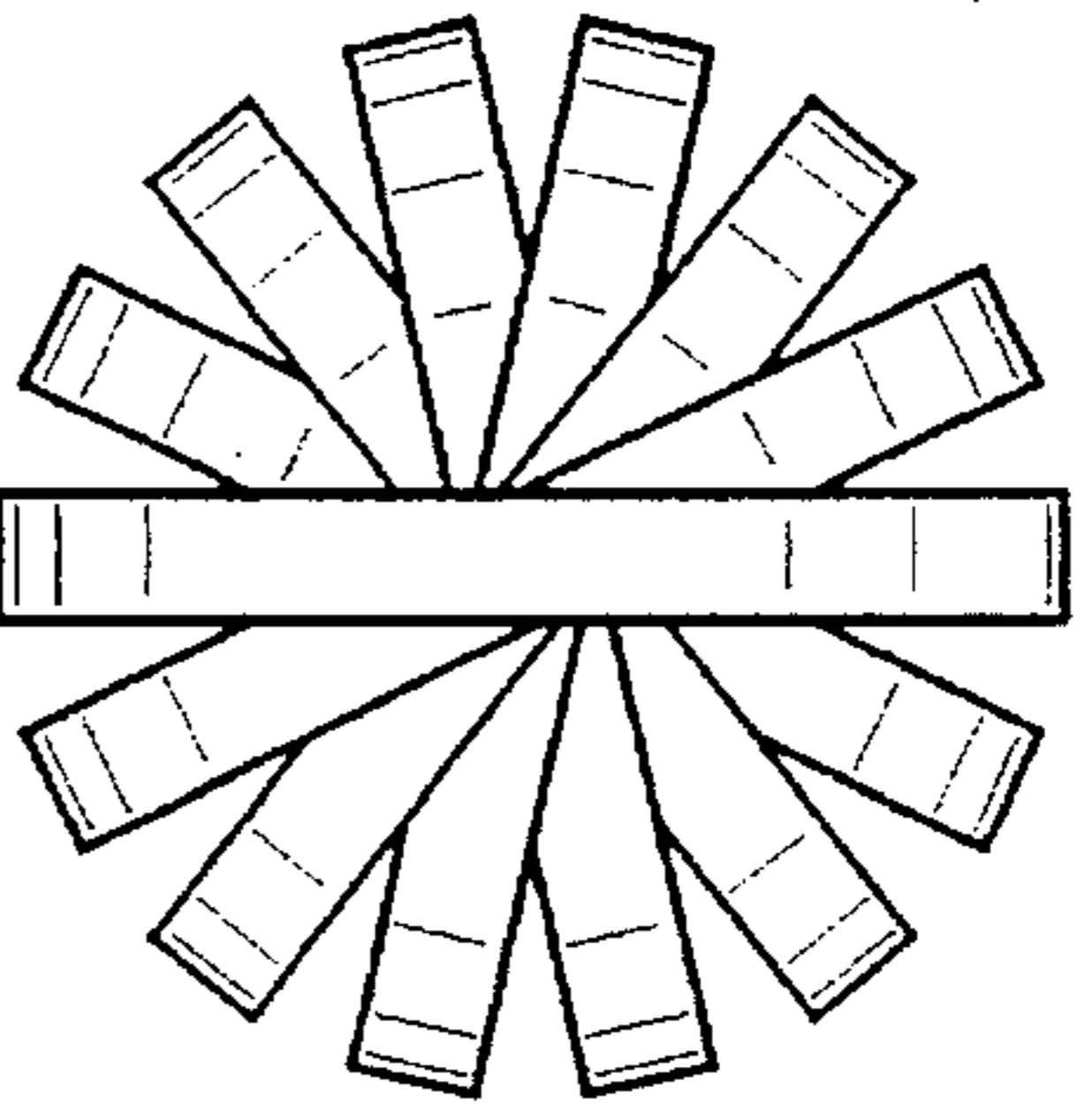

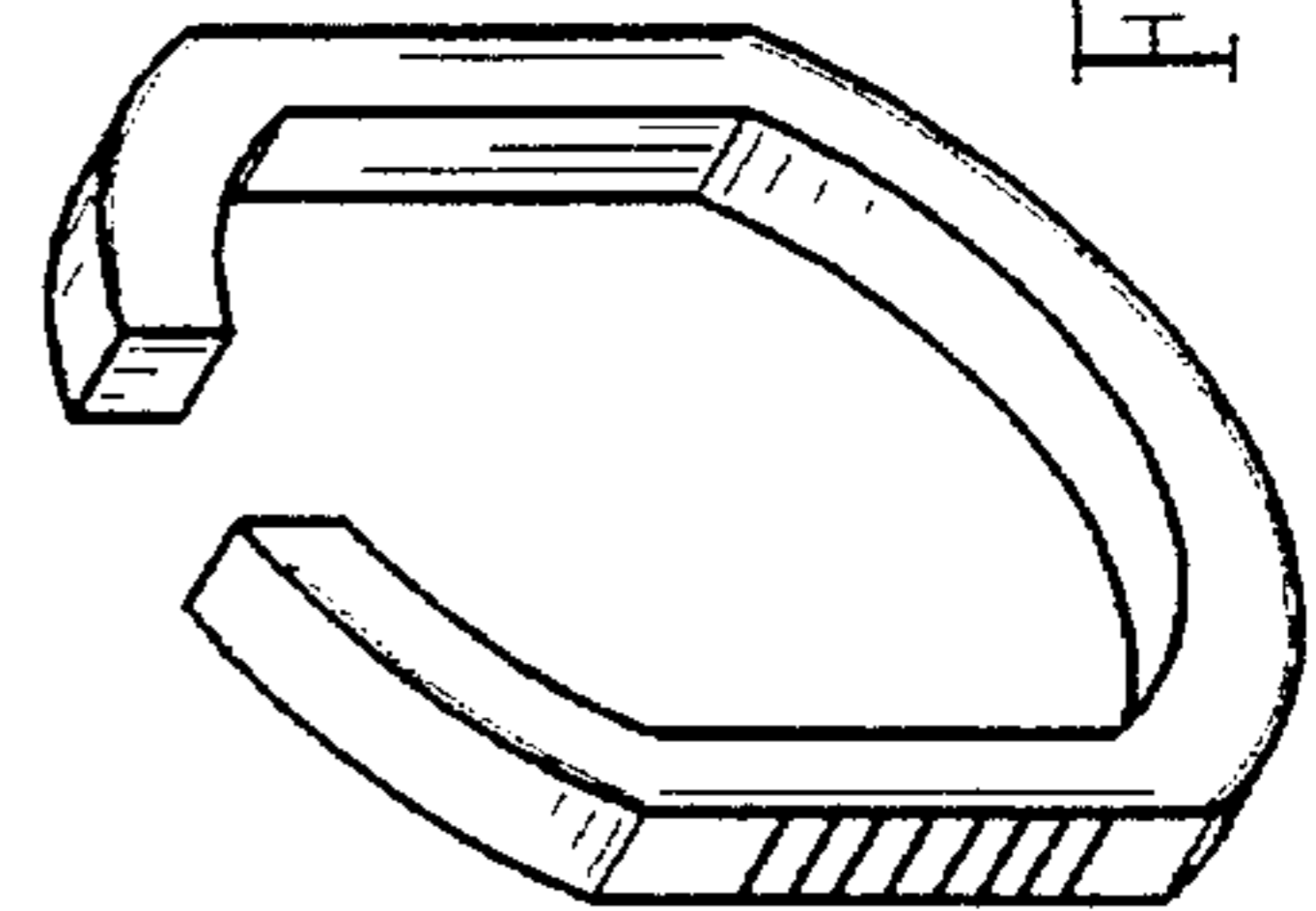

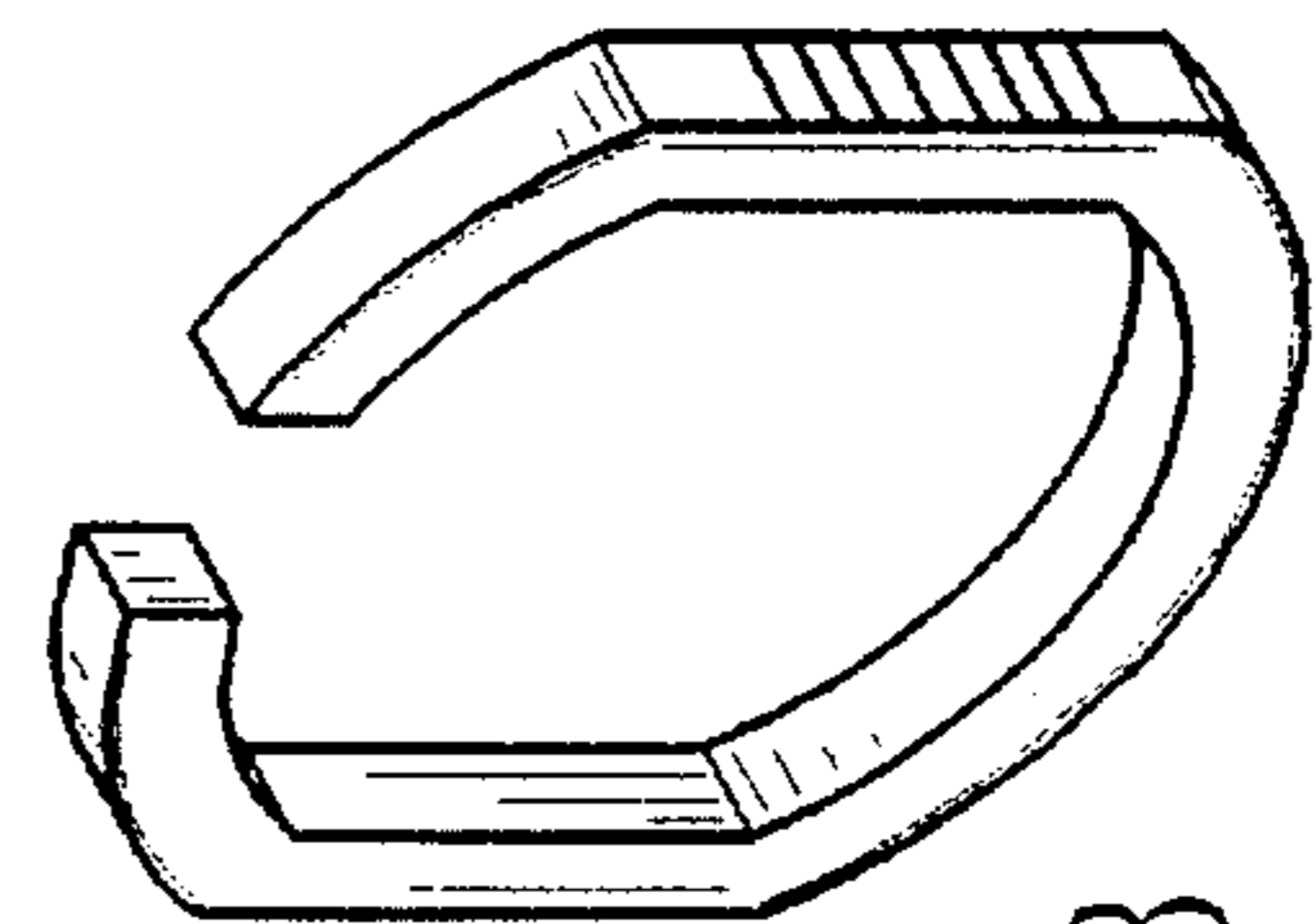

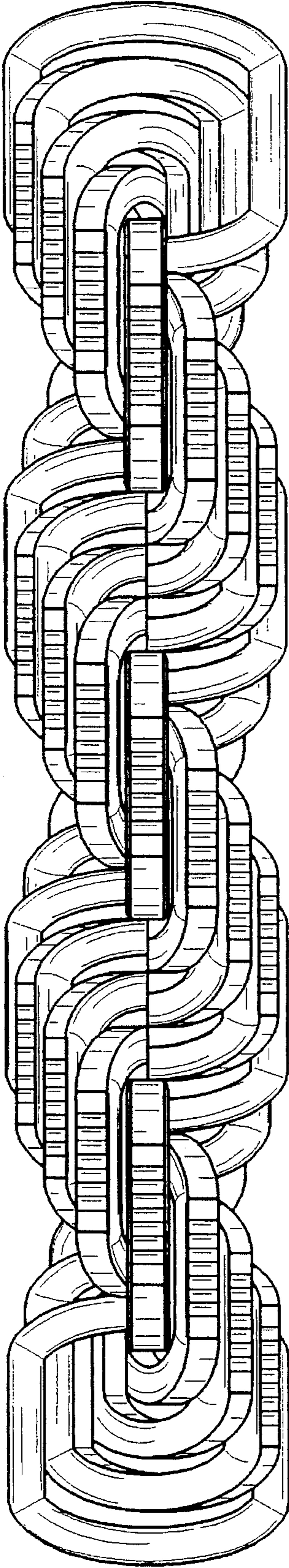

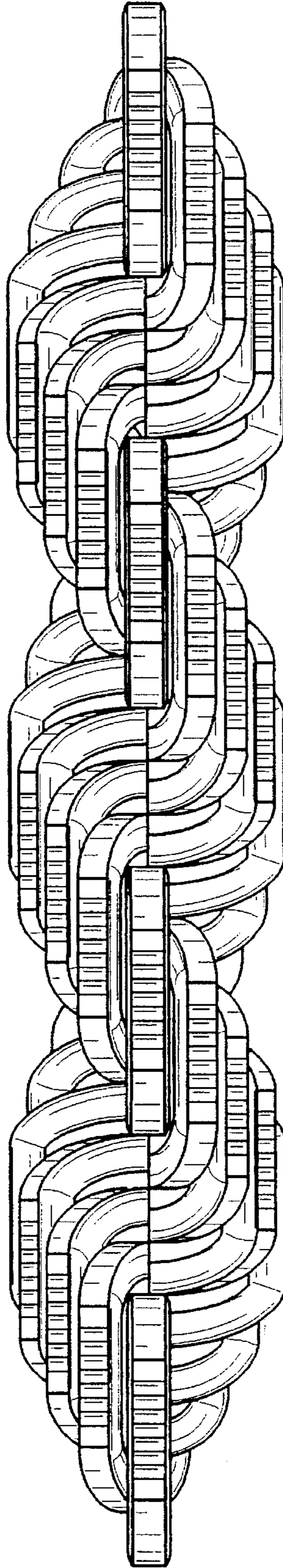

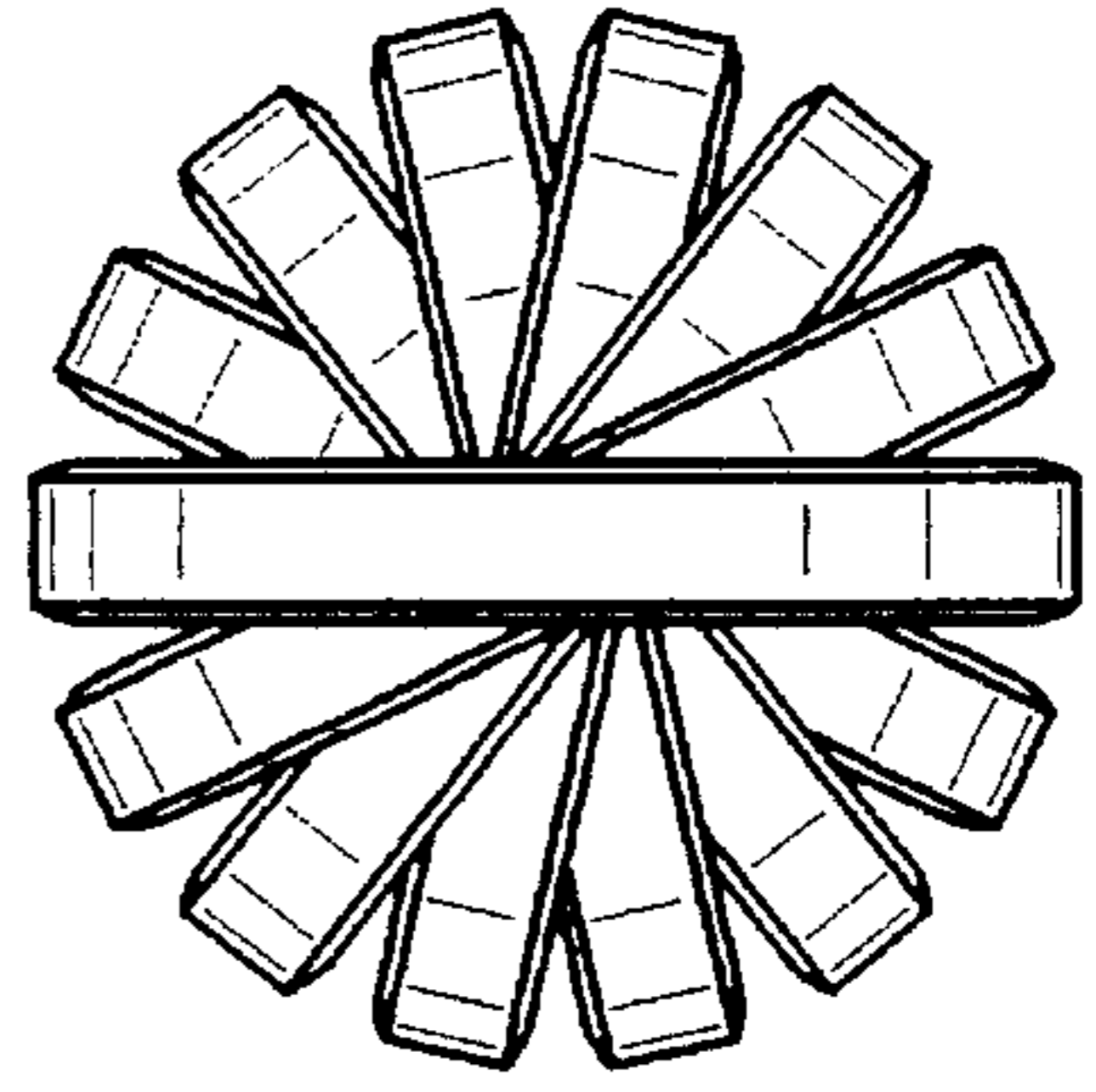

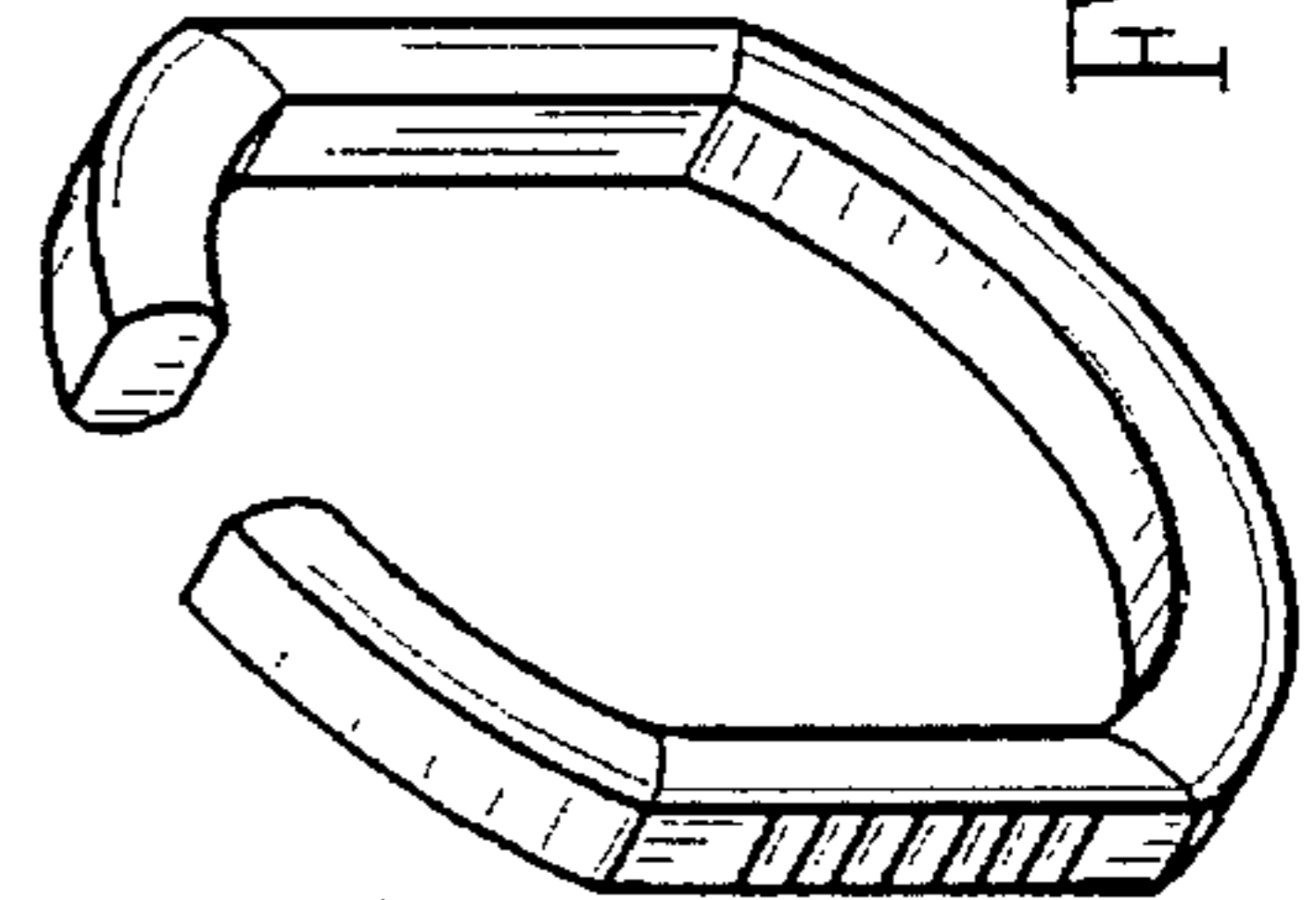

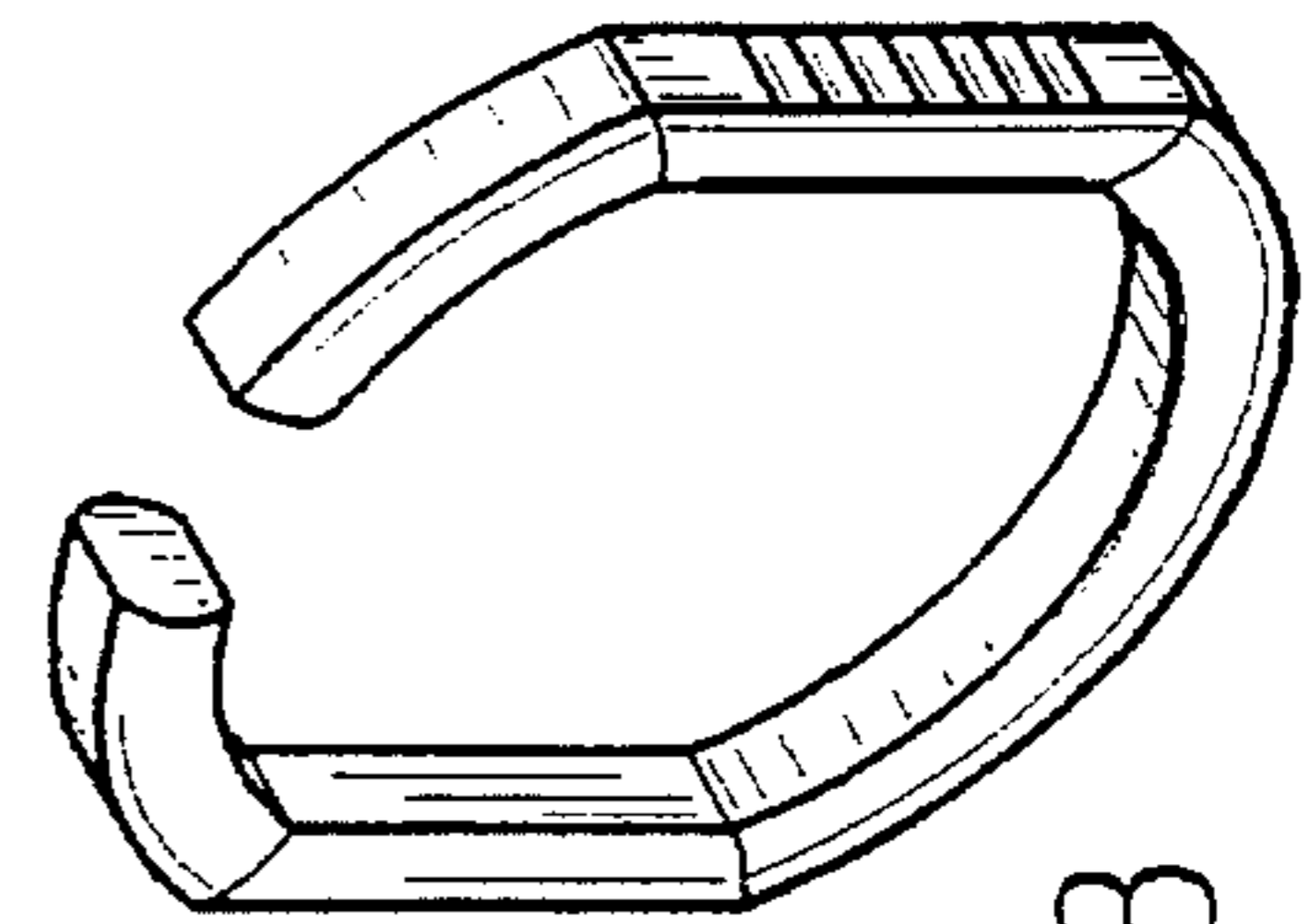

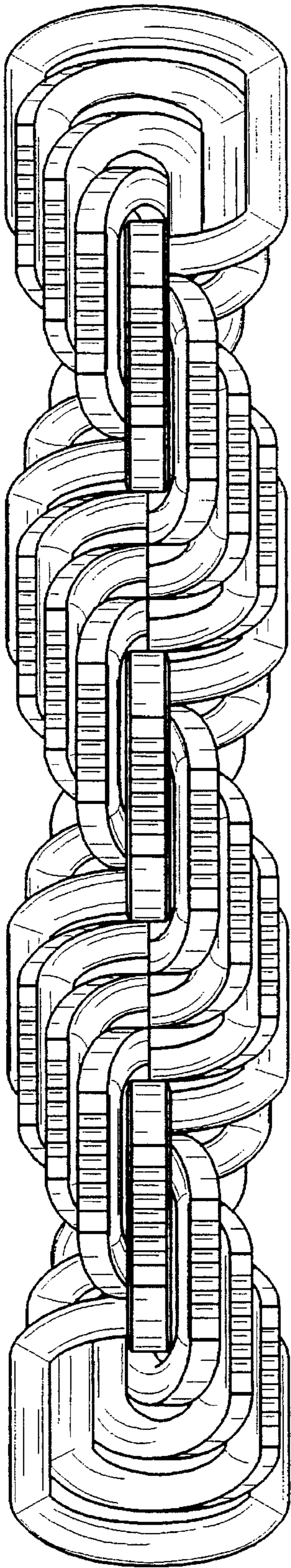

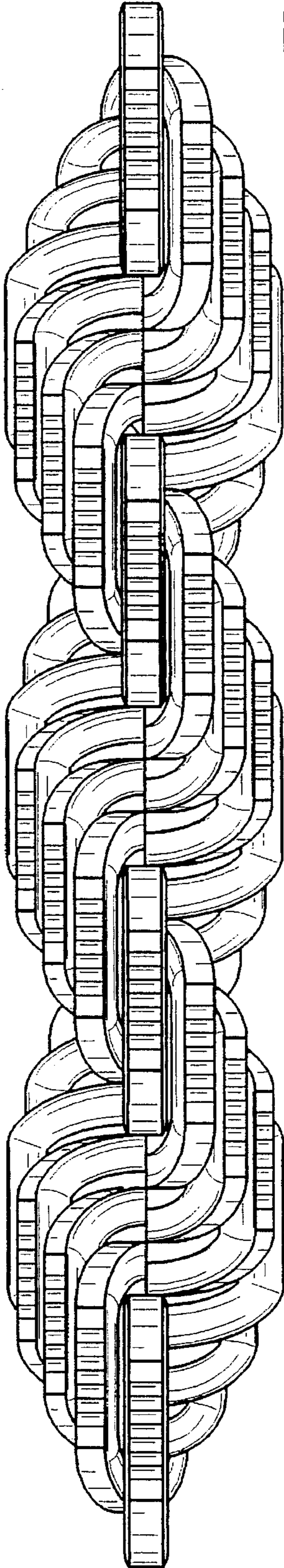

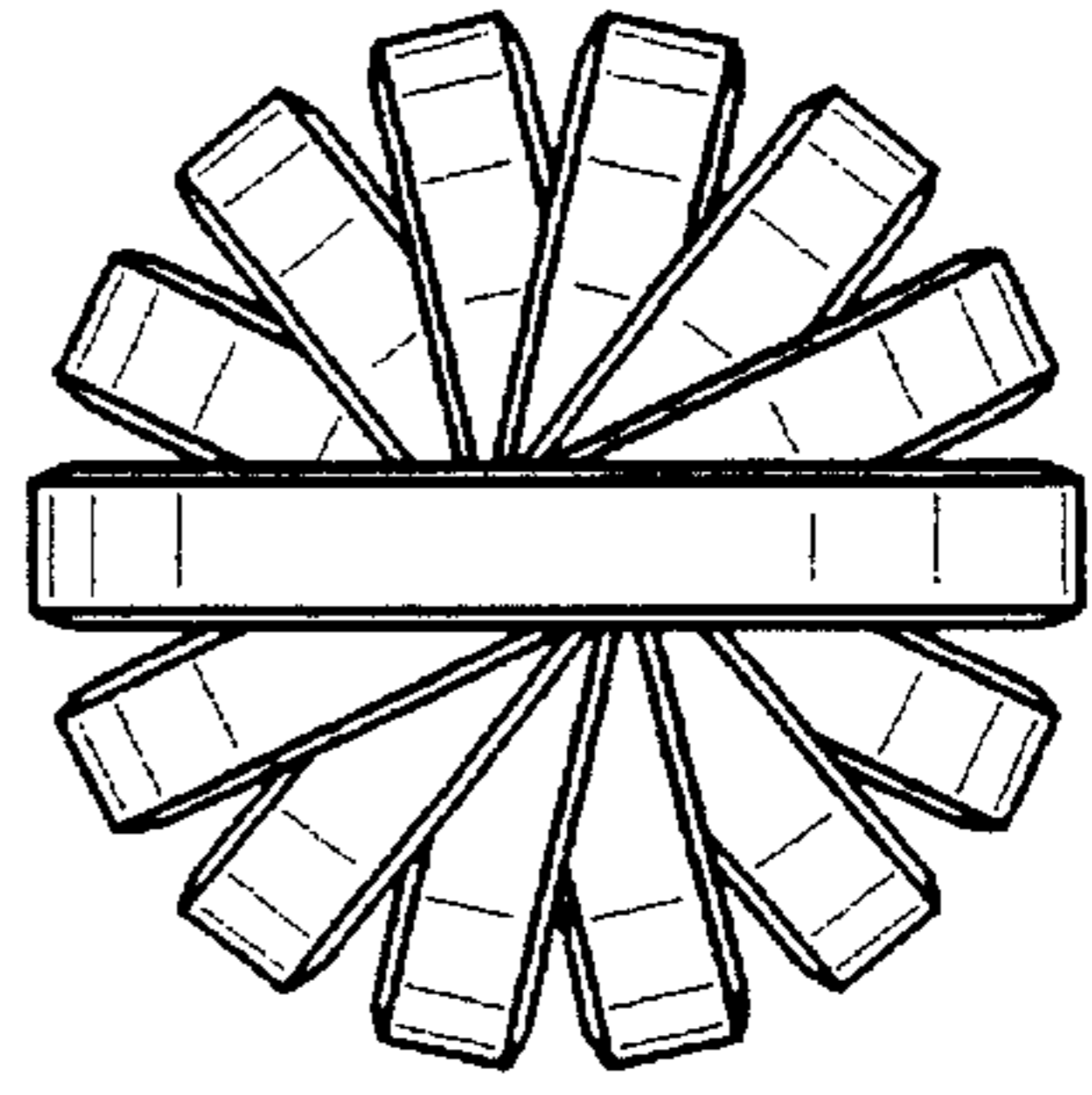

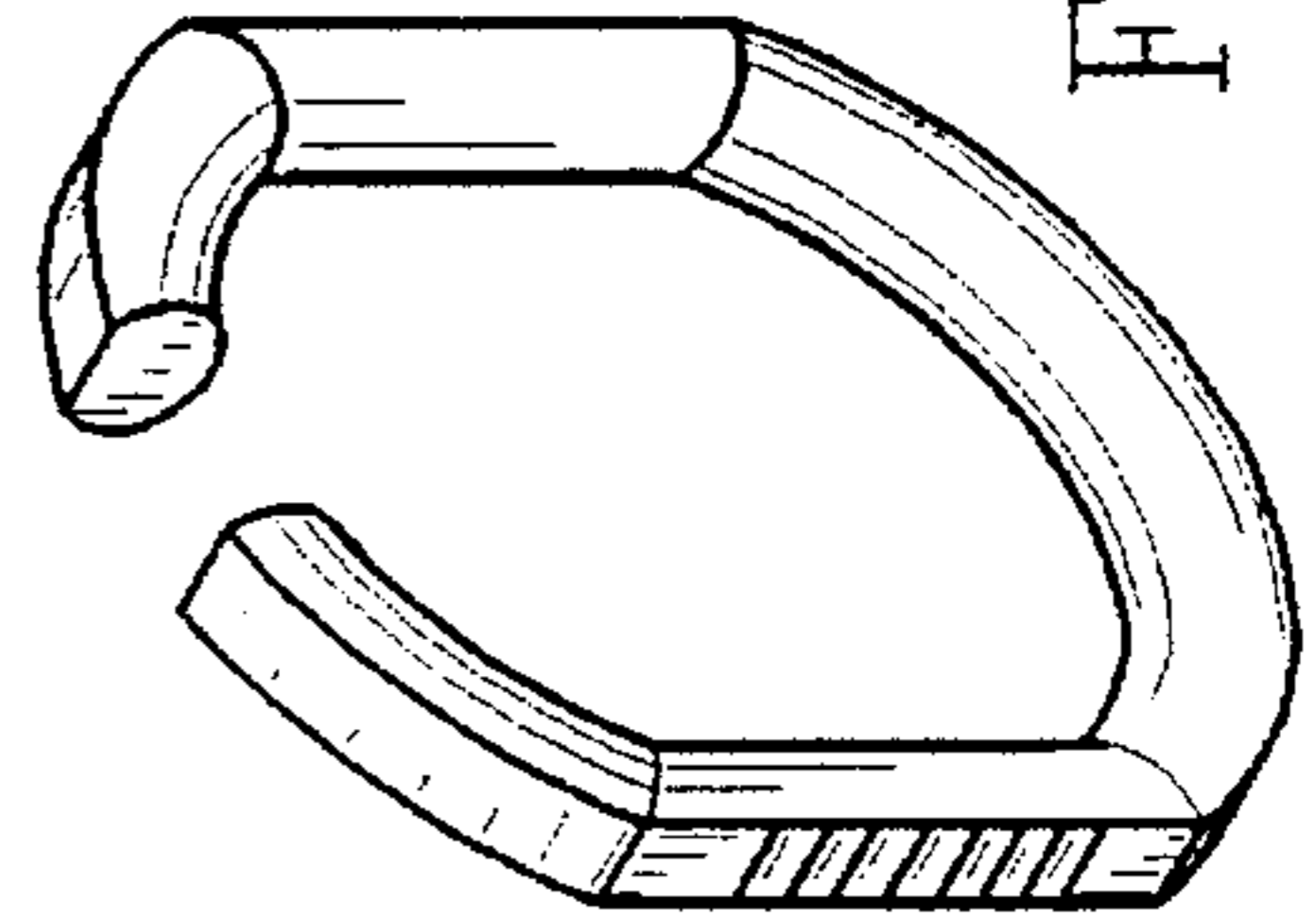

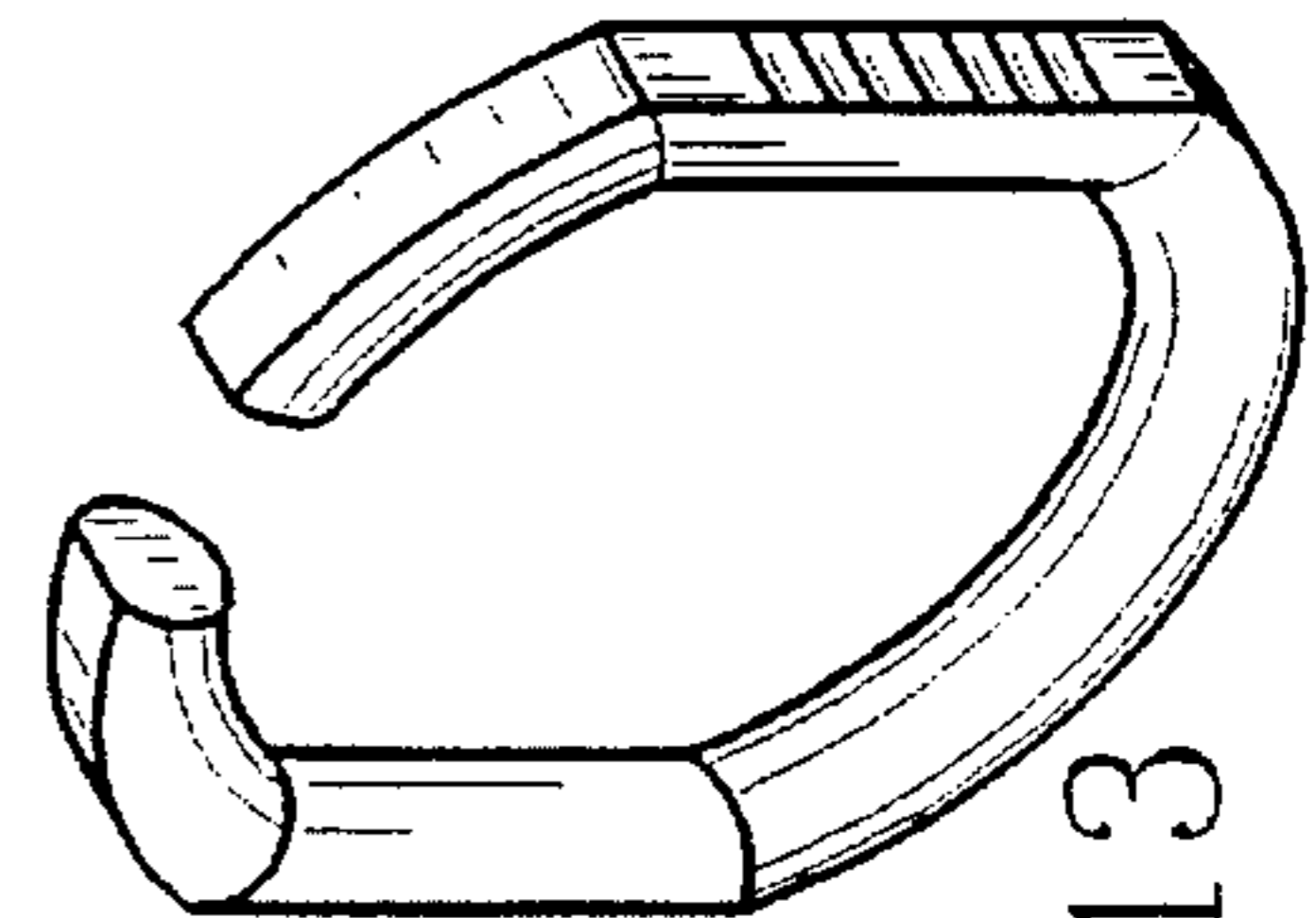

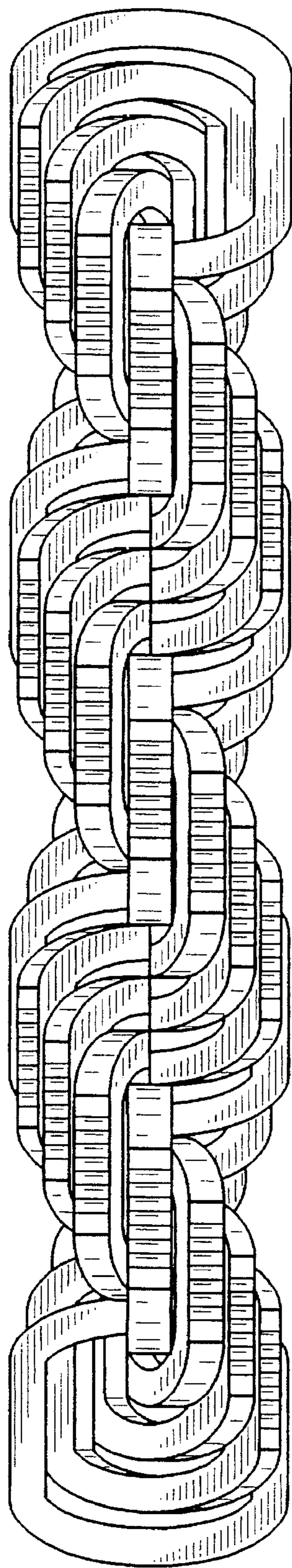

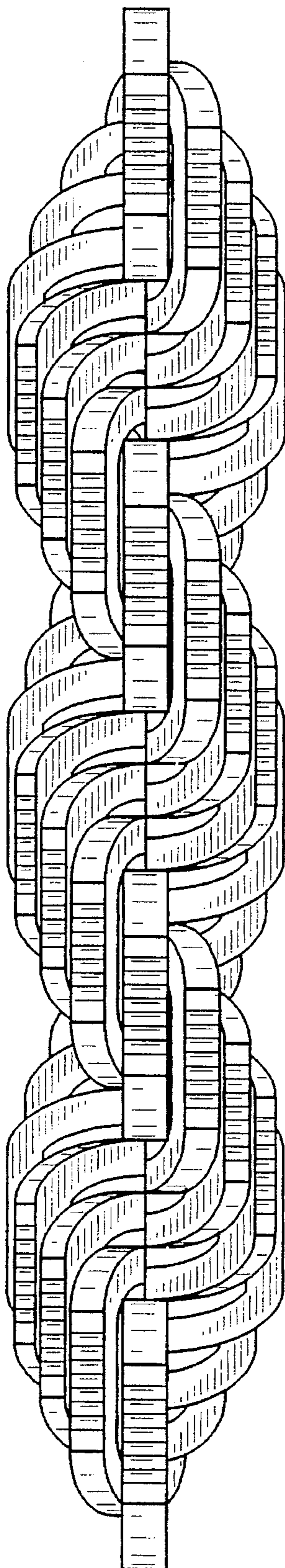

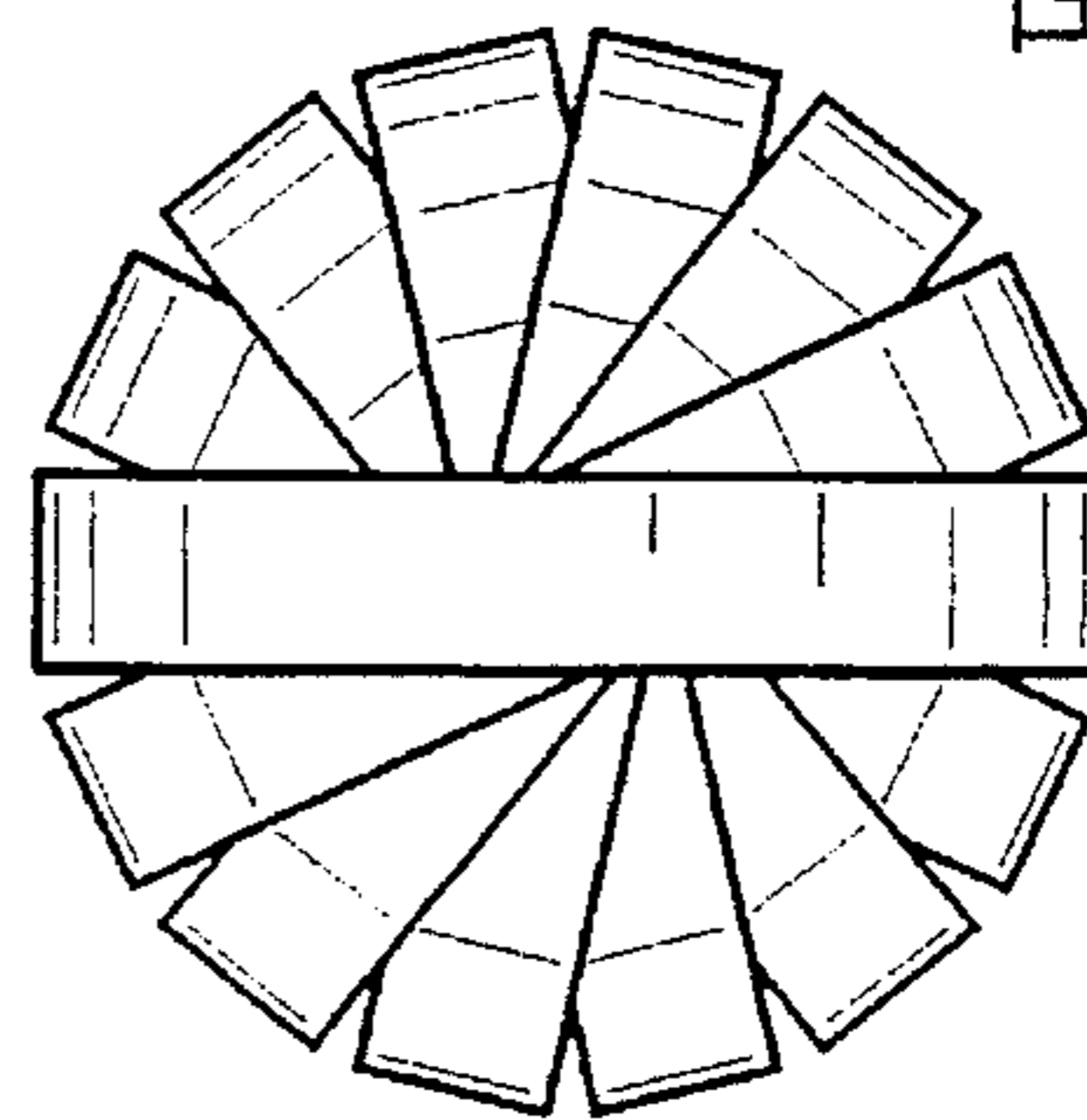

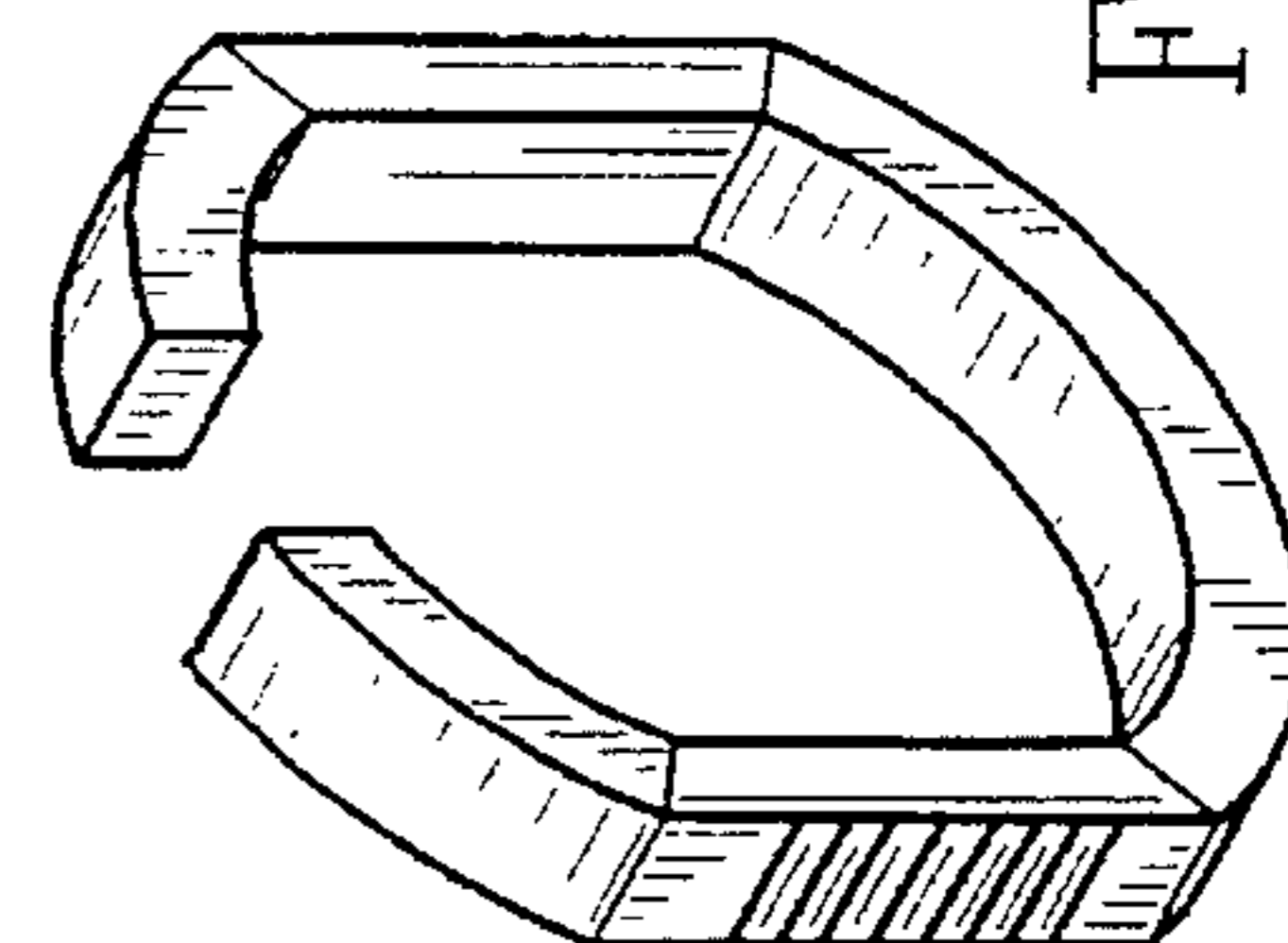

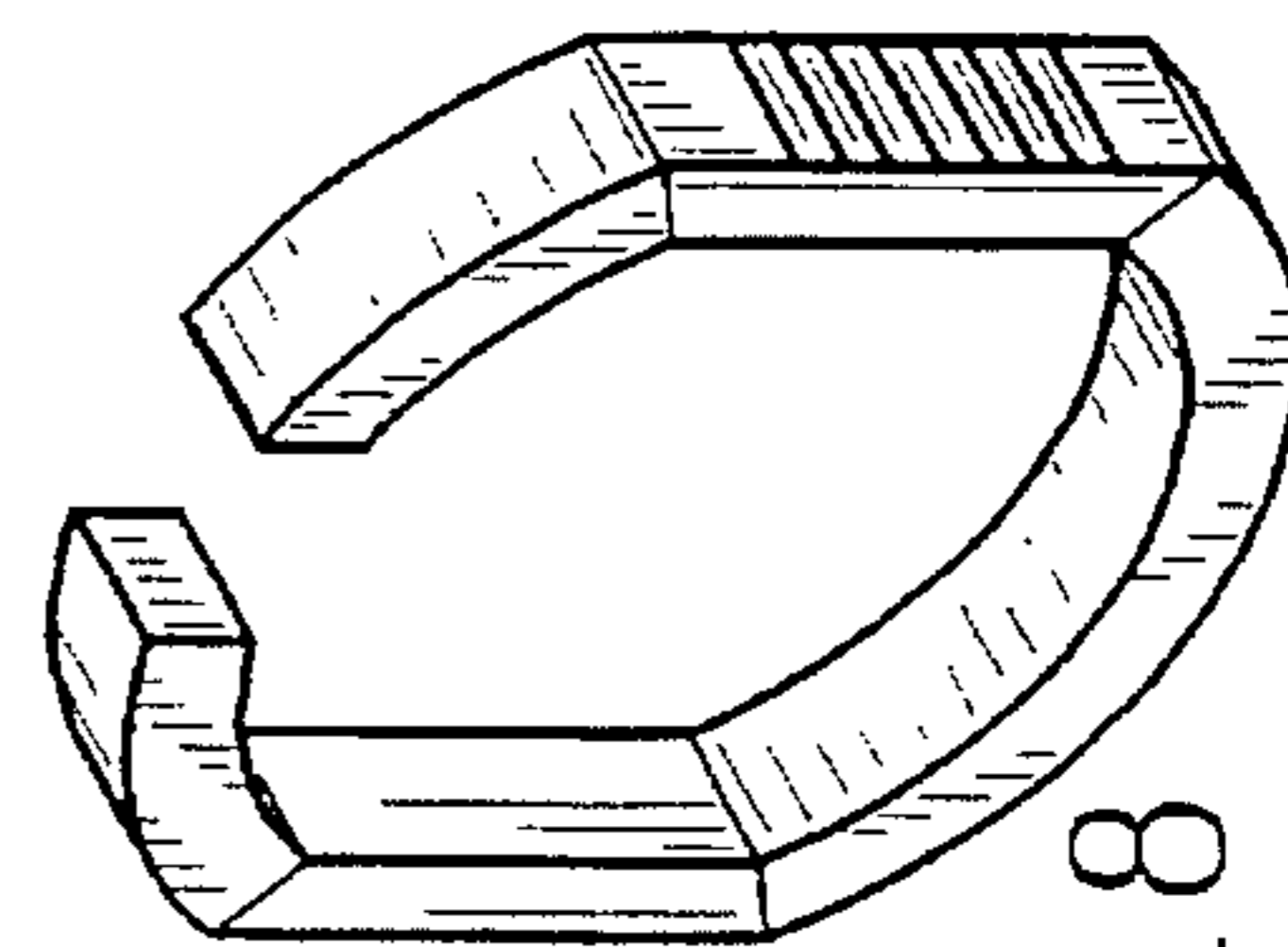
