FIG. 5 is a front side elevation view thereof showing our new design.

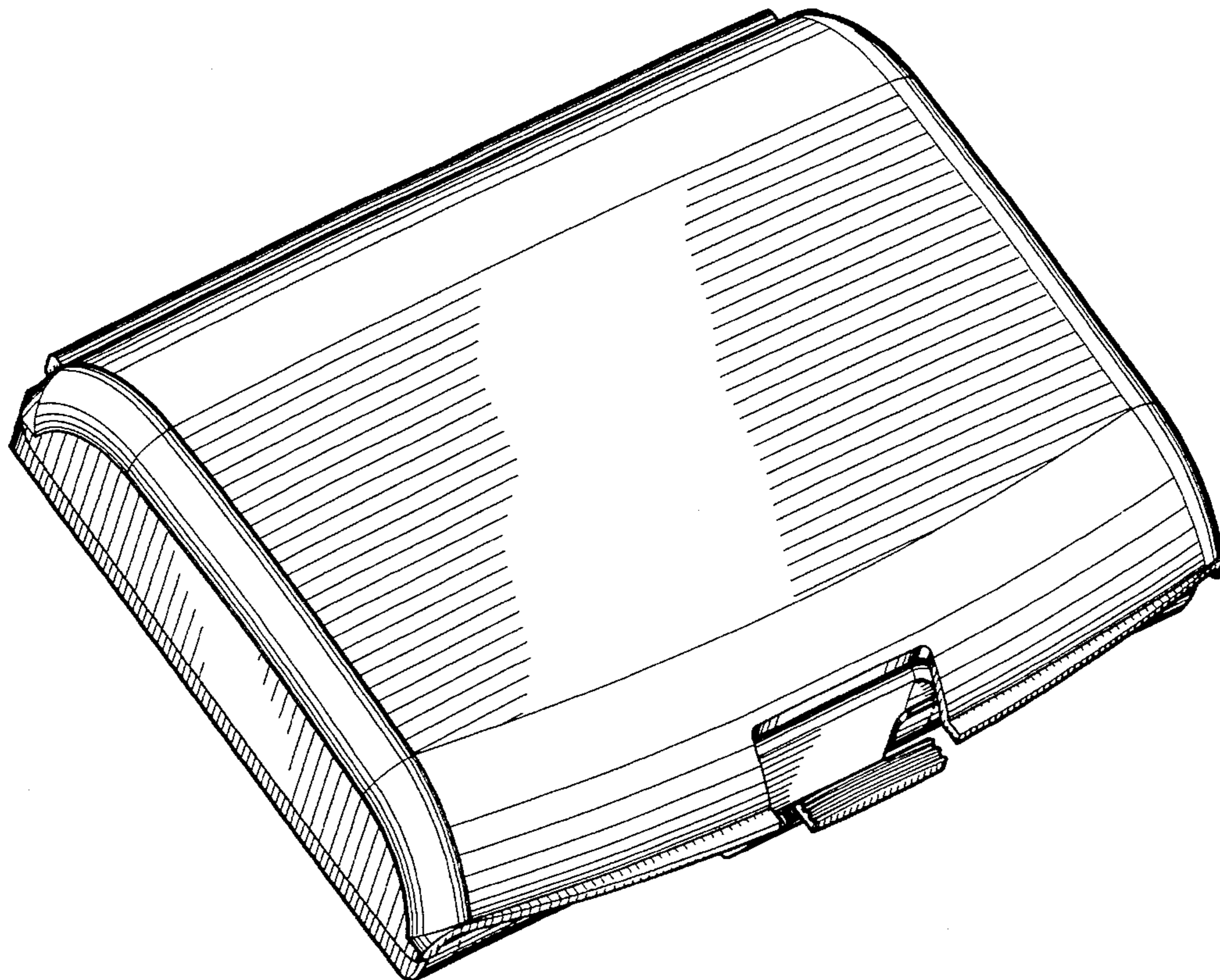

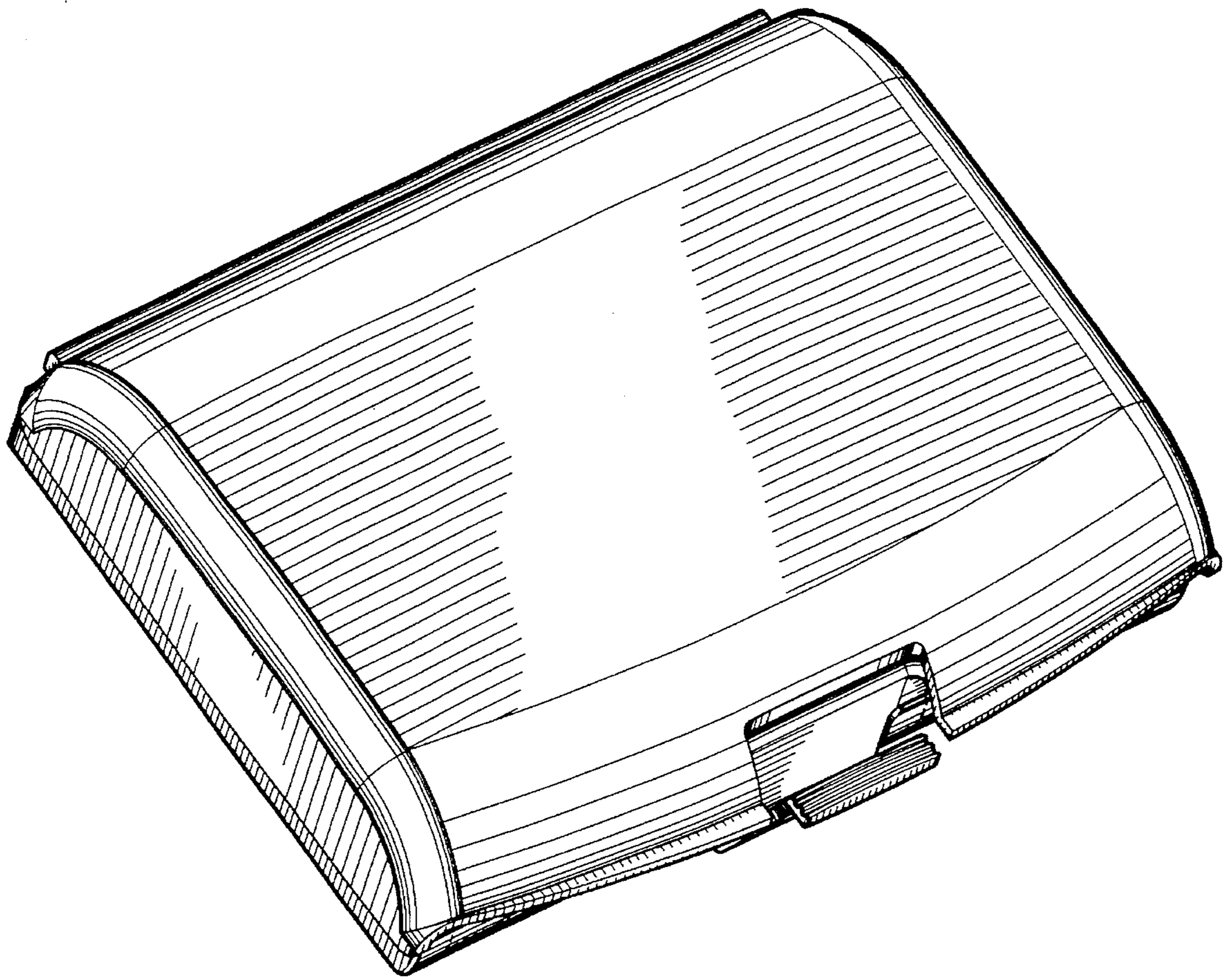

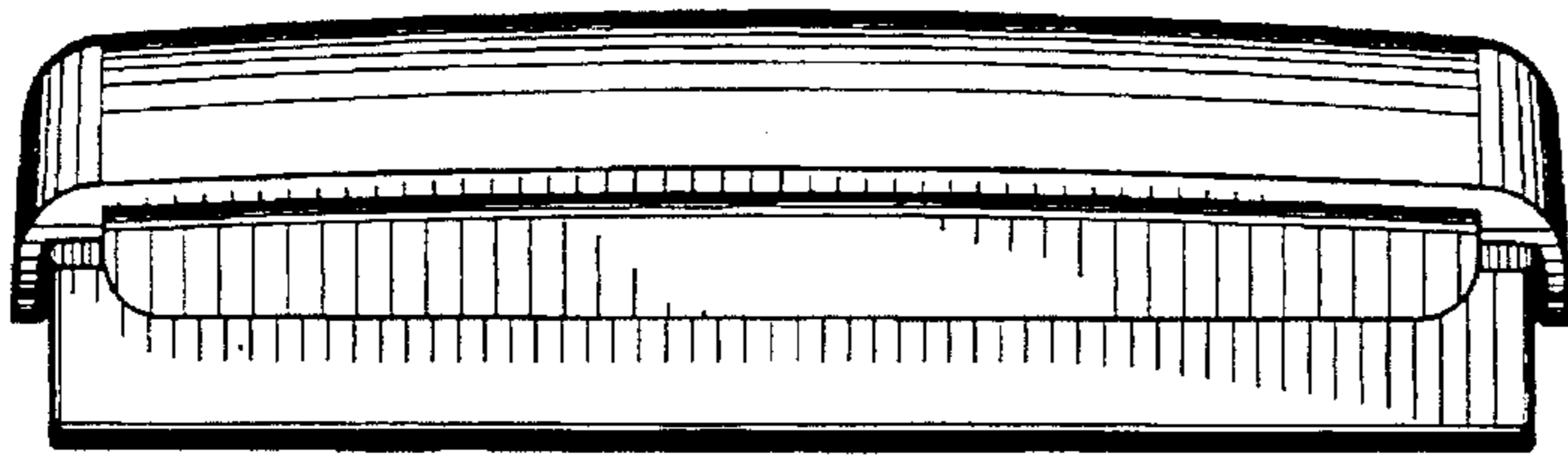

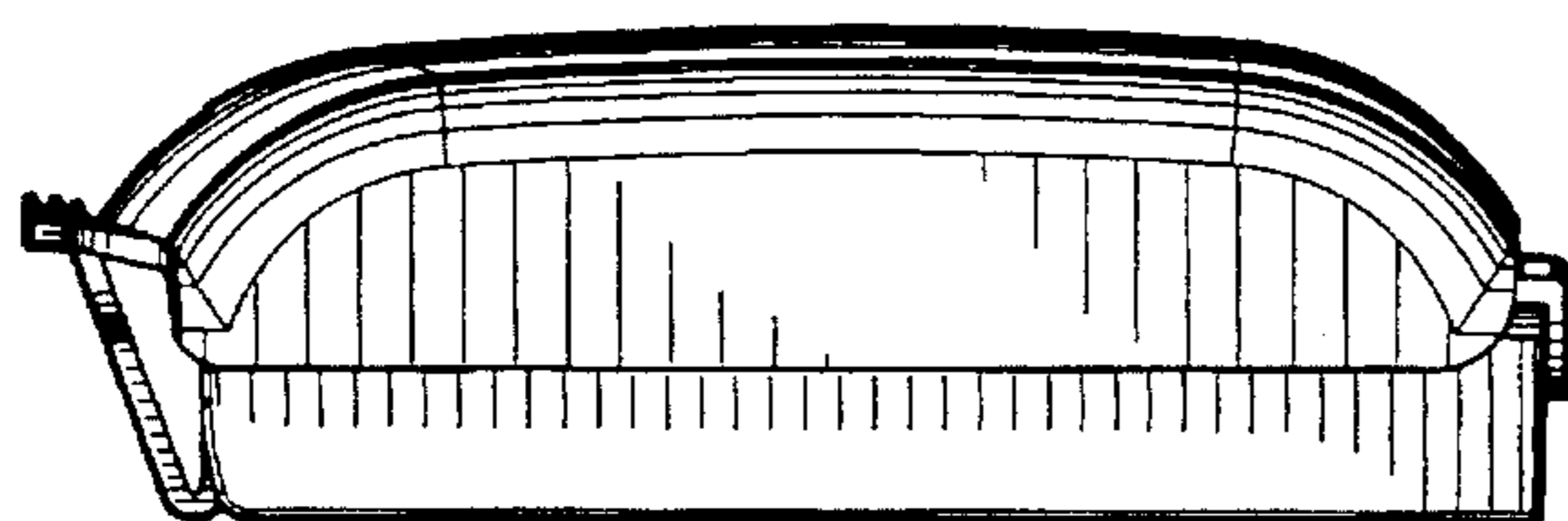
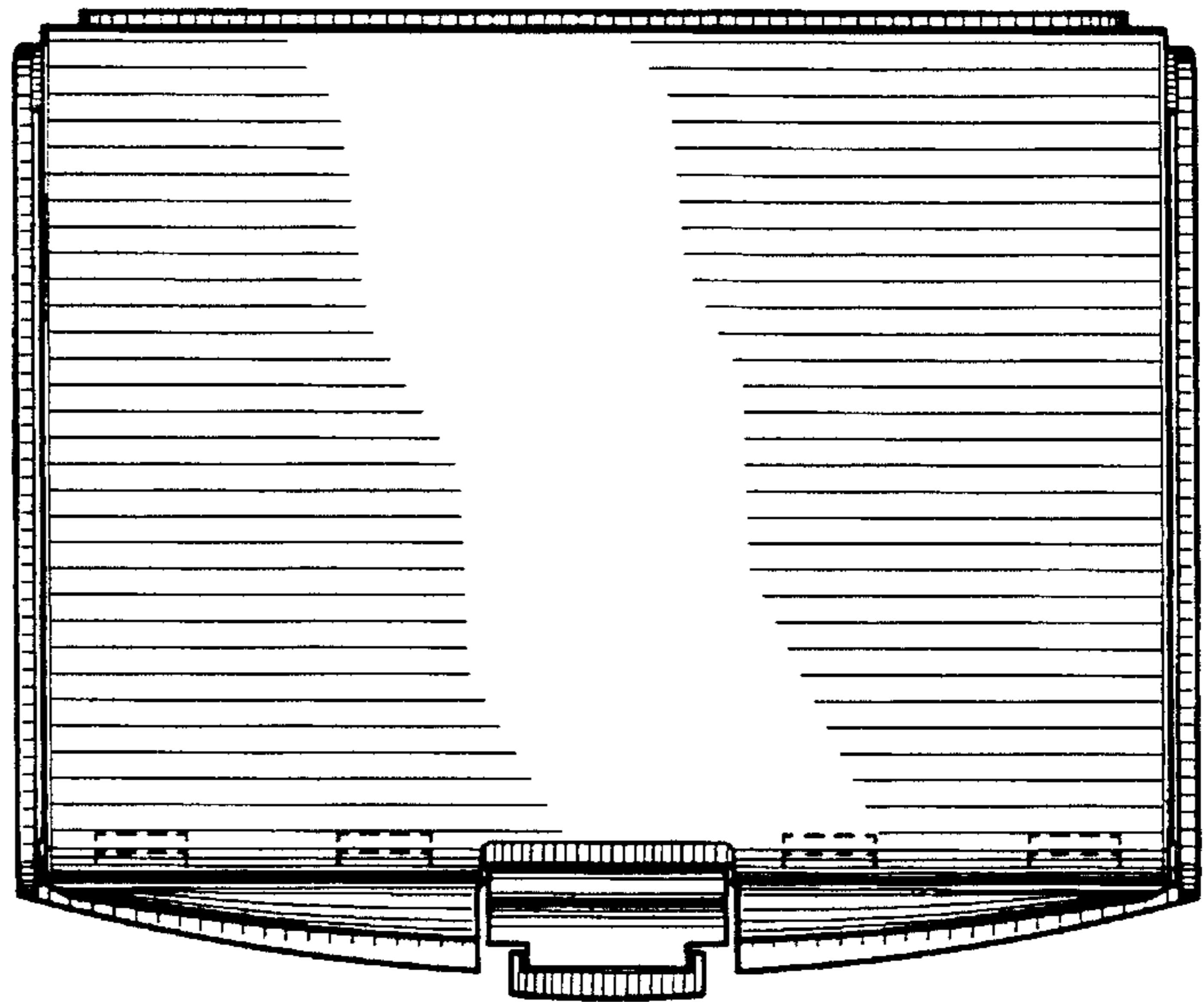
