[57] **CLAIM**

The ornamental design for a plastic stackable table with nesting removable tray, as shown.

**DESCRIPTION**

FIG. 1 is a right, front perspective view of a plastic stackable table with a nesting removable tray showing my new design; FIG. 2 is a right side elevational view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a right, front perspective exploded view thereof showing the tray removed; and, FIG. 7 is a right, front perspective view of my new design showing the plastic stackable table with the tray placed on the table in a position turned upside down from the nested position depicted in FIGS. 1-6.

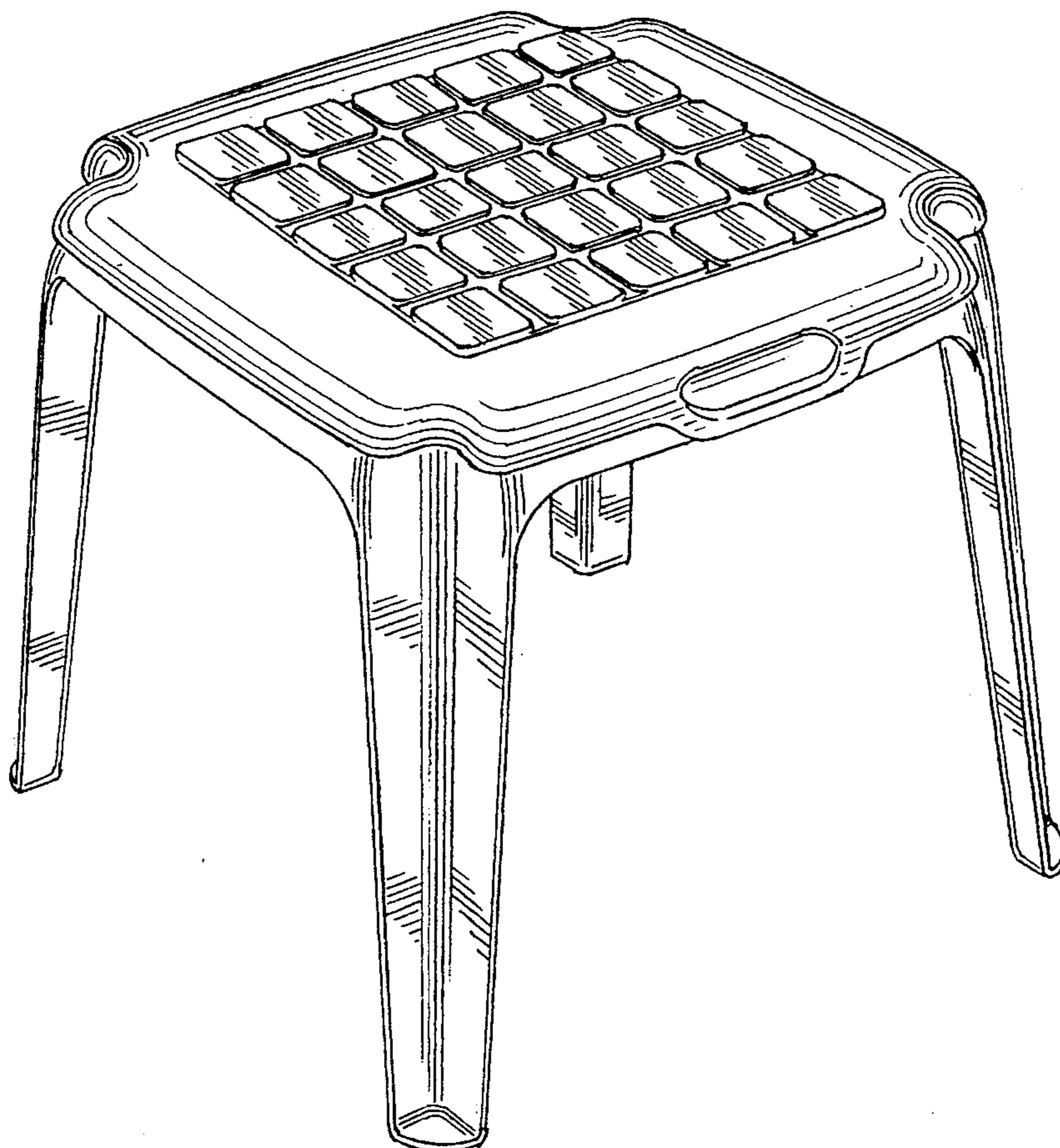

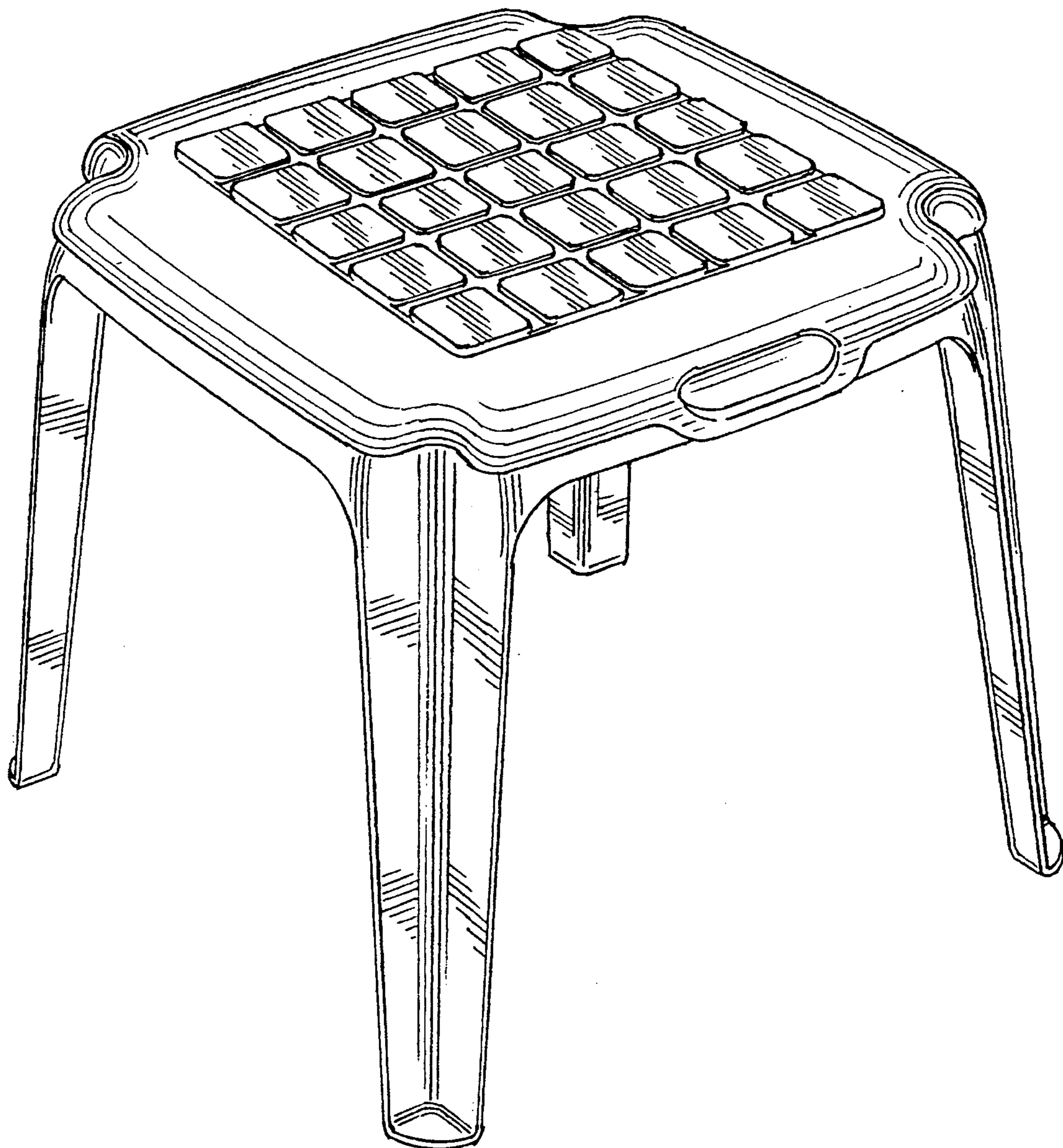

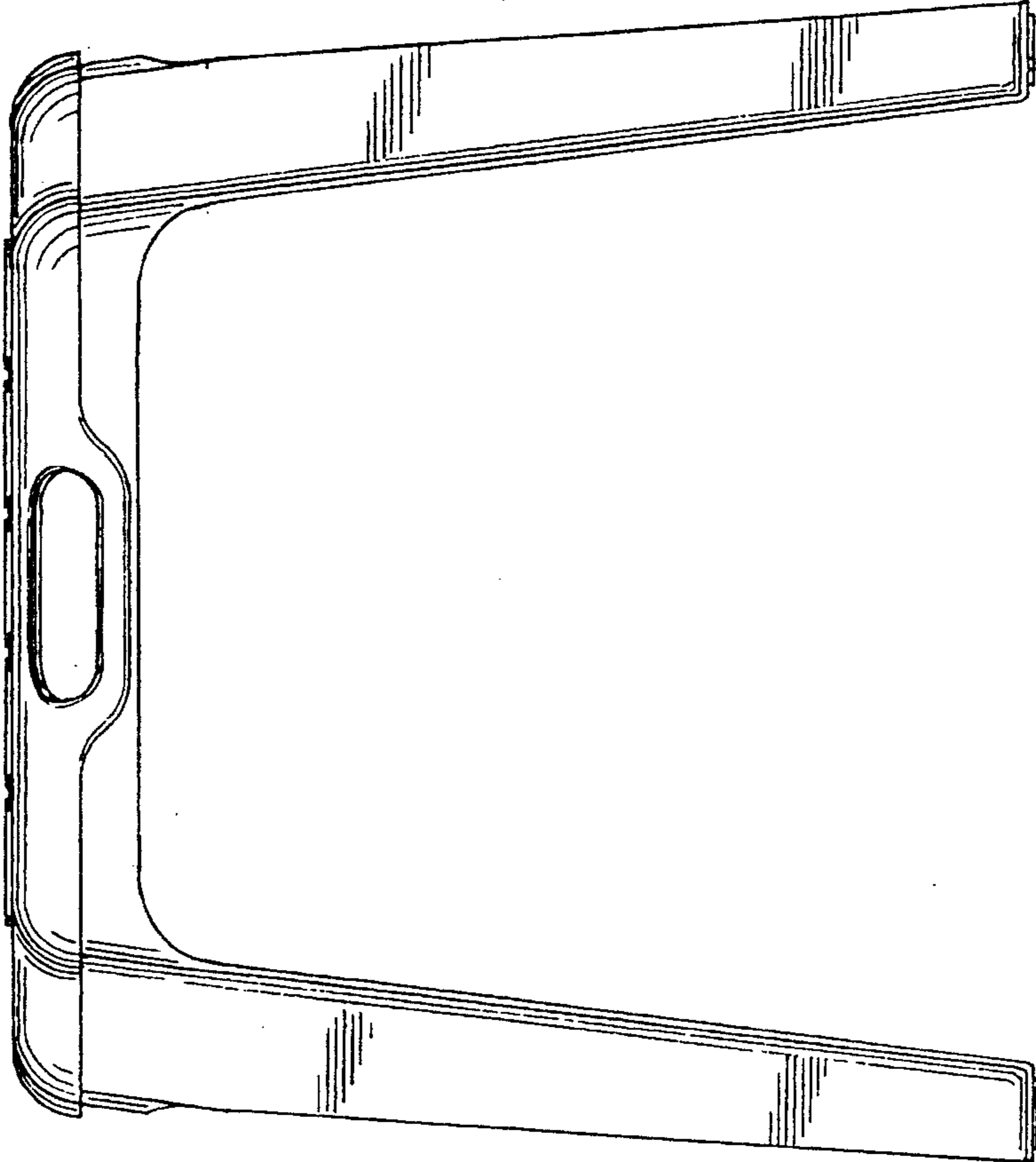
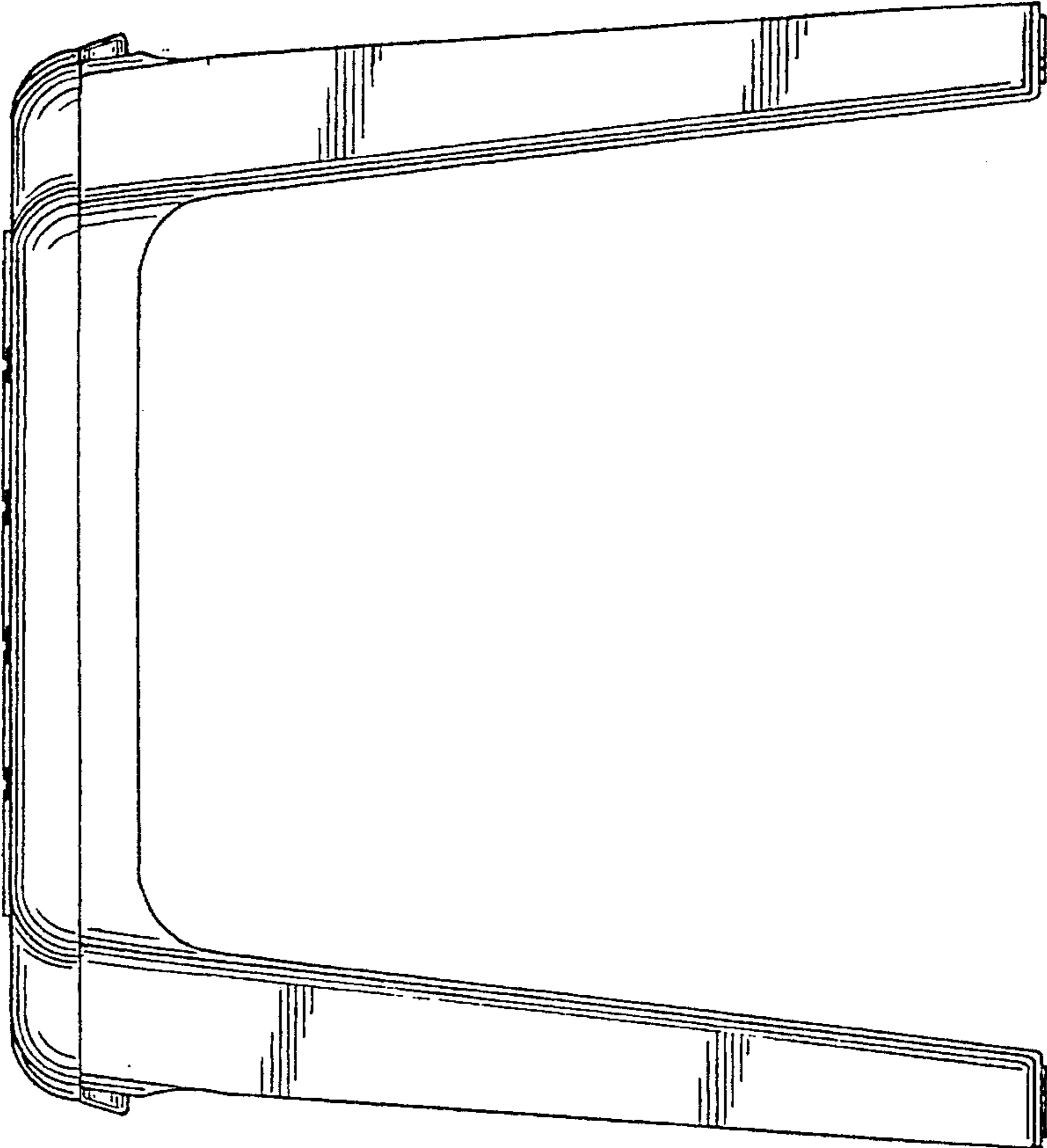

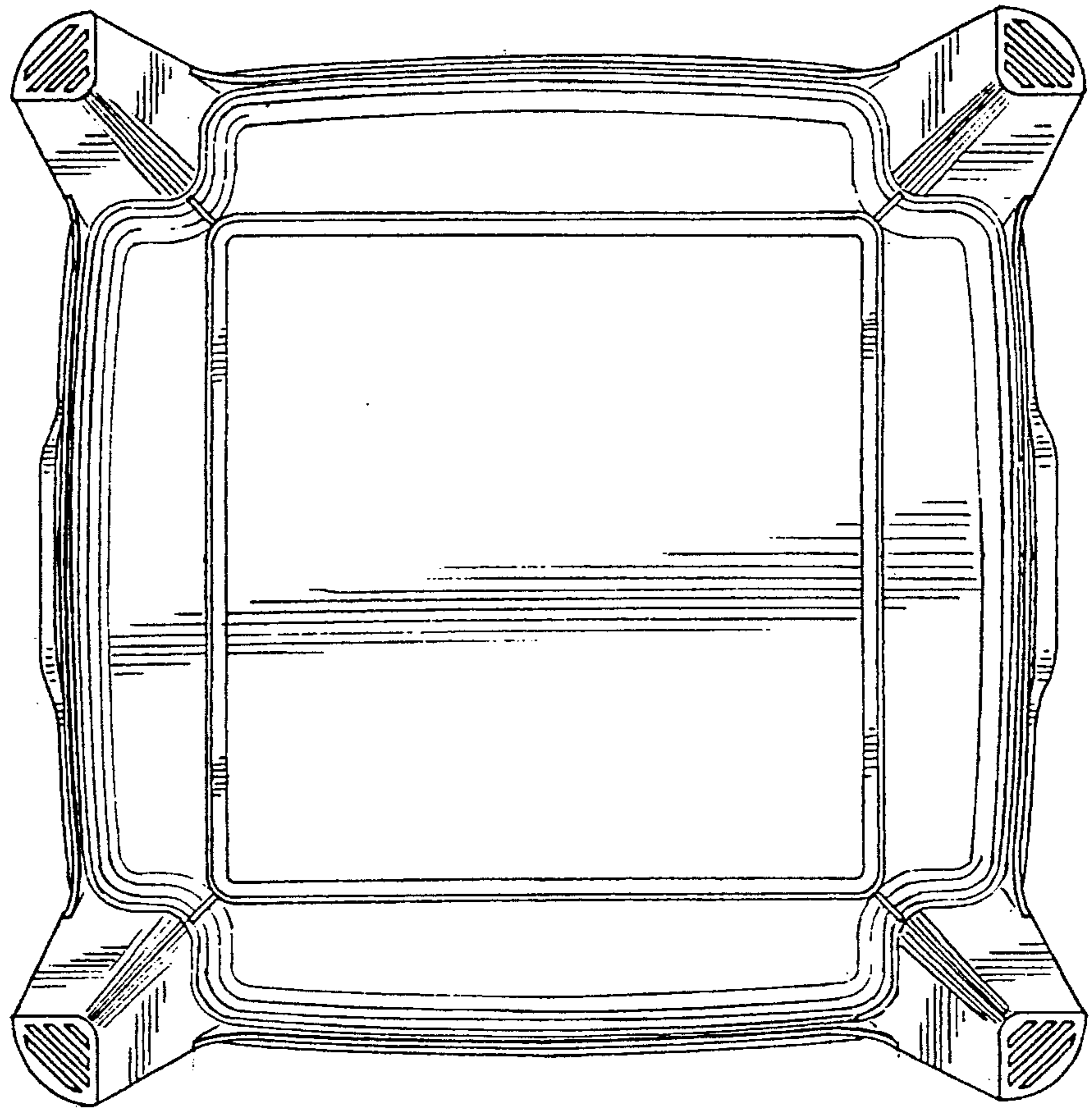

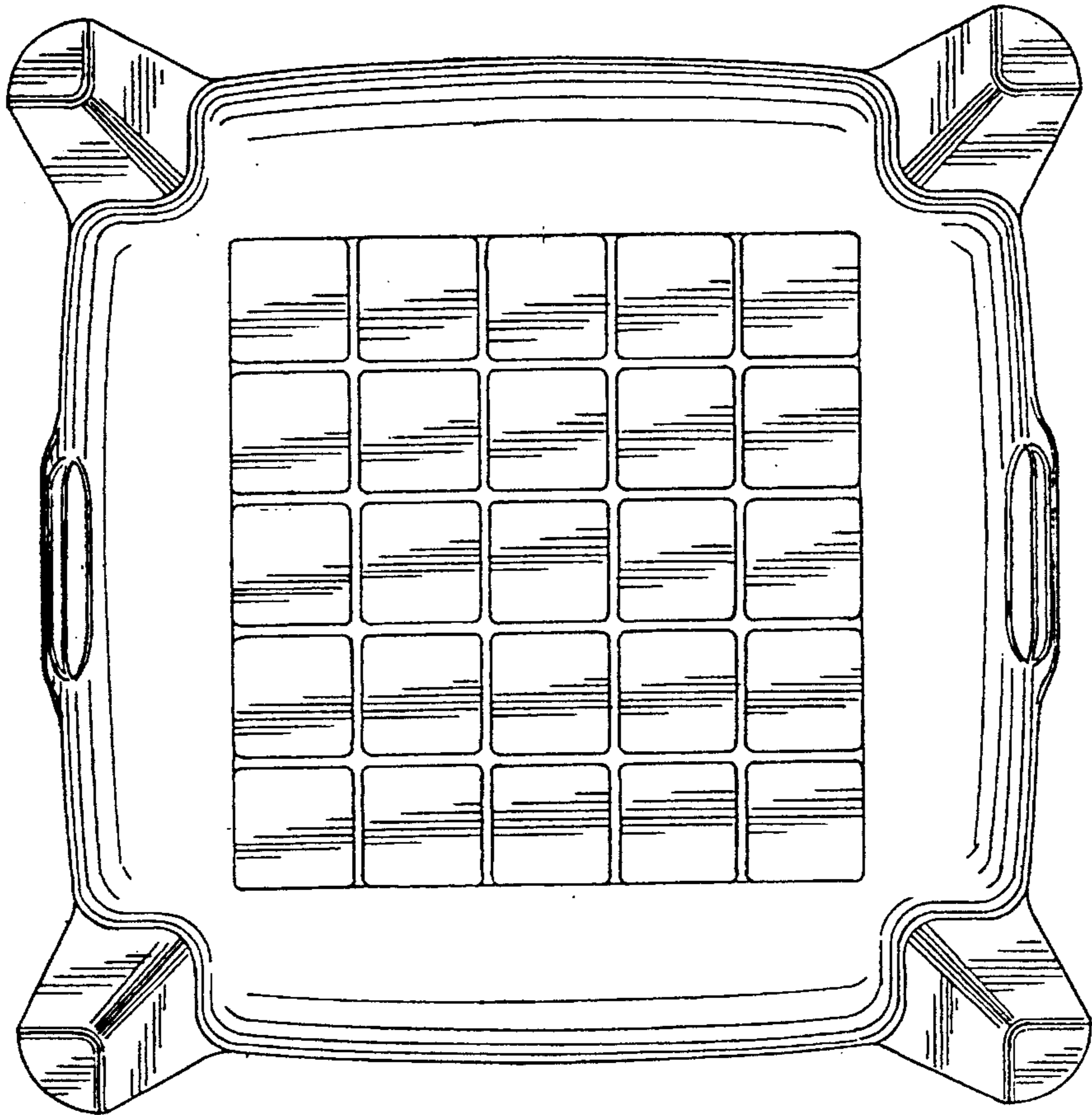

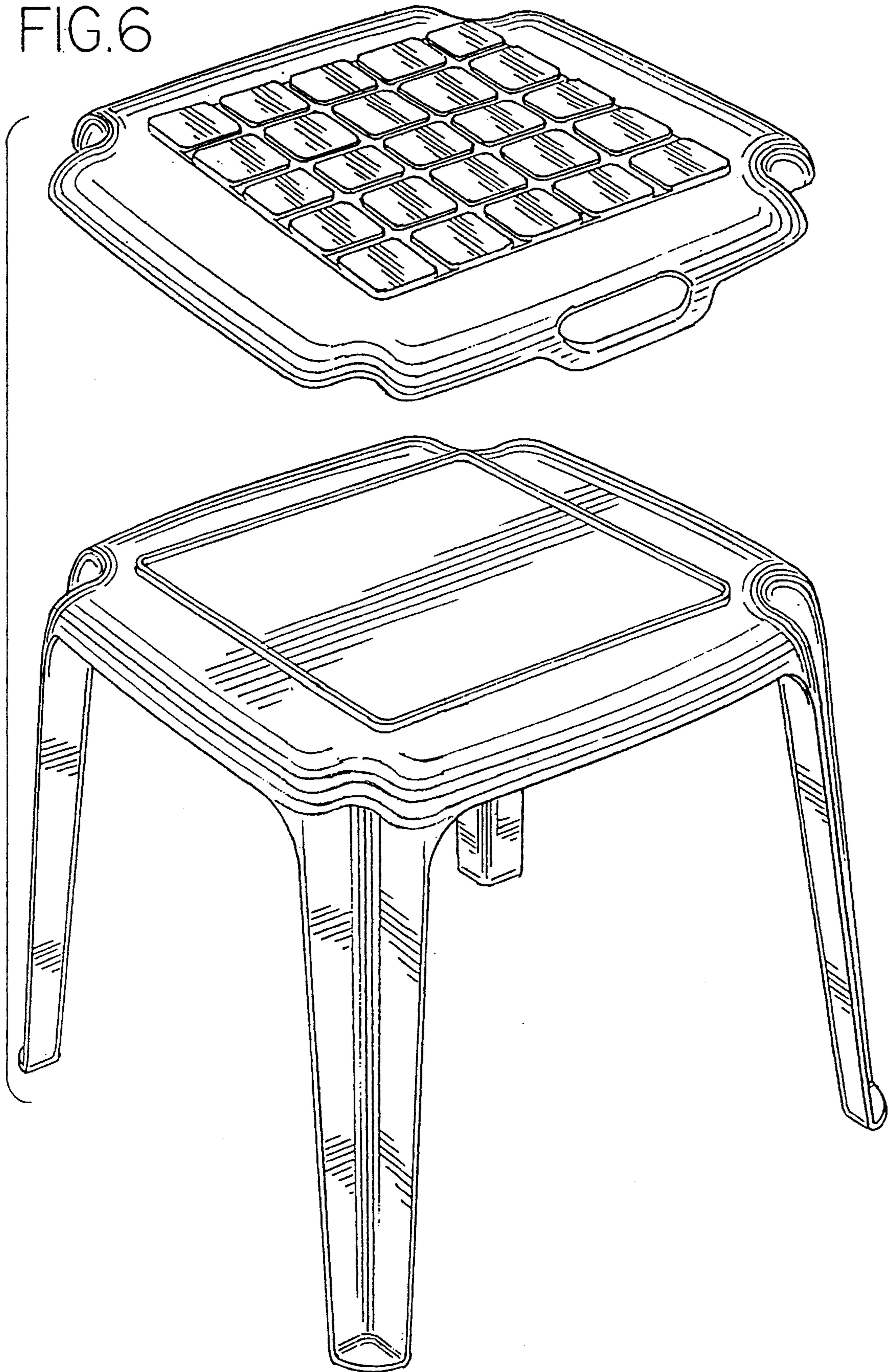
