[57] CLAIM

The ornamental design for a screwdriver, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a screwdriver, showing my new design, the rear view being a mirror image thereof; FIG. 2 is a right side elevation view of the screwdriver of FIG. 1, the left side elevation view being a mirror image thereof; FIG. 3 is a bottom plan view of the screwdriver of FIG. 1; FIG. 4 is a top plan view of the screwdriver of FIG. 1; and, FIG. 5 is an alternative front elevation view of the screwdriver of FIG. 1, with parts separated.

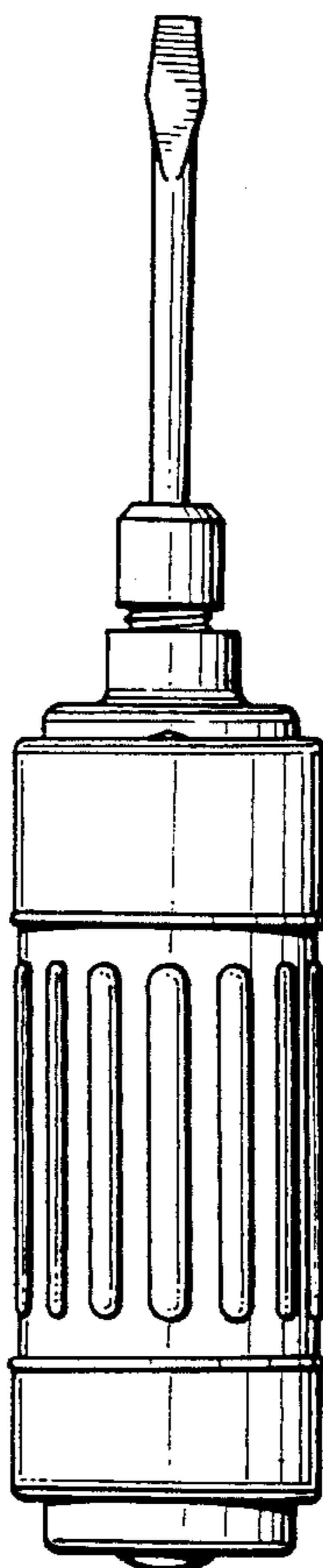

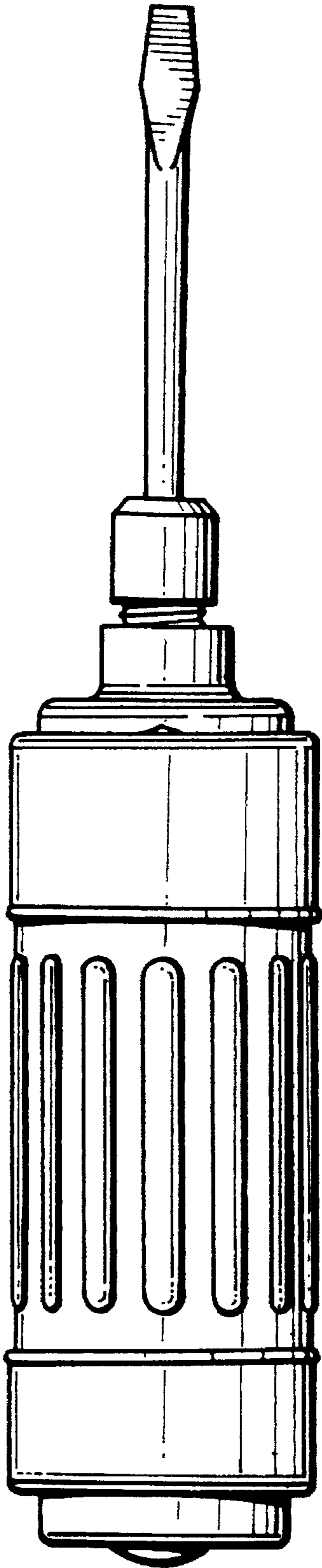

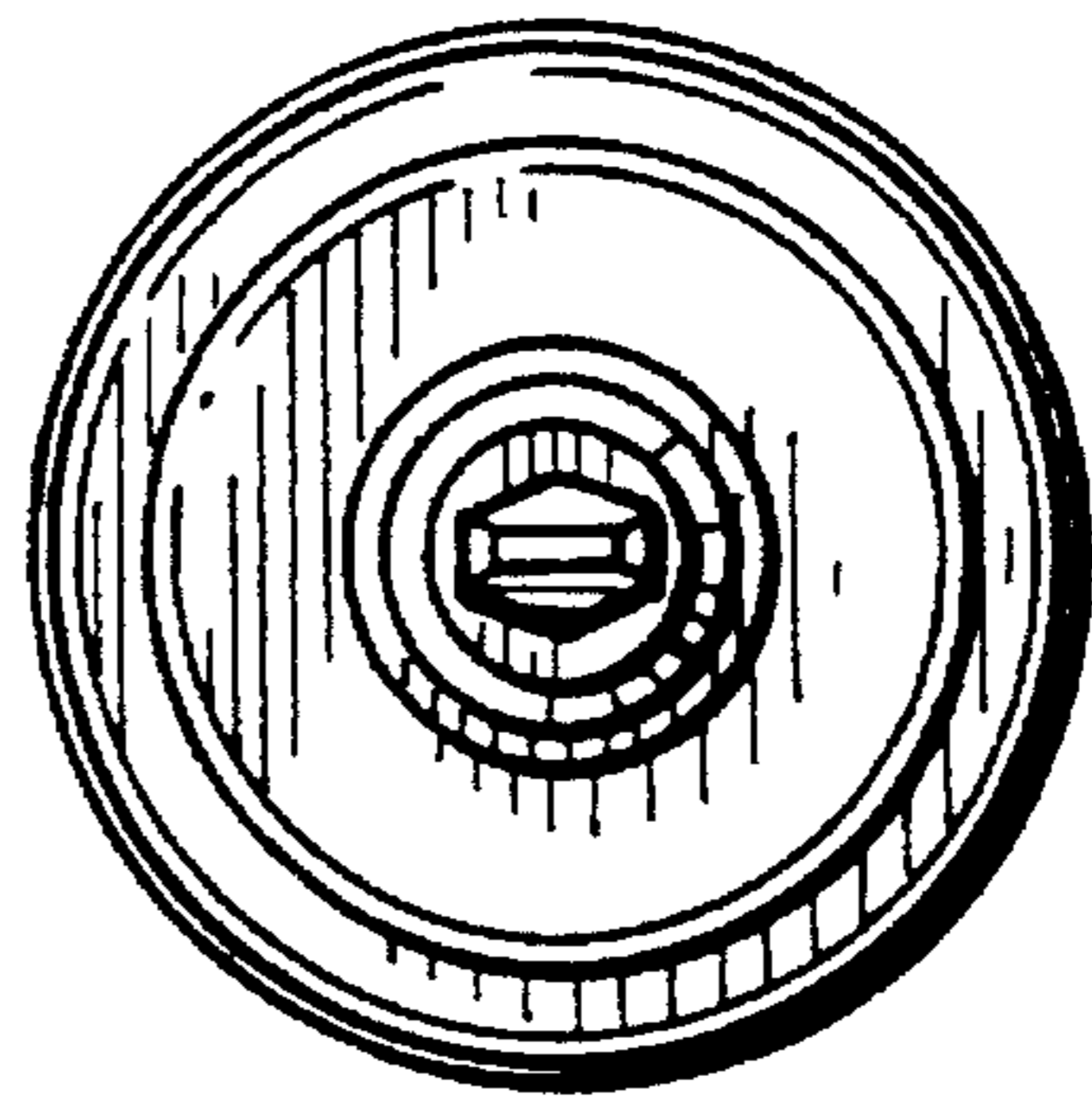

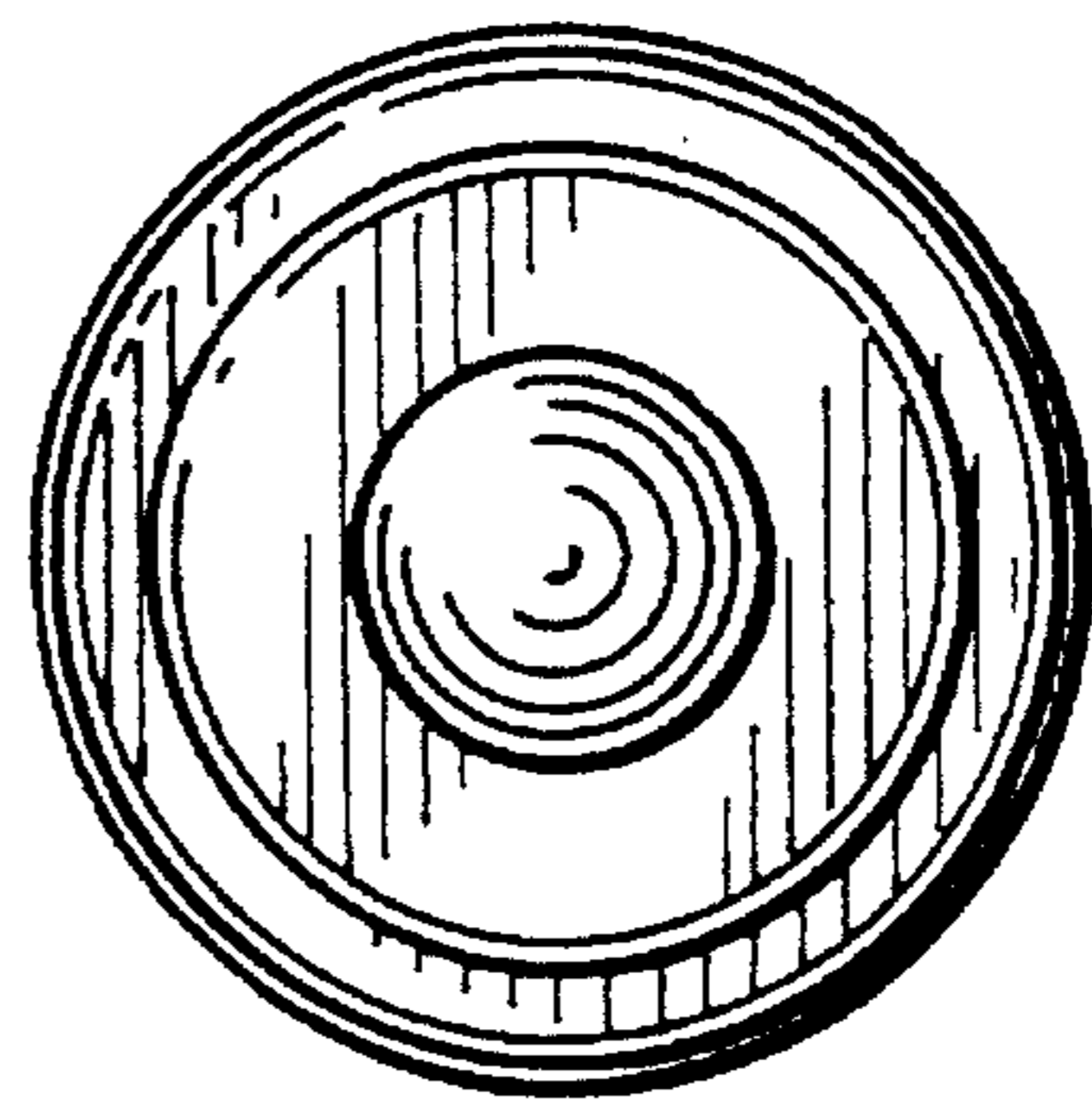

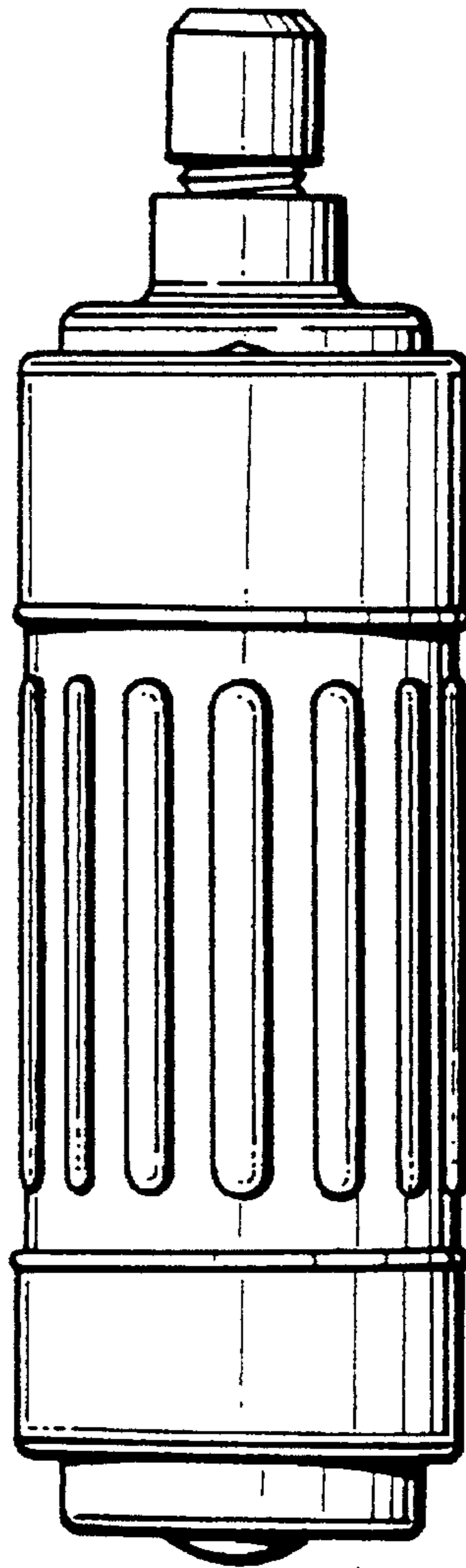
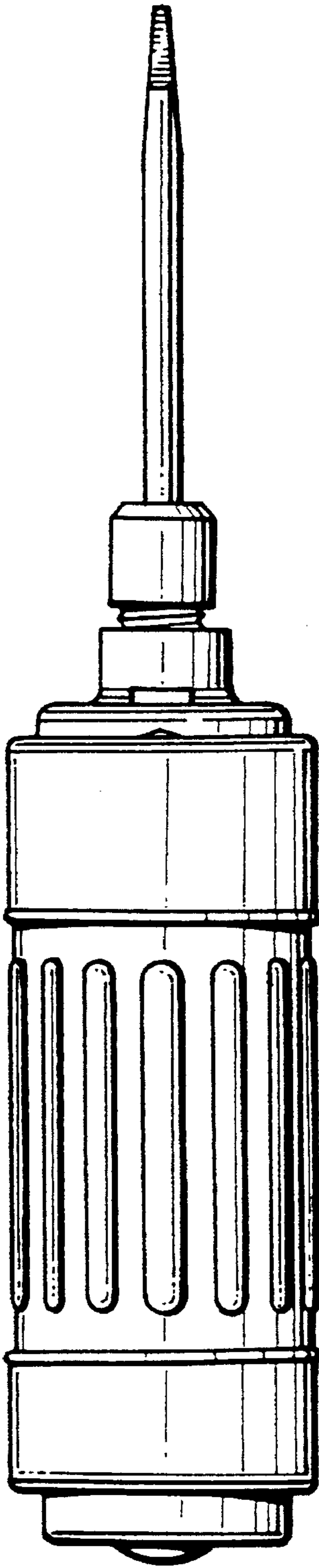
