[57] **CLAIM**

The ornamental design for a cross spoked license plate frame, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a cross spoked license

plate frame showing my new design;

FIG. 2 is a right side elevational view, the left side elevational view being the mirror image thereof;

FIG. 3 is a top plan view, the bottom plan view is the mirror image thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a sectional view along line 5—5 of FIG. 1;

FIG. 6 is a sectional view along line 6—6 of FIG. 1;

FIG. 7 is a front elevational view of a second embodiment;

FIG. 8 is a right side elevational view of FIG. 7, the left side elevational view being the mirror image thereof;

FIG. 9 is a top plan view of FIG. 7, the bottom plan view is the mirror image thereof;

FIG. 10 is a rear elevational view of FIG. 7;

FIG. 11 is a sectional view along line 11—11 of FIG. 7;

FIG. 12 is a sectional view along line 12—12 of FIG. 7;

FIG. 13 is a sectional view along line 13—13 of FIG. 7;

FIG. 14 is a front elevational view of a third embodiment;

FIG. 15 is a right side elevational view of FIG. 14, the left side elevational view being the mirror image thereof;

FIG. 16 is a top plan view of FIG. 14, the bottom plan view is the mirror image thereof;

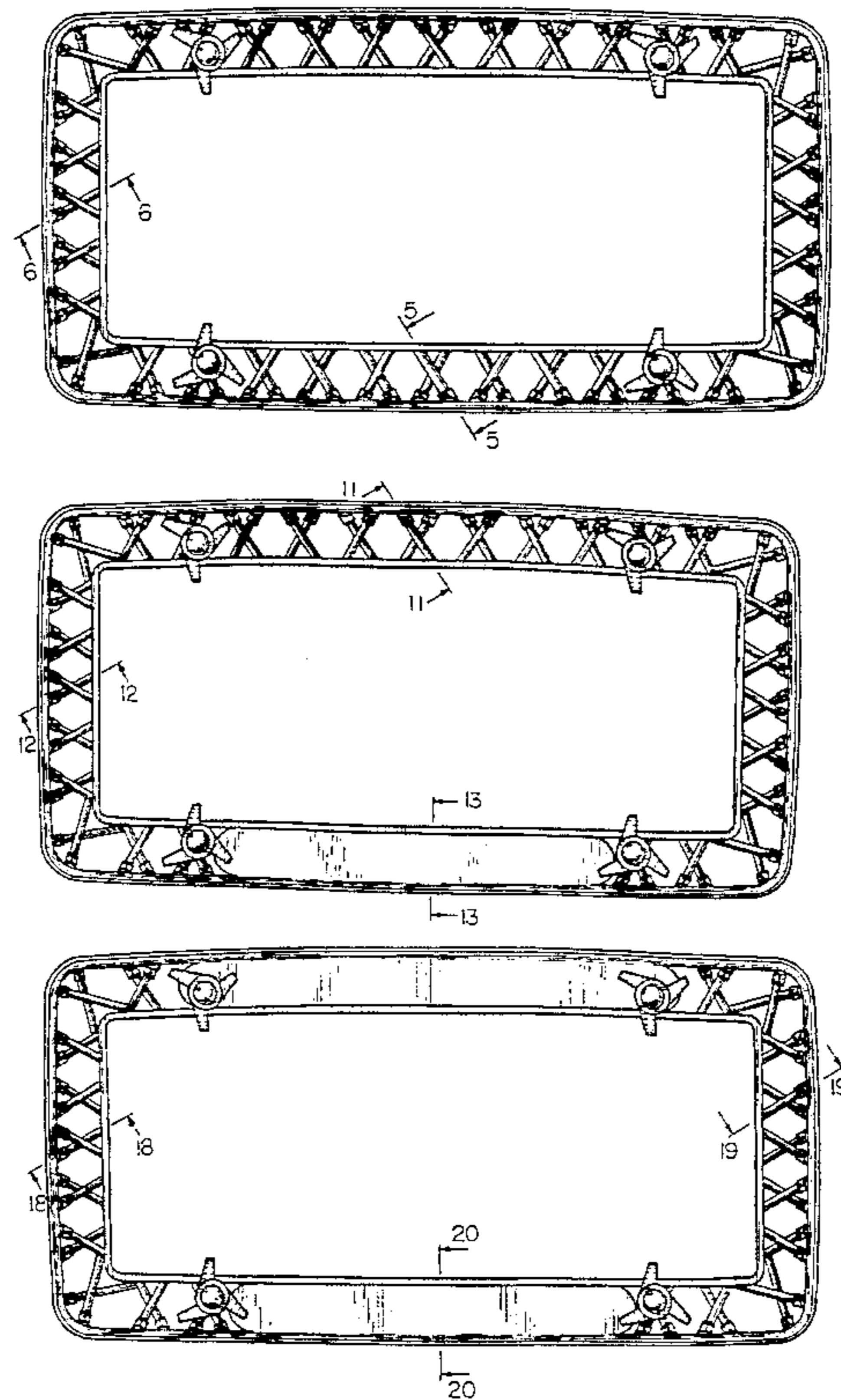
FIG. 17 is a rear elevational view of FIG. 14;

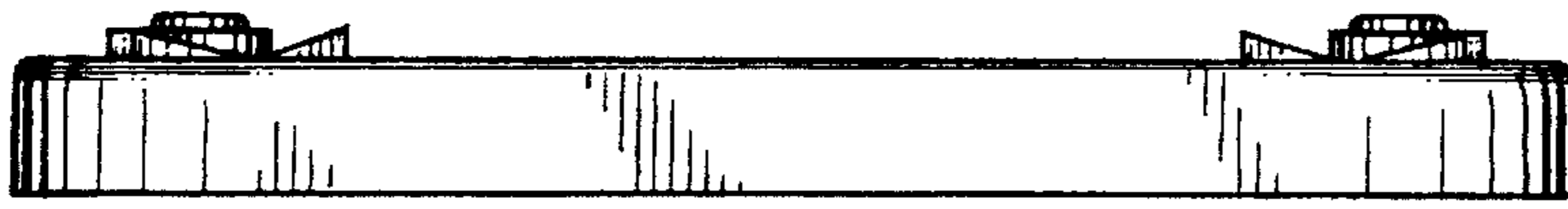

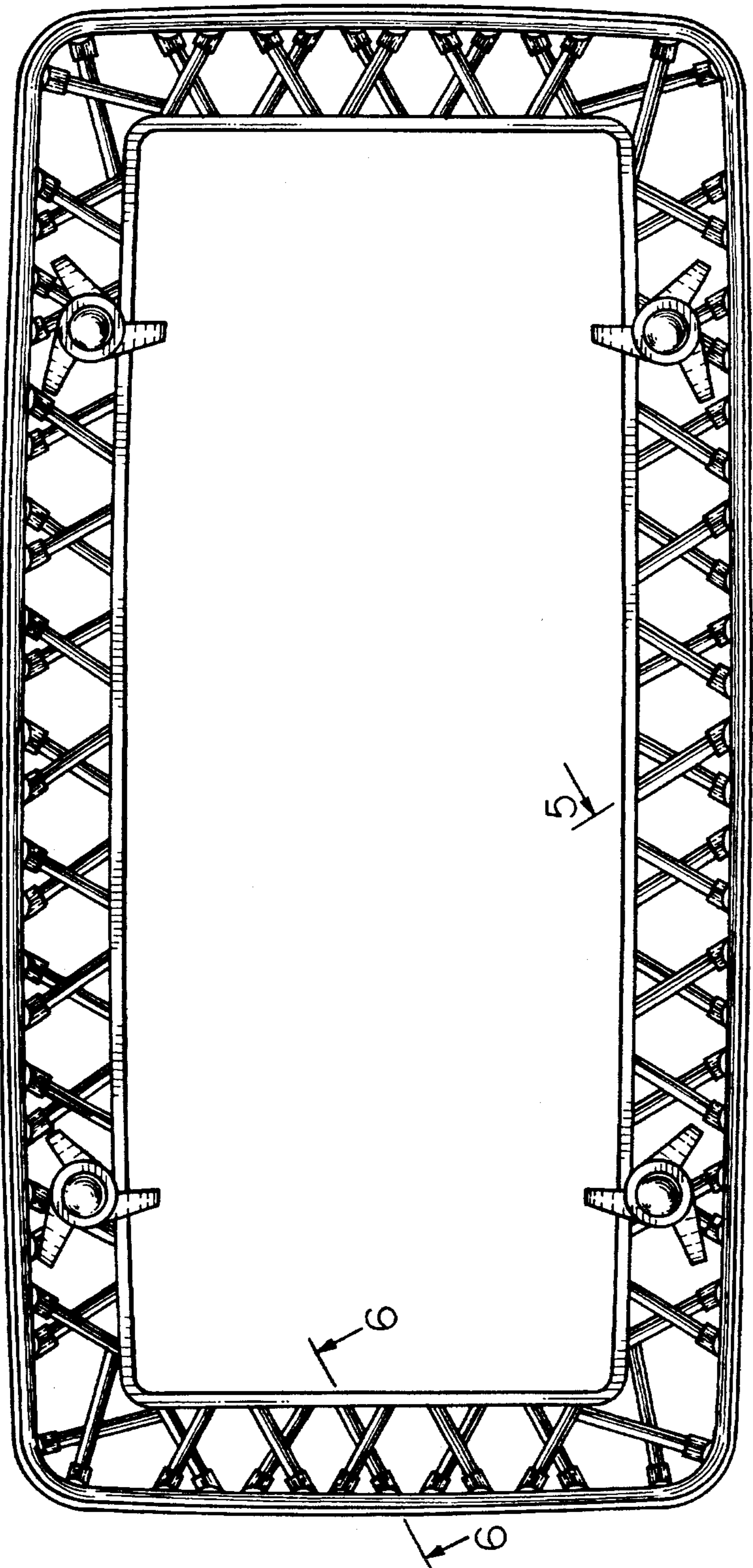

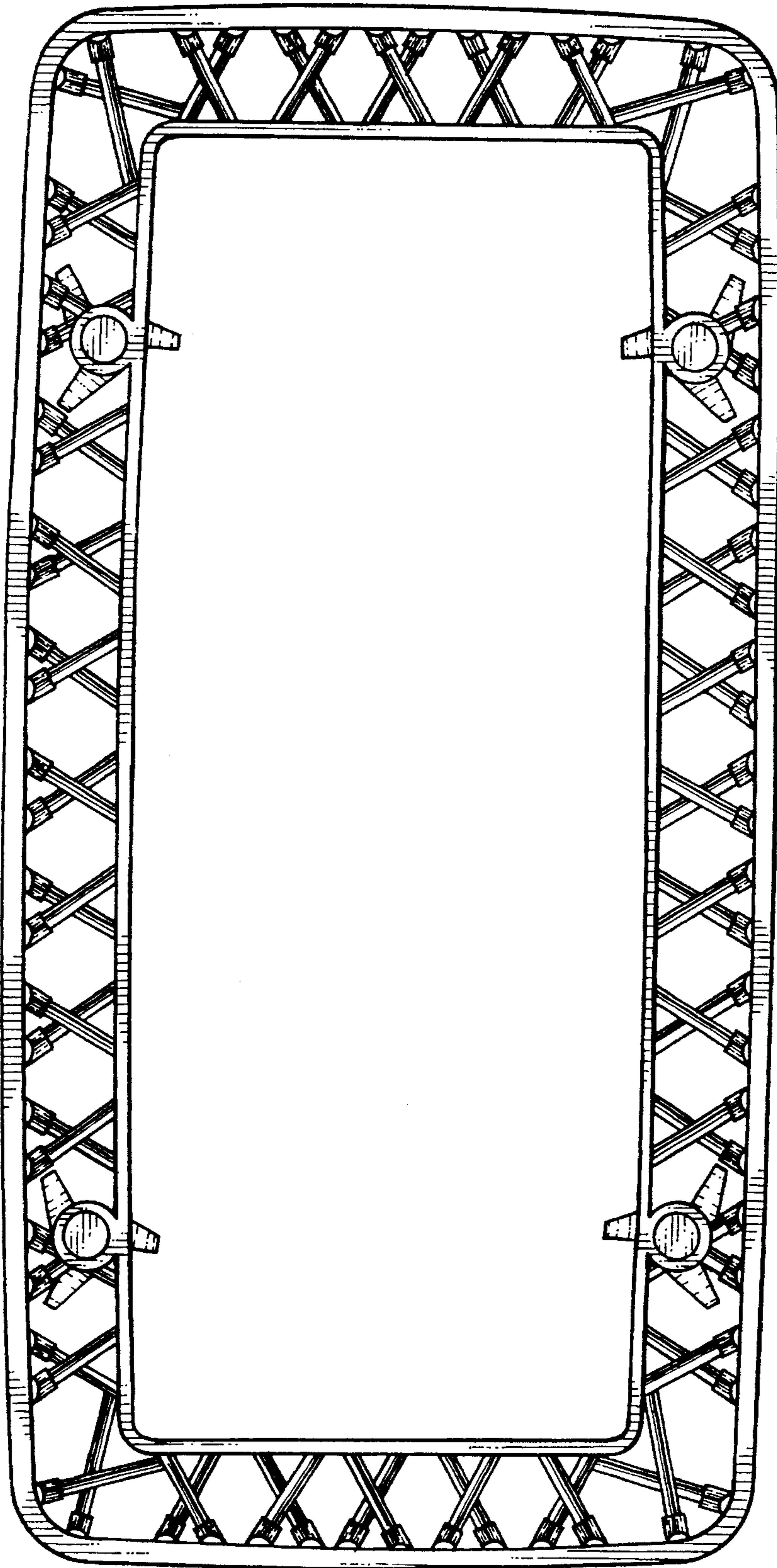

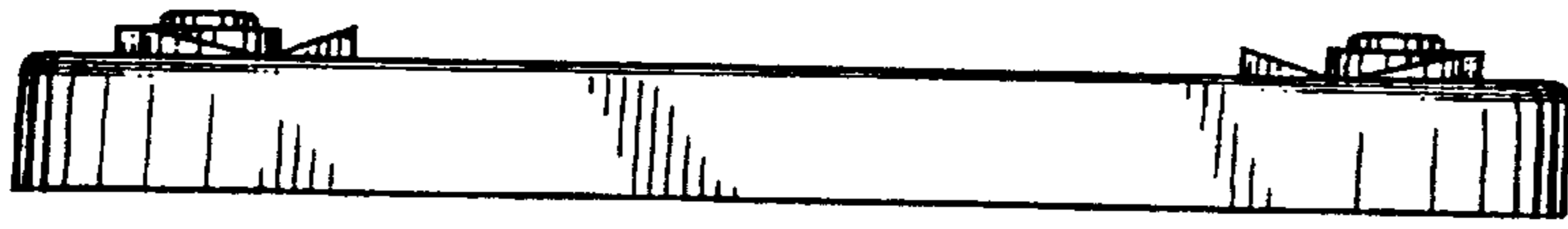

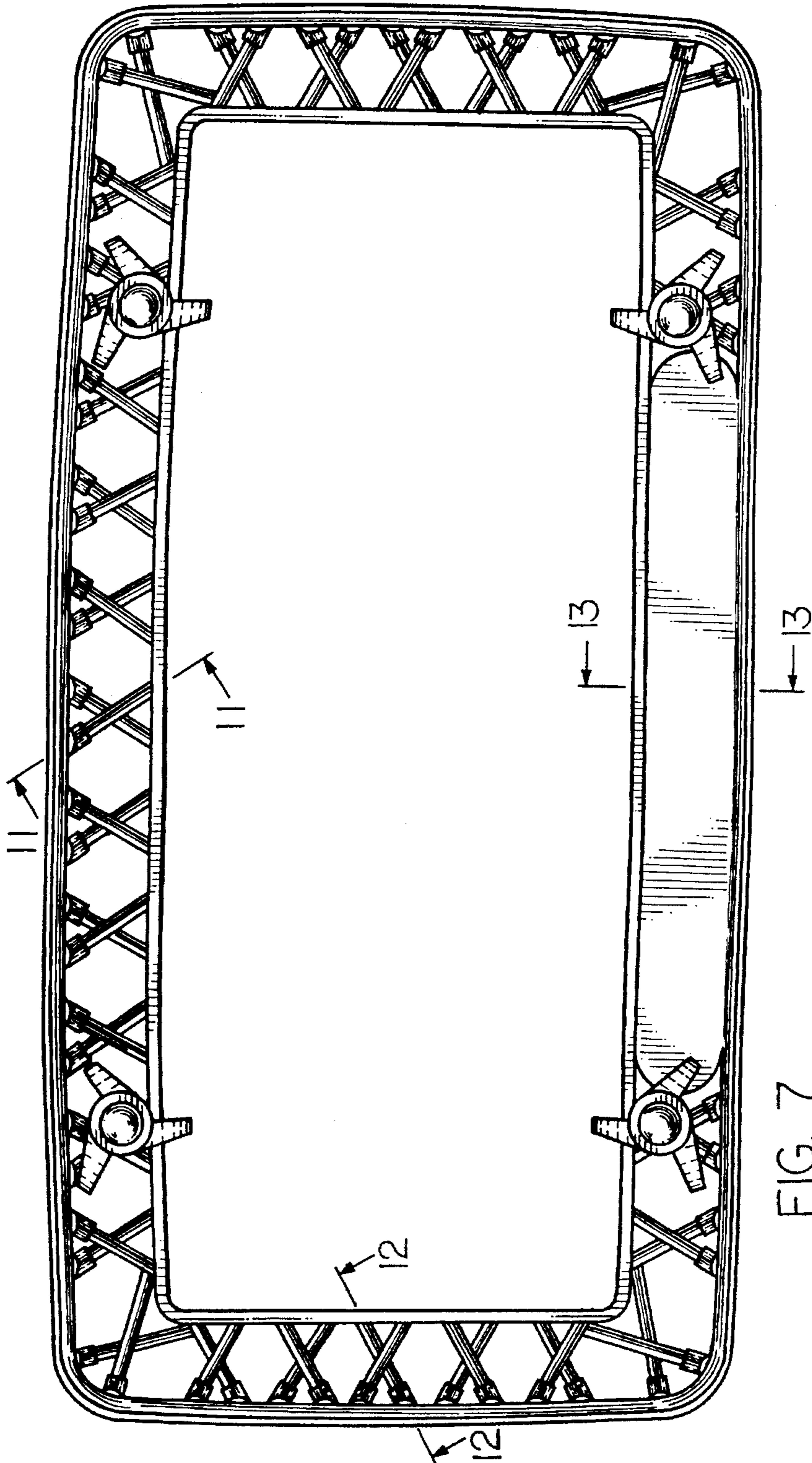

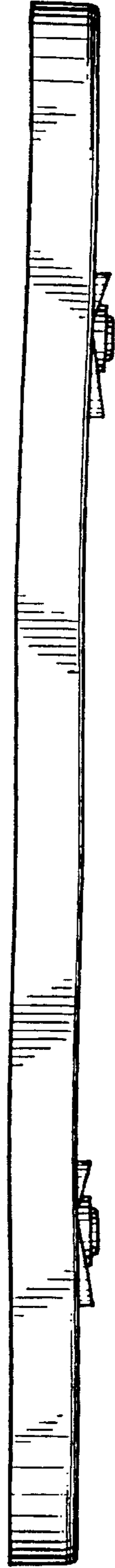

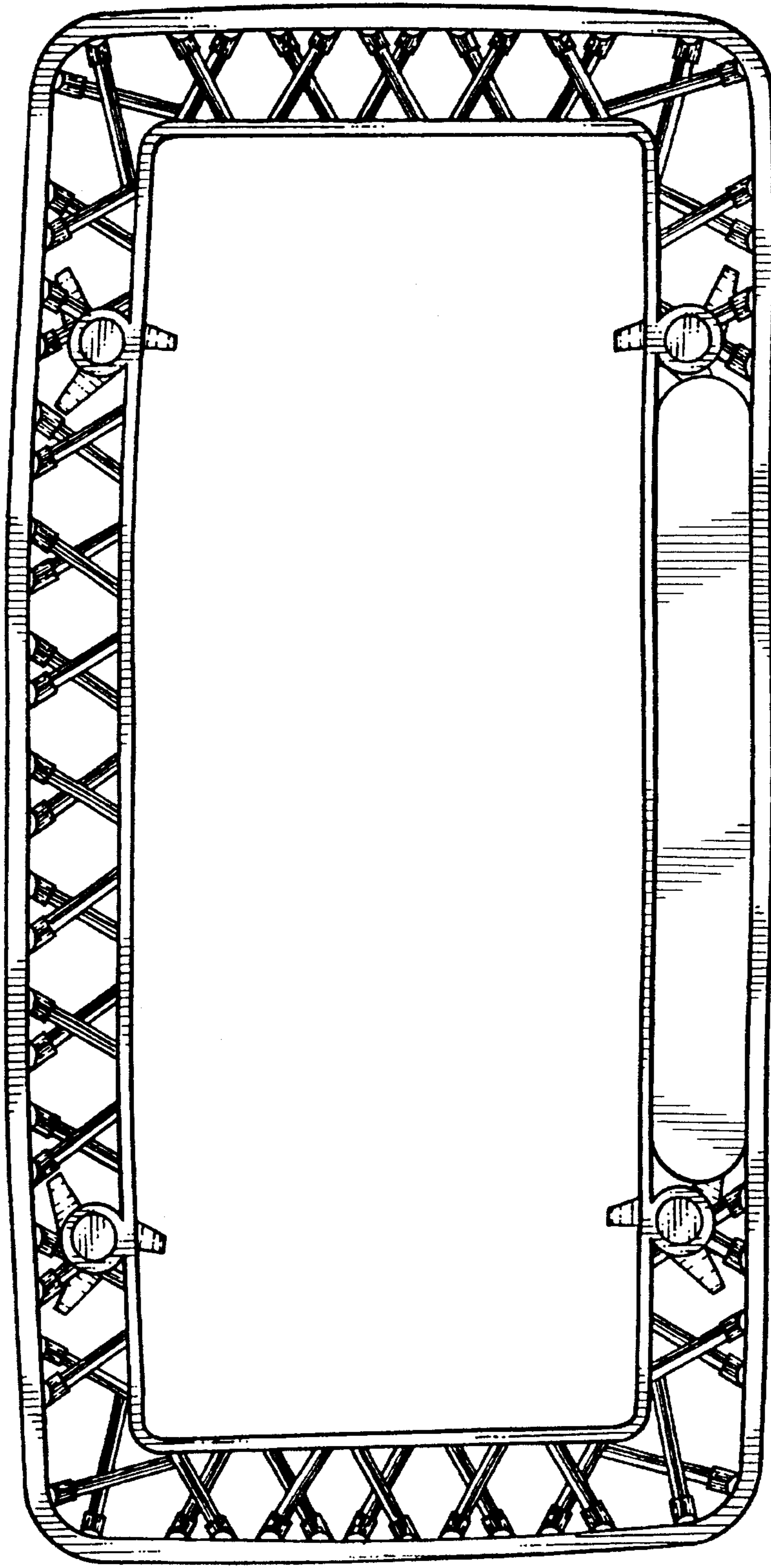

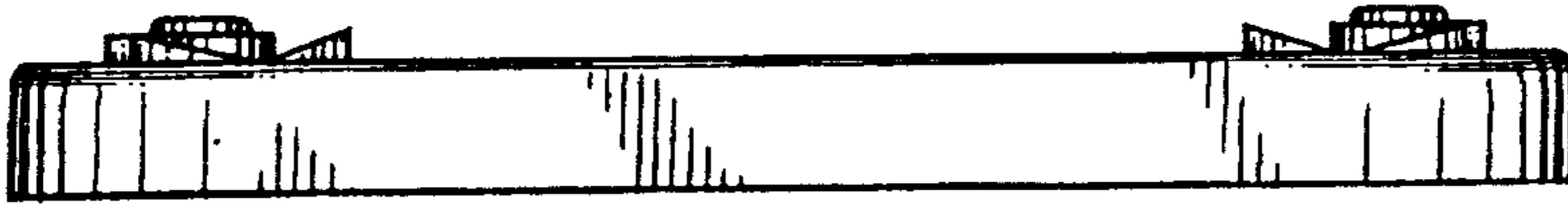

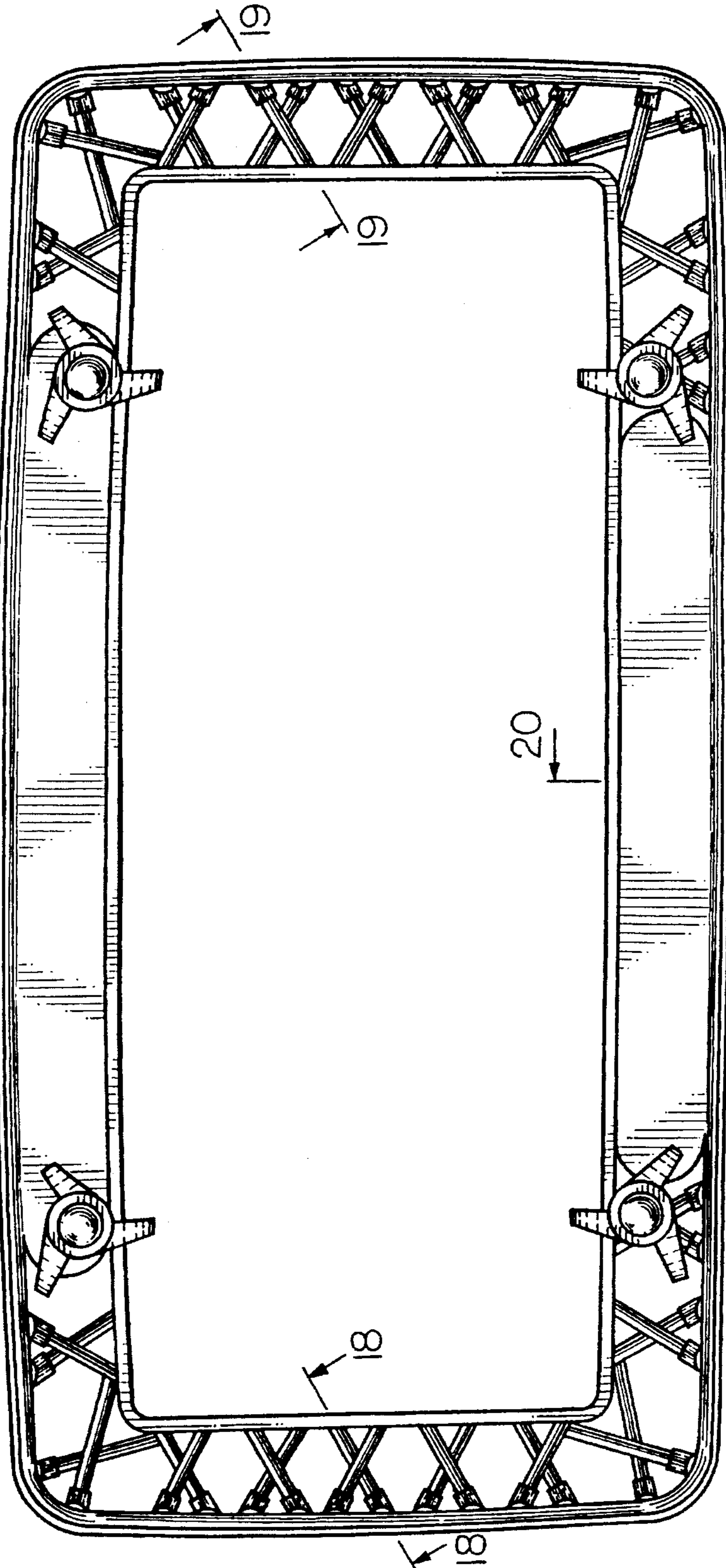

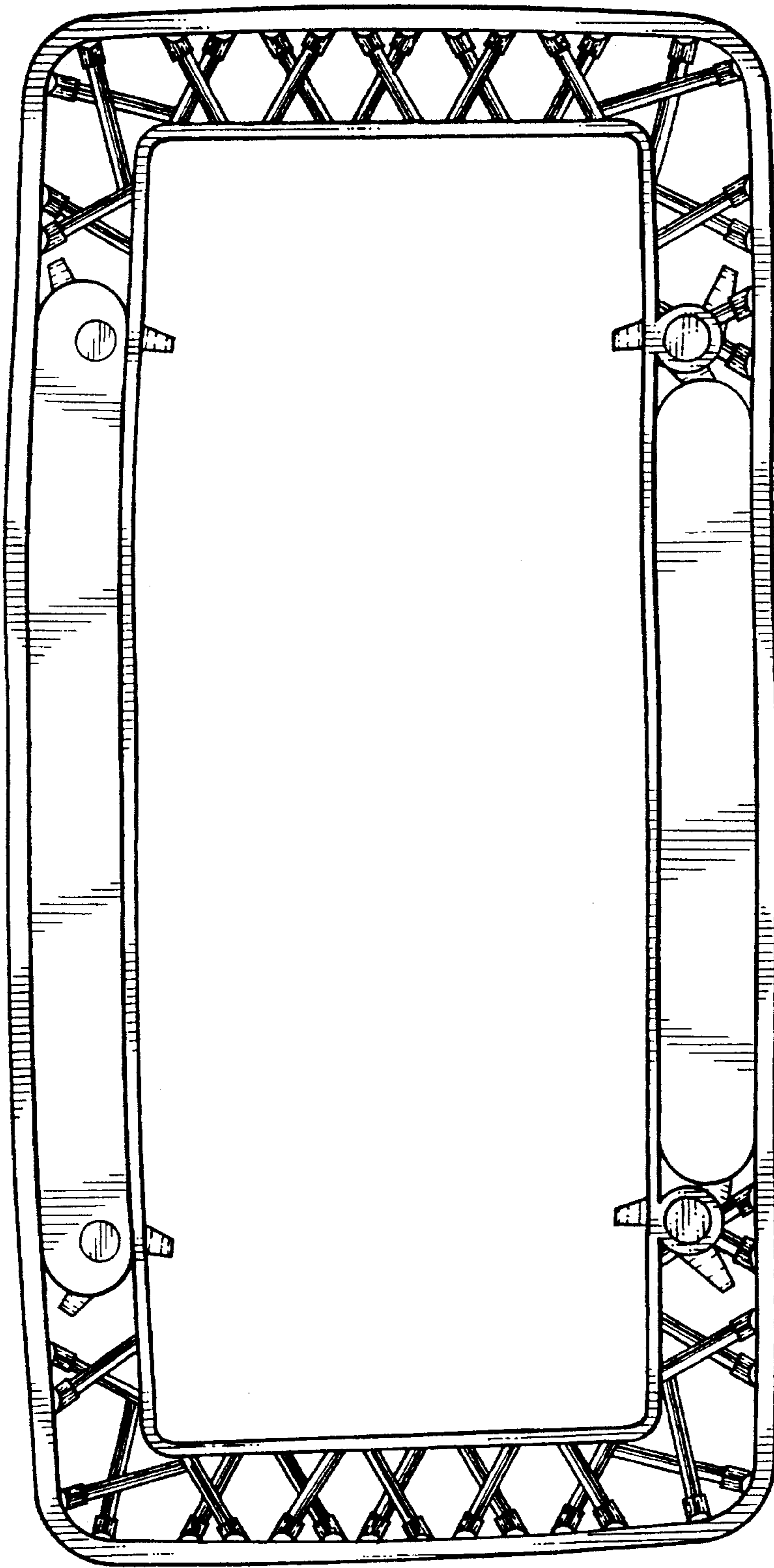
