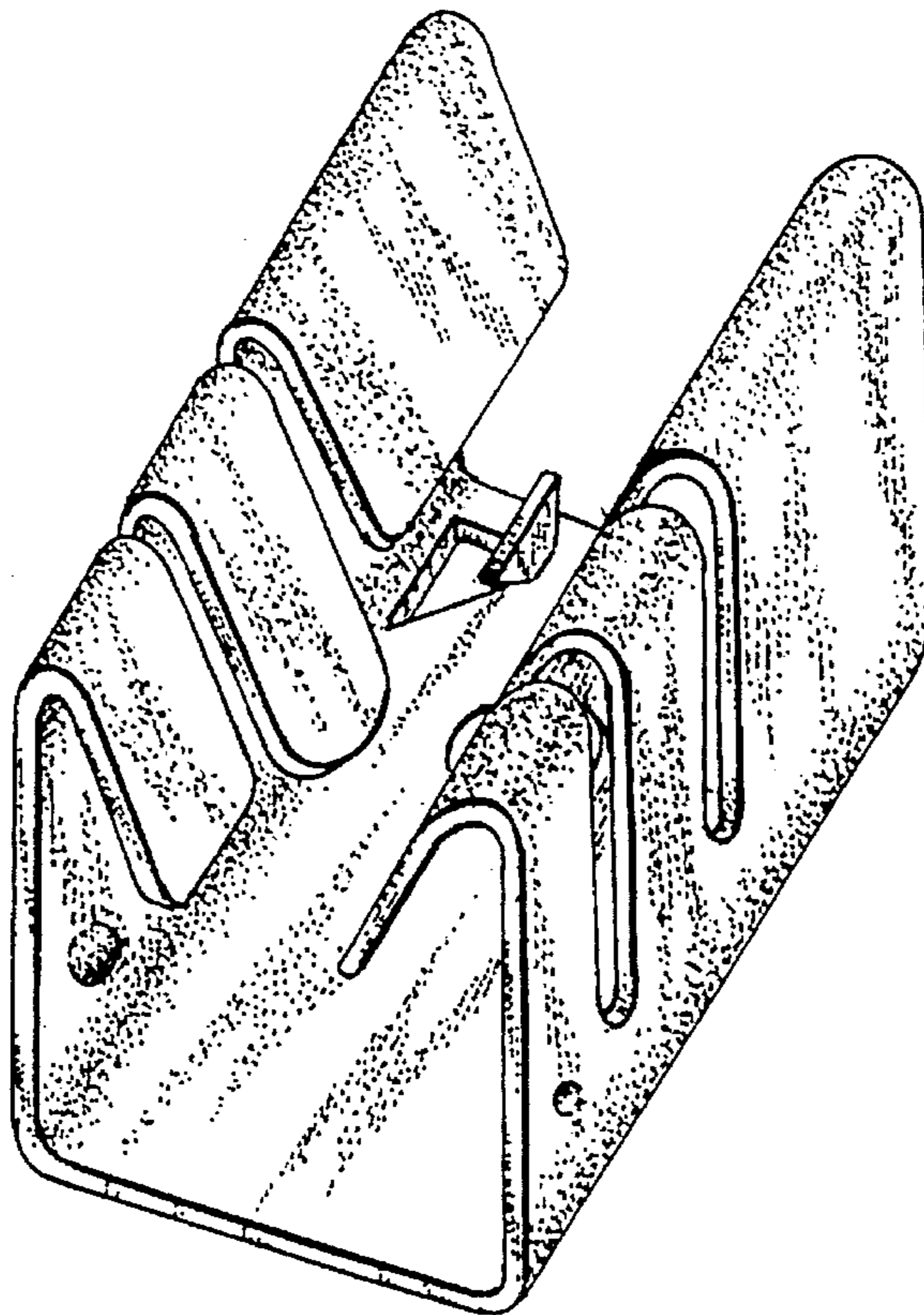
FIG. 1 is an isometric view of a clamping heat sink, showing

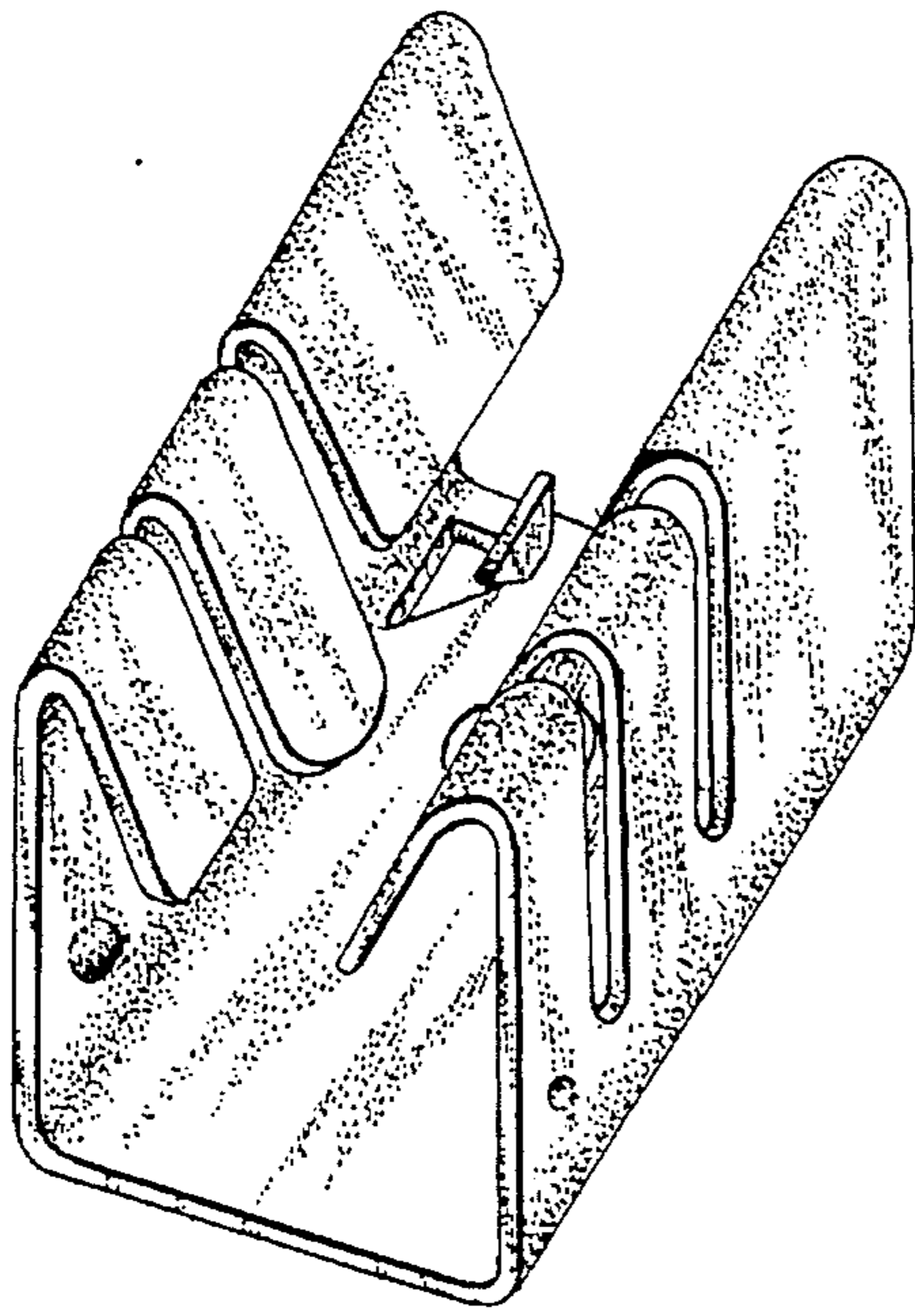

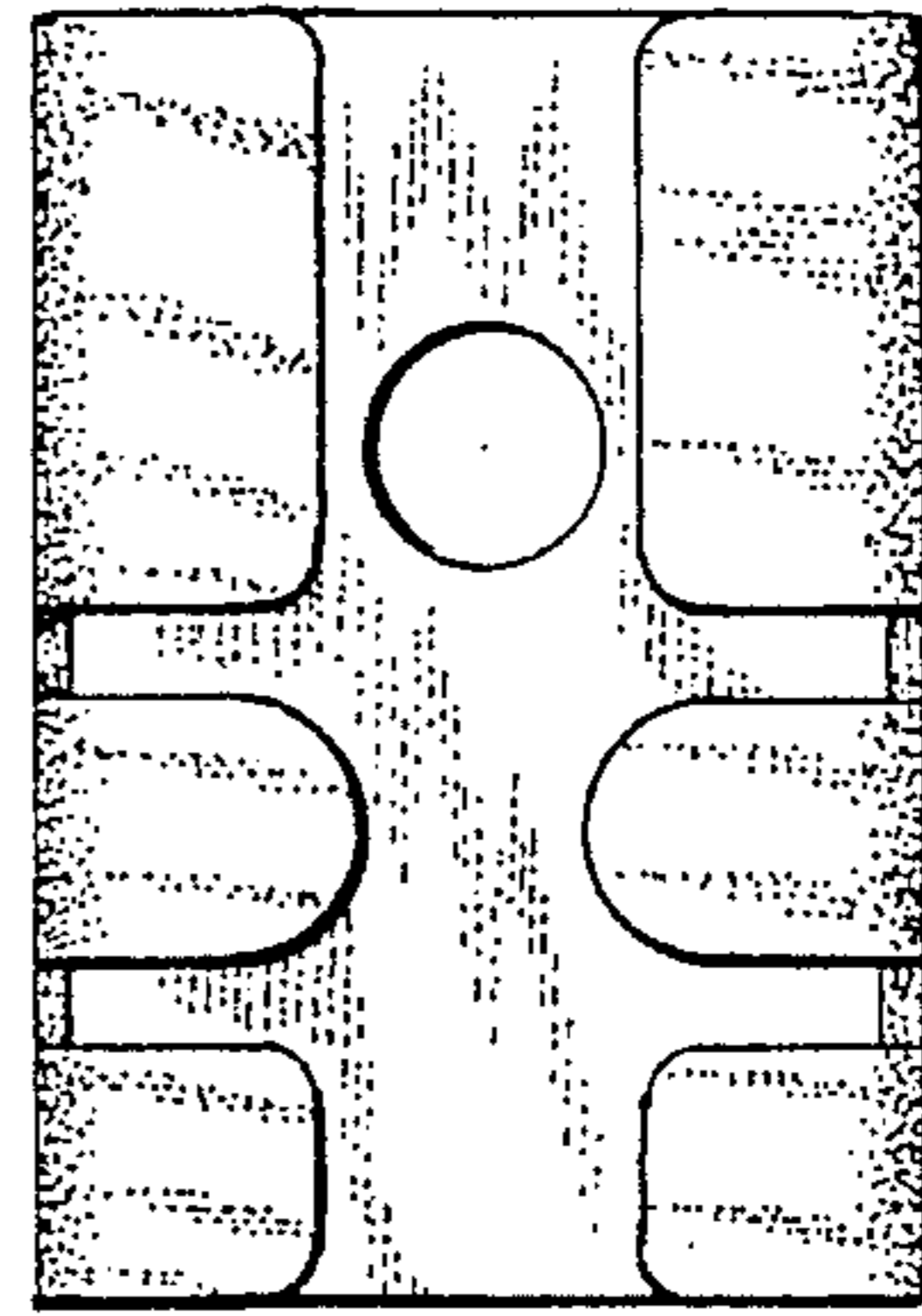

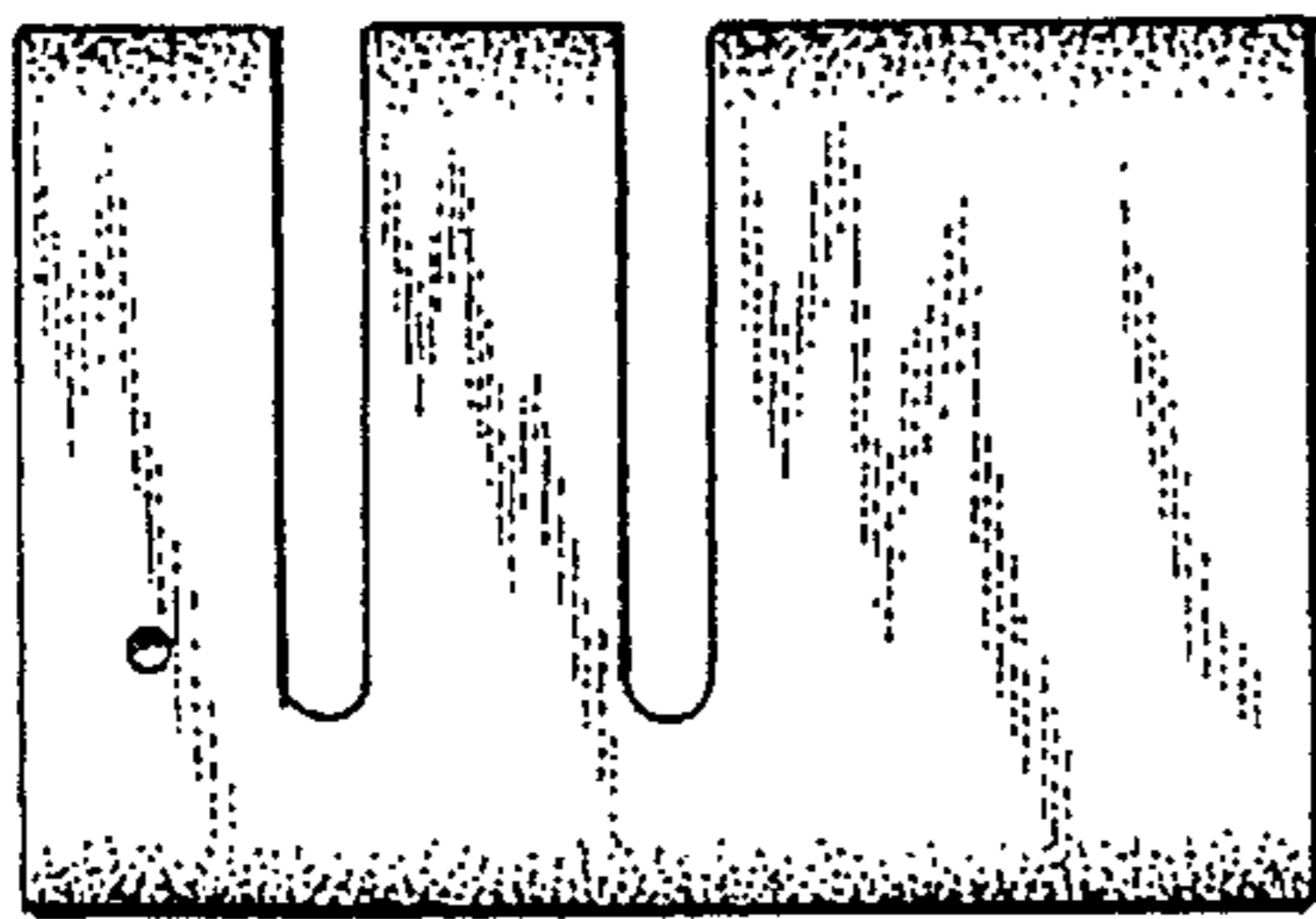

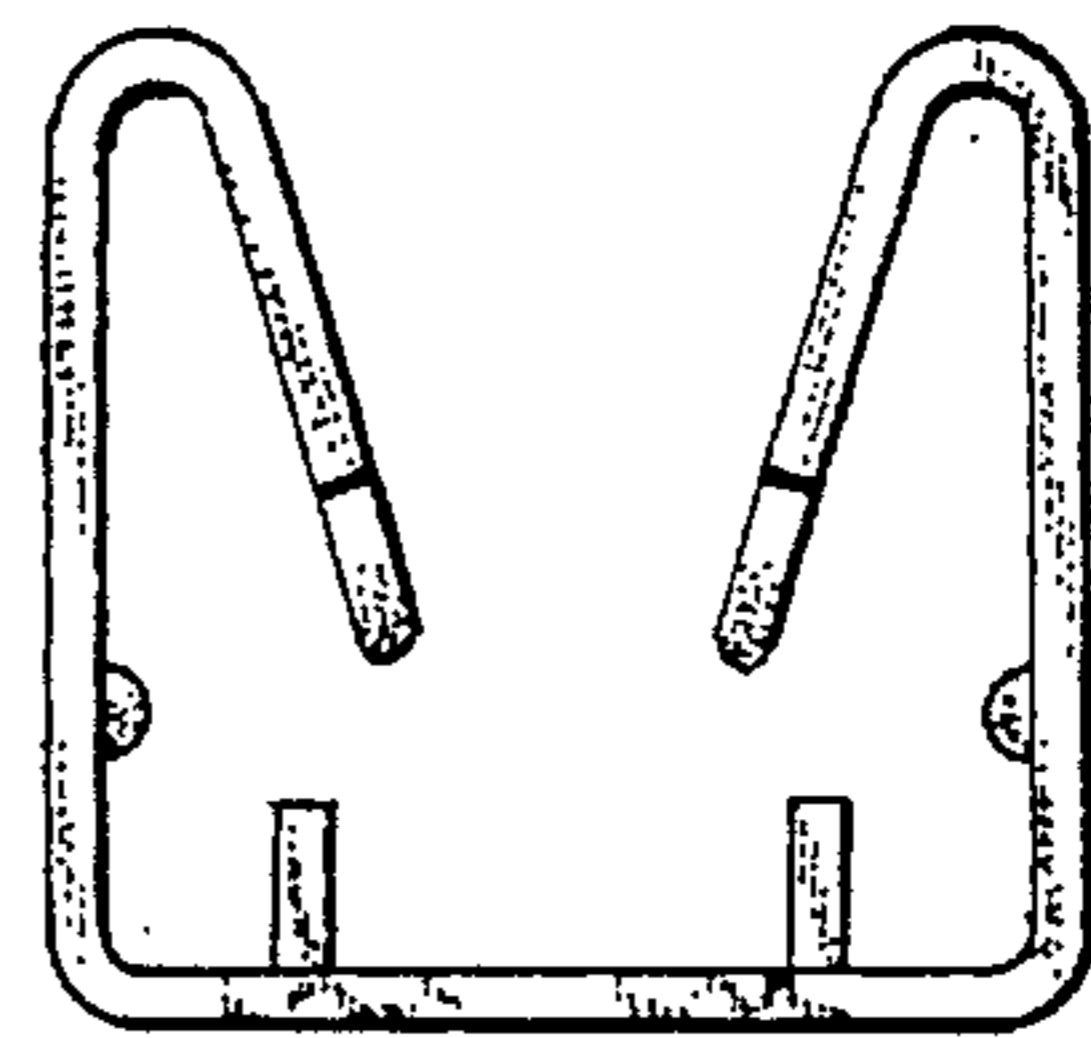

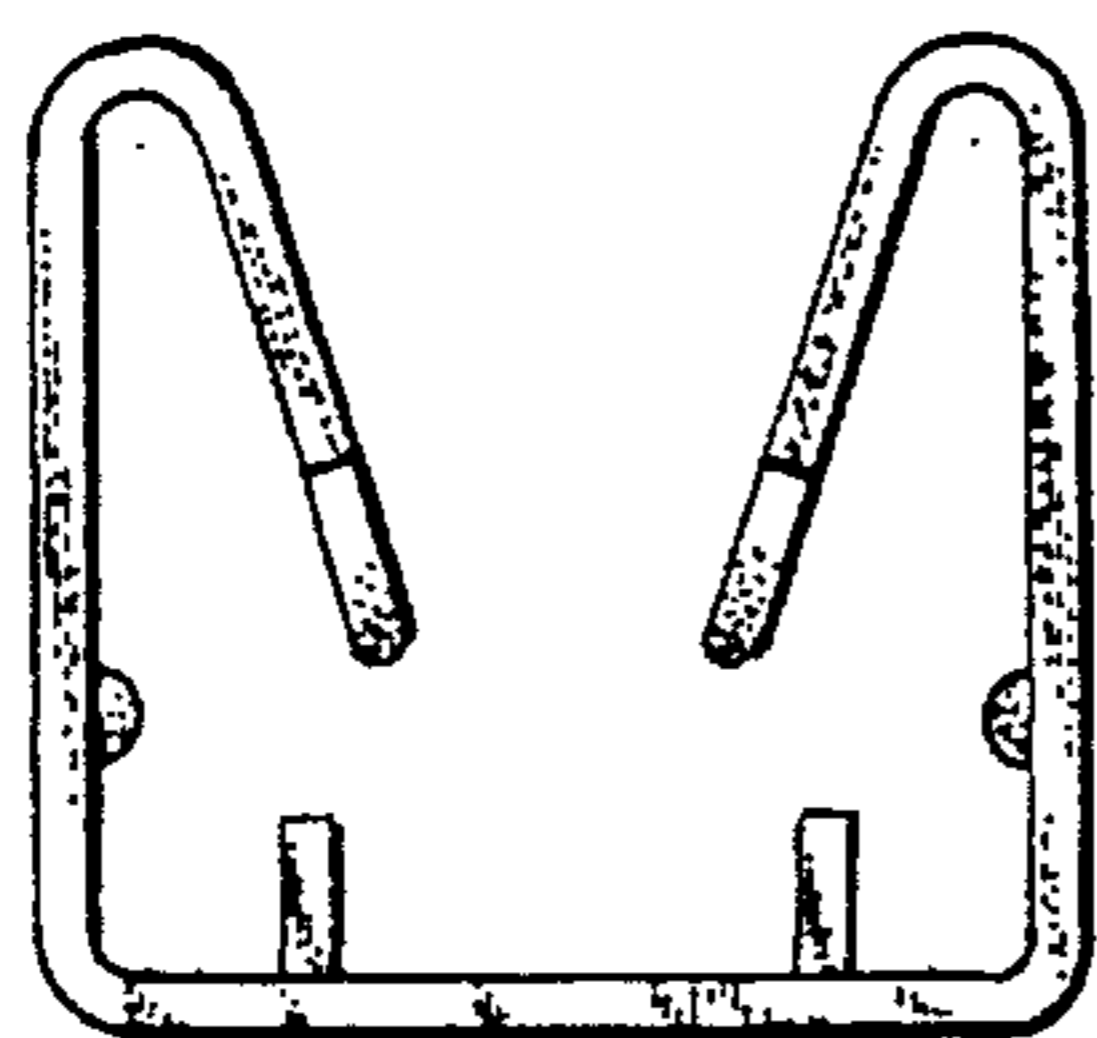

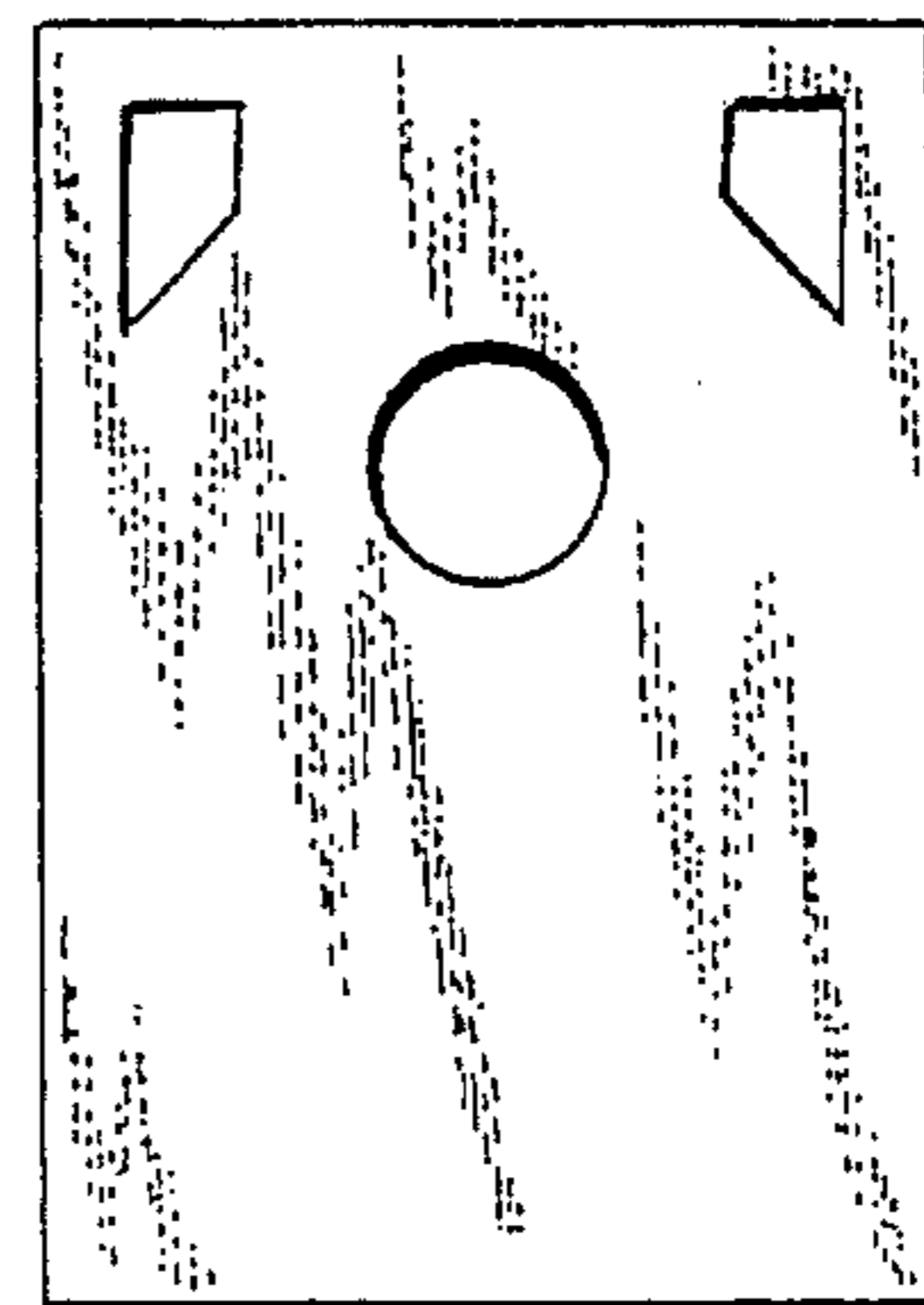

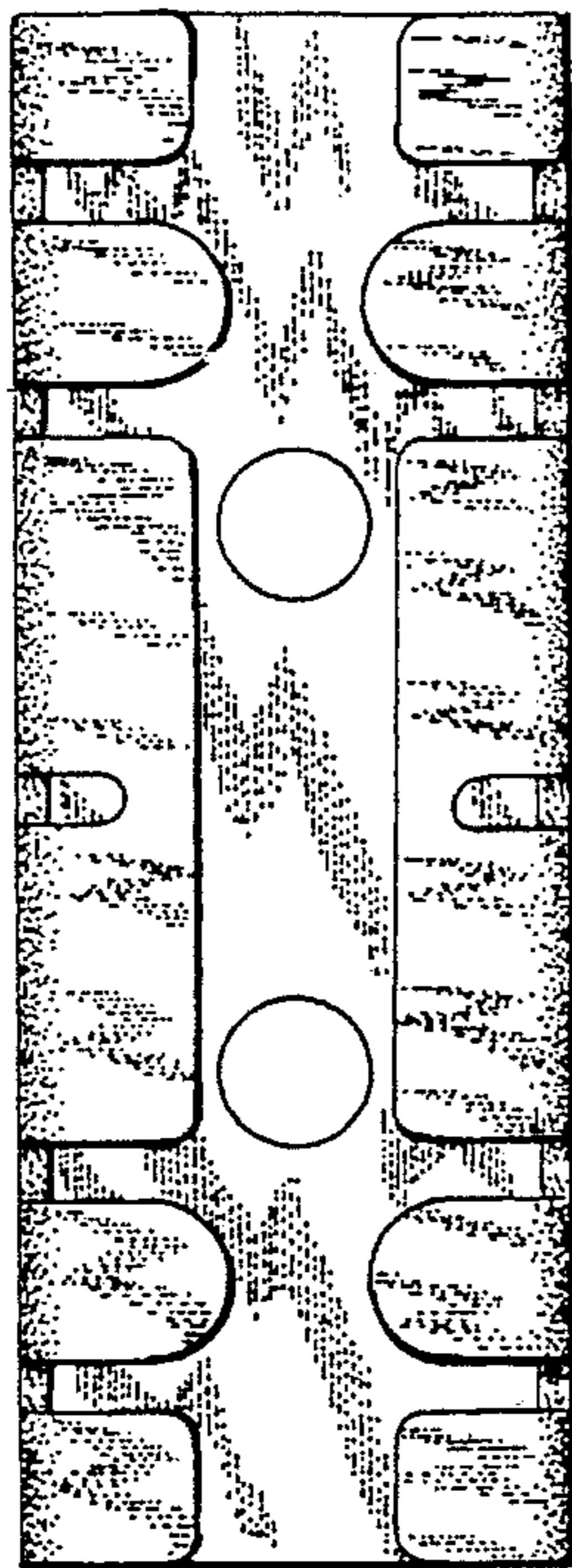

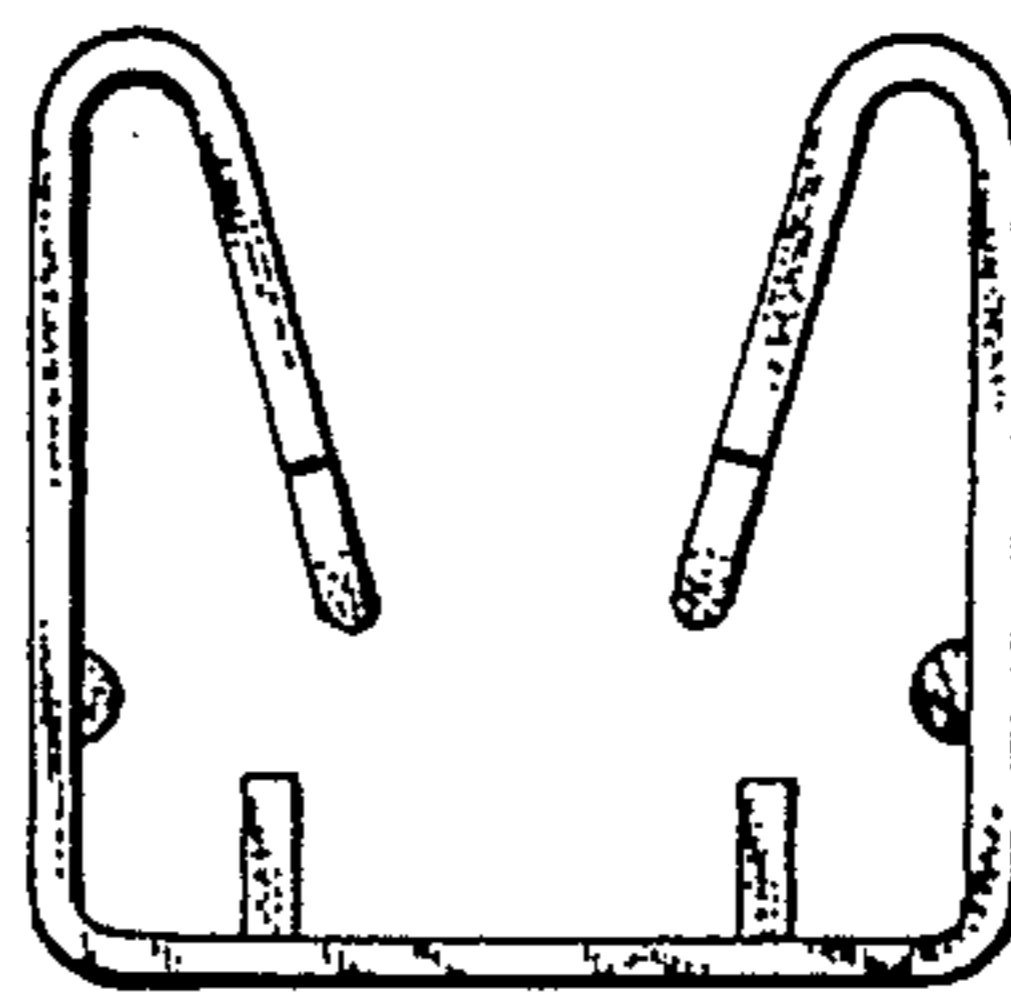

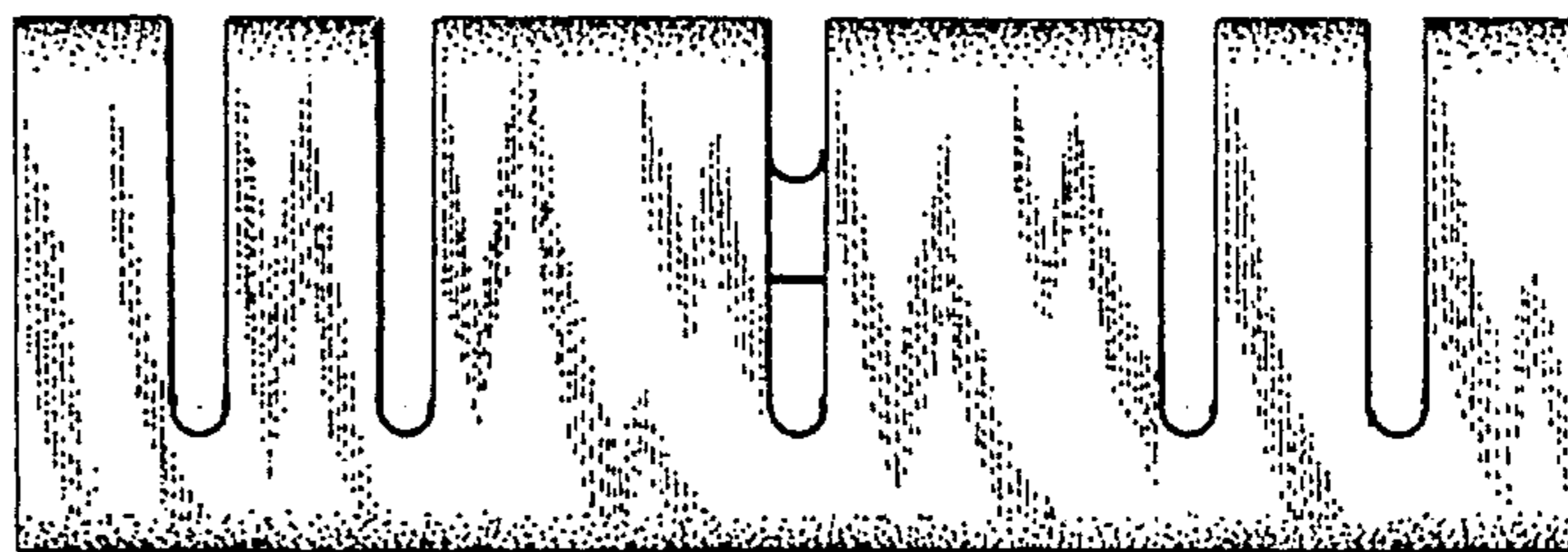

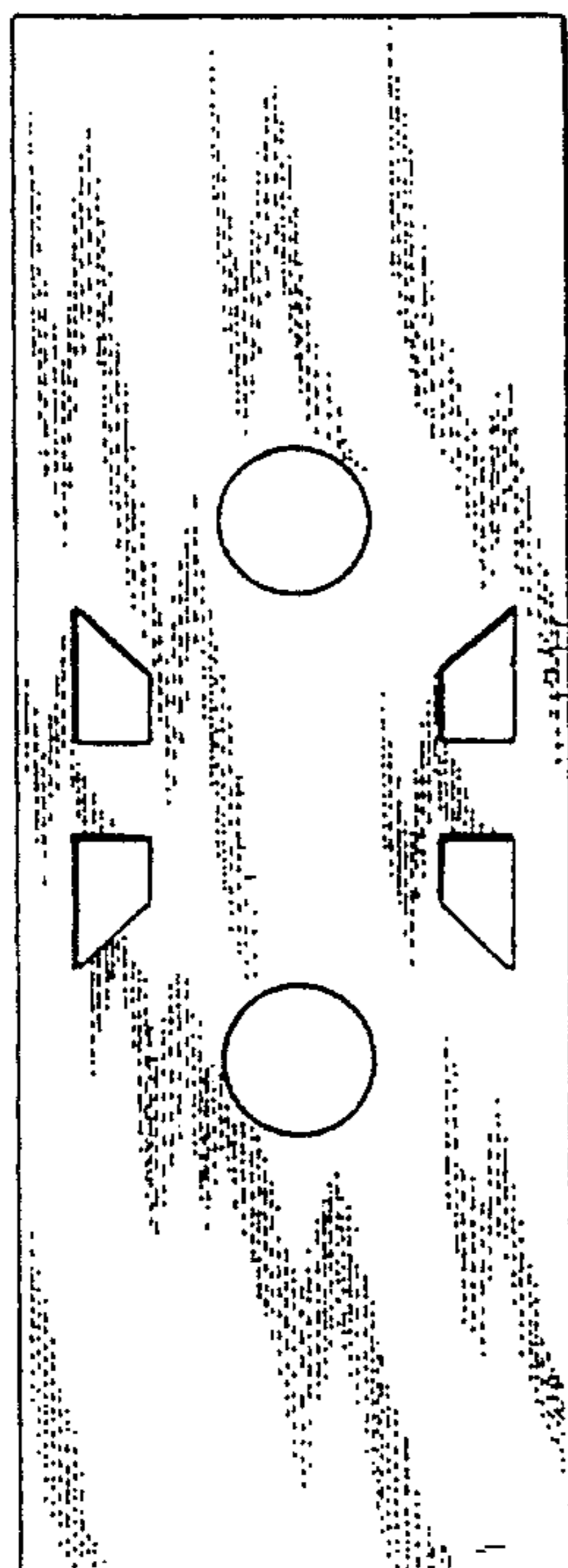
