[57] **CLAIM**

The ornamental design for a handle portion of a laundry basket, as shown and described.

DESCRIPTION

FIG. 1 is a top right front perspective view of a handle portion of a laundry basket showing my new design. The broken line showing of a laundry basket is for illustrative purposes only and forms no part of the claimed design;

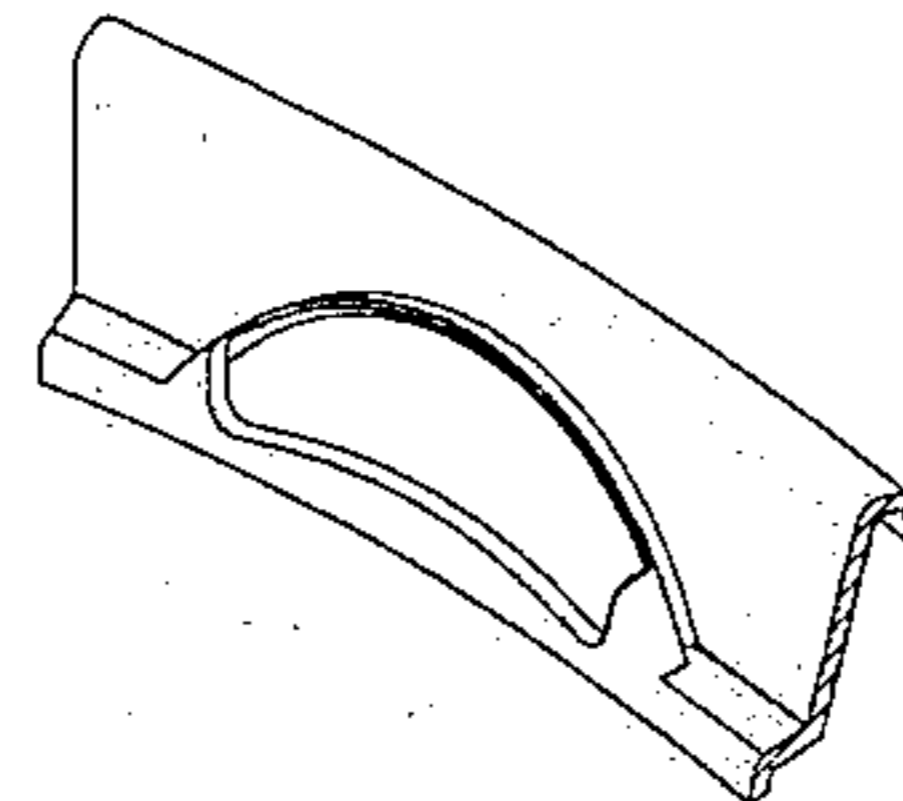


FIG. 2 is a front elevational view thereof;

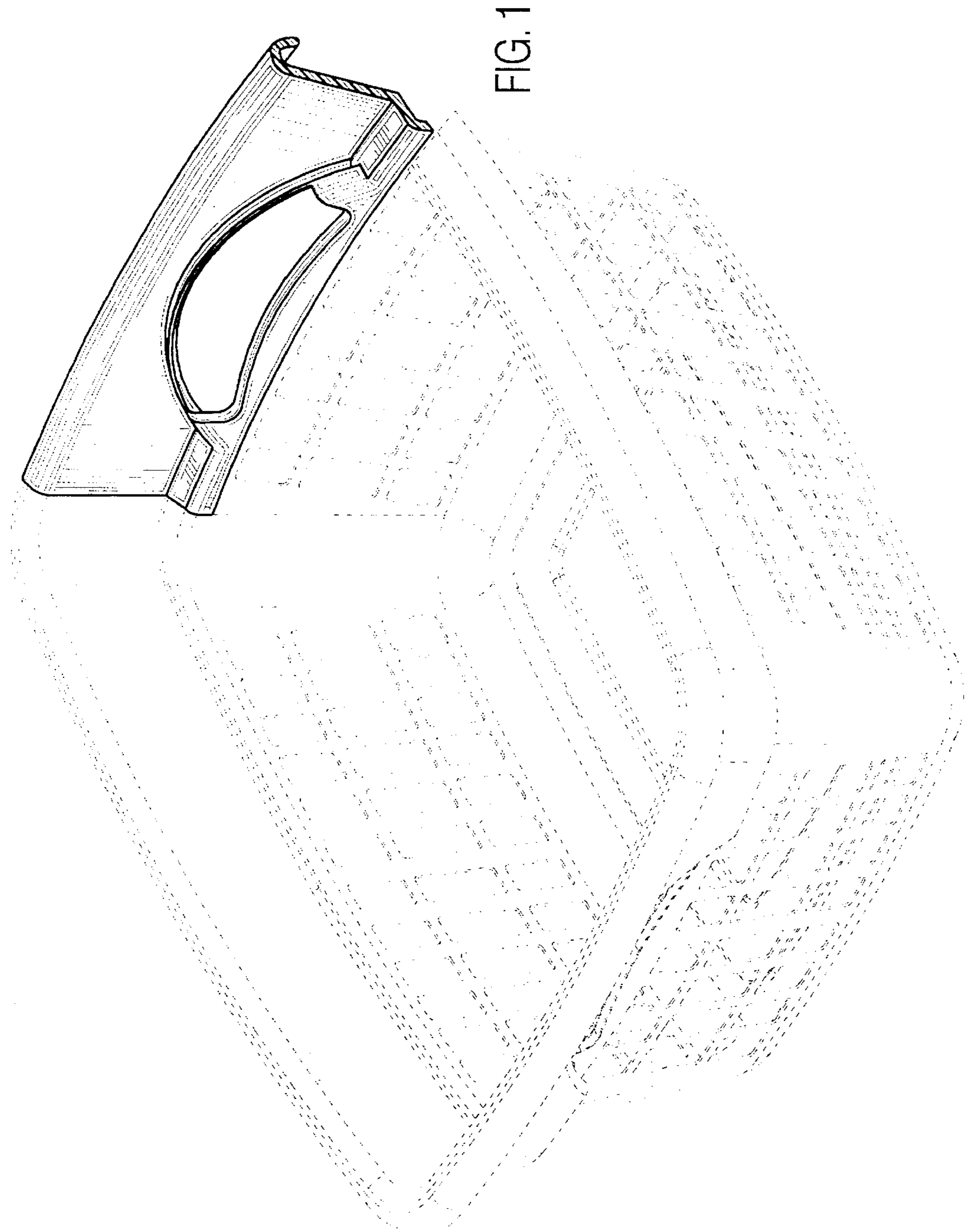

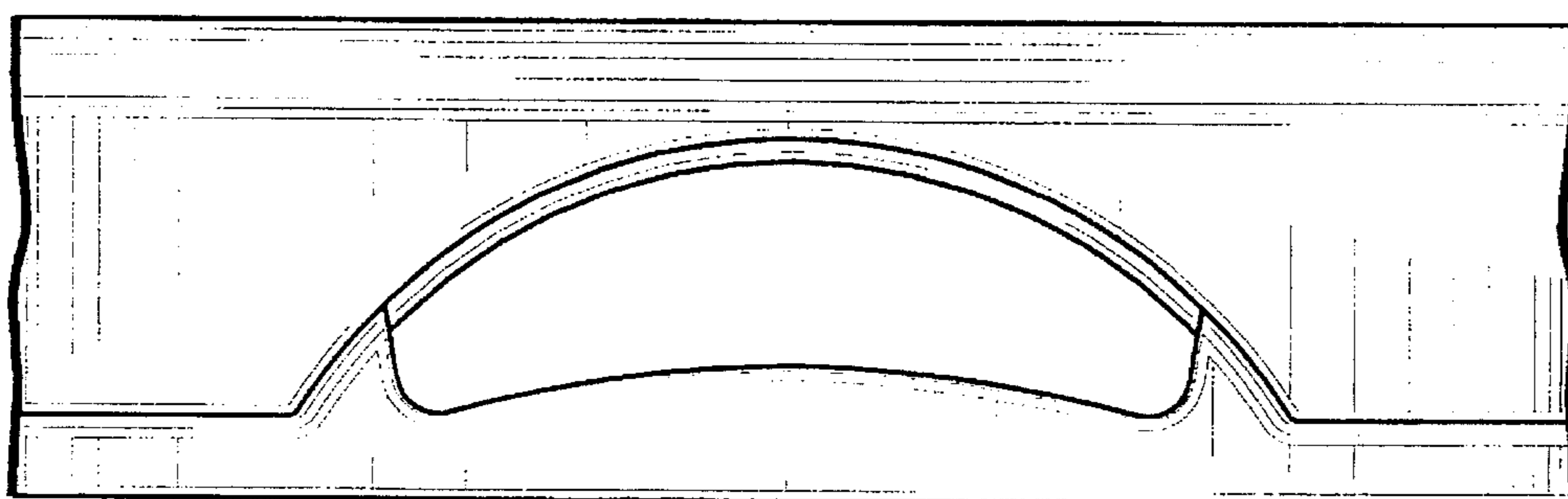

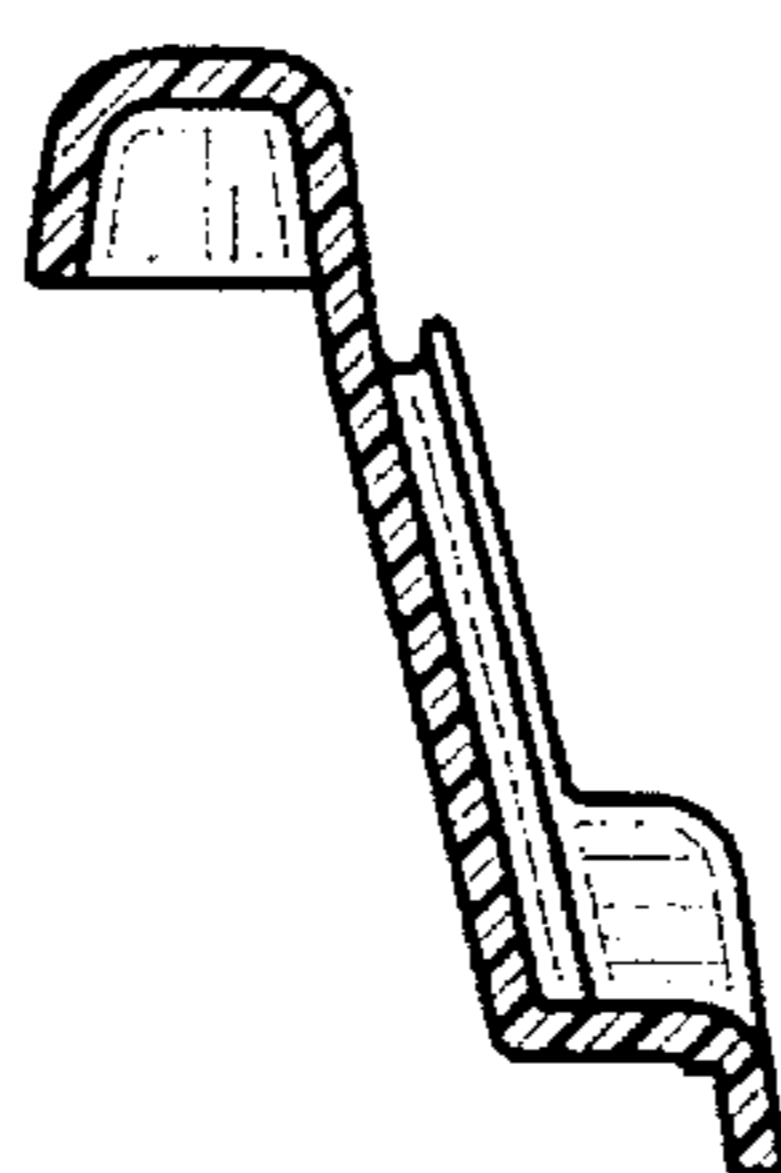

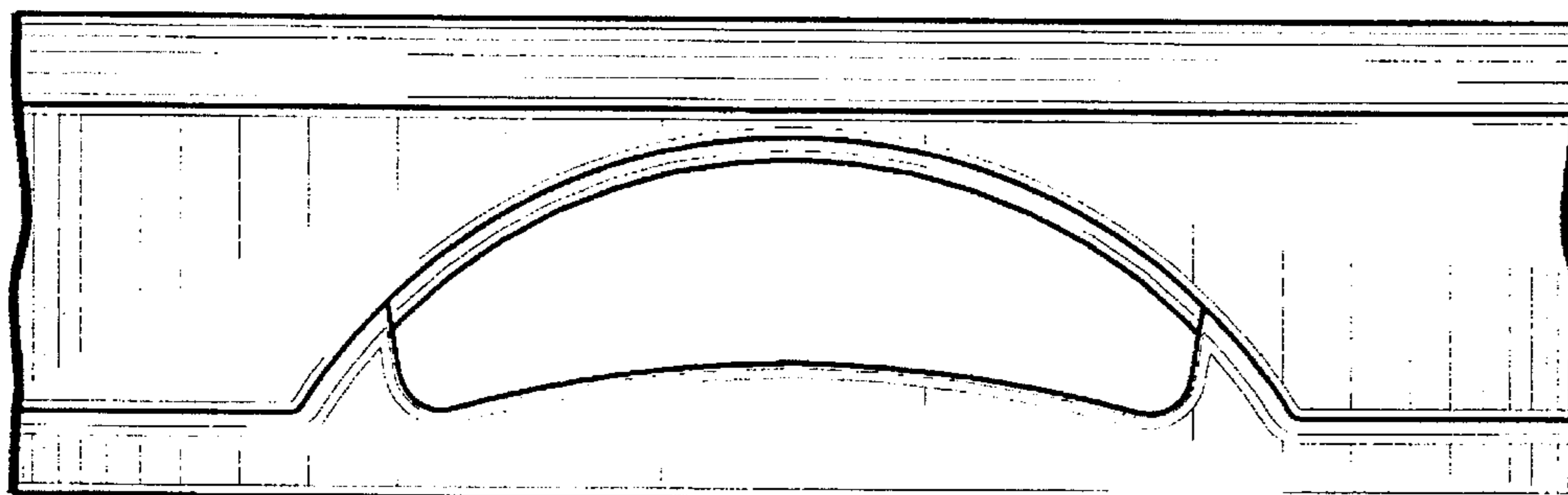

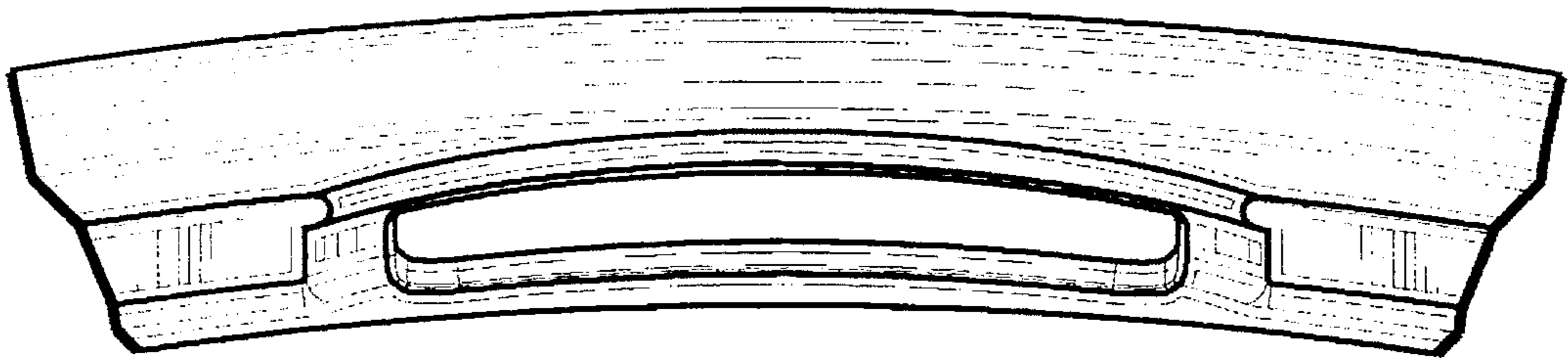

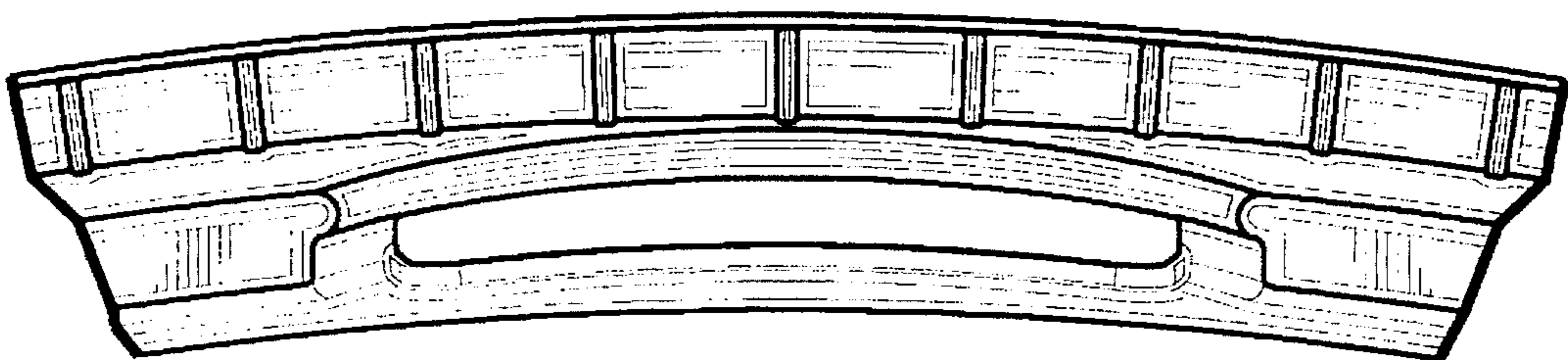
