The ornamental design for a waste container, as shown and

DESCRIPTION

FIG. 1 is a top left front perspective view of a waste
container showing our new design;

FIG. 2 is a right side elevational view thereof, the left side
elevational view being a mirror image;

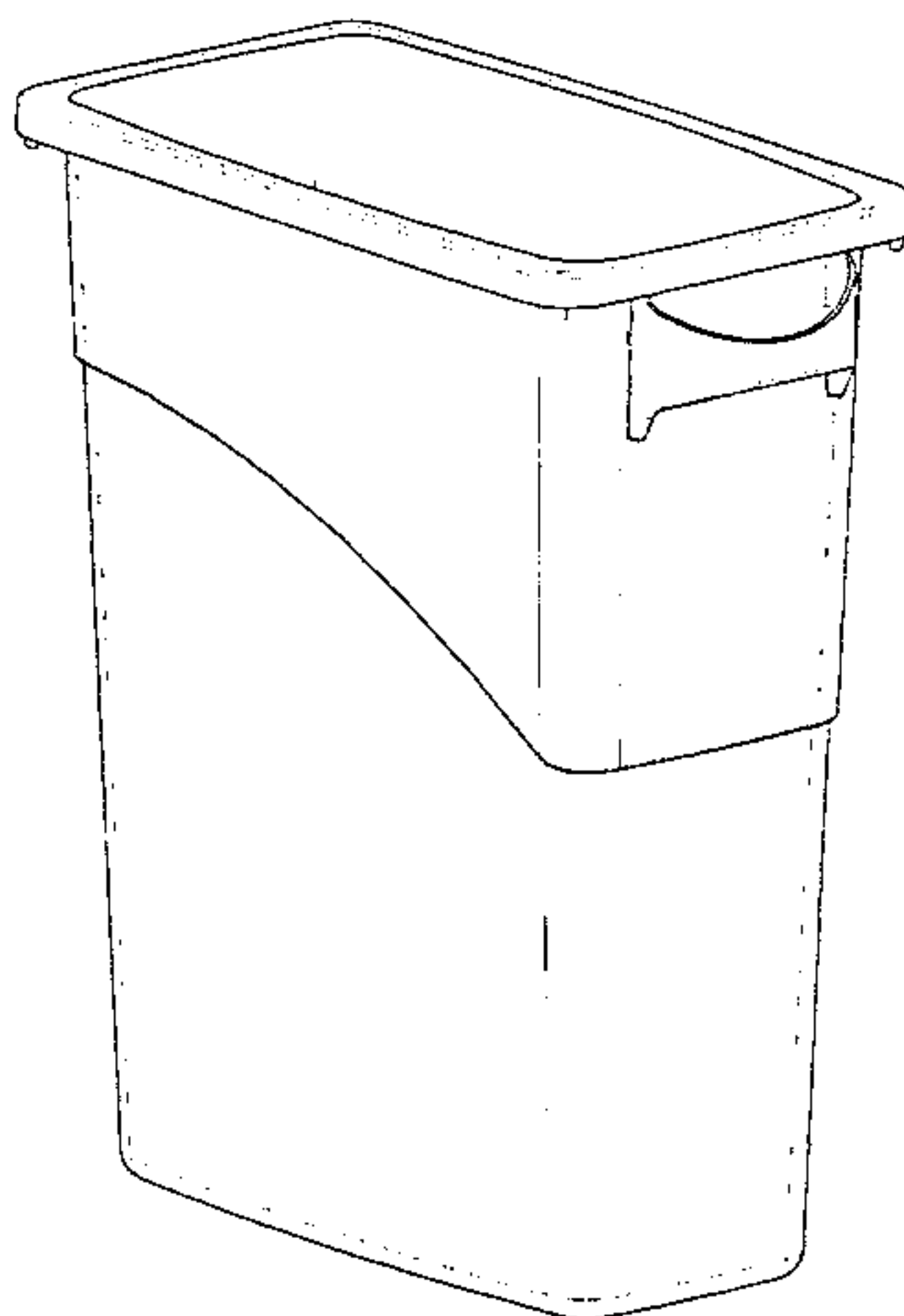
FIG. 3 is a rear elevational view thereof;

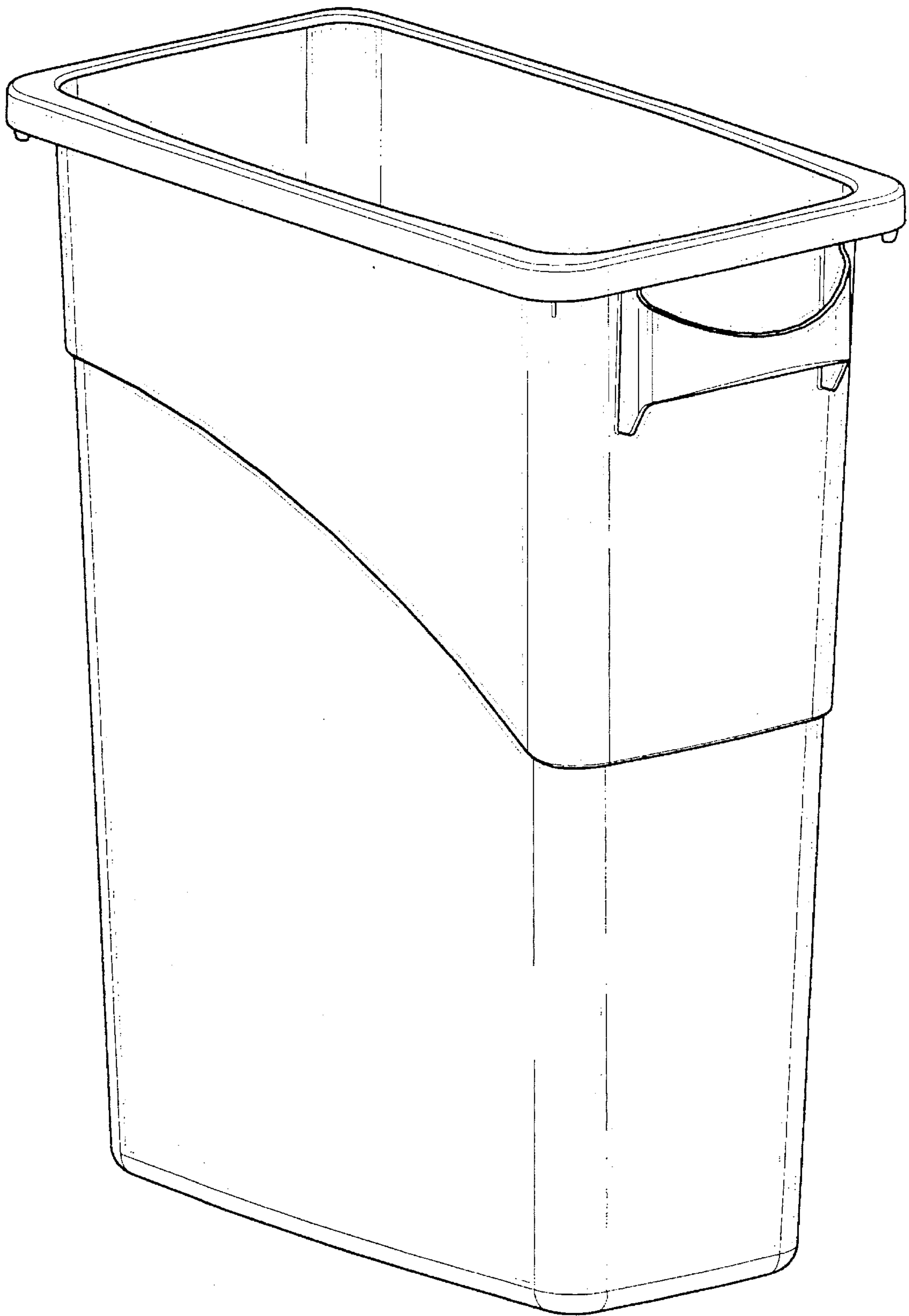

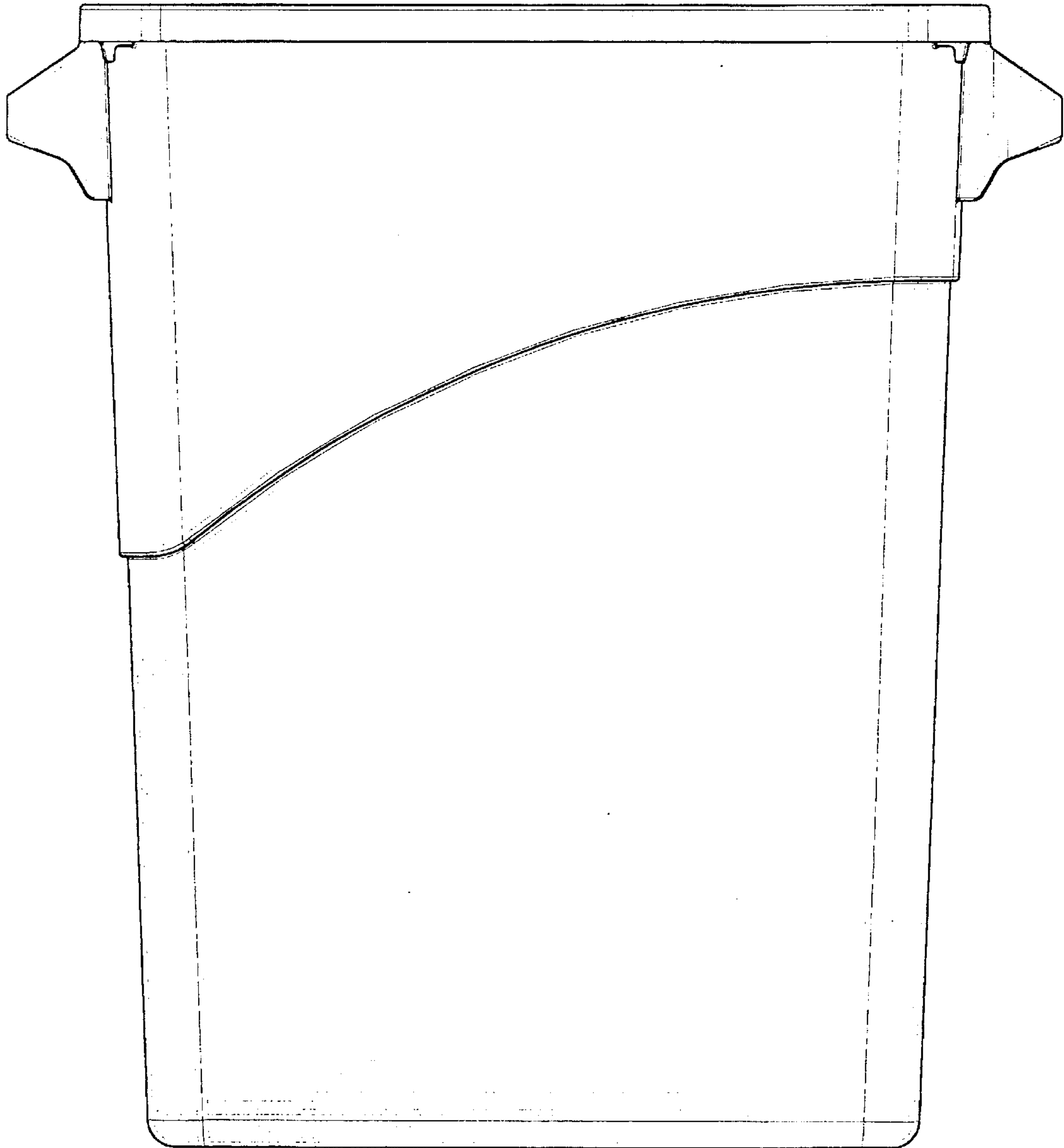

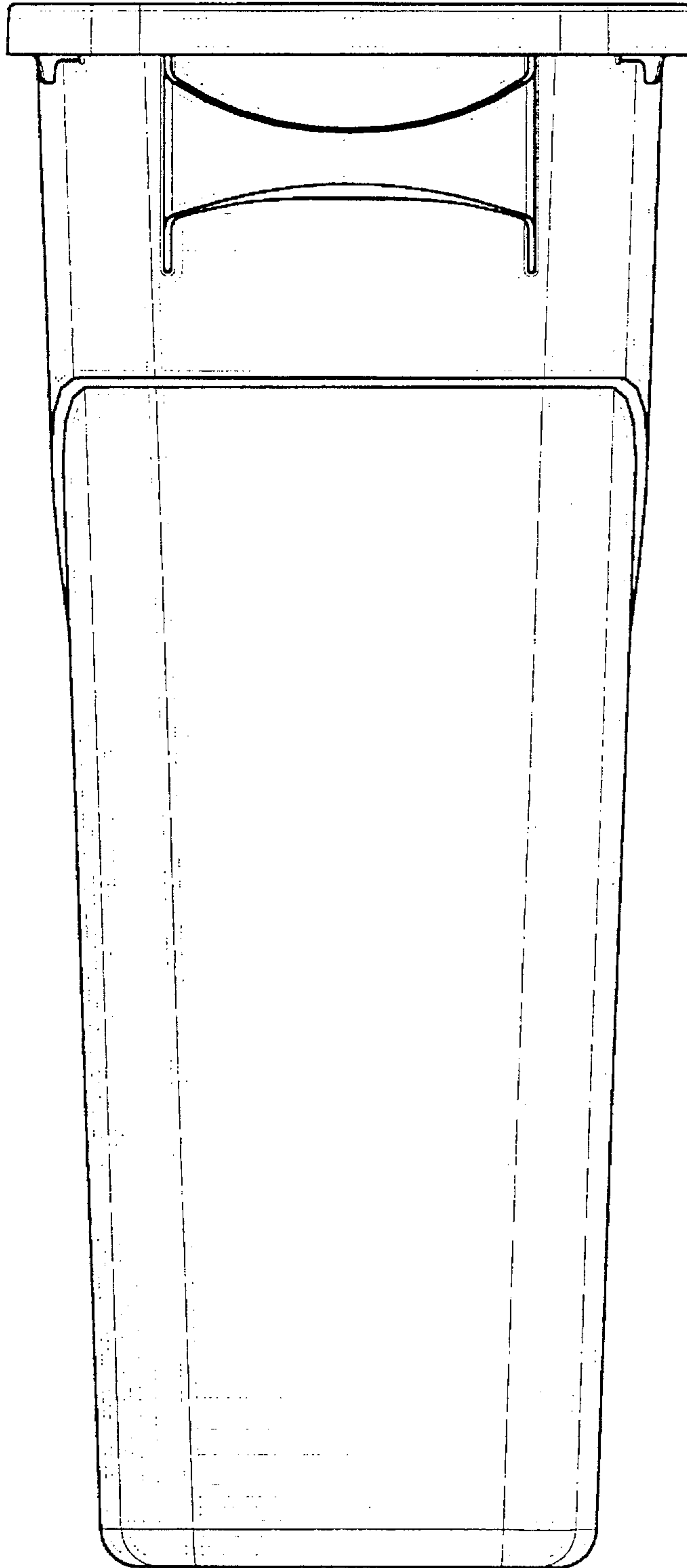

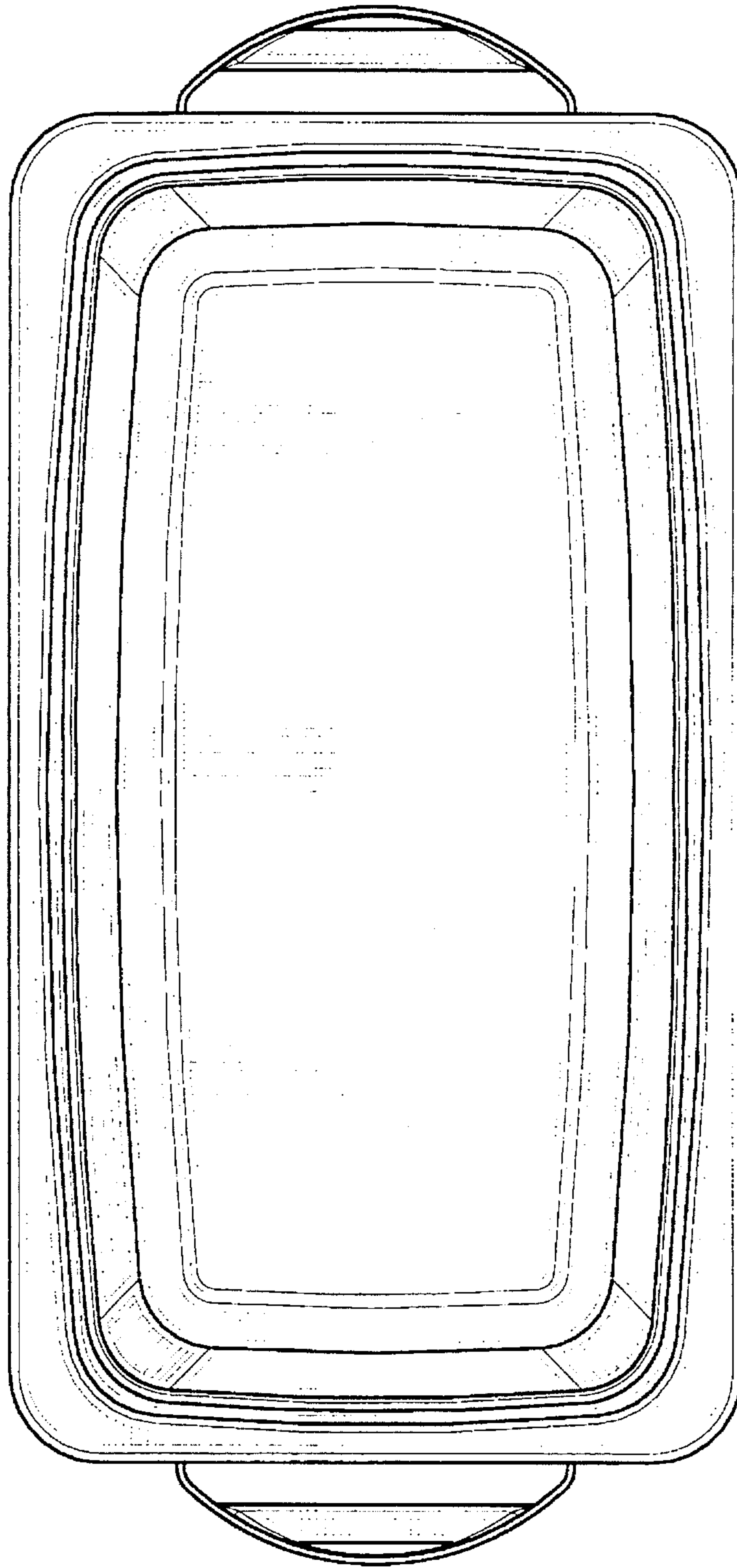

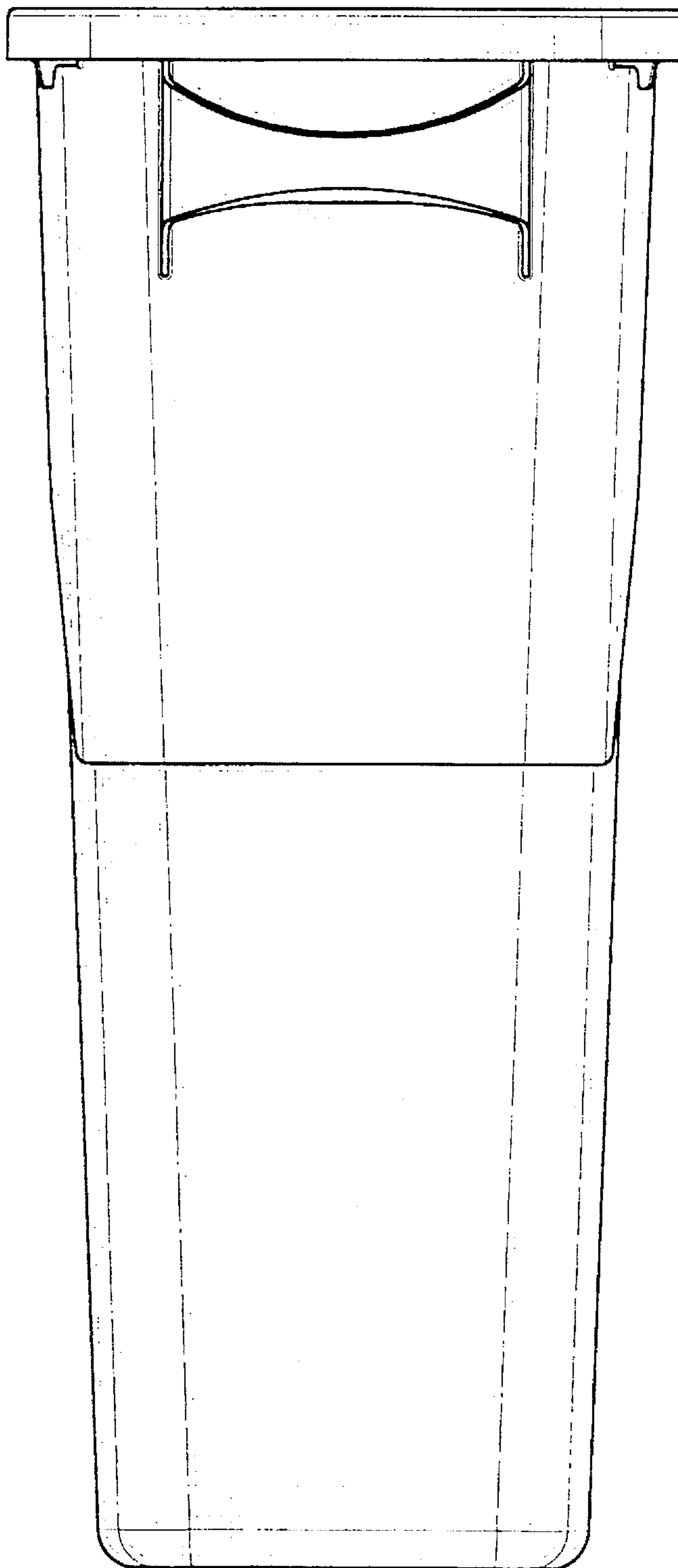
