FIG. 4 is a right view end thereof;

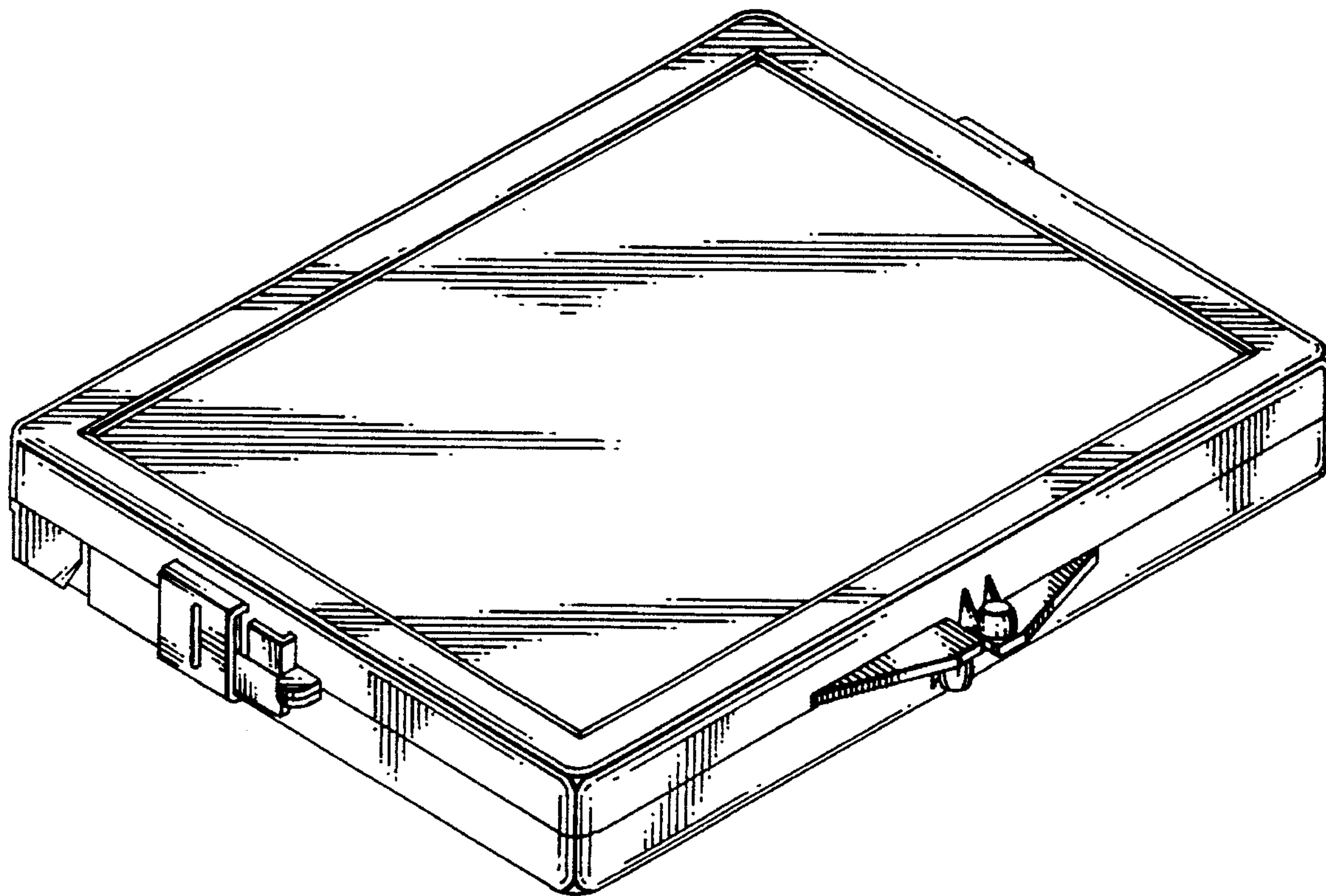
FIG. 5 is a bottom view thereof;

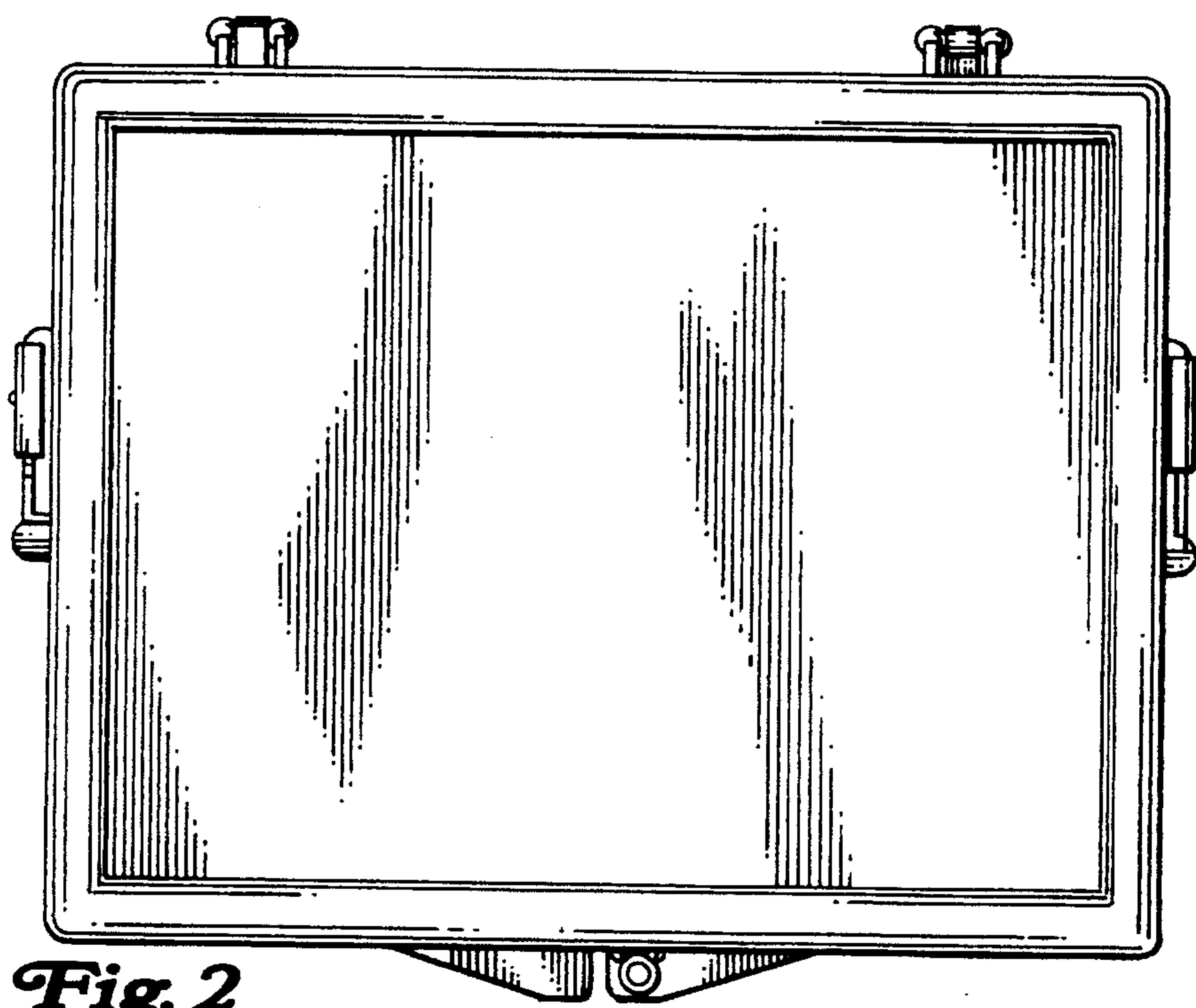
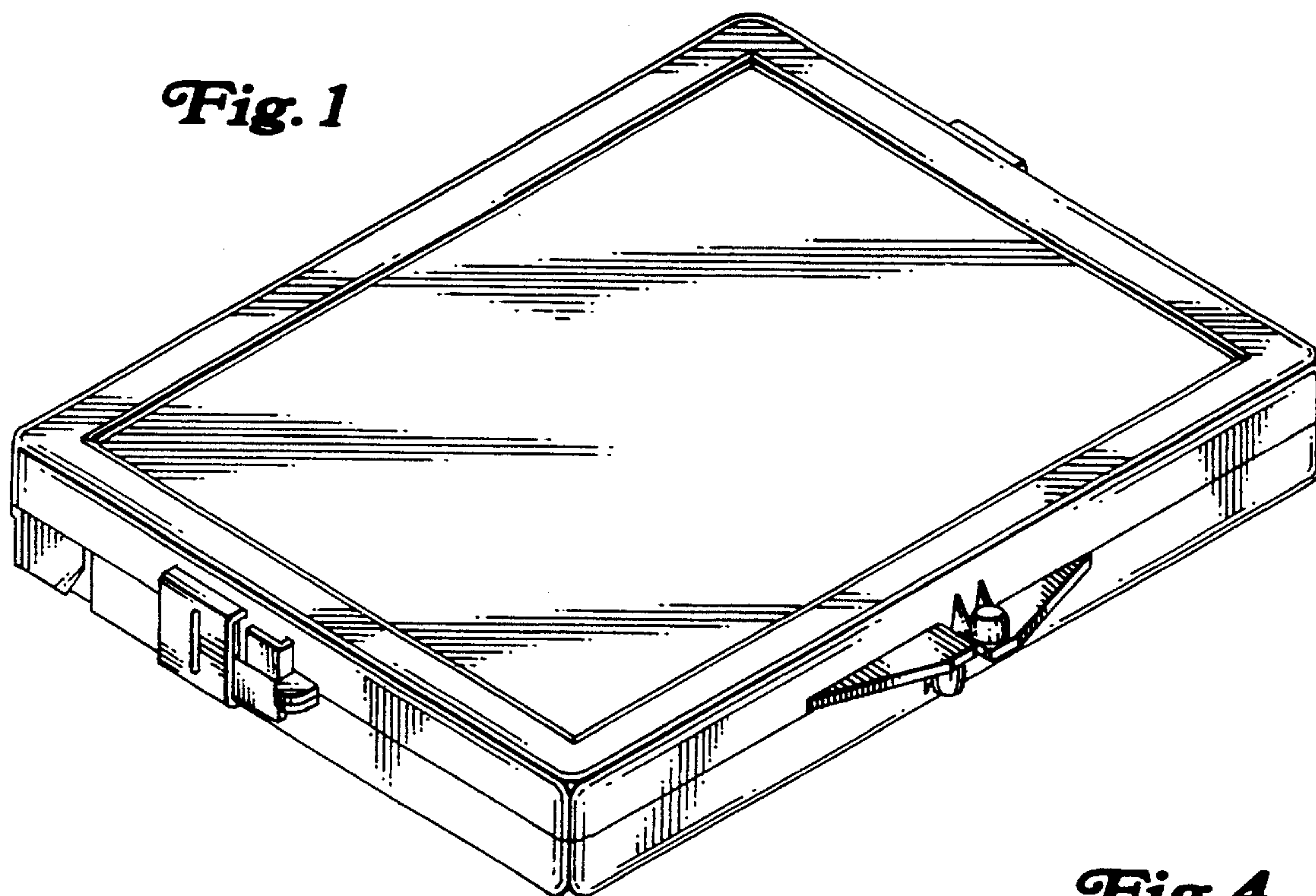
FIG. 6 is a left end view thereof;

FIG. 7 is a rear view thereof; and,

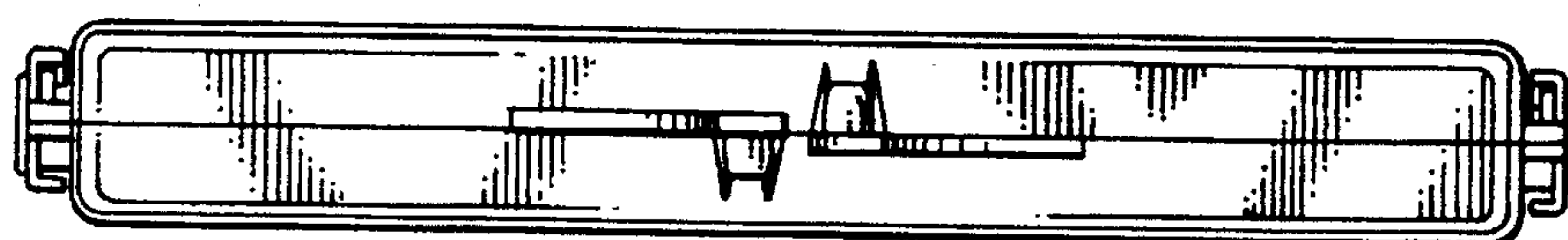
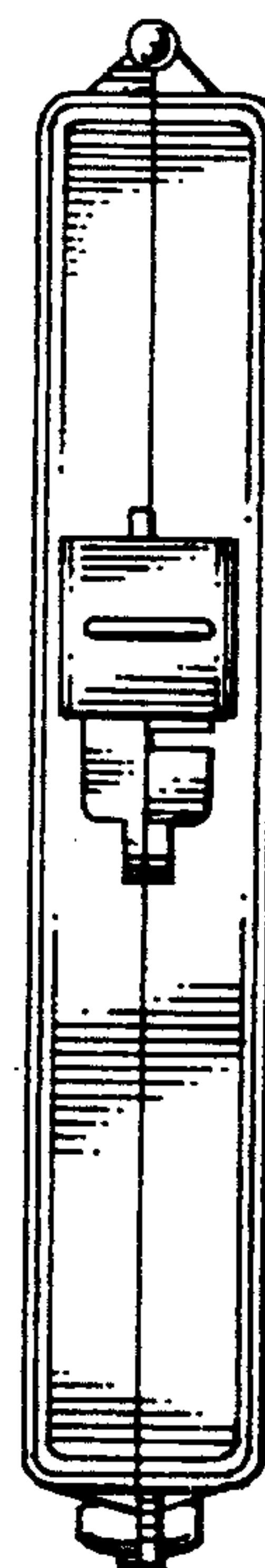
FIG. 8 is a right end view thereof, similar to FIG. 4, but showing the latch in an alternative position.

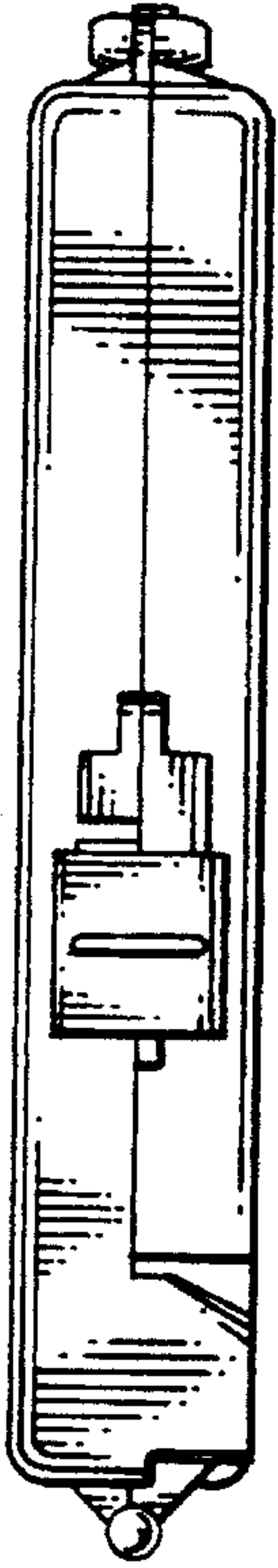

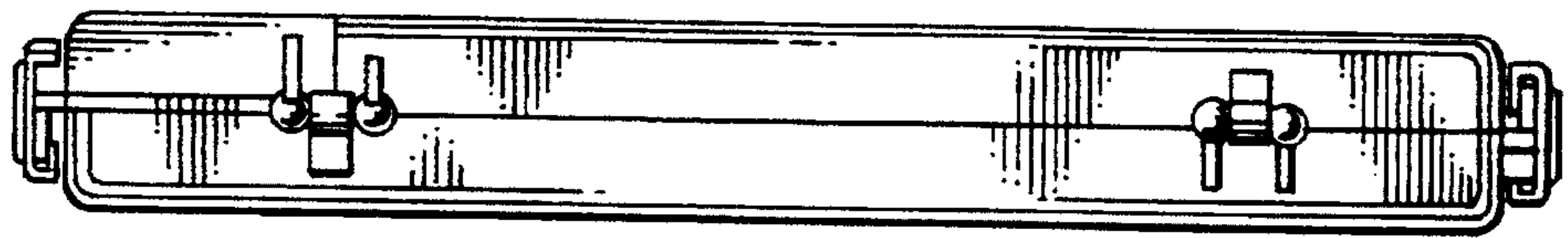
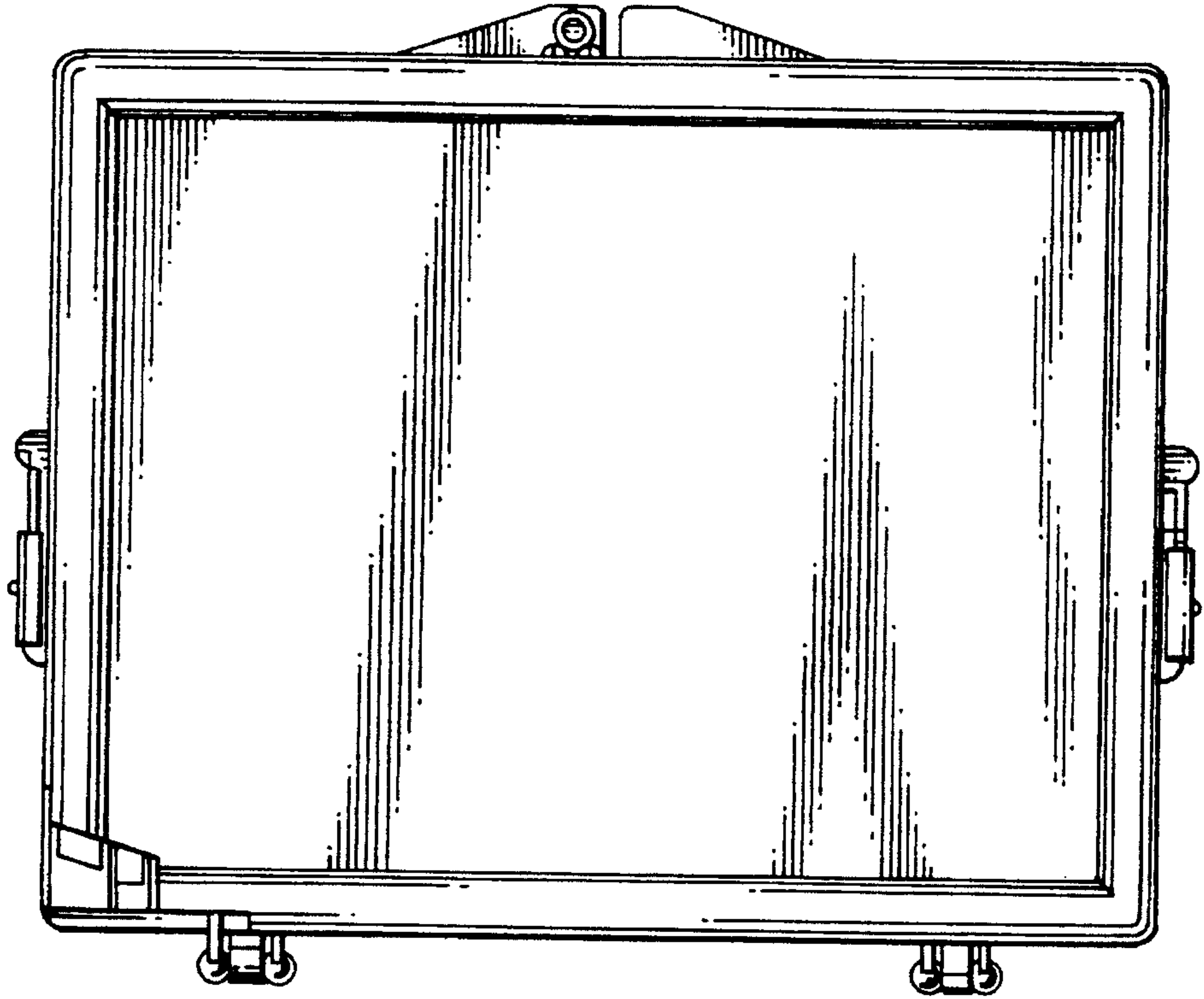




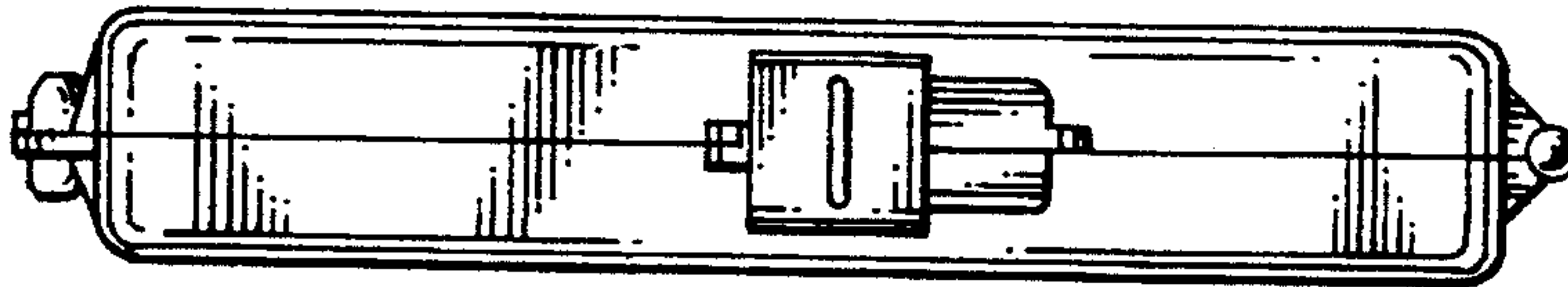
