[57] CLAIM

The ornamental design for an outsole for an athletic shoe, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevational view of an outsole for an athletic shoe showing our new design, the broken lines showing a shoe upper or a portion thereof in FIGS. 1 through 4 and 7, being for illustrative purposes only and forming no part of the claimed design;

FIG. 2 is a bottom plan view thereof;

FIG. 3 is a left side elevational view thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a front elevational view thereof;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a right side elevational view of an alternate embodiment of the design shown in FIG. 1;

FIG. 8 is a bottom plan view of FIG. 7;

FIG. 9 is a left side elevaitonal view of FIG. 7;

FIG. 10 is a top plan view of FIG. 7;

FIG. 11 is a front elevational view of FIG. 7; and,

FIG. 12 is a rear elevational view of FIG. 7.

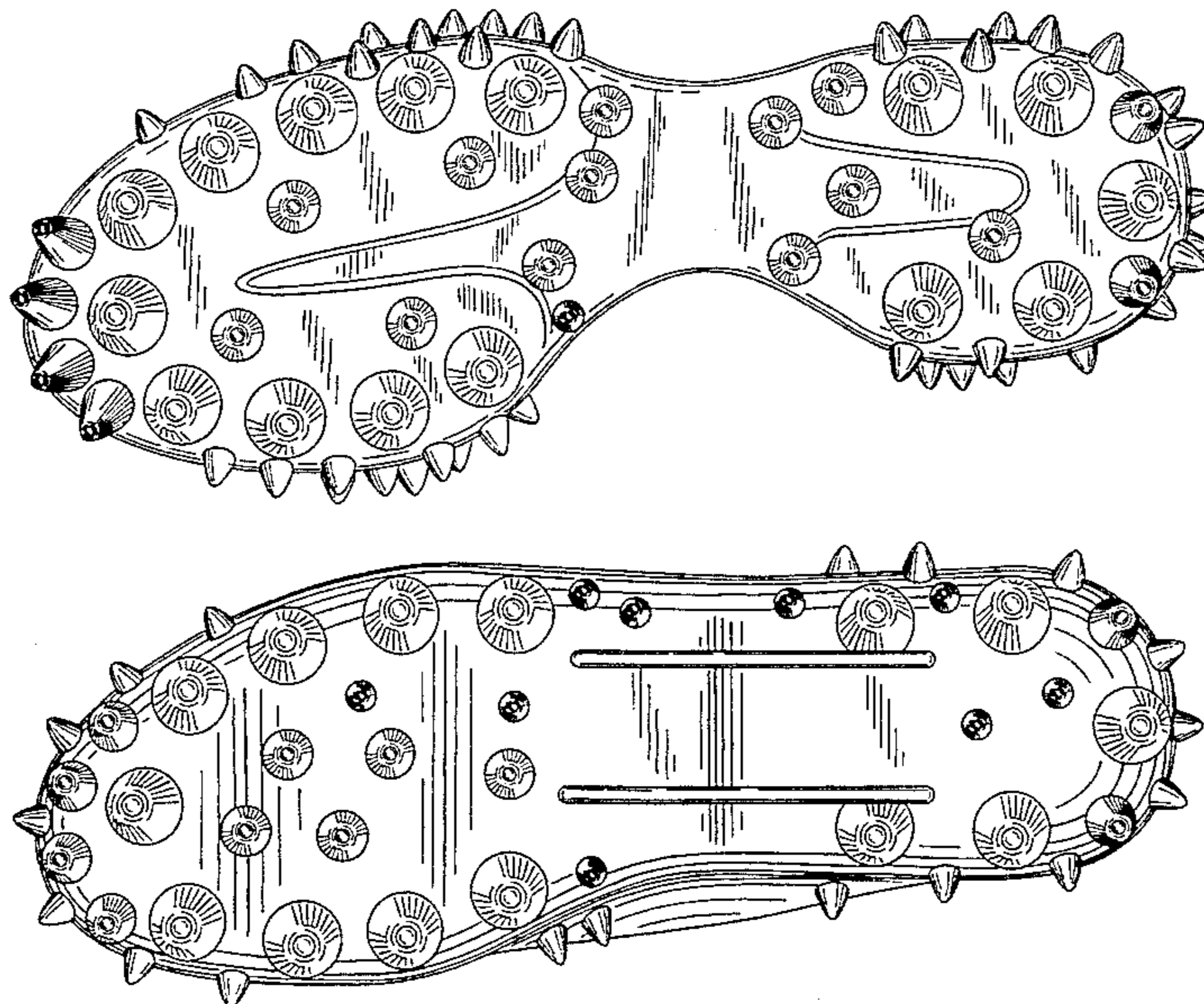

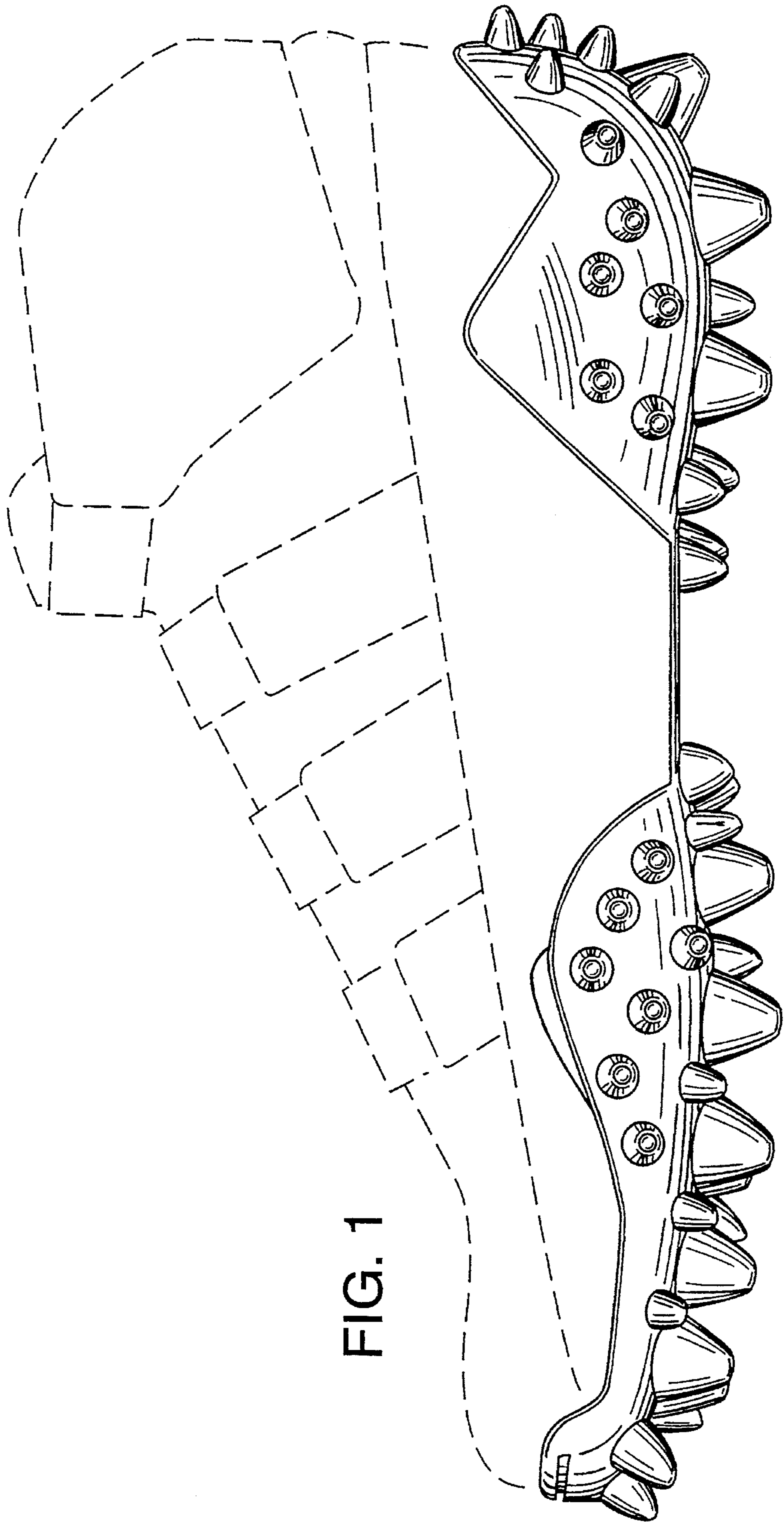

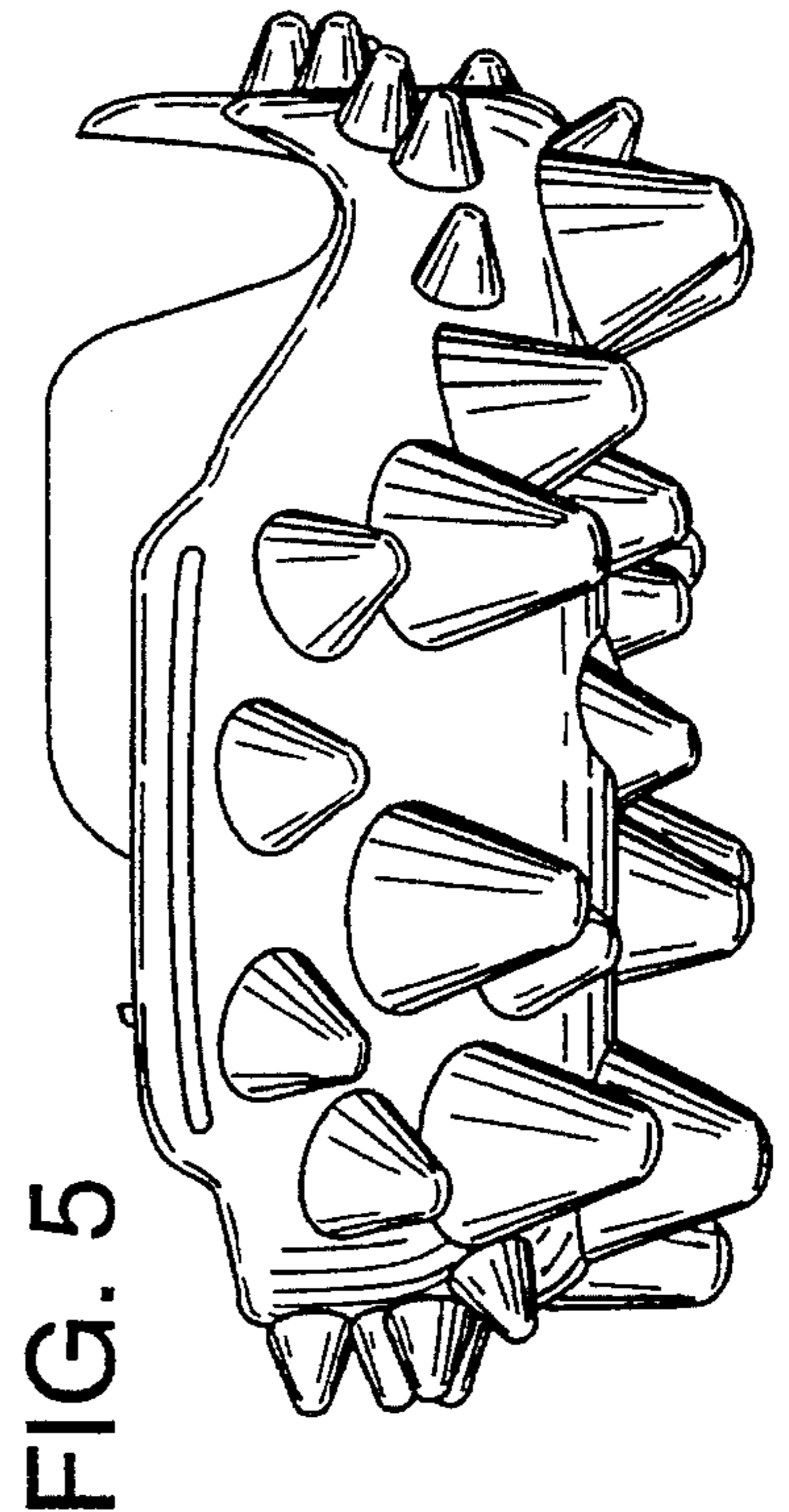
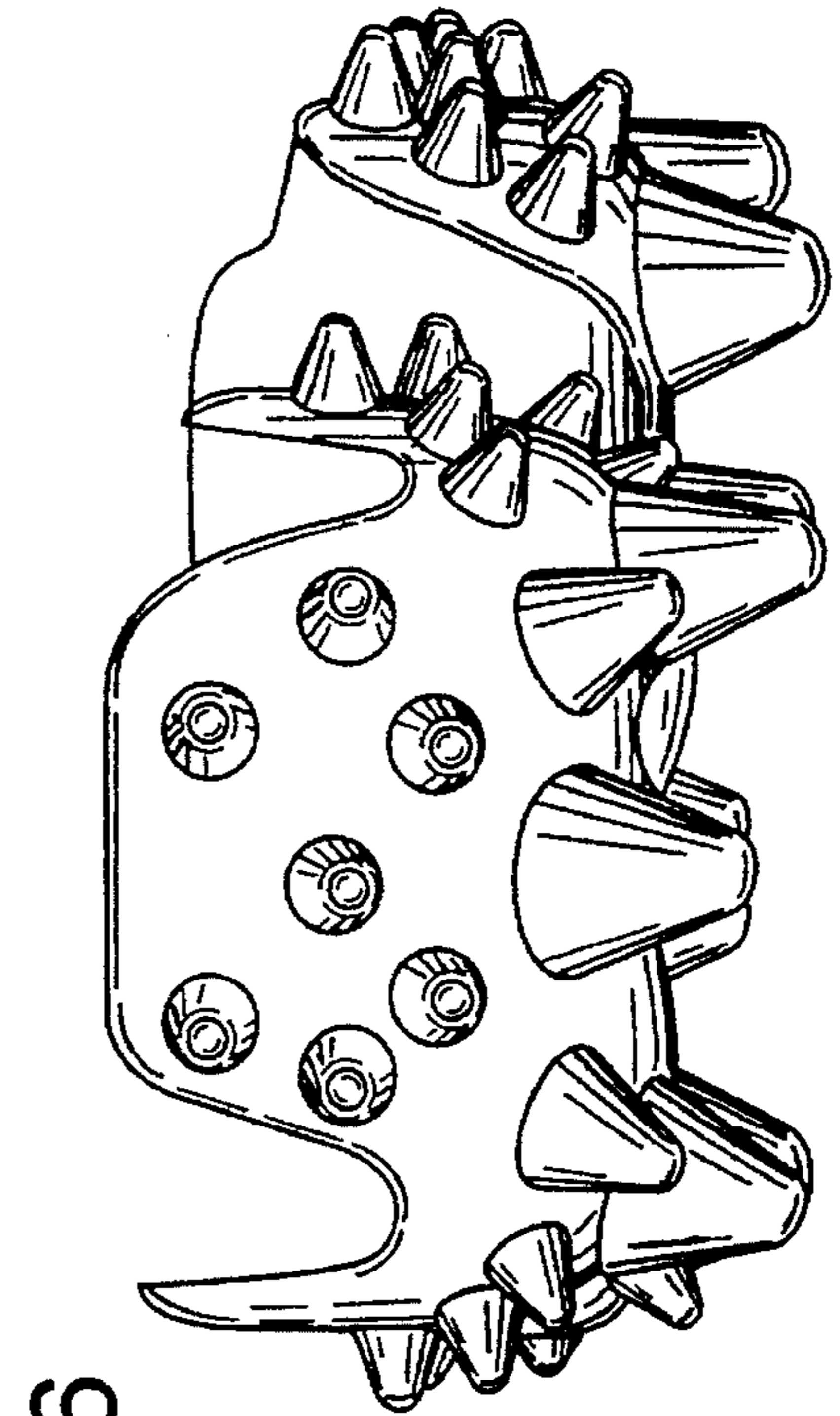
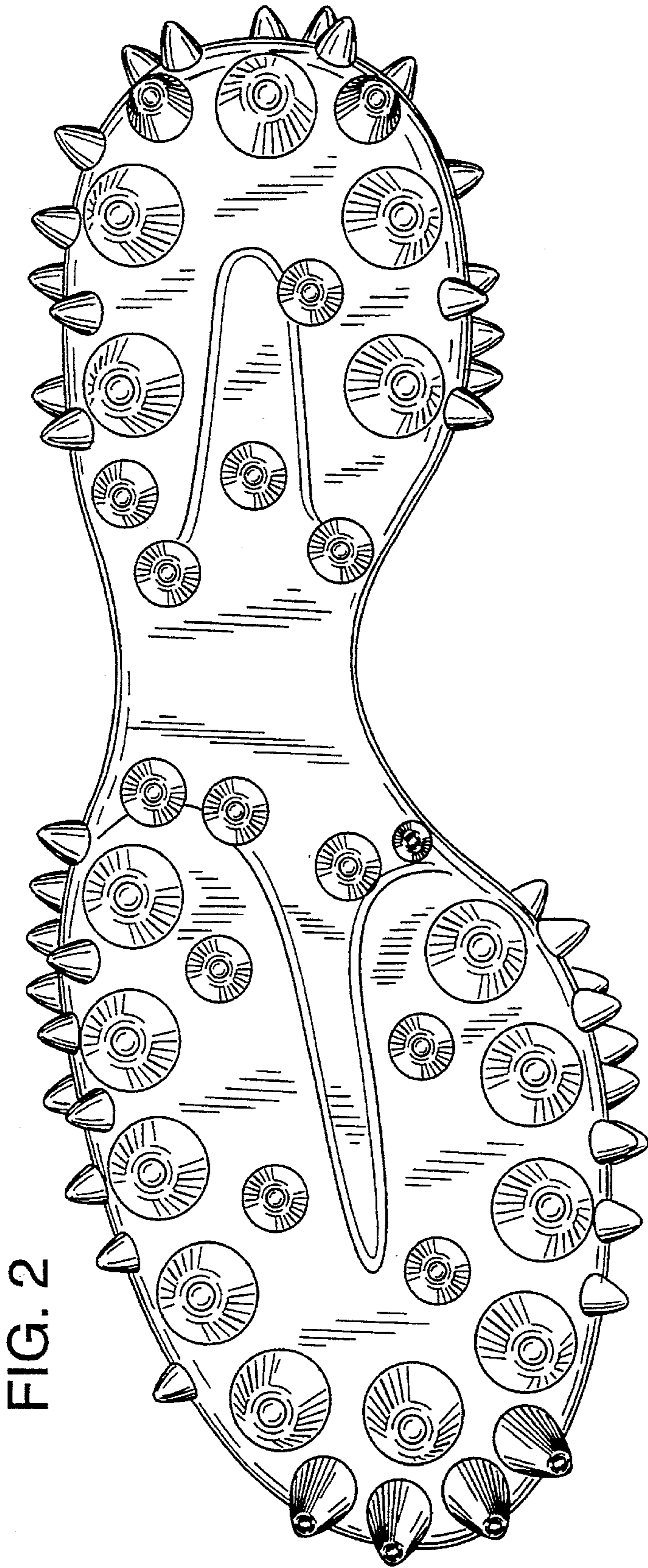

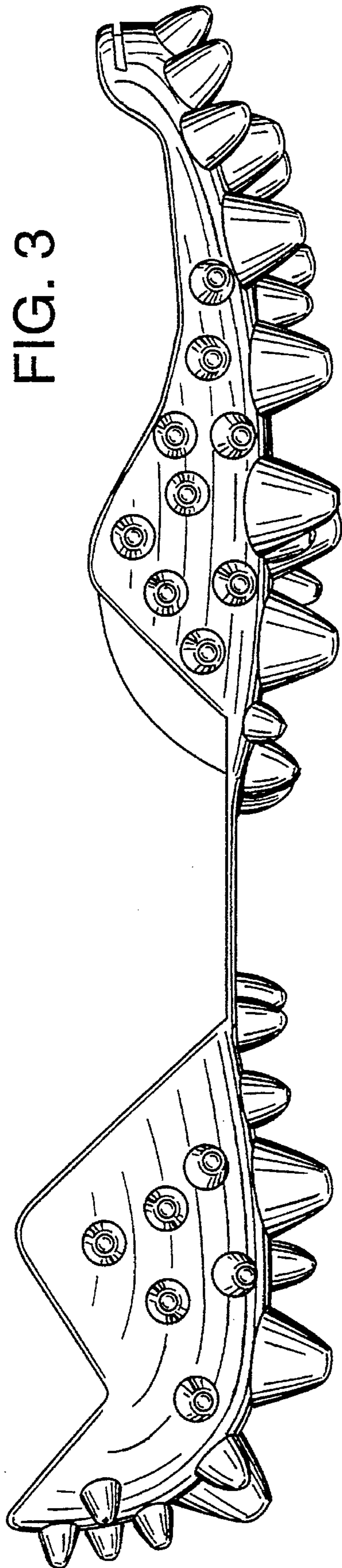
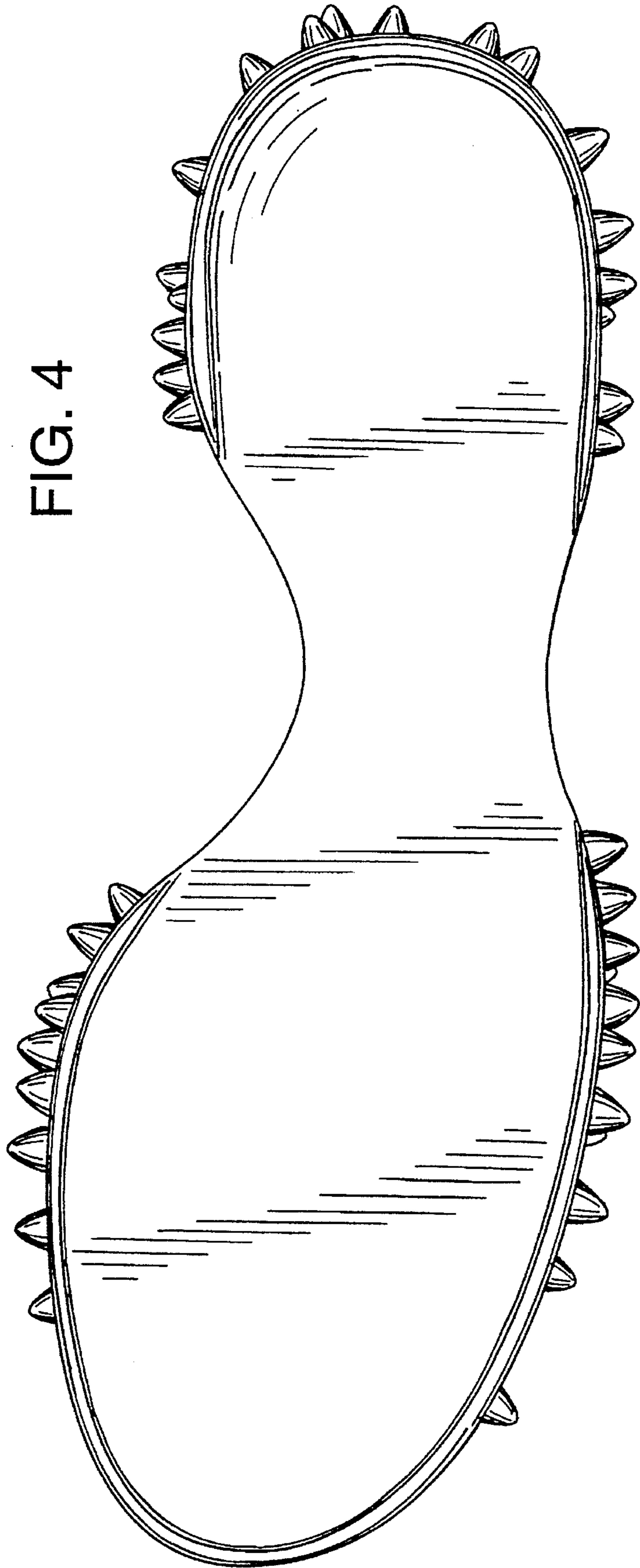

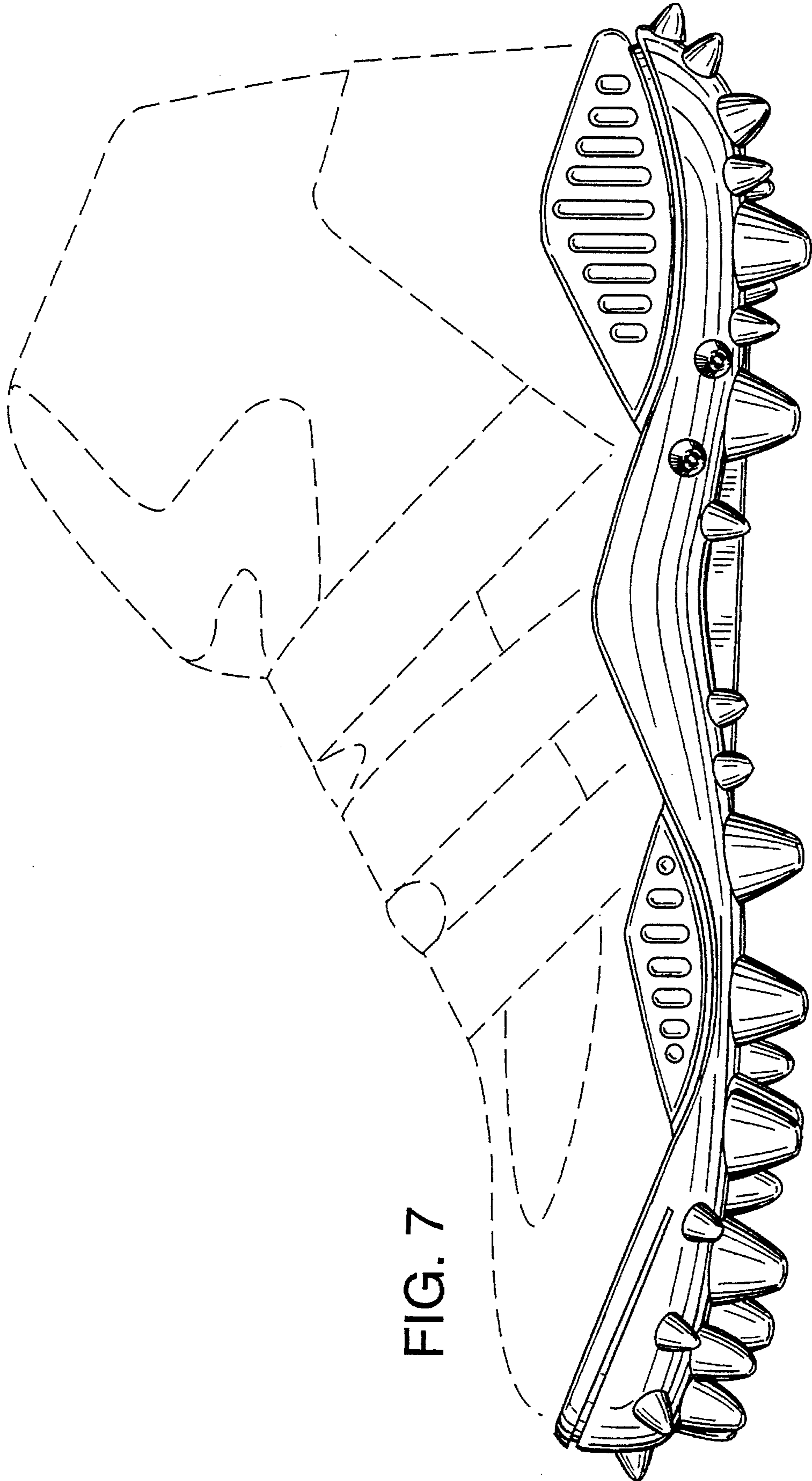

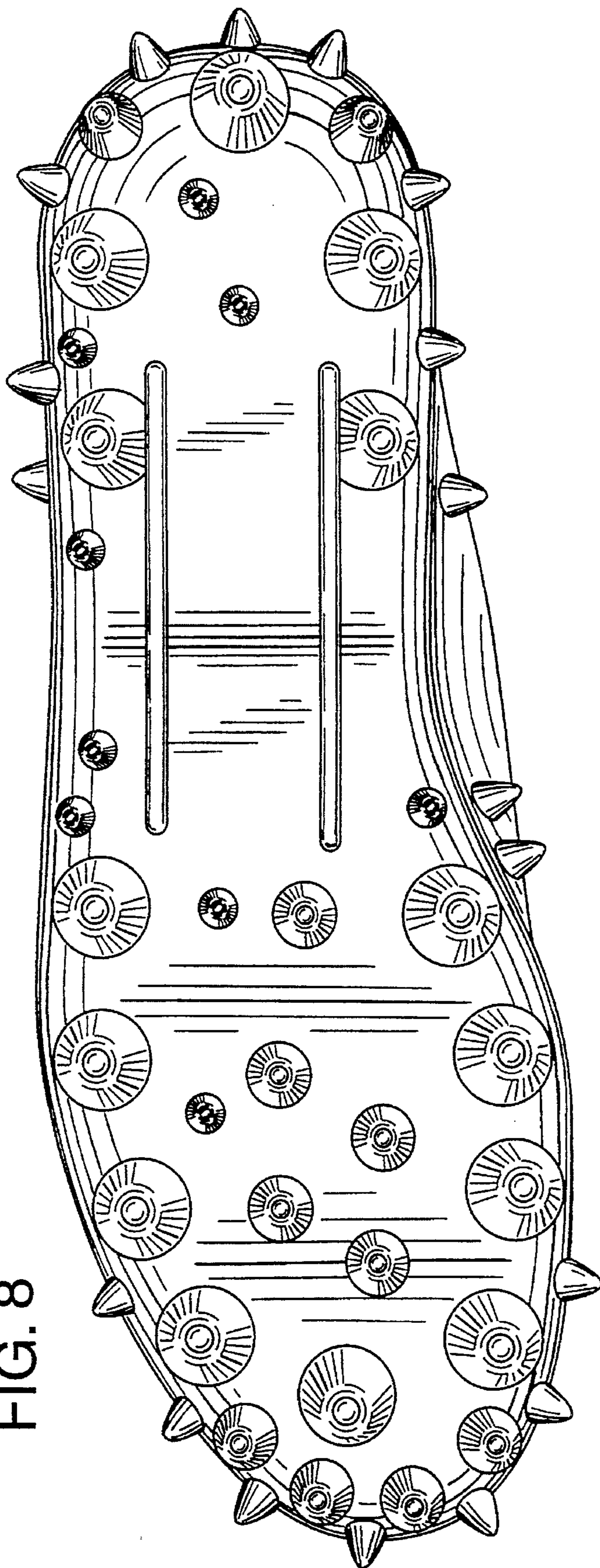

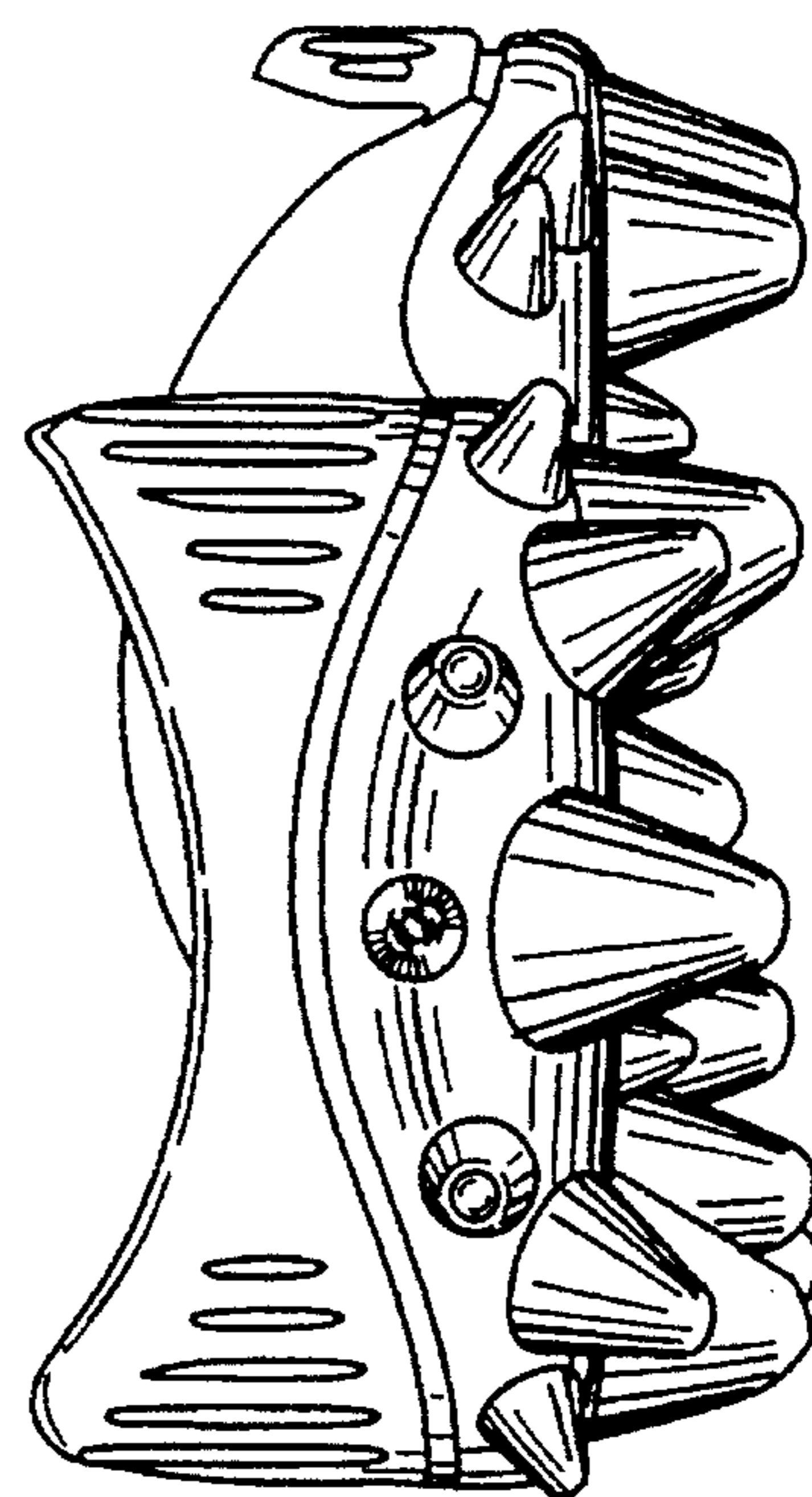

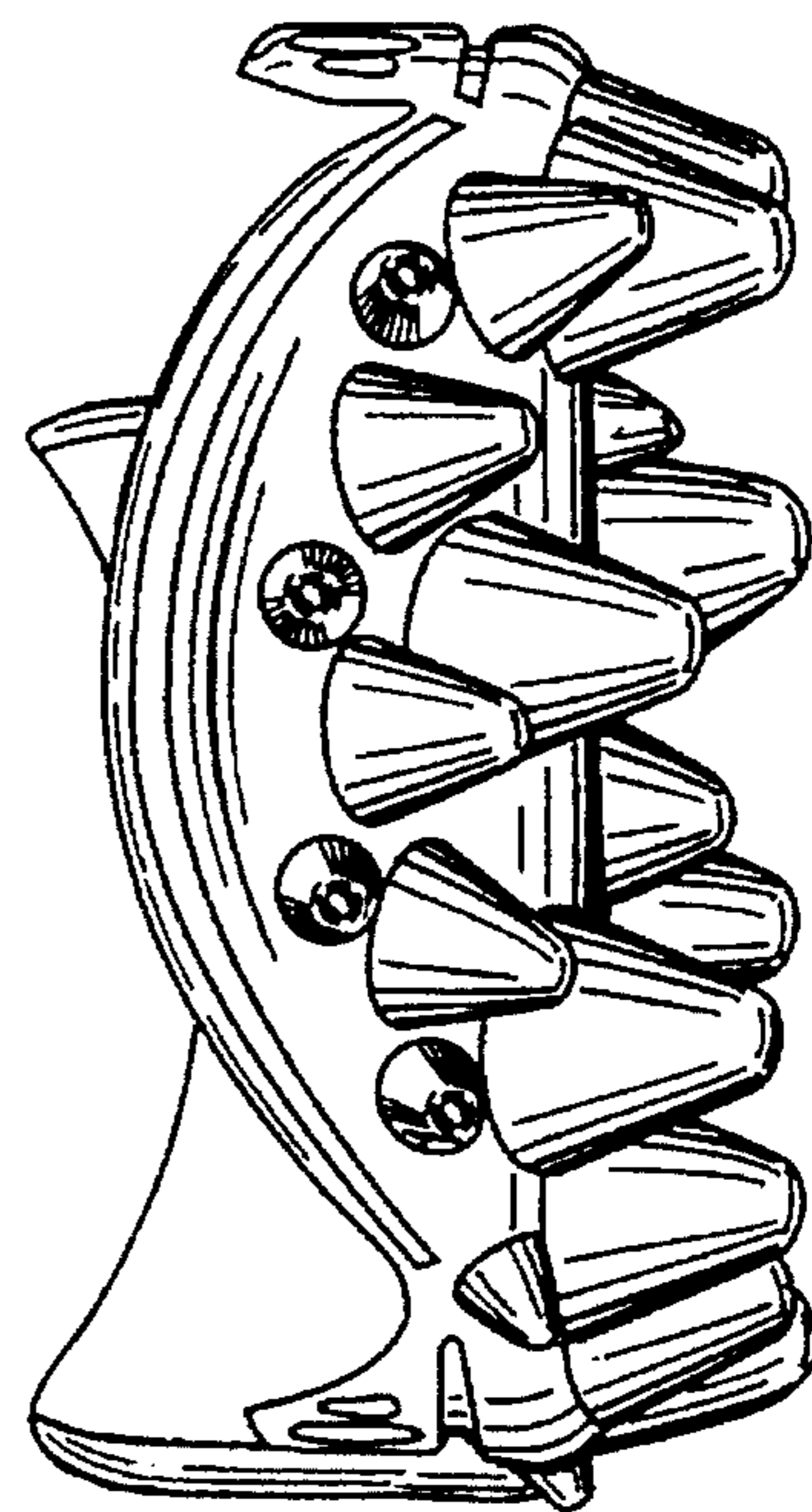

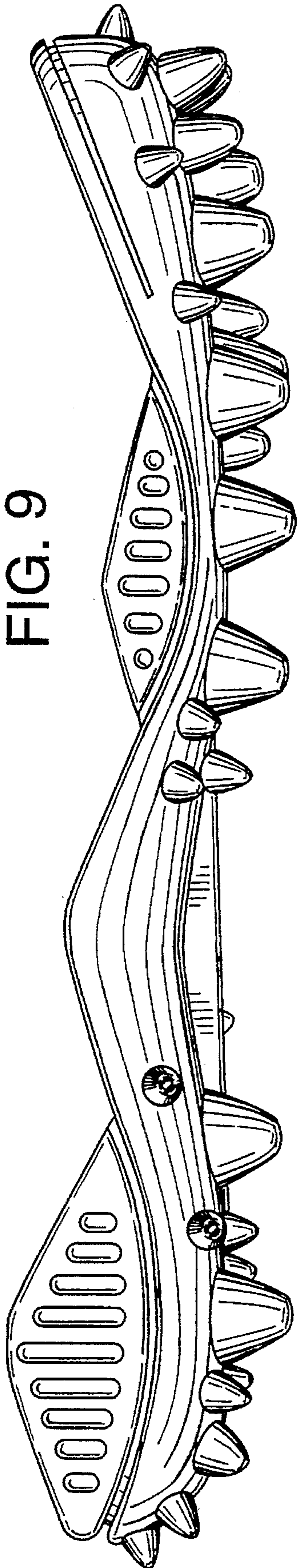
