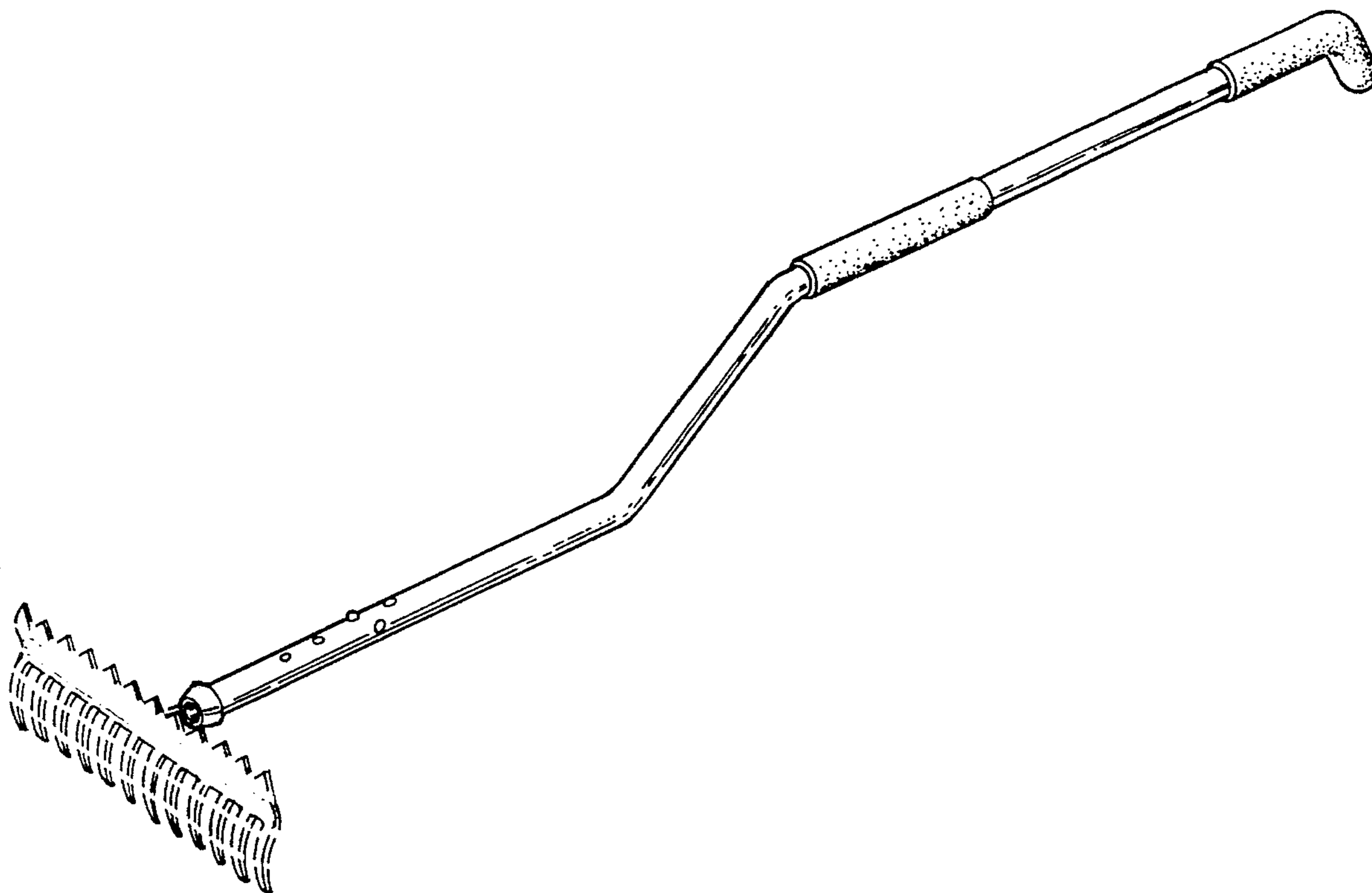
[57] CLAIM

The ornamental design for a tool handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tool handle showing our new design, the broken-line disclosure of a rake head being for illustrative purposes only and forming no part of the claimed design;
FIG. 2 is a top end view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a rear elevational view thereof; and,
FIG. 7 is a bottom end view thereof.

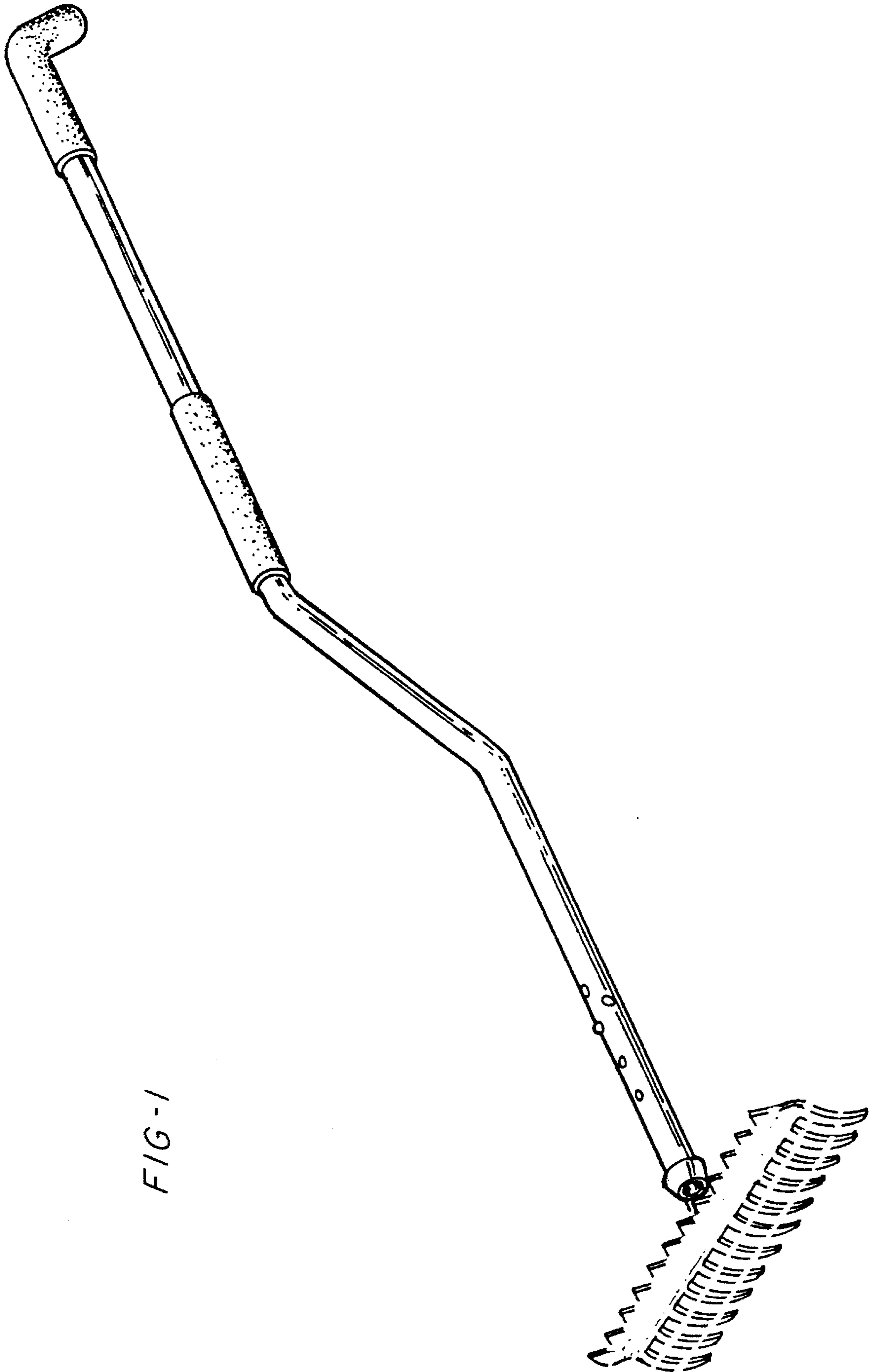

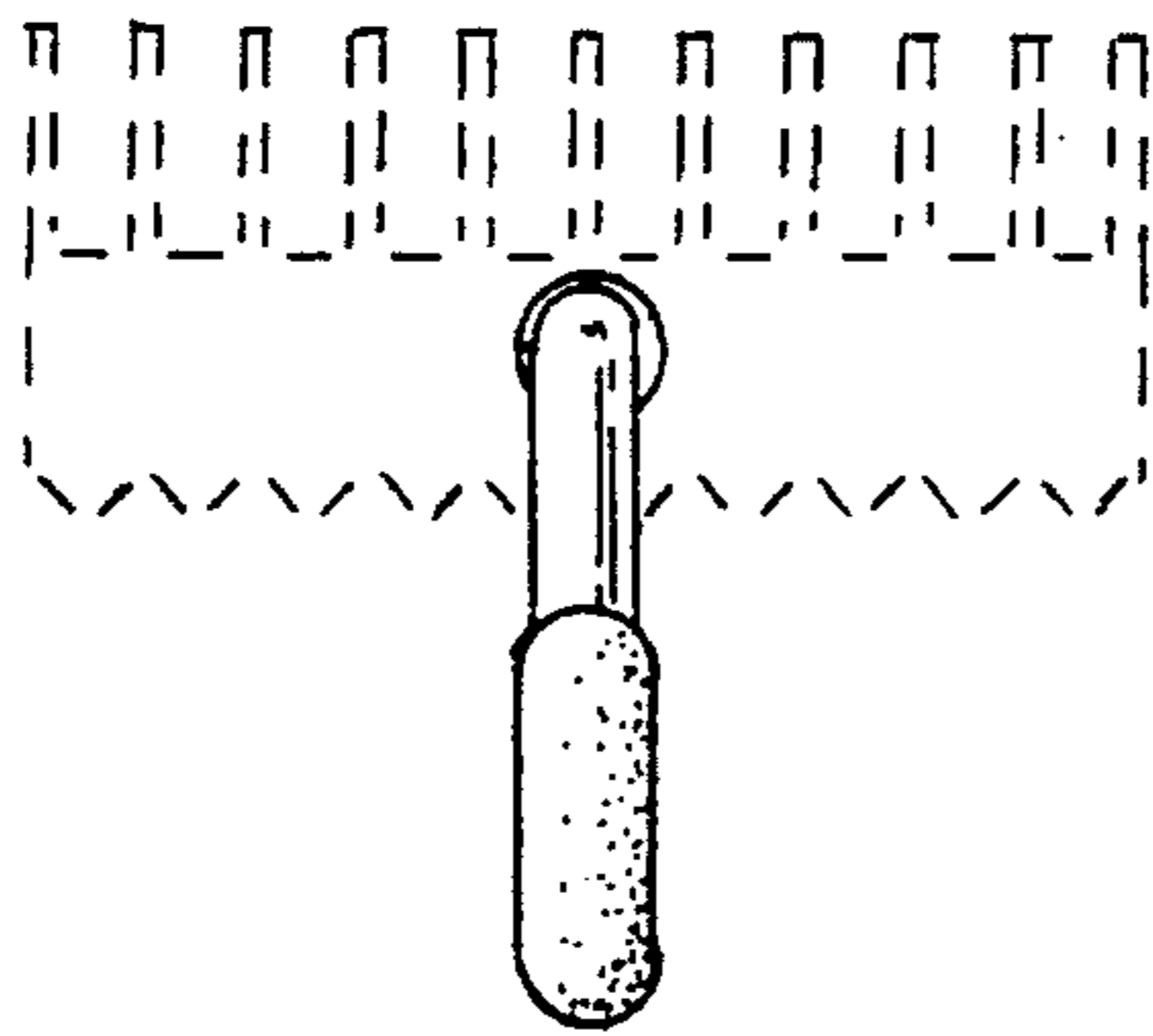

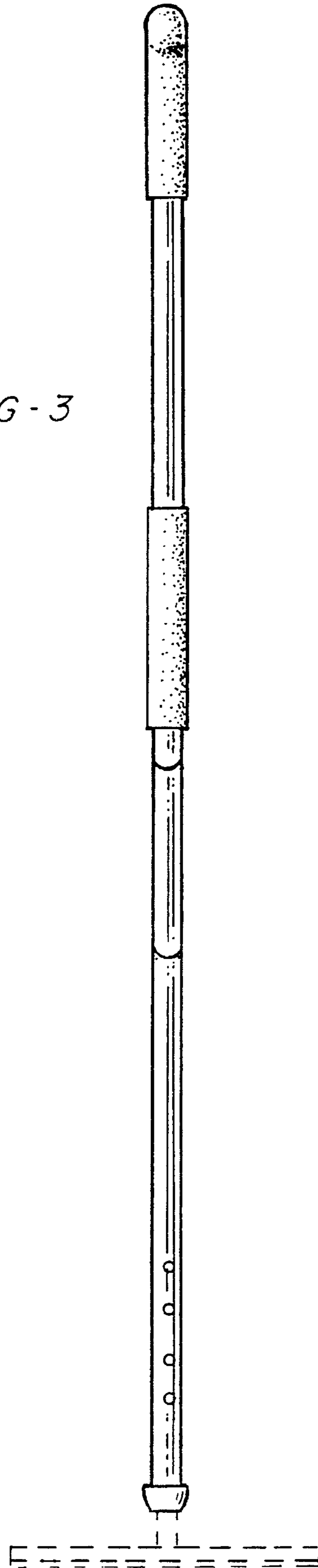

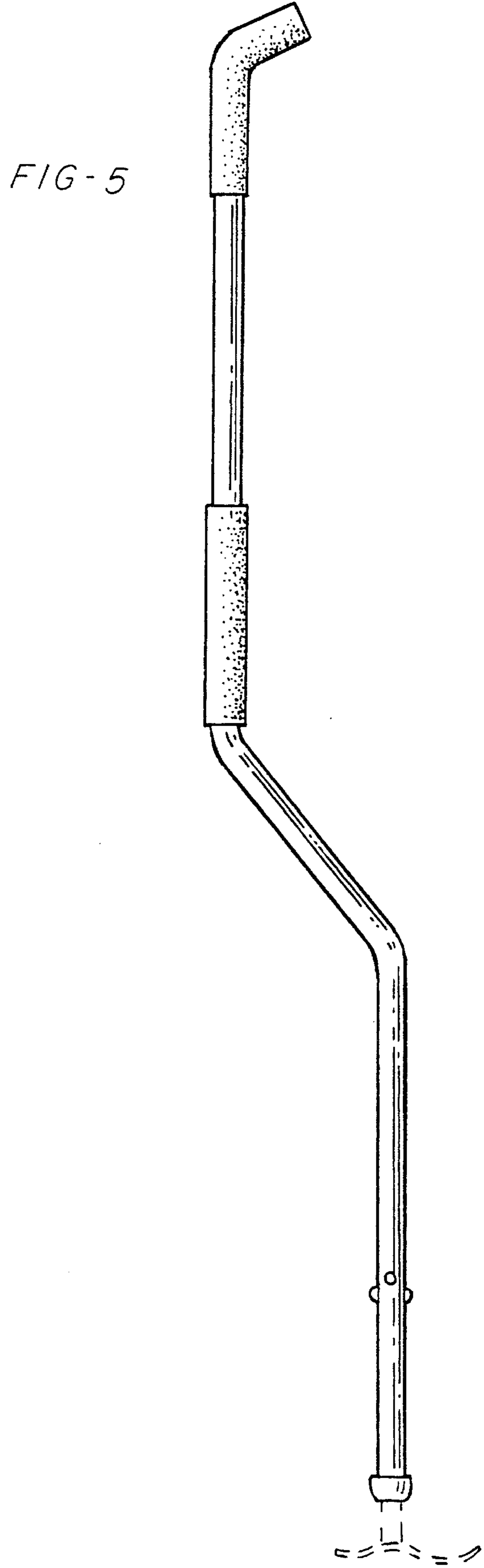
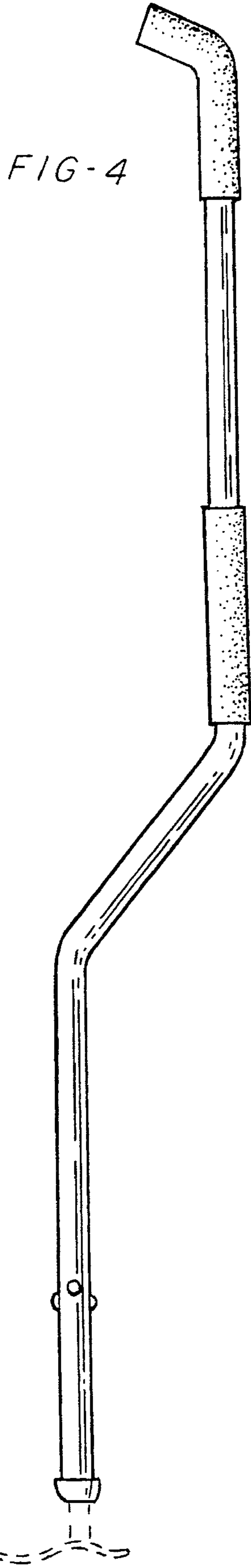

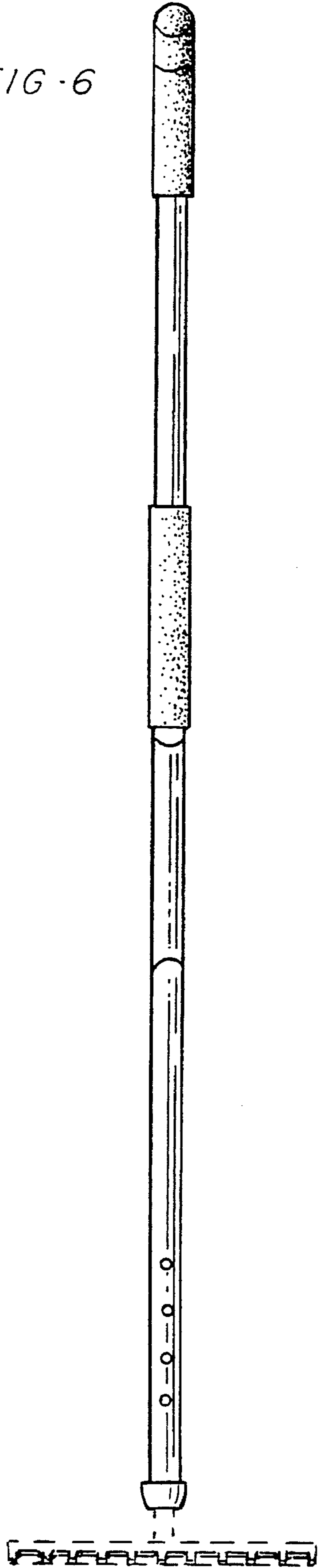
