The ornamental design for foot member, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of foot member embodying the present design;

FIG. 2 is a front view thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a sectional view taken along line 4—4 of FIG. 3;

FIG. 5 is a right side view thereof;

FIG. 6 is a bottom view thereof;

FIG. 7 is a front view thereof without a cover portion;

FIG. 8 is a bottom view thereof without a cover portion;

FIG. 9 is a sectional view taken along line 9—9 of FIG. 8;

FIG. 10 is a front view of the cover portion;

FIG. 11 is a sectional view taken along line 11—11 of FIG. 12;

FIG. 12 is a top plan view of the cover portion;

FIG. 13 is a bottom view of the cover portion; and,

FIG. 14 is an environmental sectional view with the broken line showing of a bolt and a fragmented surface being for illustrative purposes only and forming no part of the claimed design.

The rear view thereof is not shown here as it is a mirror image of the front view.

The left side view thereof is not shown here as it is a mirror image of the right side view.

The elements of the claimed design are shown separately for clarity of illustration.

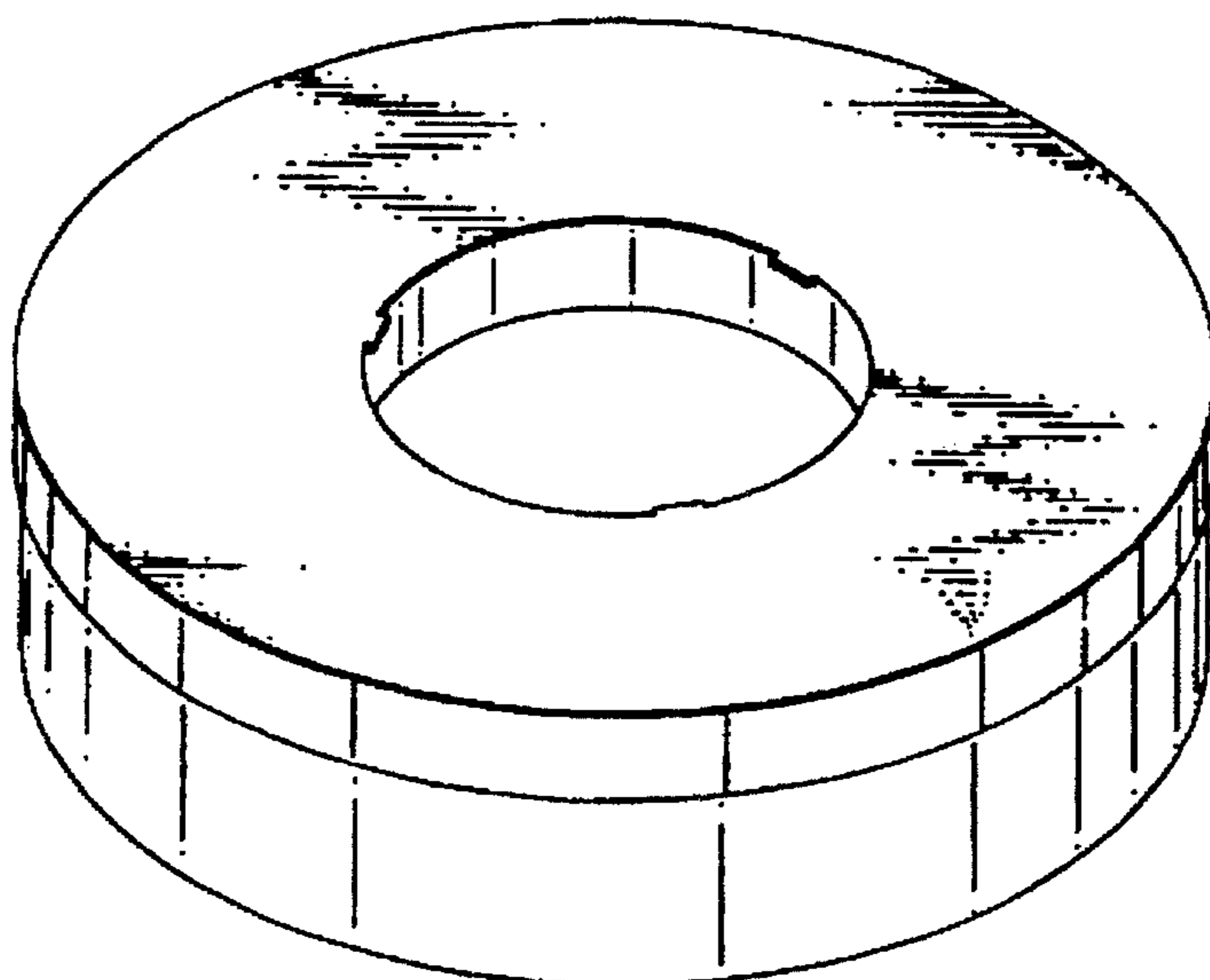

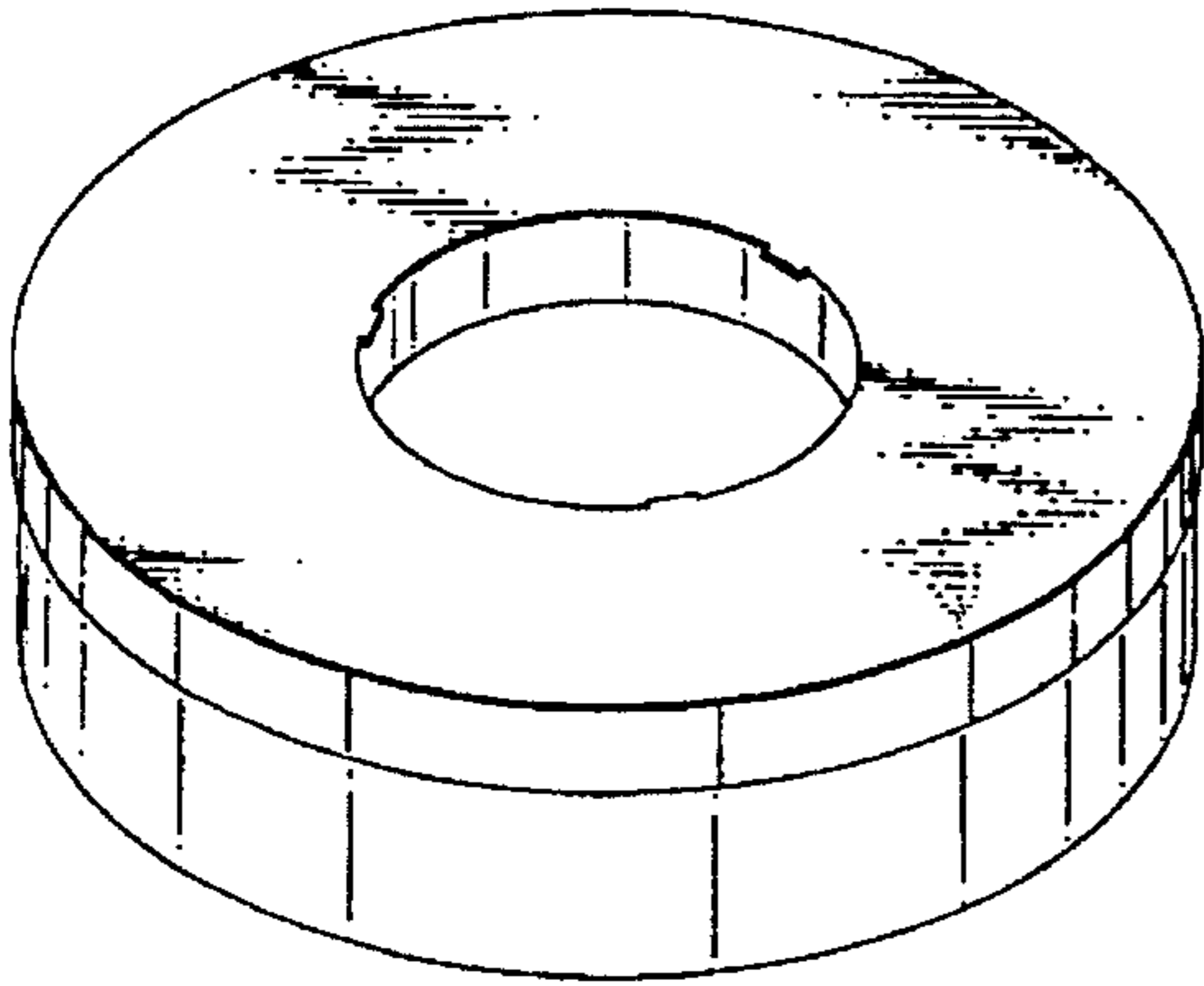

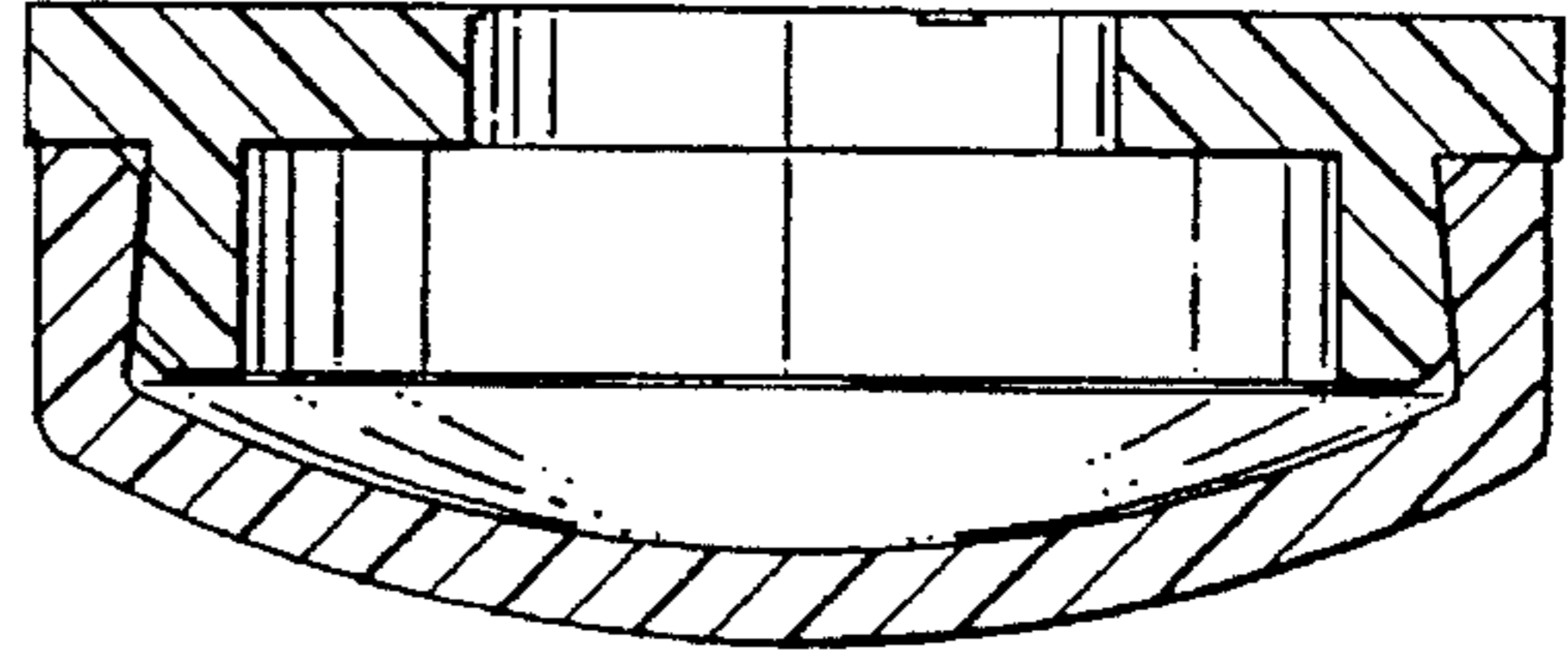

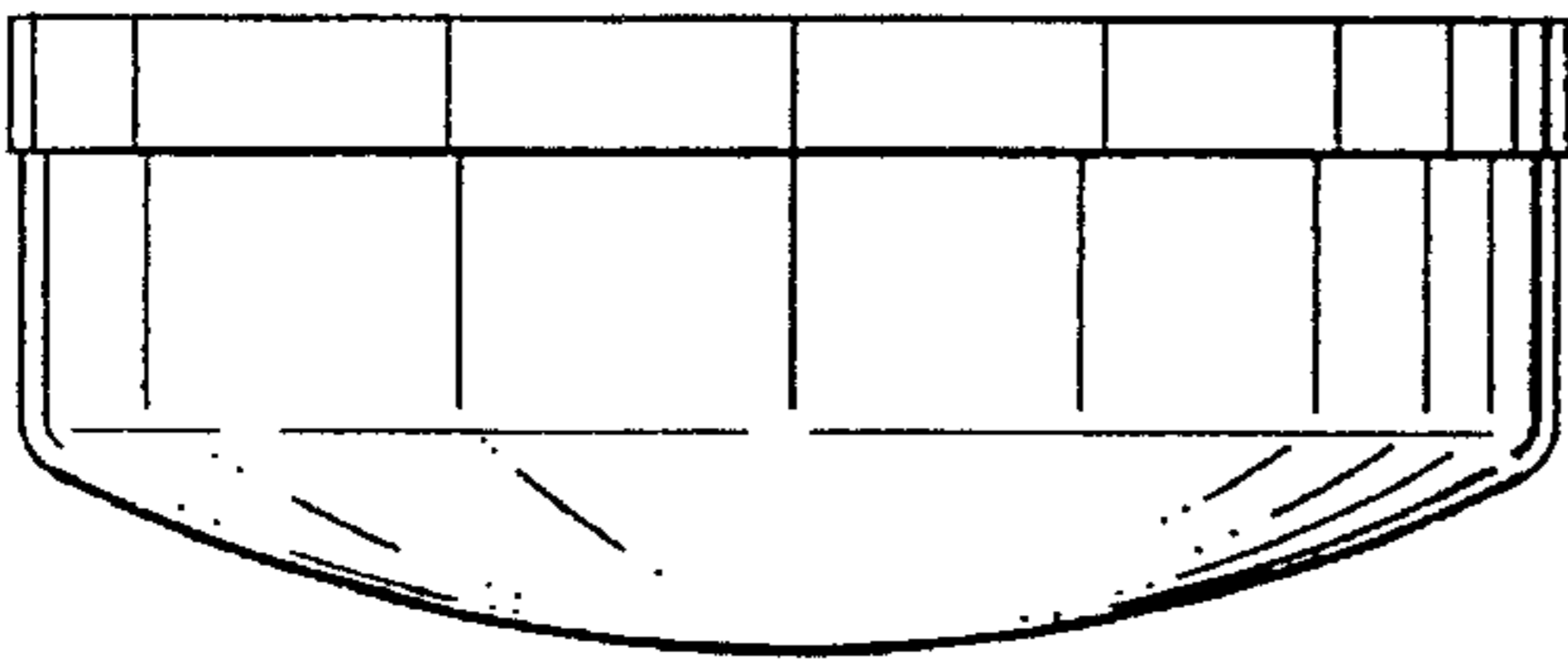

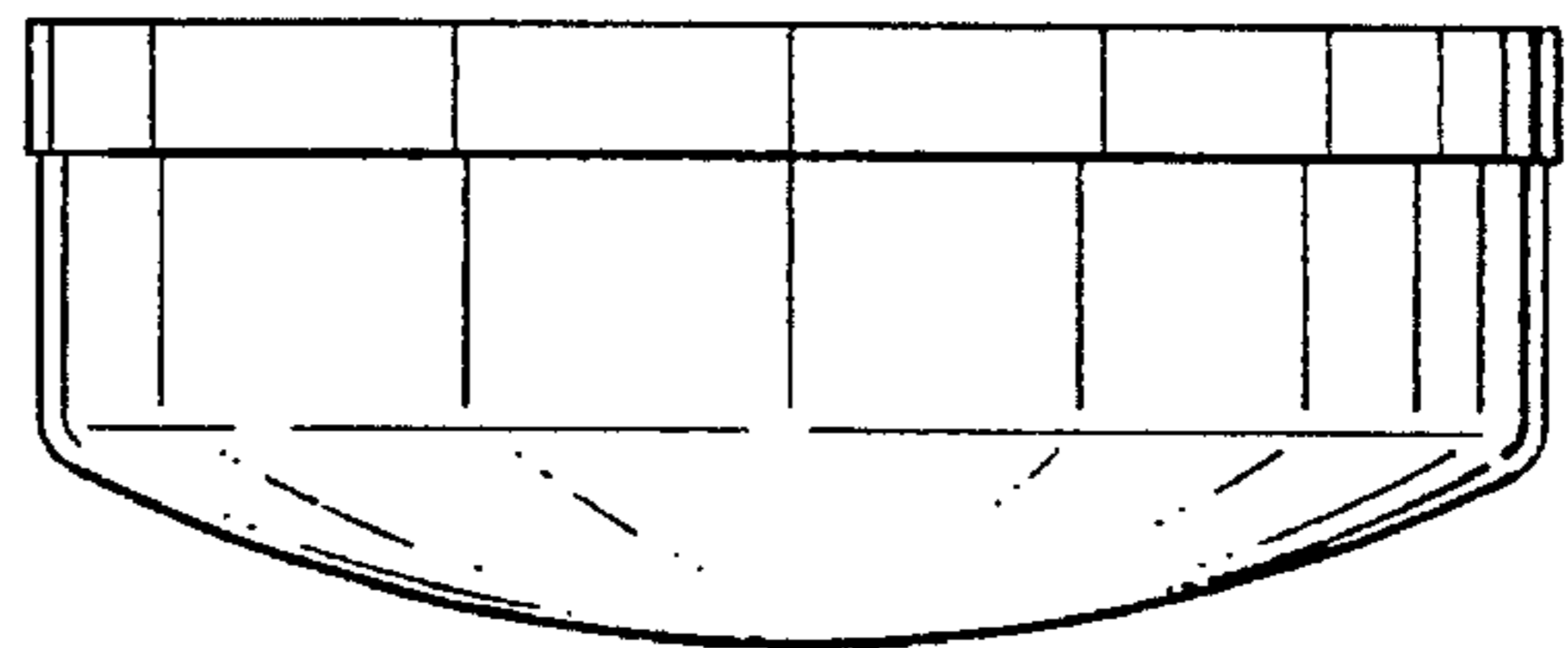

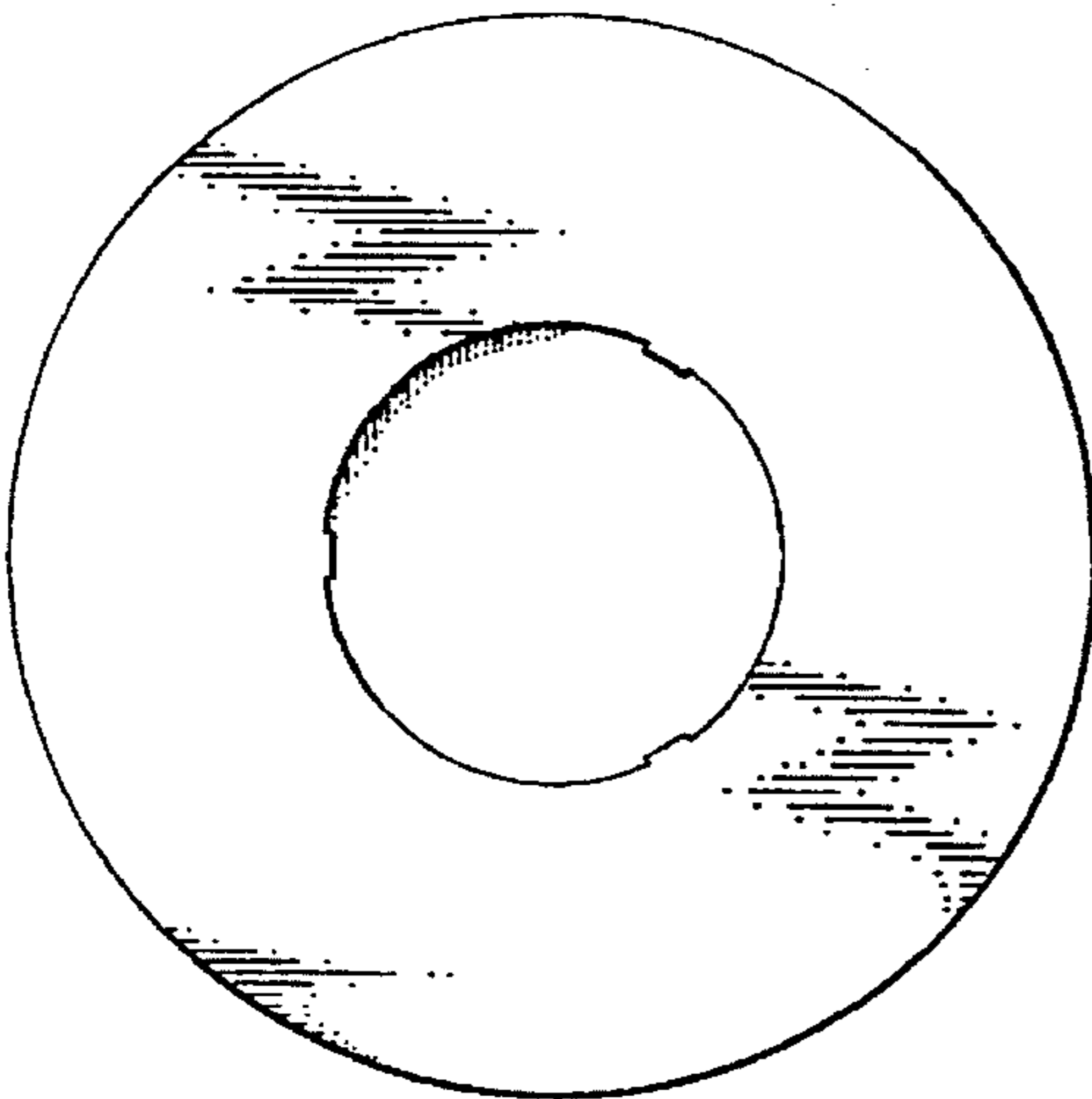

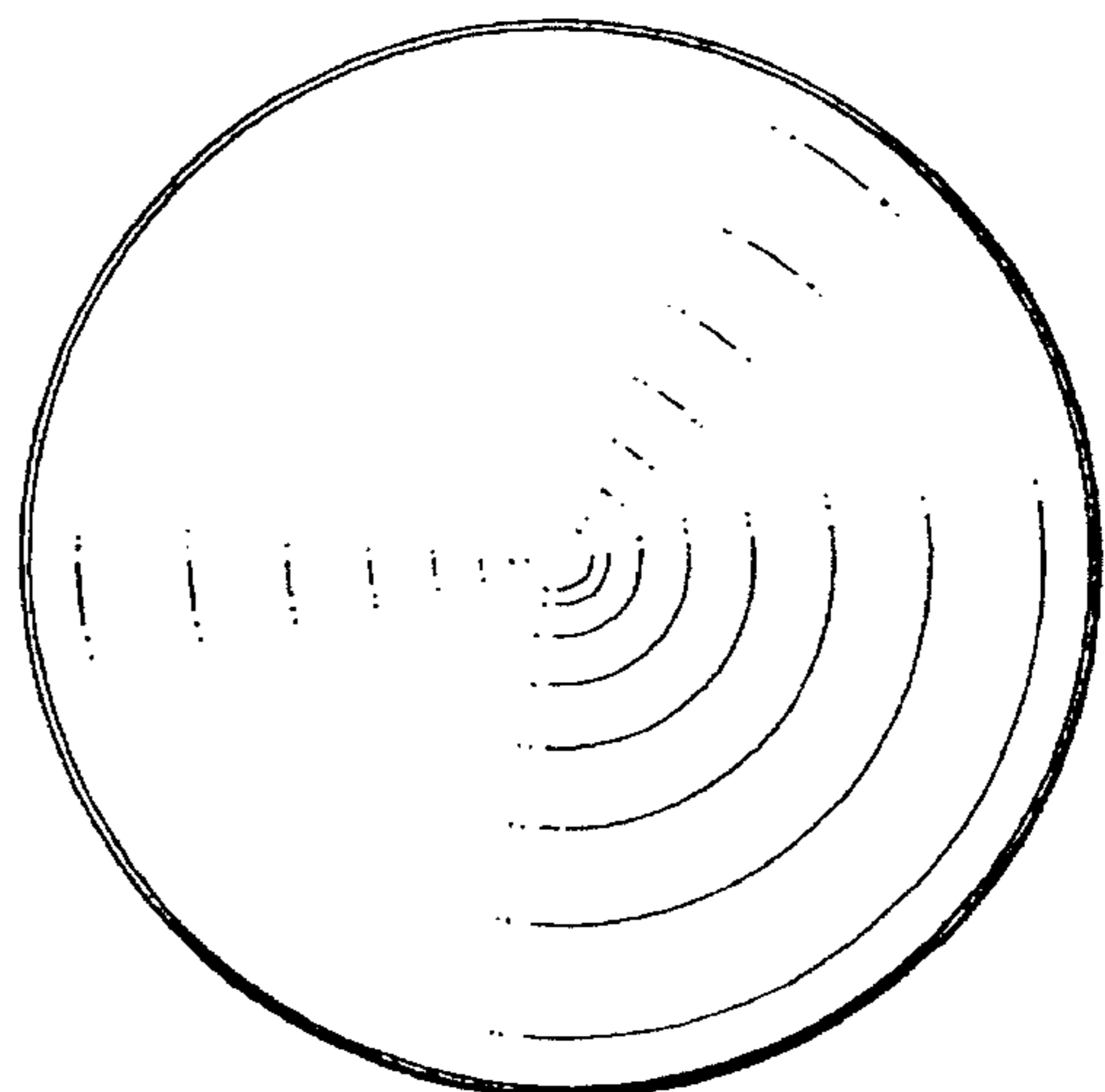

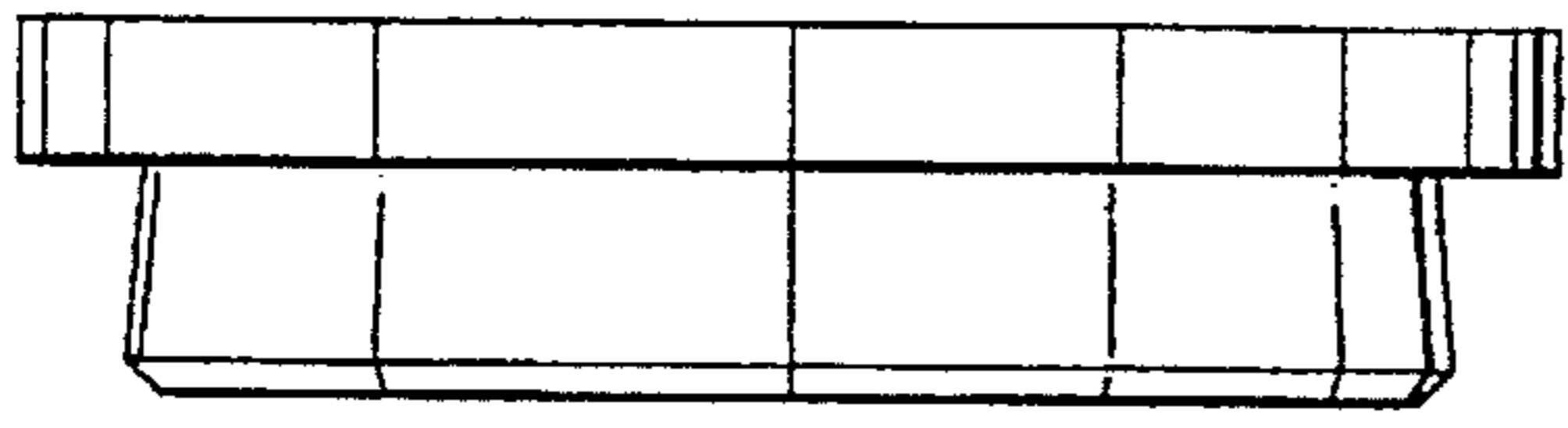

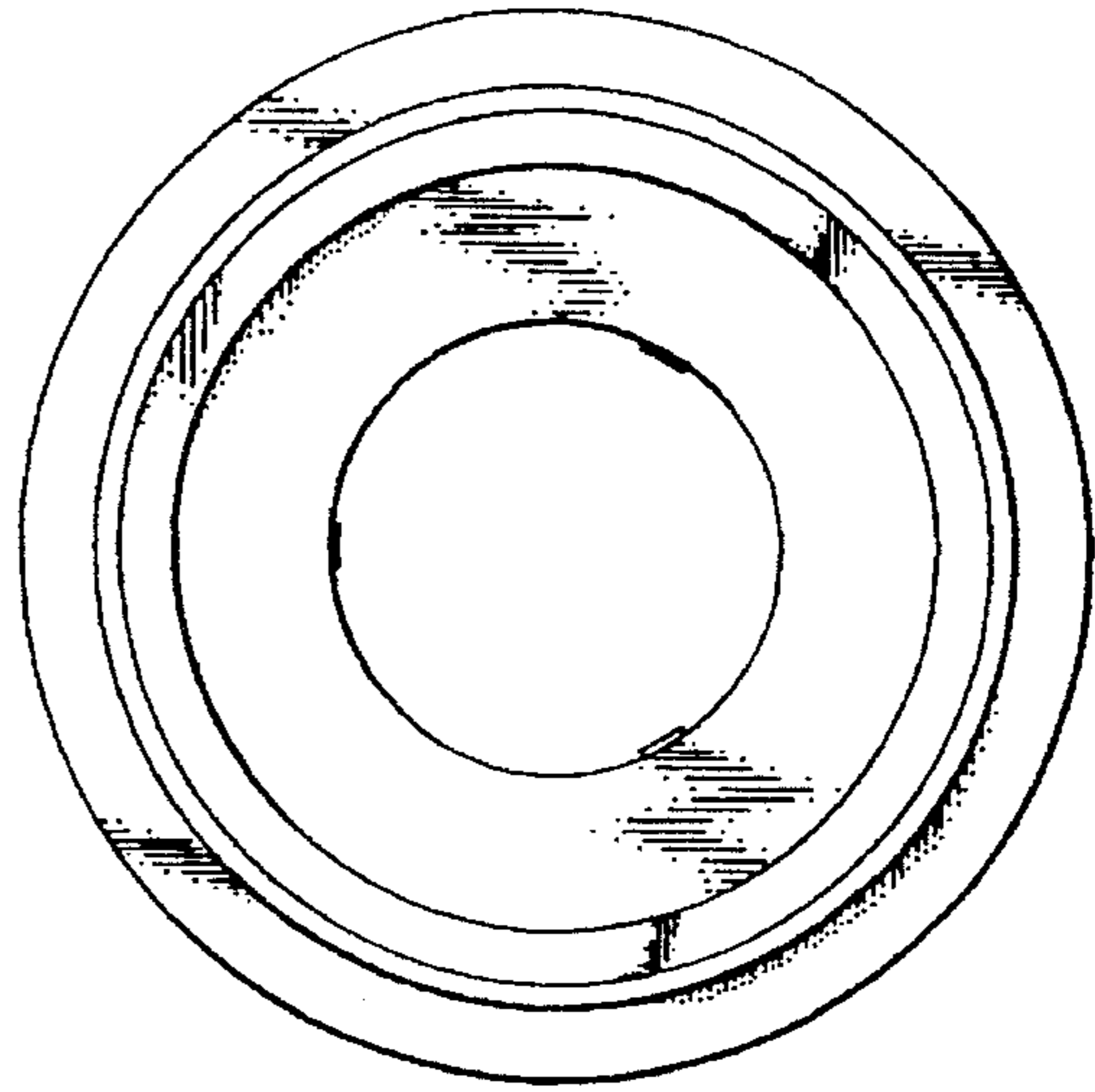

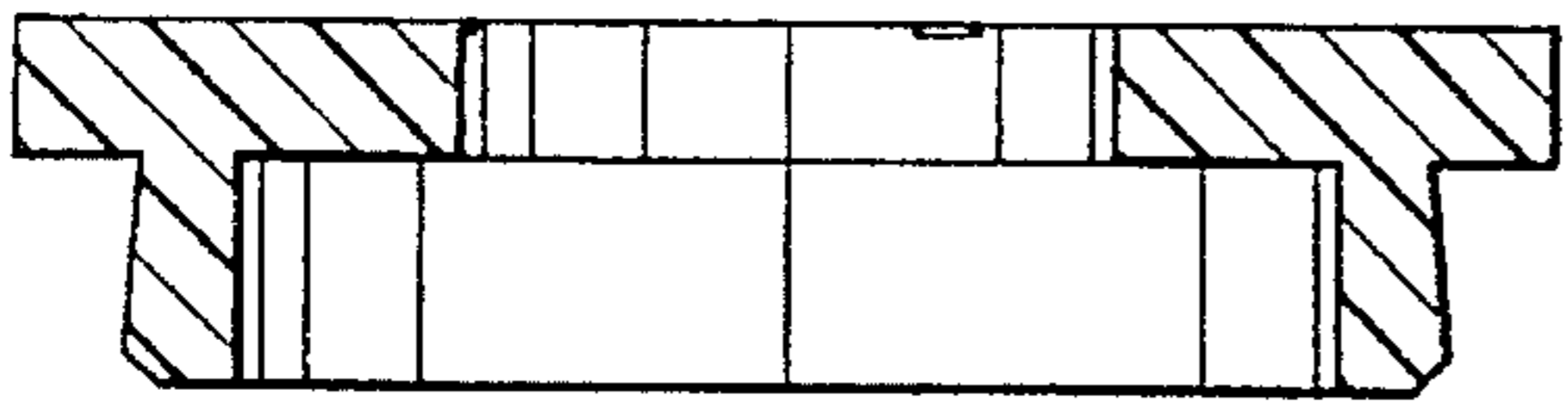

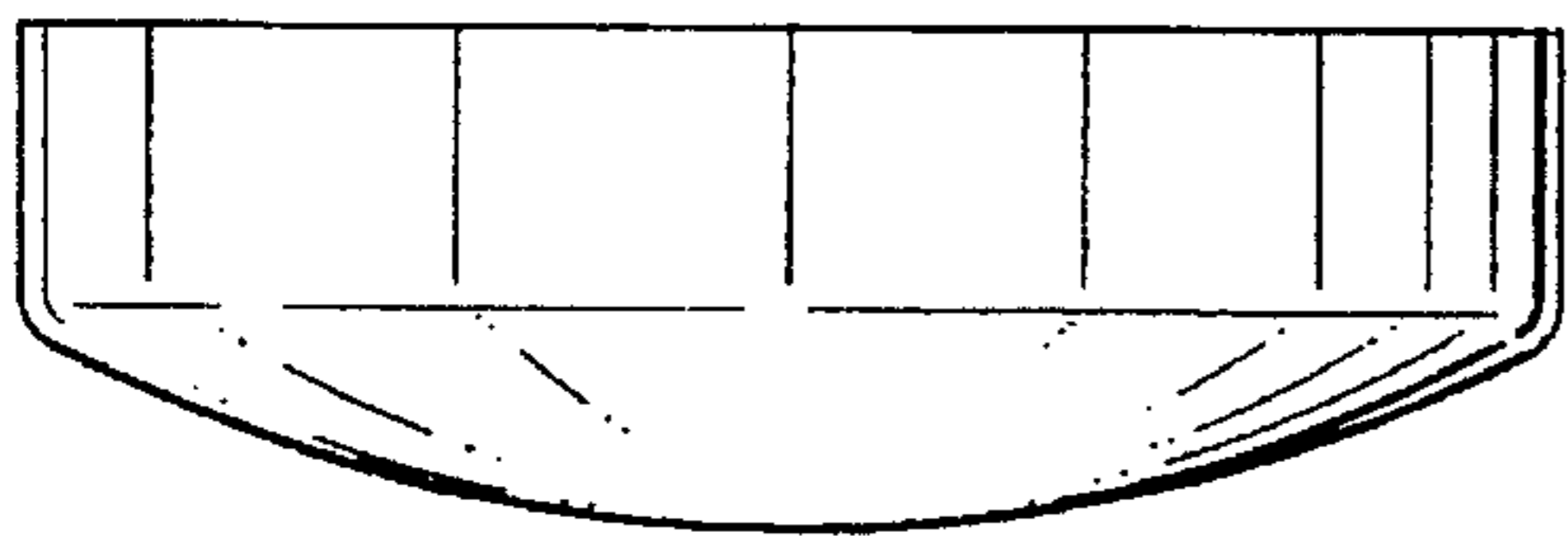

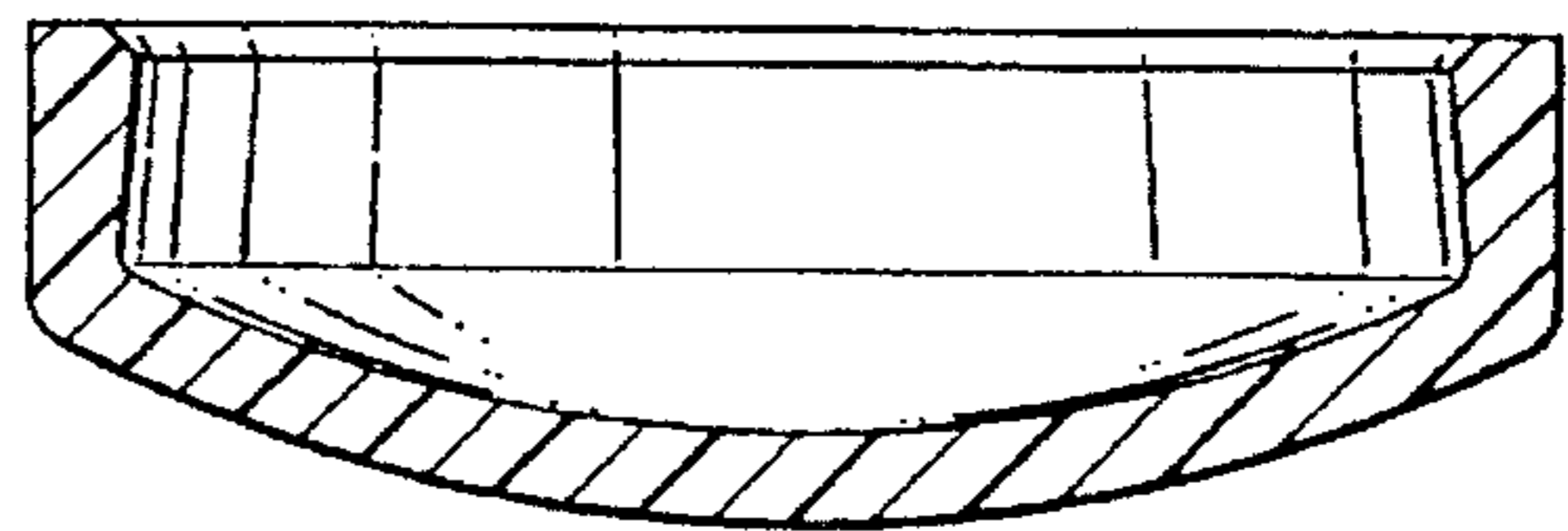

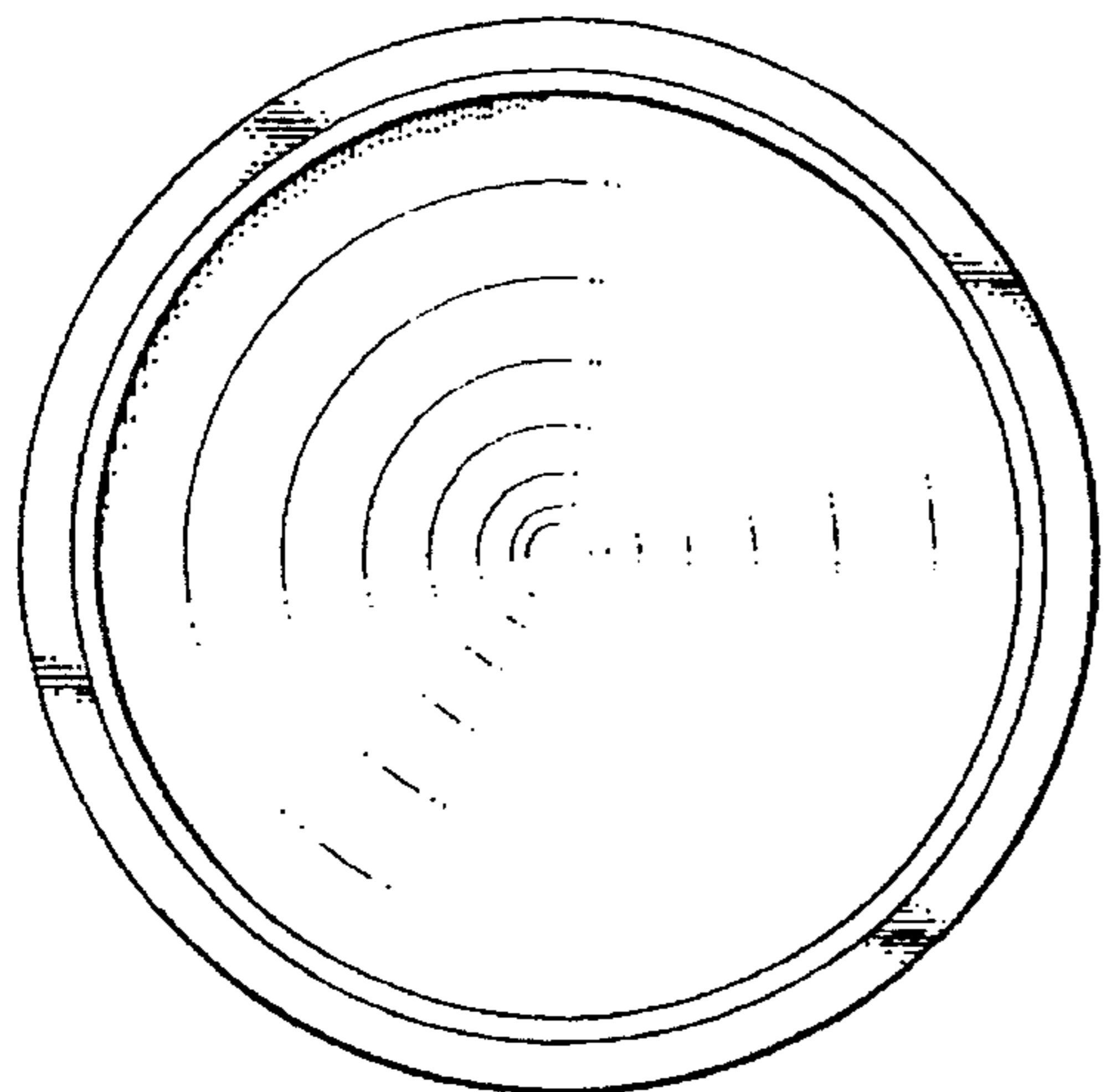

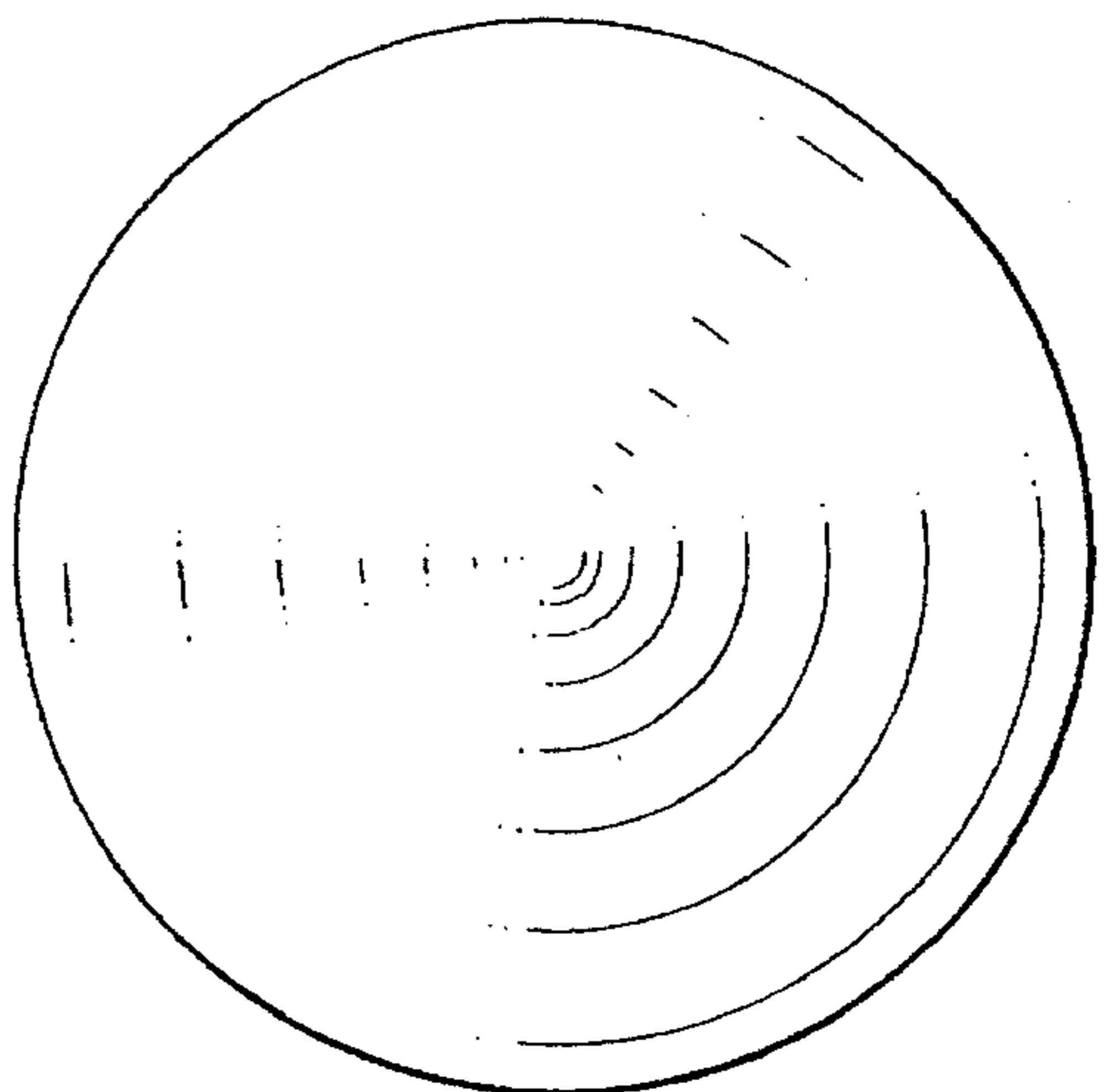
