DESCRIPTION

FIG. 6 is a rear elevational view thereof;

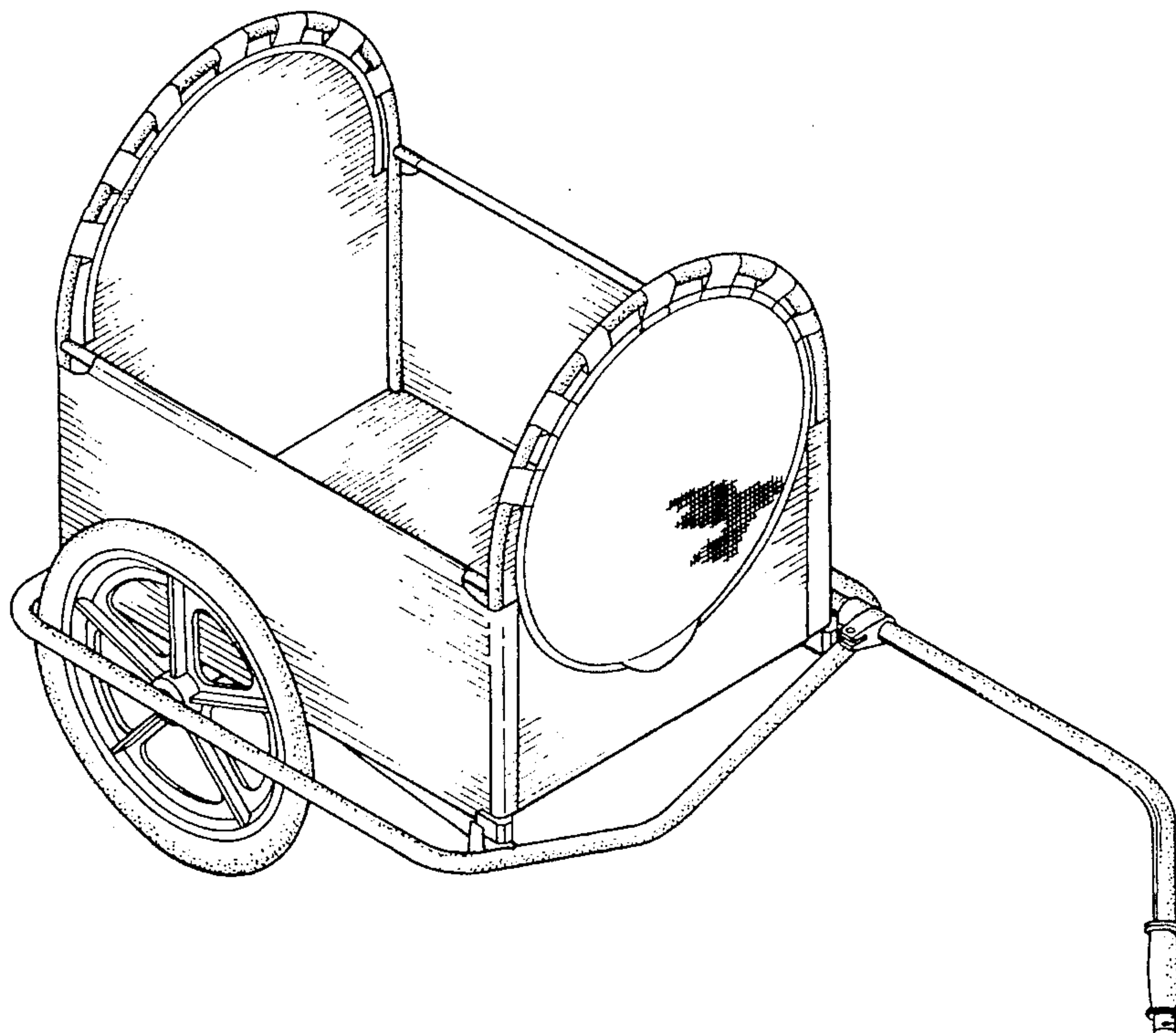
FIG. 7 is a bottom plan view thereof;

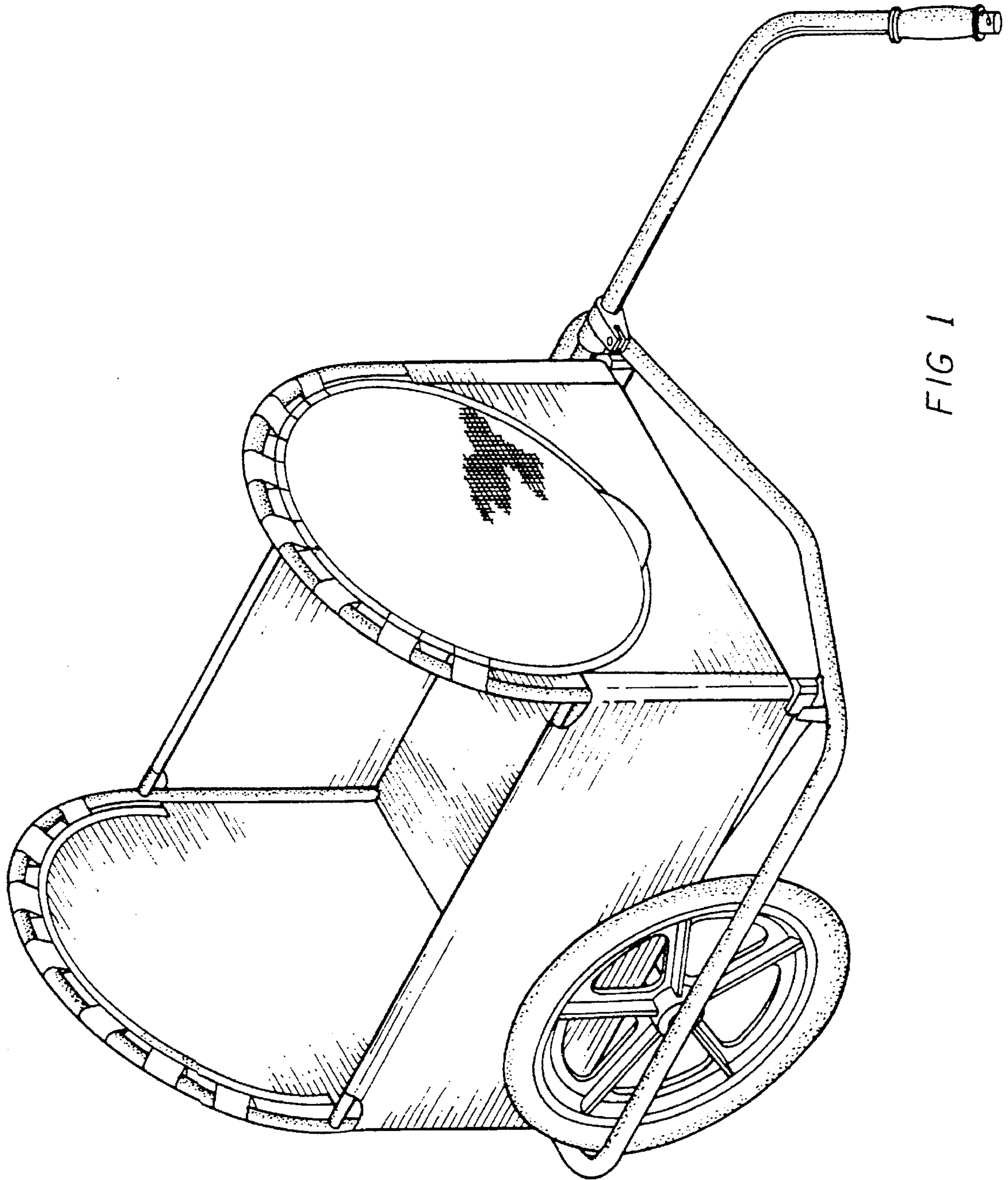

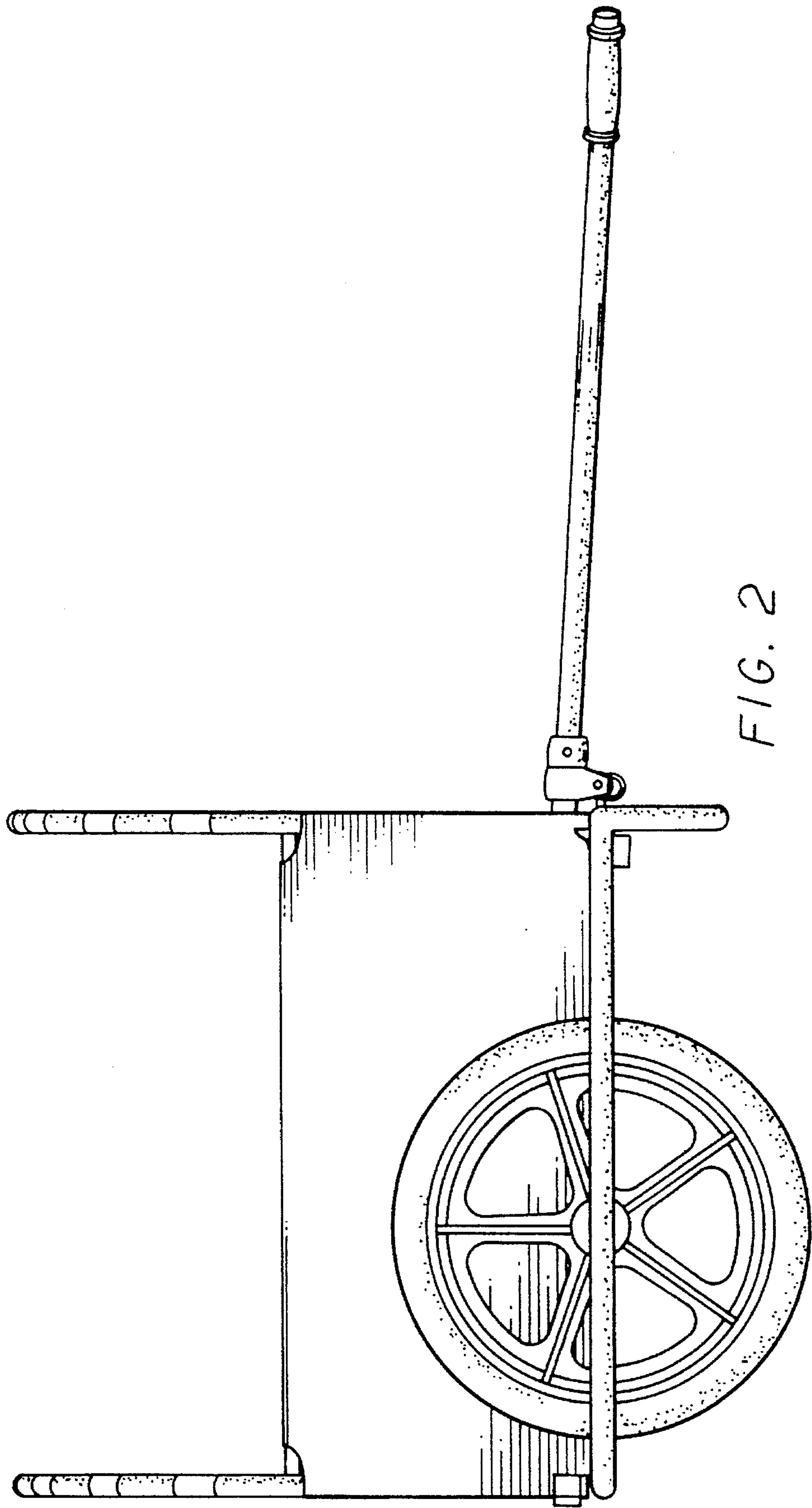

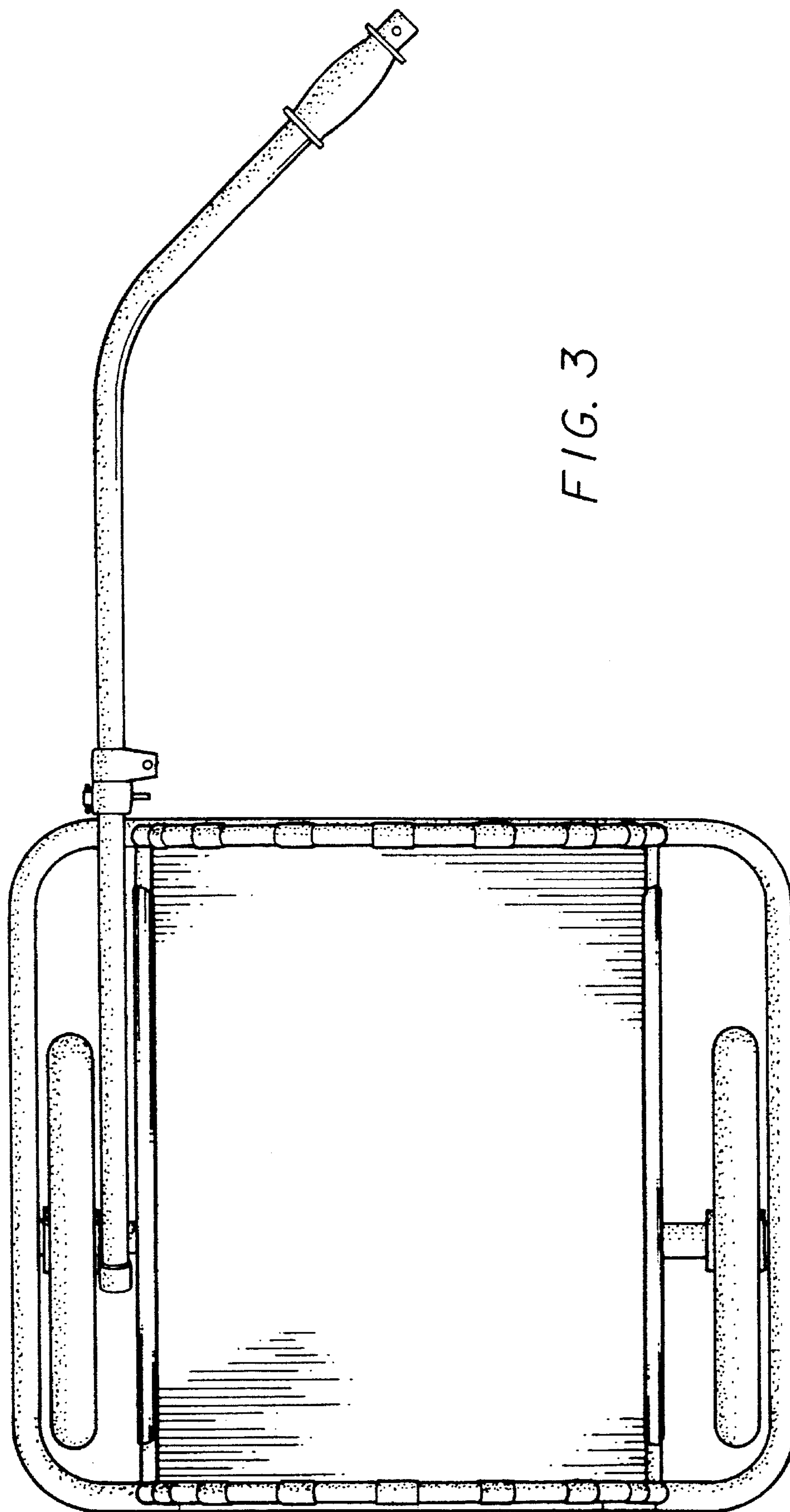

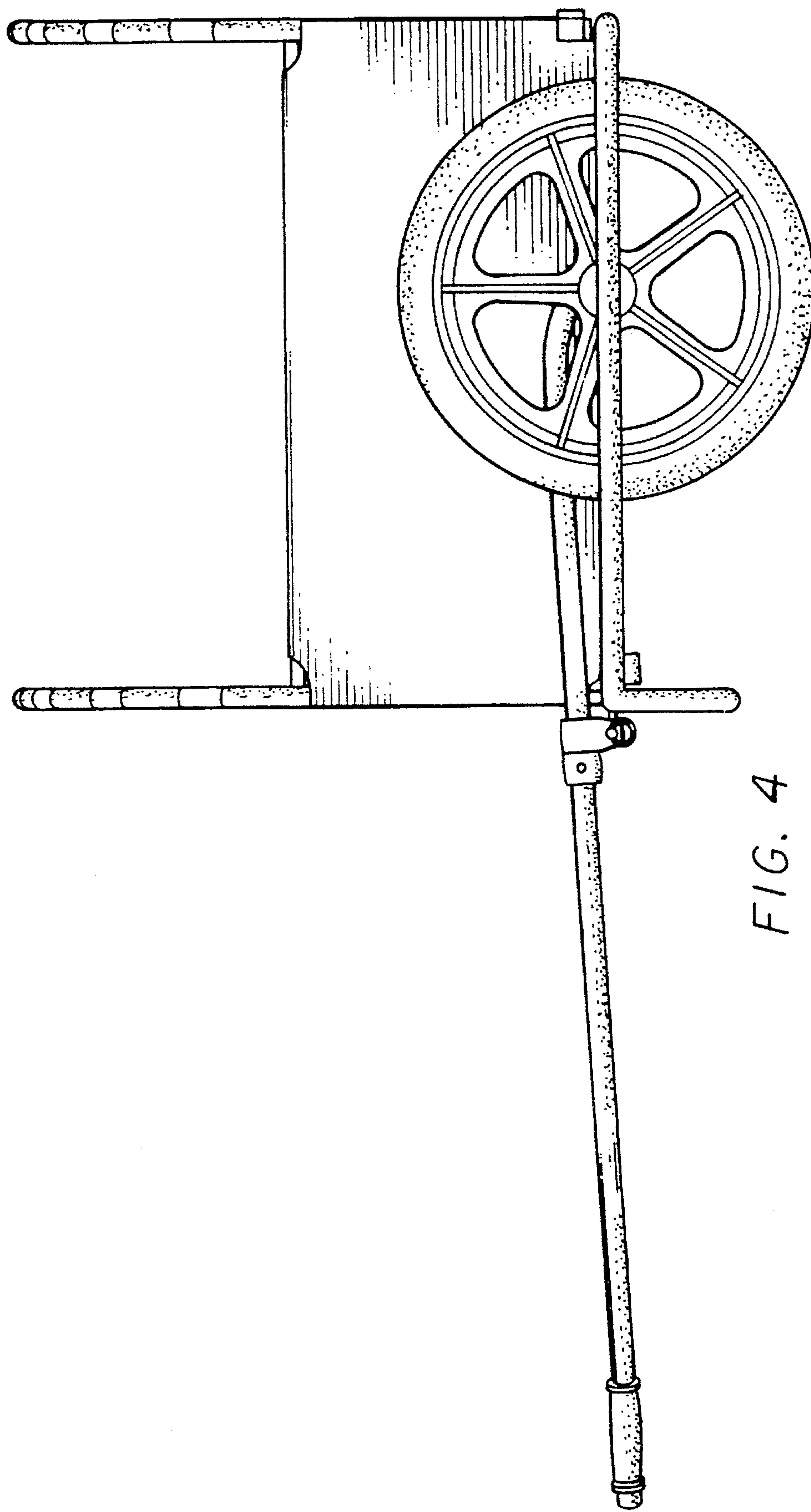

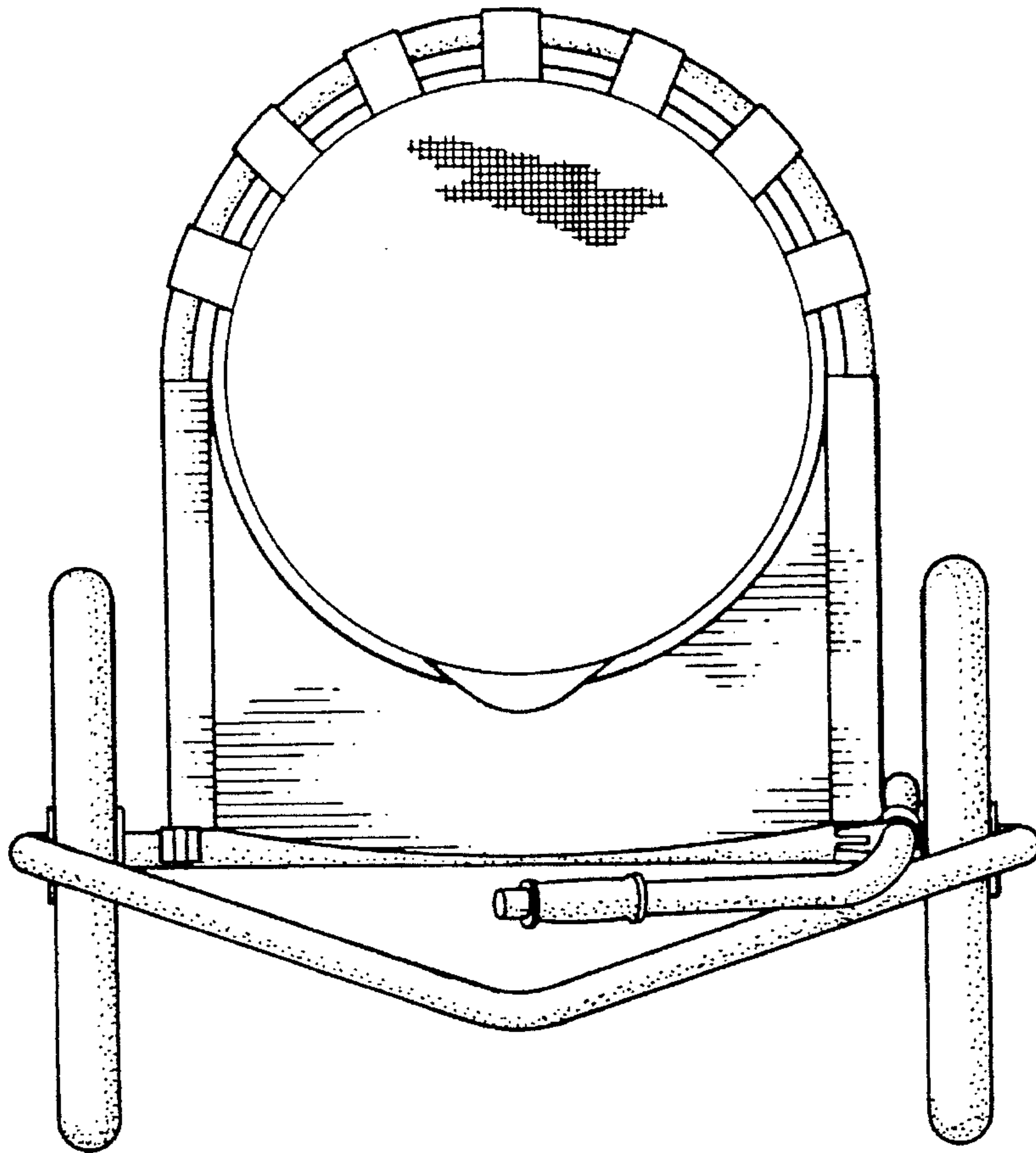

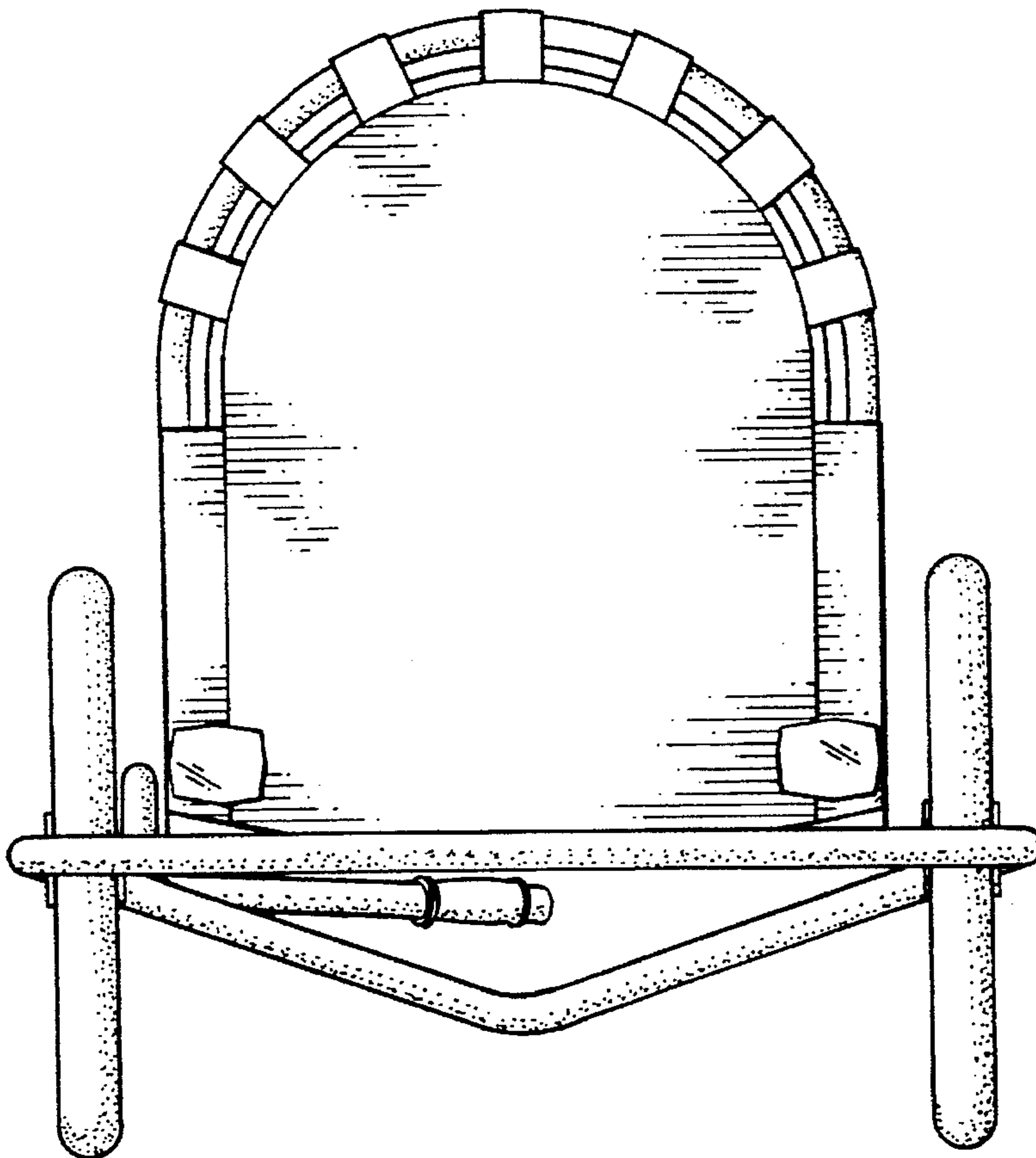
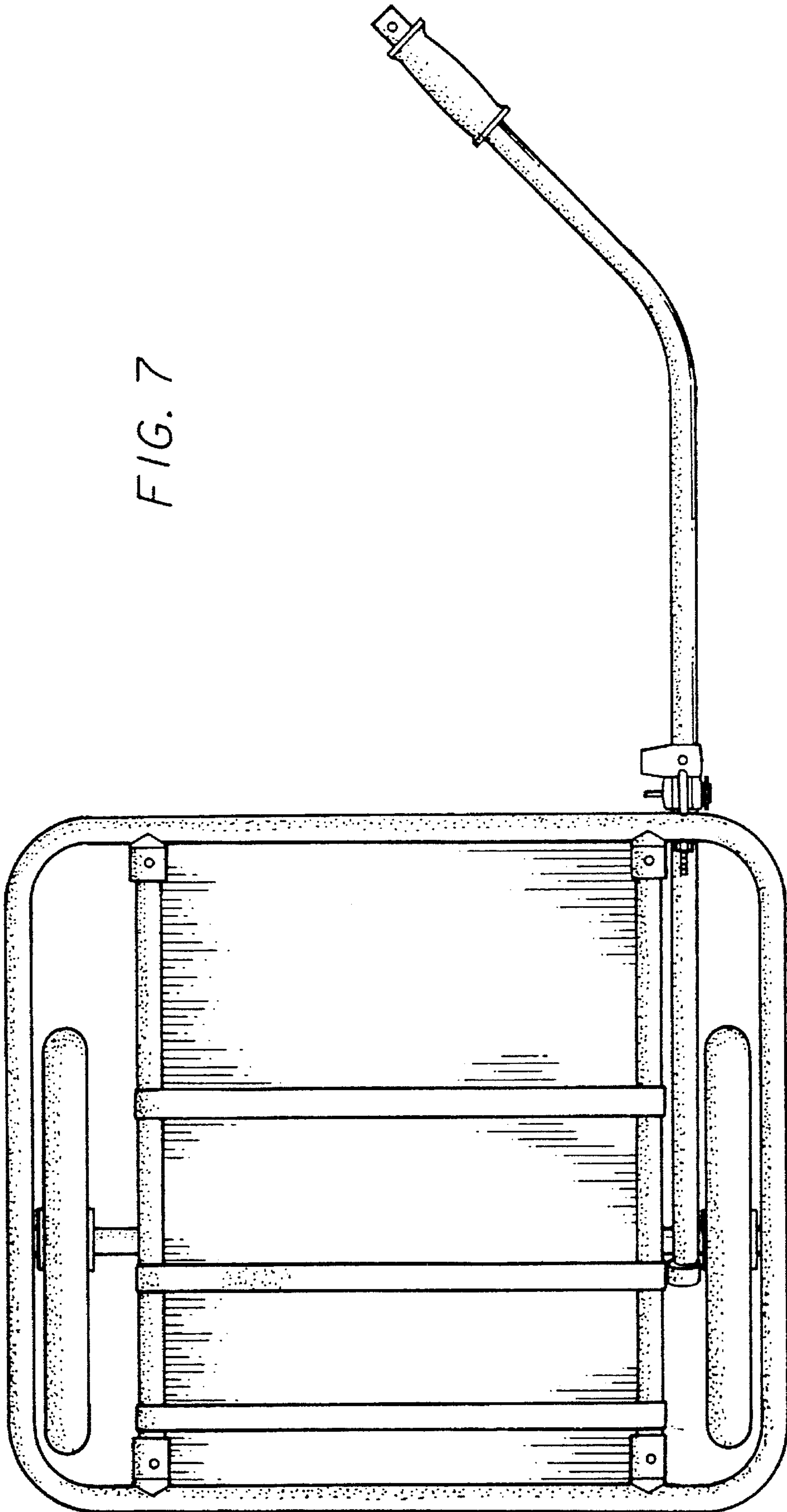

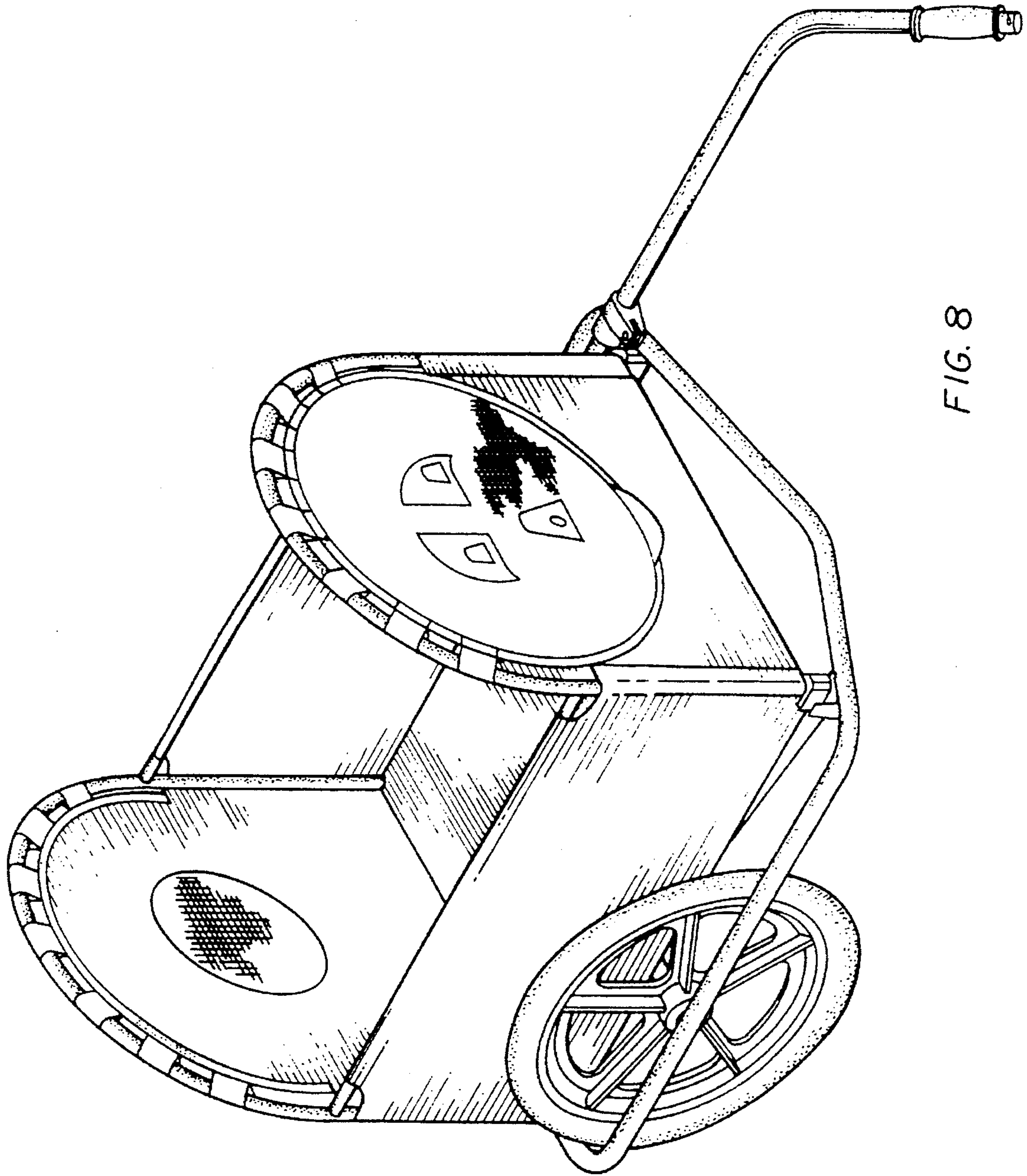

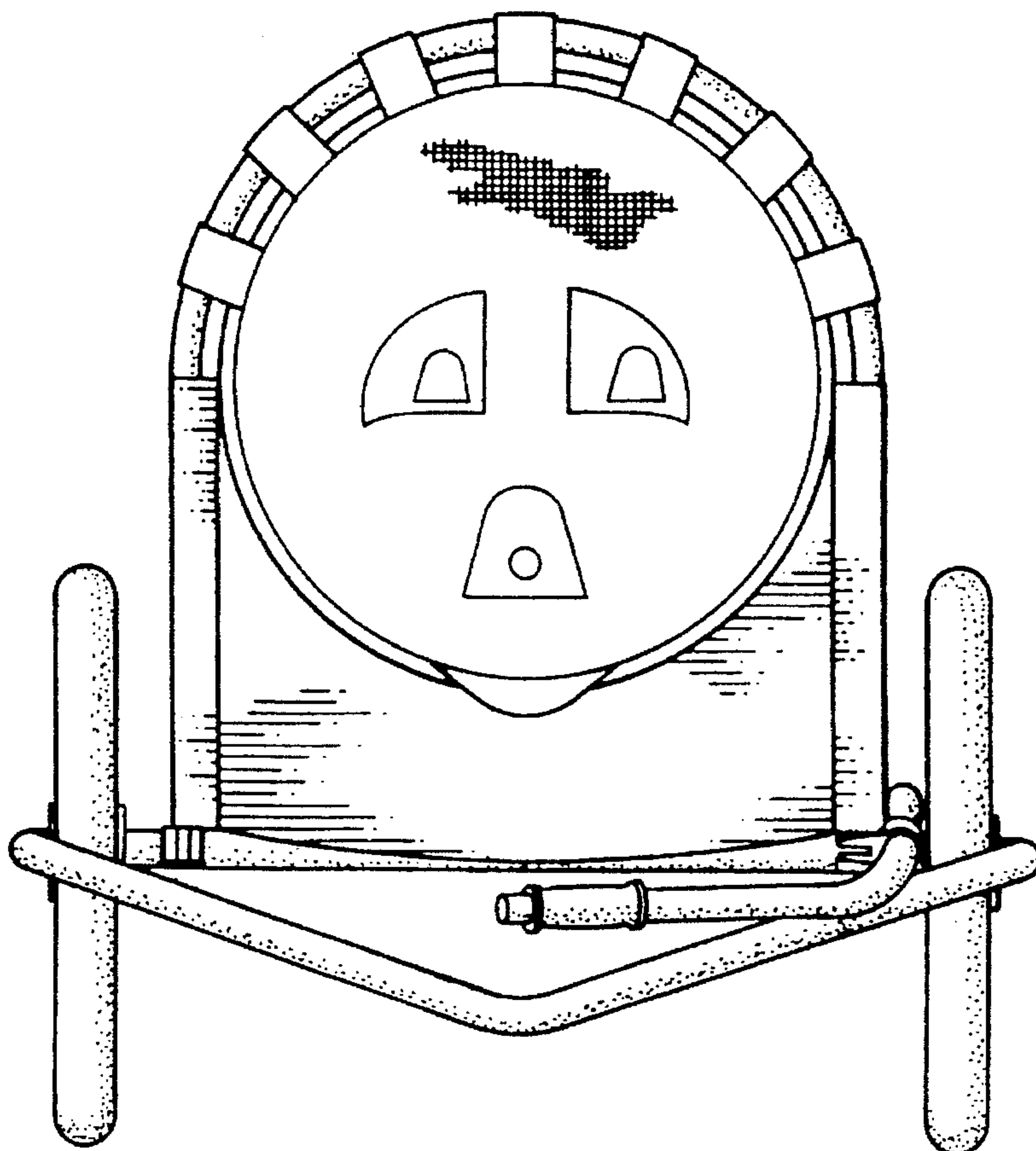

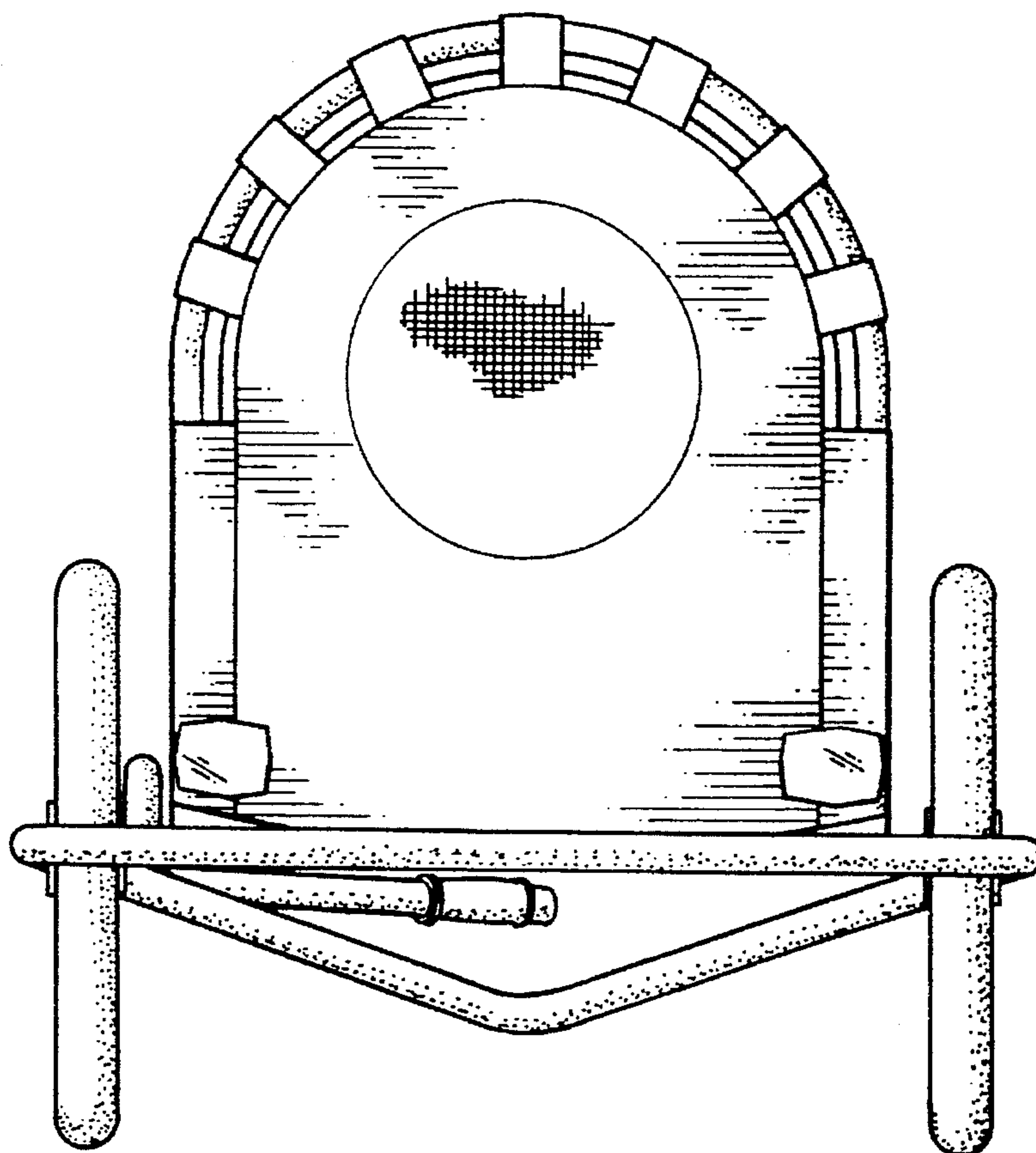
