FIG. 7 is a left side elevation thereof;

FIG. 9 is a front elevation view of an inverter showing a second embodiment of the new design with power supplied. All other views are the same as the first embodiment; and, FIG. 10 is a perspective view as seen from the rear and lower left of the inverter.

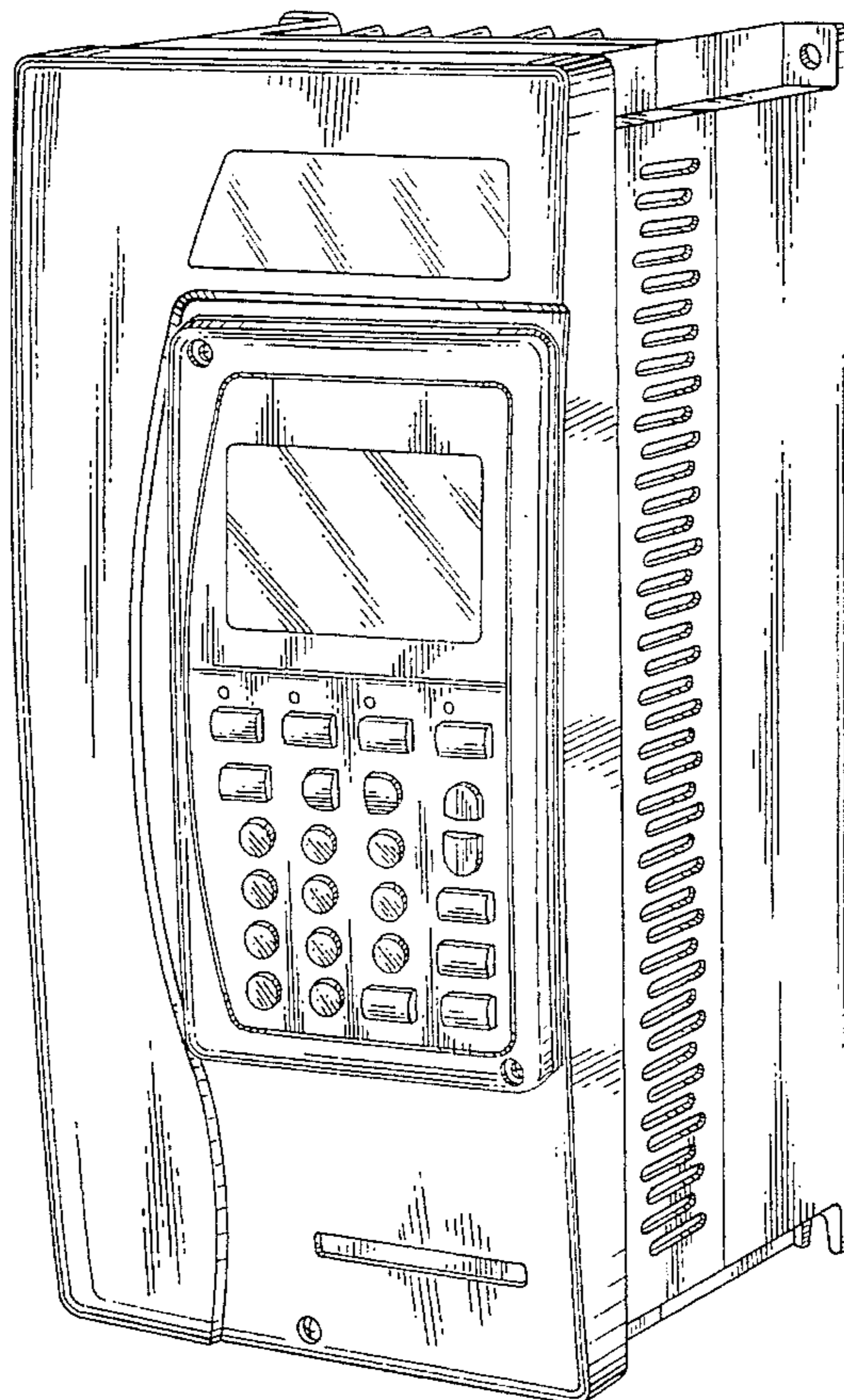

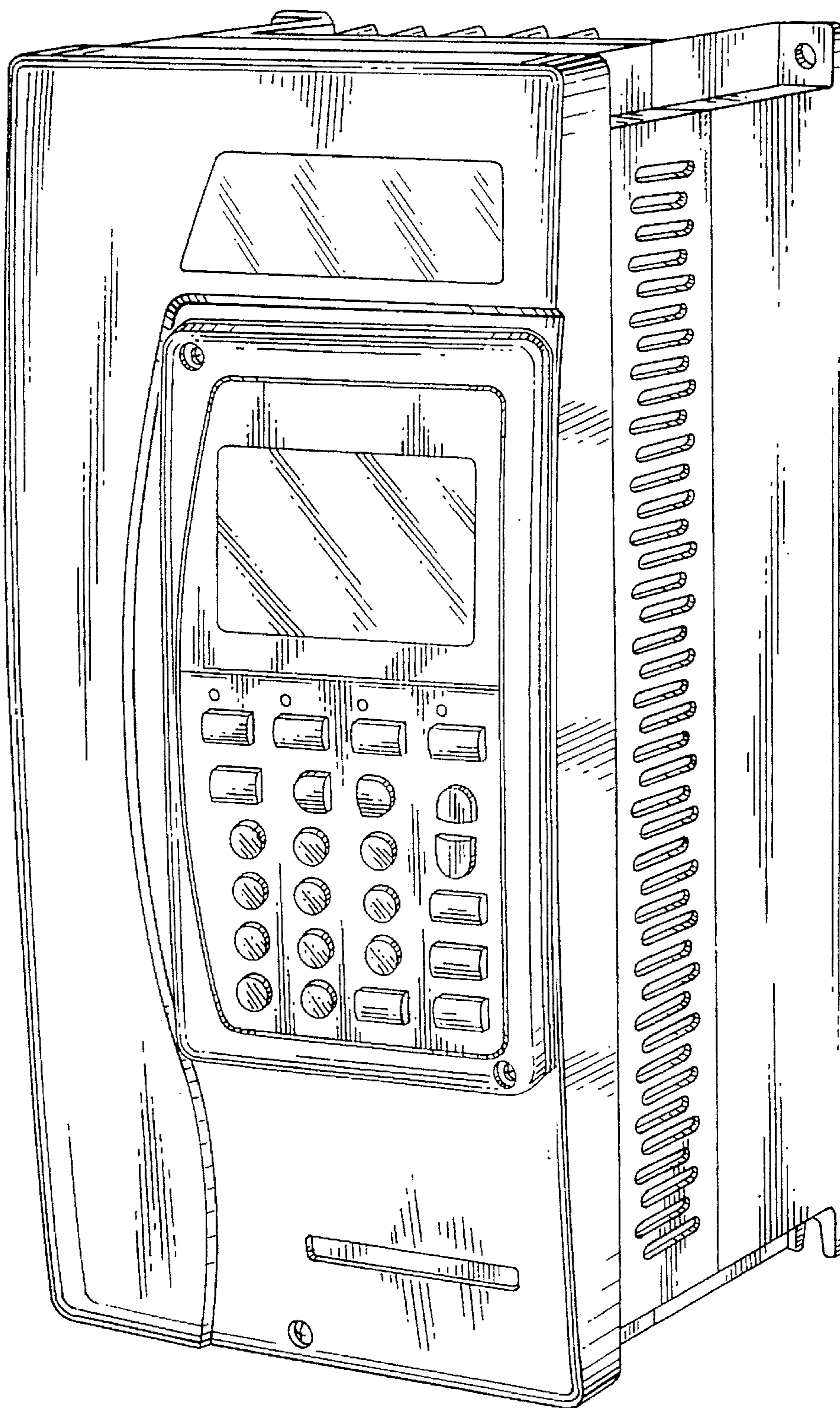
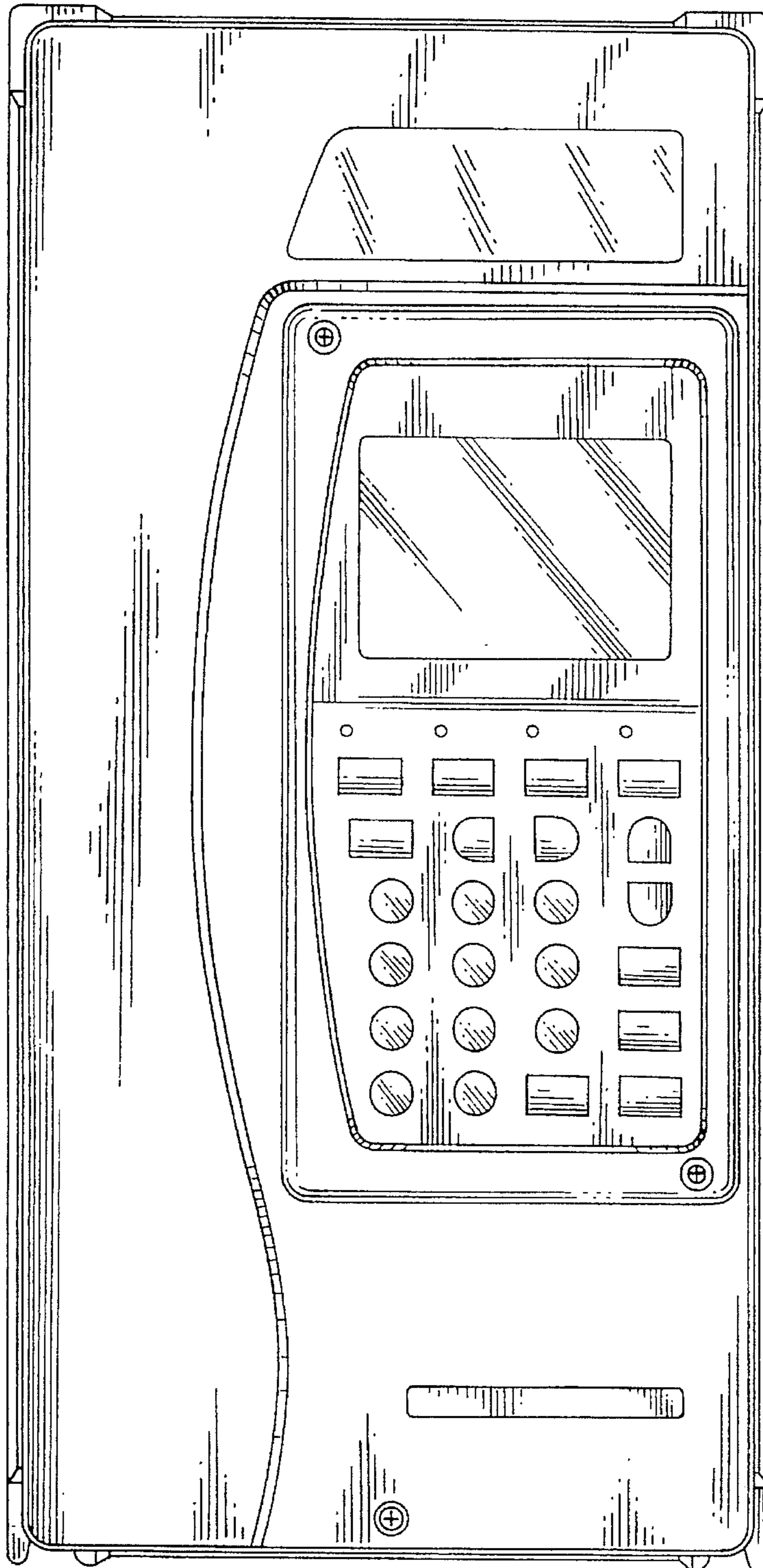

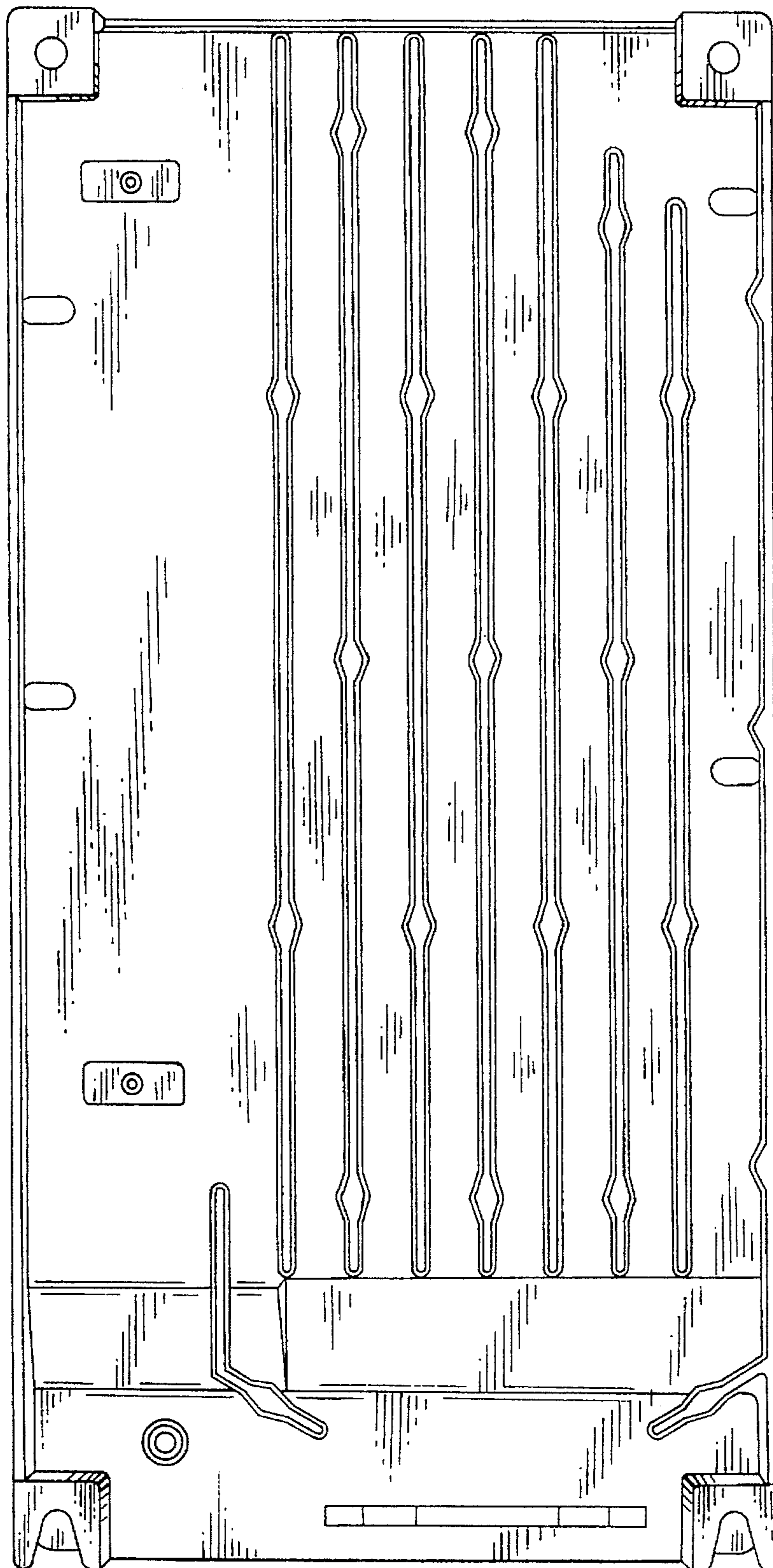

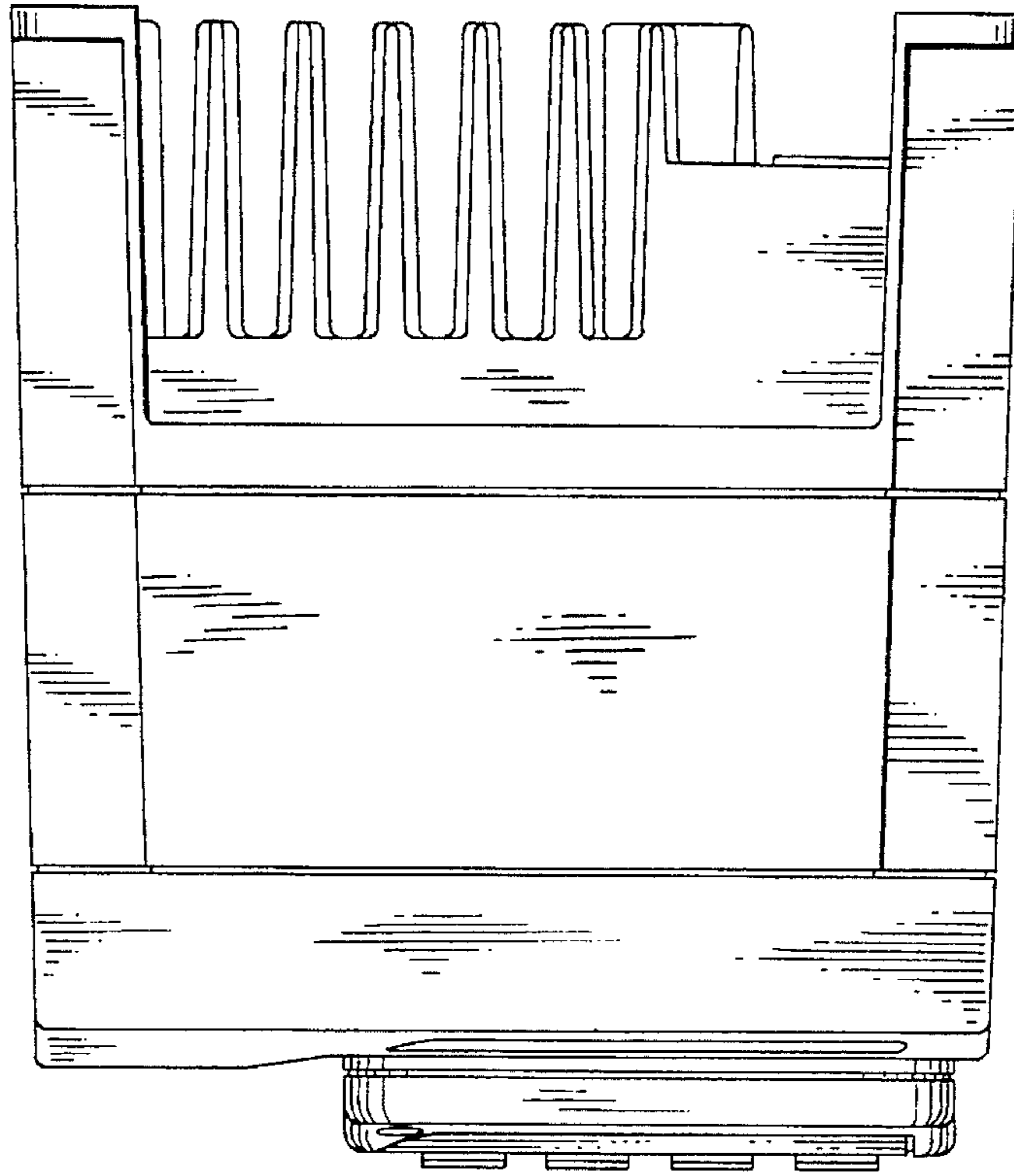

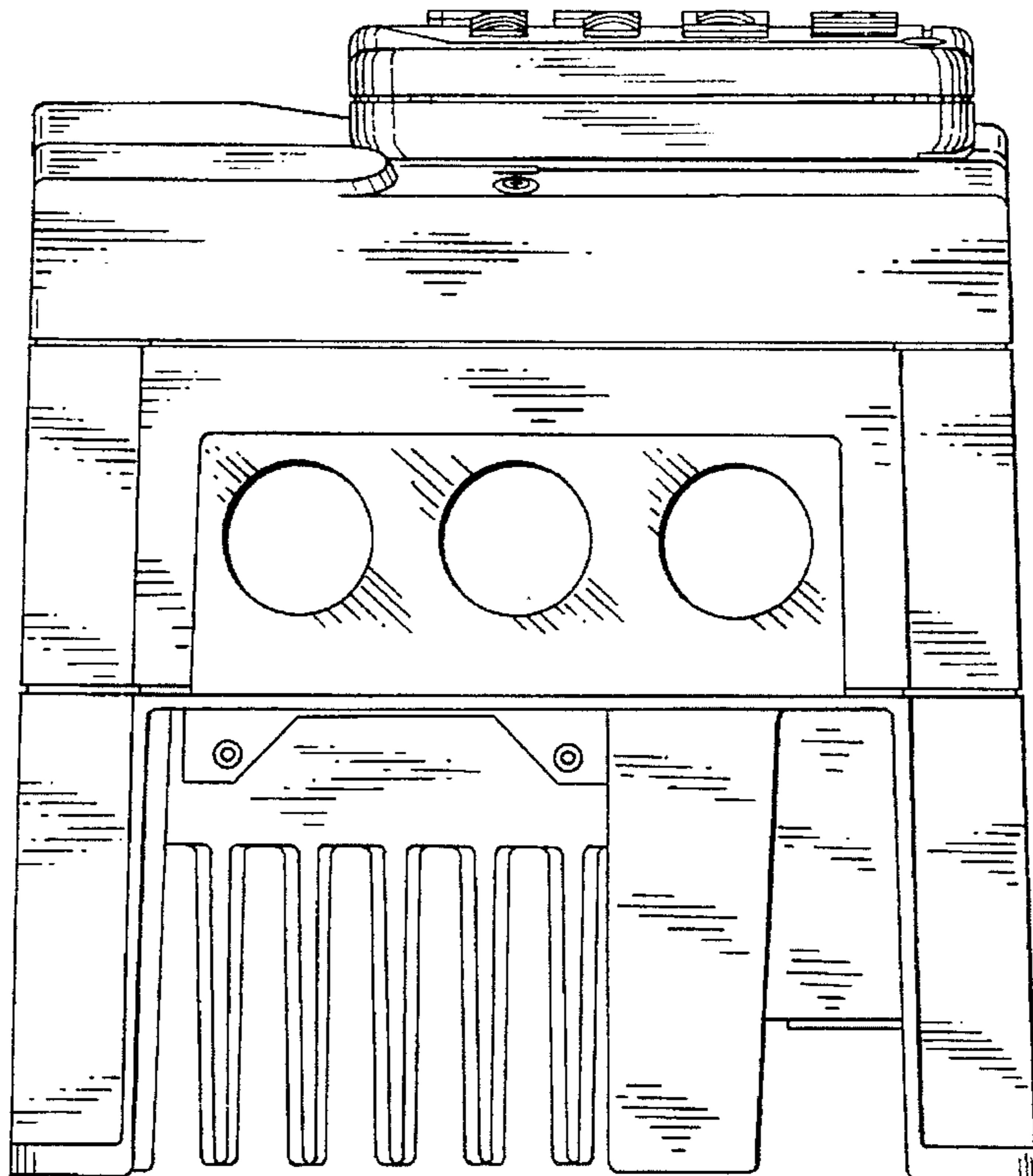

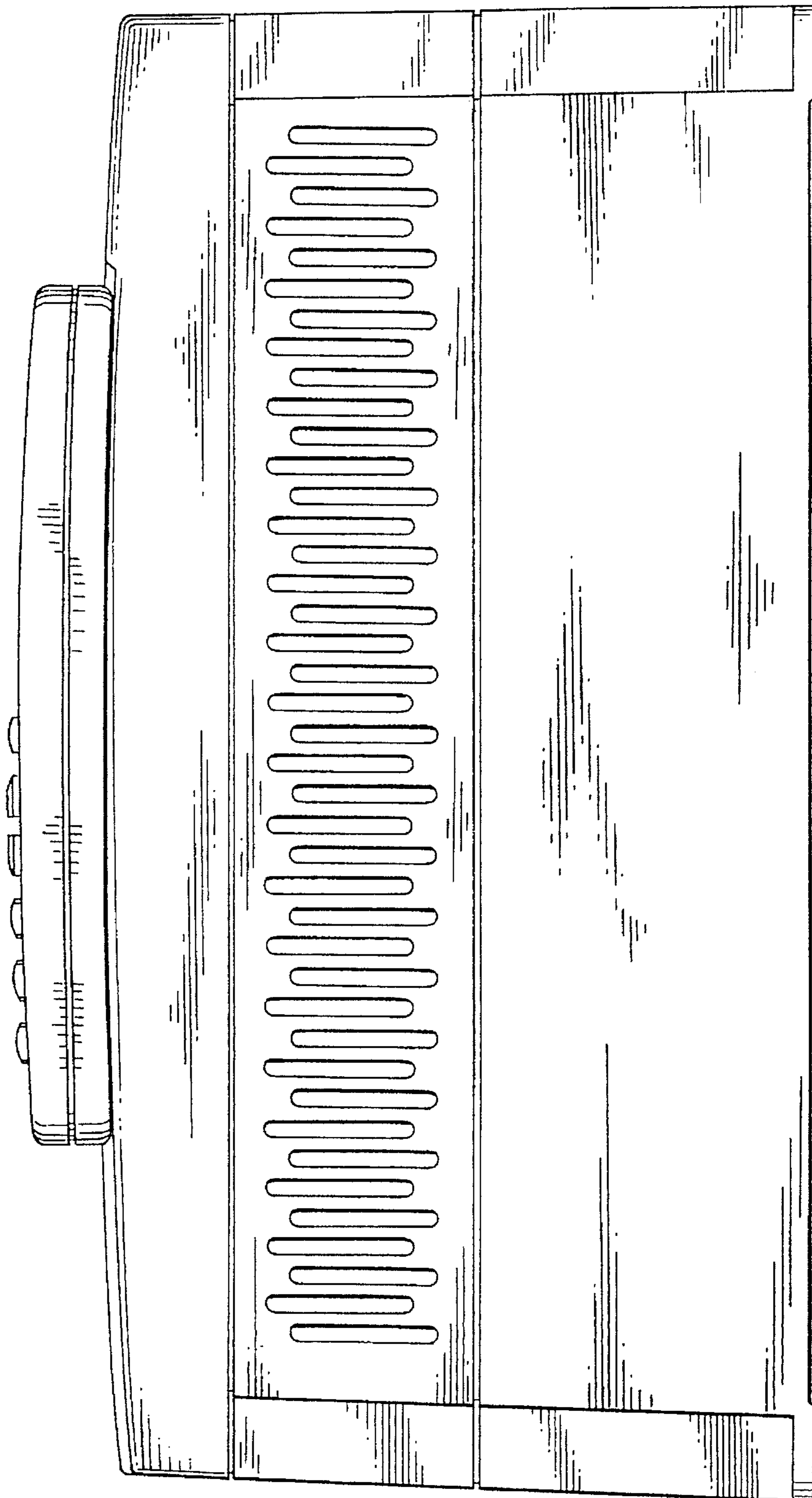

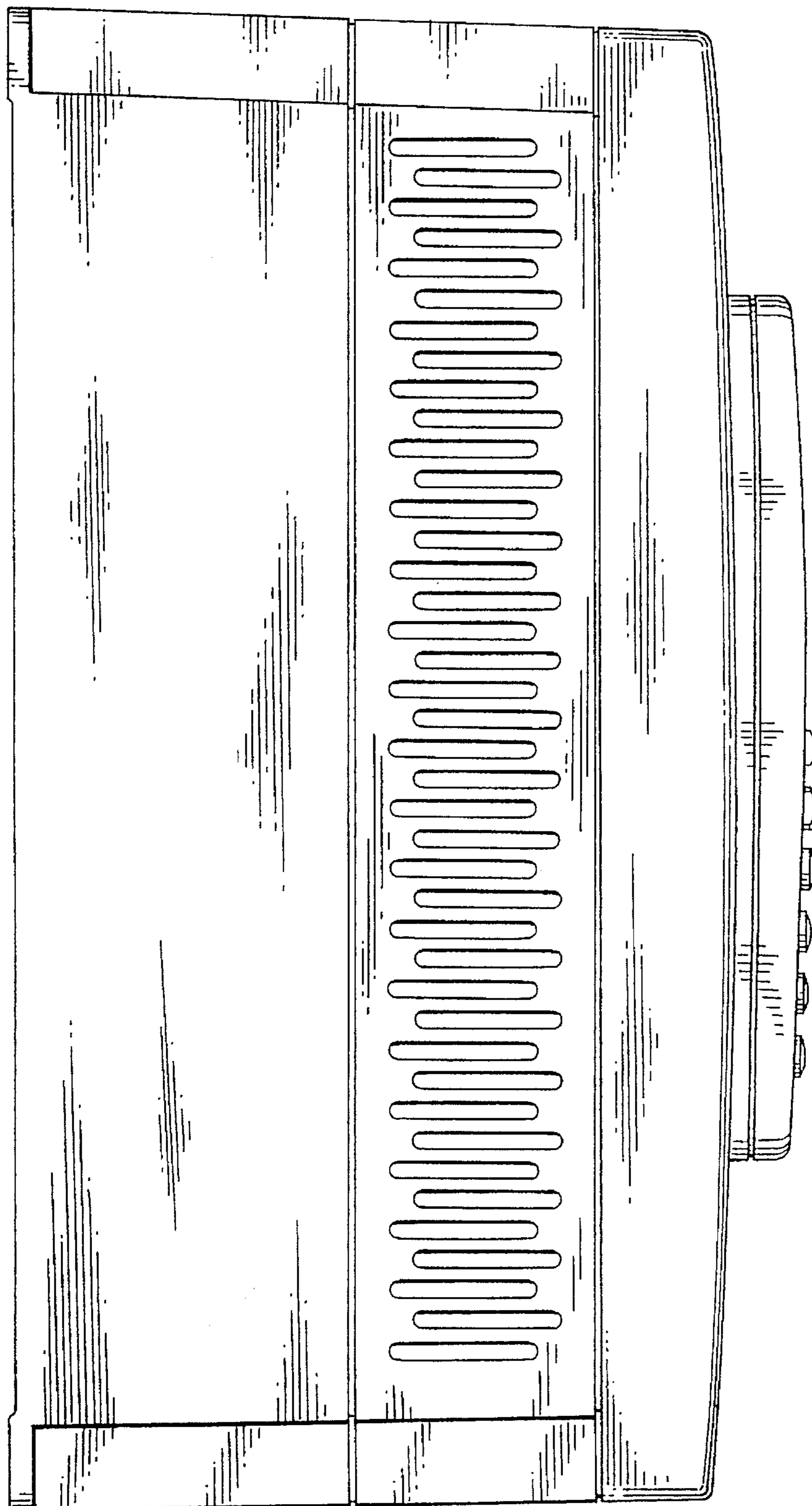

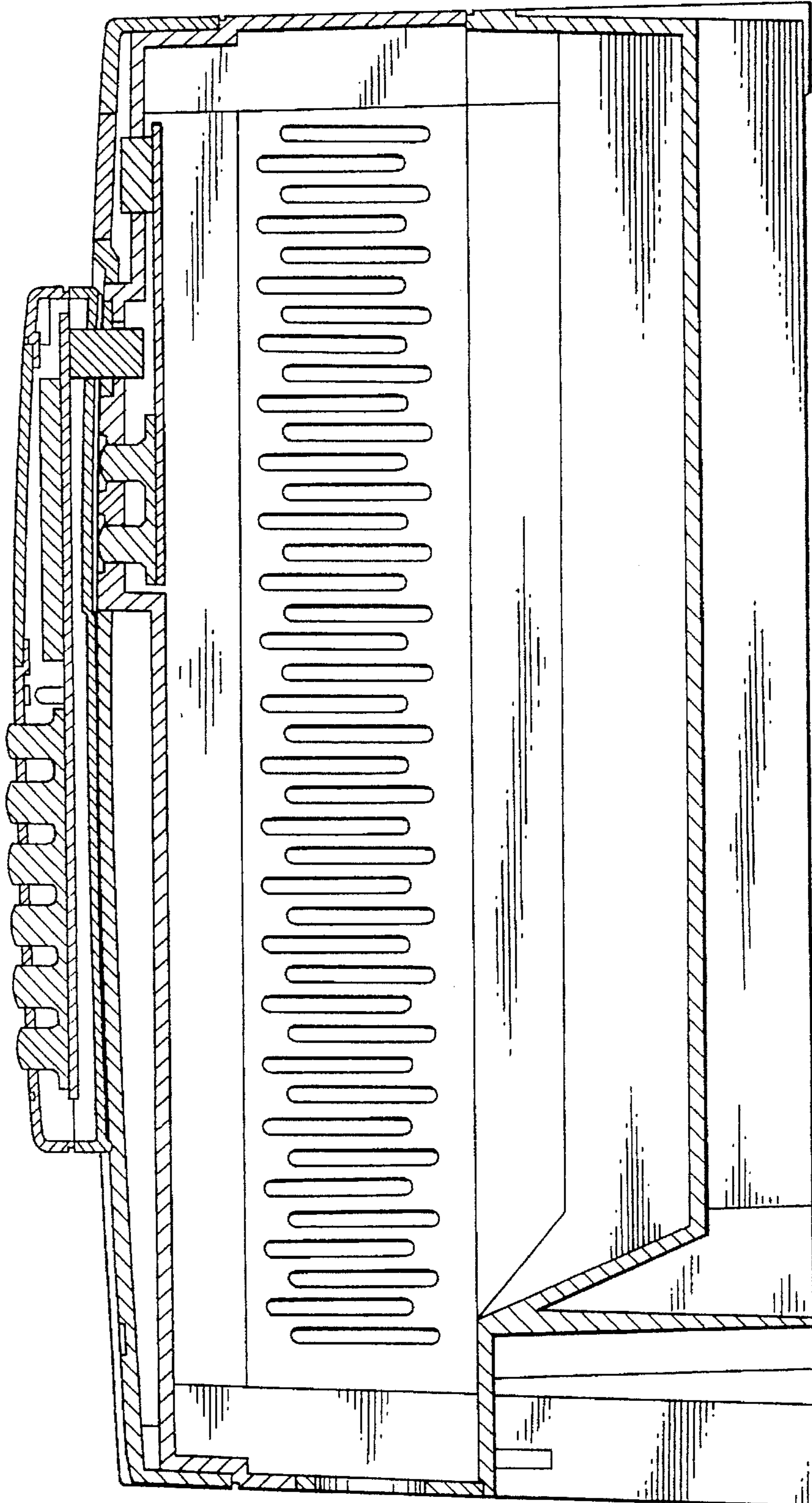

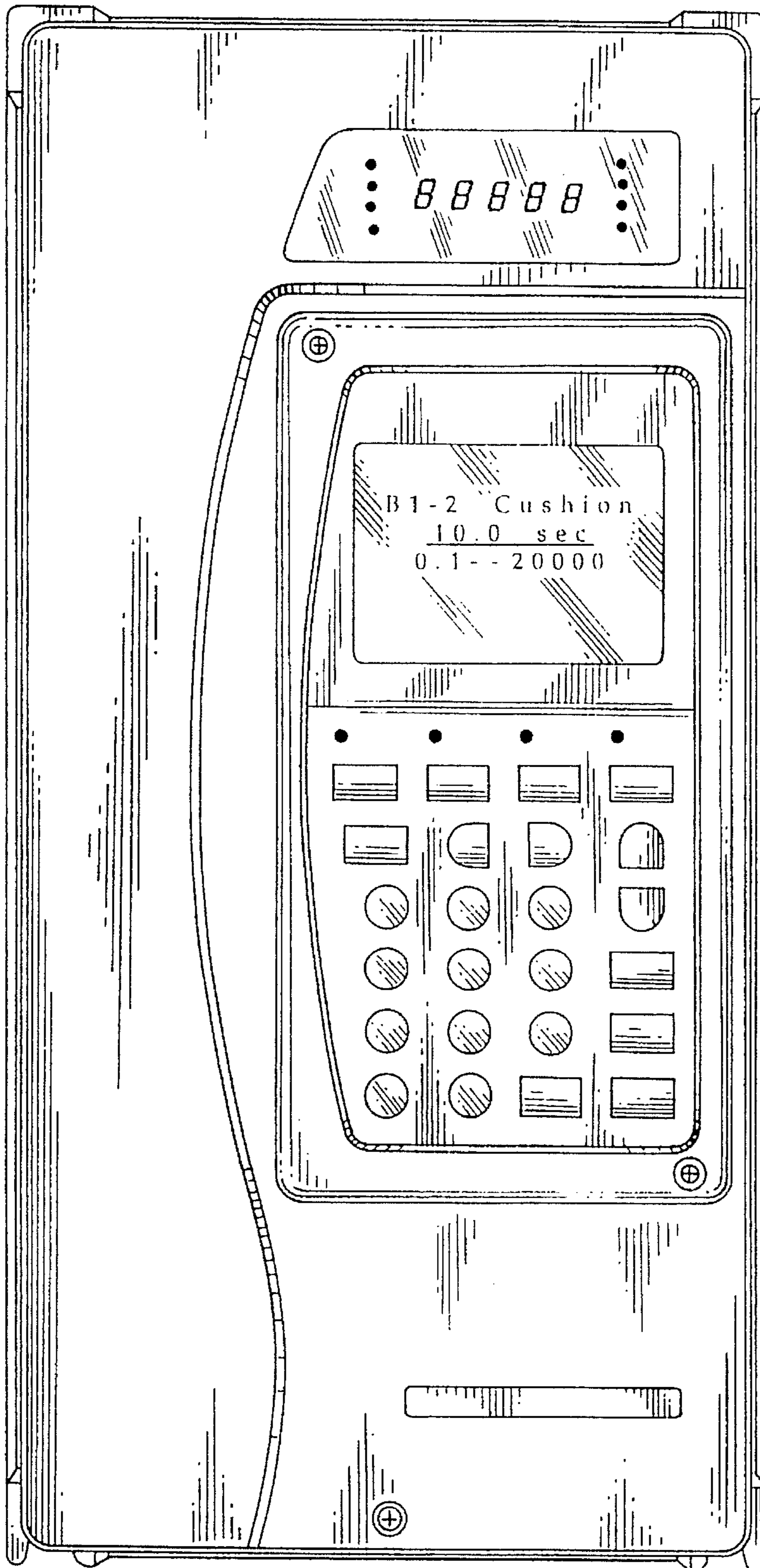
