[57] **CLAIM**

The ornamental design for a skate boot, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a skate boot showing my new design, the skate frame and wheels shown in broken lines are for illustrative purposes only and form no part of claimed design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a right side elevation view;
FIG. 5 is a left side elevation view thereof;
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is a top plan view thereof.

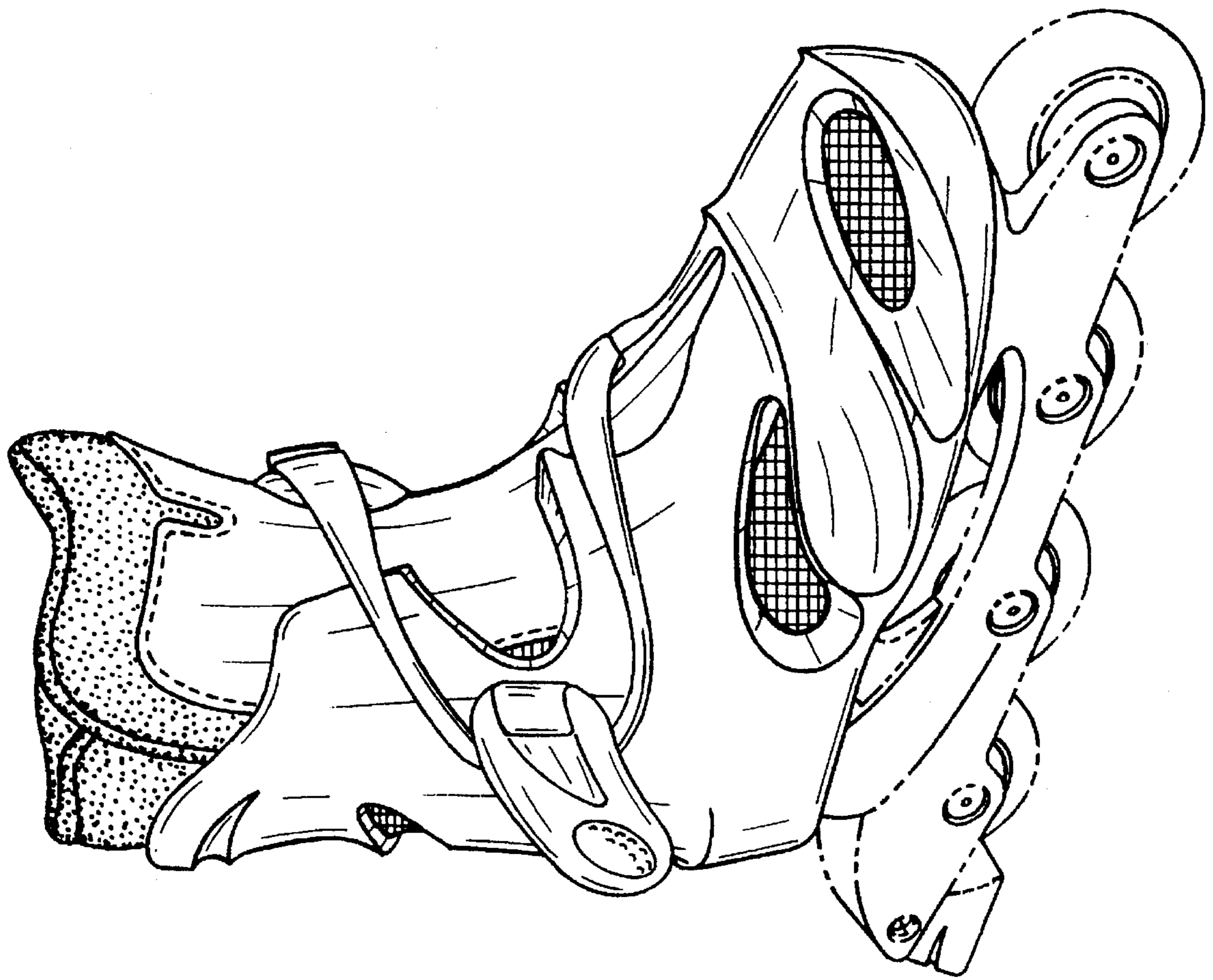

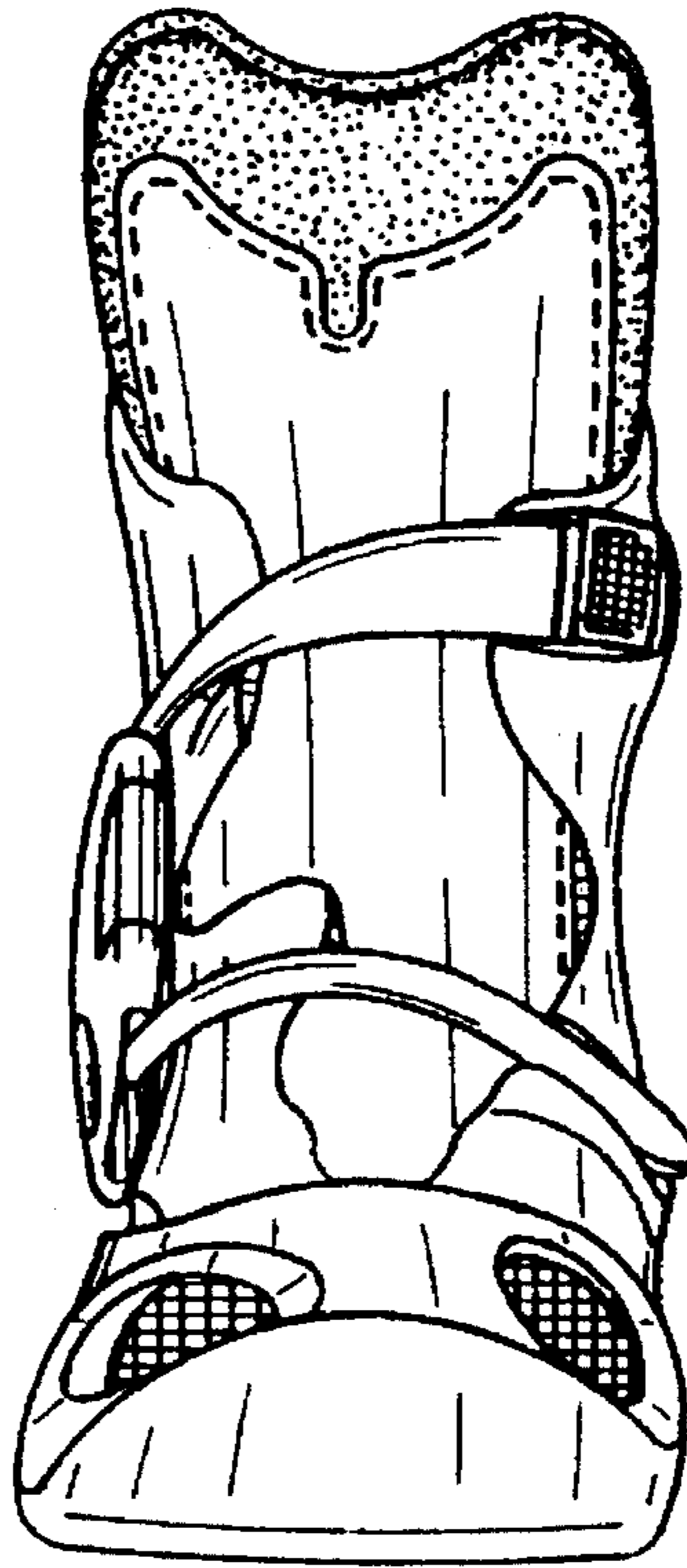
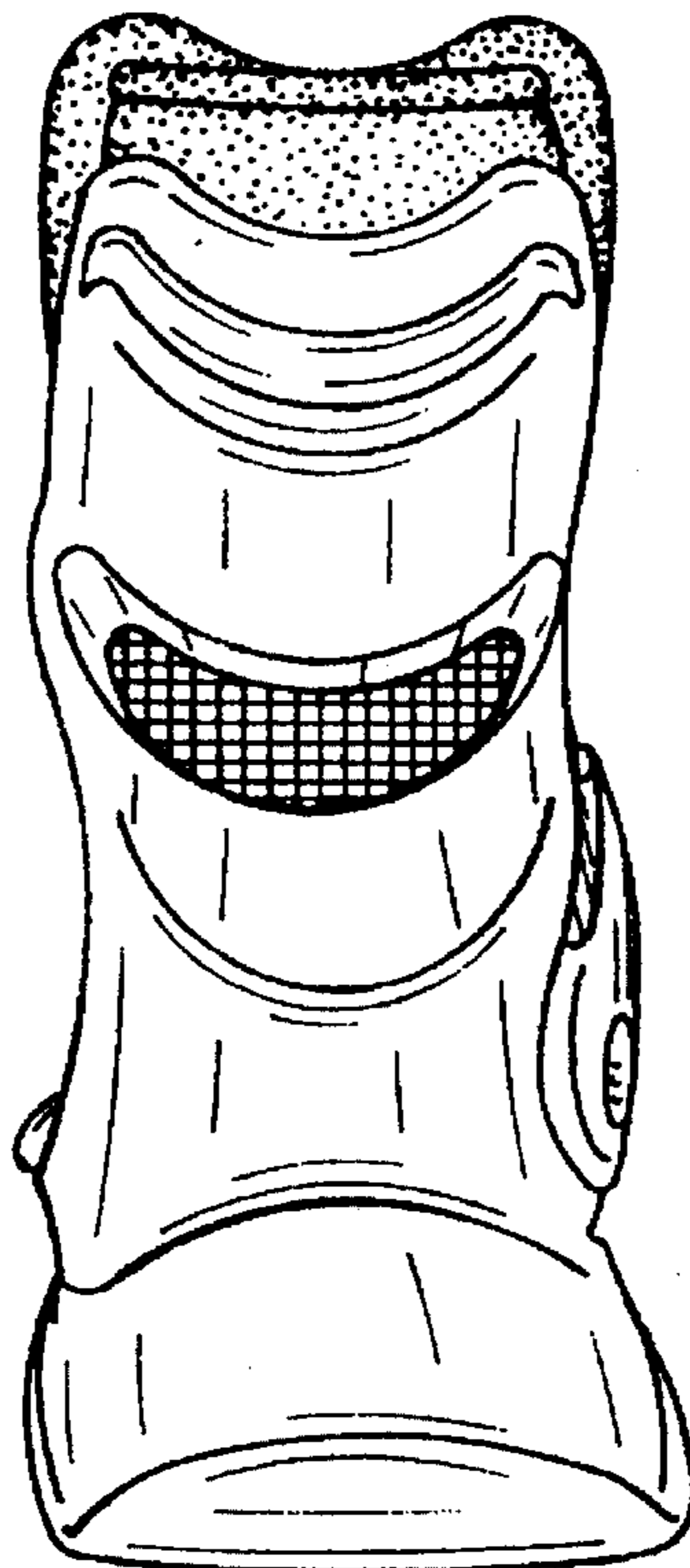

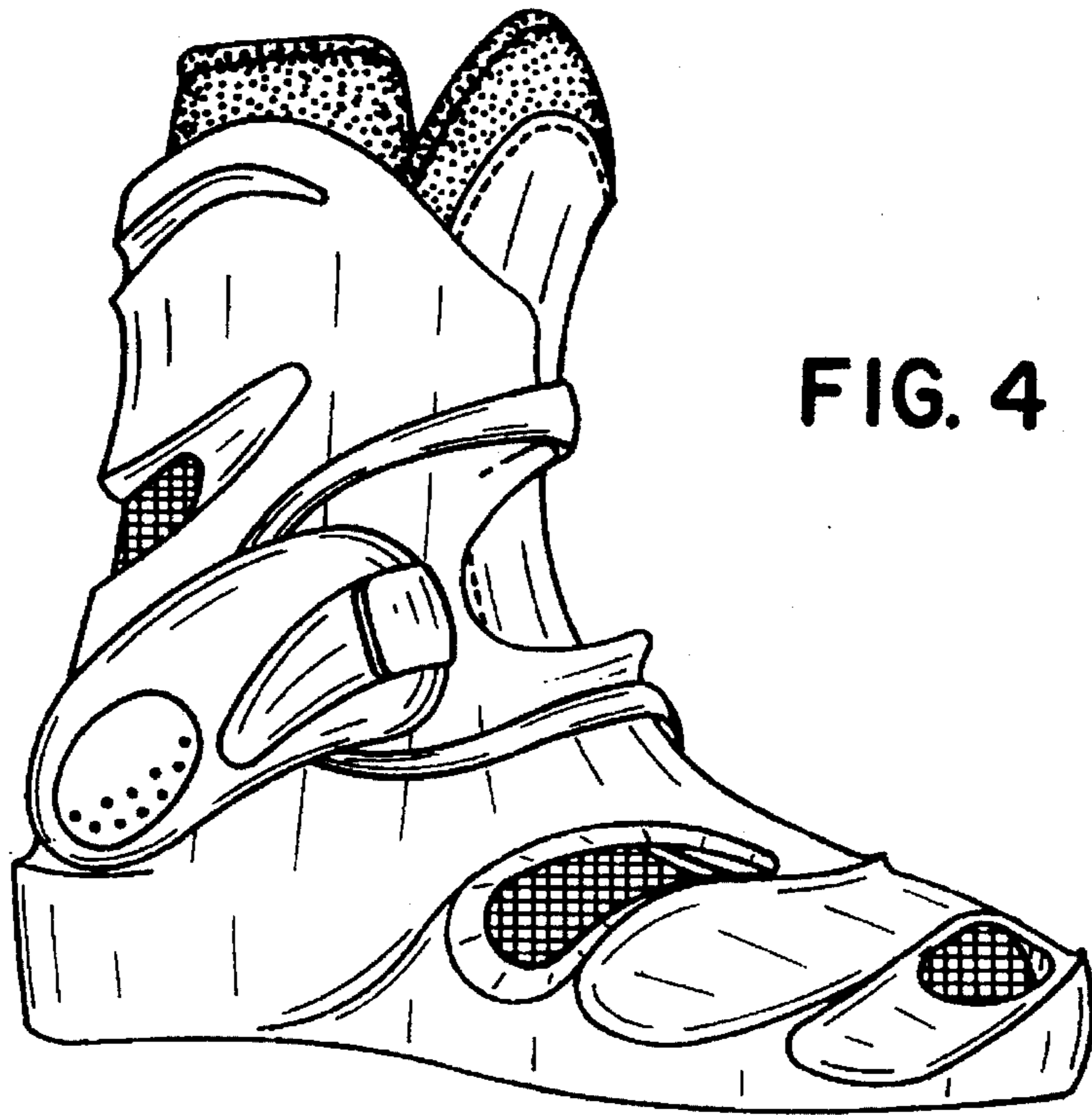

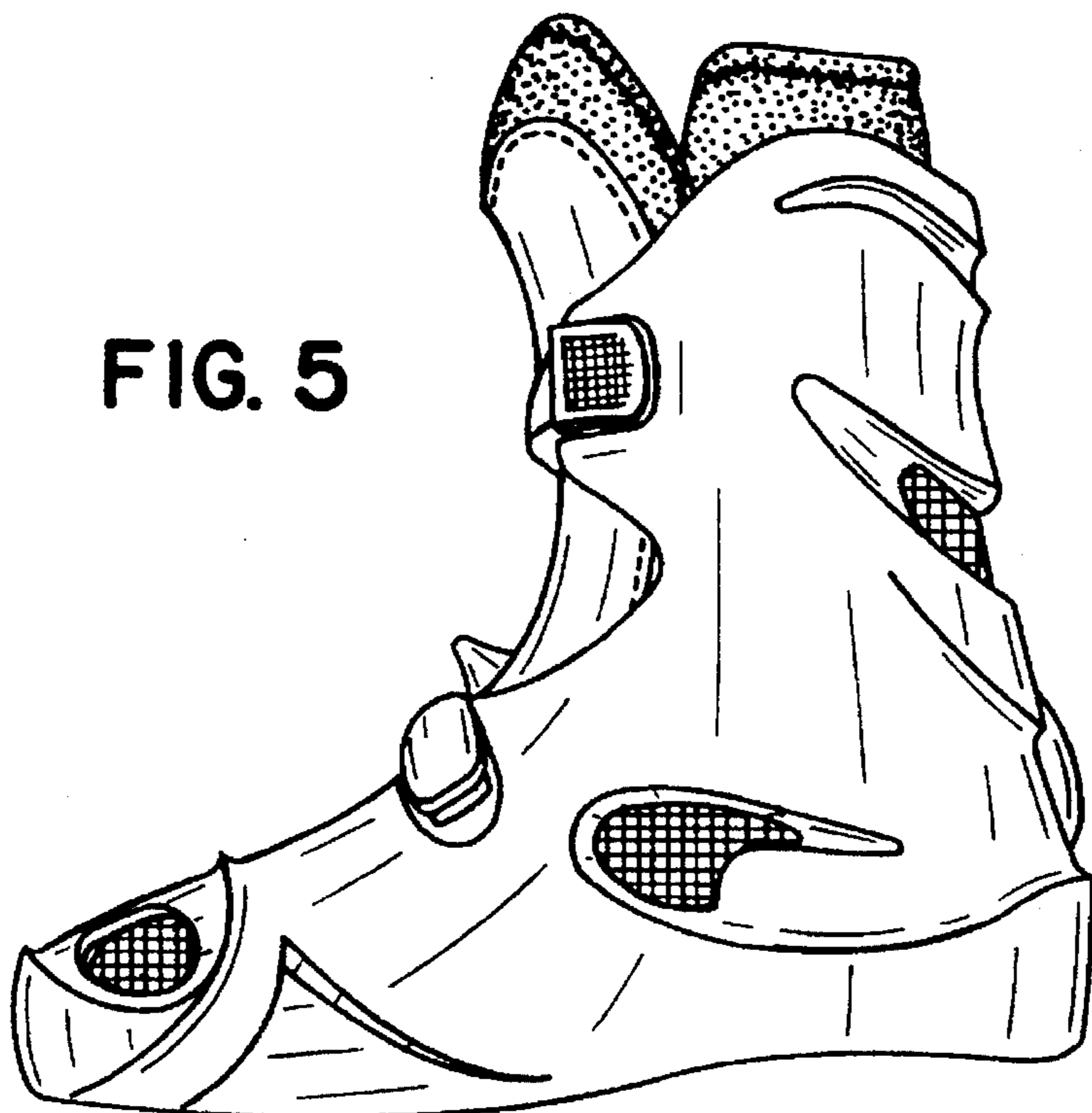

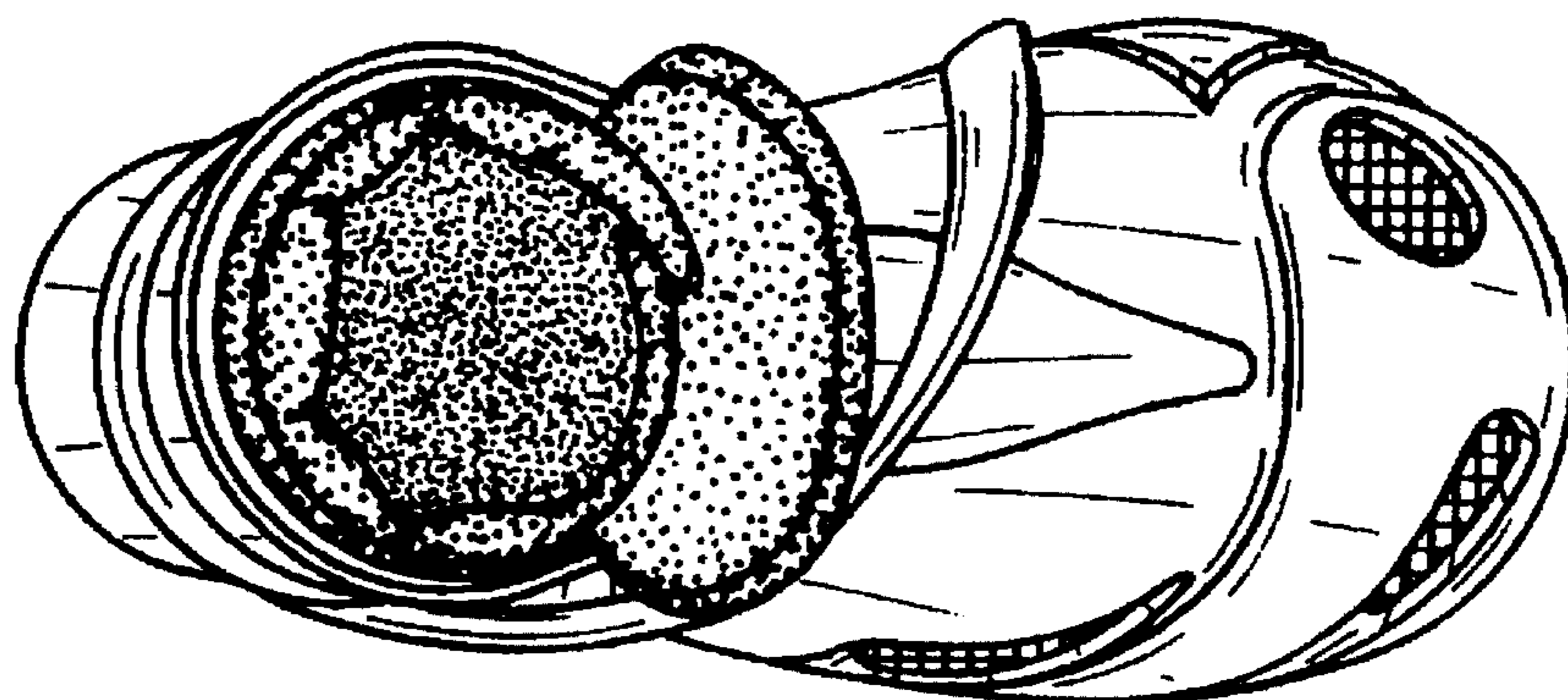
