DESCRIPTION

FIG. 1 is a top plan view of a repeat pattern of a shoe sole showing my new design, the broken lines shown along the borders representing the boundaries of the repeat units, and not being claimed as part of the design; and, FIG. 2 is an enlarged fragmentary view taken on line 2—2 of FIG. 1.

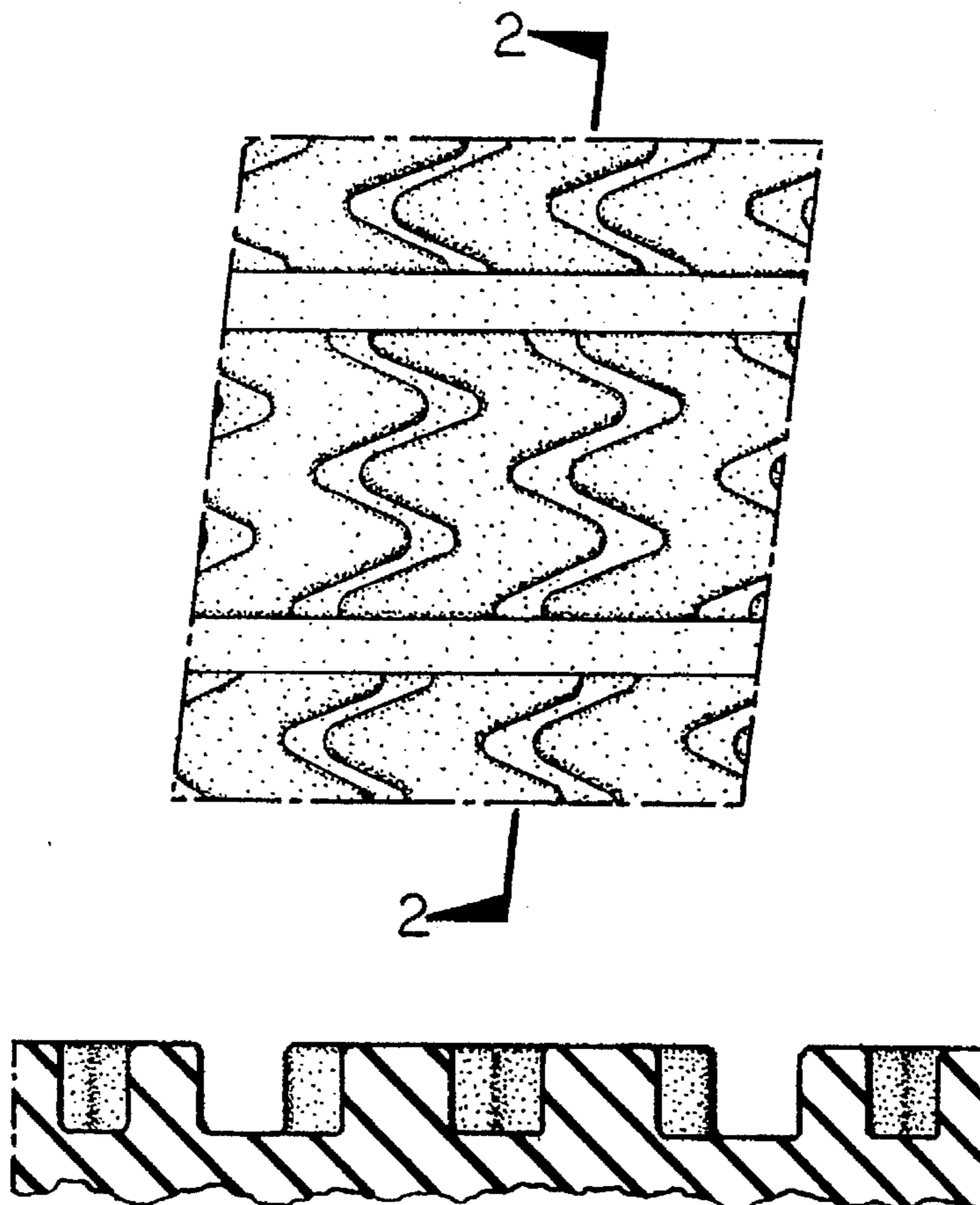

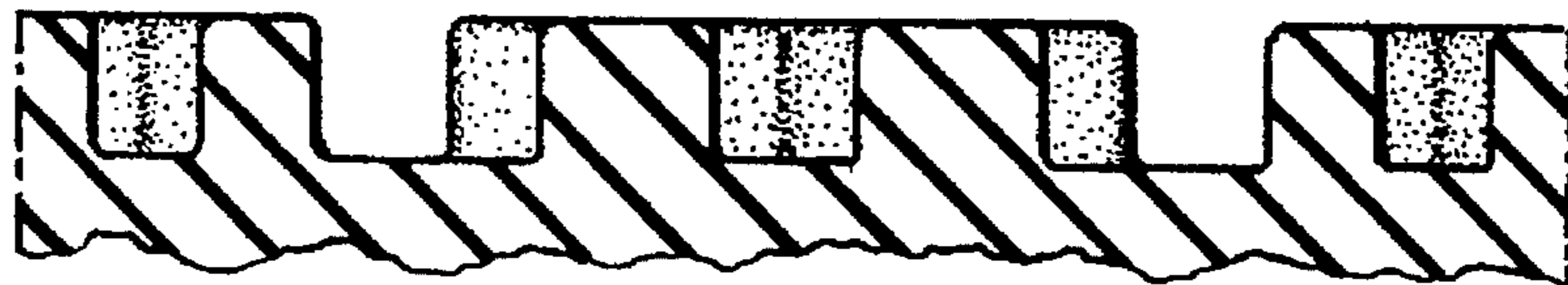
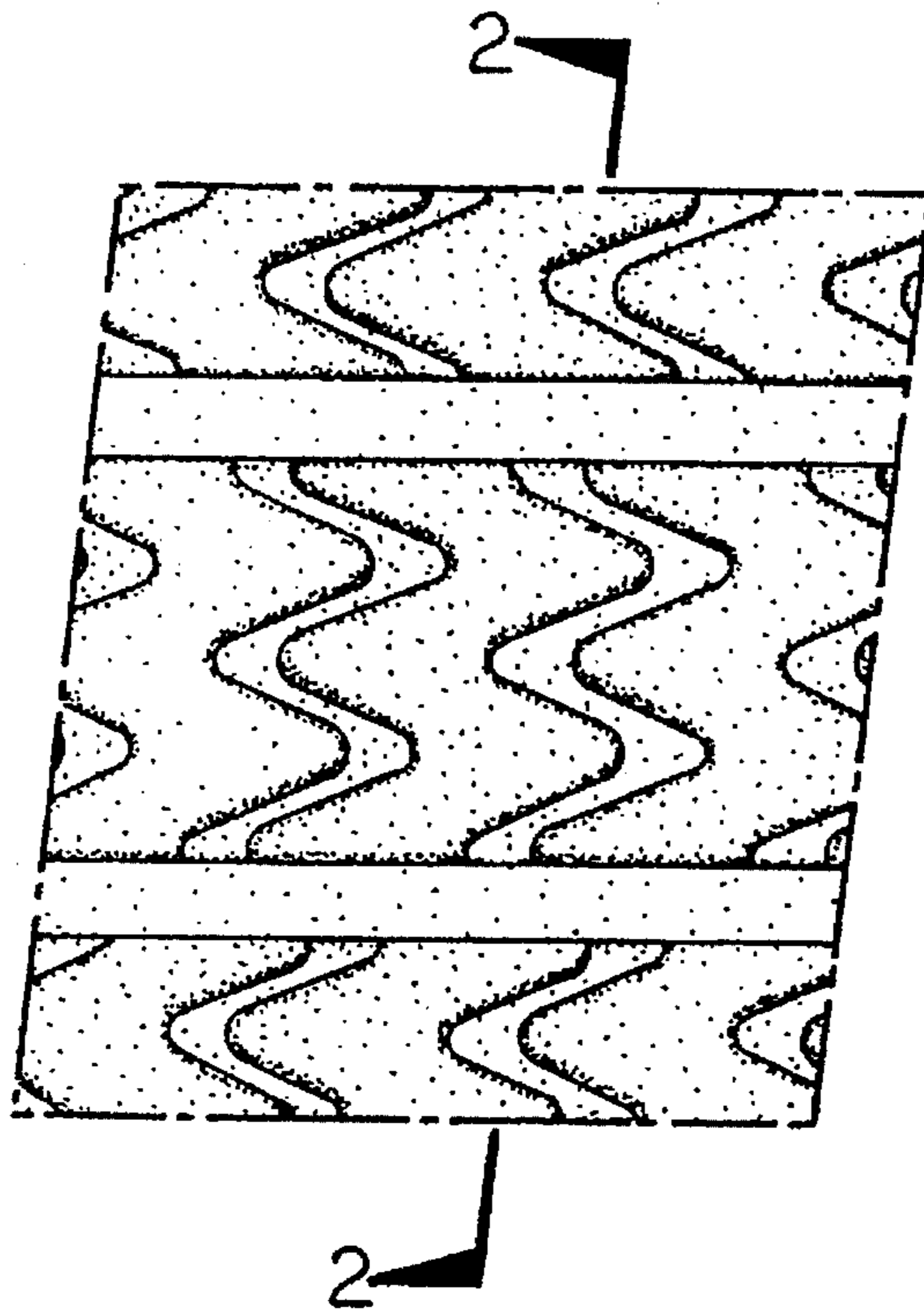
