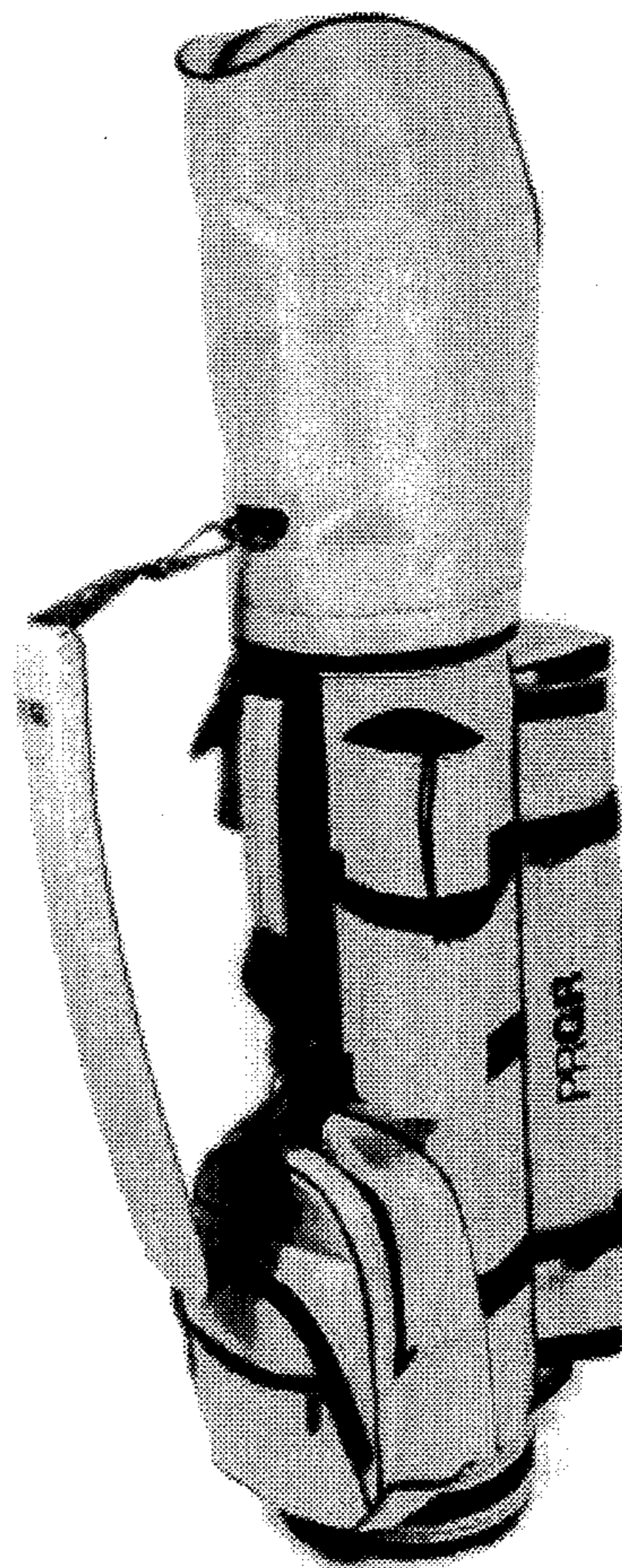
[57] CLAIM

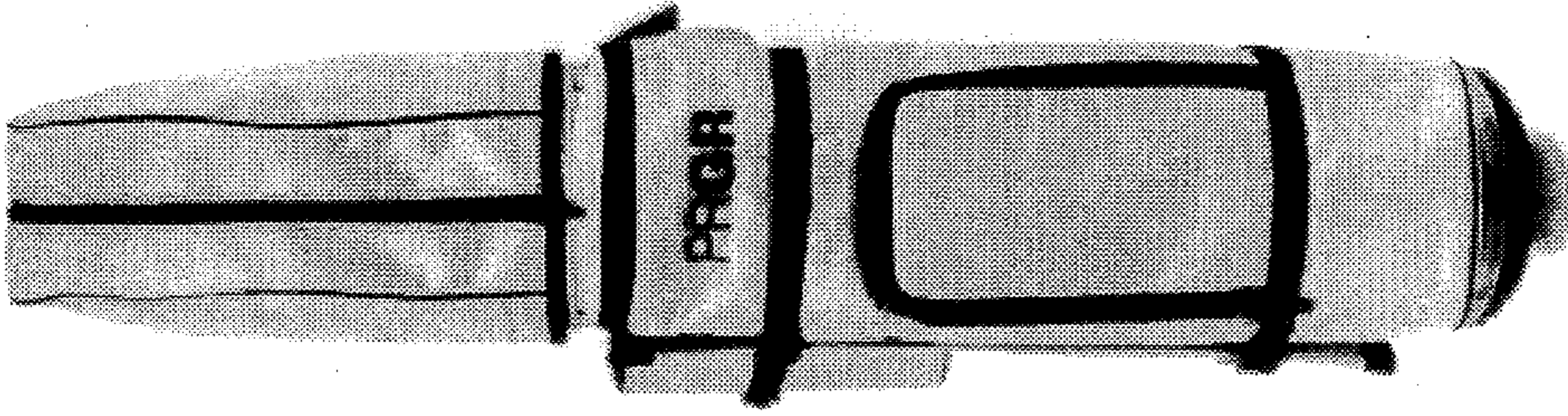

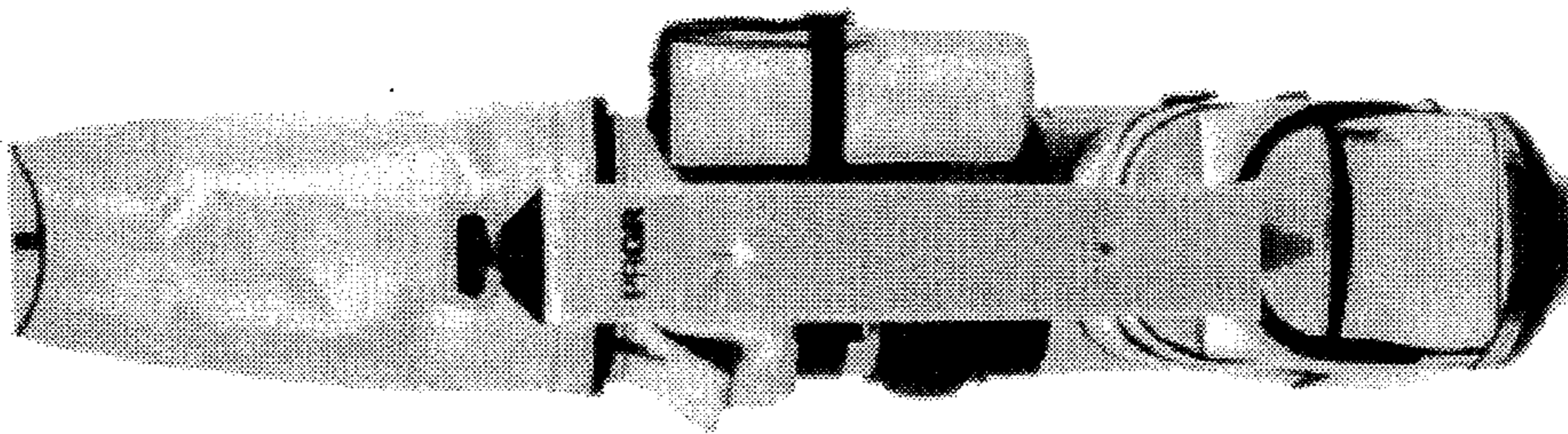

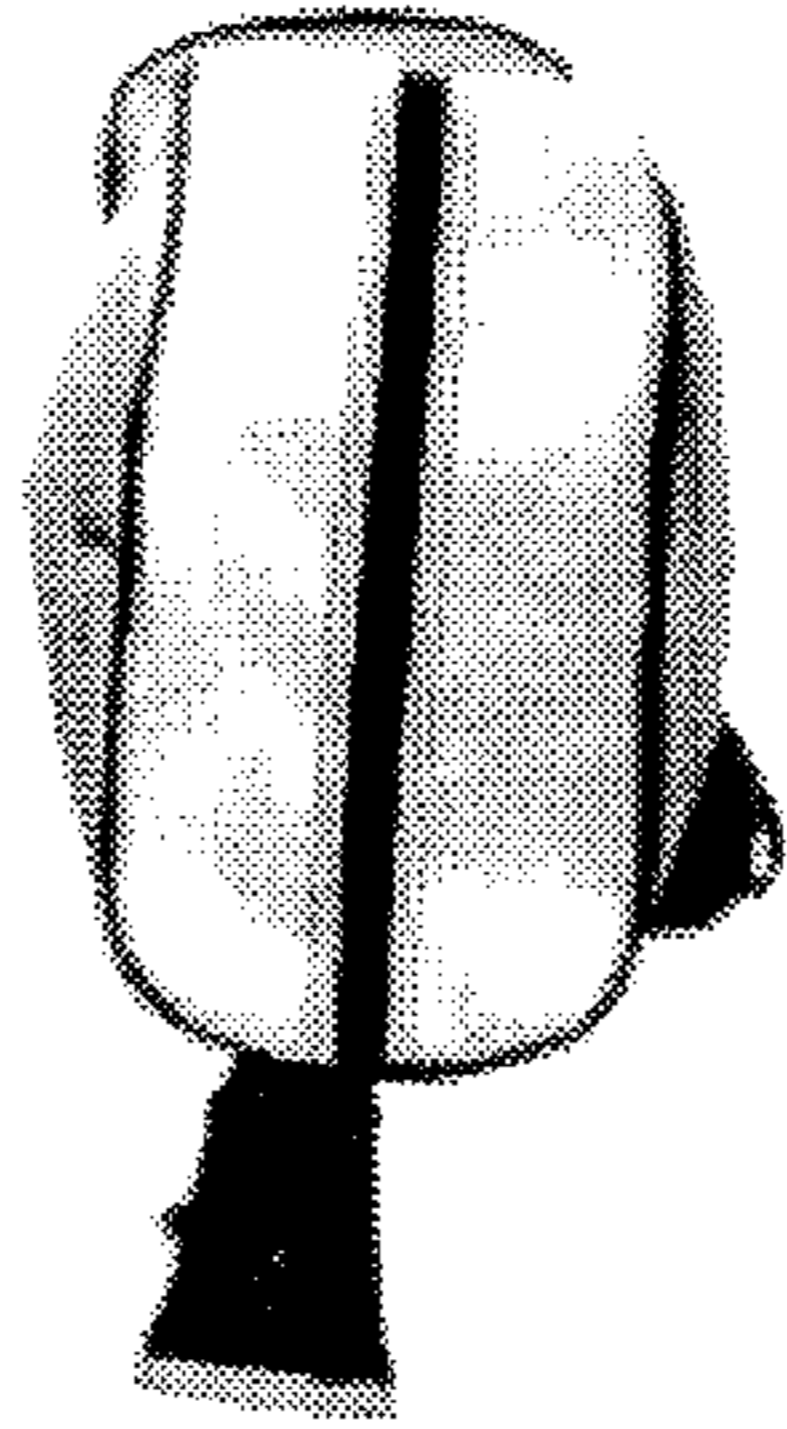

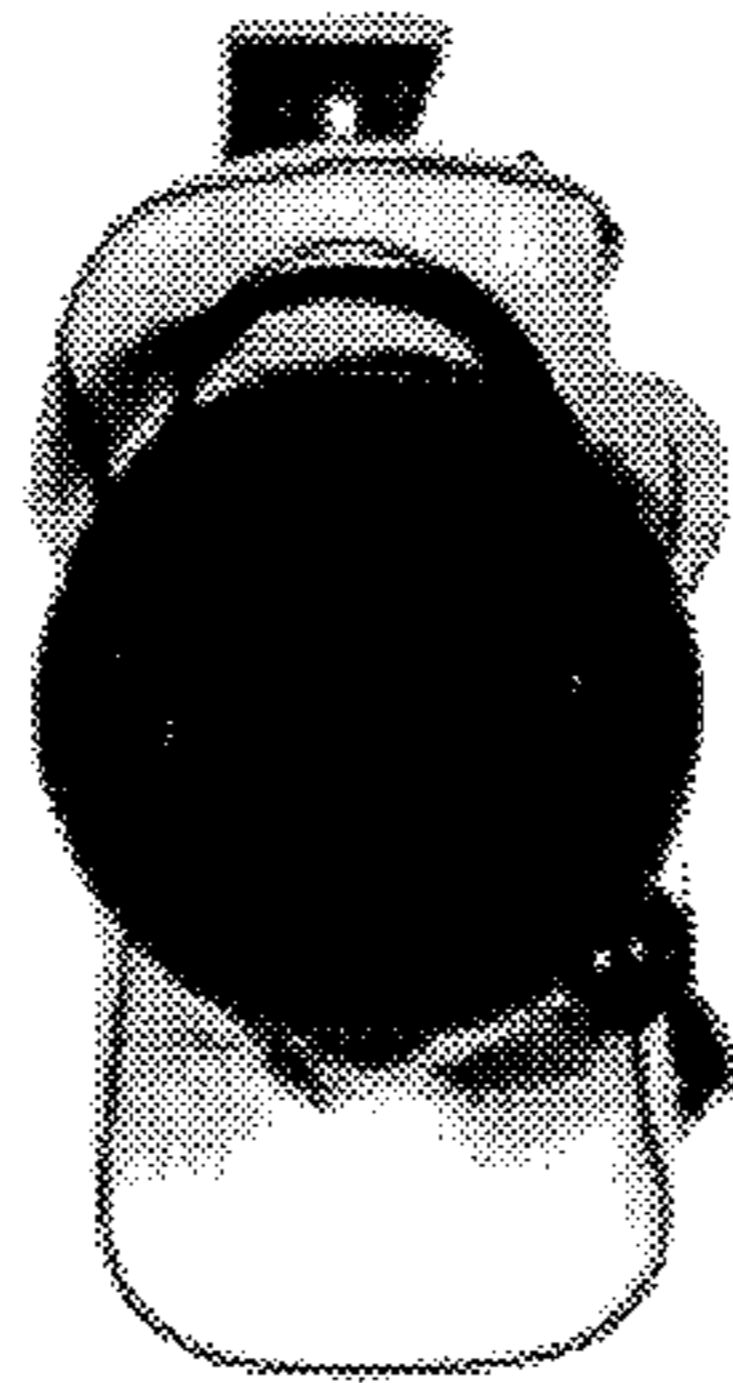

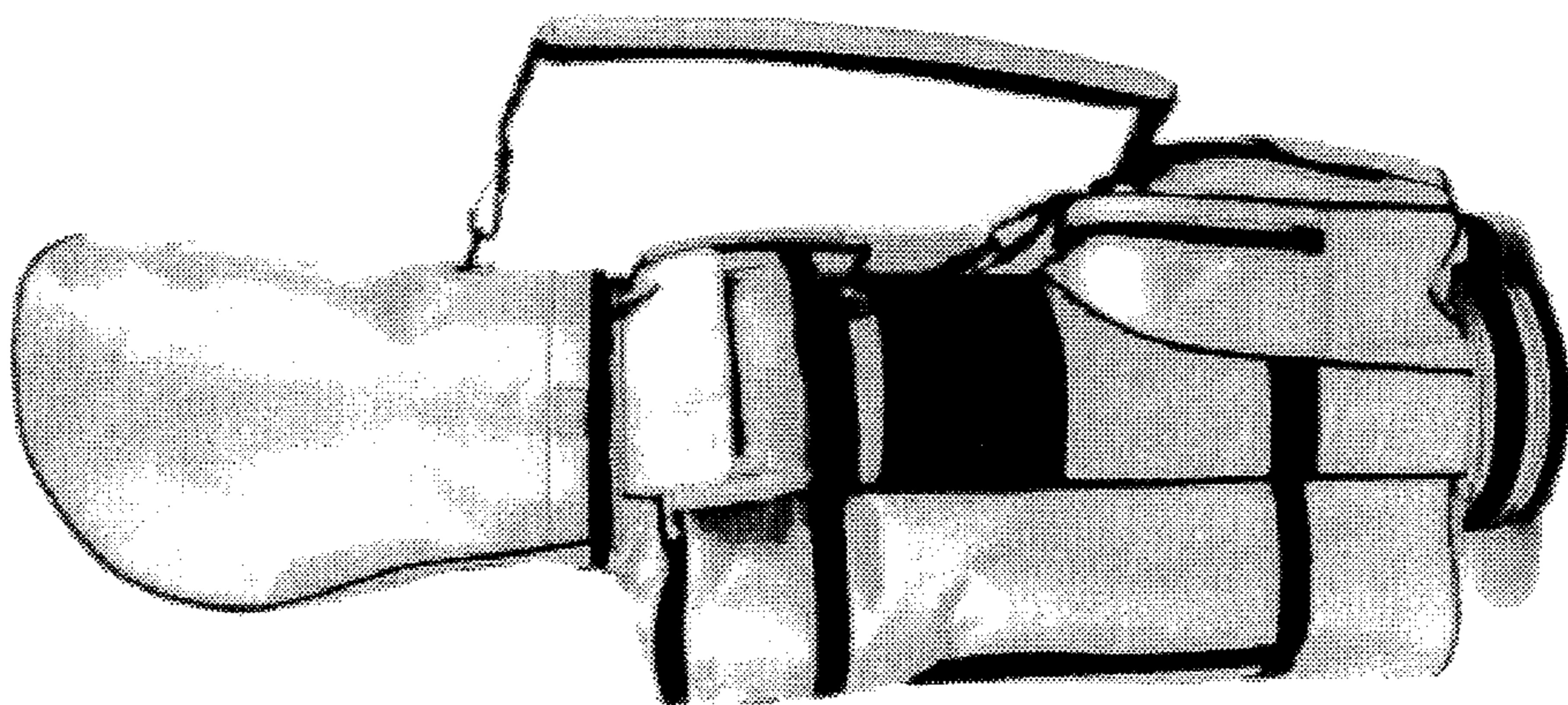

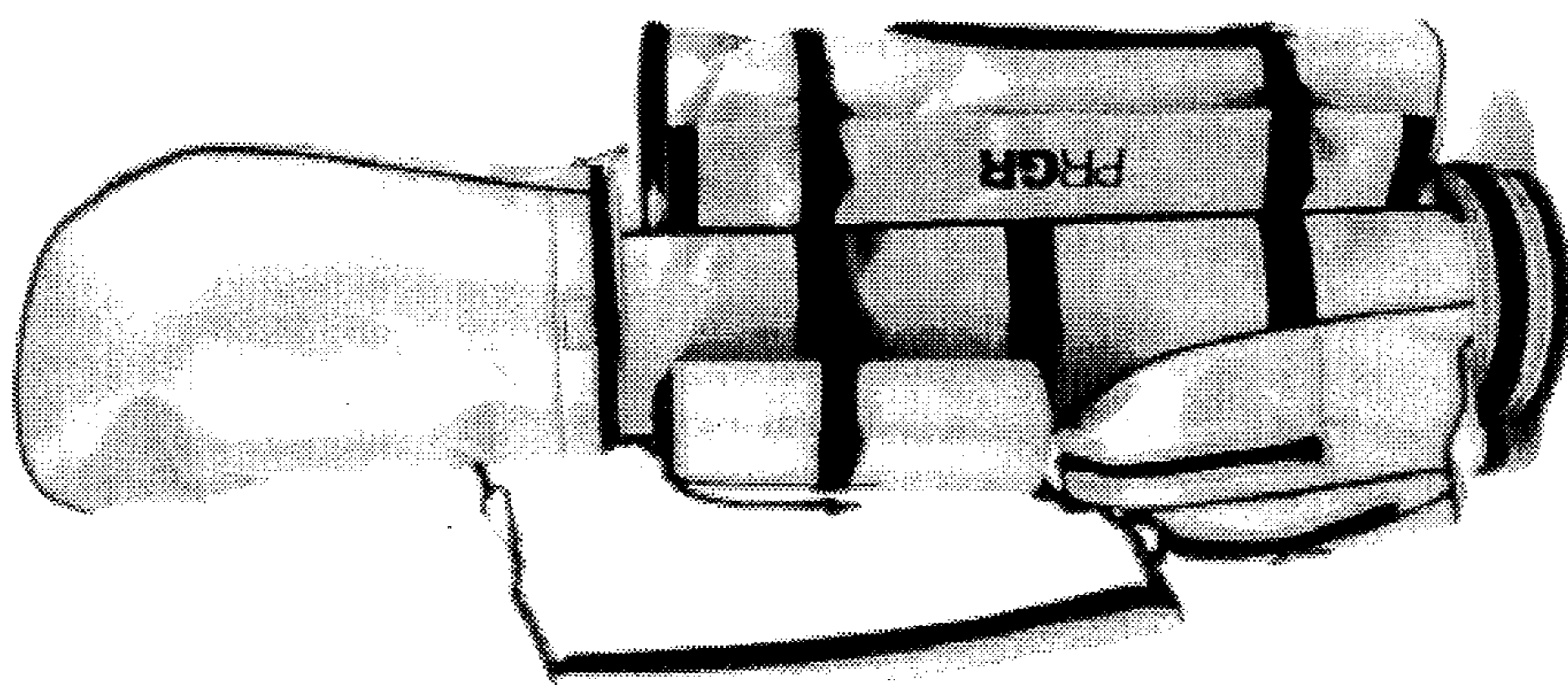

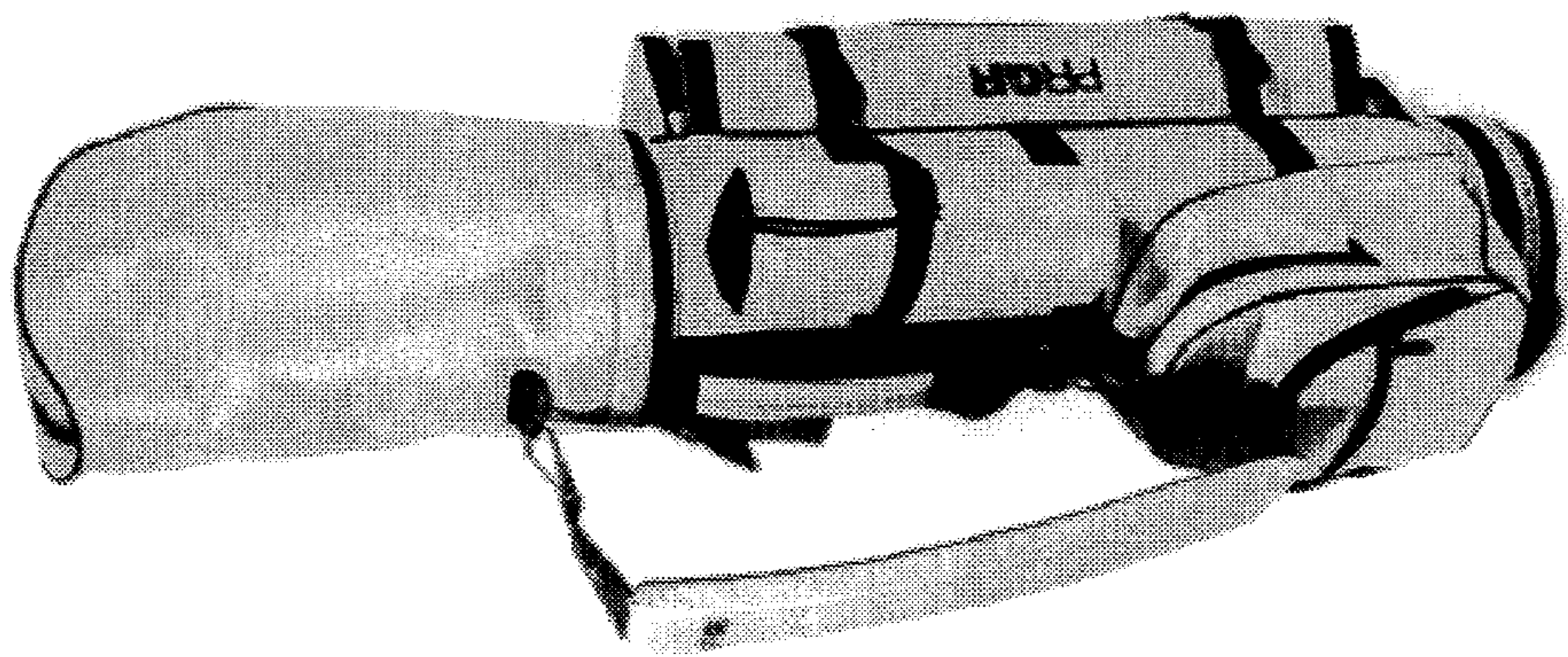

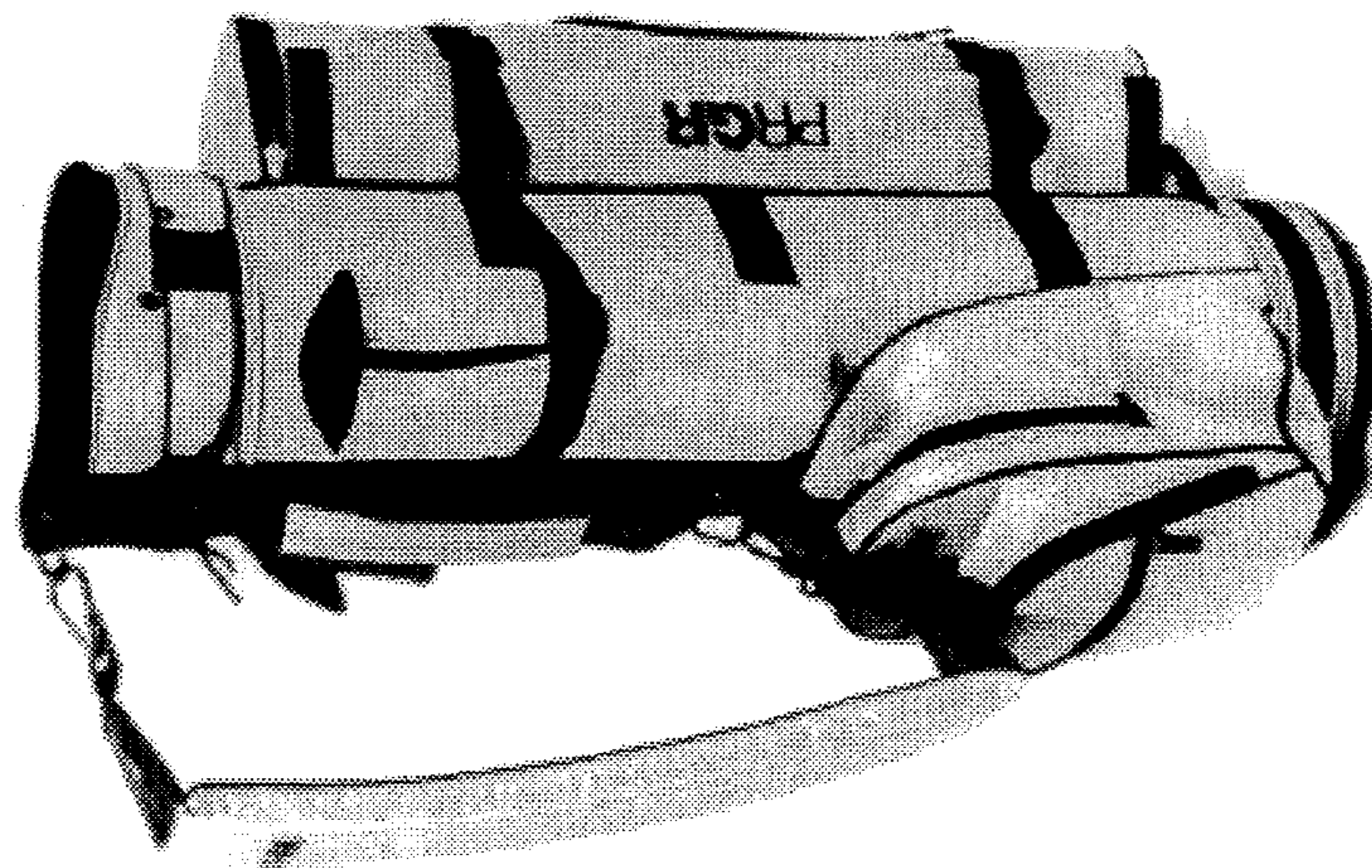
