[57] **CLAIM**

The ornamental design for a food storage container lid, as shown and described.

DESCRIPTION

FIG. 1 is a top right front perspective view of a food storage container lid showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a left side elevational view thereof;

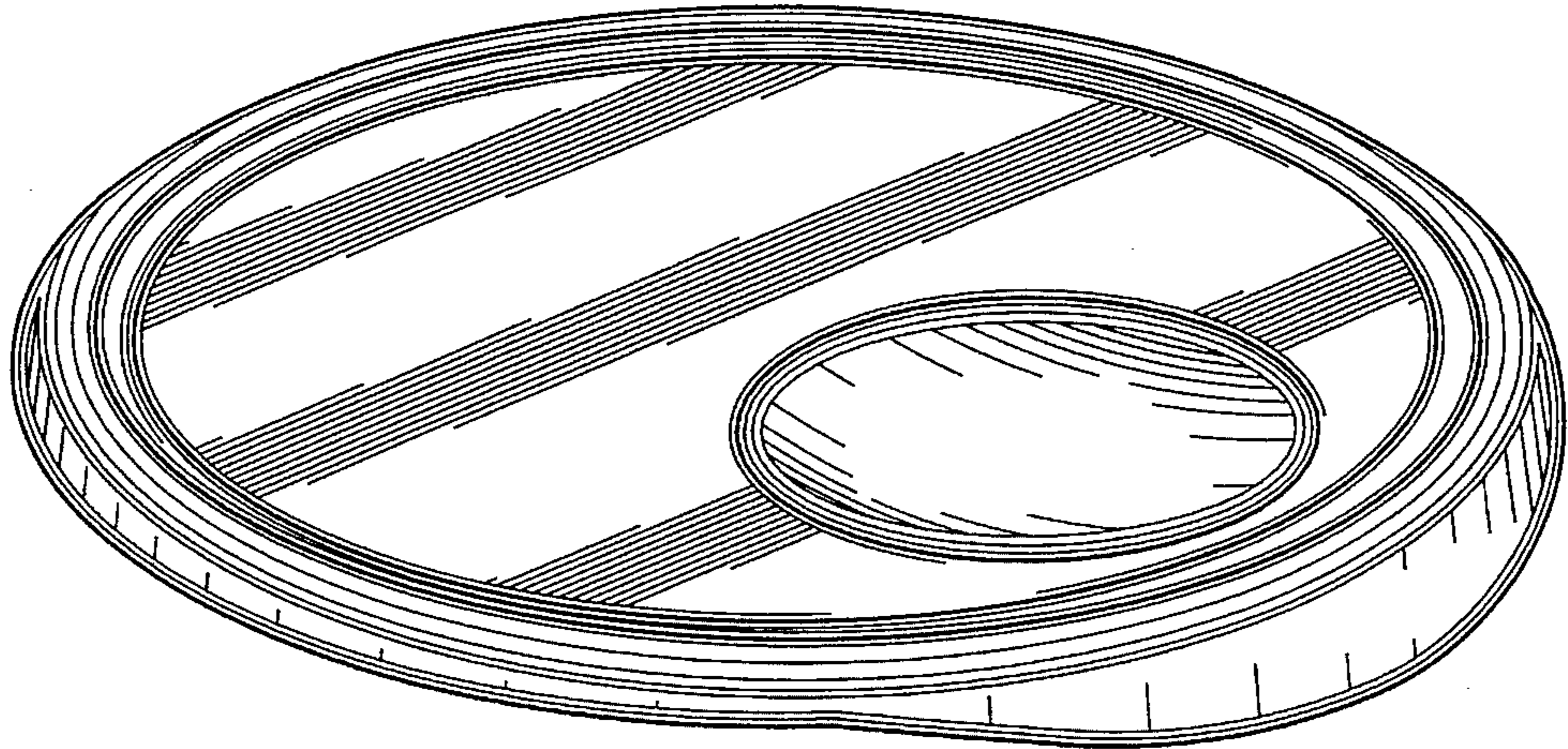
FIG. 4 is a right side elevational view thereof;

FIG. 5 is a front elevational view thereof; the rear elevational view being a mirror image;

FIG. 6 is a bottom plan view thereof; and,

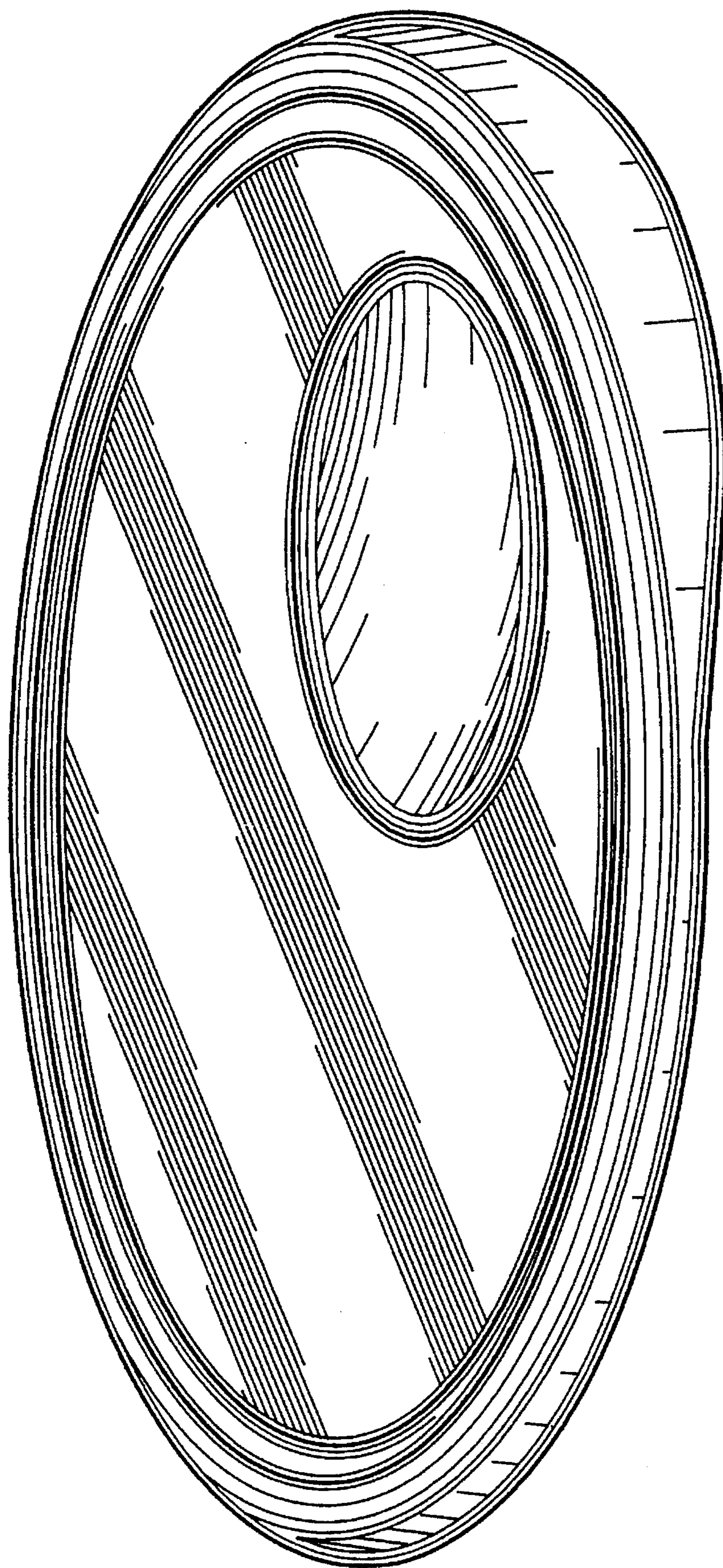

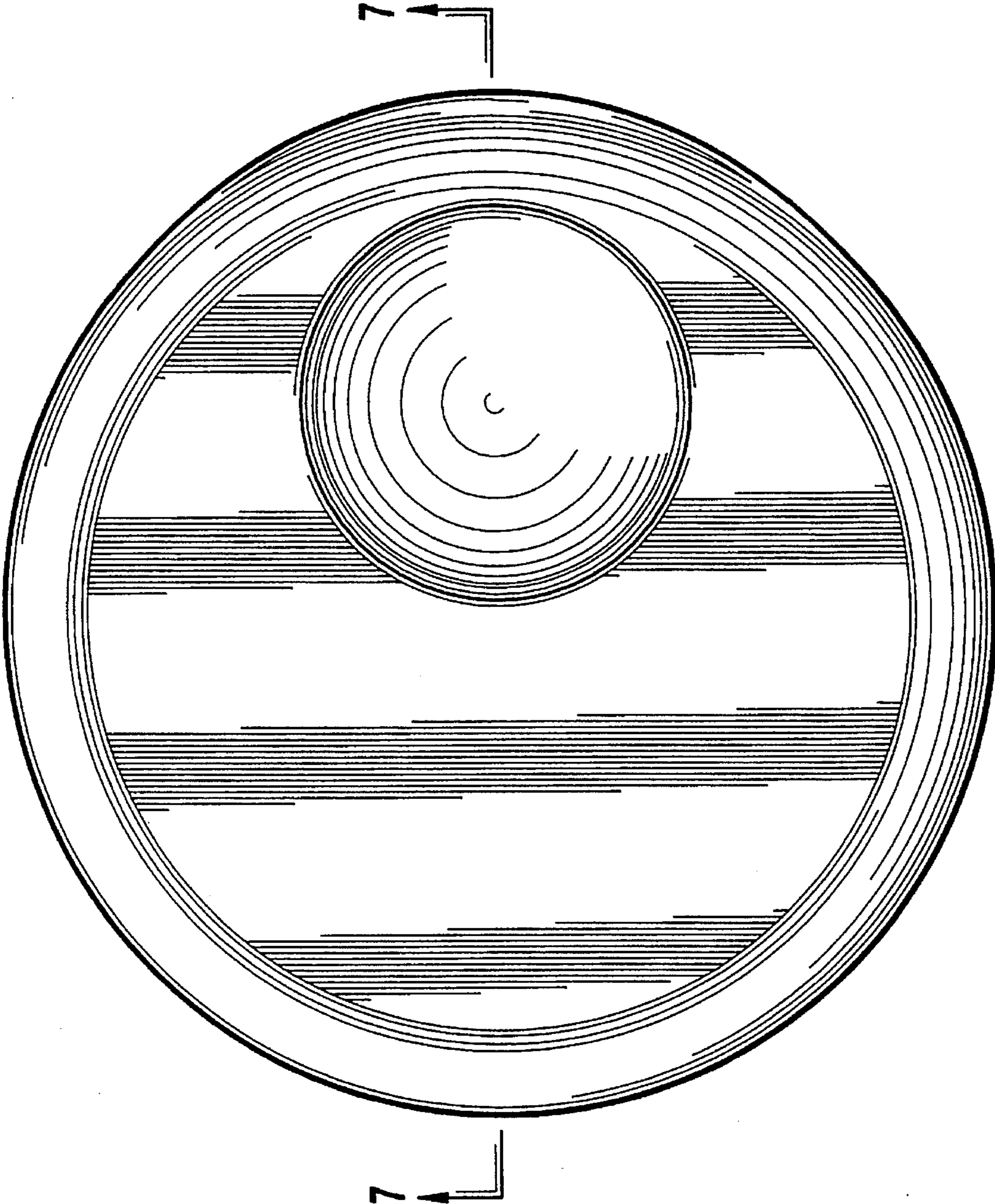

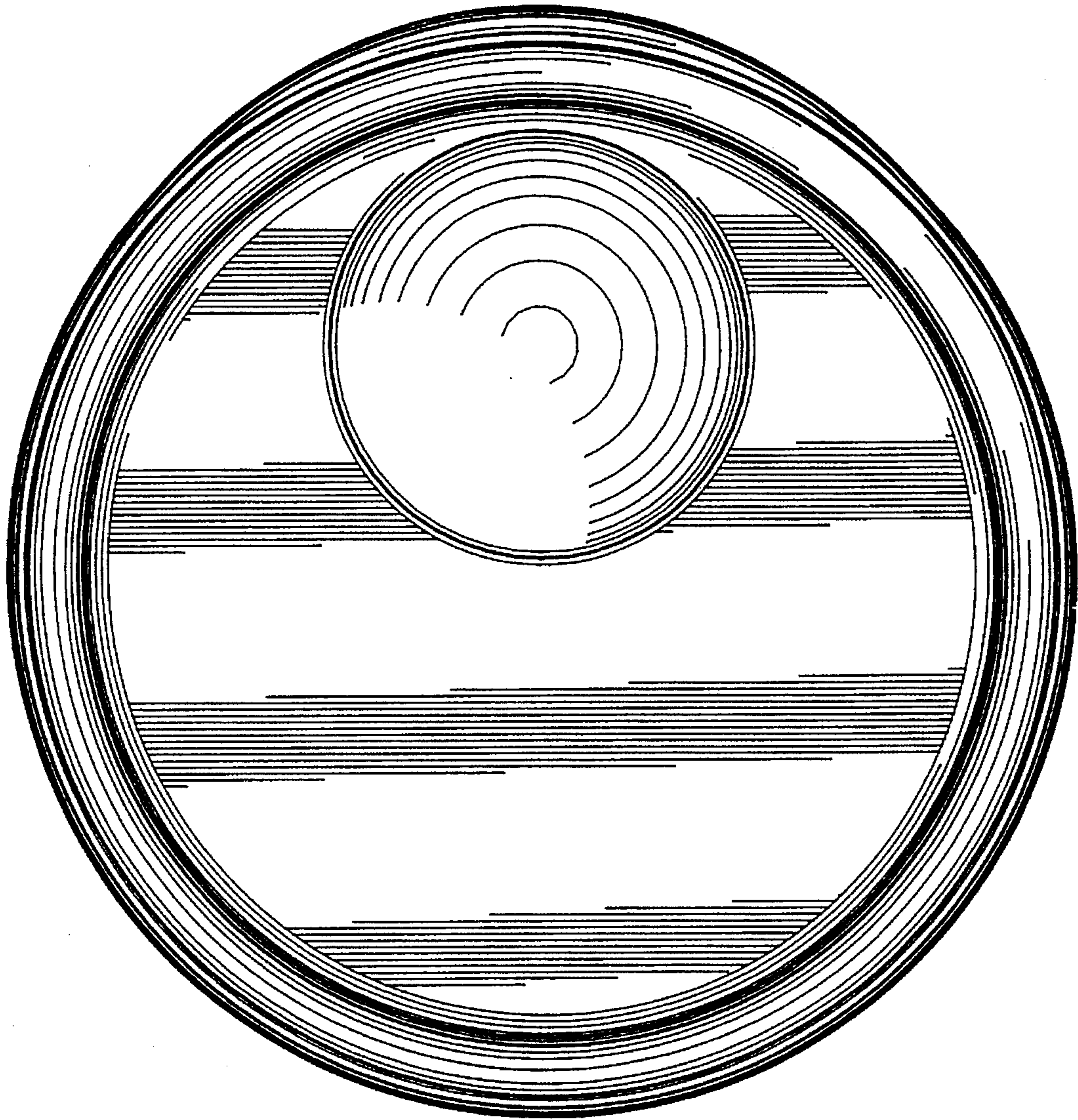

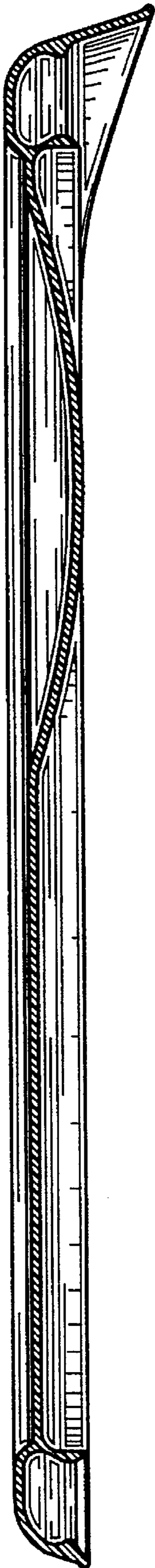
