[57] **CLAIM**

The ornamental design for combined flexible pickup tool components, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of combined flexible pickup tool components showing my new design, with the remaining components being shown in phantom lines for illustrative purposes only and form no part of the claimed design;

FIG. 2 is an enlarged, front elevational view of one of the components of FIG. 1;

FIG. 3 is a rear elevational view of the component of FIG. 2;

FIG. 4 is a left side elevational view of the component of FIG. 2;

FIG. 5 is a right side elevational view of the component of FIG. 2;

FIG. 6 is a top plan view of the component of FIG. 2;

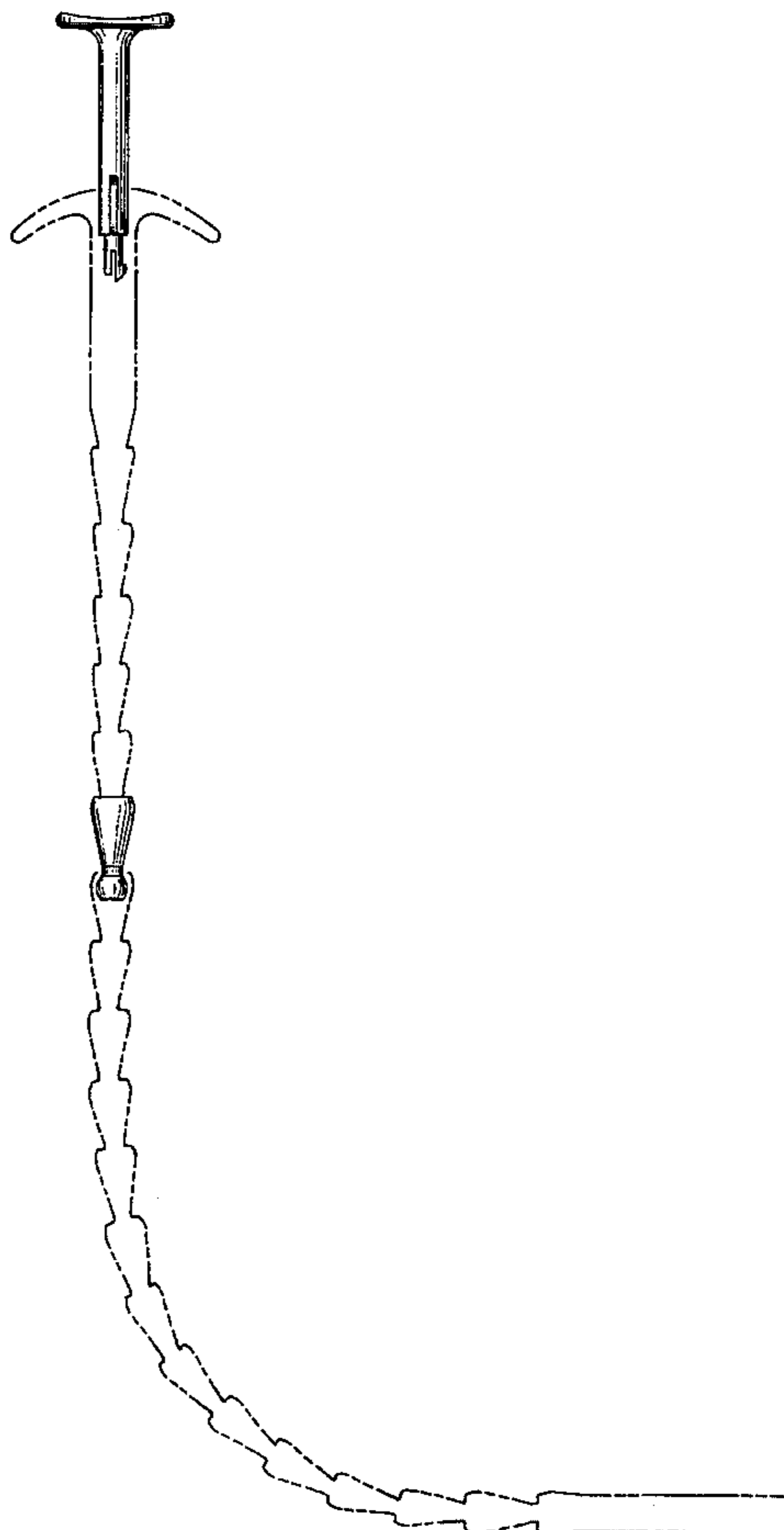
FIG. 7 is a bottom plan view of the component of FIG. 2;

FIG. 8 is an enlarged, side elevational view of another of the components of FIG. 1, the opposite side, front and rear elevational views being identical;

FIG. 9 is a top plan view of the component of FIG. 8; and,

FIG. 10 is a bottom plan view of the component of FIG. 8. The component parts in FIGS. 2-7 and FIGS. 8-10 are shown separately for clarity of illustration.

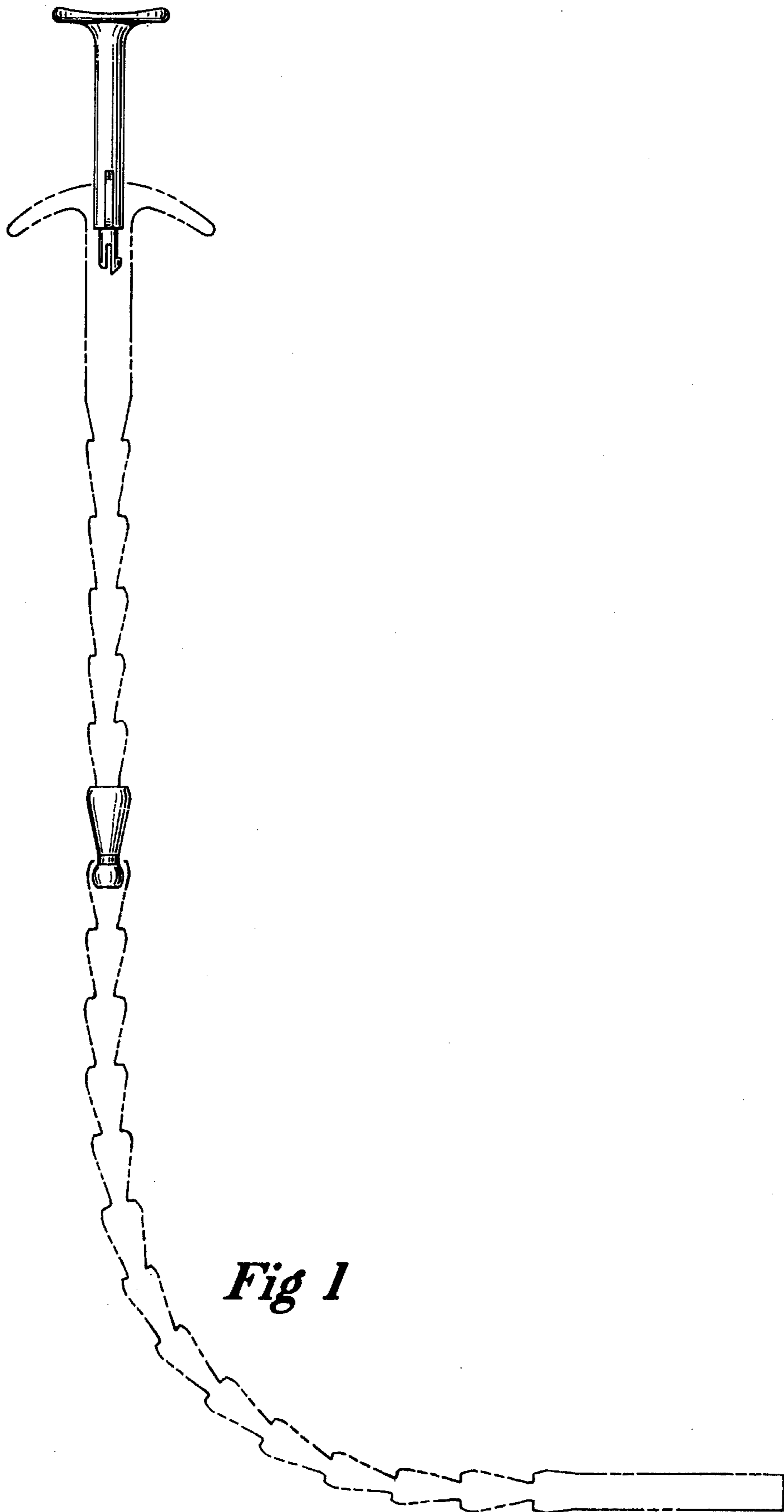

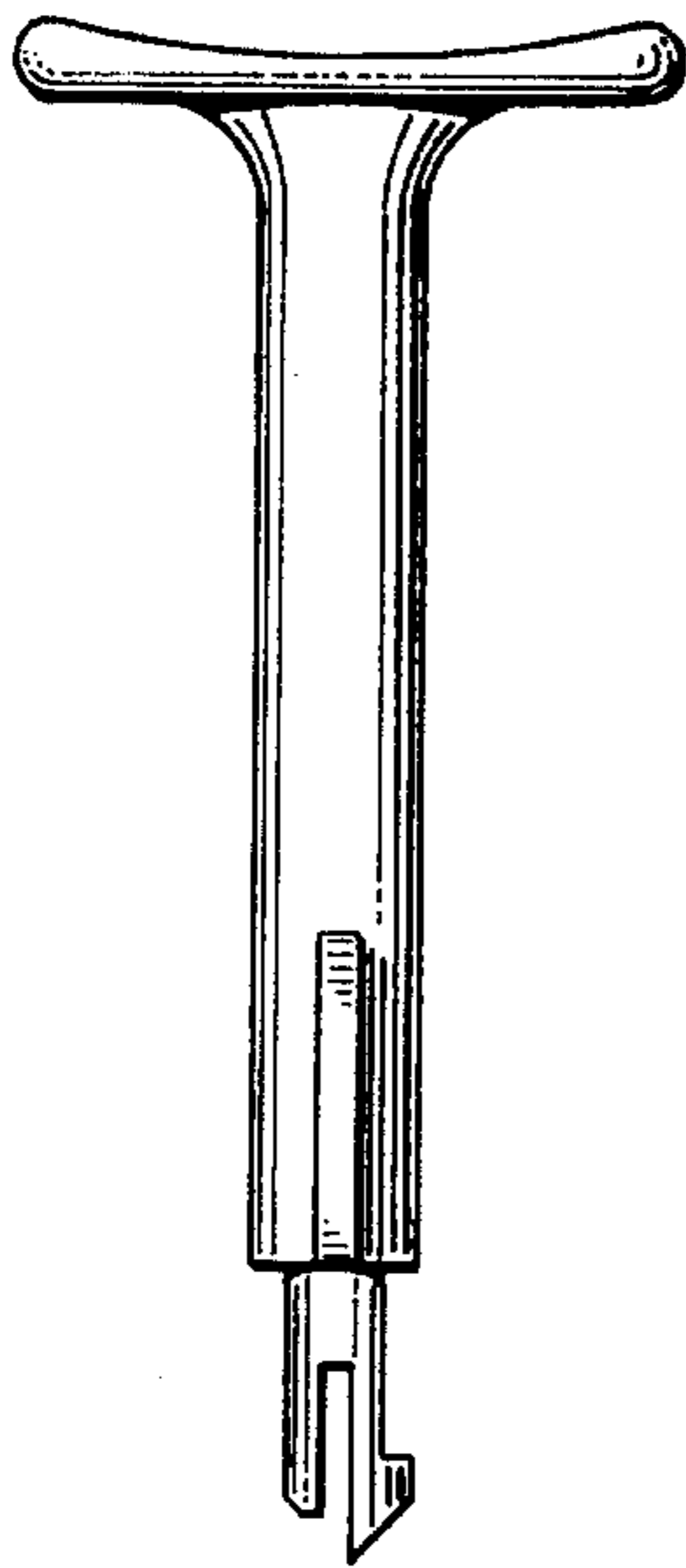

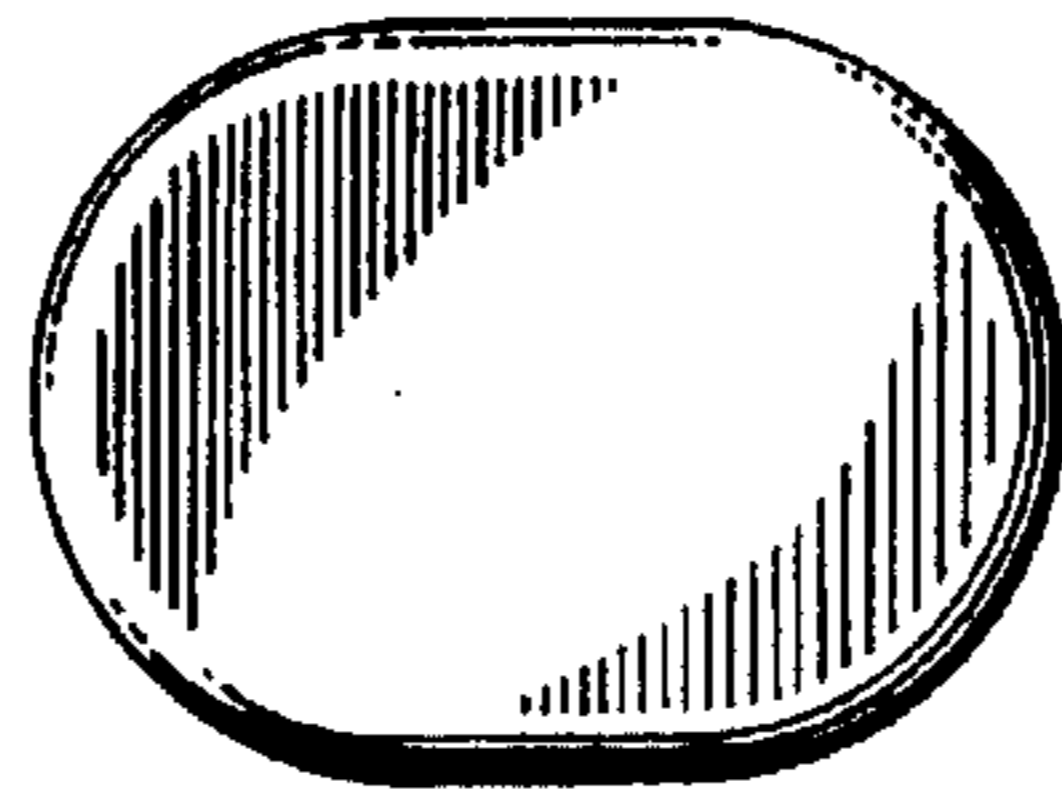

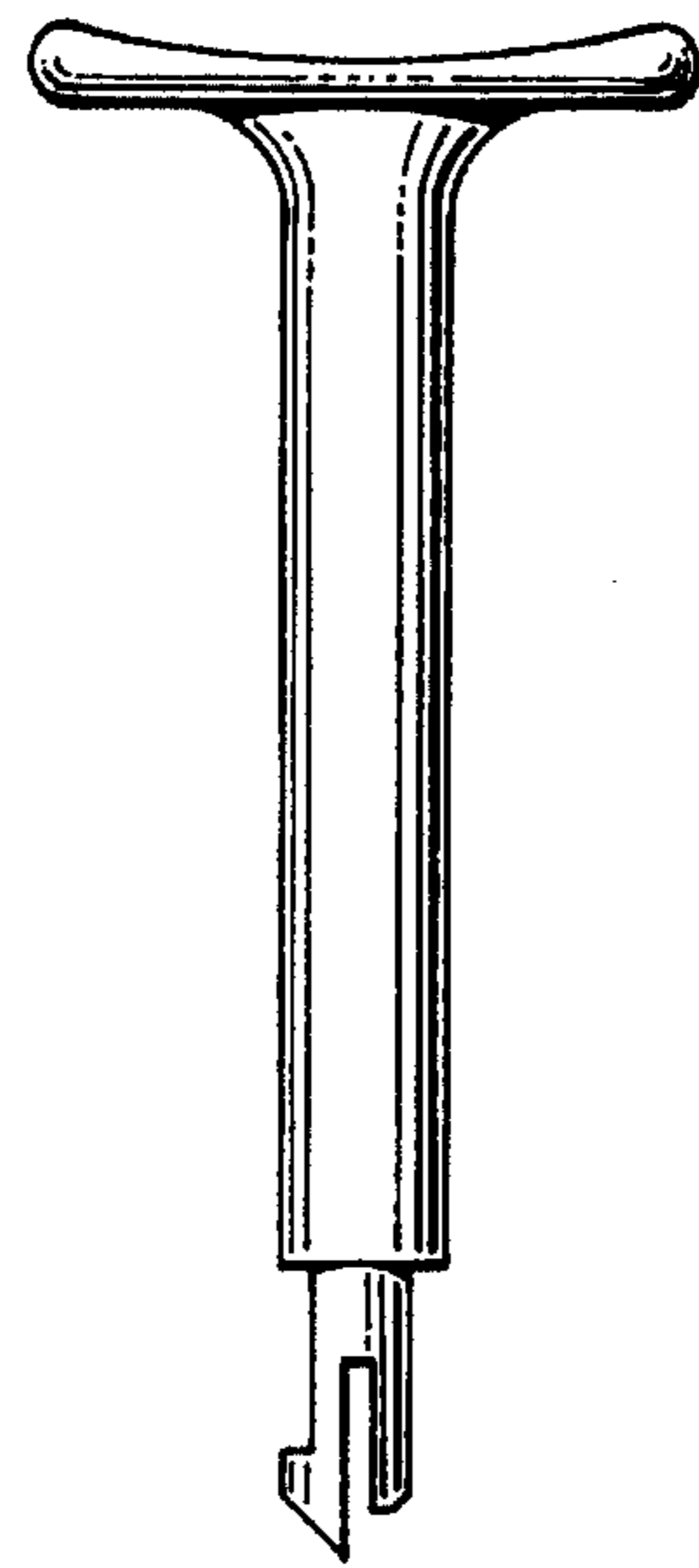

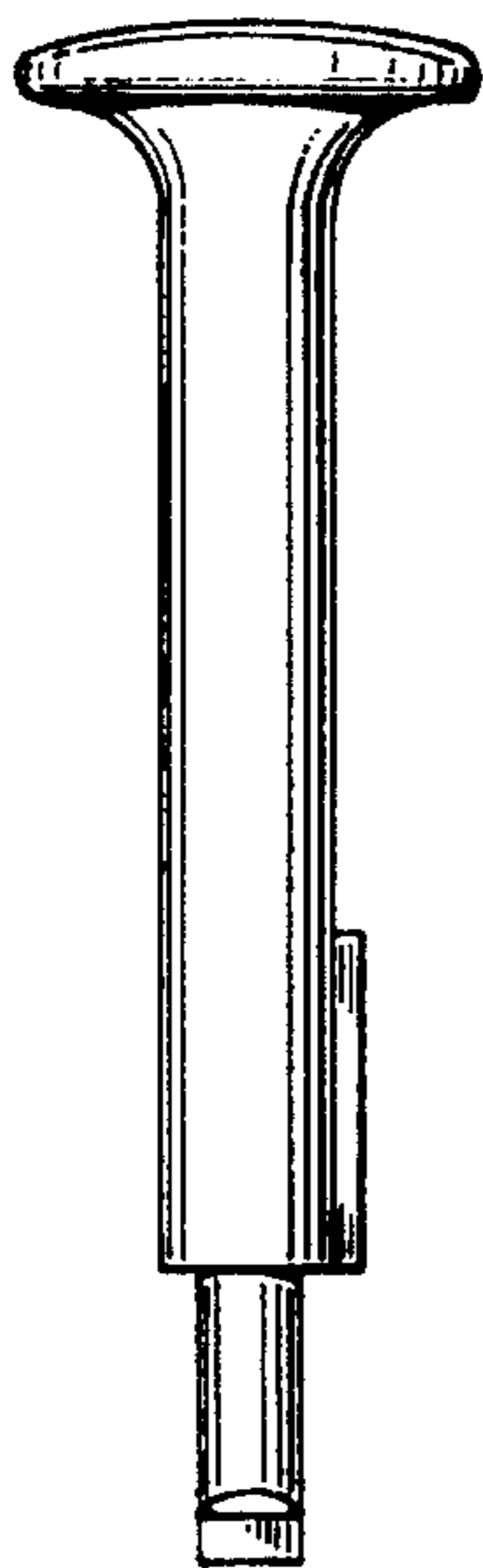

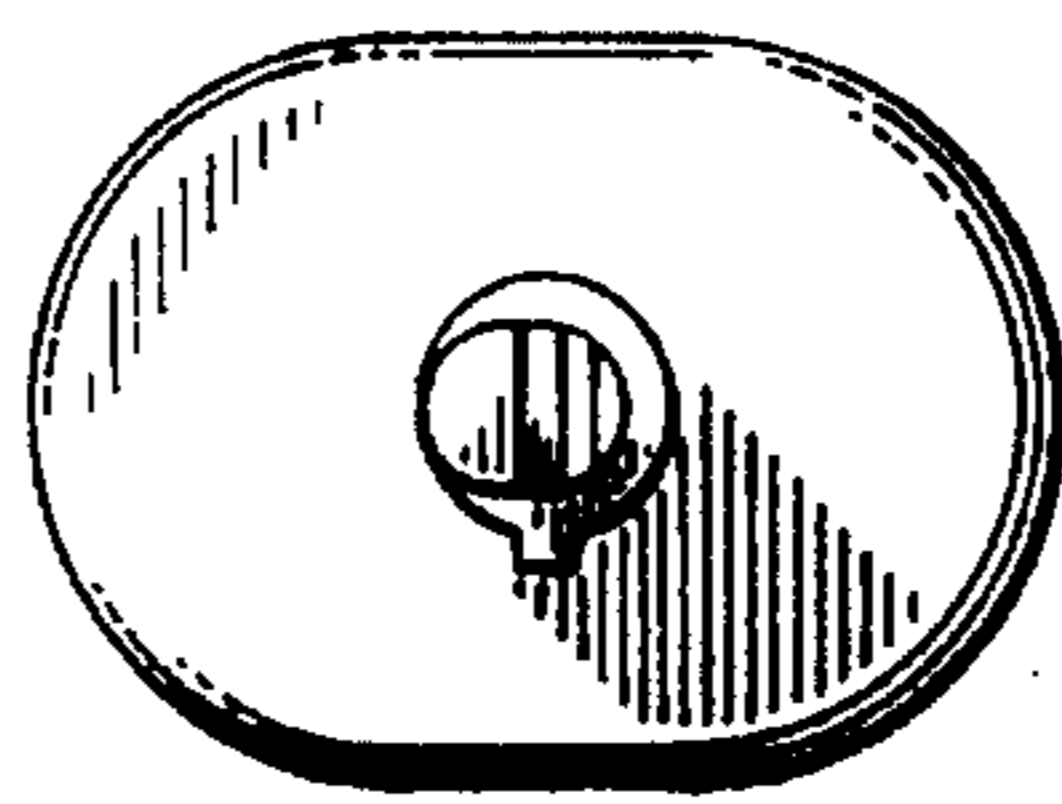

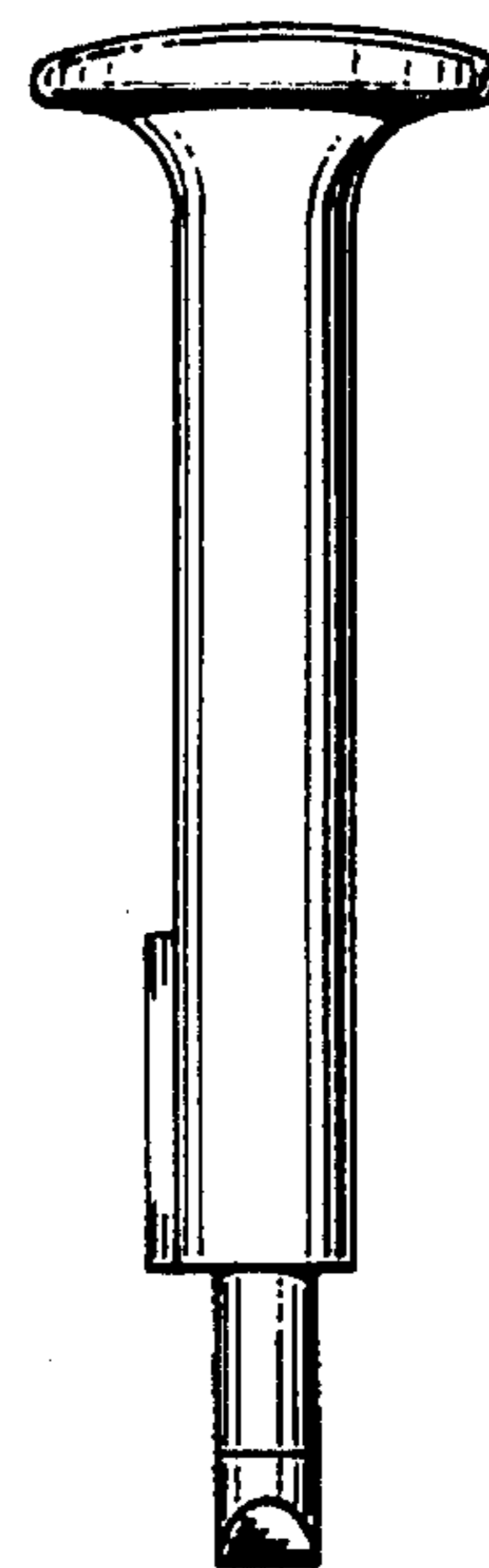

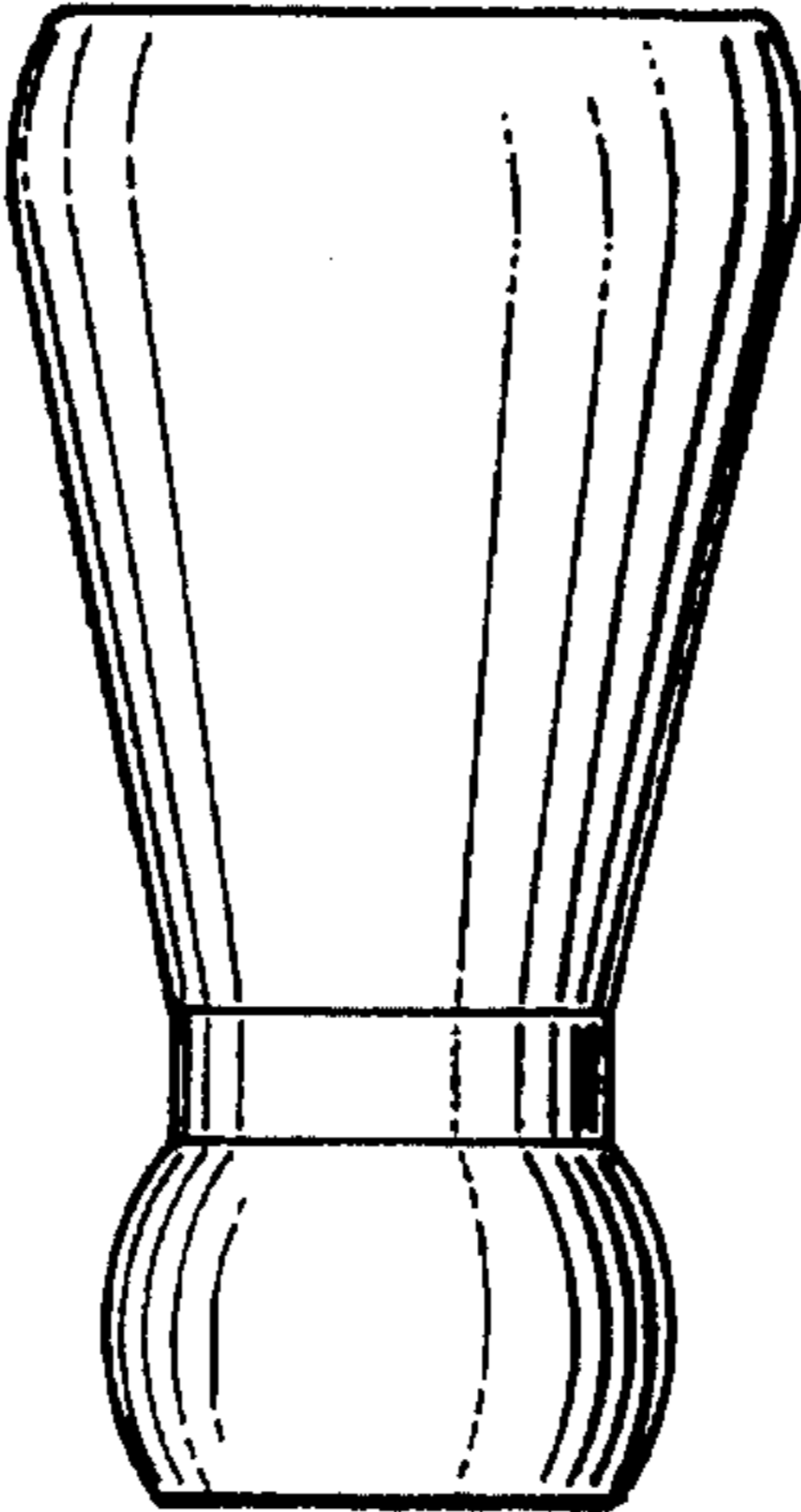

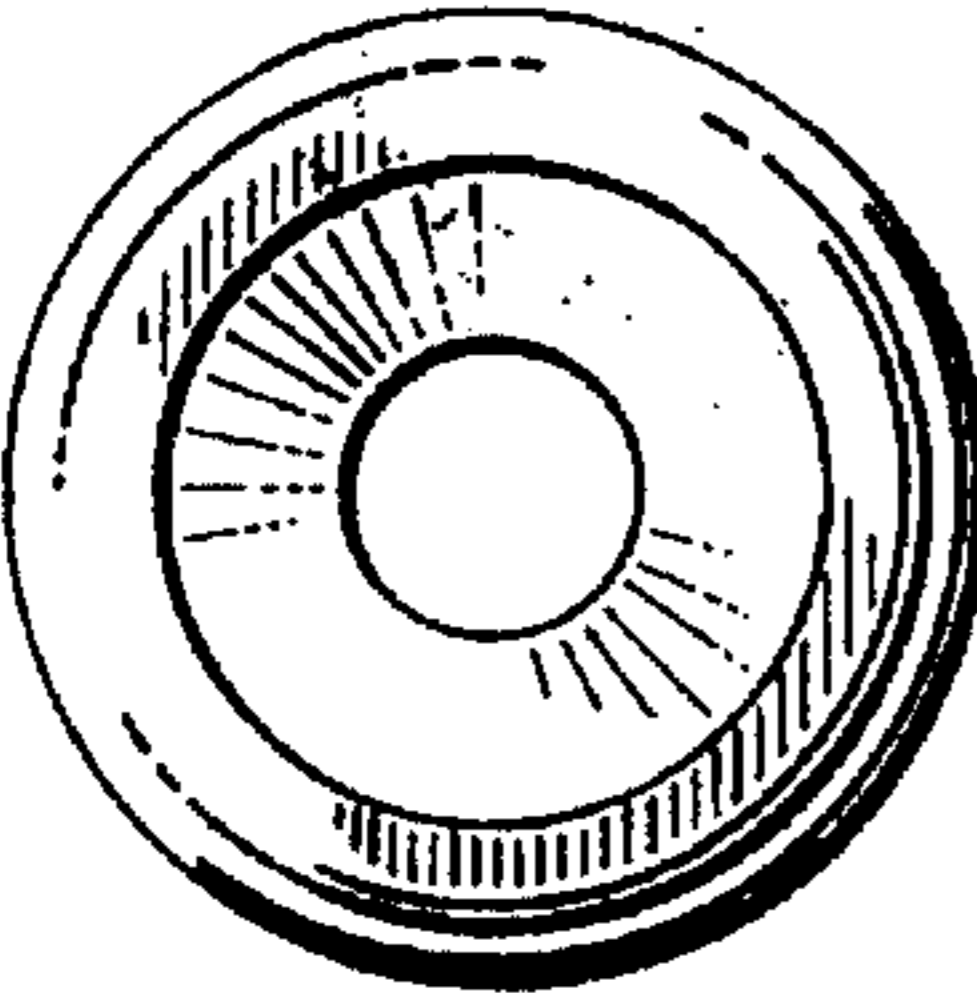

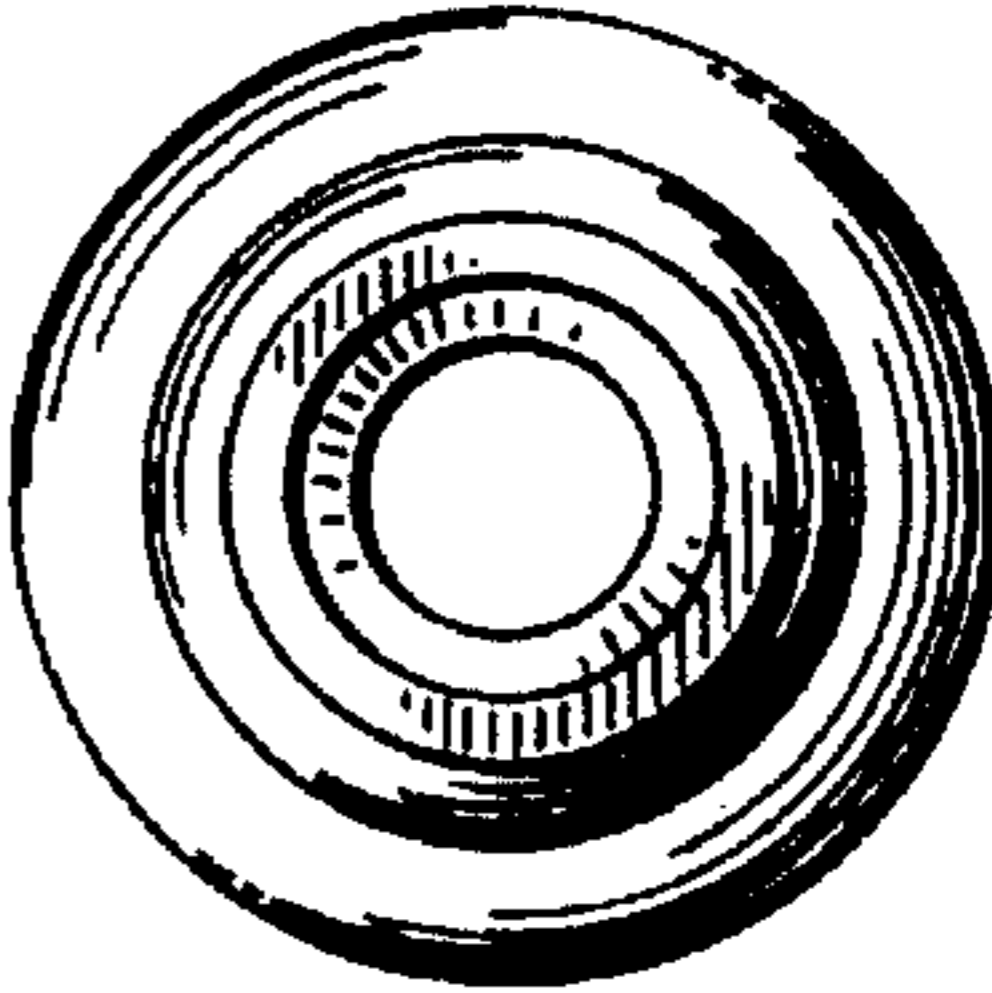
