### [57] CLAIM

The ornamental design for a track for a vehicle, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view taken from above and from the rear of a portion of a track for a vehicle showing our new design, it being understood that the tread design continues uniformly through the belt indicated in light full lines;

FIG. 2 is an enlarged perspective view taken from above and from the rear of a portion of a track for a vehicle showing our new design, shown broken away for convenience of illustration;

FIG. 3 is an enlarged perspective view taken from below and from the rear of a portion of a track for a vehicle showing our new design, shown broken away for convenience of illustration;

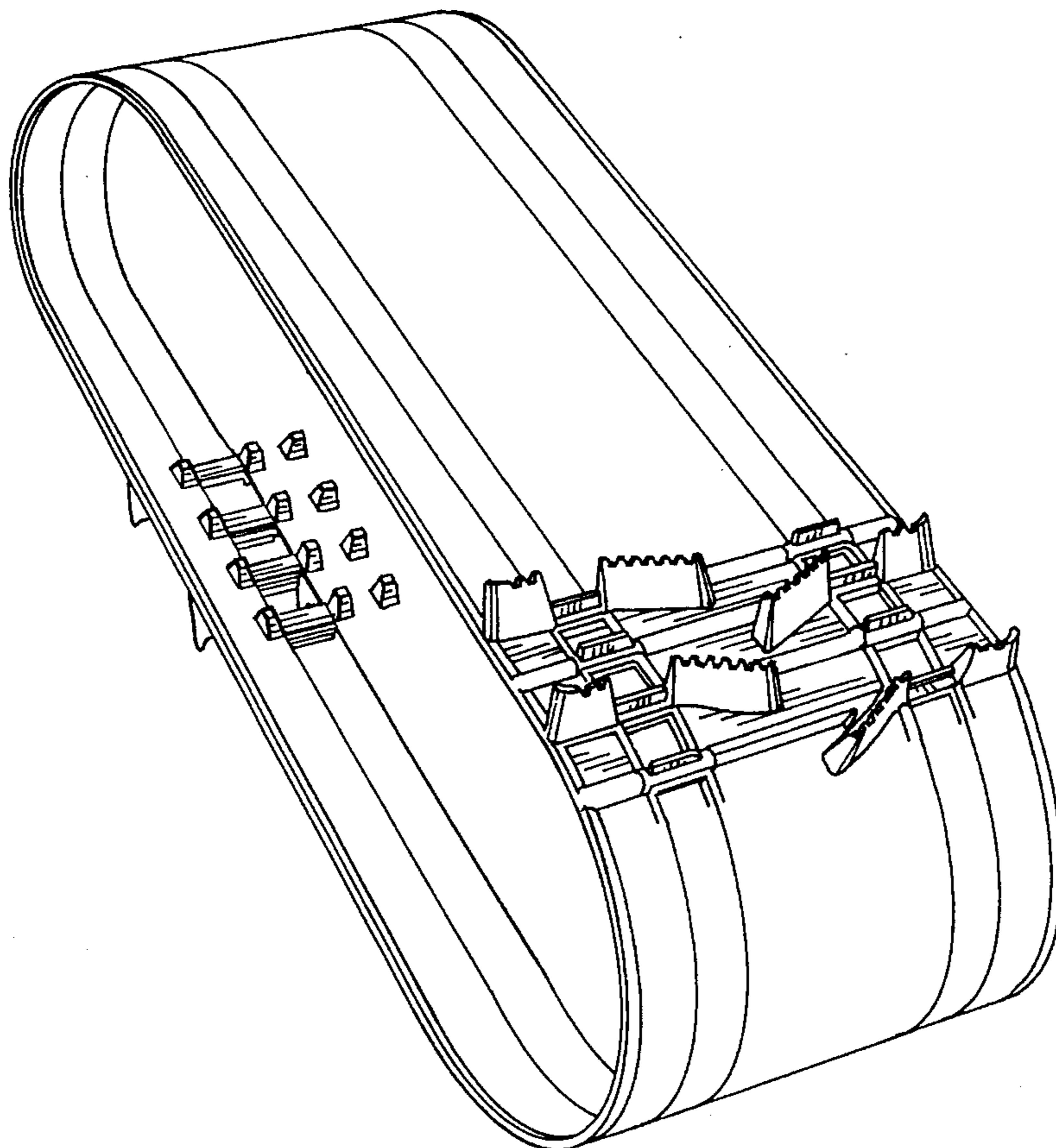
FIG. 4 is top plan view thereof;

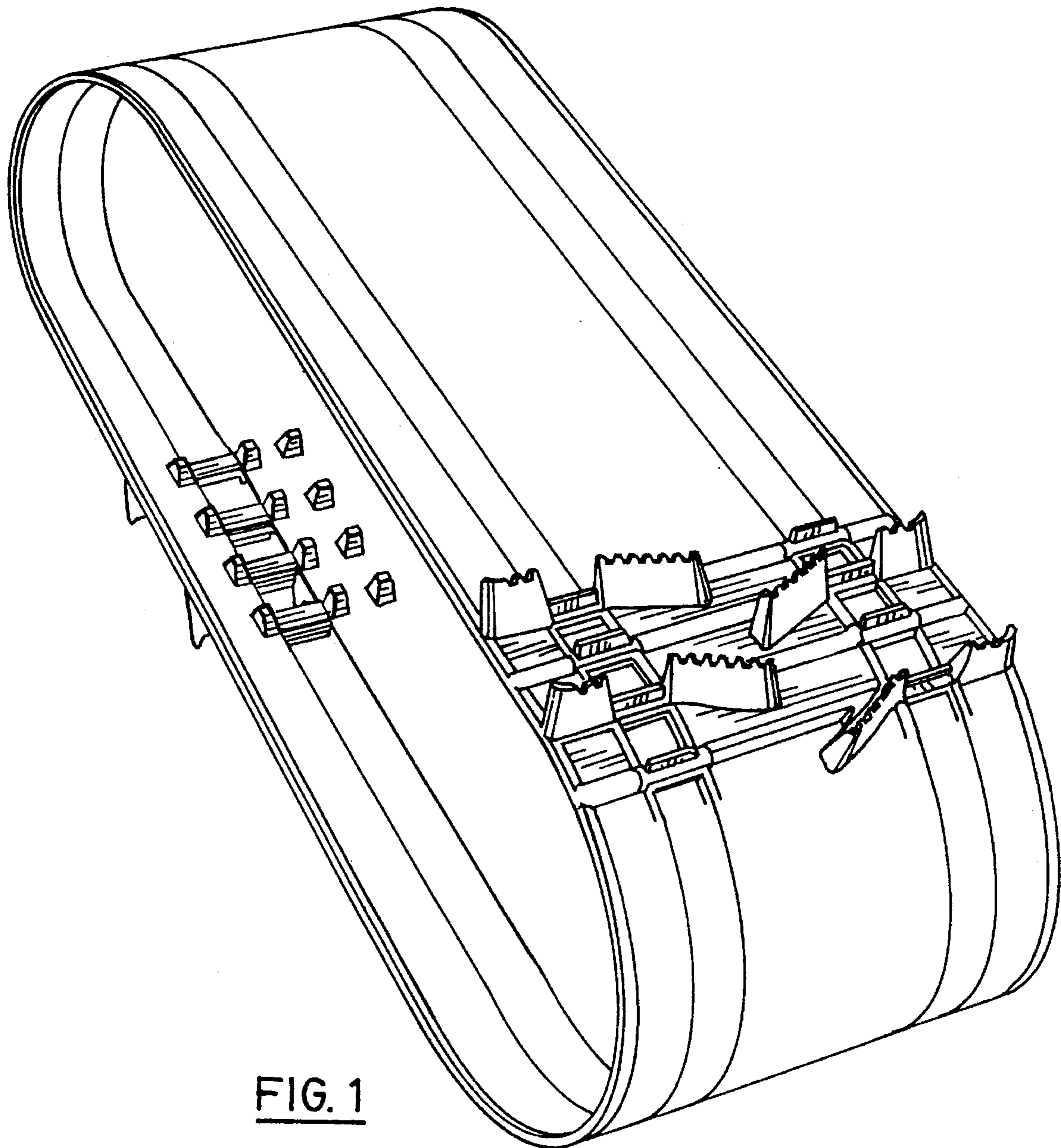

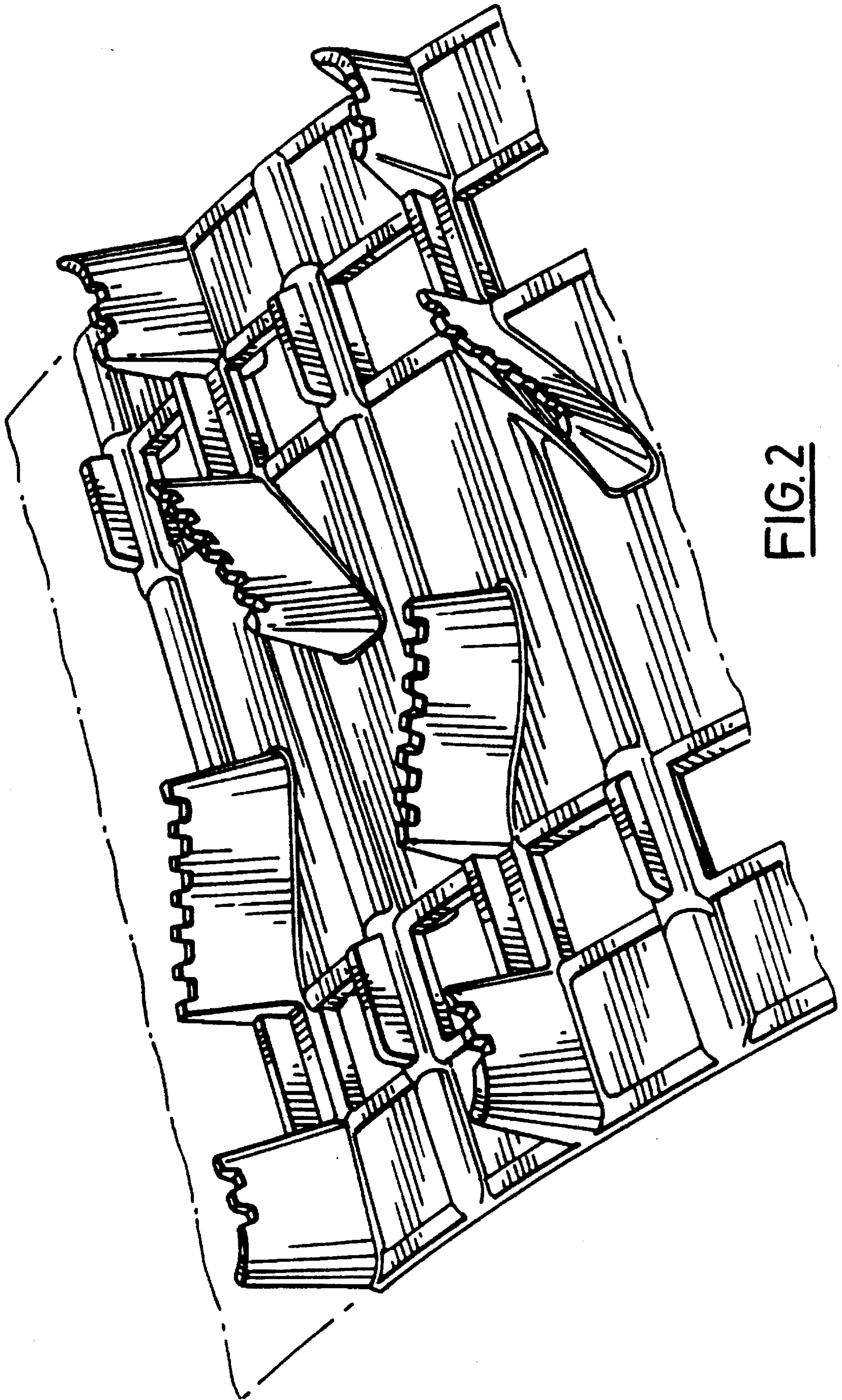

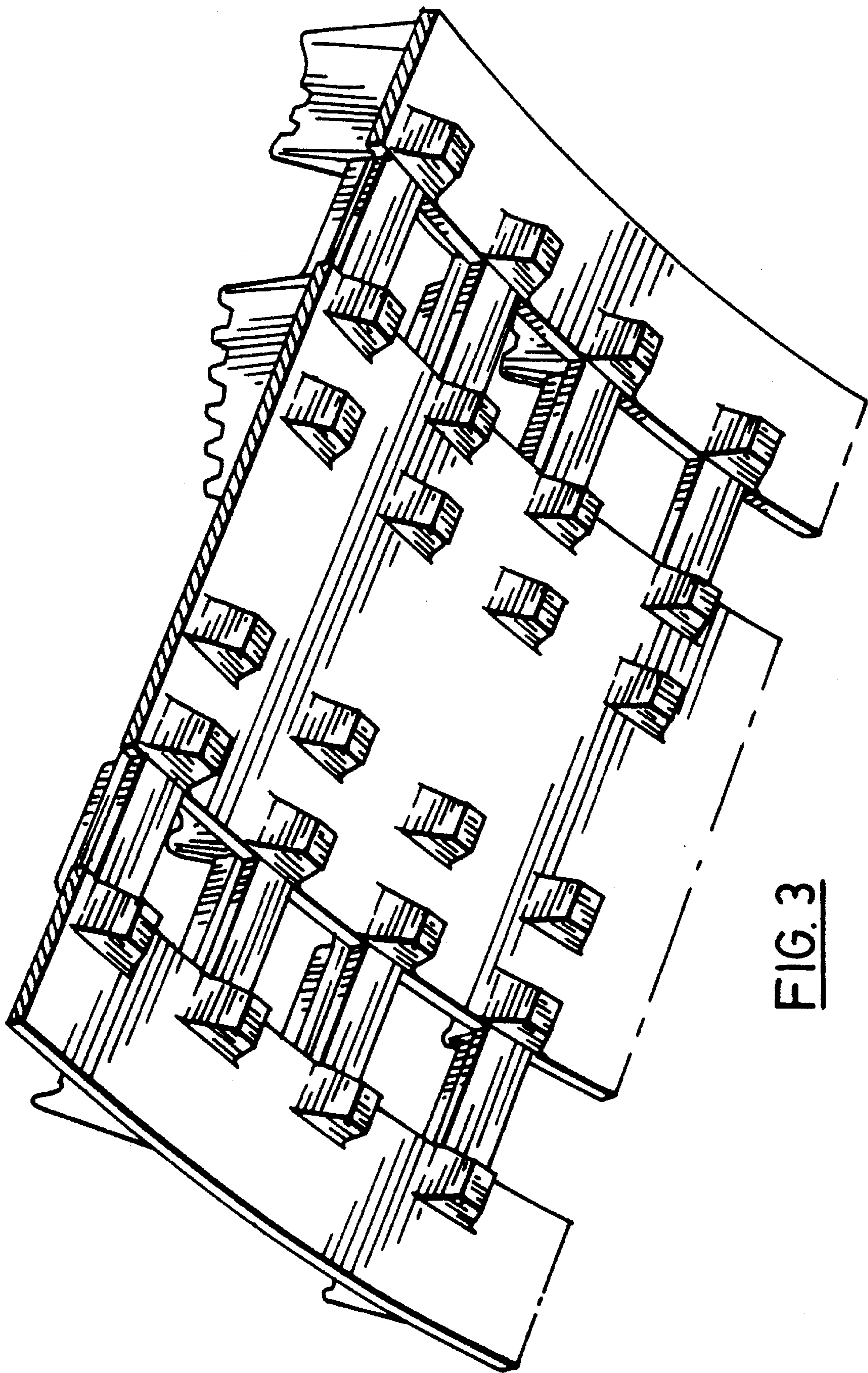

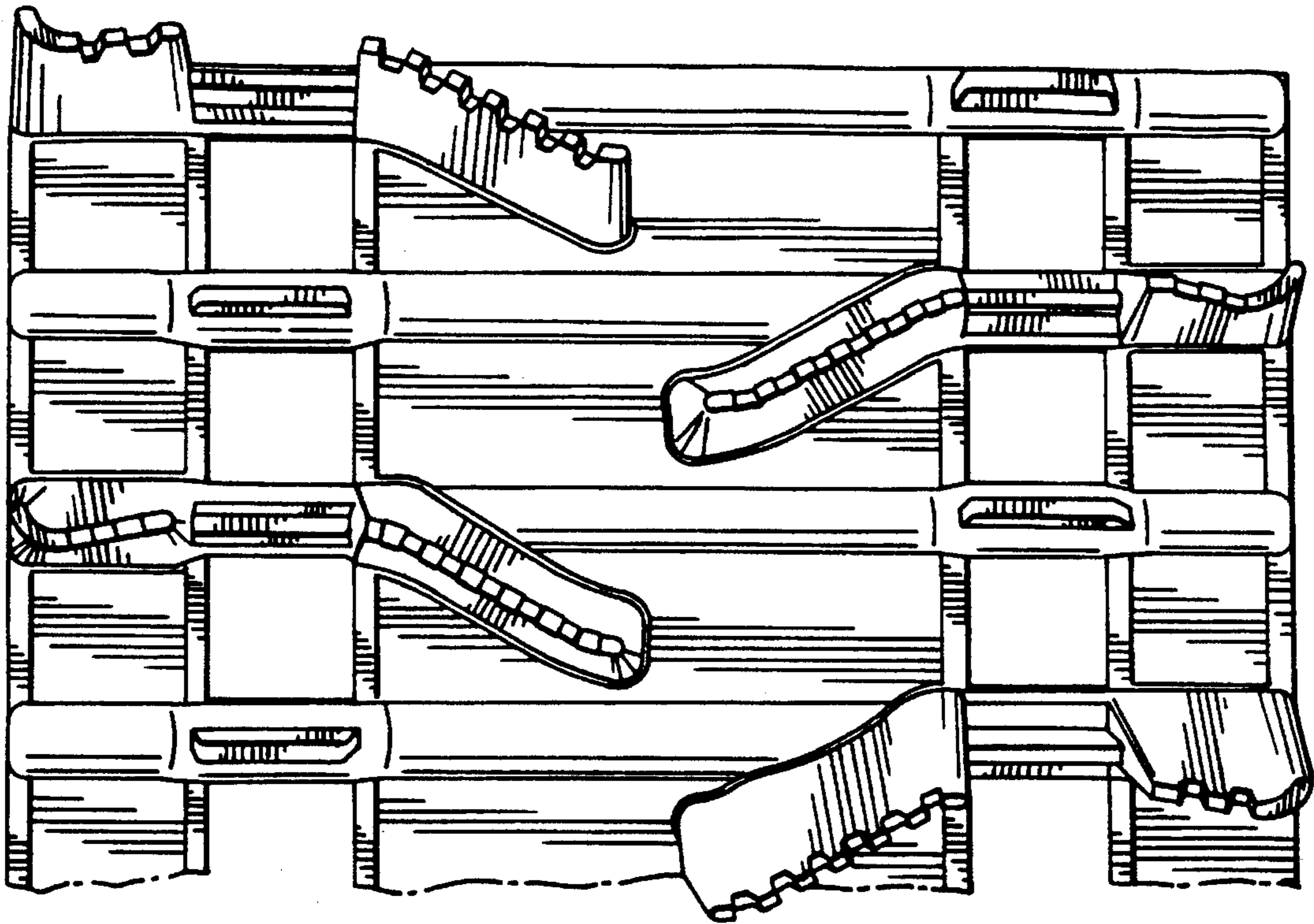

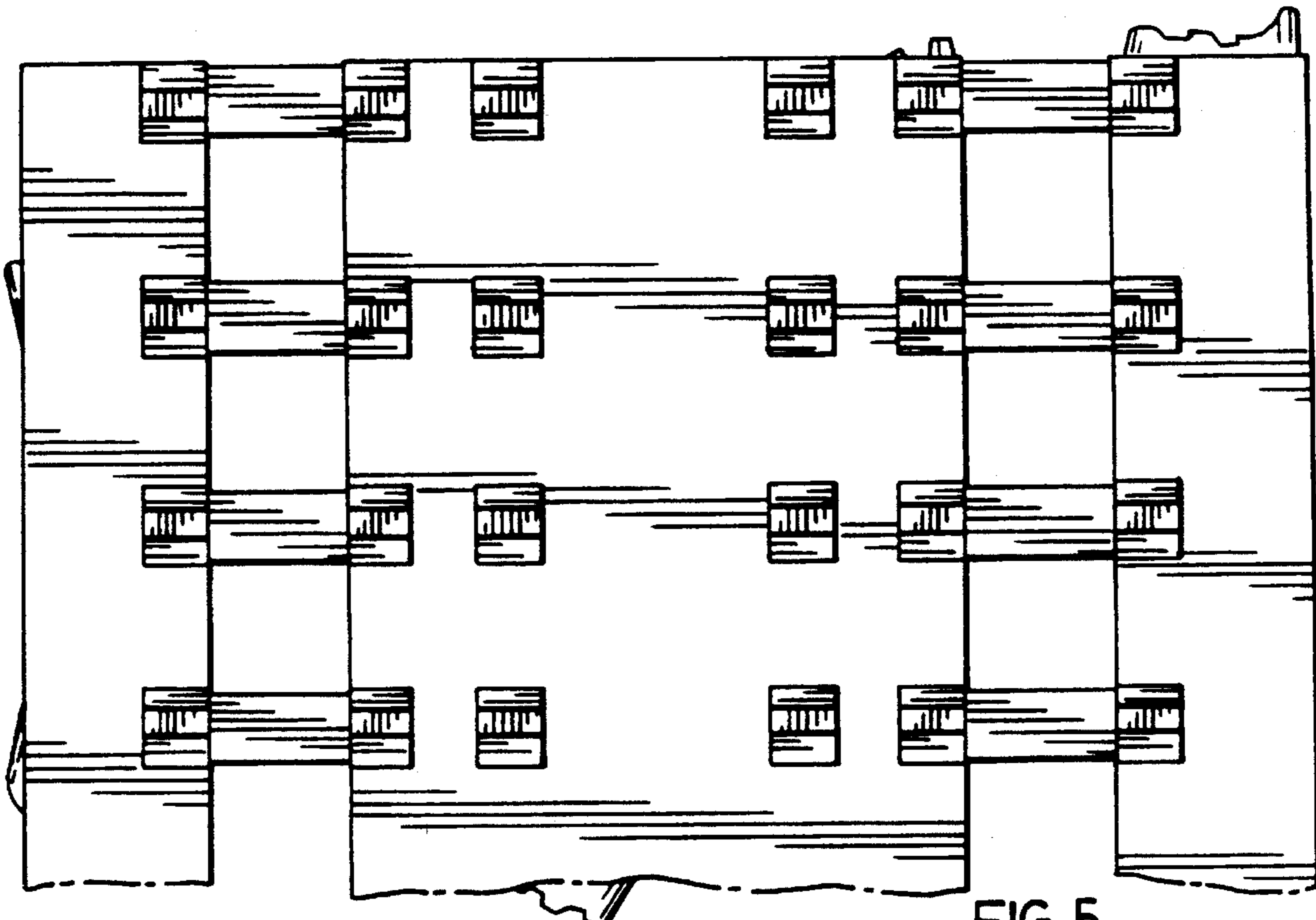

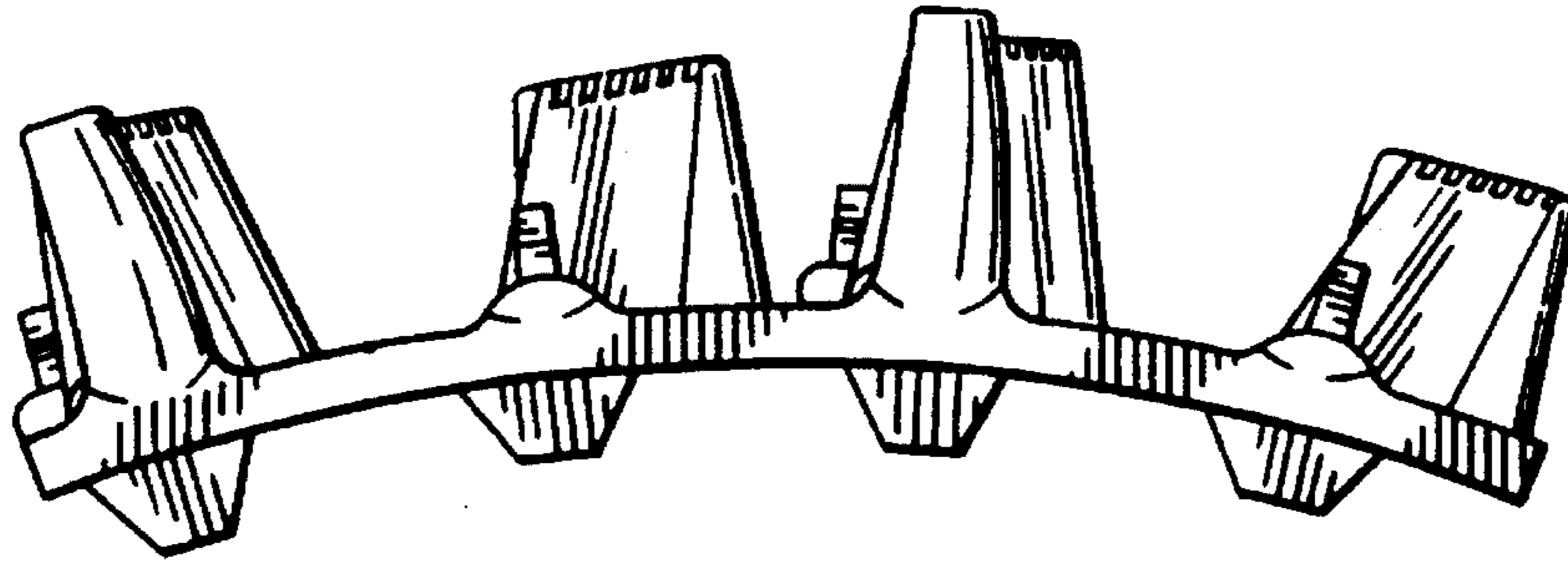

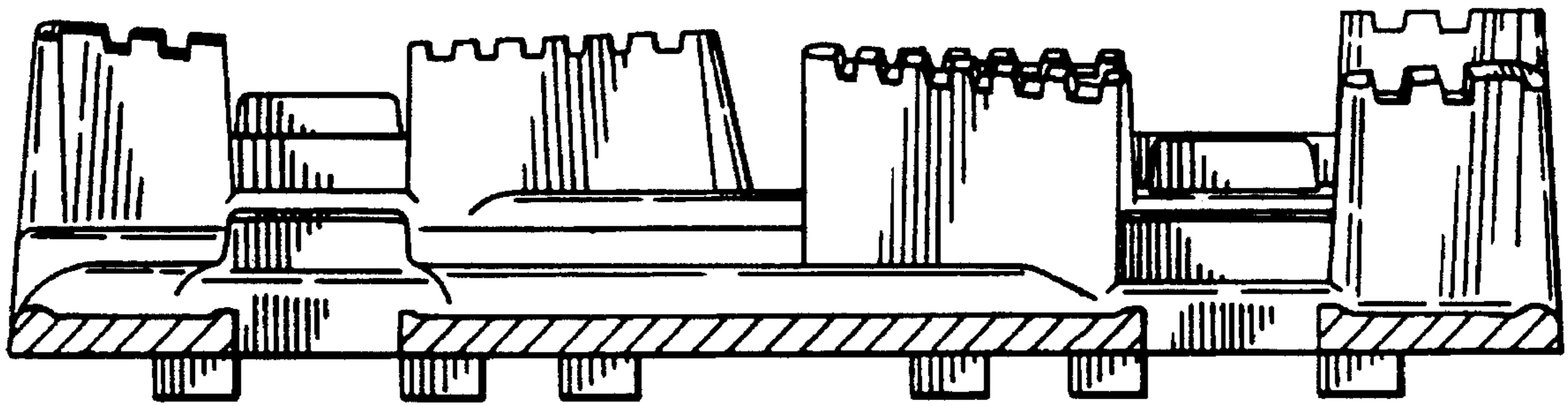
