FIG. 3 is a back view of the coffeemaker showing my design;

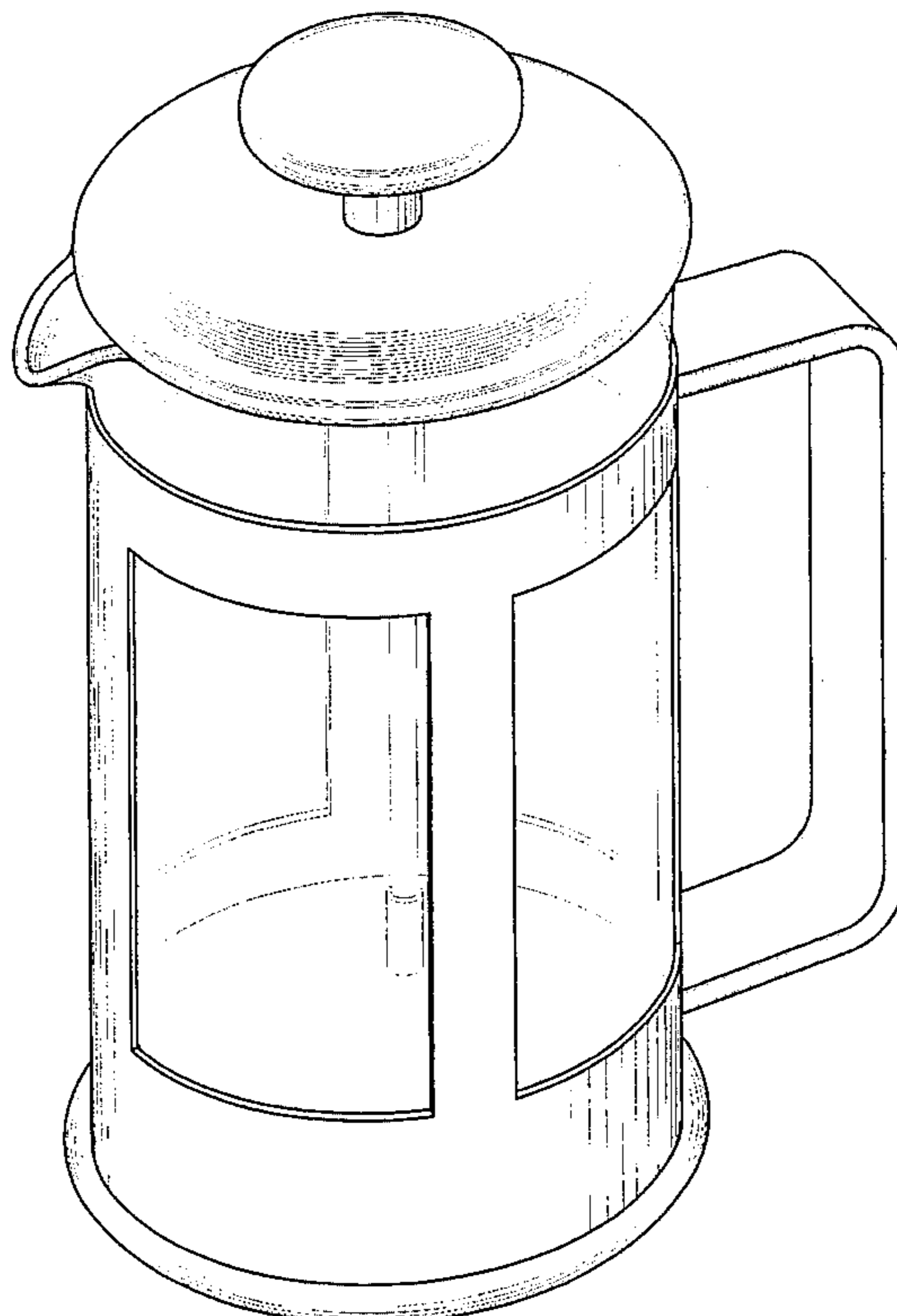
FIG. 4 is a right side view of the coffeemaker showing my new design;

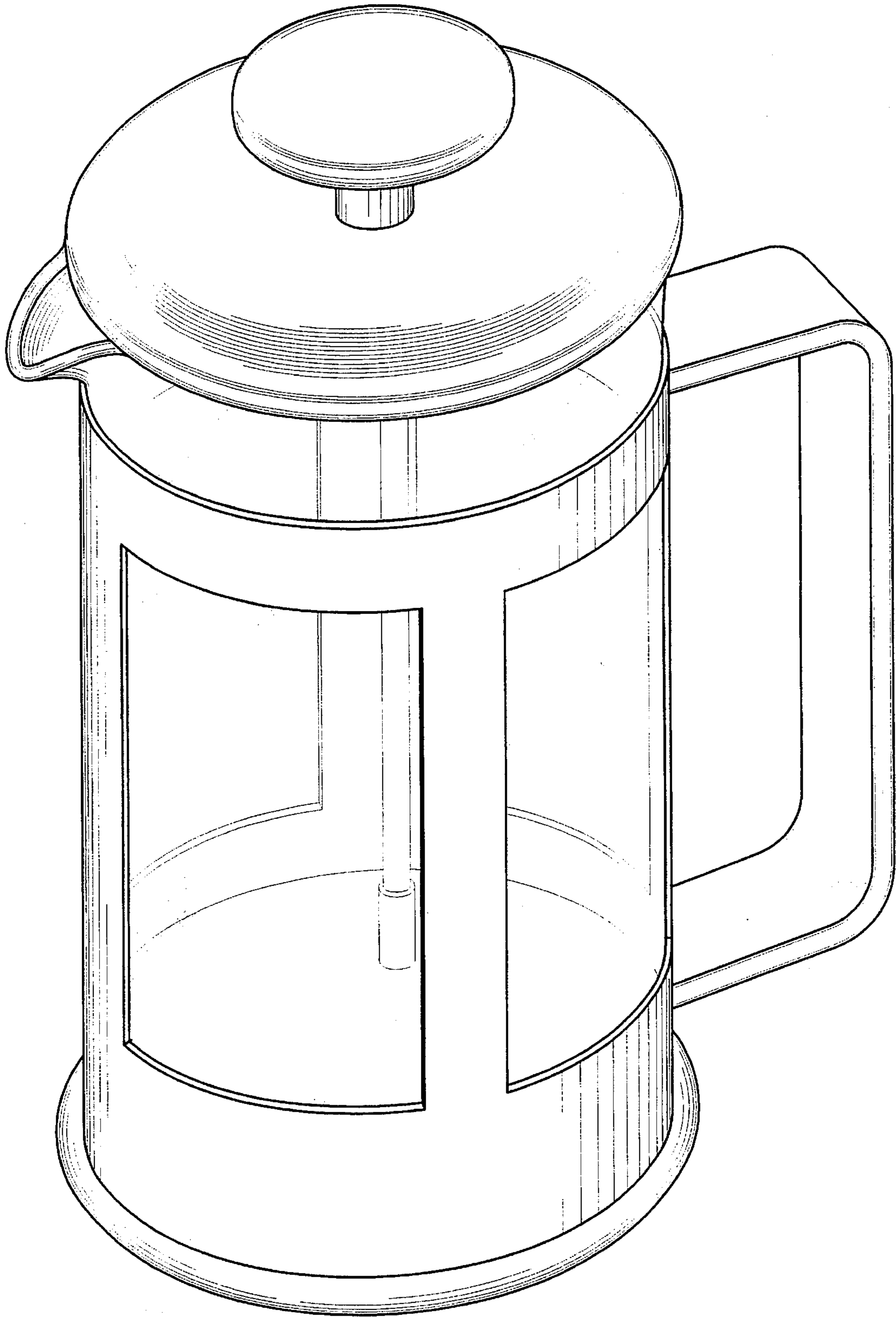

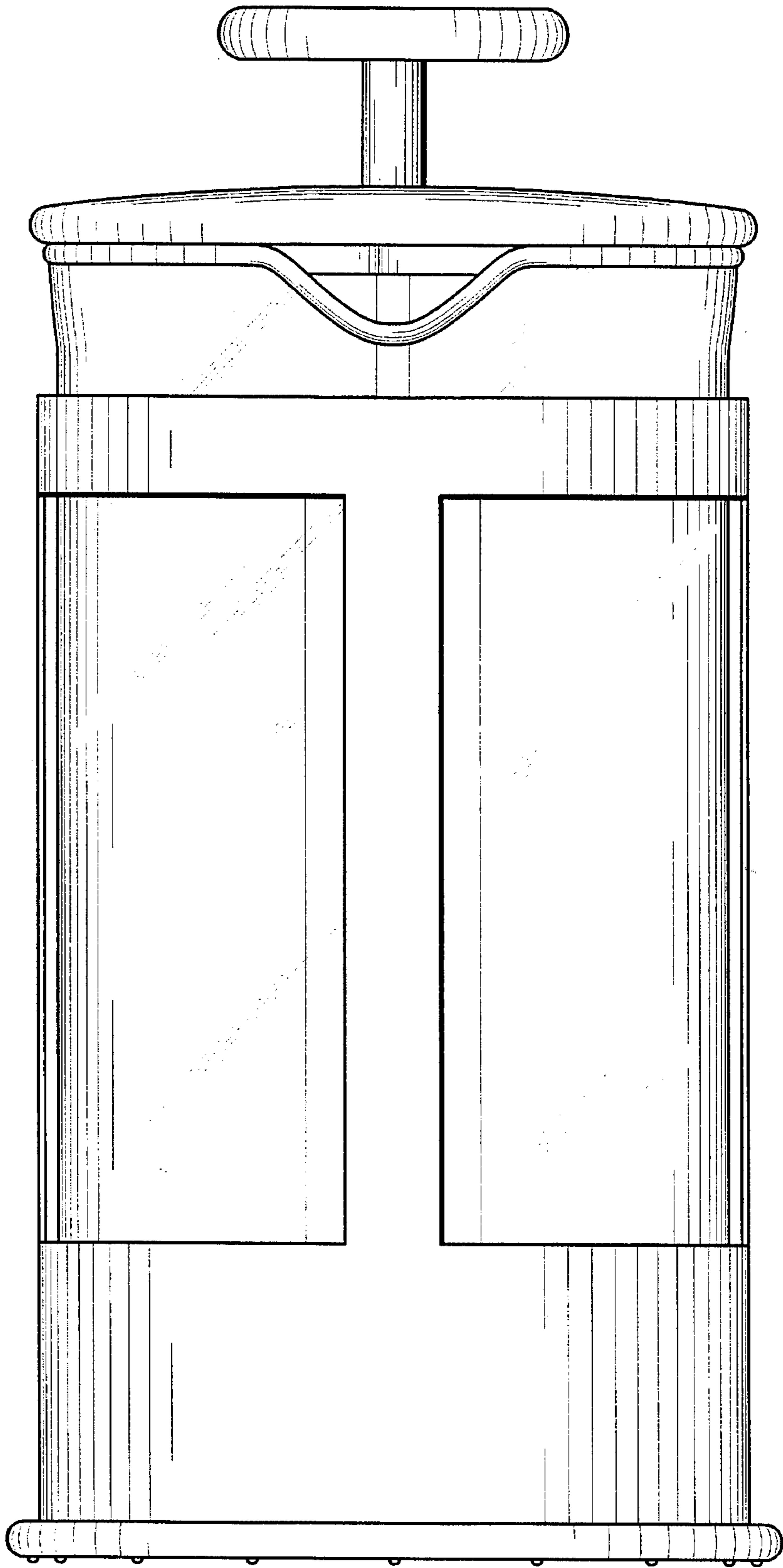

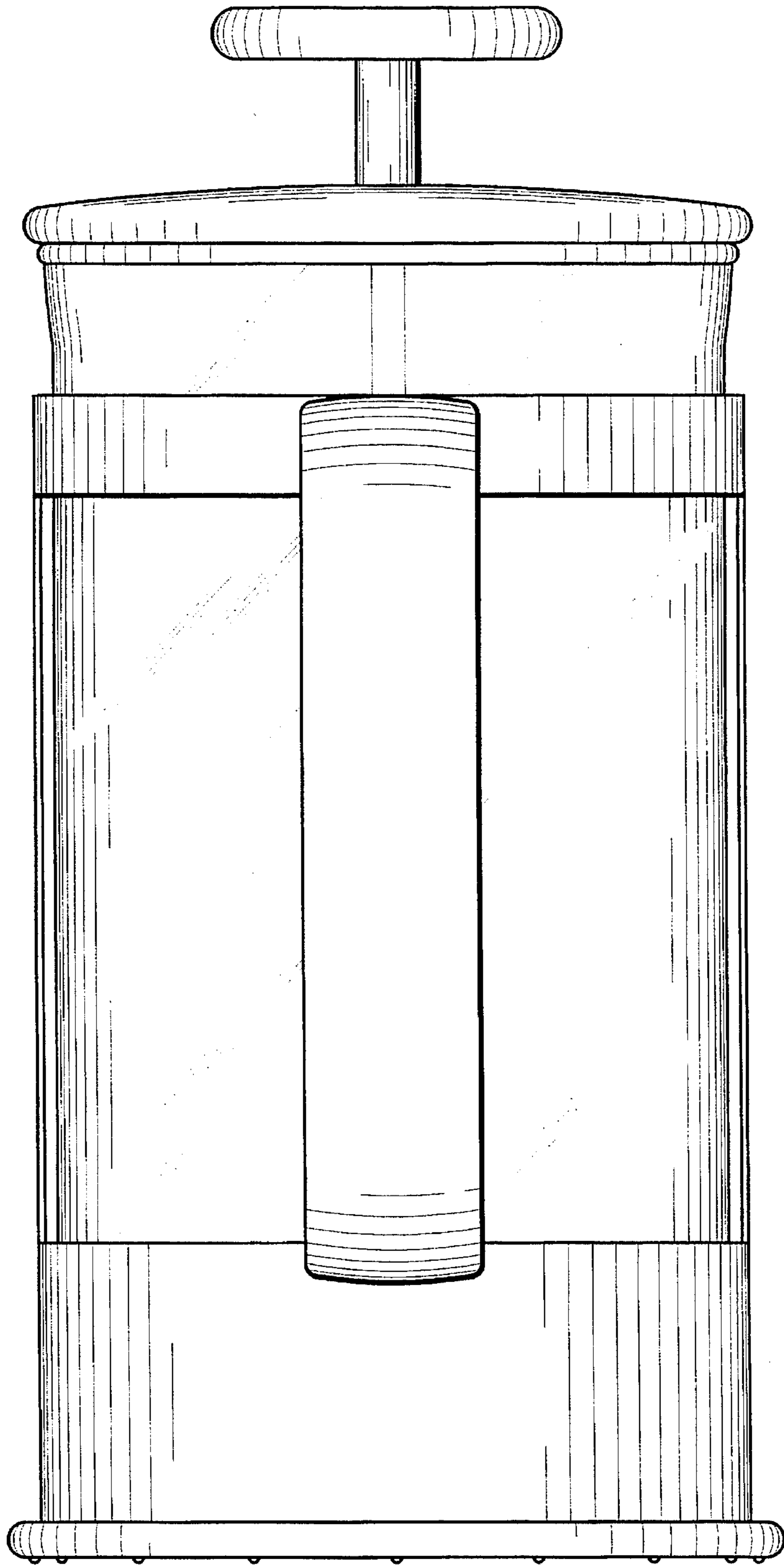

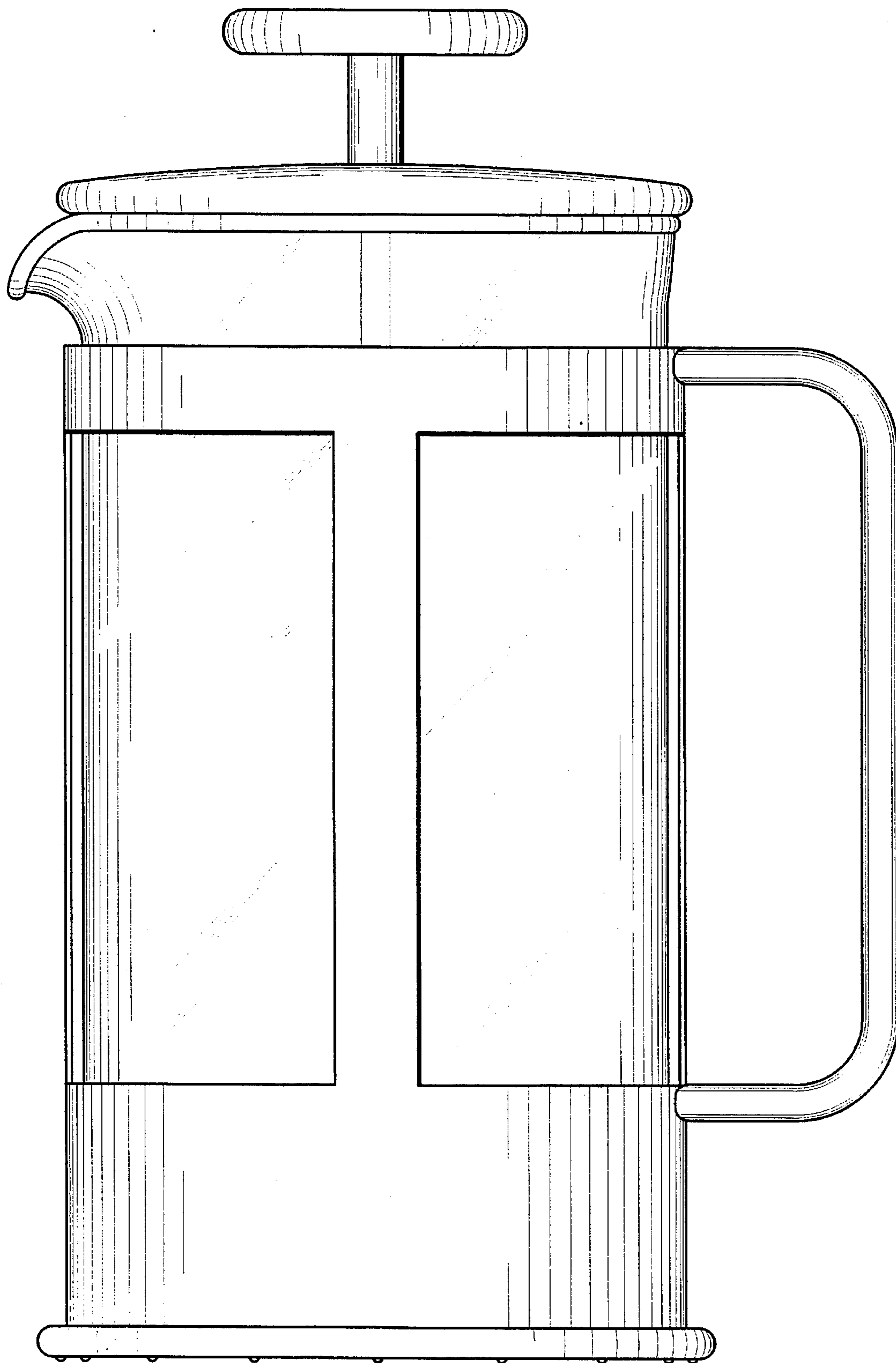

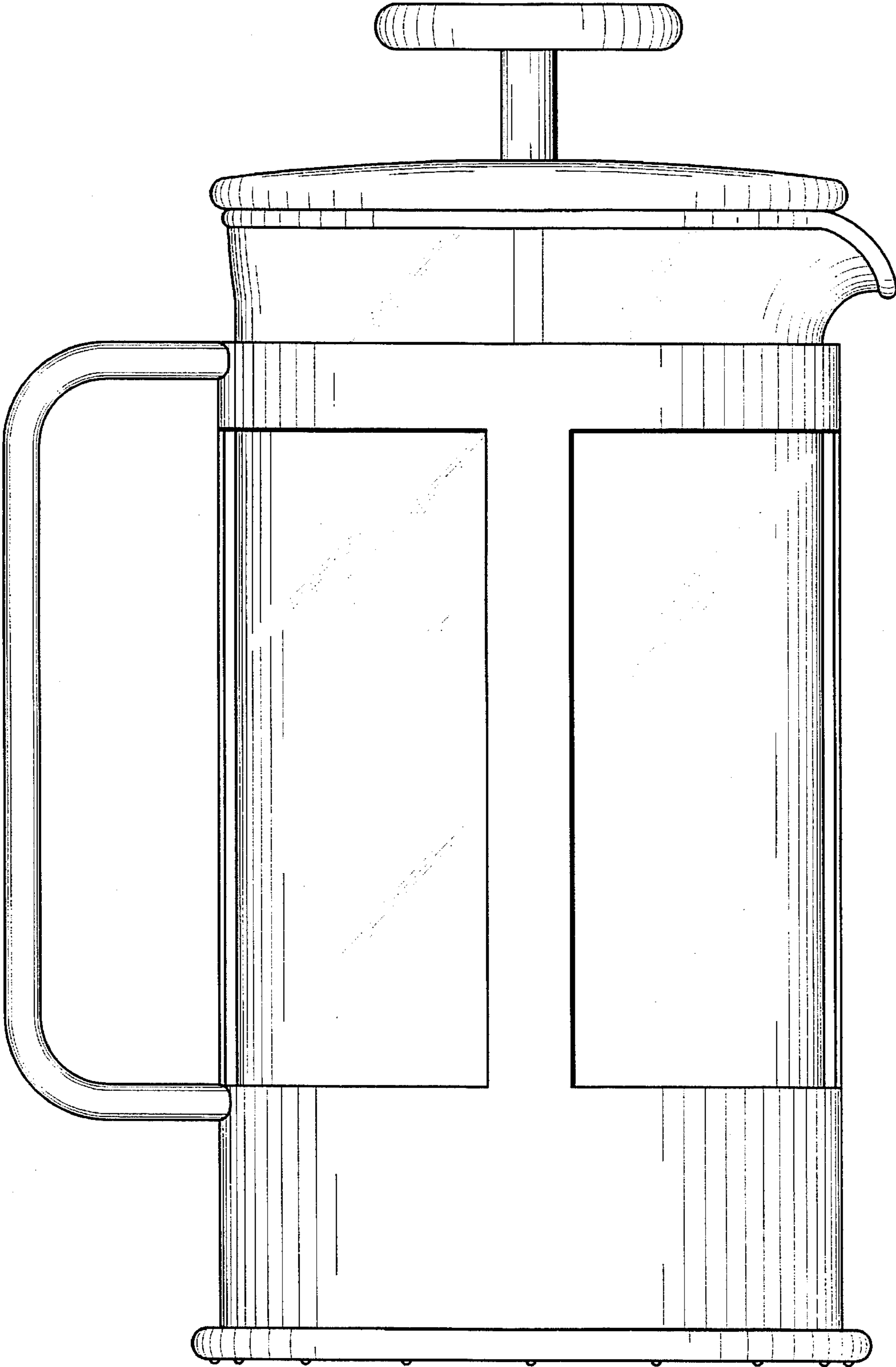

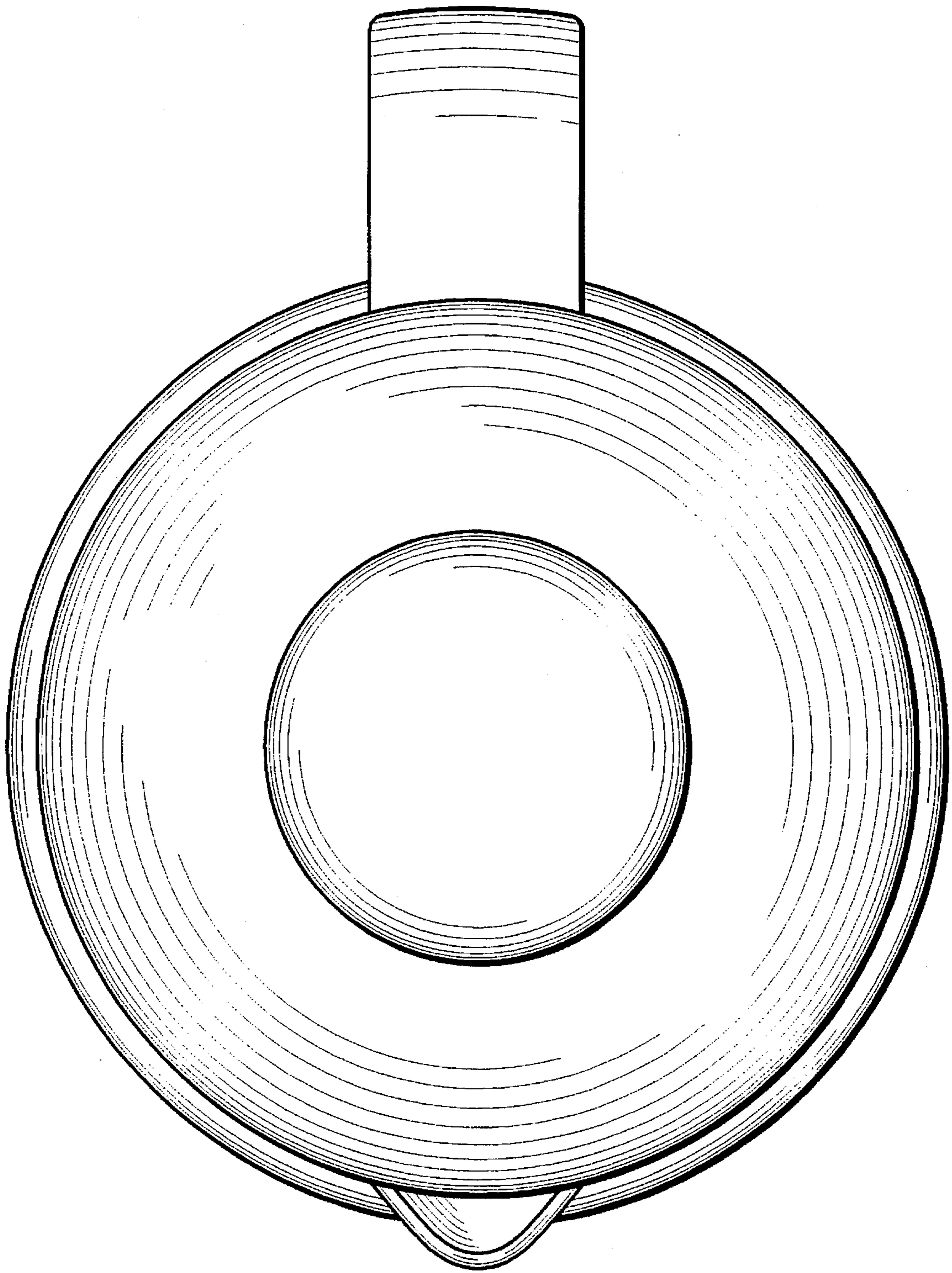

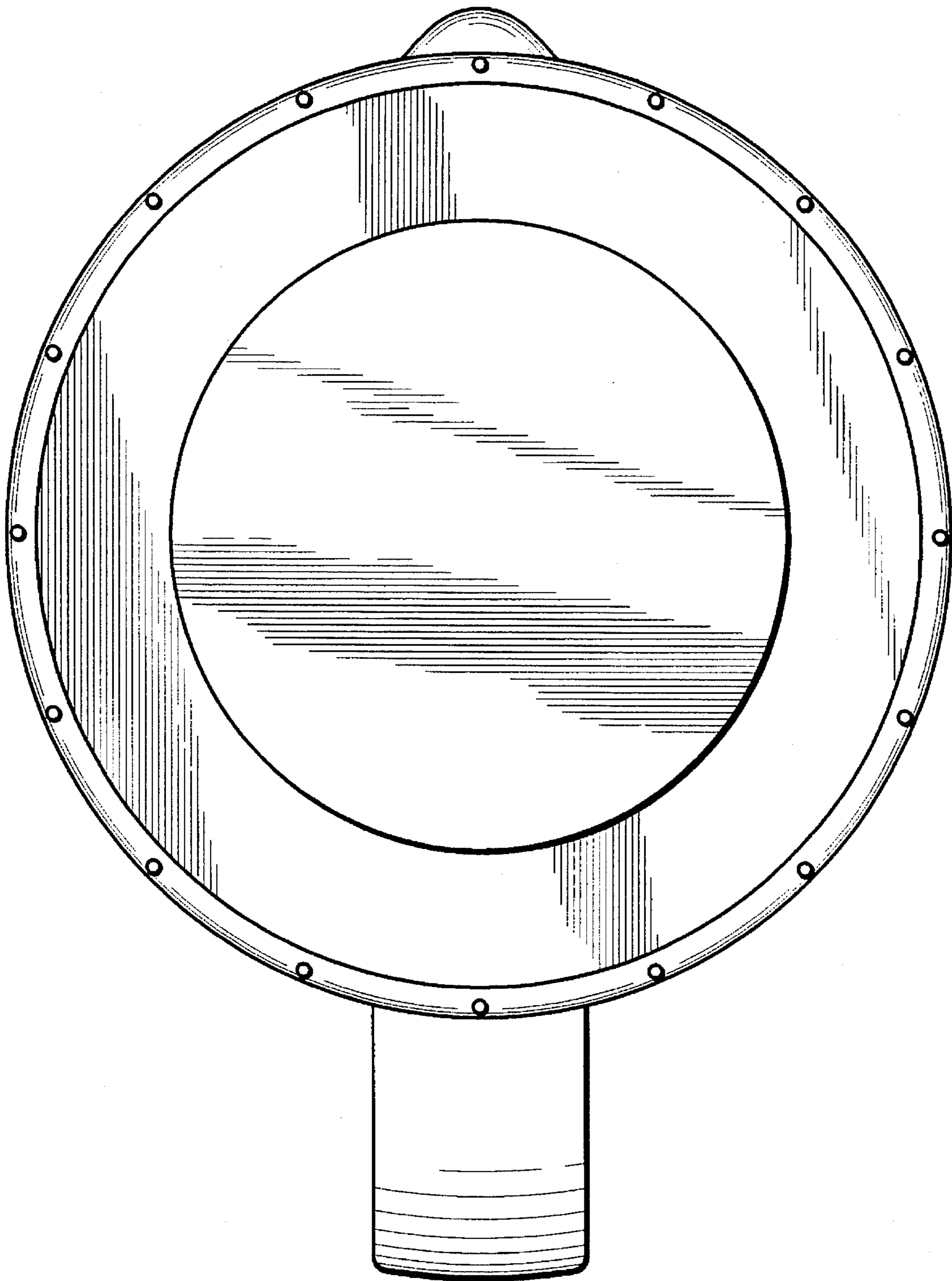
