DESCRIPTION

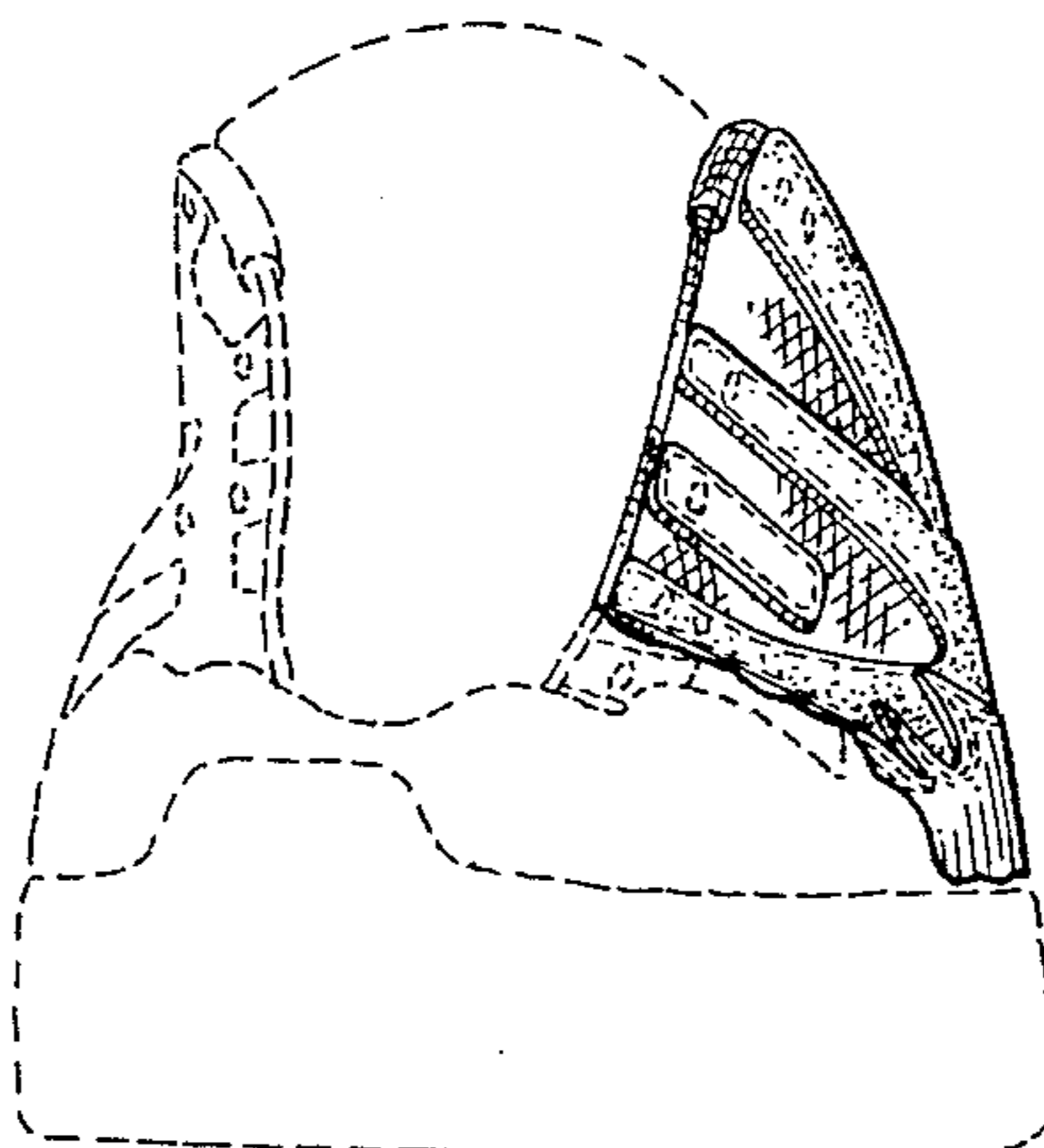
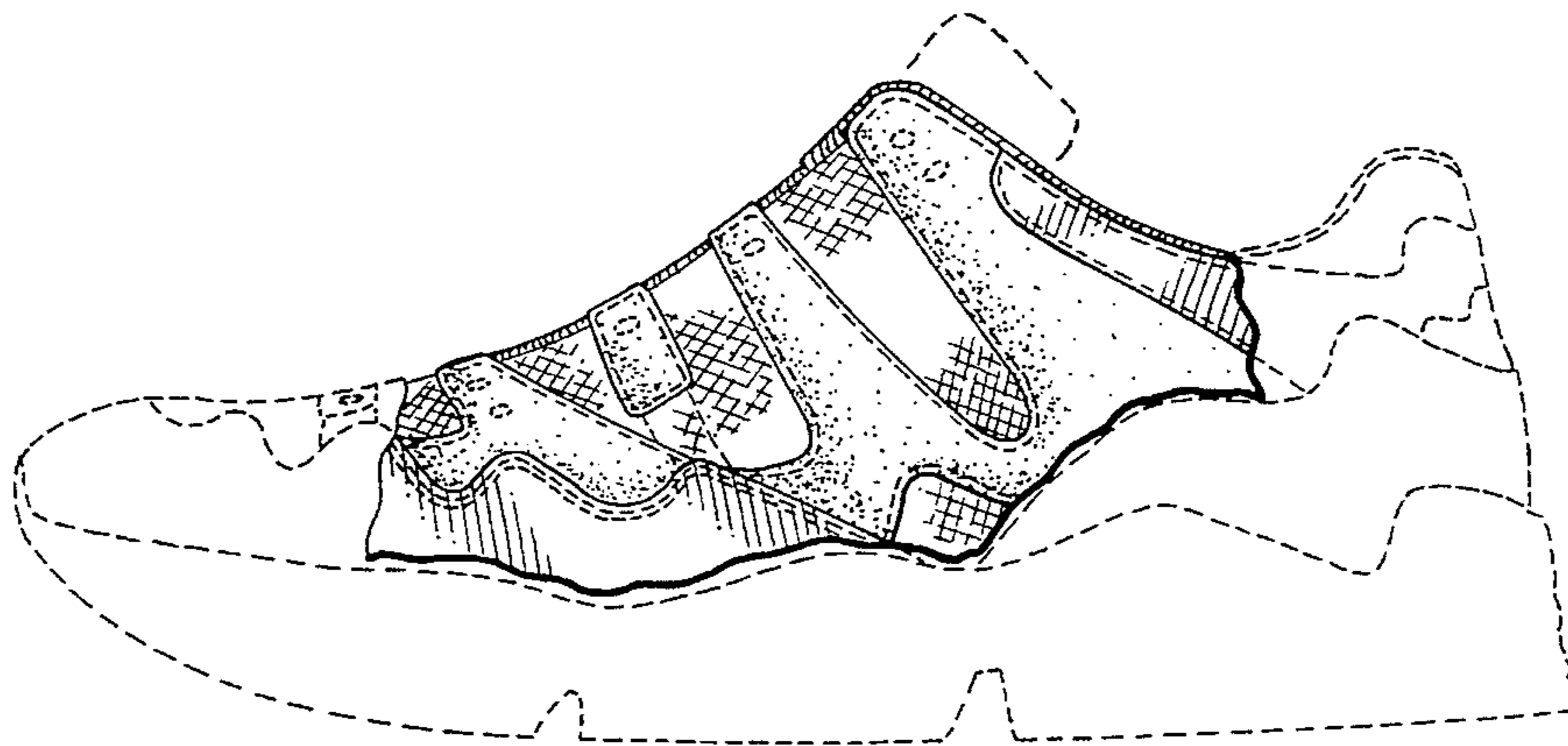
FIG. 1 is a side elevational view of a side element of a shoe upper showing my new design;

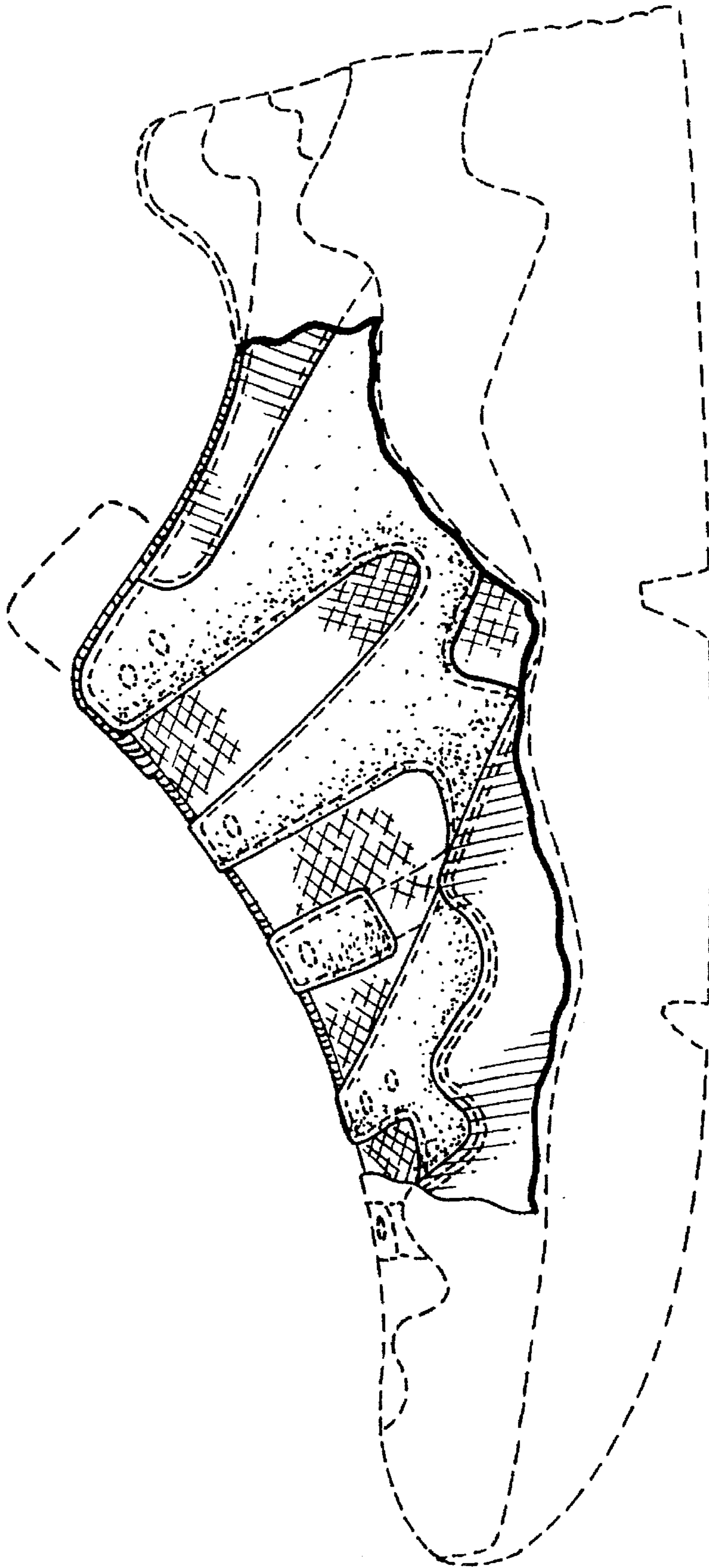

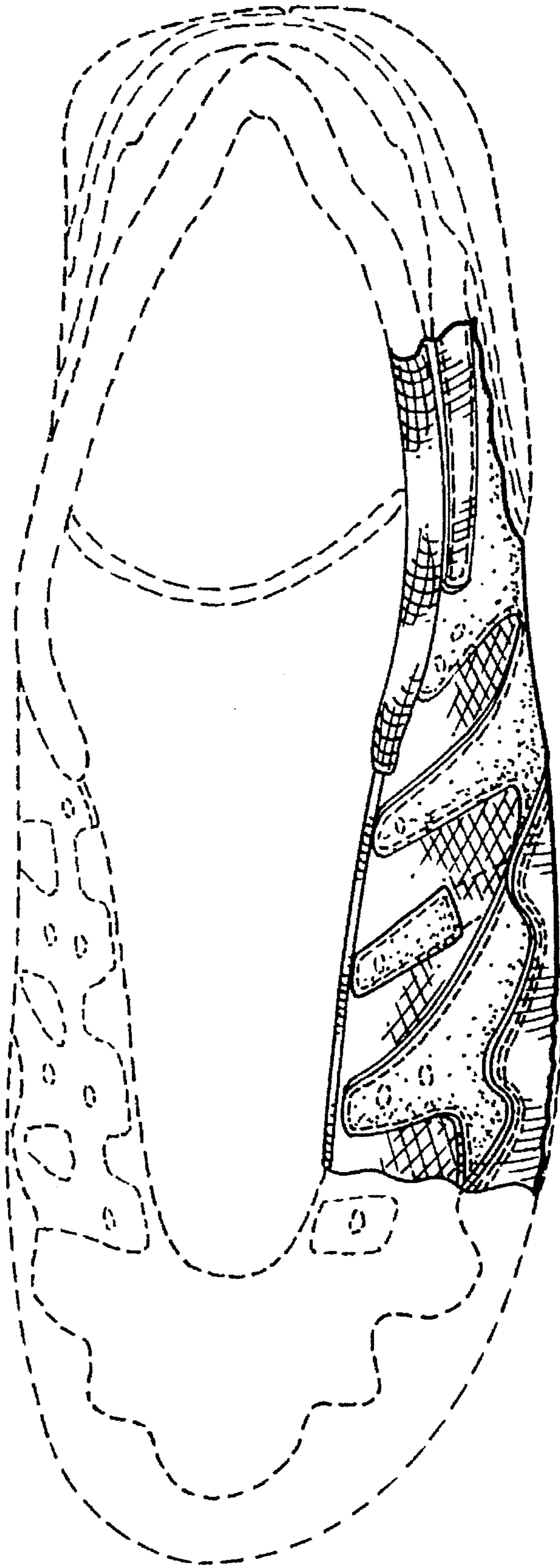

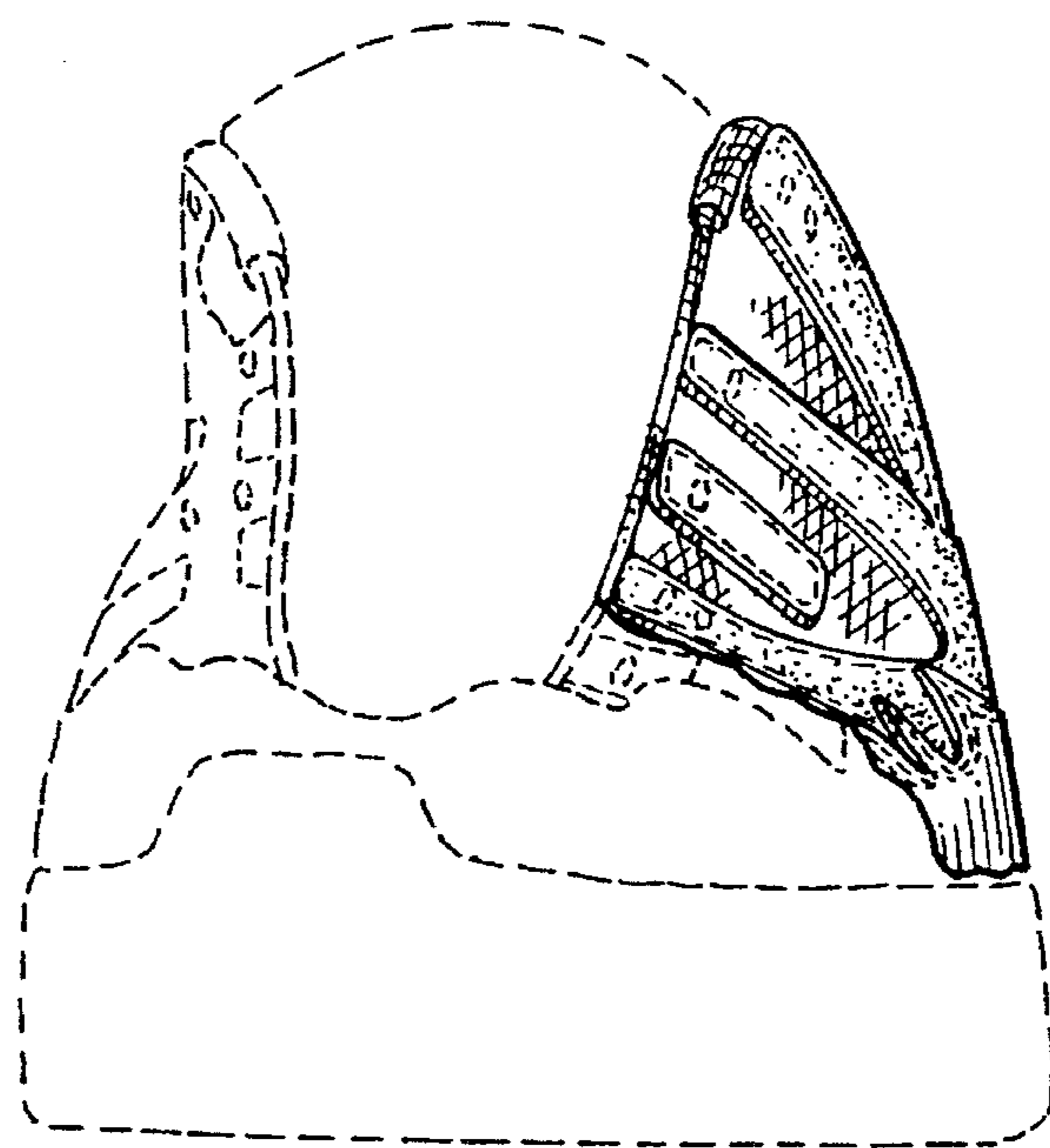

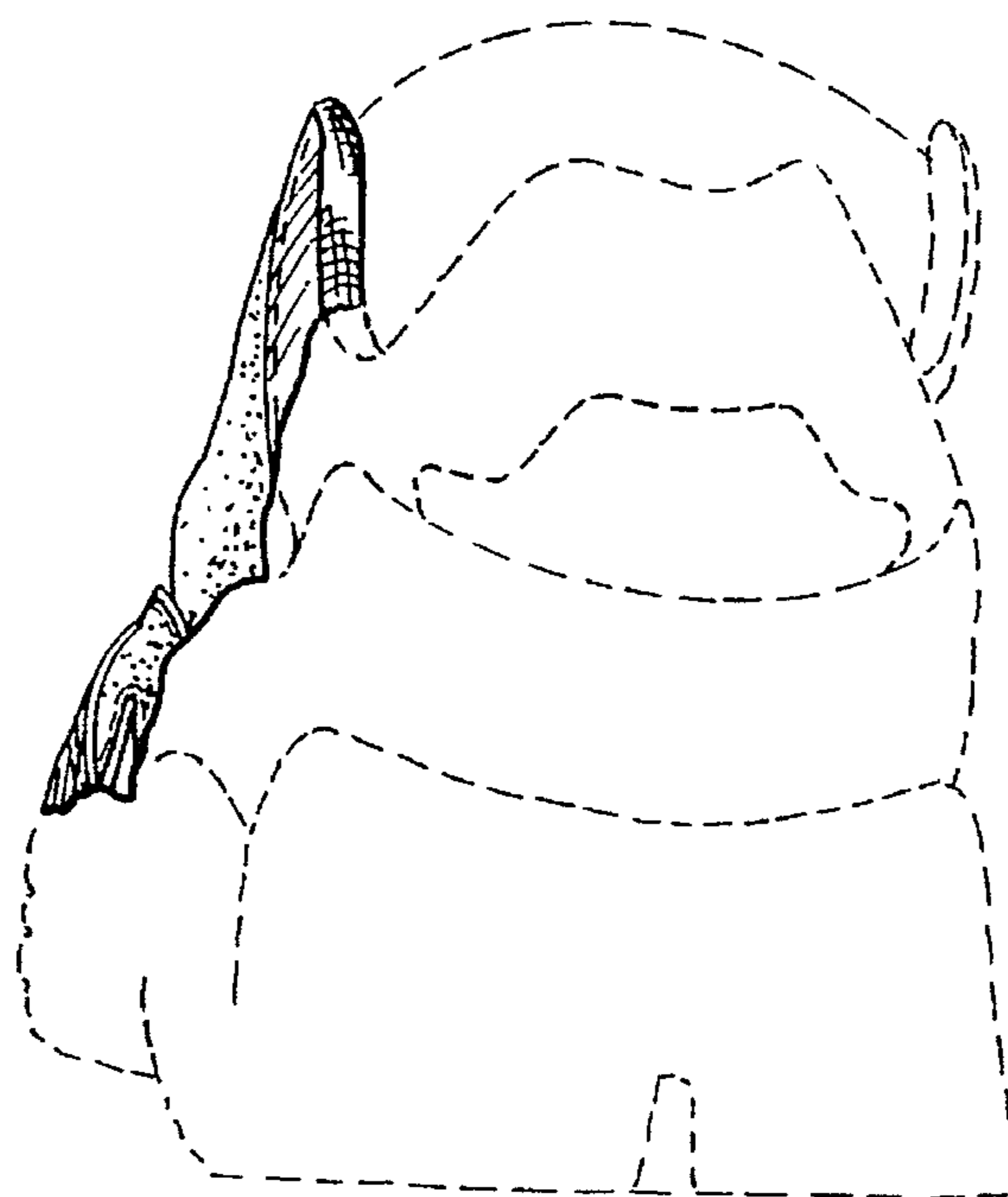
