FIG. 7 is a front bottom perspective view thereof;

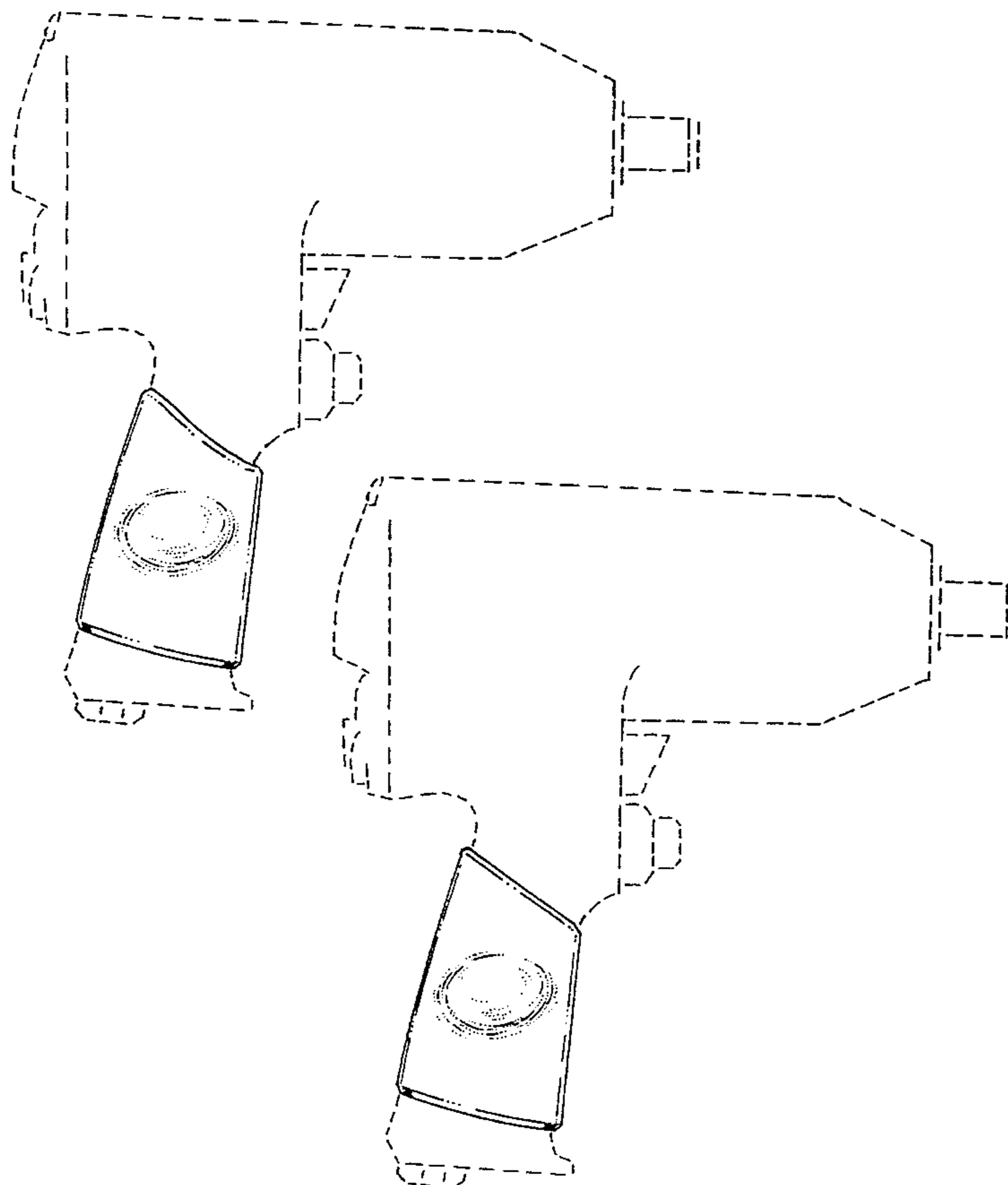
FIG. 8 is a front left top perspective view thereof;

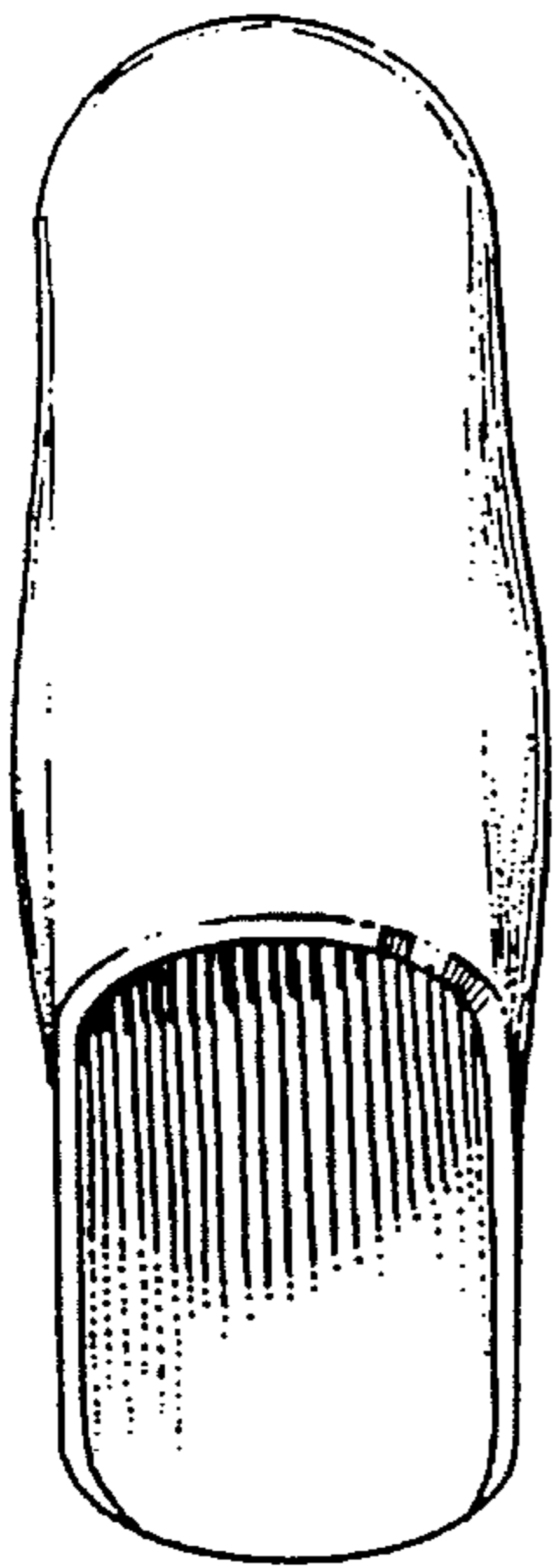

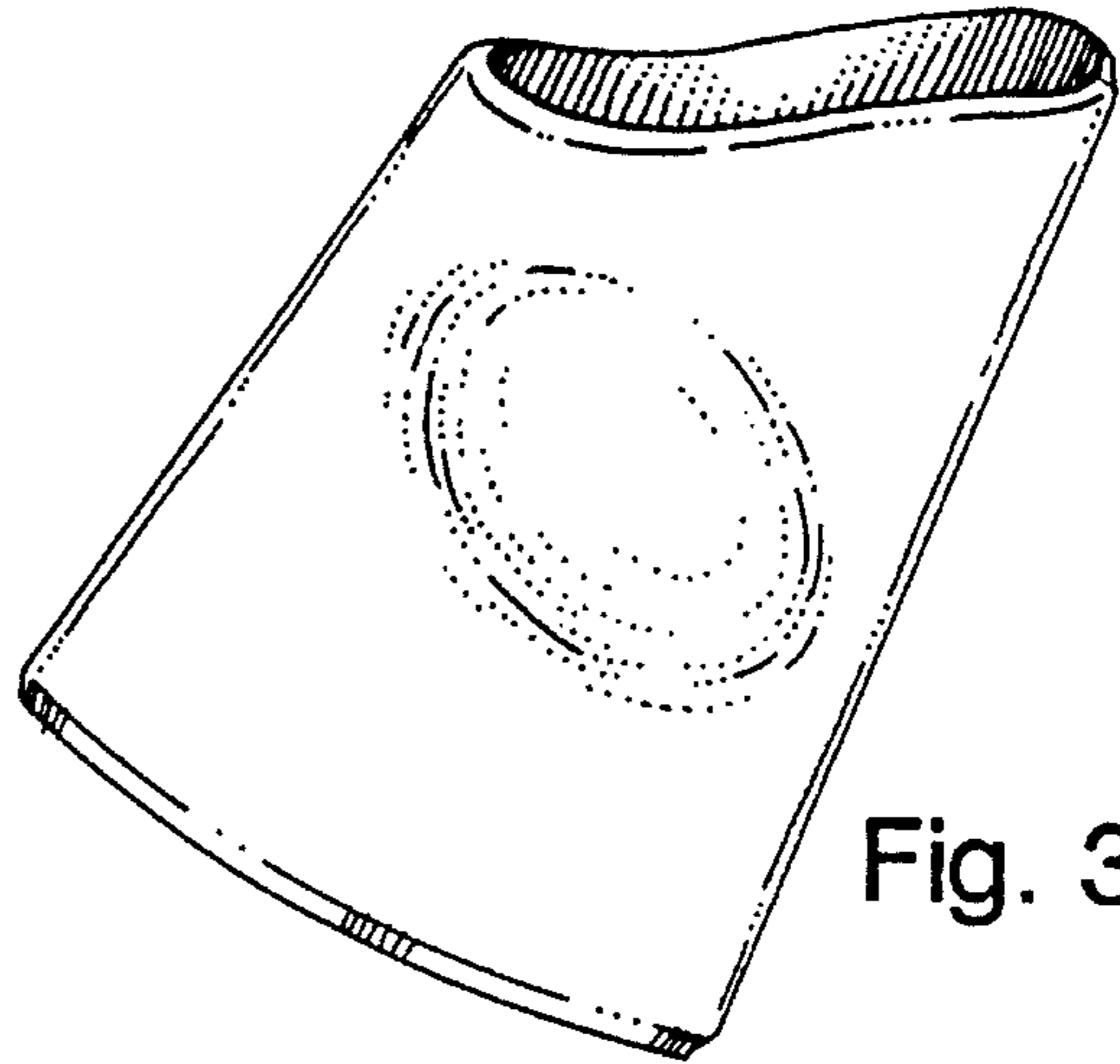

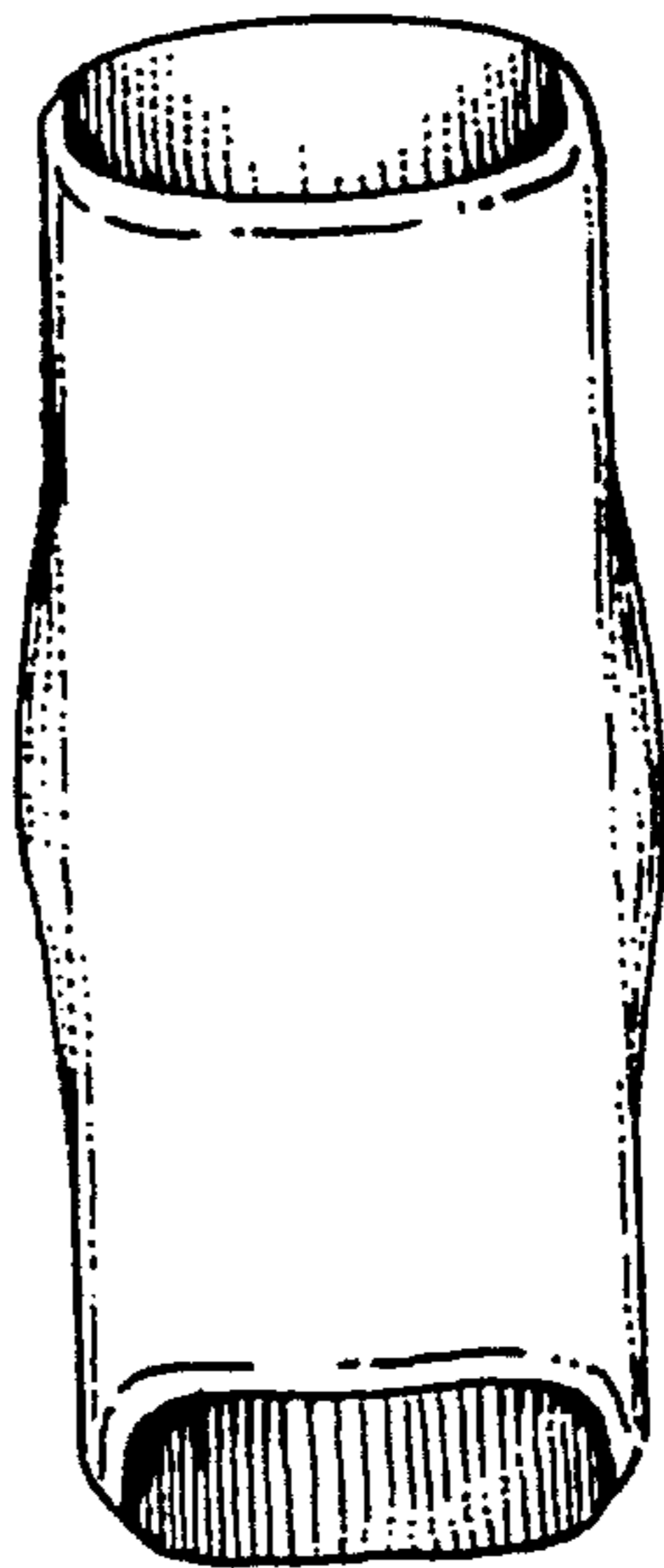

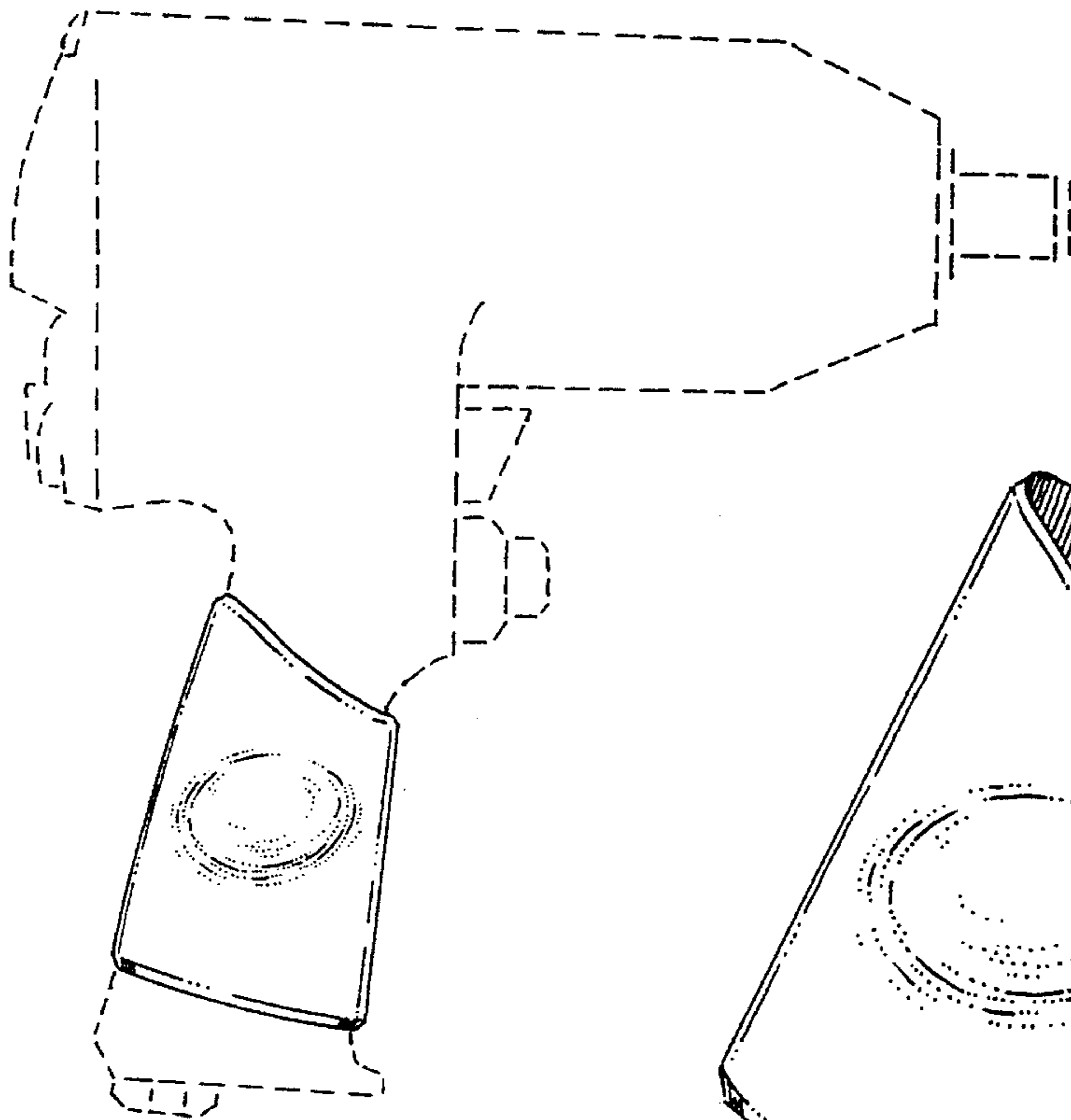

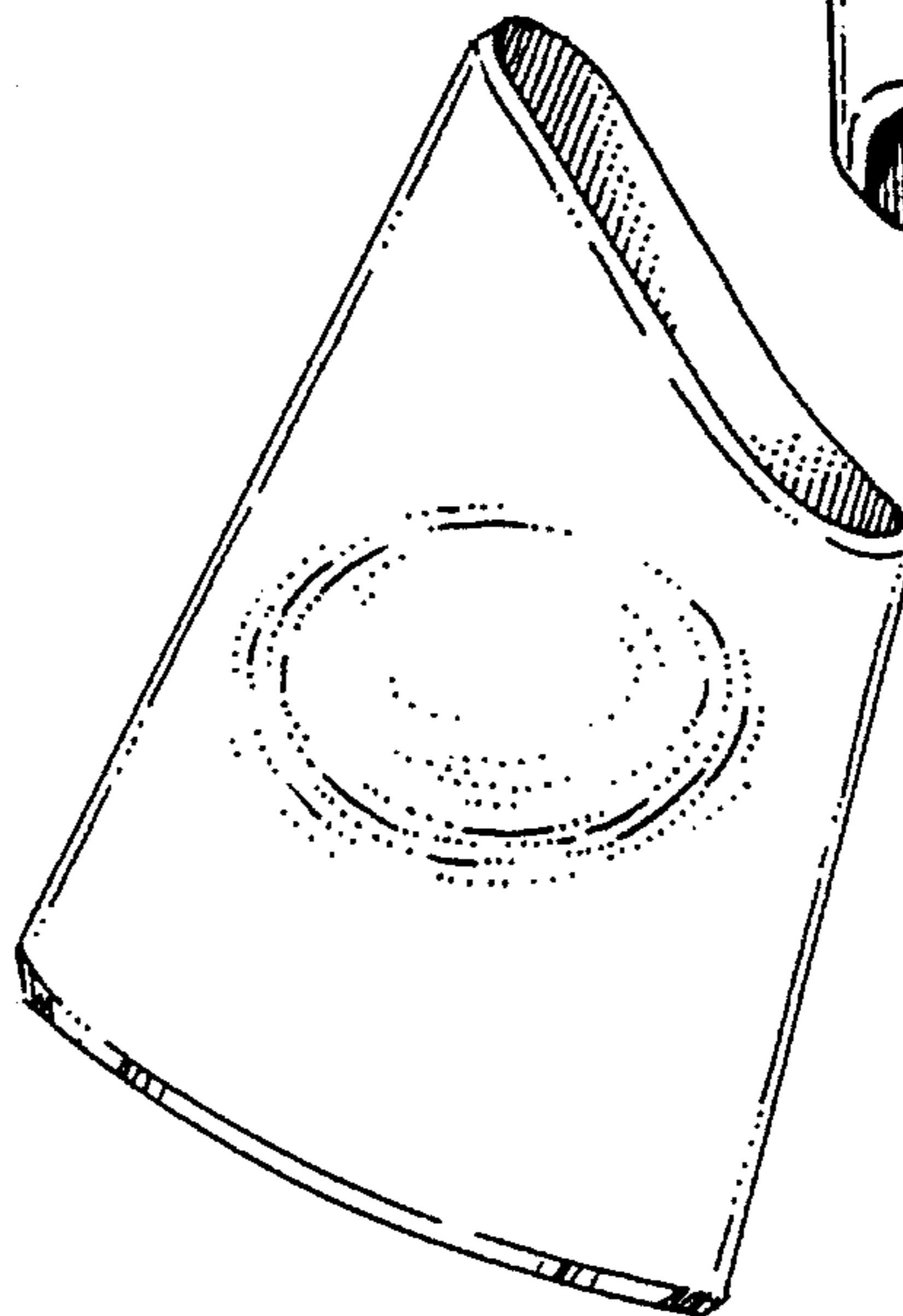

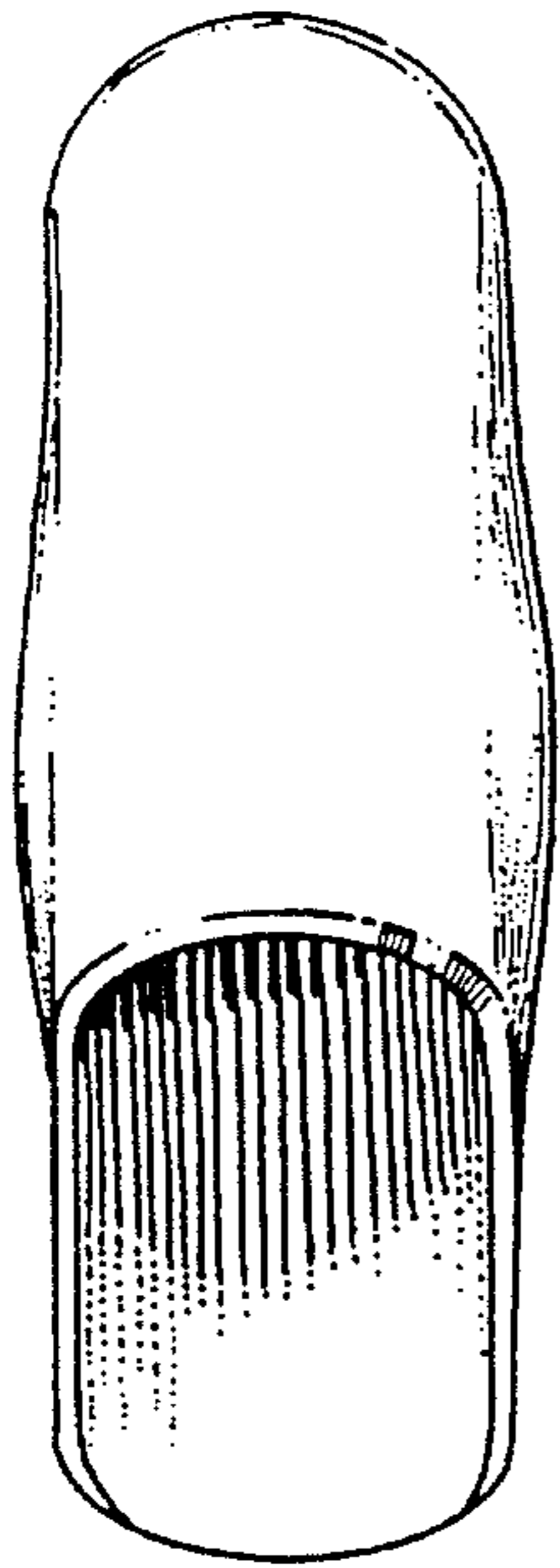

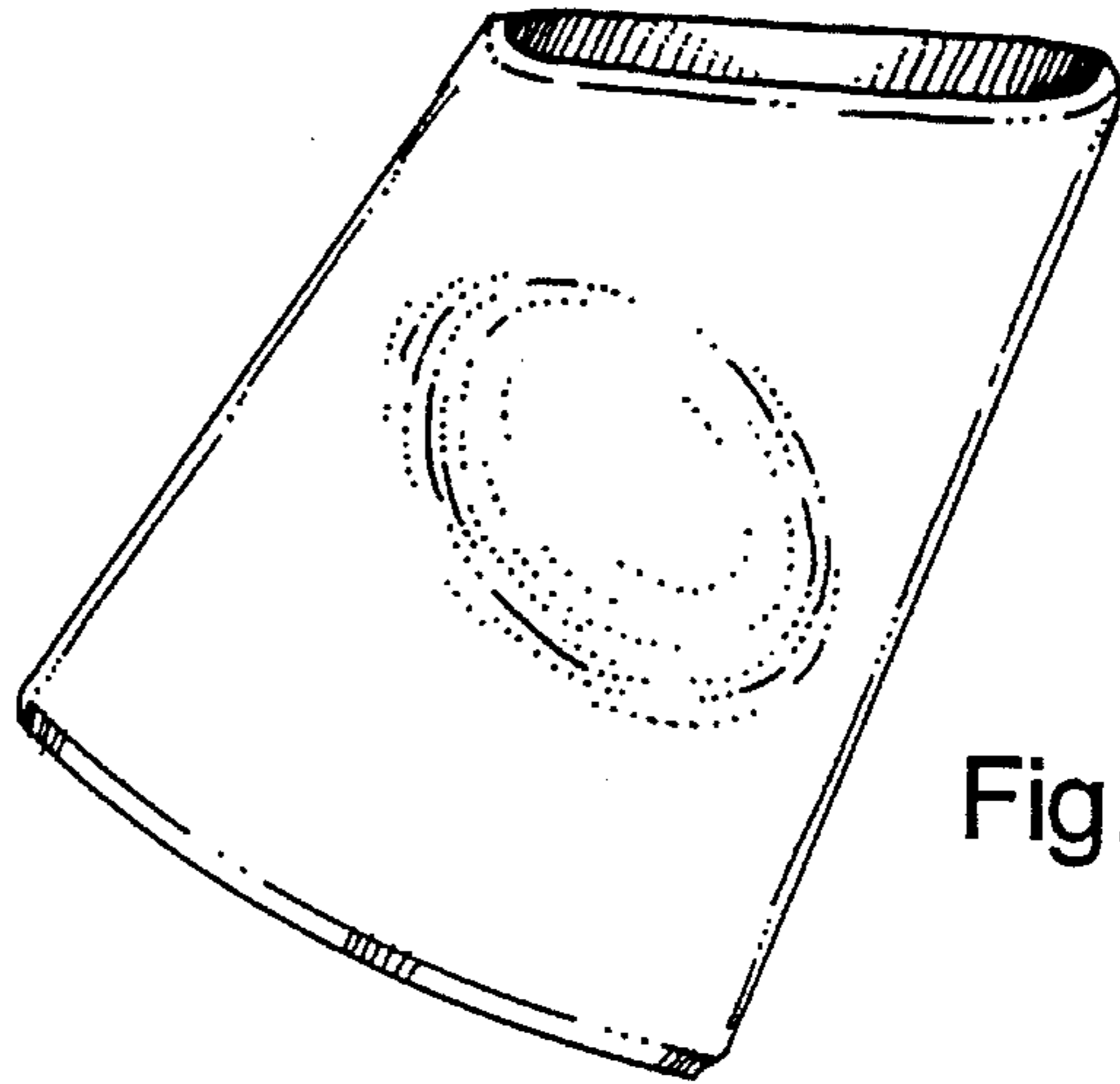

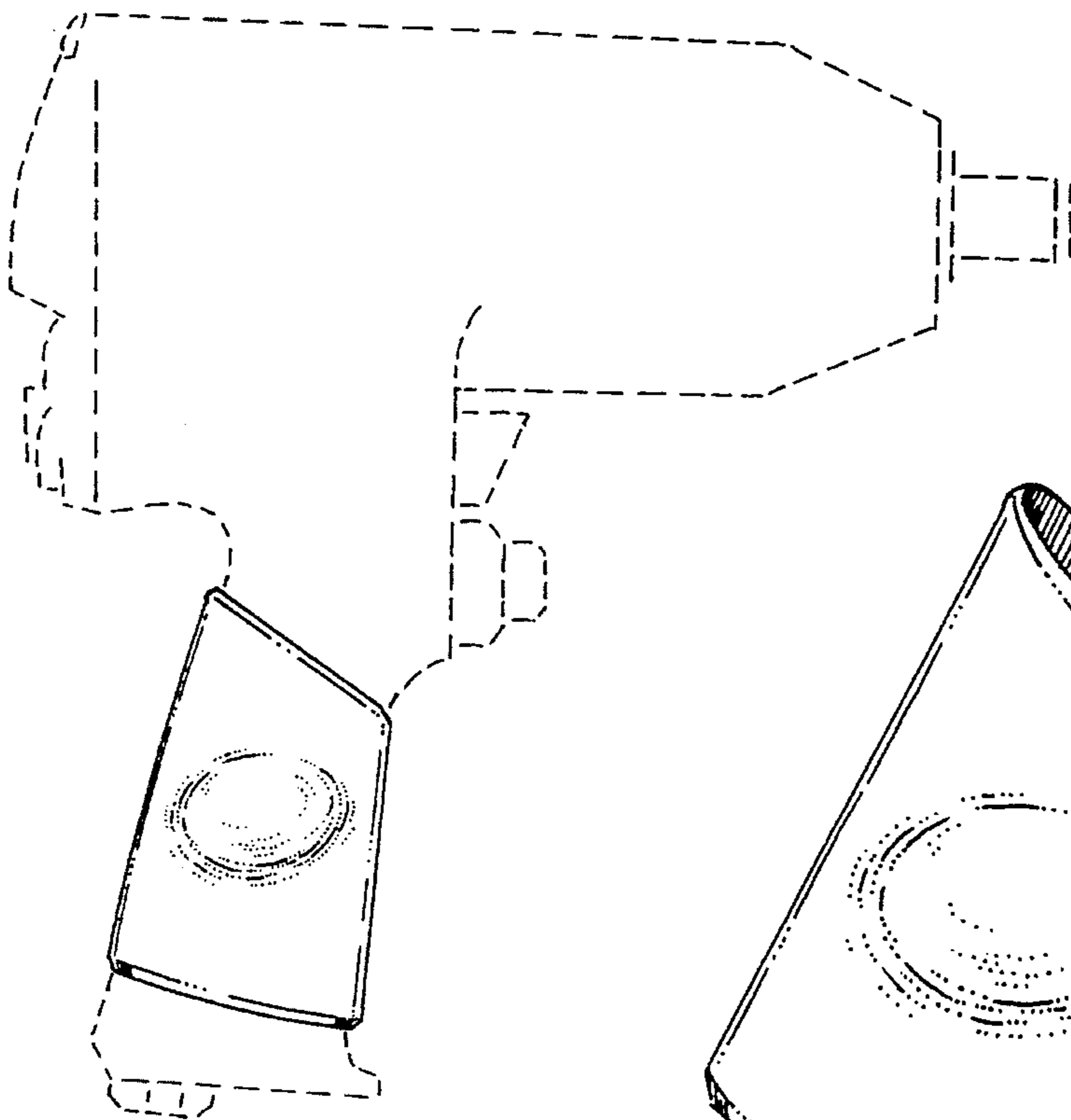

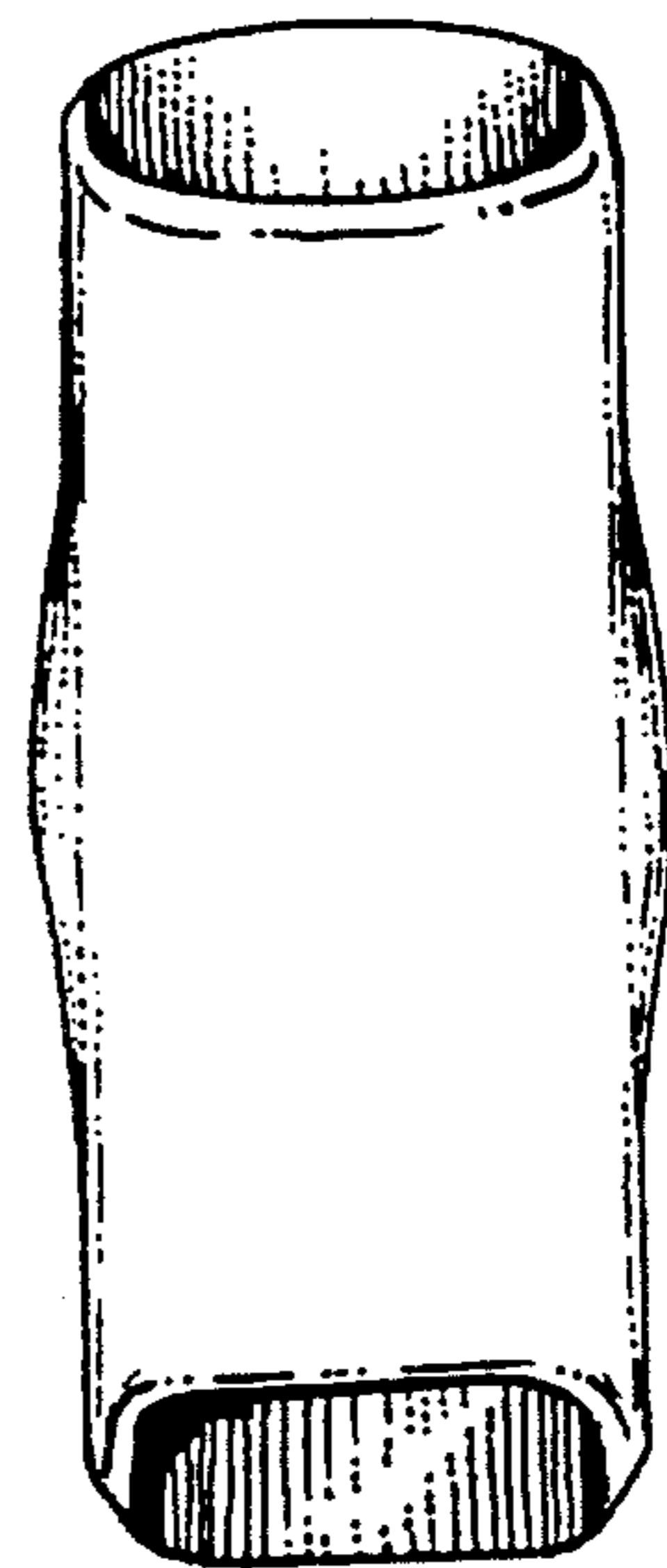

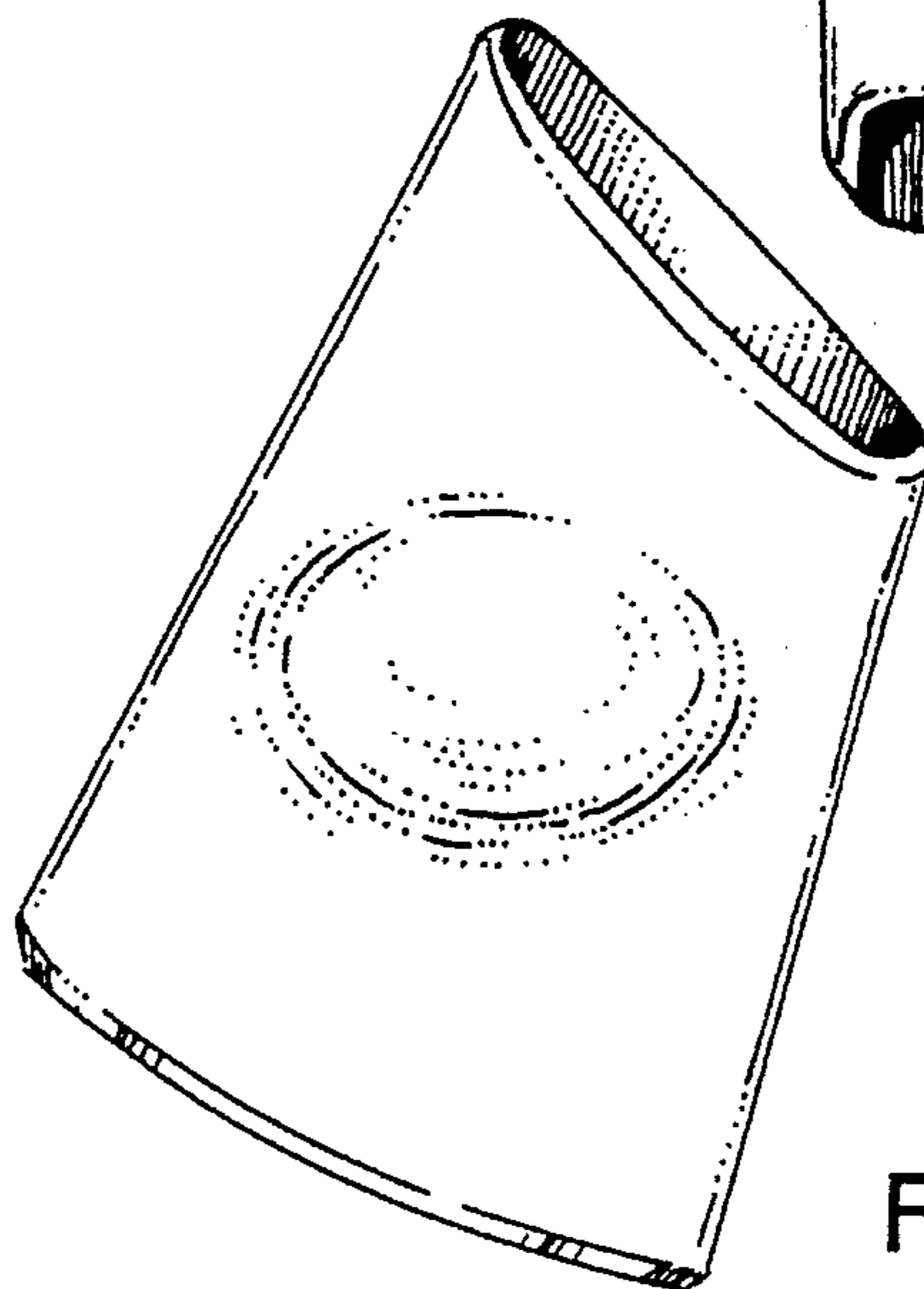
