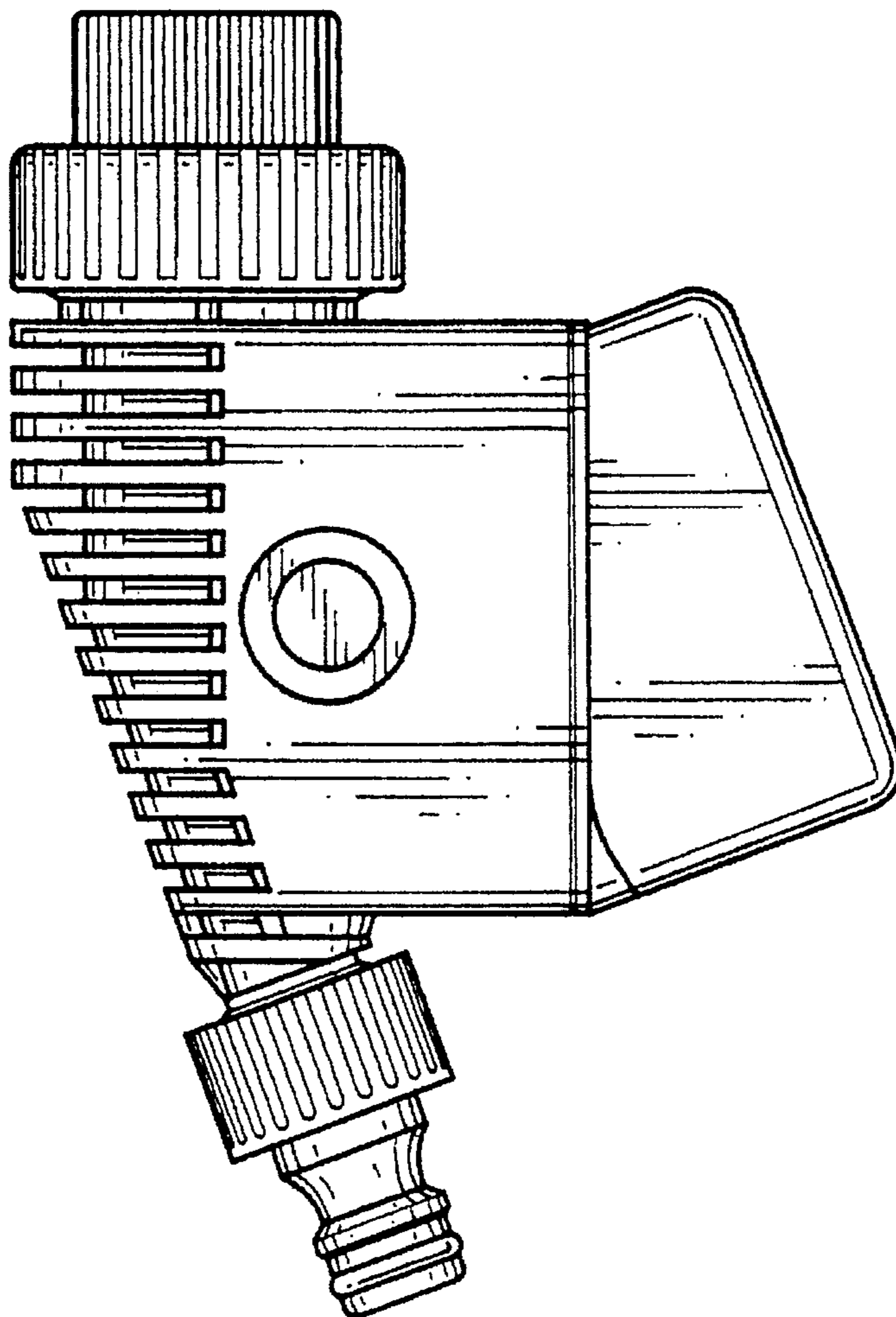
### [57] CLAIM

The ornamental design for a case for irrigation timer, as described and as illustrated in the drawings.

### DESCRIPTION

FIG. 1 shows a left-hand lateral view of our case, with closed cover, the right-hand lateral view being identical; FIG. 2 shows a front view of the case of FIG. 1; FIG. 3 shows a top view of the case of FIG. 2; FIG. 4 shows a bottom view of the case of FIG. 2; FIG. 5 shows a rear view of said case; FIG. 6 is similar to FIG. 1, but with open cover; and, FIG. 7 is similar to FIG. 2, but with open cover.

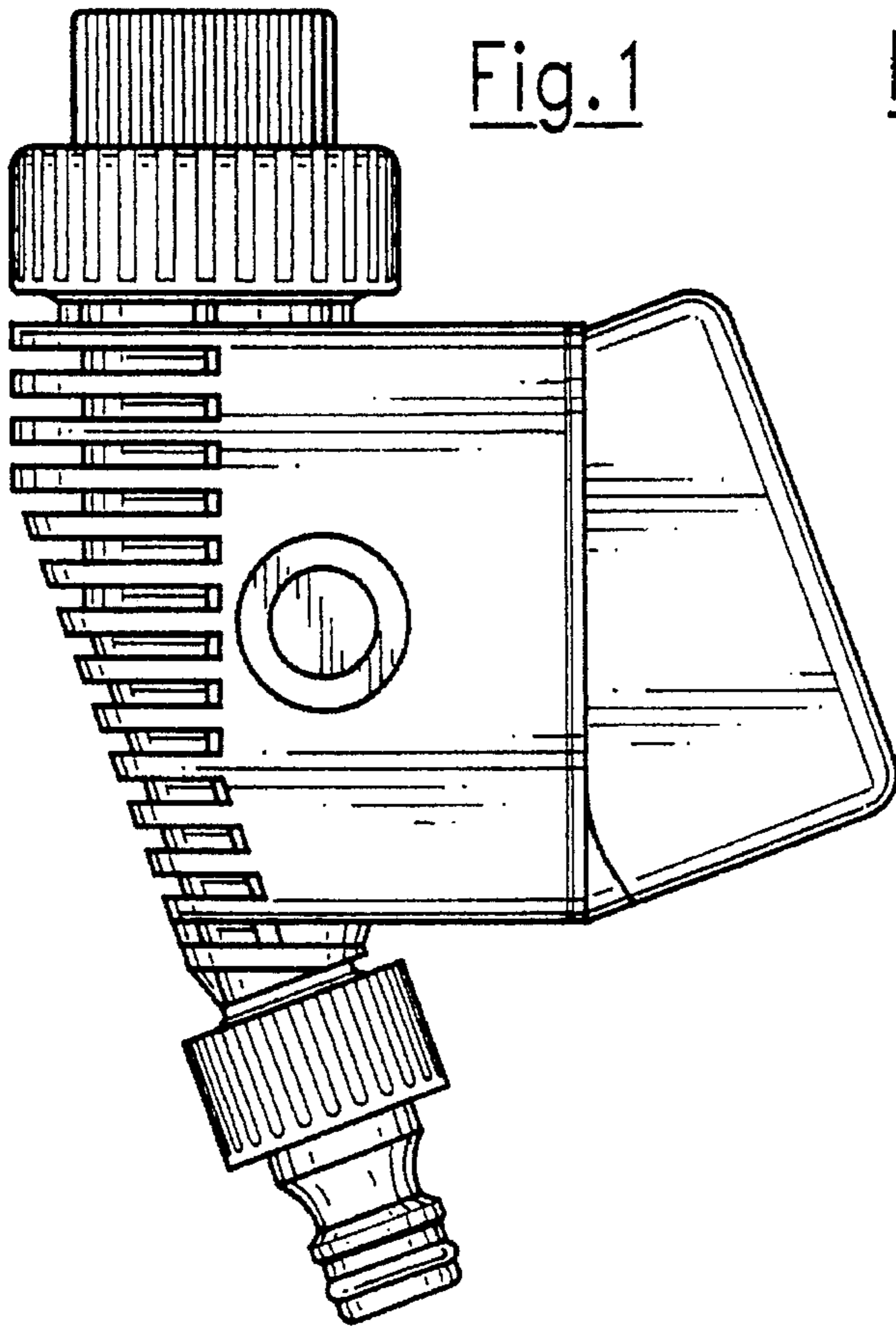

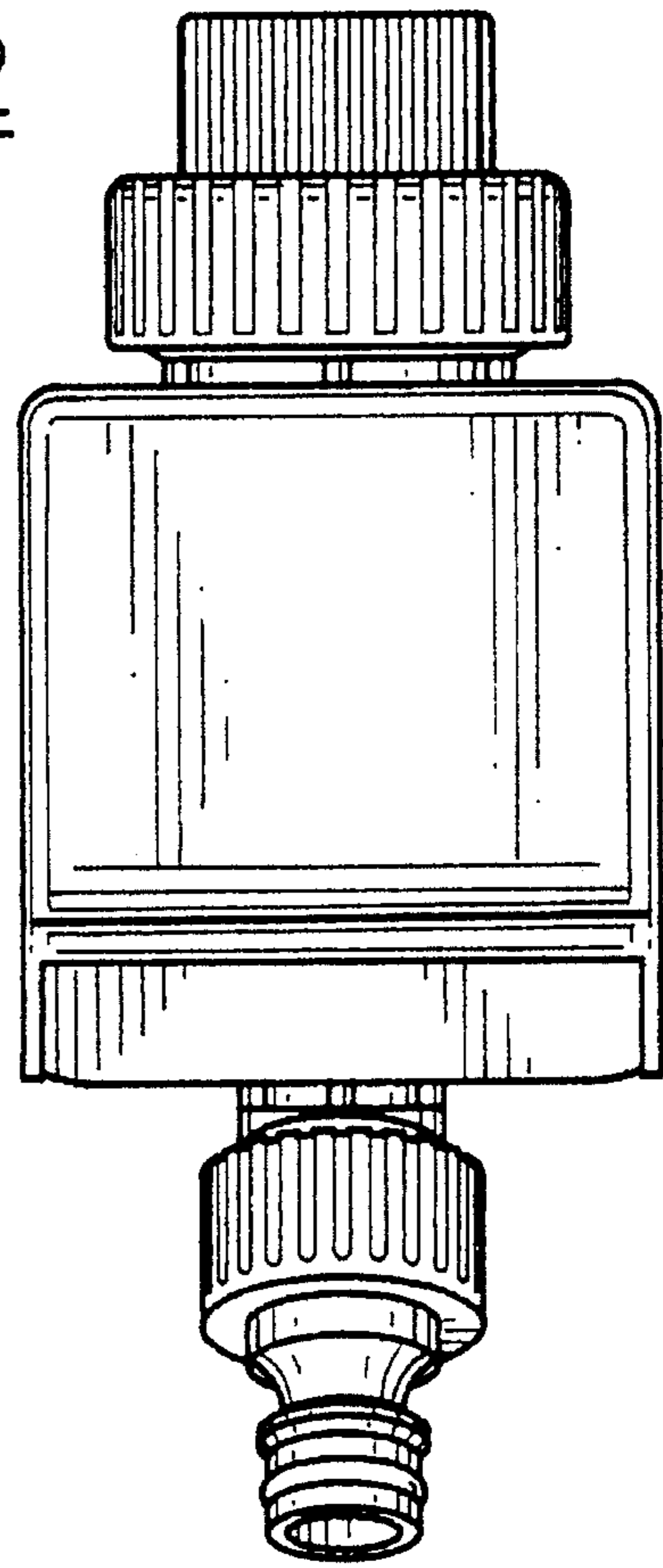

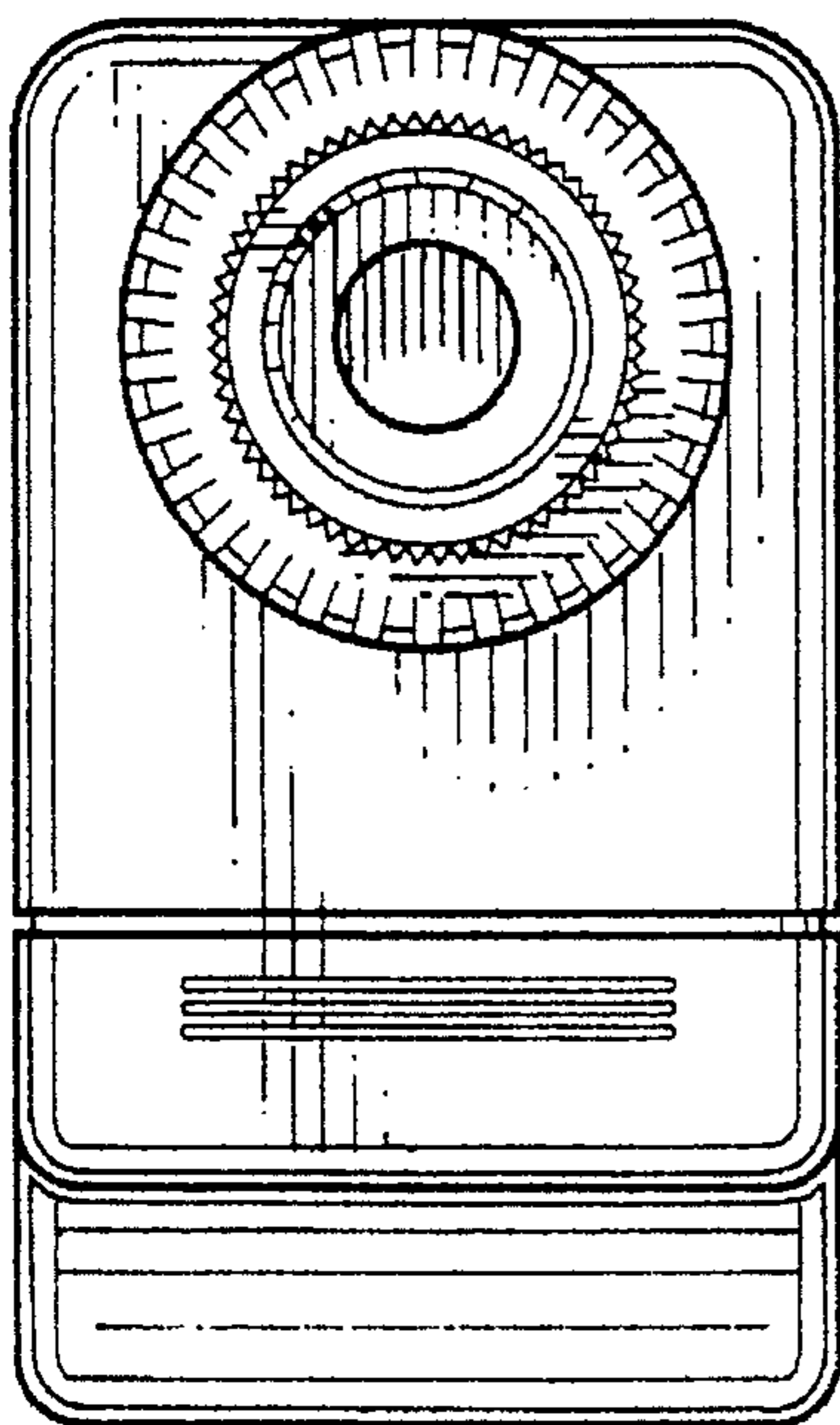
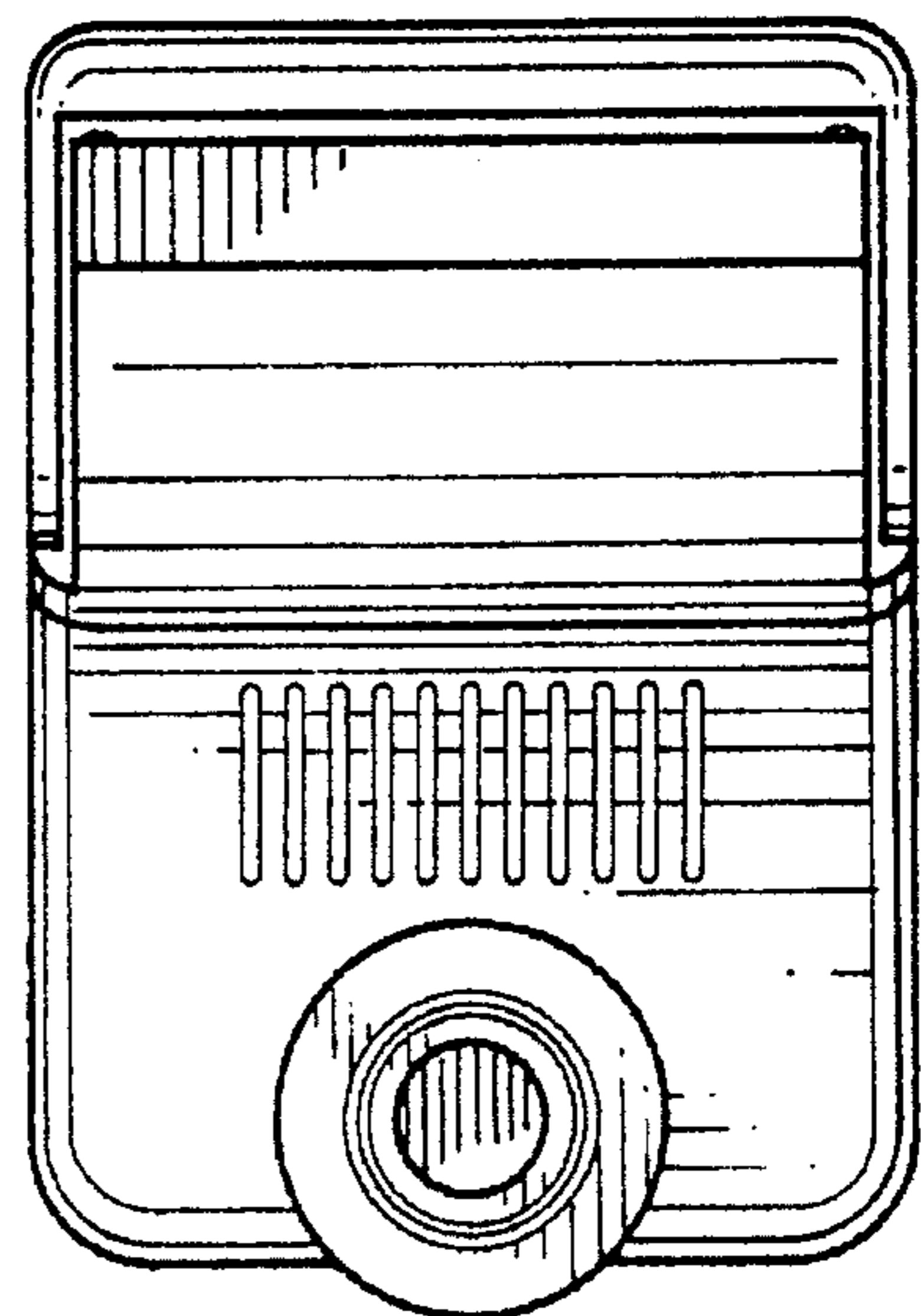

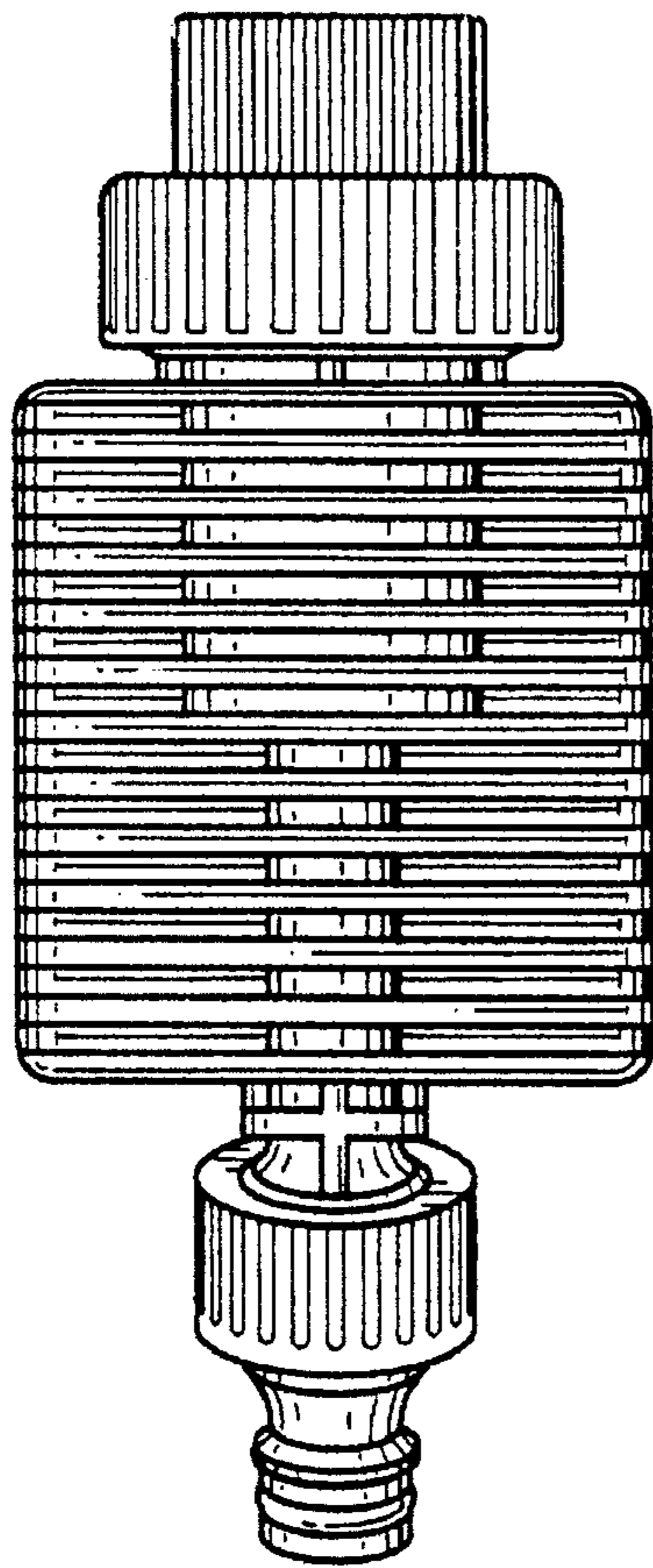

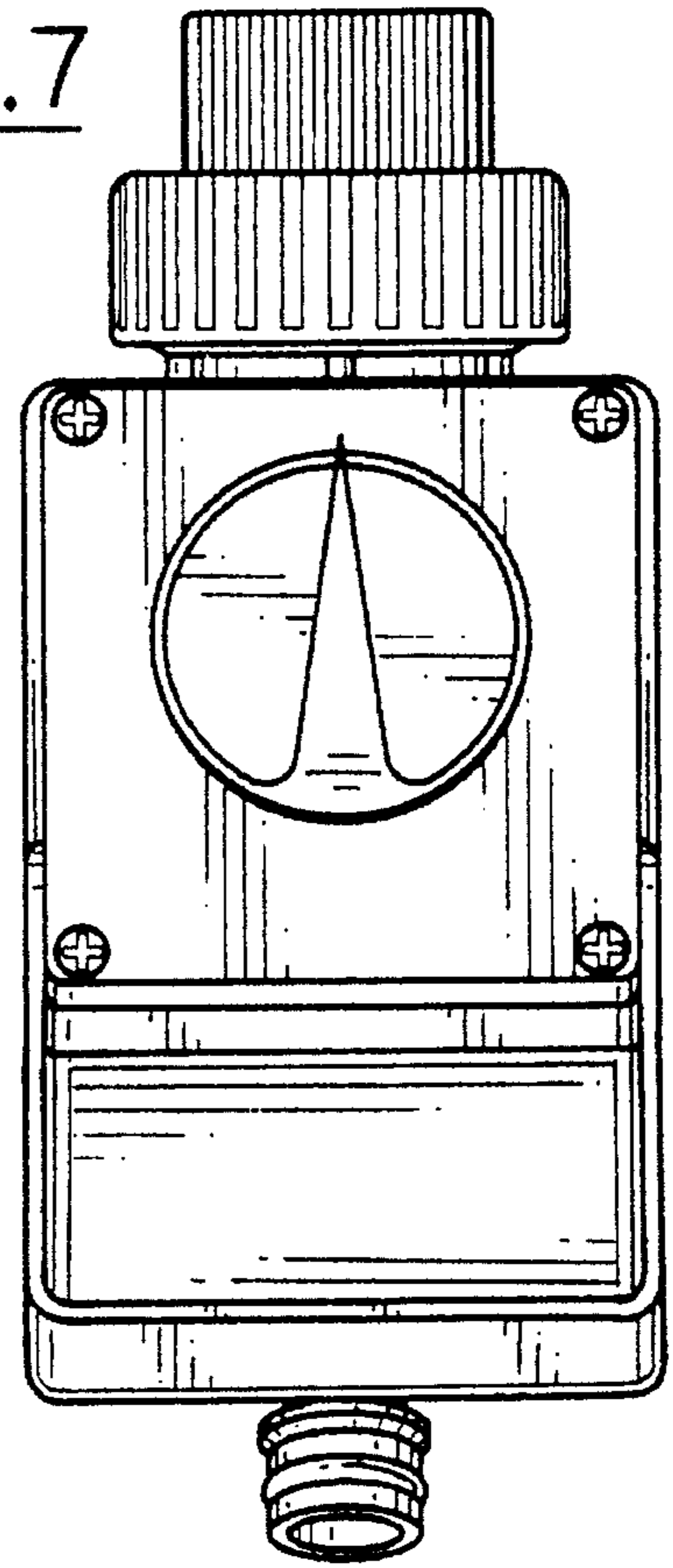

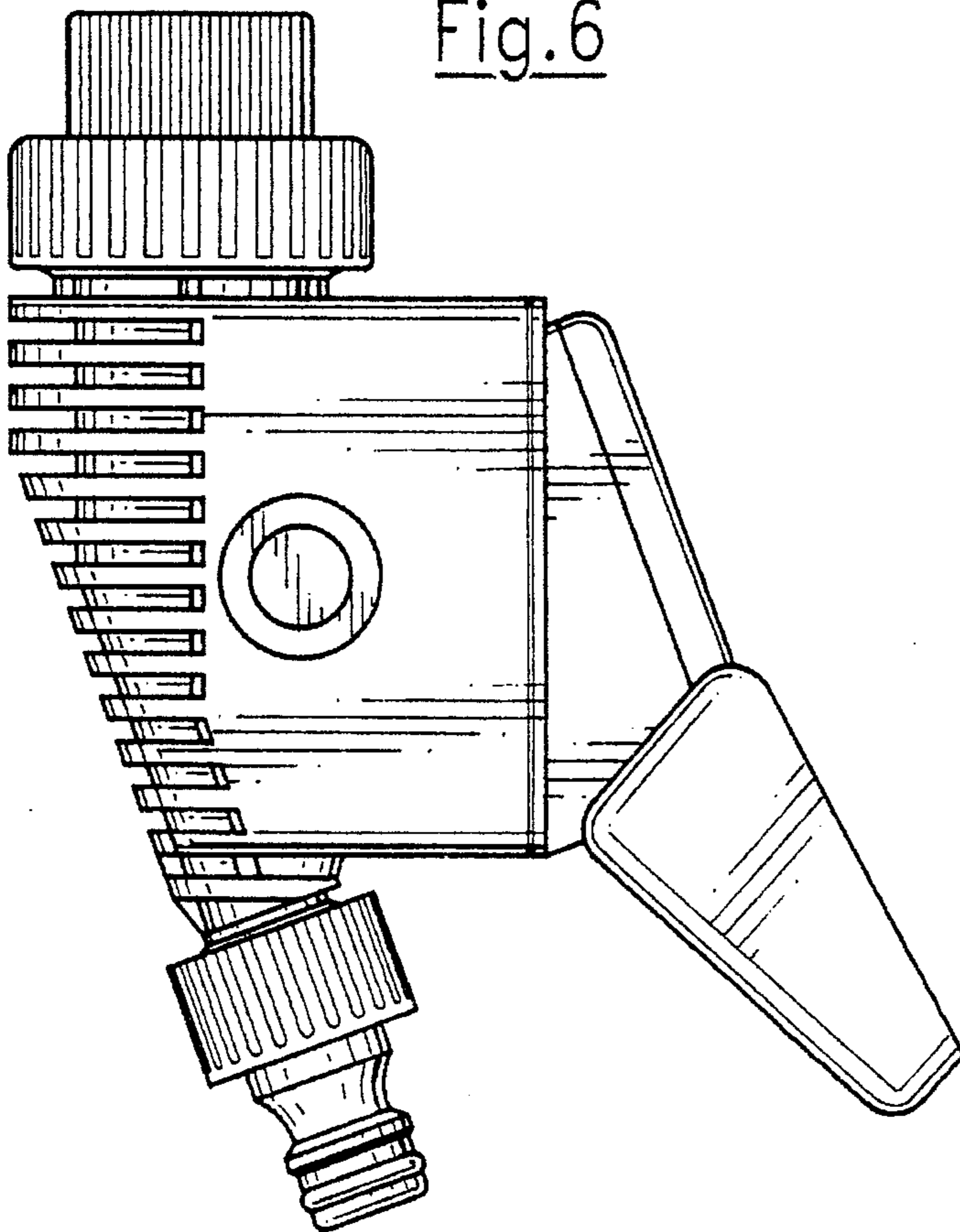
