[57] **CLAIM**

The ornamental design for a combined television, compact disc player and integral remote control, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view showing my new design of a combined television, compact disc player and integral remote control;

FIG. 2 is a top plan view thereof;

FIG. 3 is a left side elevational view thereof, the right side being a mirror image;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a reduced right side, front perspective view of the combined television, compact disc player and integral remote control;

FIG. 7 is a right side, front perspective view thereof with speakers and remote control in an alternative position;

FIG. 8 is a left side, rear perspective view thereof with speakers and remote control in the position shown in FIG. 1;

FIG. 9 is an enlarged left side, rear perspective view of the remote control shown separately for clarity of illustration;

FIG. 10 is a top plan view thereof;

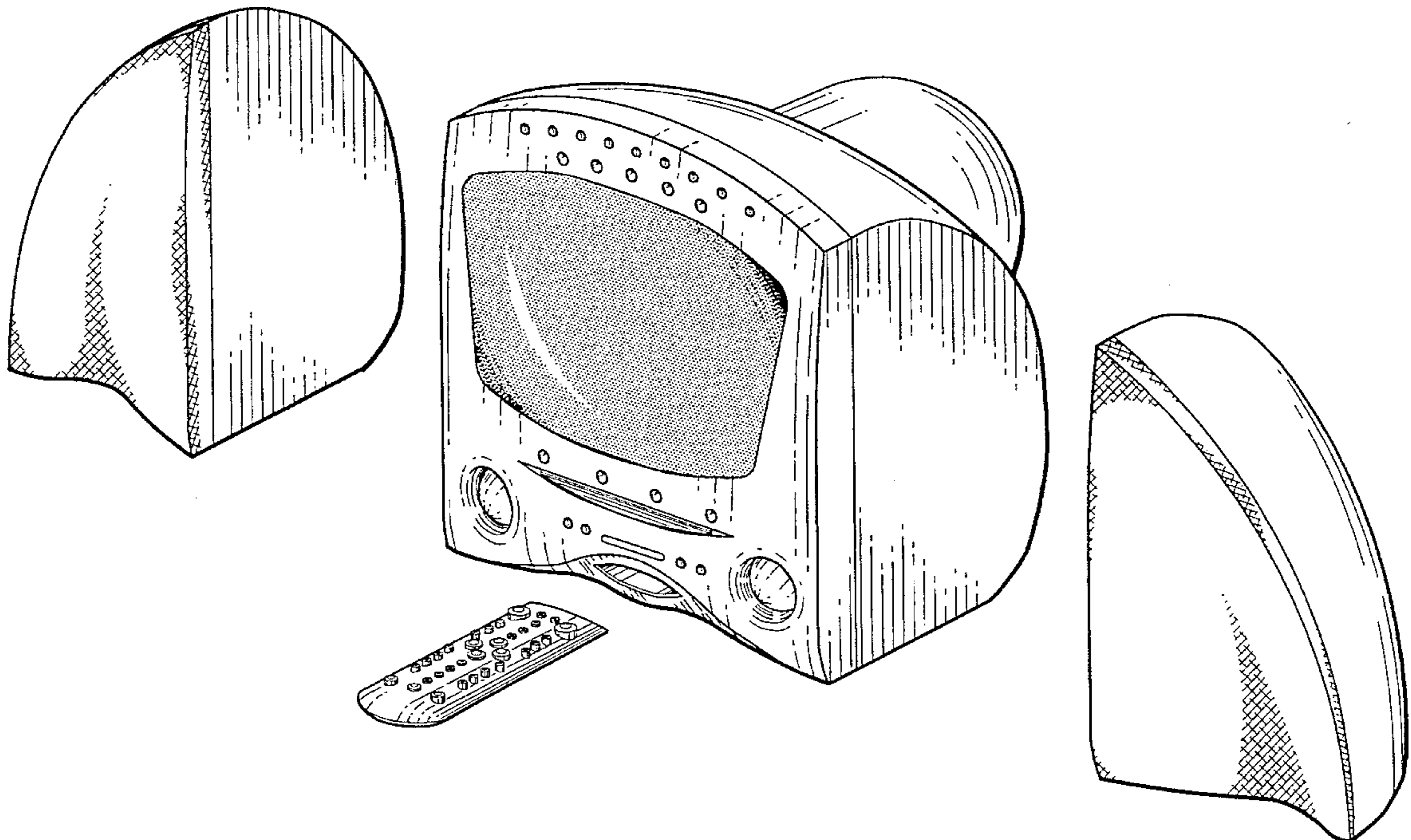
FIG. 11 is a rear elevational view thereof;

FIG. 12 is a left side elevational view thereof, the right side elevational view being a mirror image;

FIG. 13 is a bottom plan view thereof; and,

FIG. 14 is a front elevational view thereof.

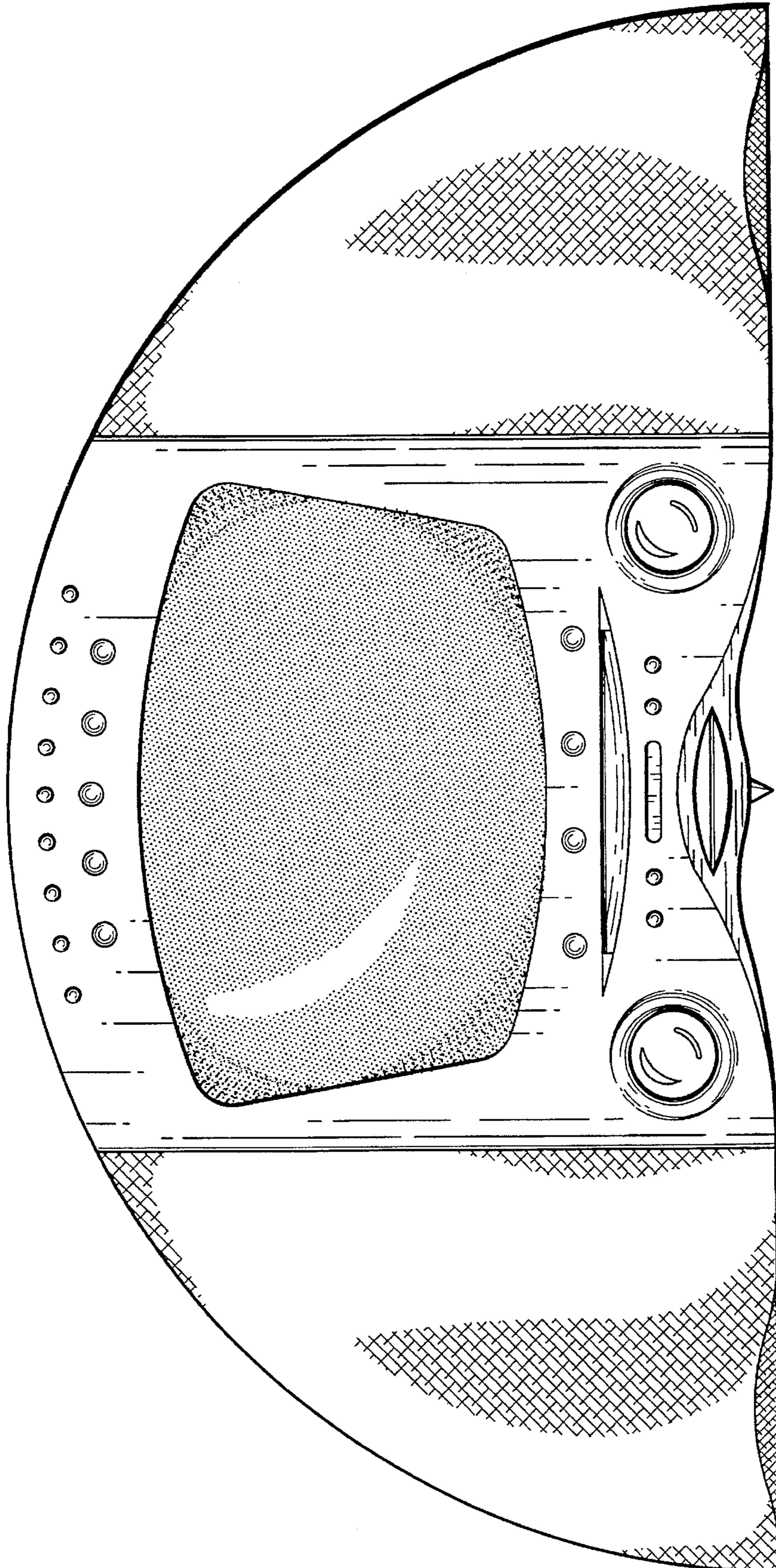

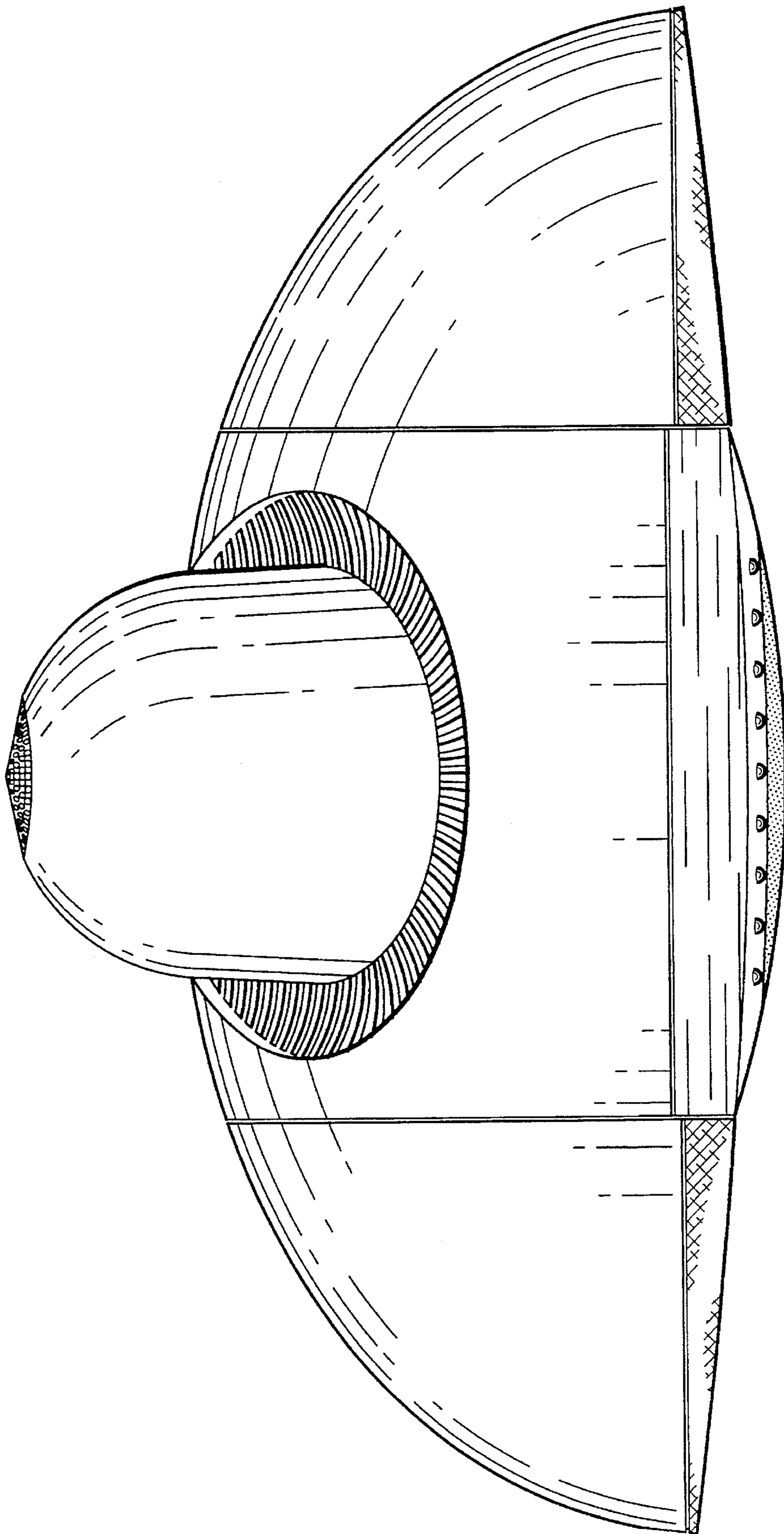

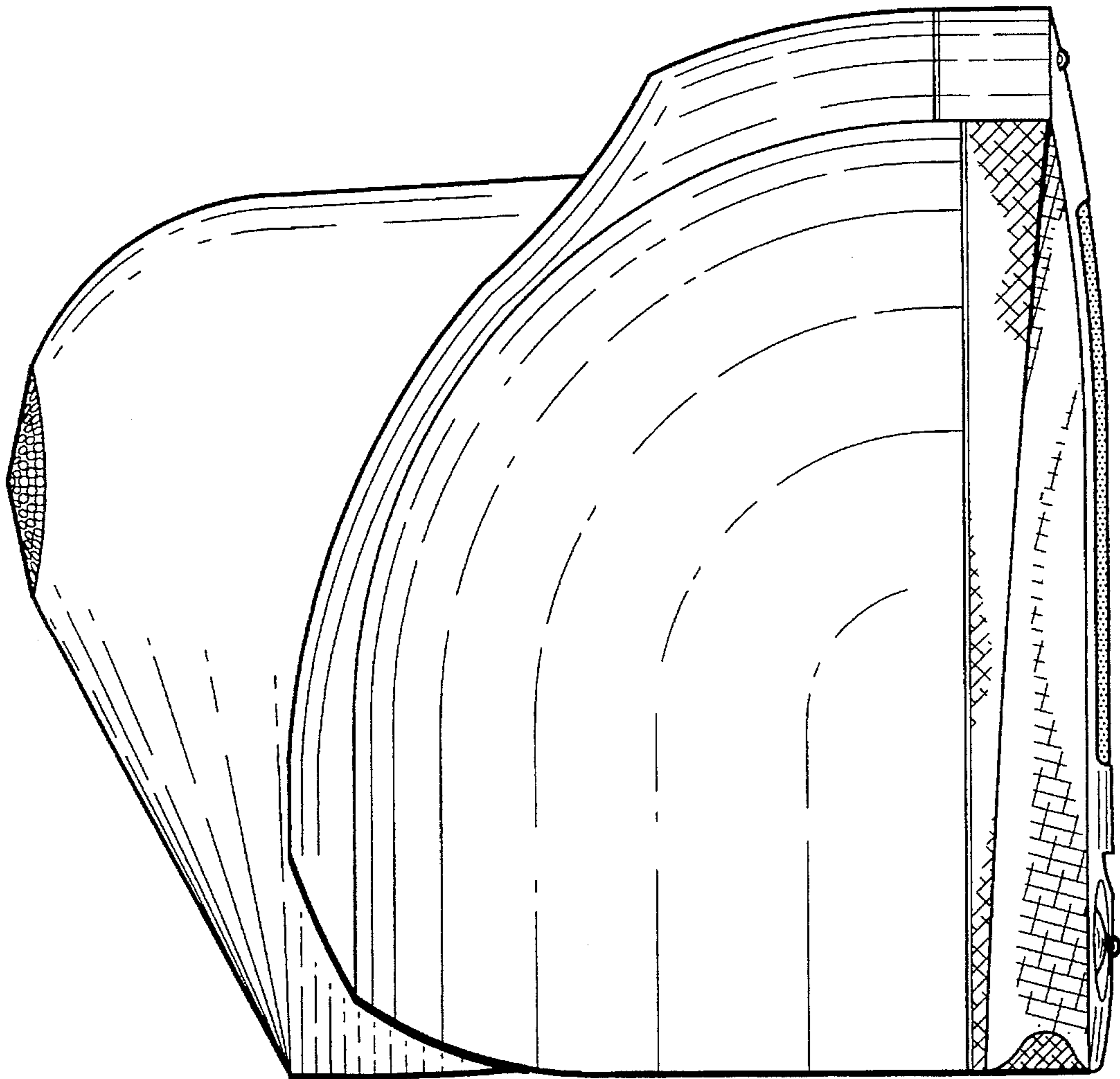

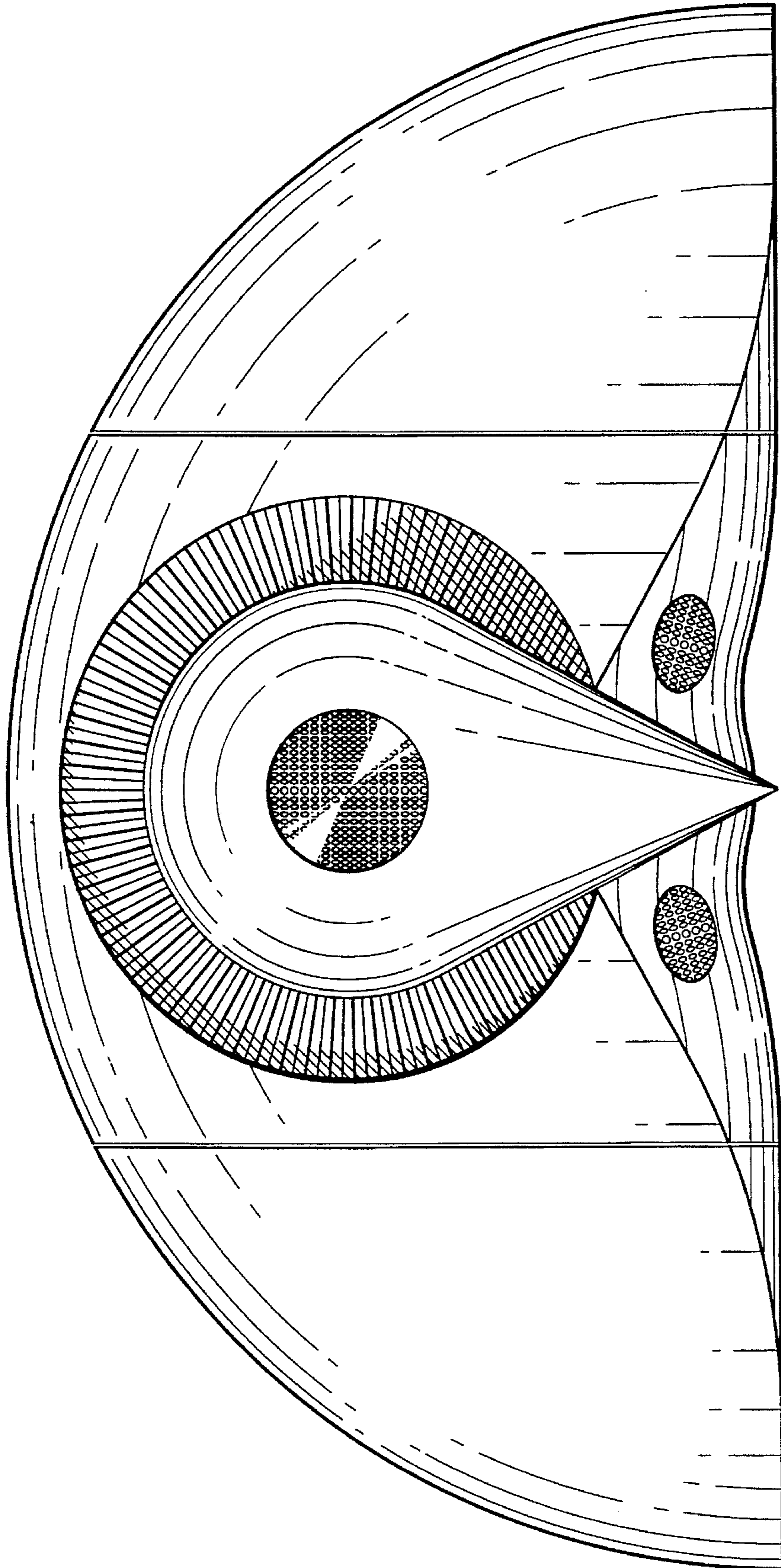

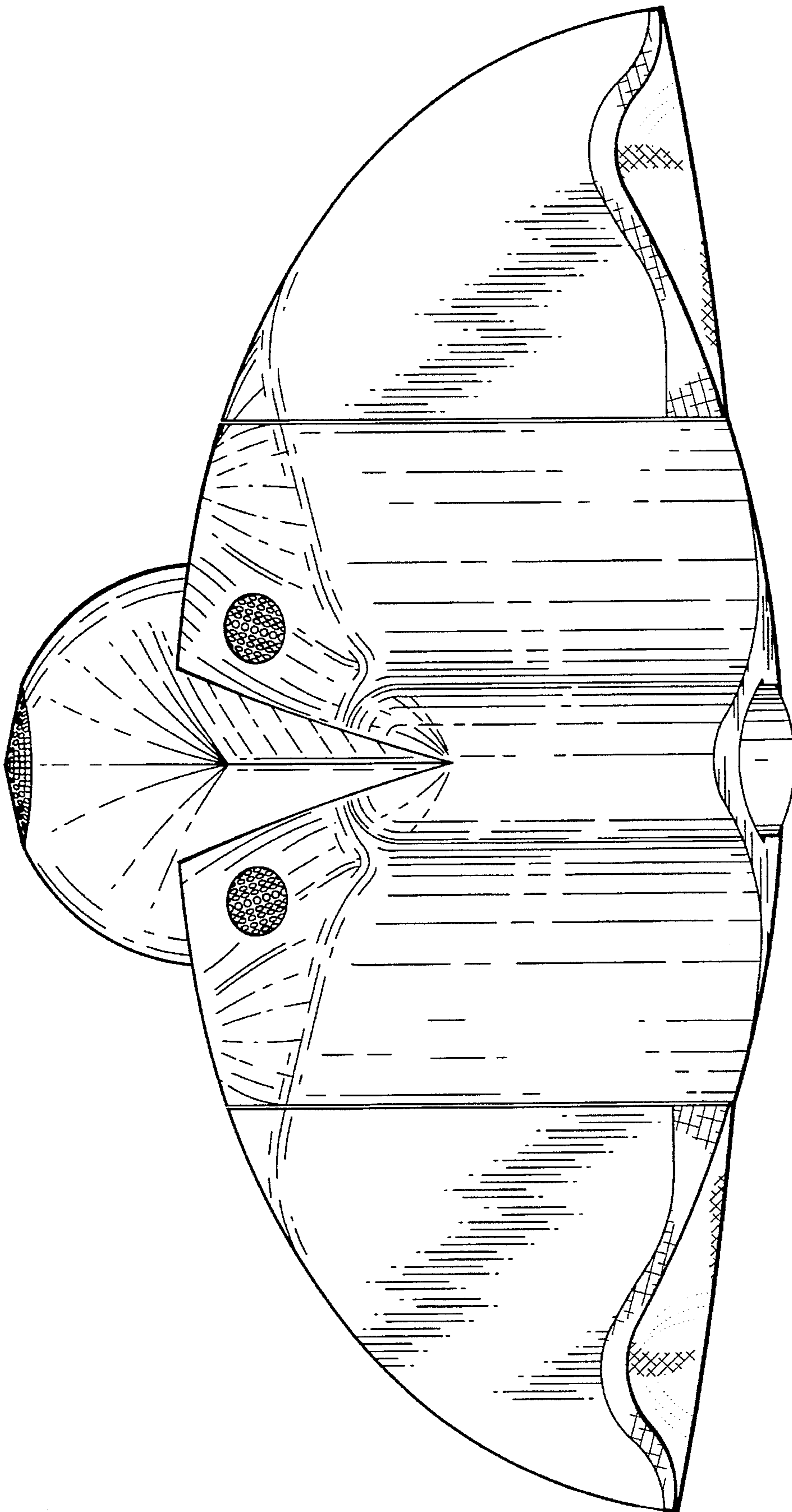

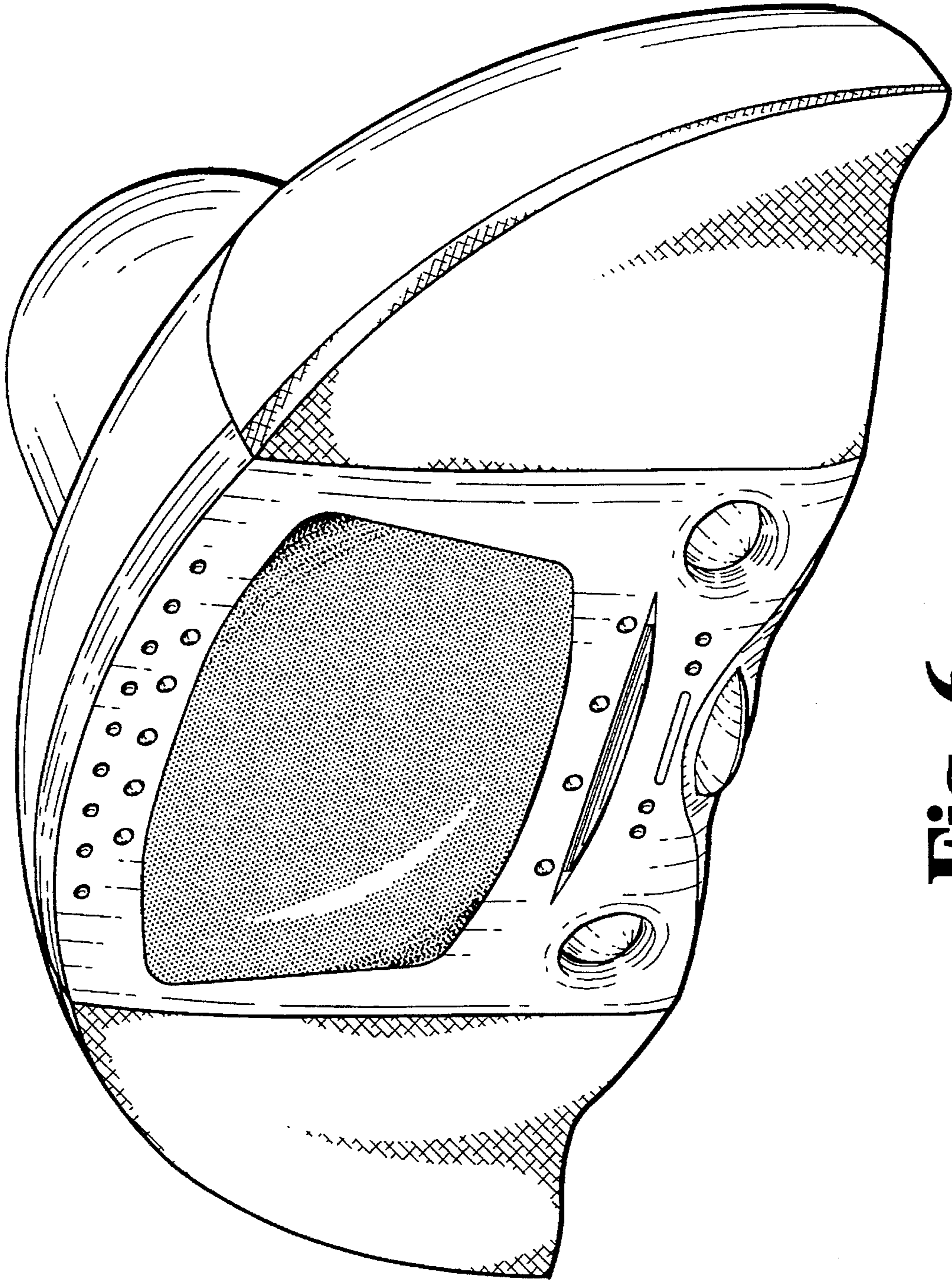

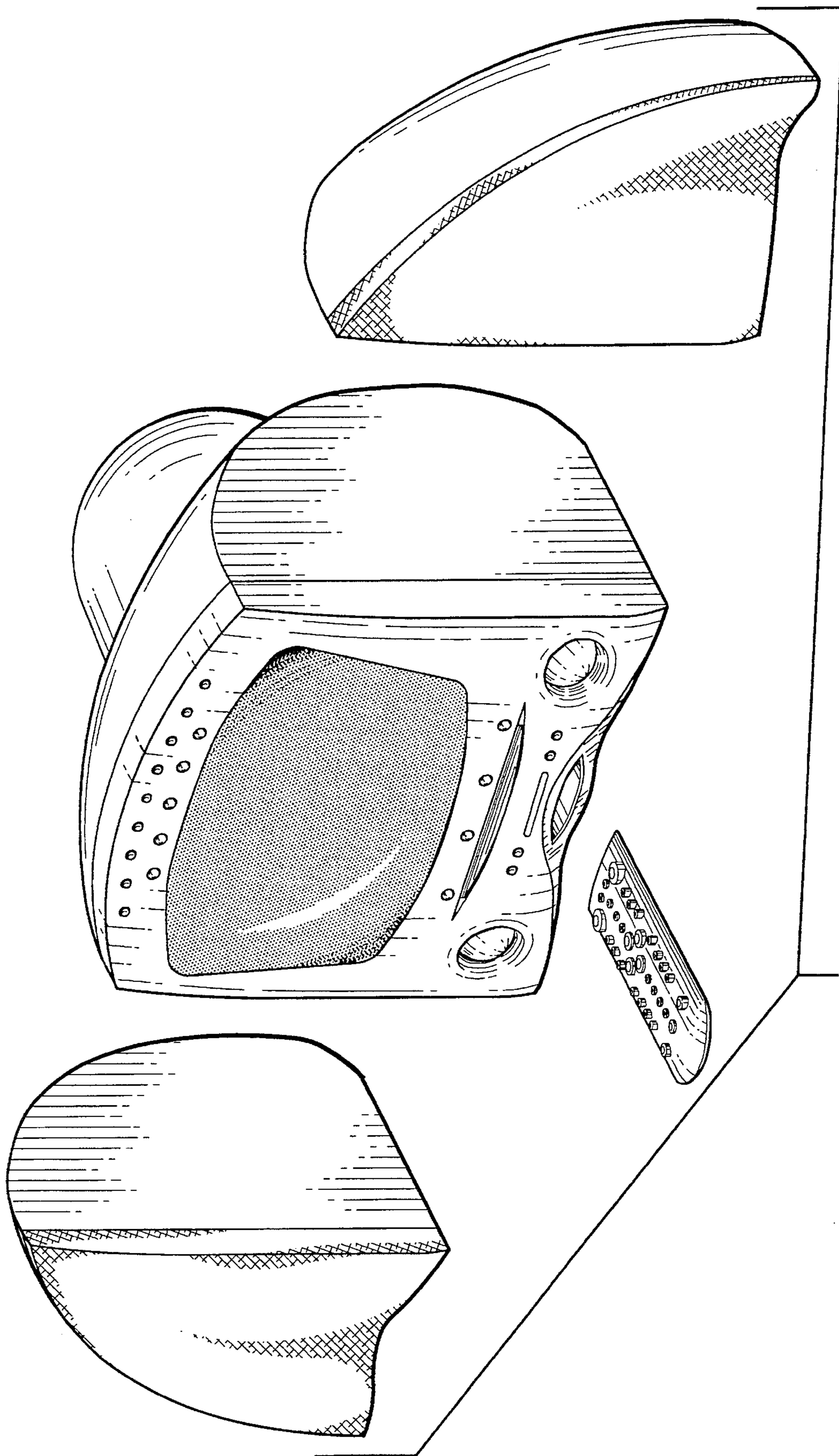

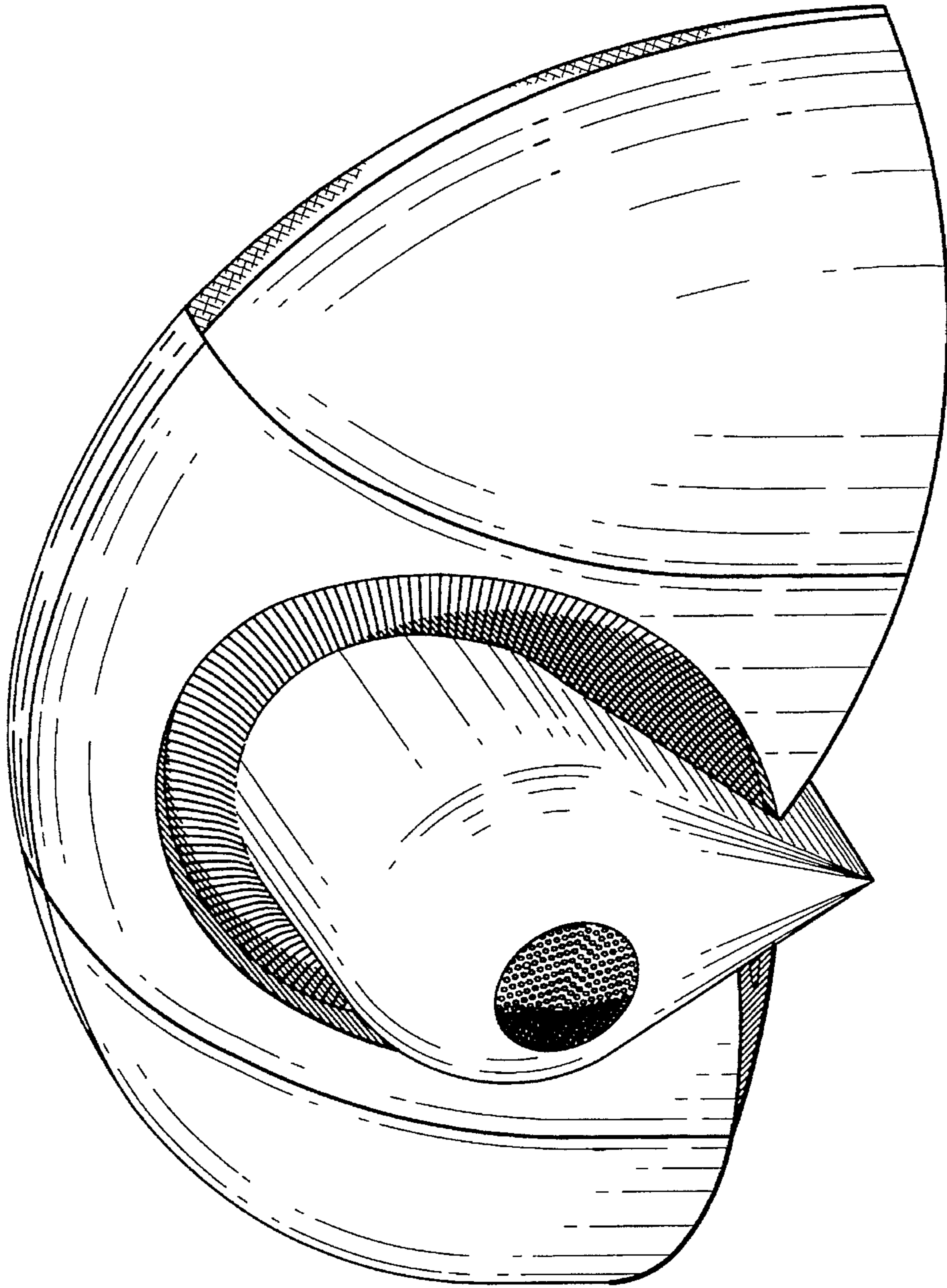

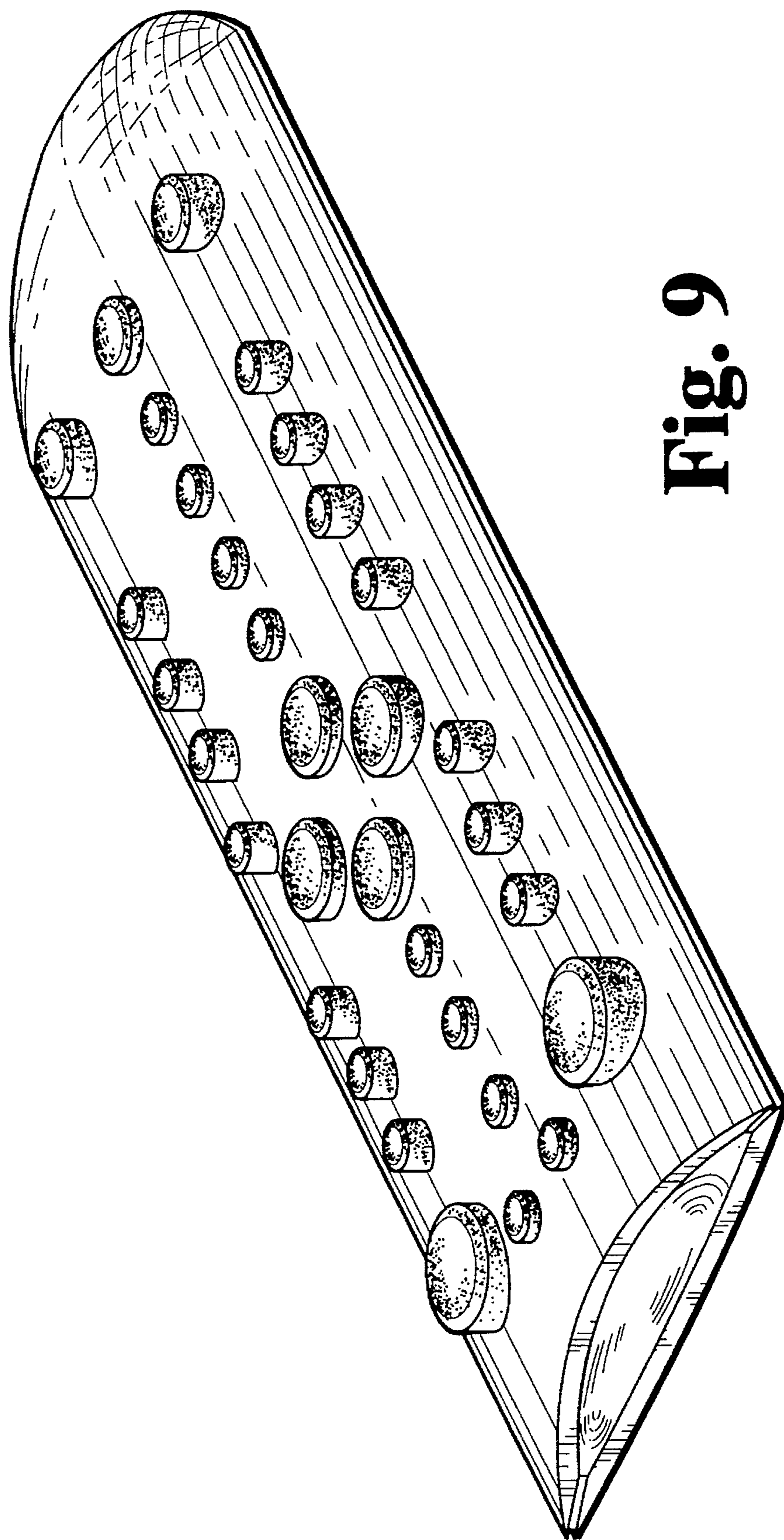

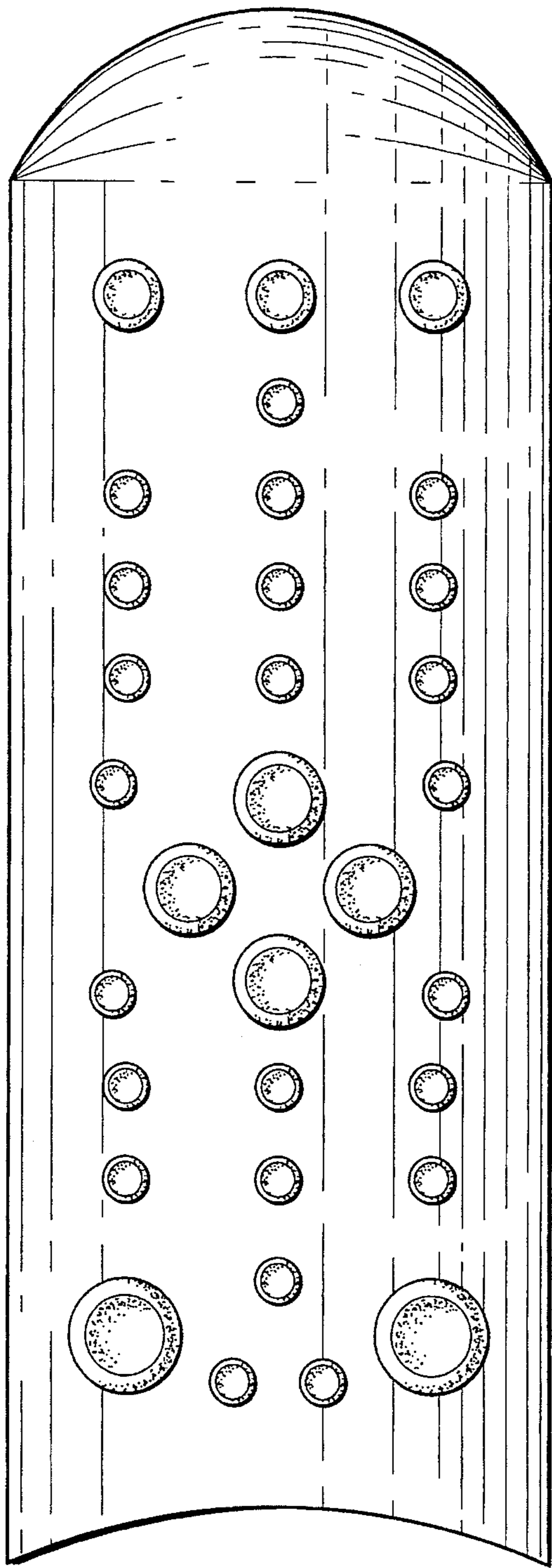

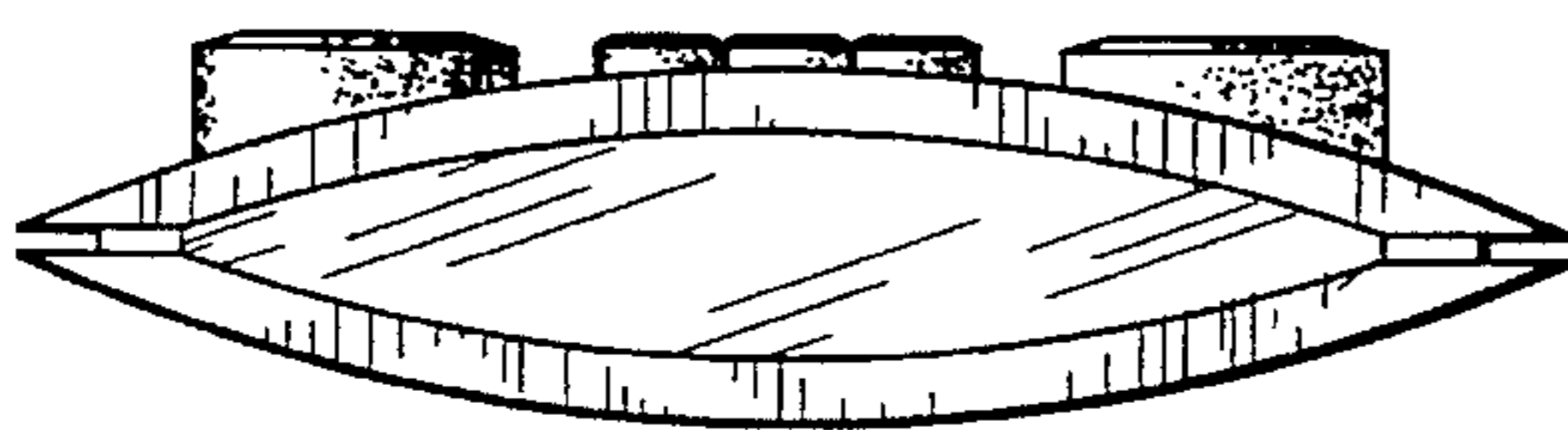

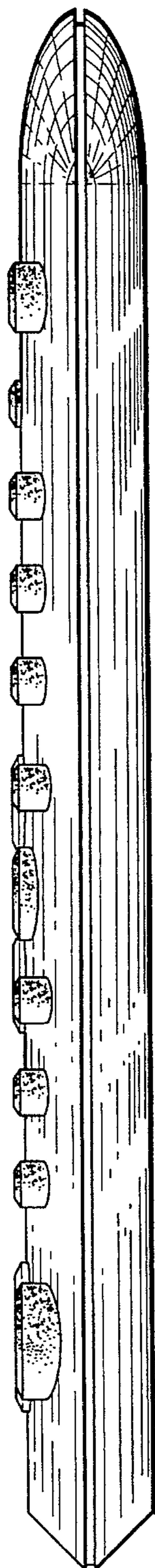

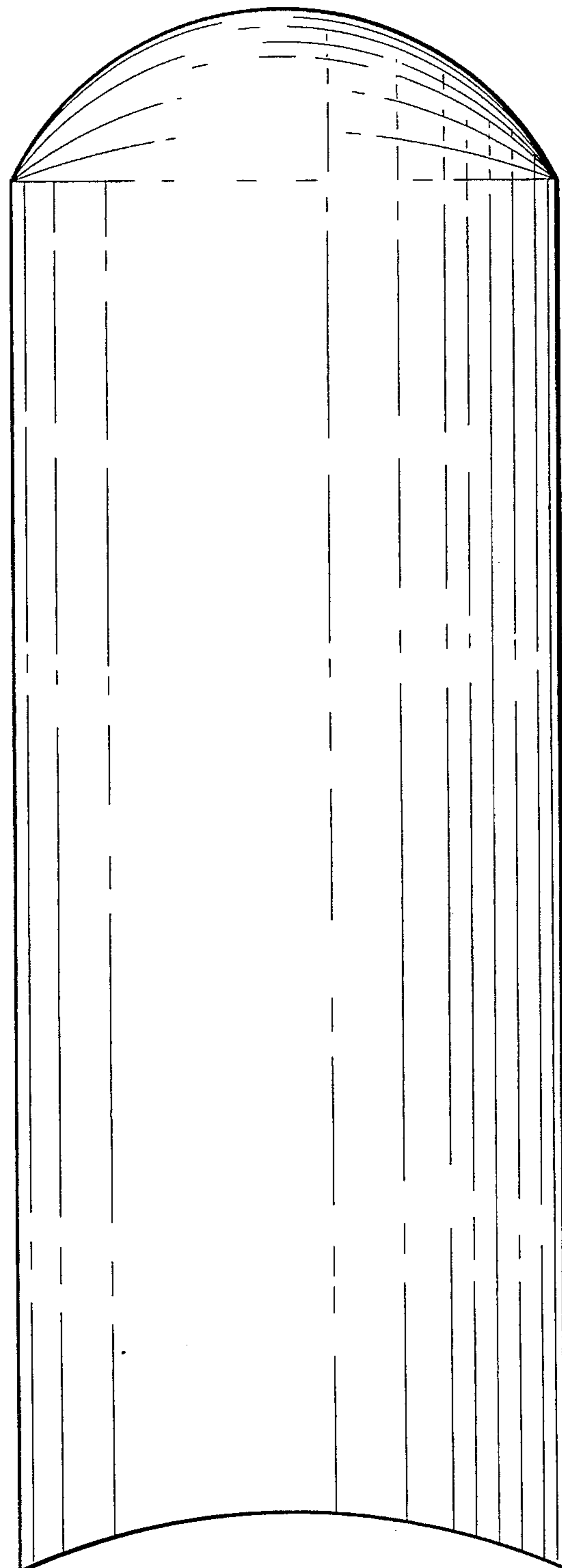

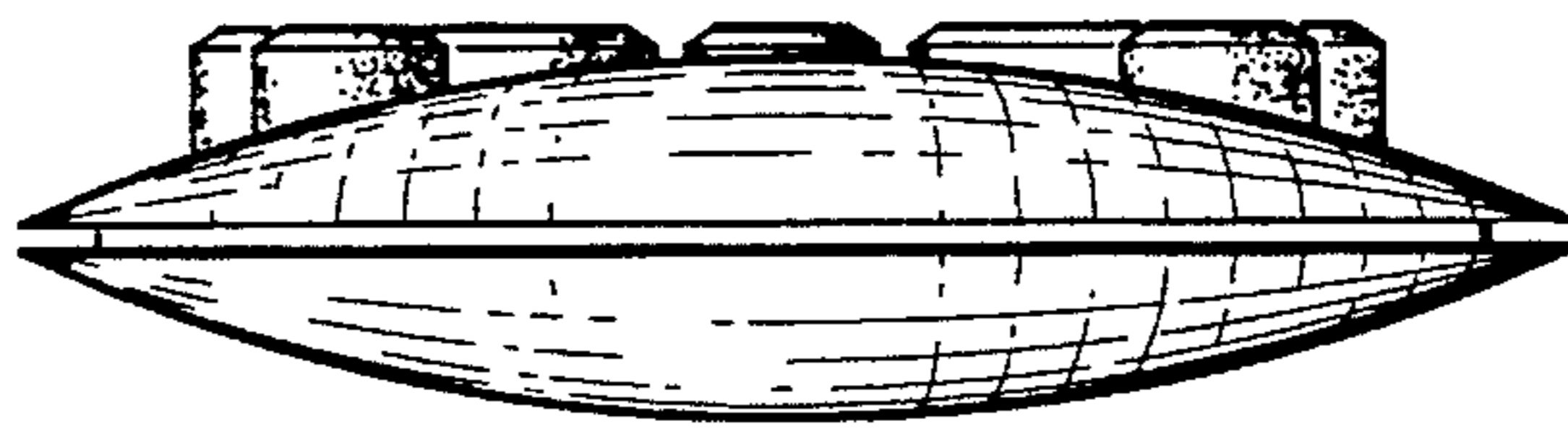
