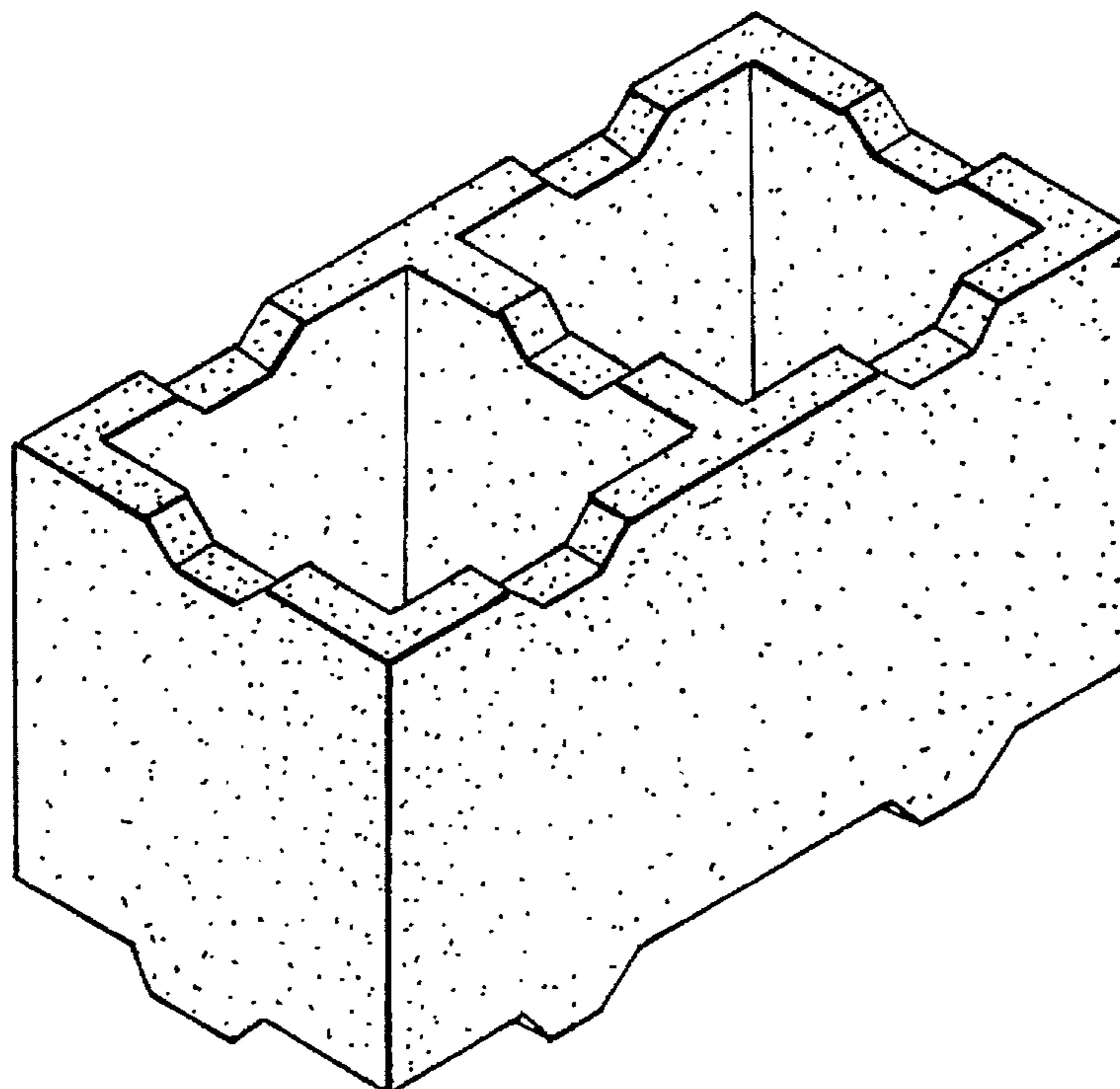
FIG. 1 is a perspective view of a cinder block showing my new design;

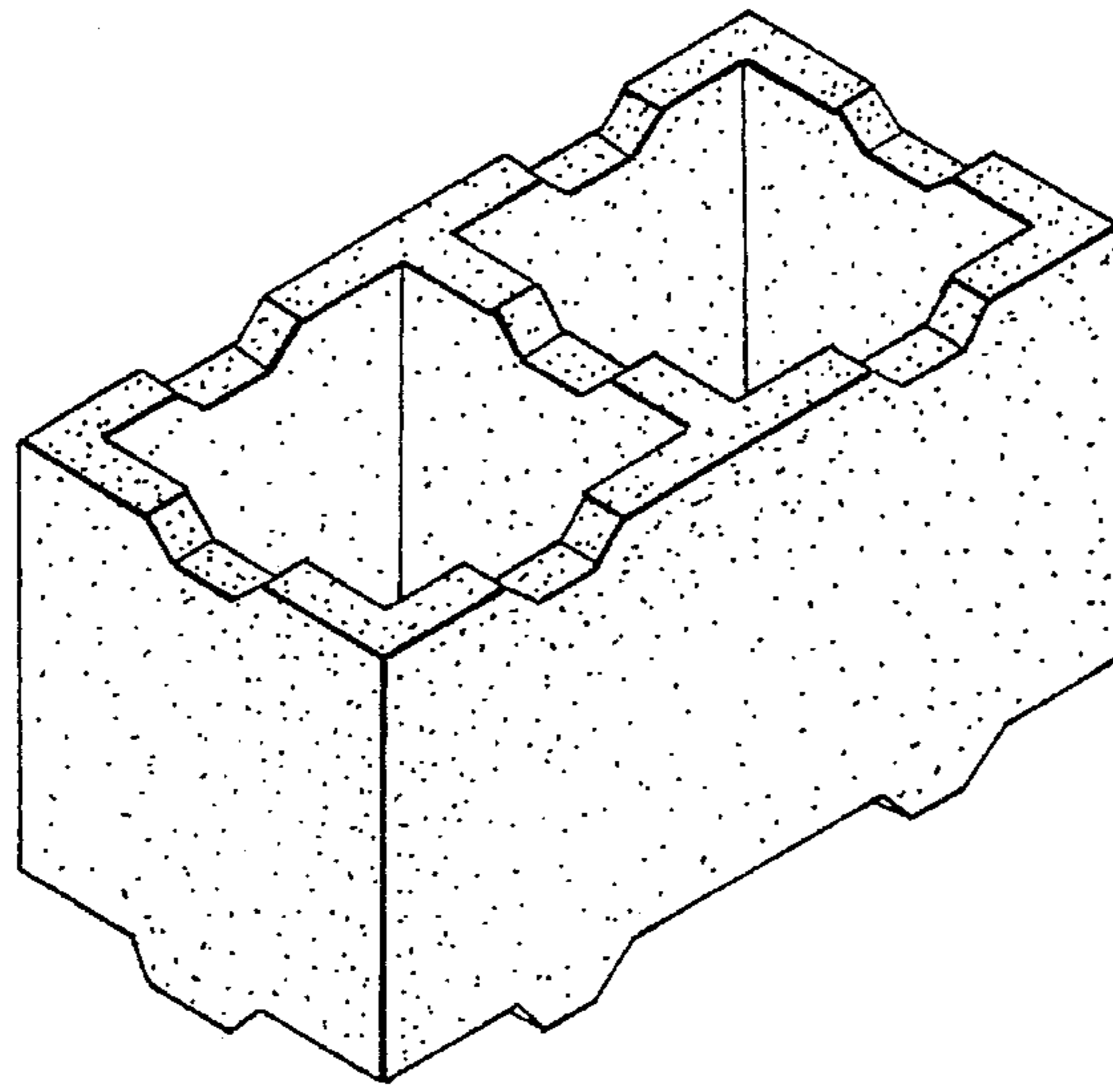

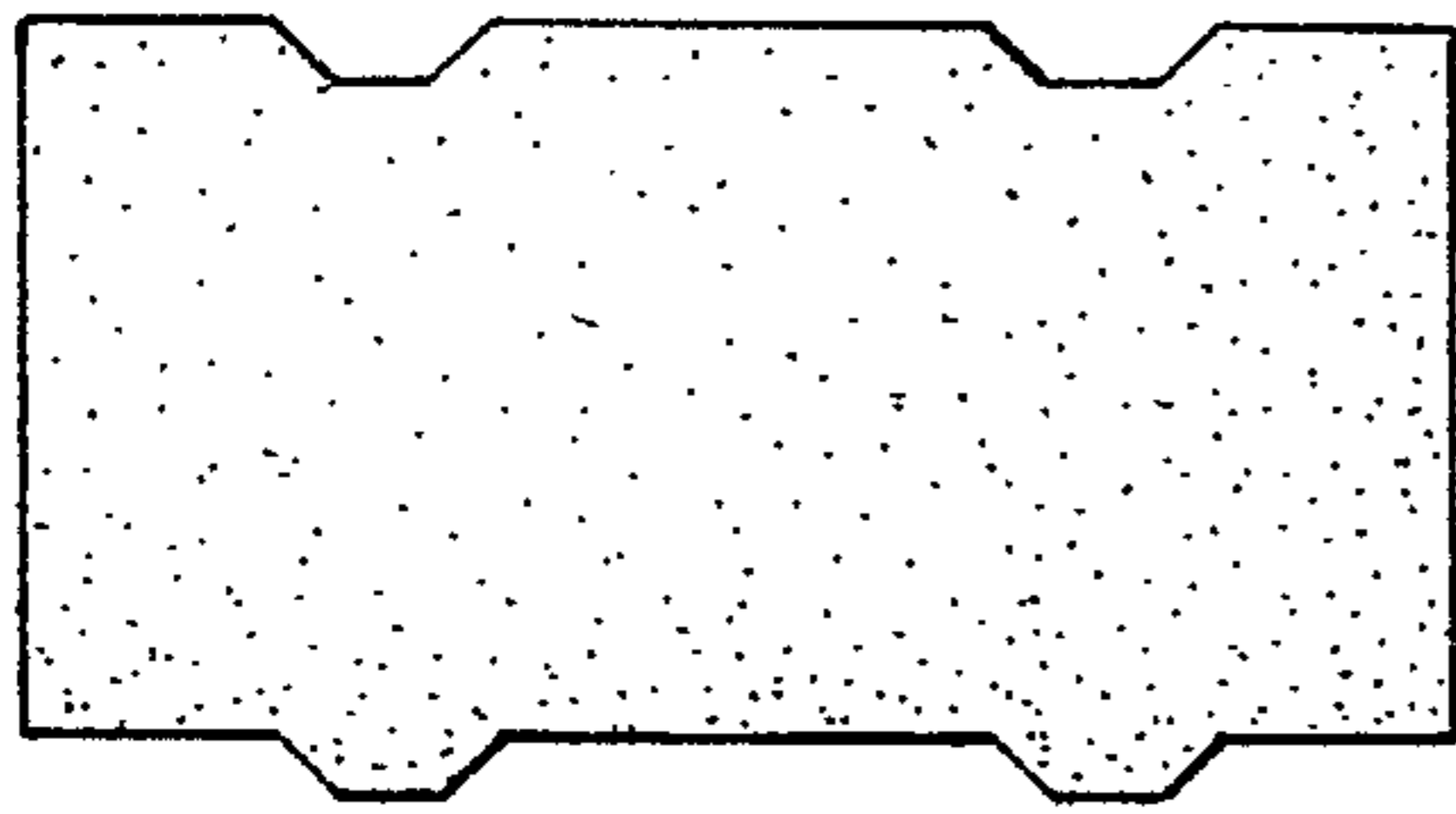

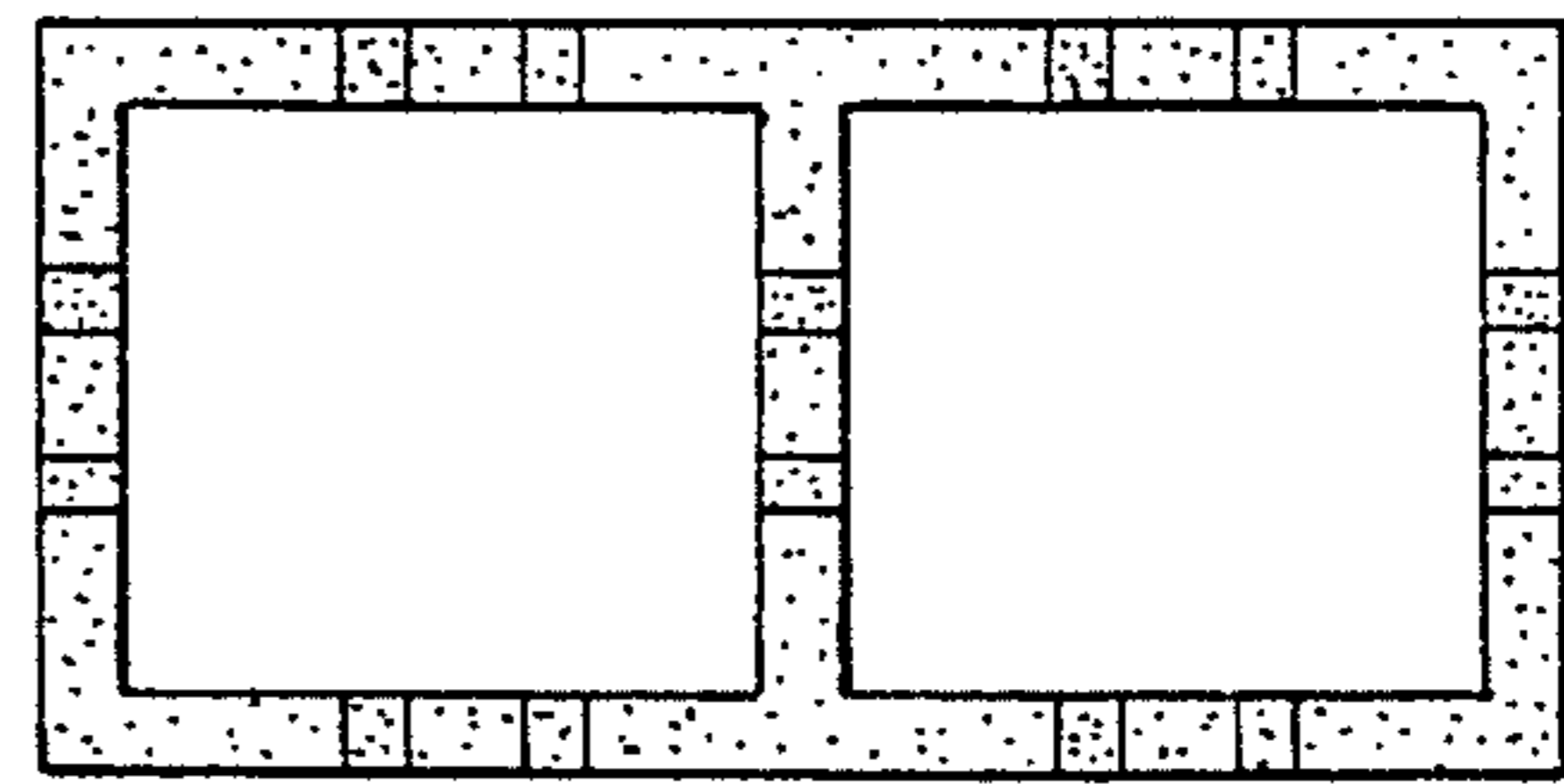

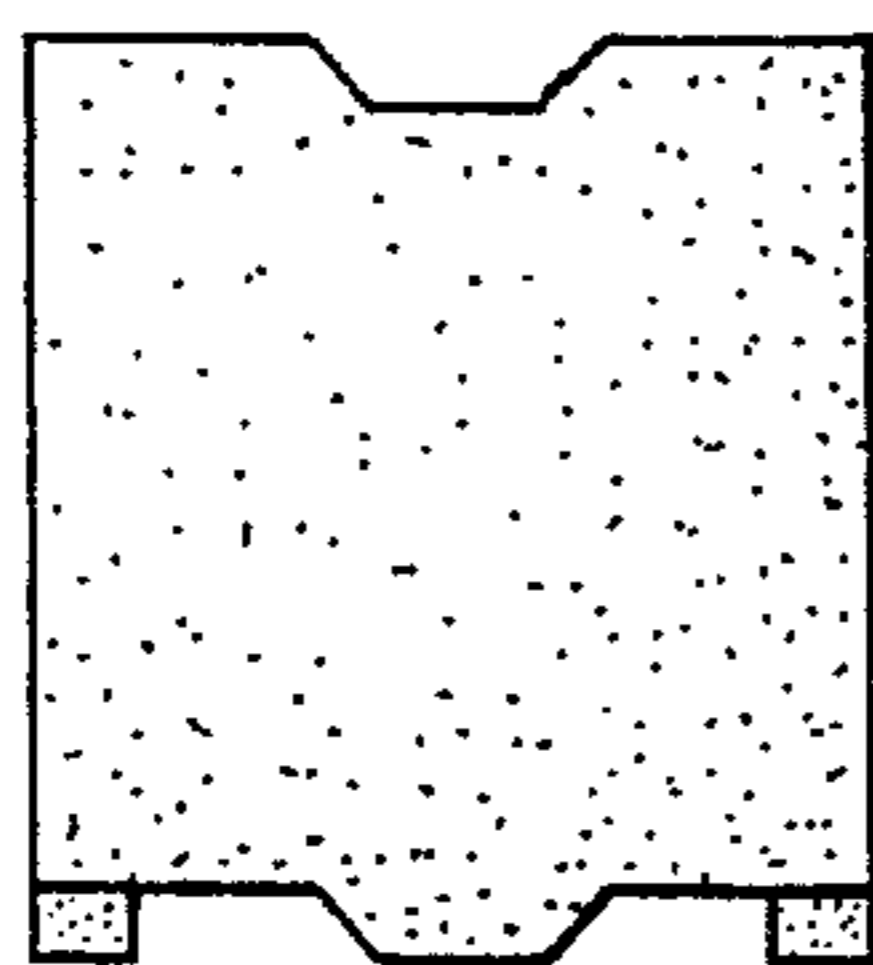

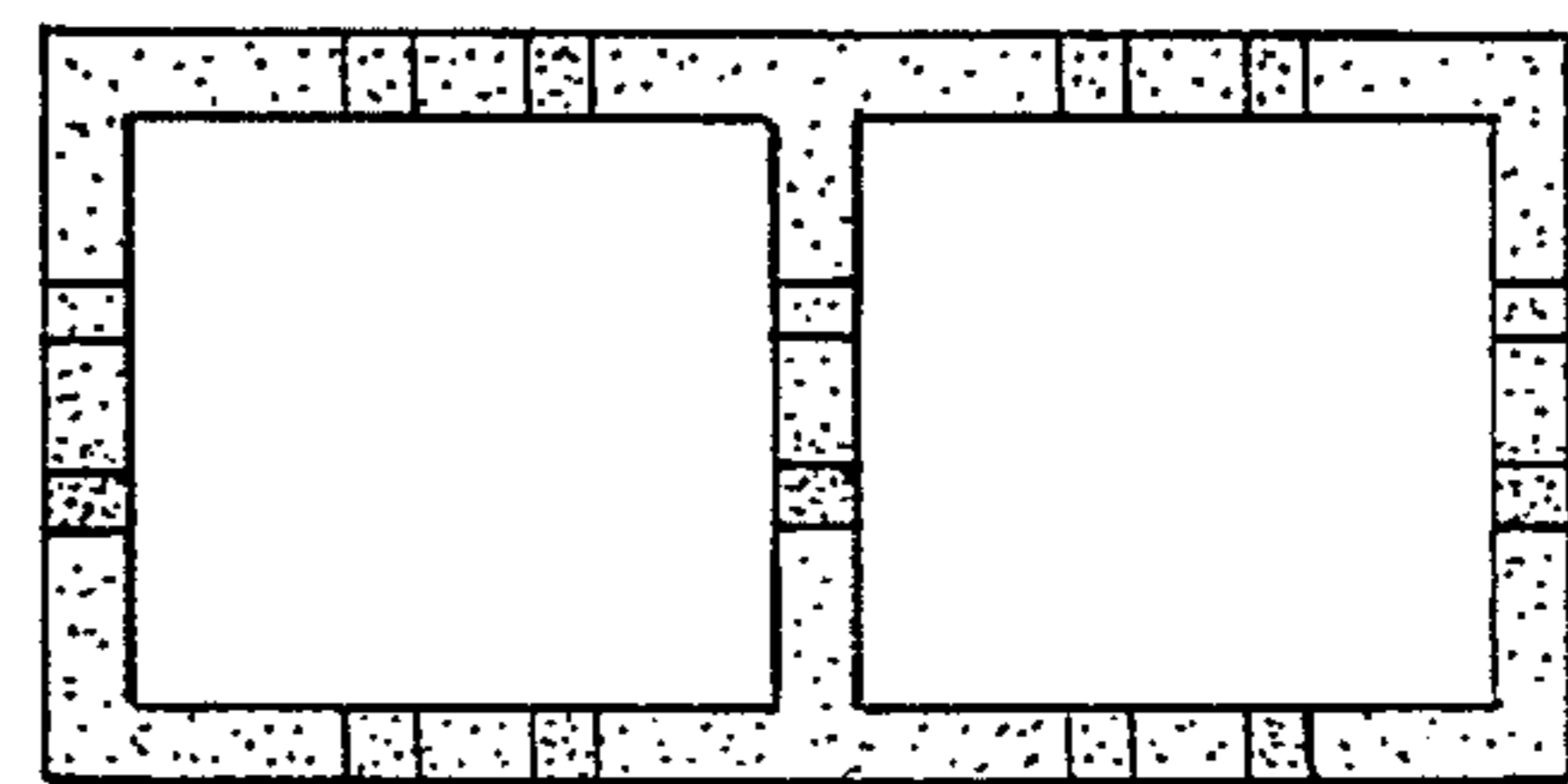

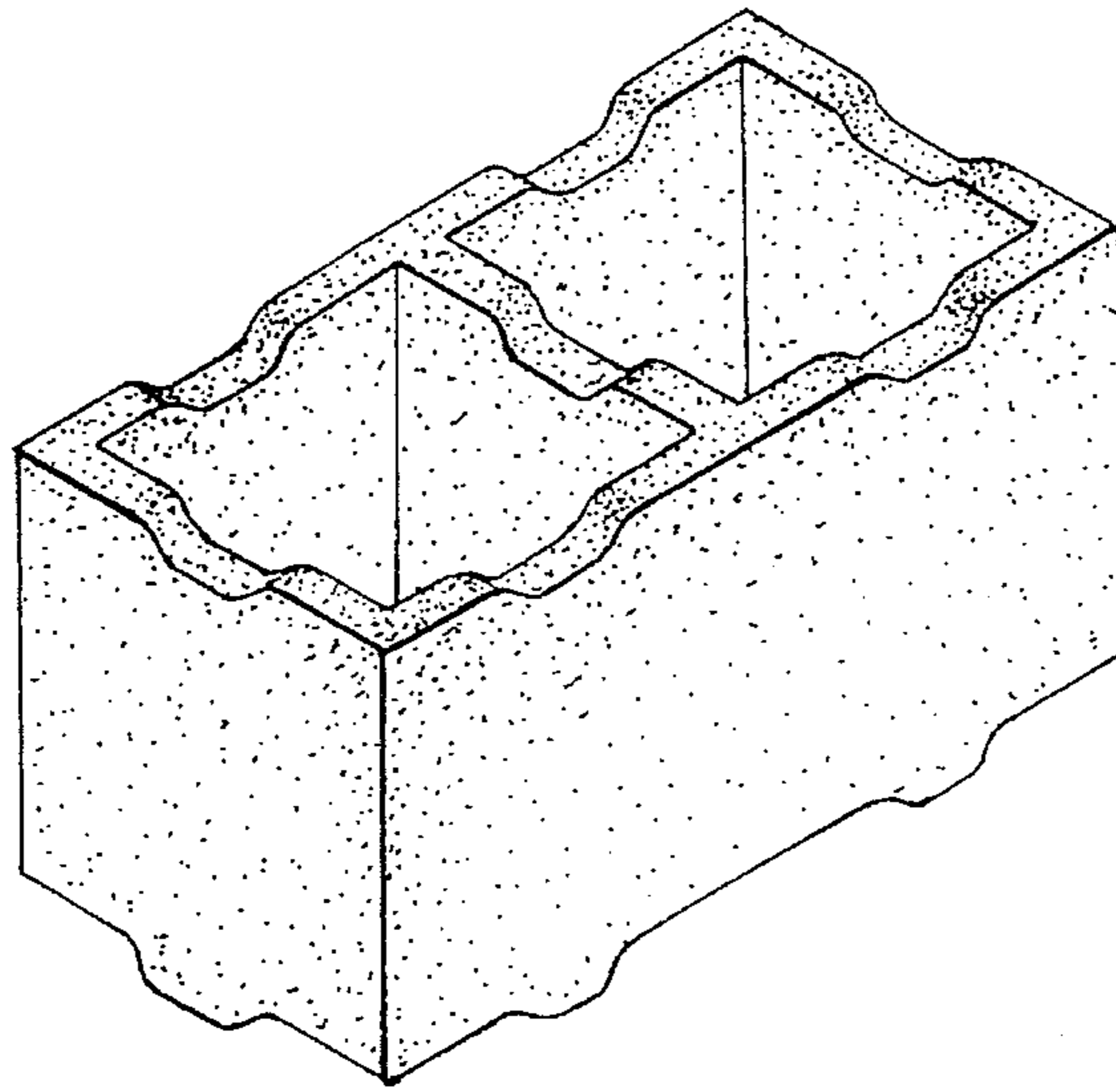

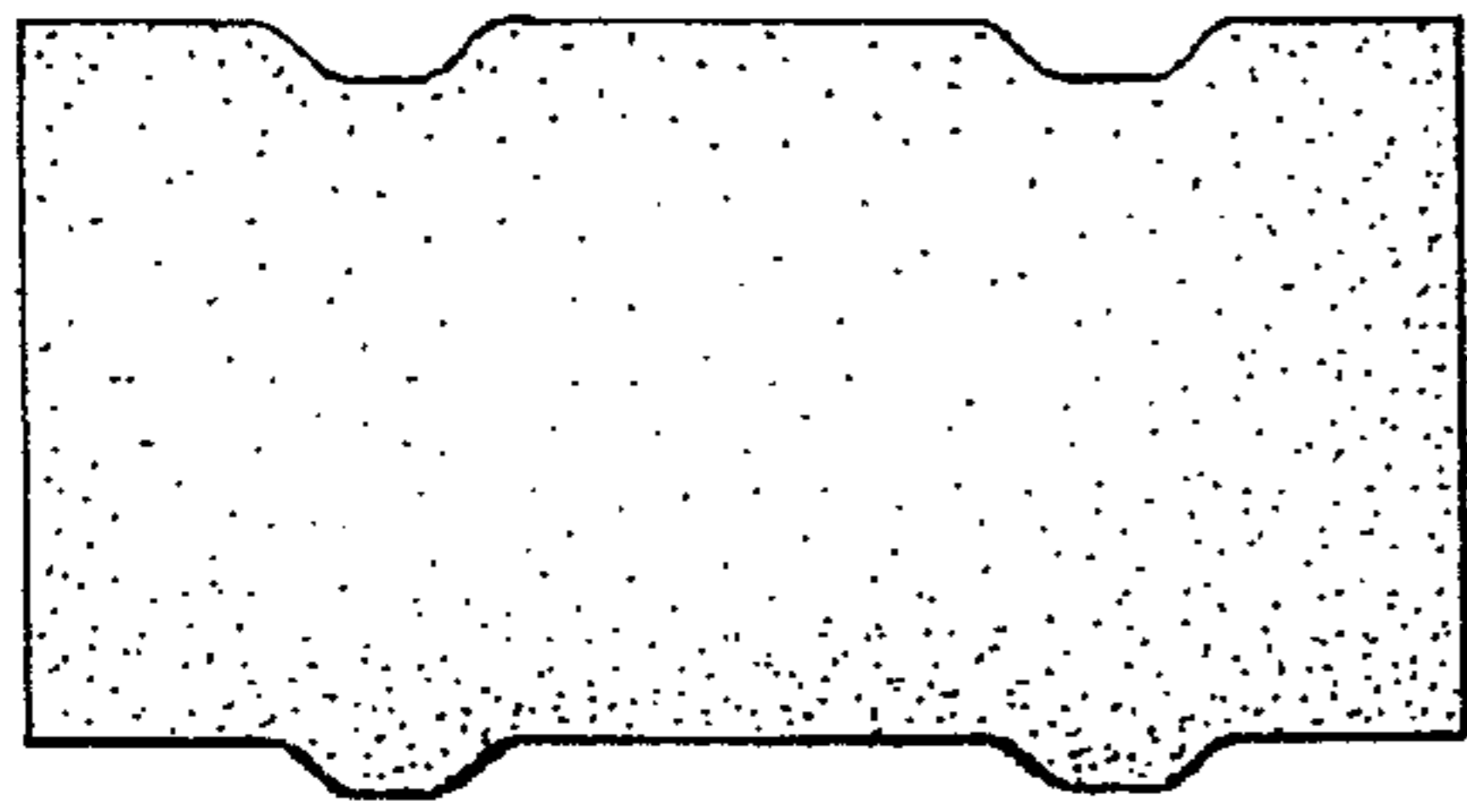

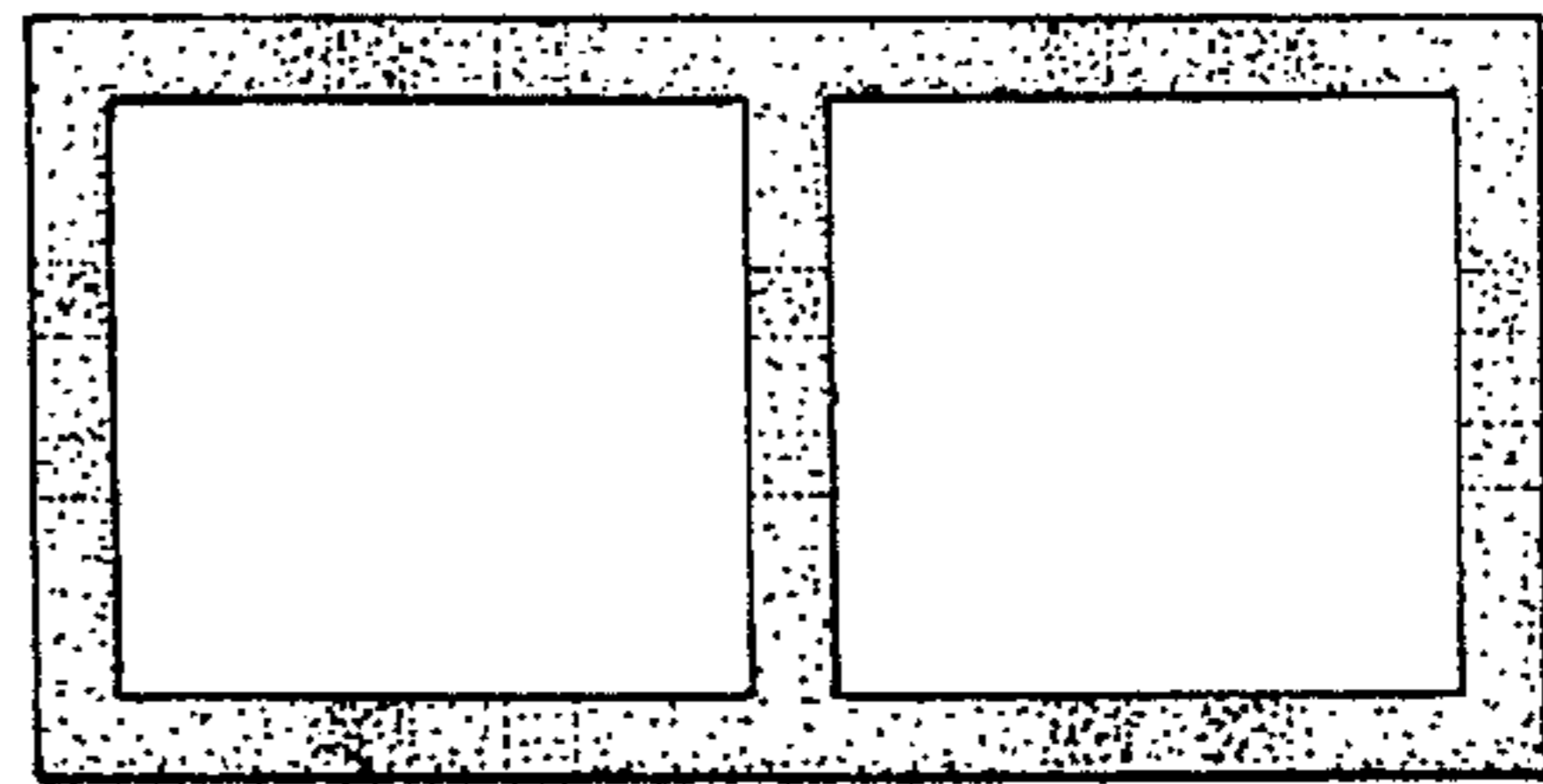

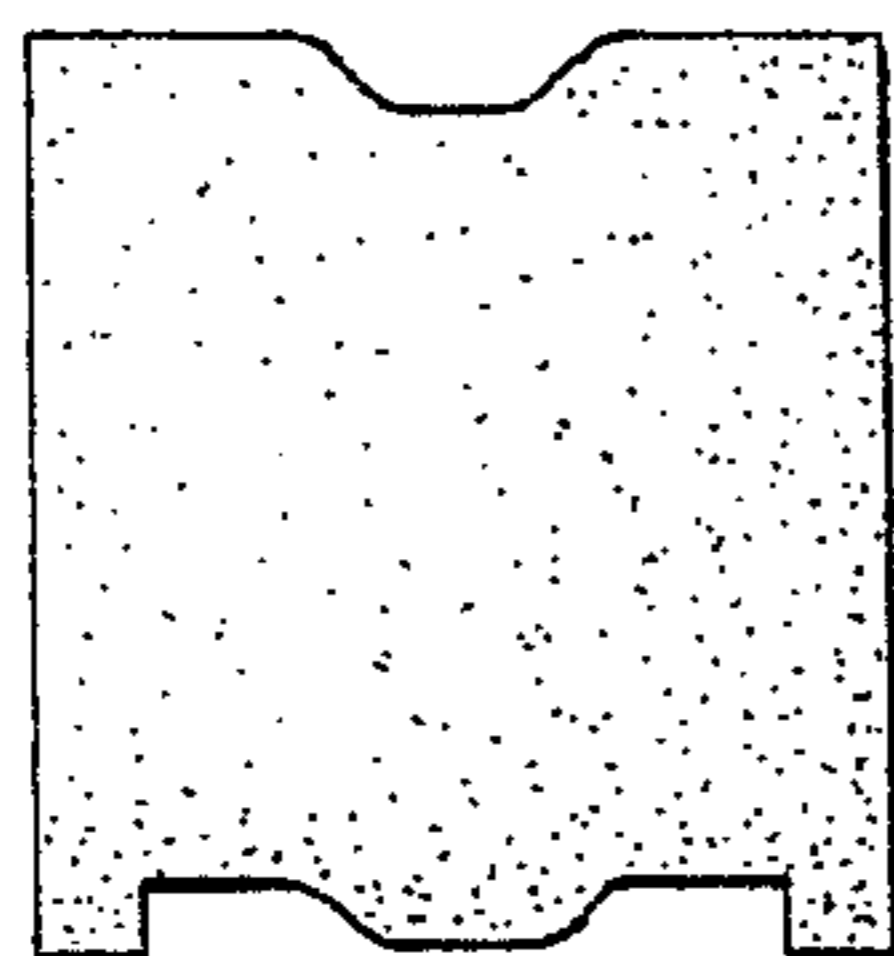

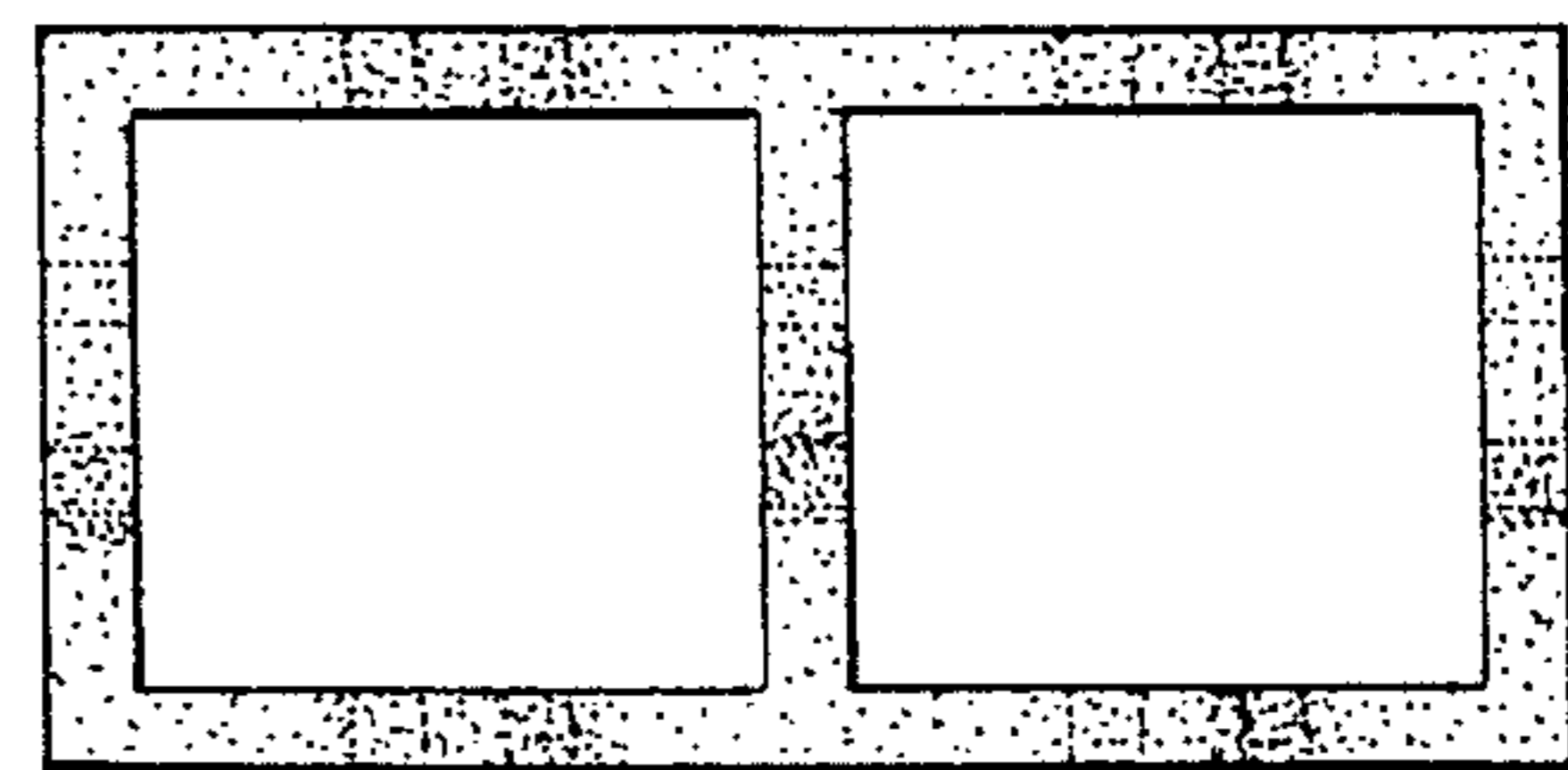
